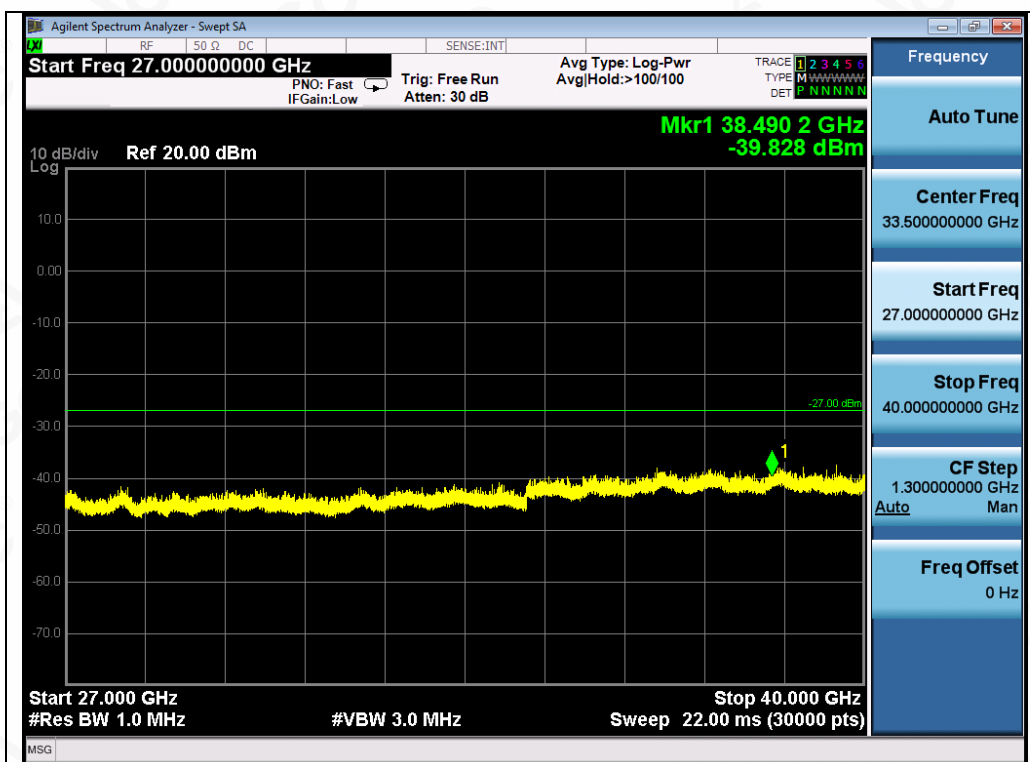

Test Graph 802.11a ANT1 5500 6Mbps Frequency Band 5

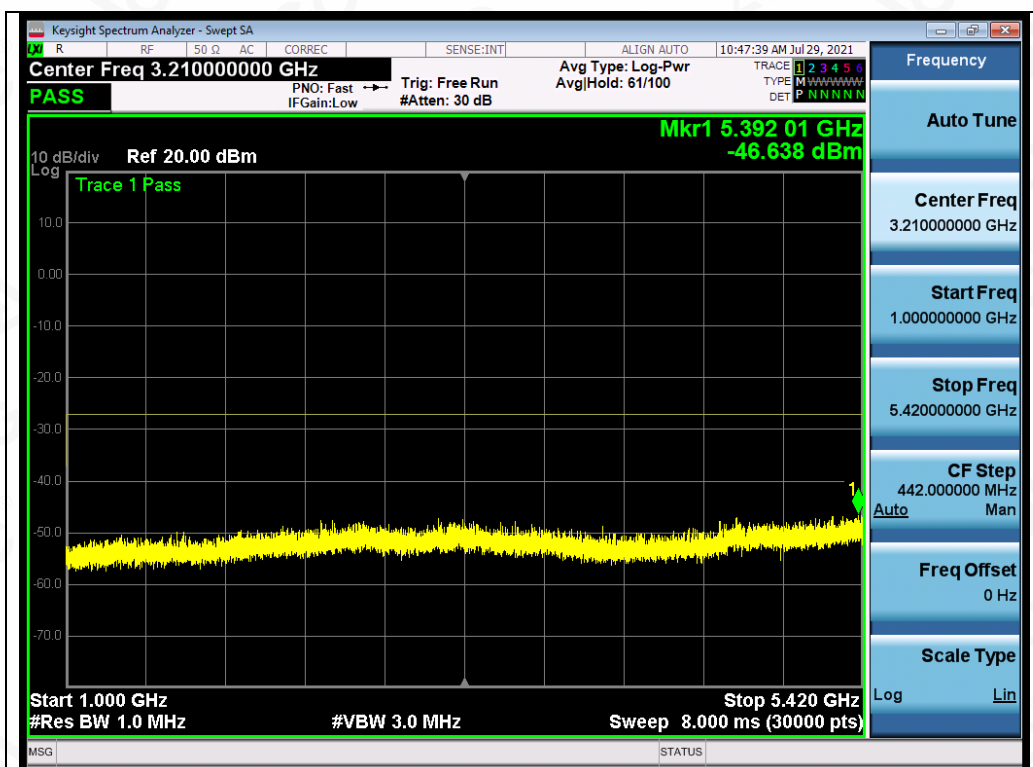


Test Graph 802.11a ANT1 5700 6Mbps Frequency Band 1

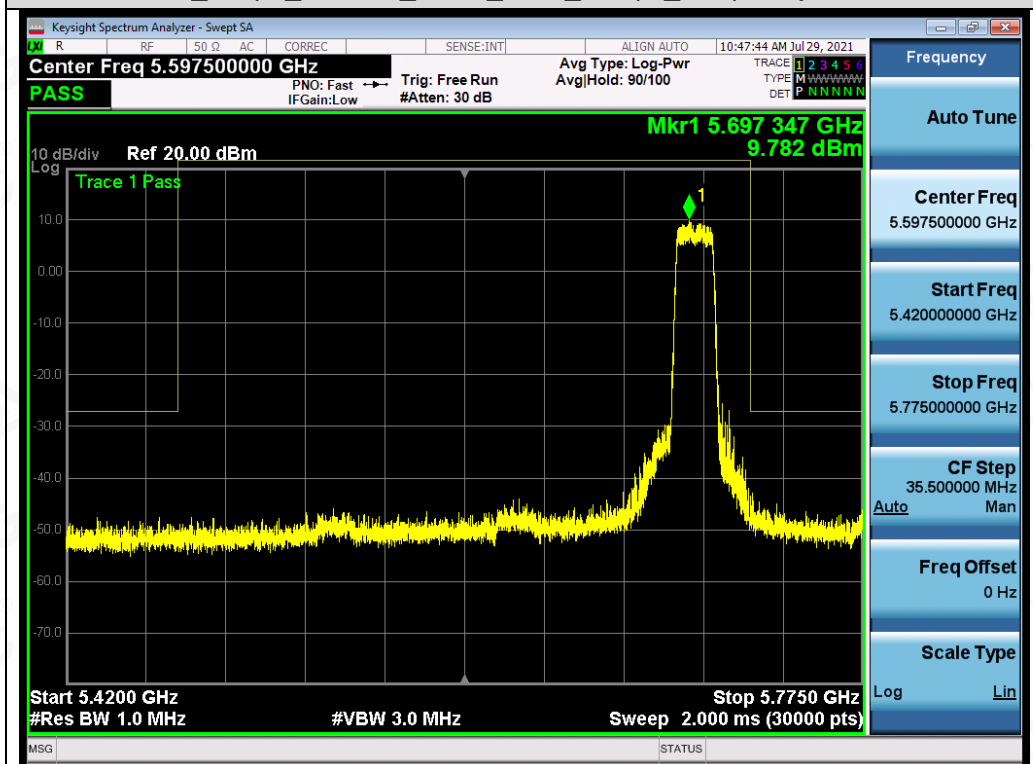

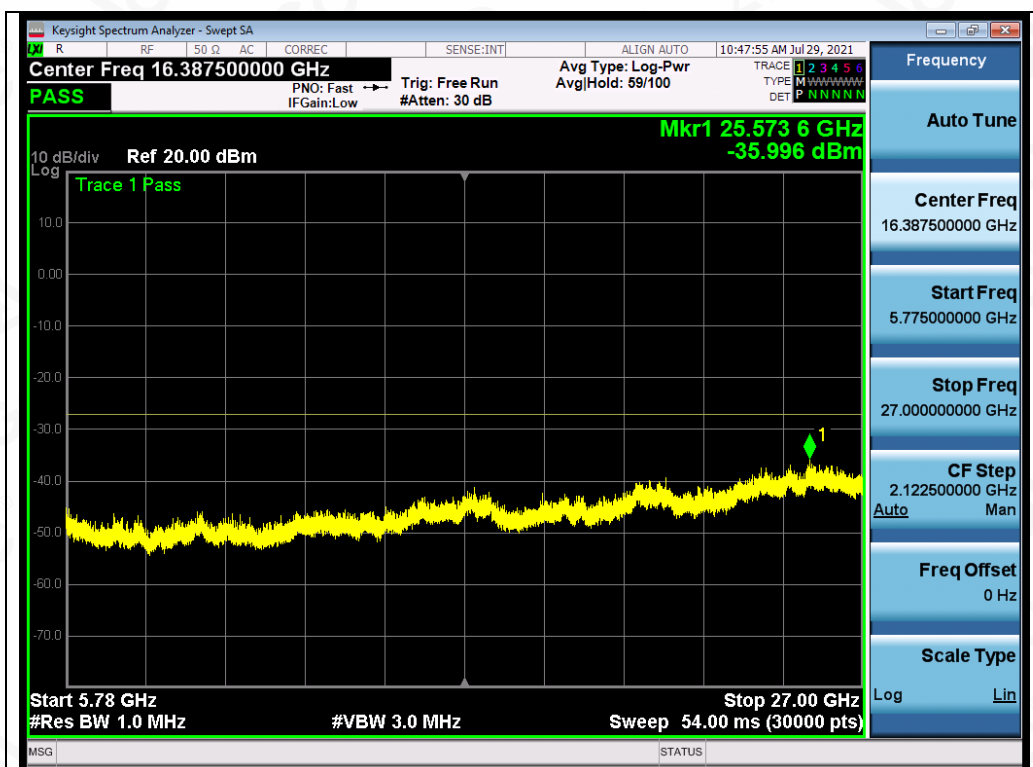

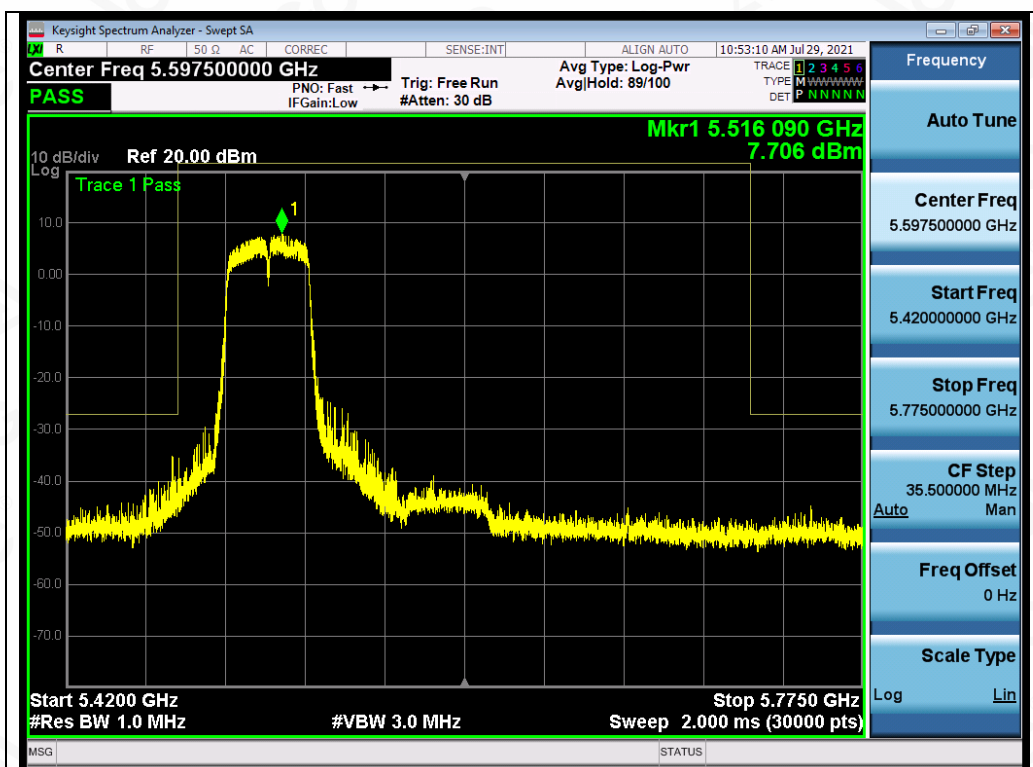
