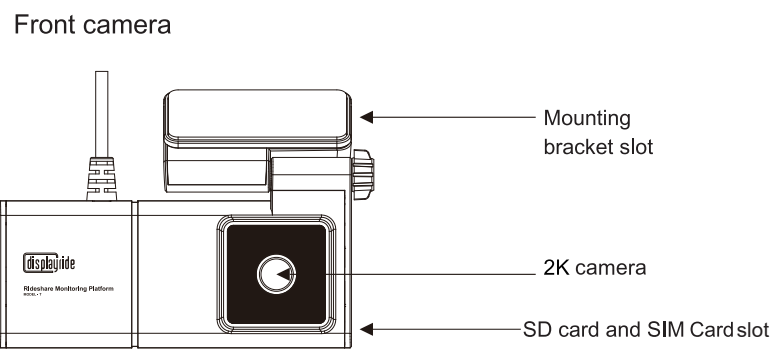




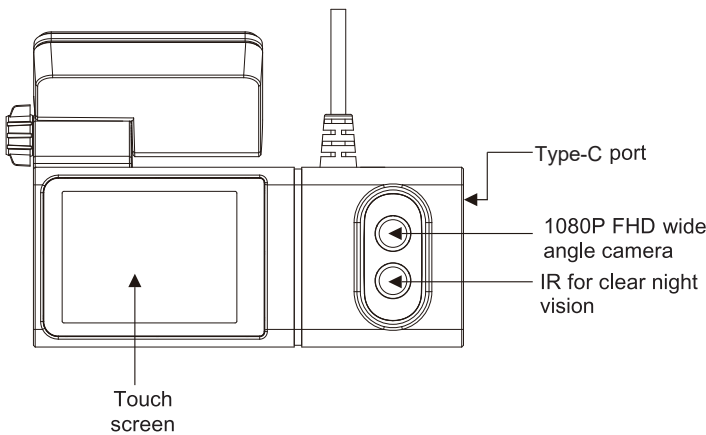

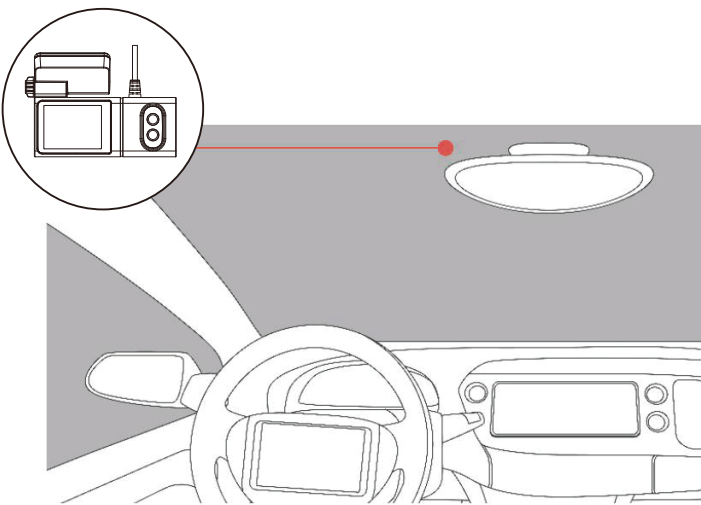
Install Dashcam

- Before you start, make sure that the vehicle is parked on a level surface and that the windshield is clean and dry.
- § Insert SIM card and SD card.
 - § Place the camera as high as possible on the driver side of the vehicle.
 - § Remove the release paper of adhesive, and mount the dashcam to the windshie ld.
 - § Adjust the camera to the proper angle for taking records.
 - § Connect the cables tightly at the ends, and Insert the cigarette lighter into the socket.

Test your Dashcam

- § Insert the power cable to the dashcam. Start your vehicle to test if the dashcam power on. Once you tested your dashcam, run the power cable along the headliner of the car along the A-Pillar to the power source for a clean installation.
- § That's it. You've successfully installed your dashcam!

Remove Dashcam

- § Power off the dashcam.
- § Disconnect the power cables.
- § Tuning the knob of the mount kit till it is loosen.
- § Take the dashcam off the mounting board.
