15.203 Requirement:

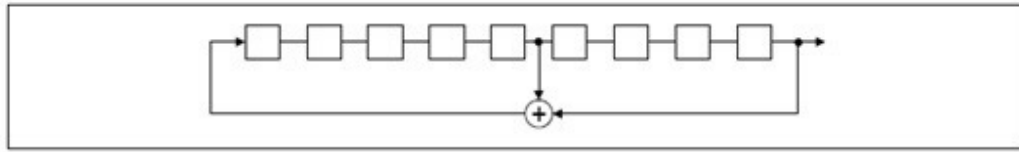
Linear Feedback Shift Register for Generation of the PRBS sequence

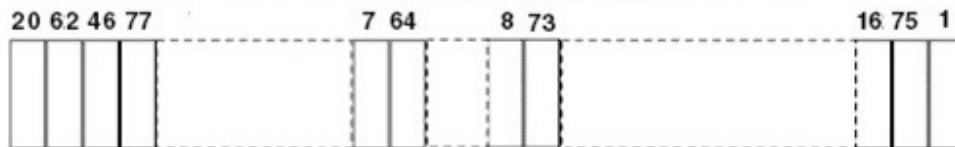

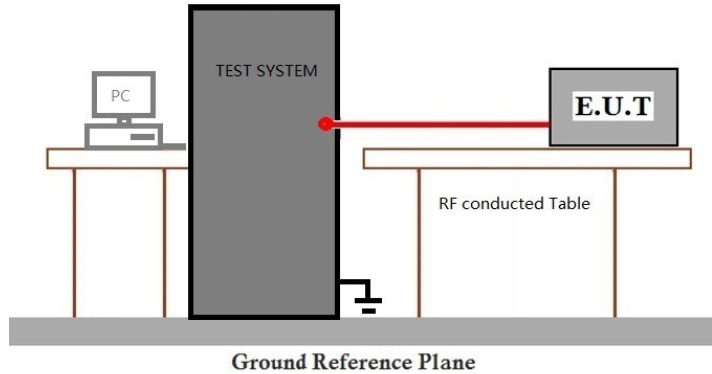

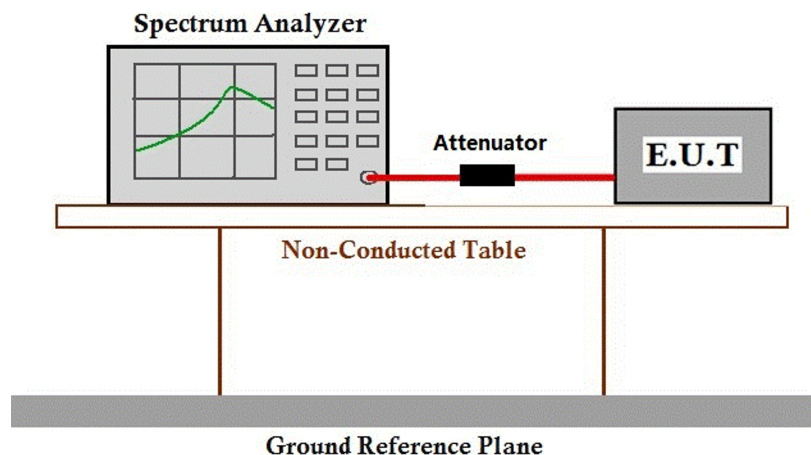

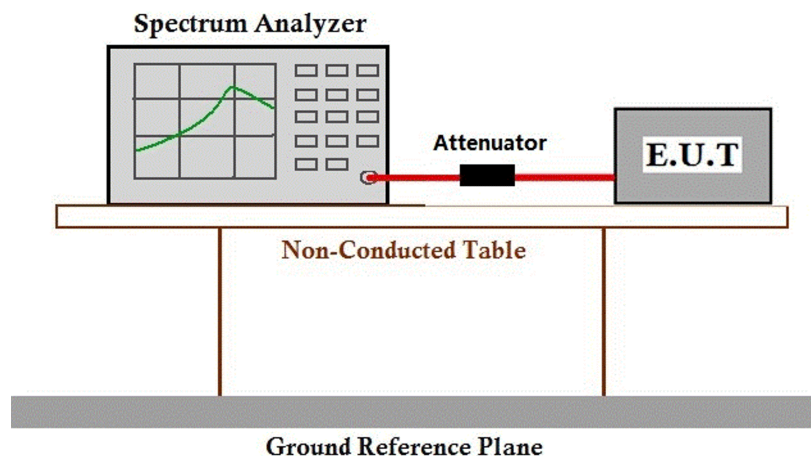

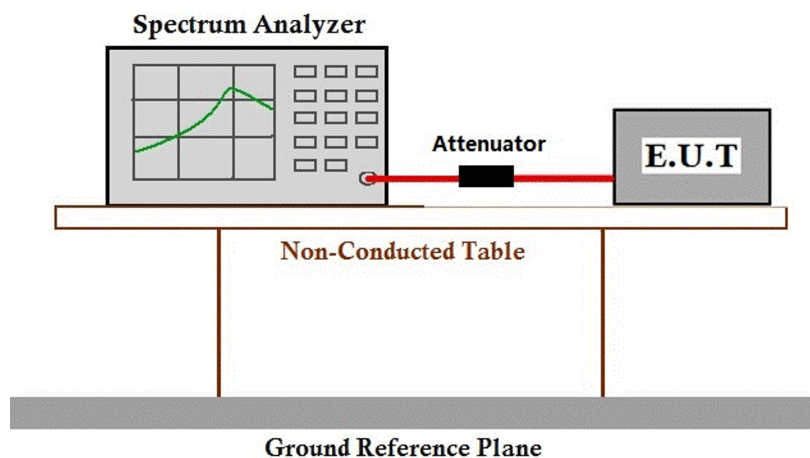

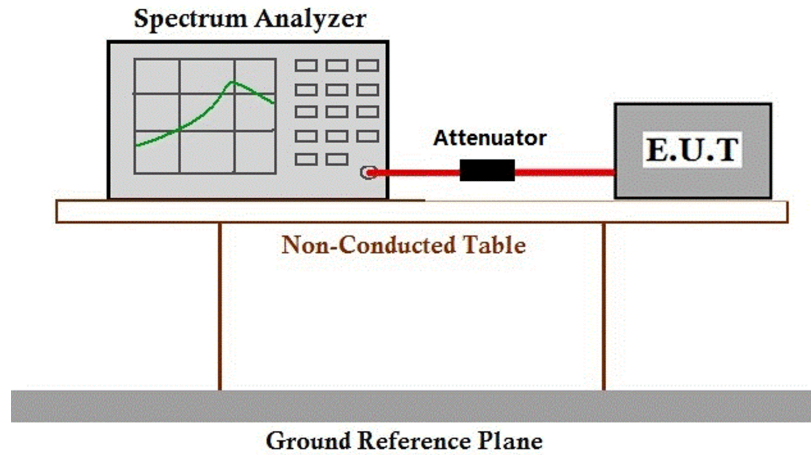

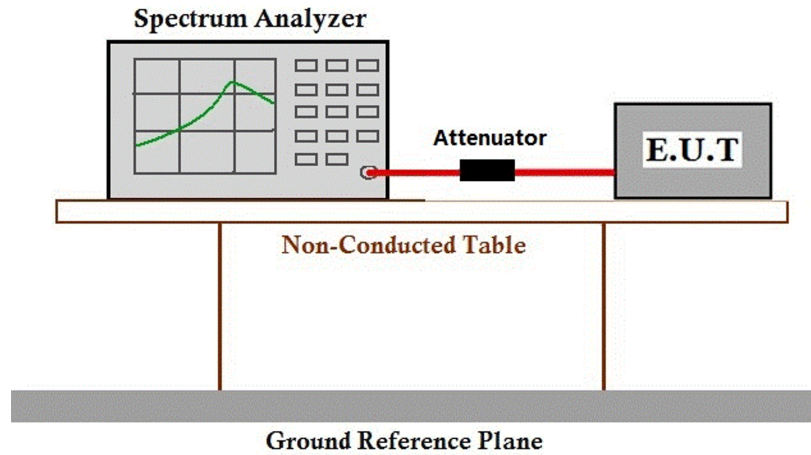

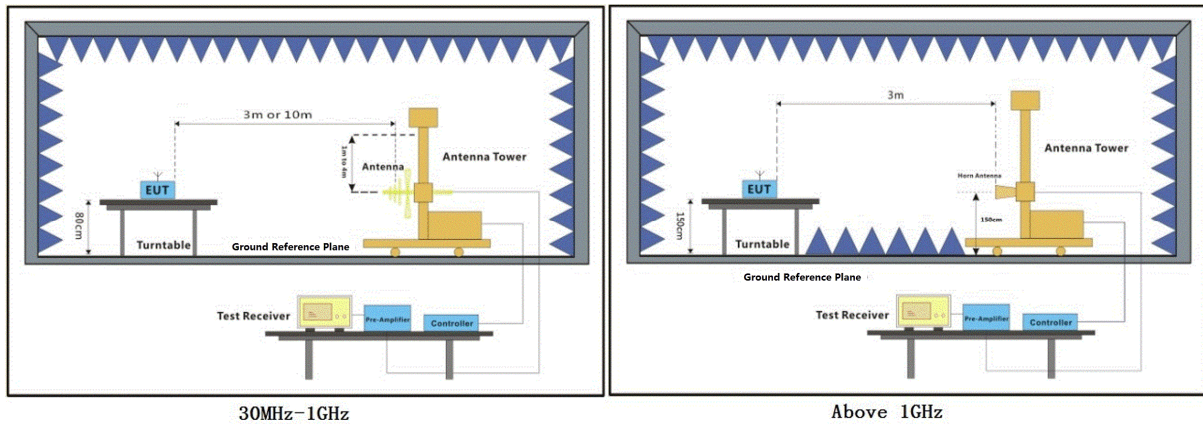

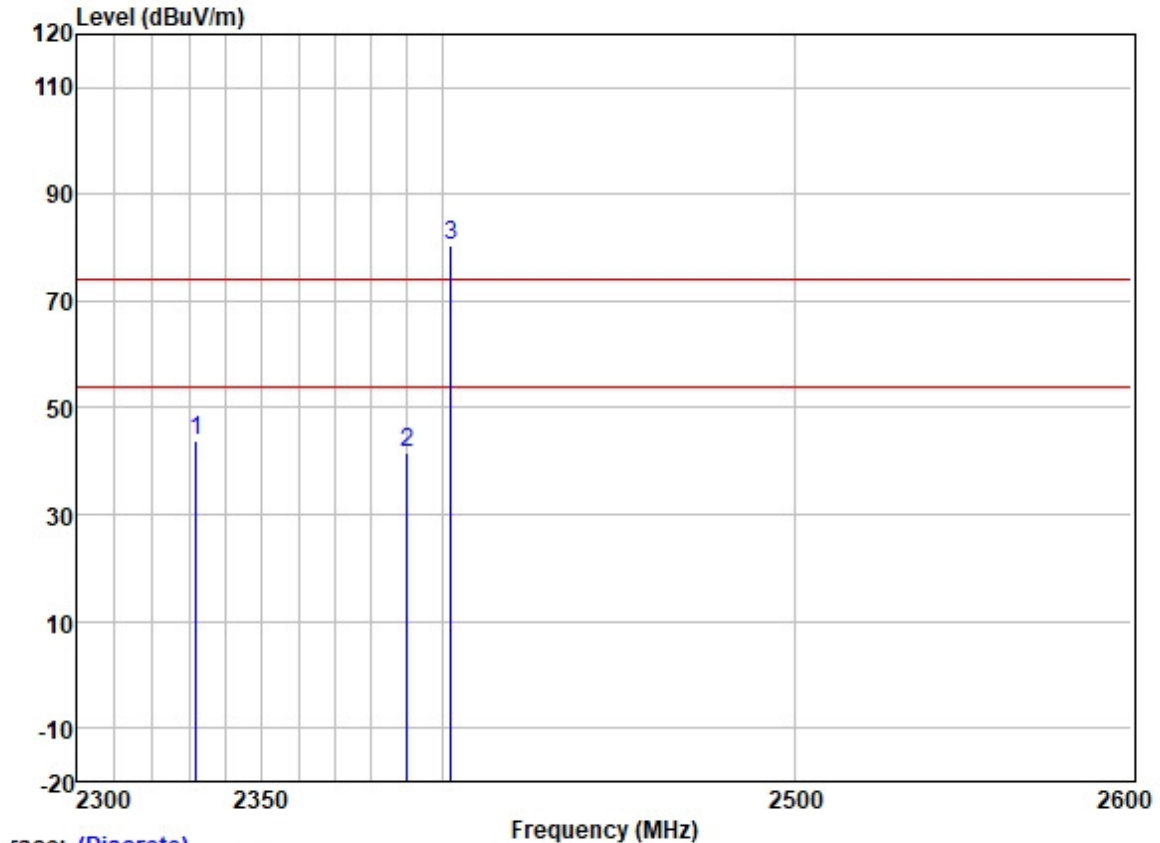

7.9.3 Test Setup Diagram



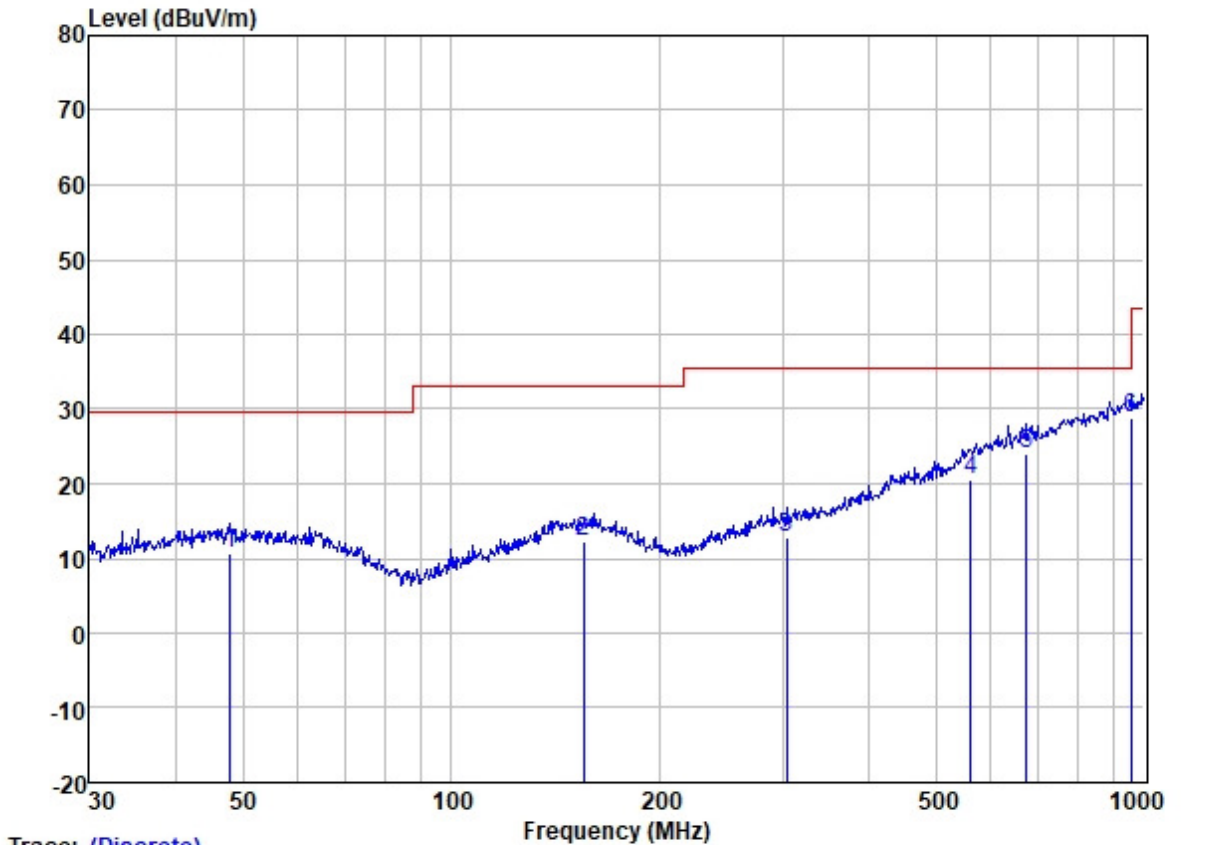

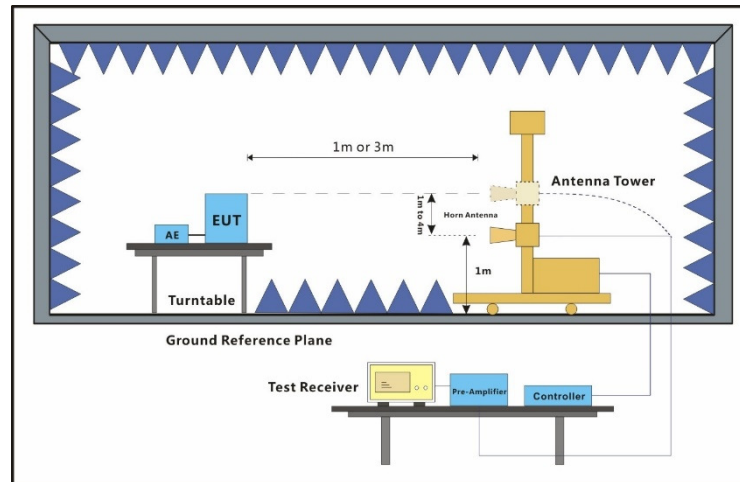
