Test Graphs of Conducted Output Power Spectral Density for band 5.25-5.35 GHz

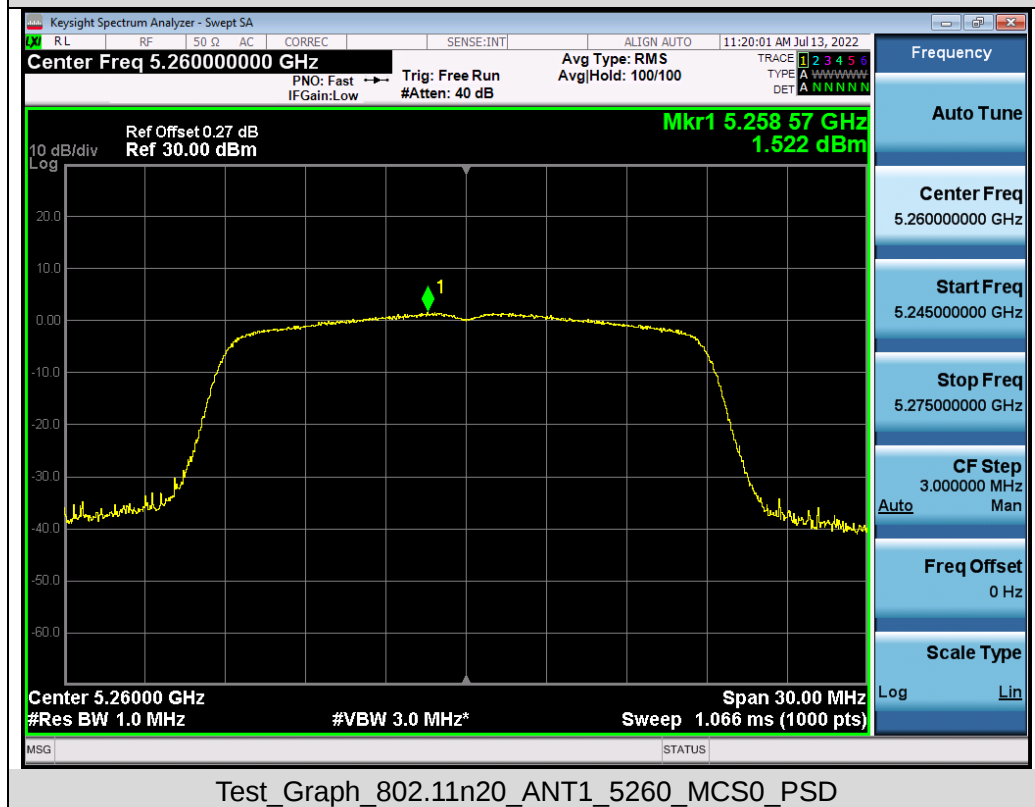

Test Graphs of Conducted Output Power Spectral Density for band 5.47-5.725 GHz

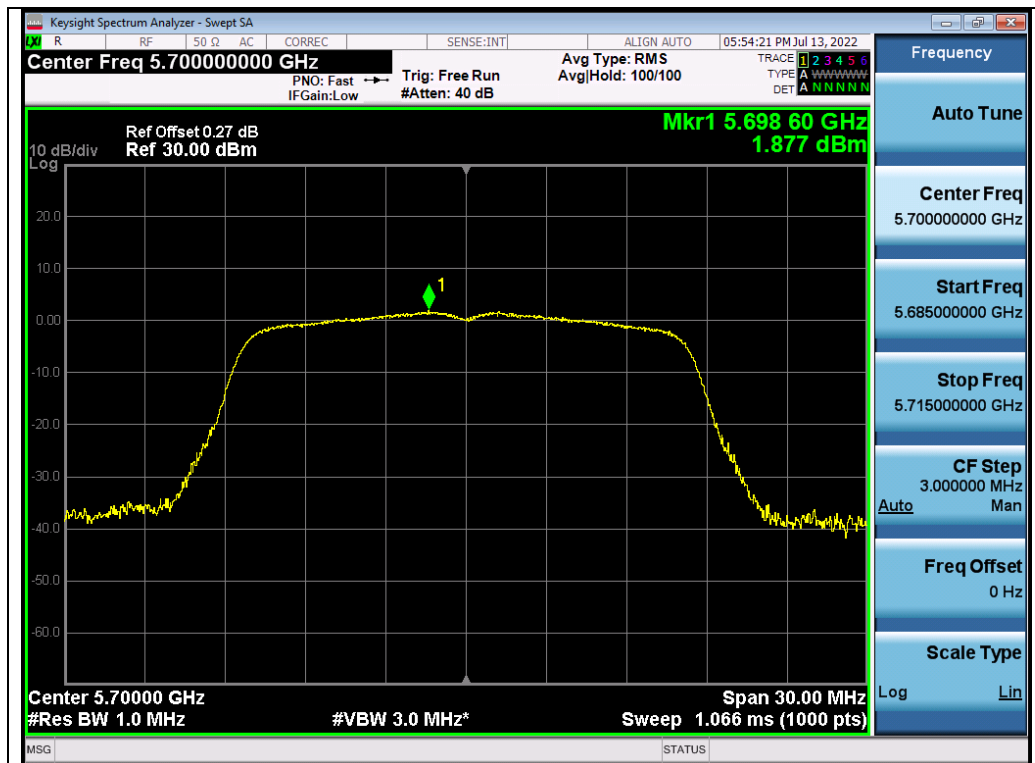

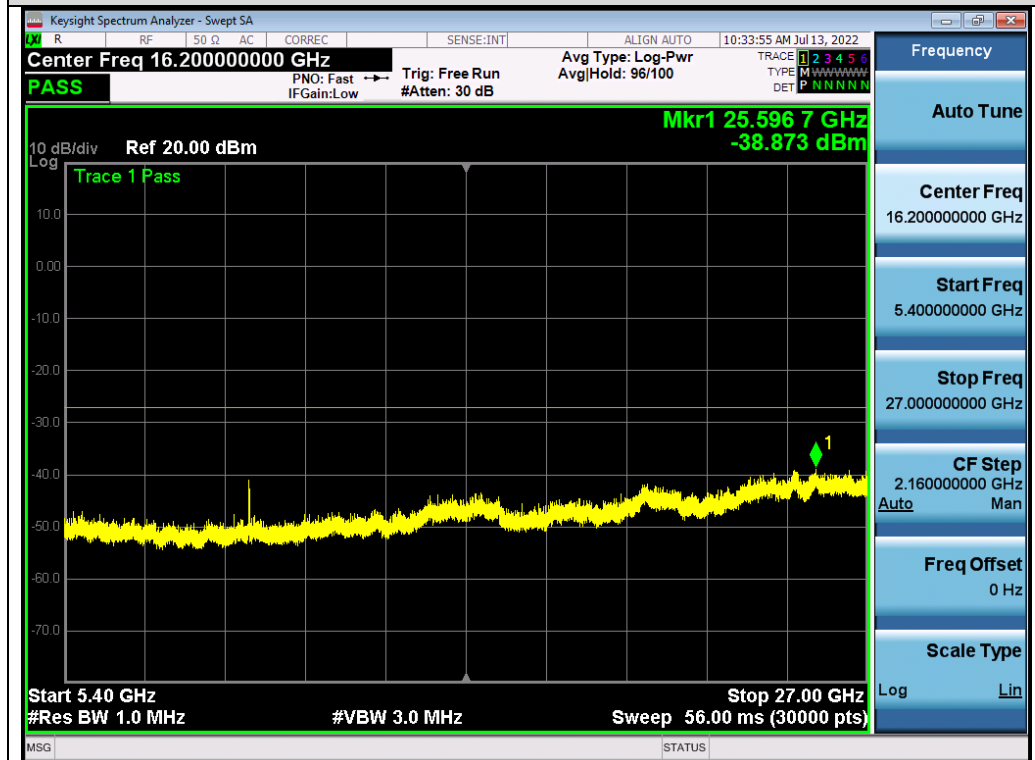
Test Graphs of Spurious Emissions outside of the 5.15-5.25 GHz band for transmitters operating in the 5.15-5.25 GHz band

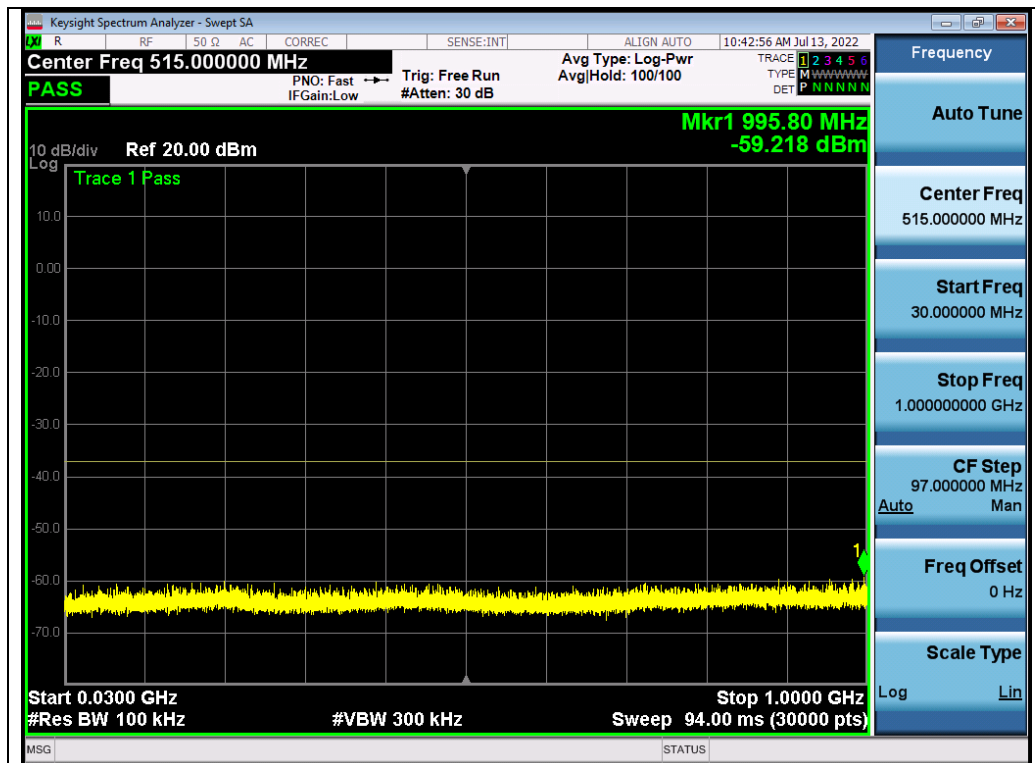


Test_Graph_802.11a_ANT1_5180_6Mbps_Frequency Band 3

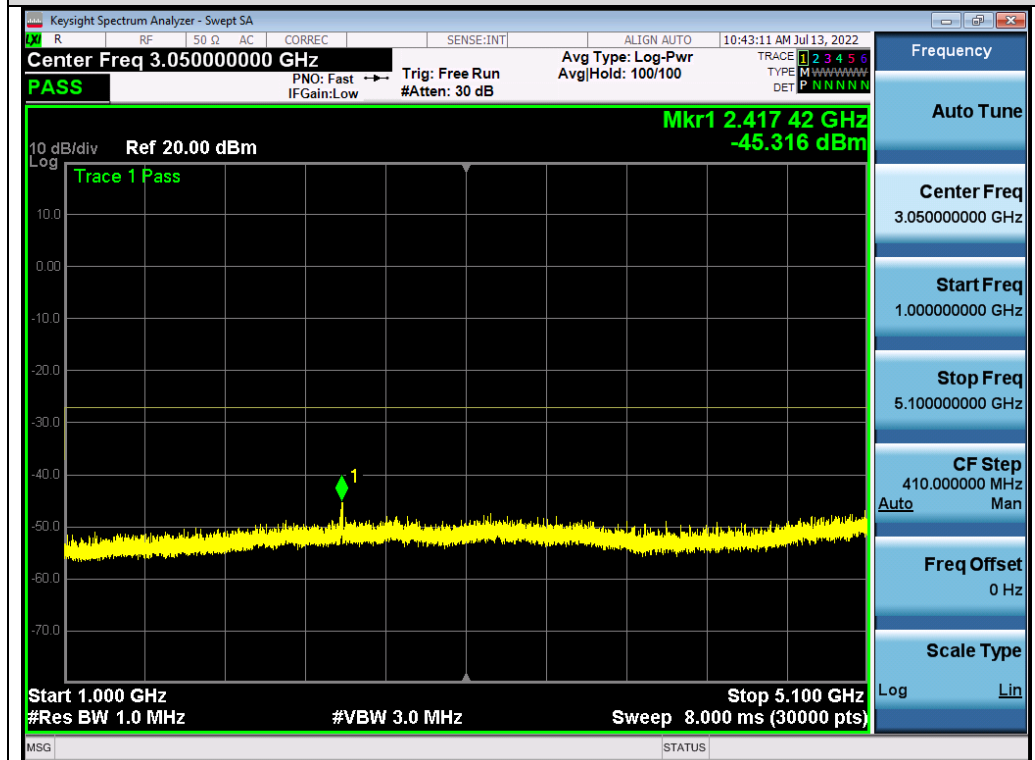

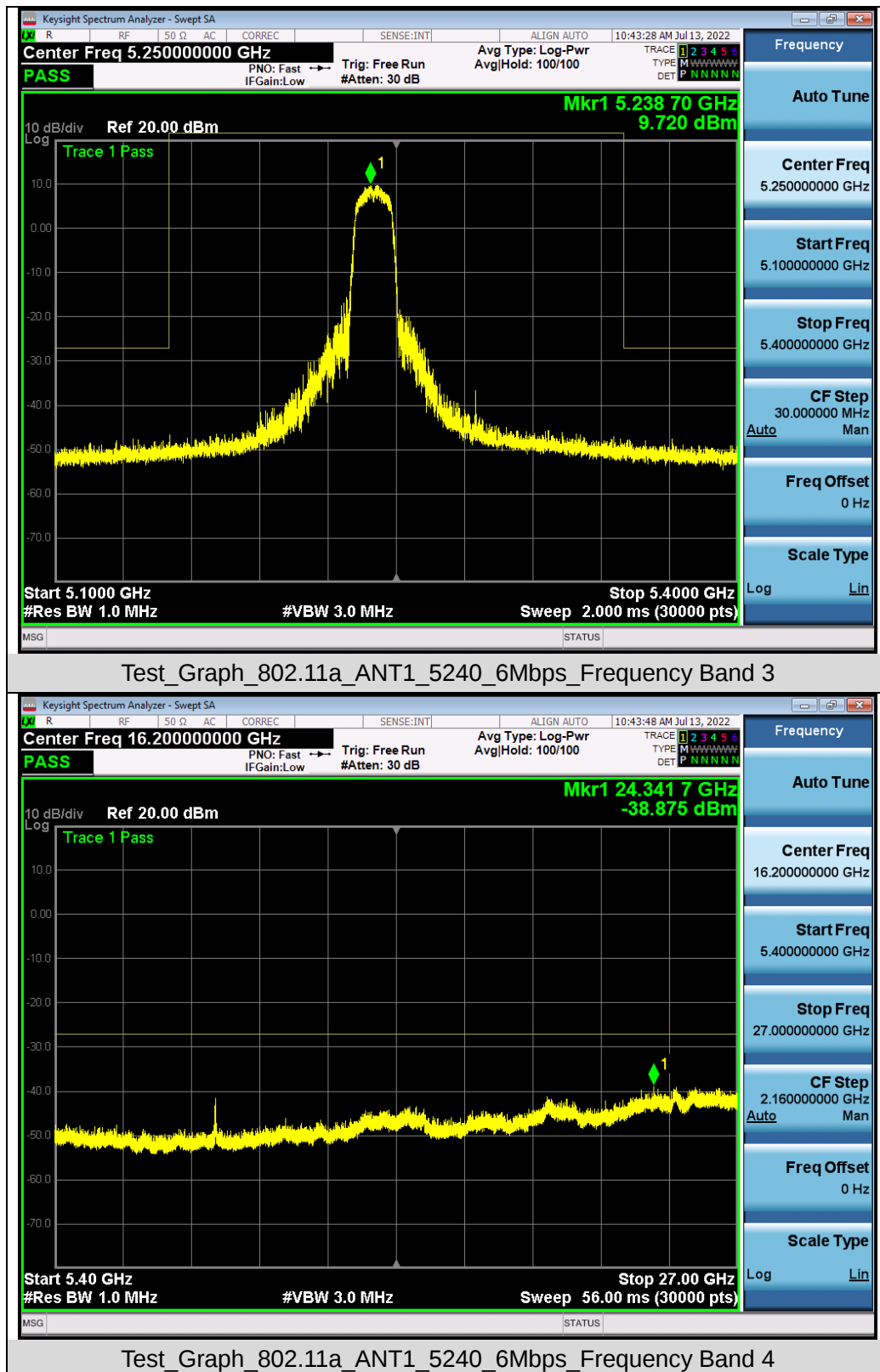


Test_Graph_802.11a_ANT1_5240_6Mbps_Frequency Band 1

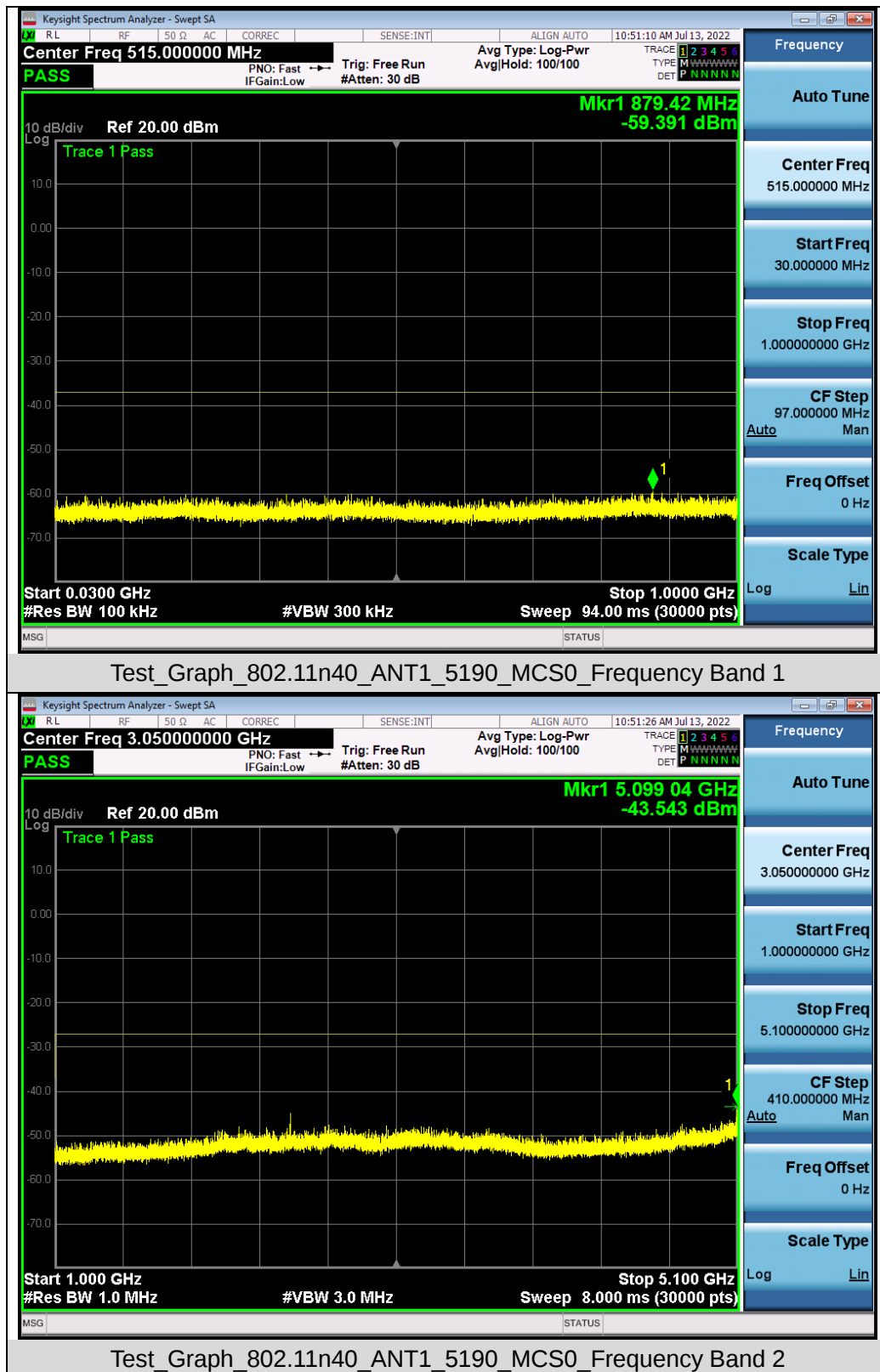

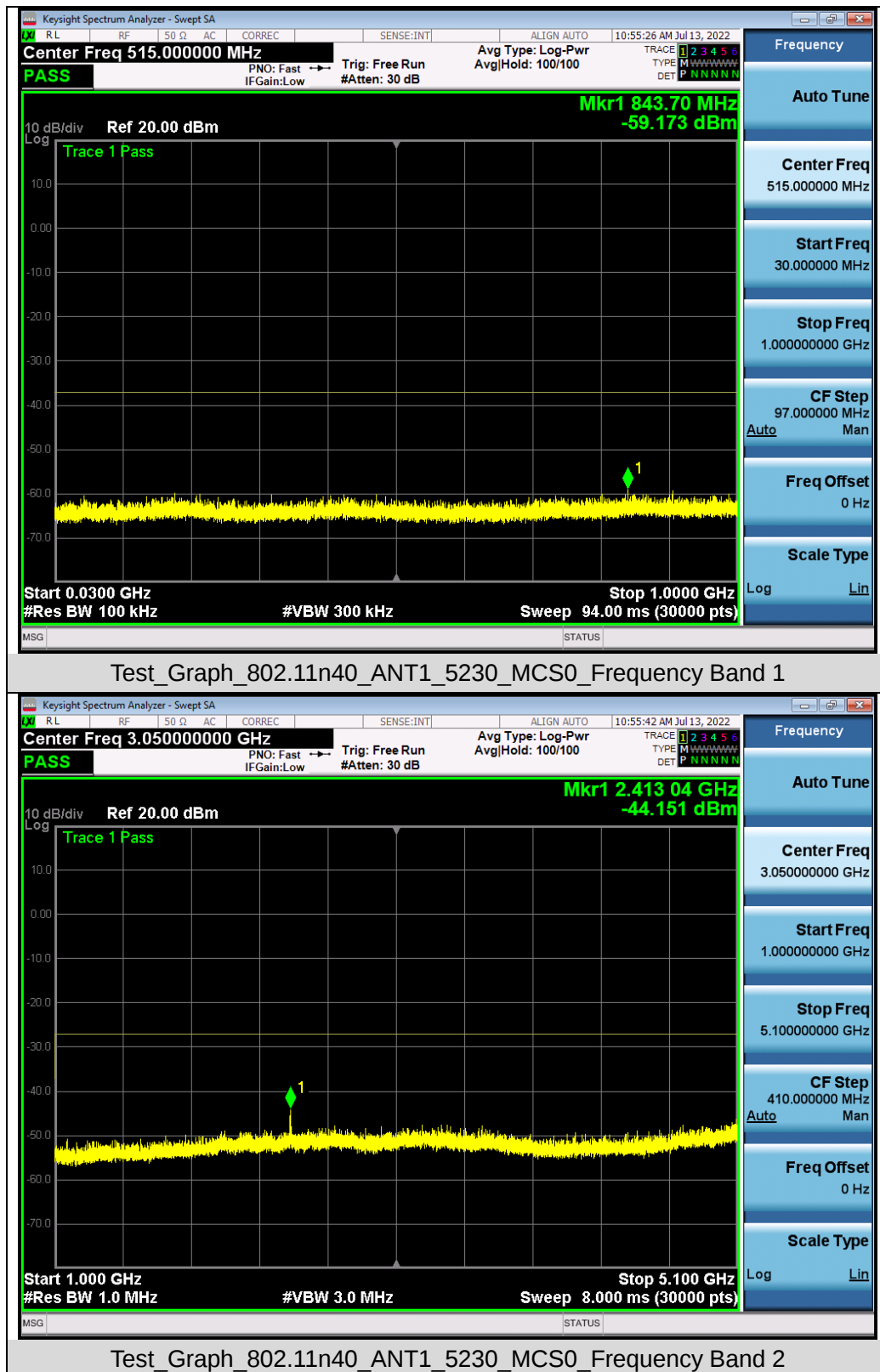


Test_Graph_802.11n40_ANT1_5190_MCS0_Frequency Band 3

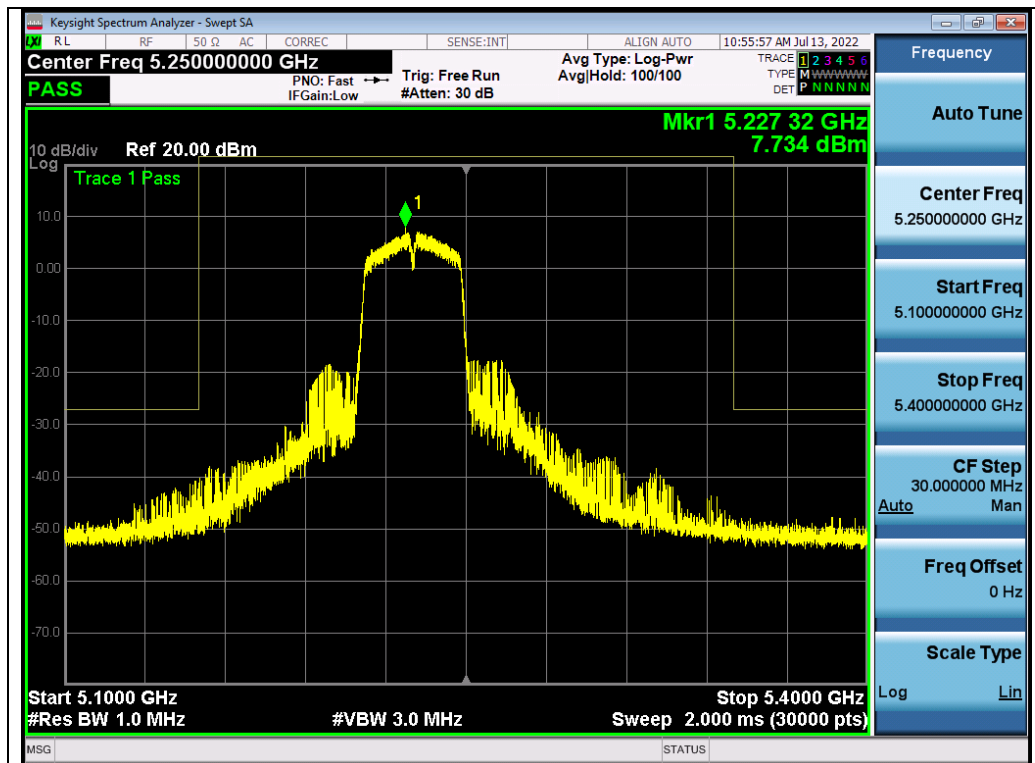

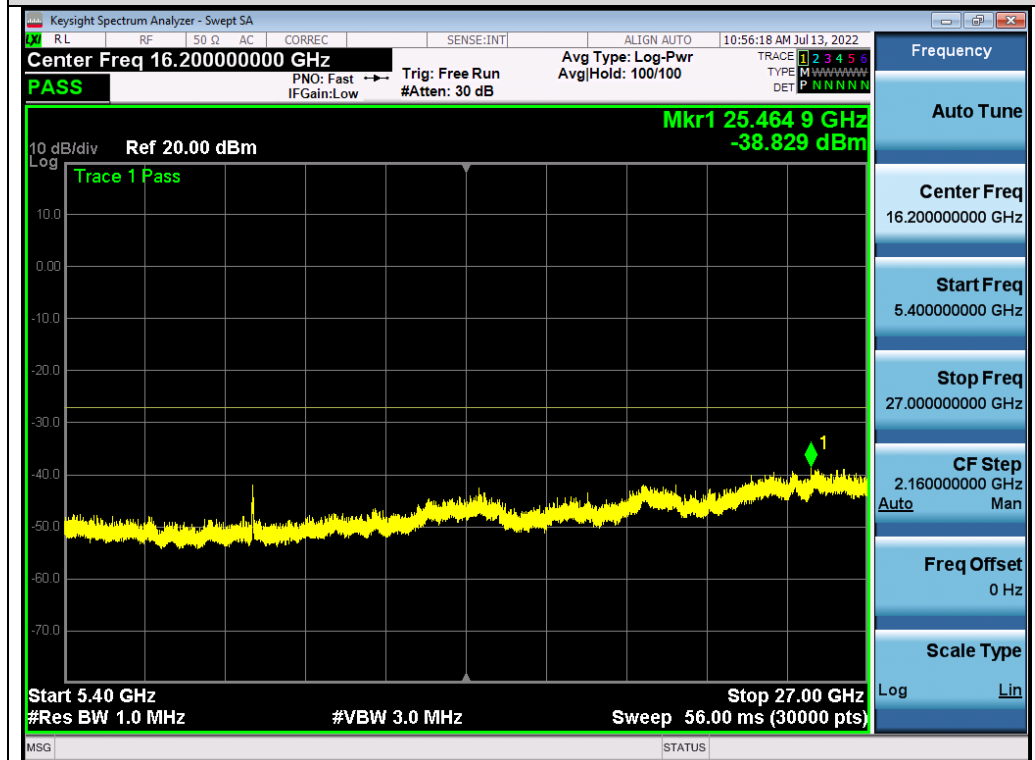

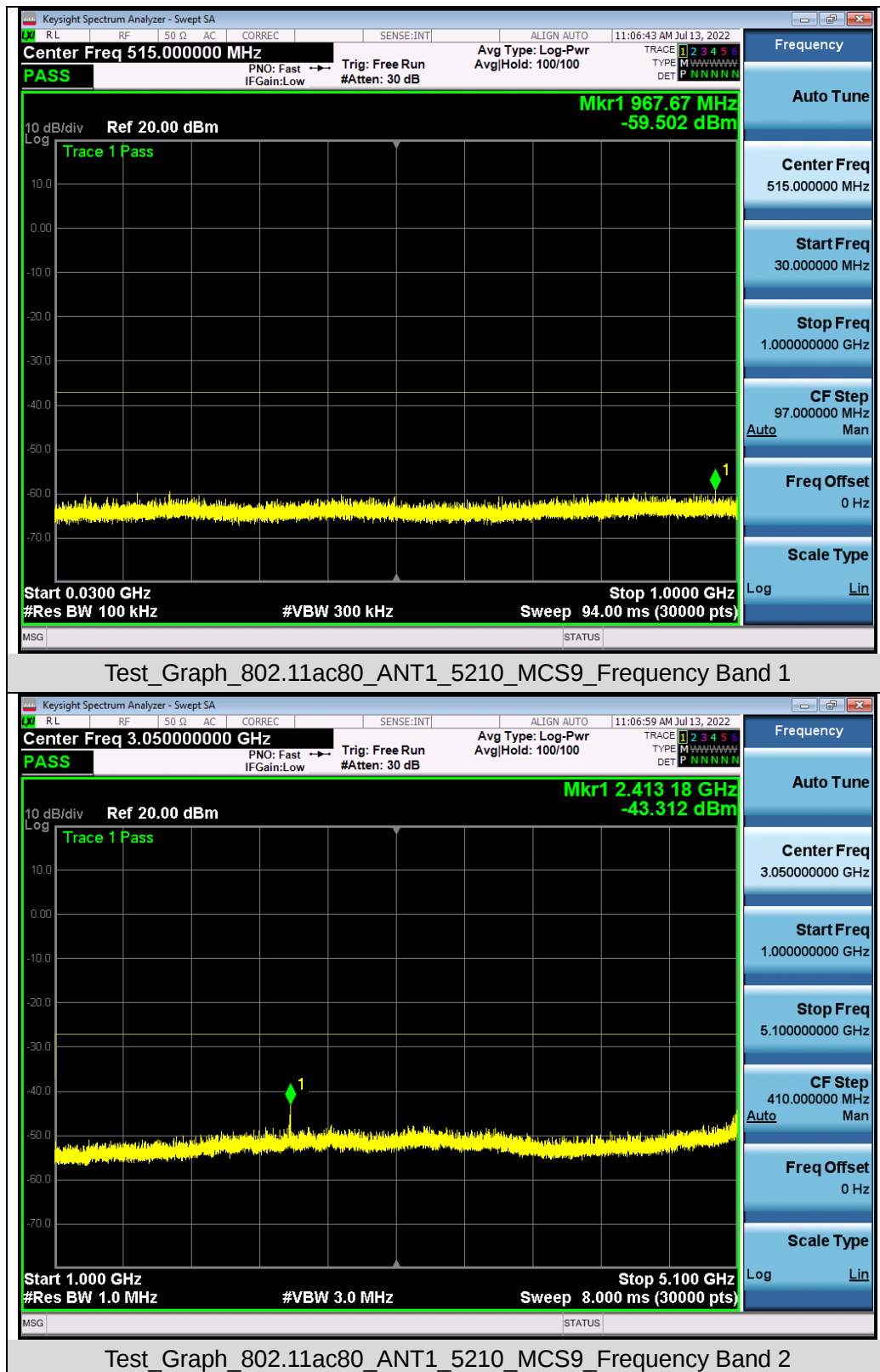


Test_Graph_802.11n40_ANT1_5230_MCS0_Frequency Band 3

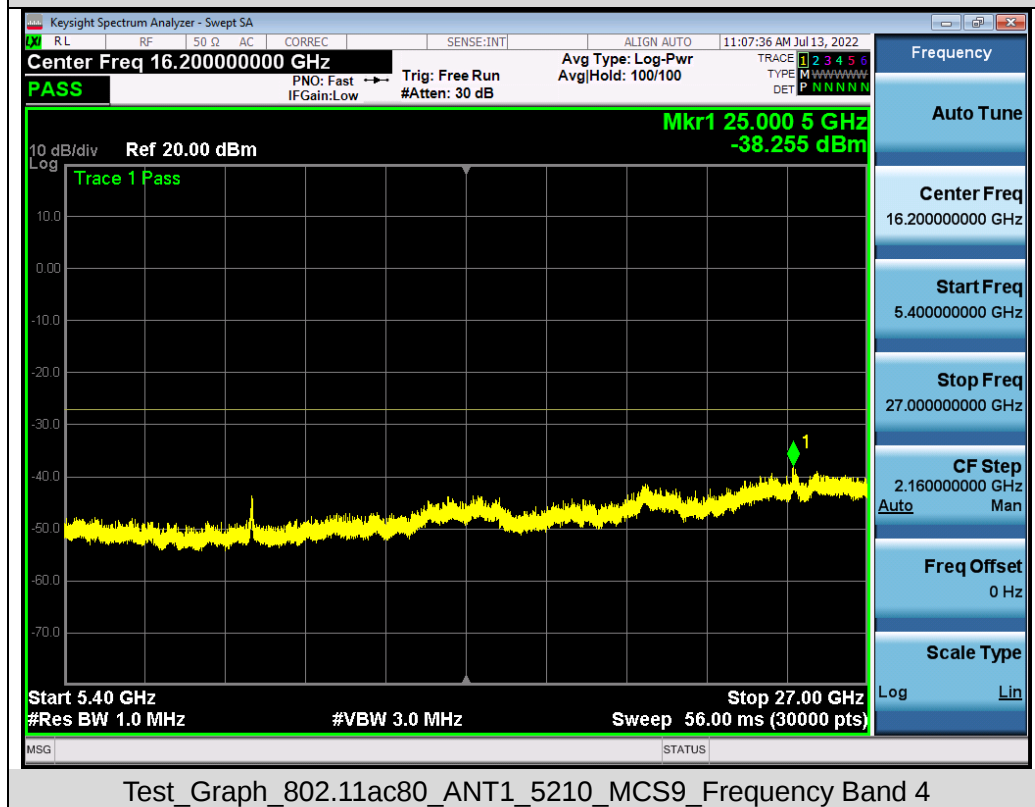

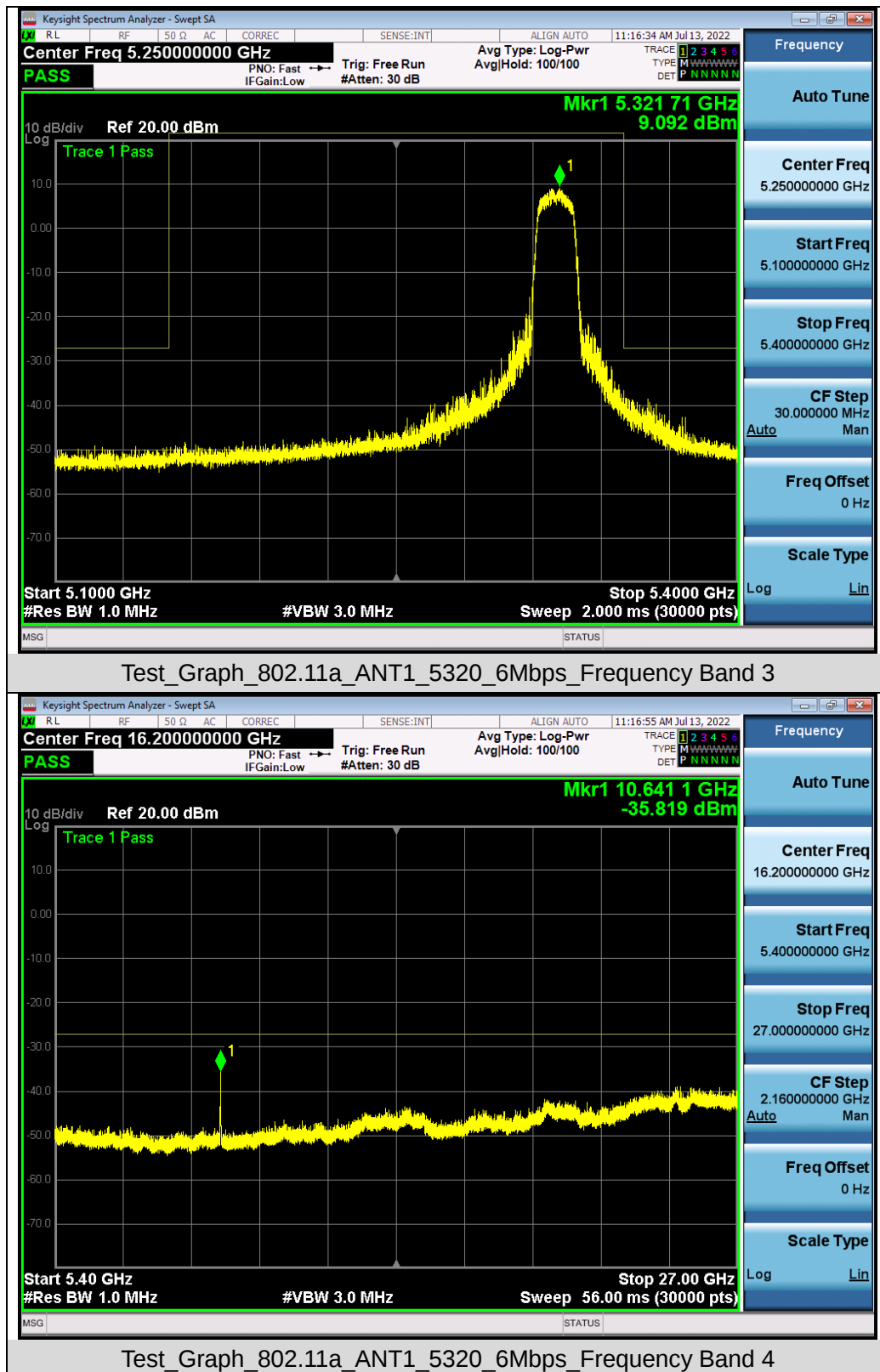


Test_Graph_802.11a_ANT1_5320_6Mbps_Frequency Band 1

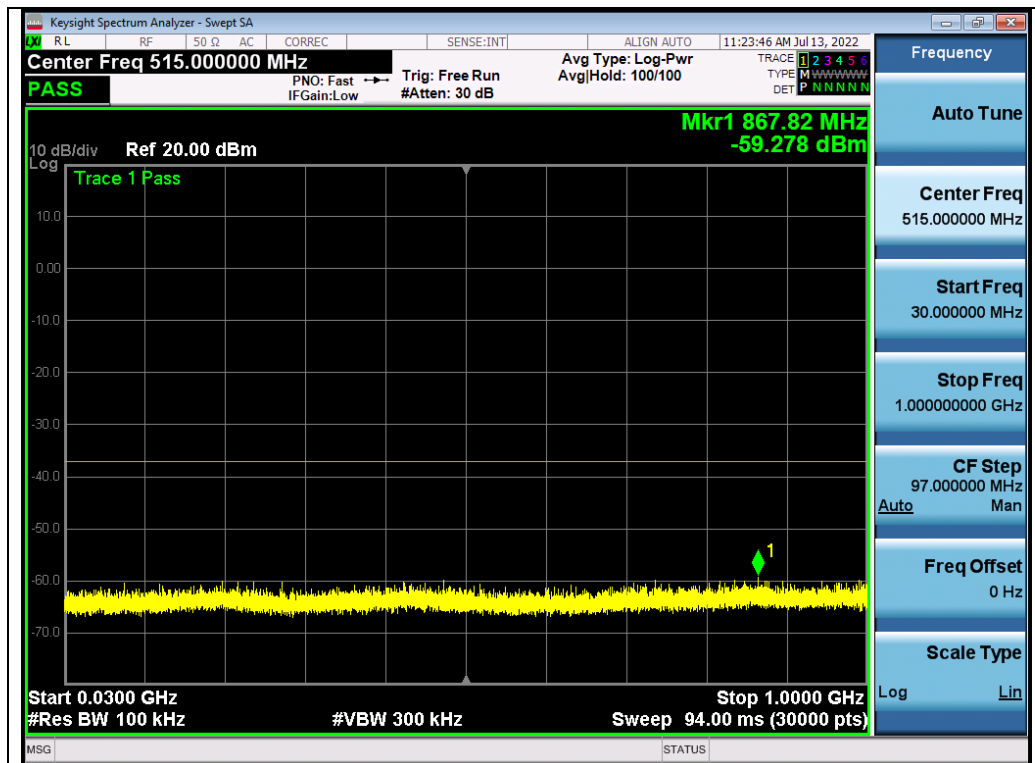

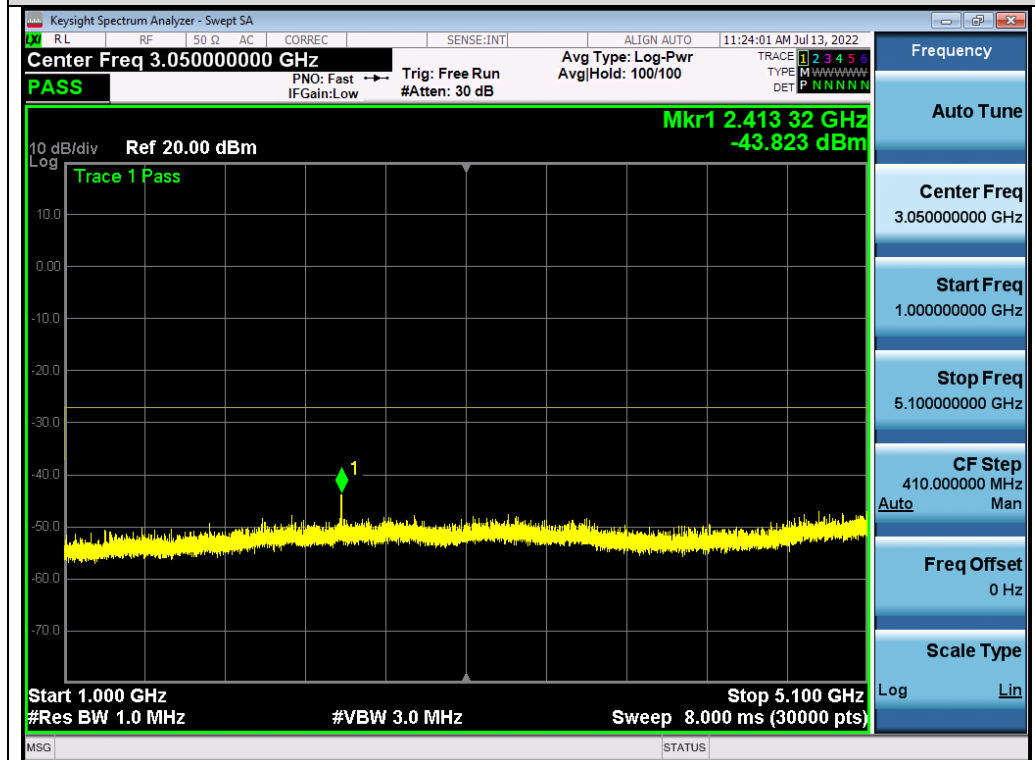

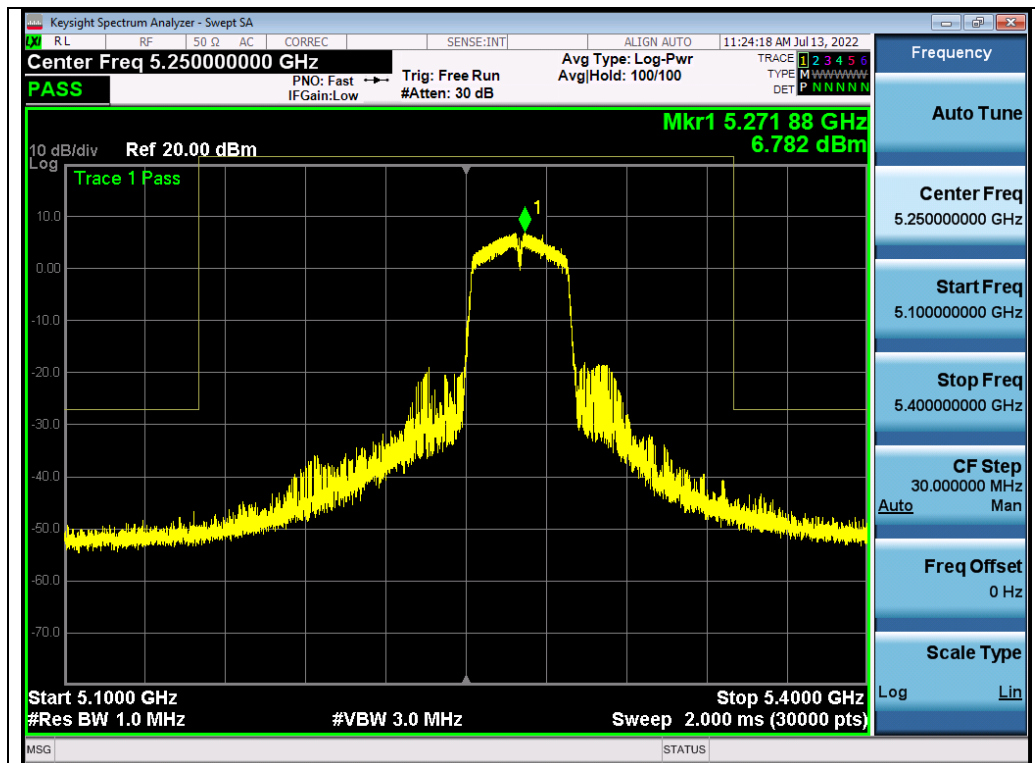


Test_Graph_802.11n40_ANT1_5270_MCS0_Frequency Band 1

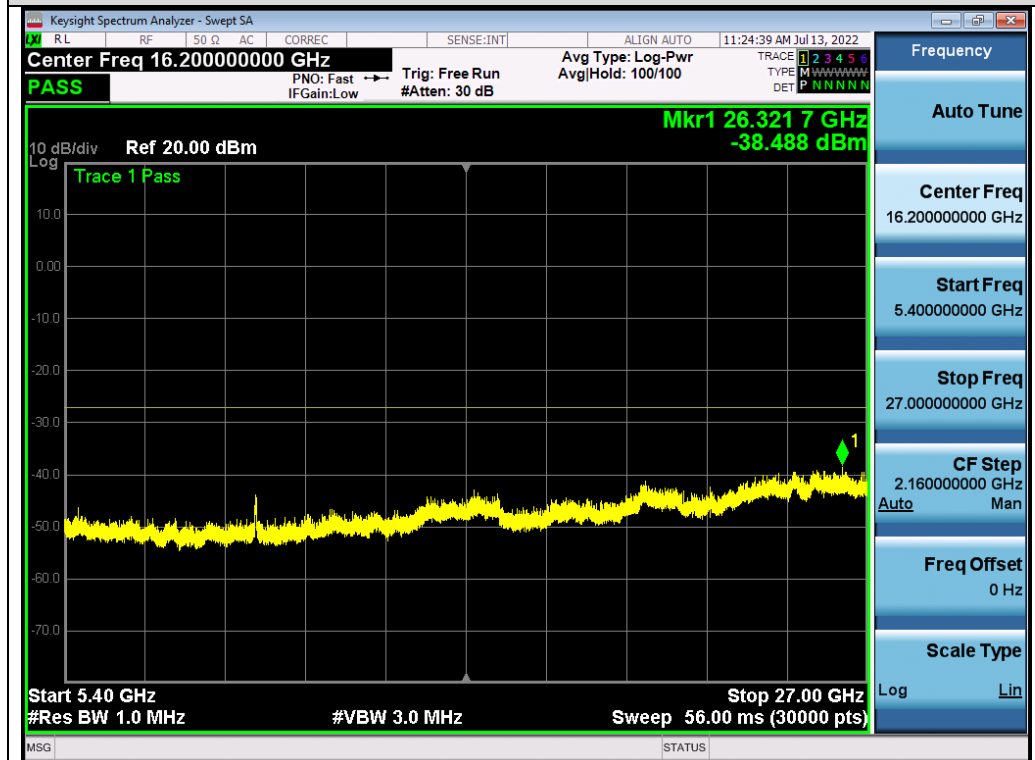

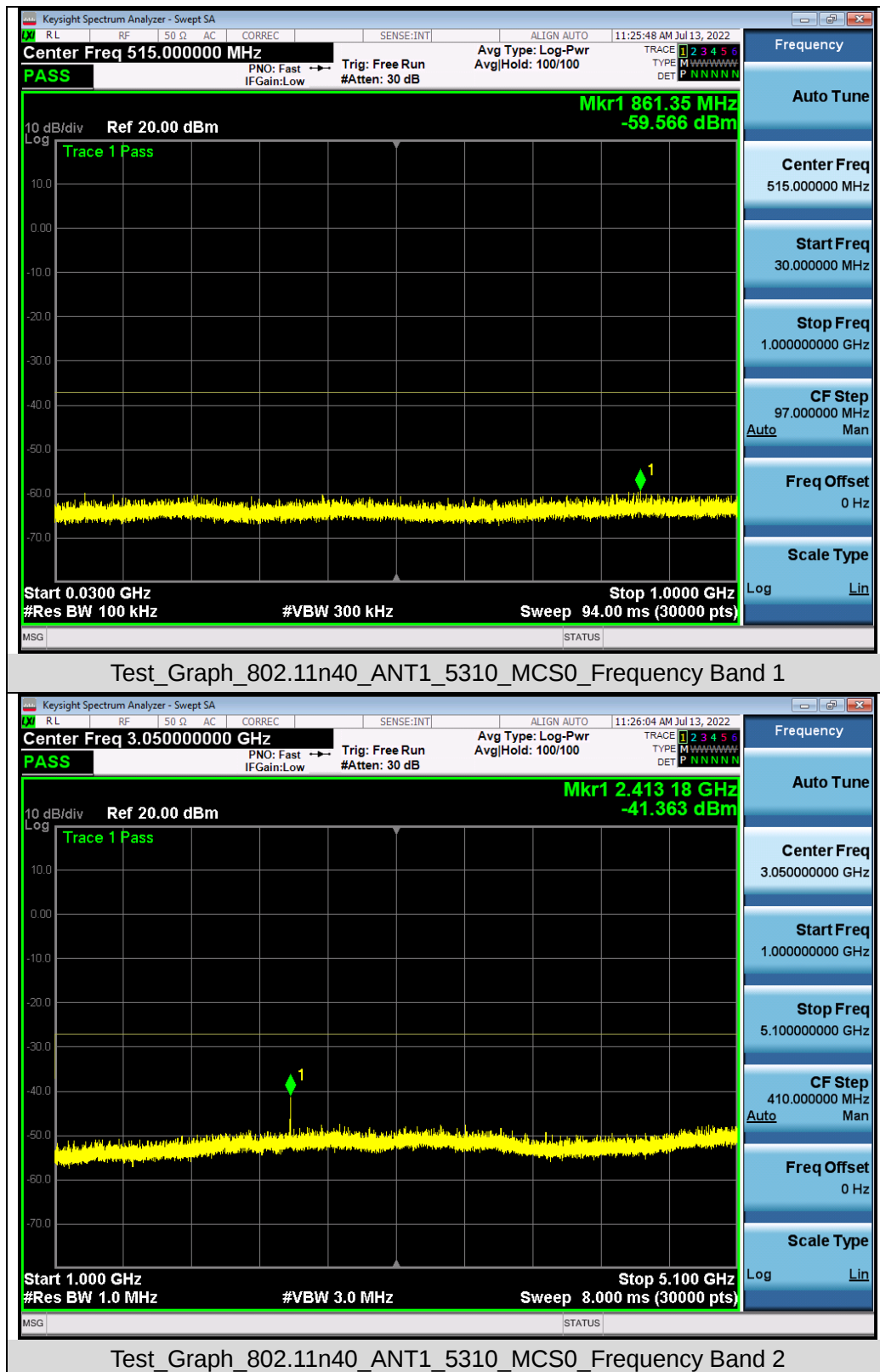


Test_Graph_802.11n40_ANT1_5270_MCS0_Frequency Band 3

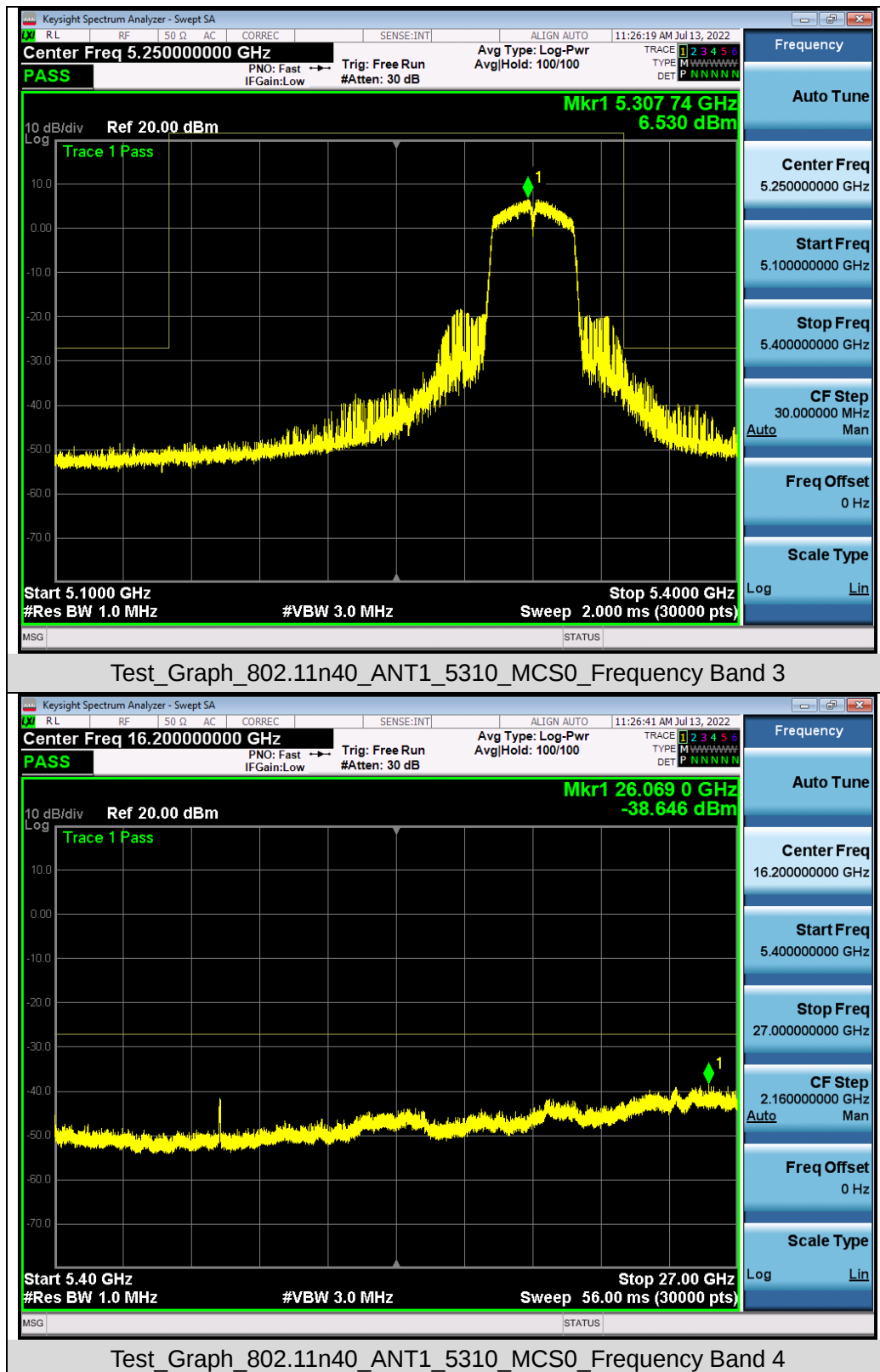

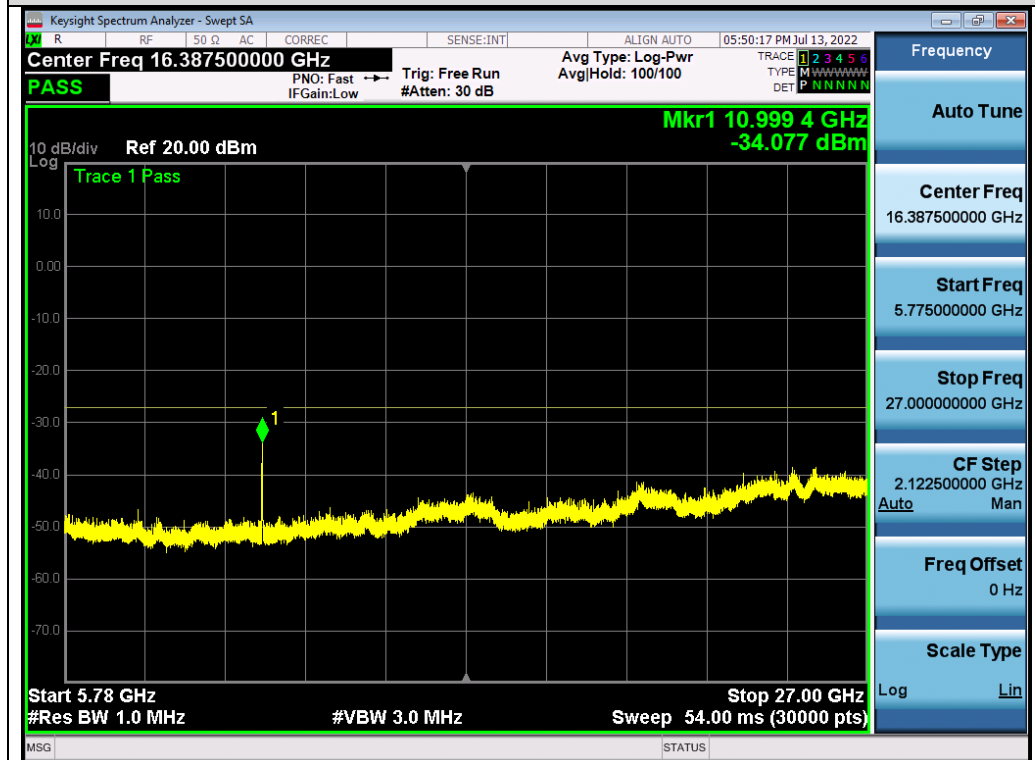
Test Graphs of Spurious Emissions outside of the 5.47-5.725 GHz band for transmitters operating in the 5.47-5.725 GHz band

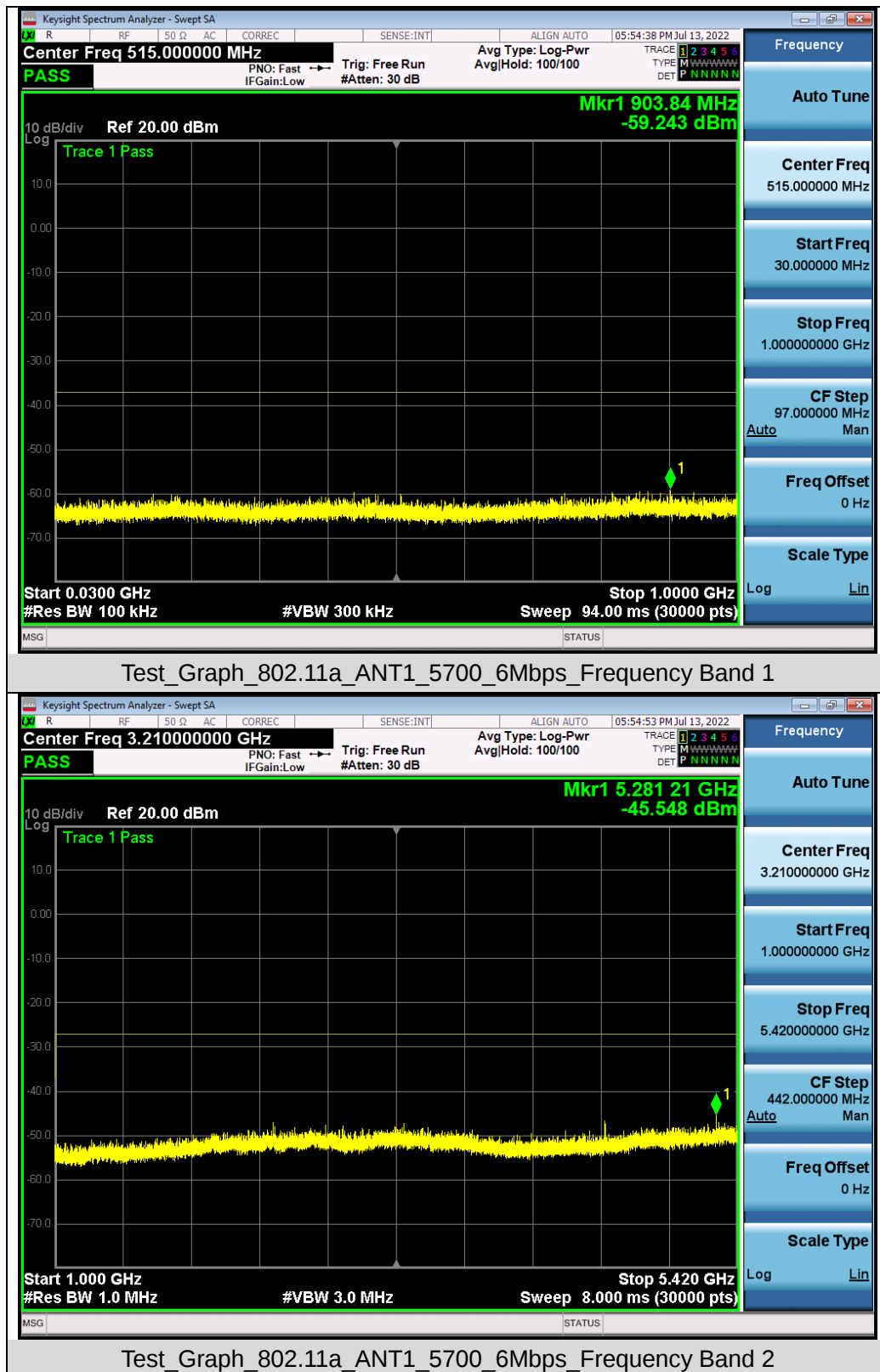


Test_Graph_802.11a_ANT1_5500_6Mbps_Frequency Band 3

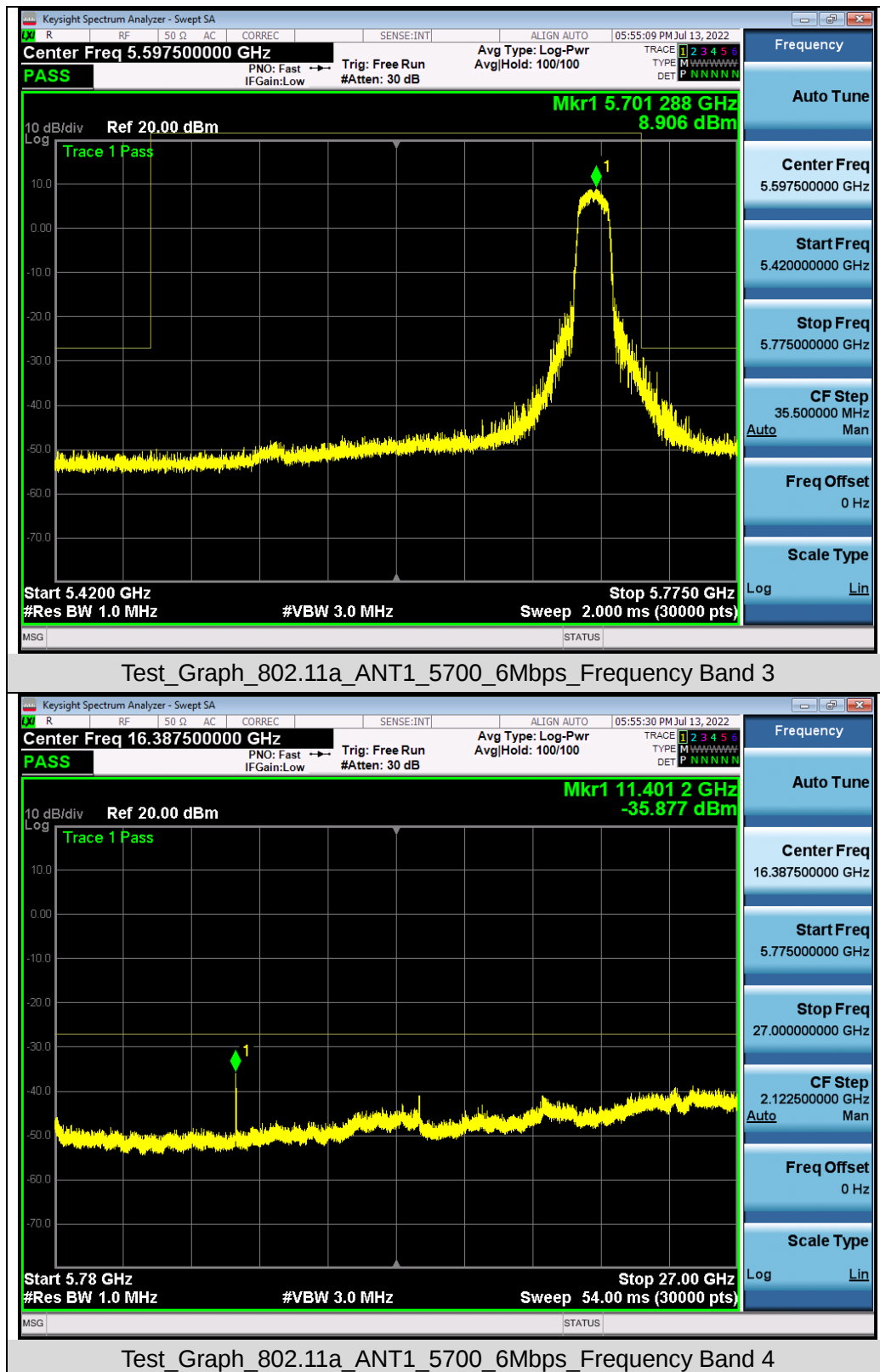

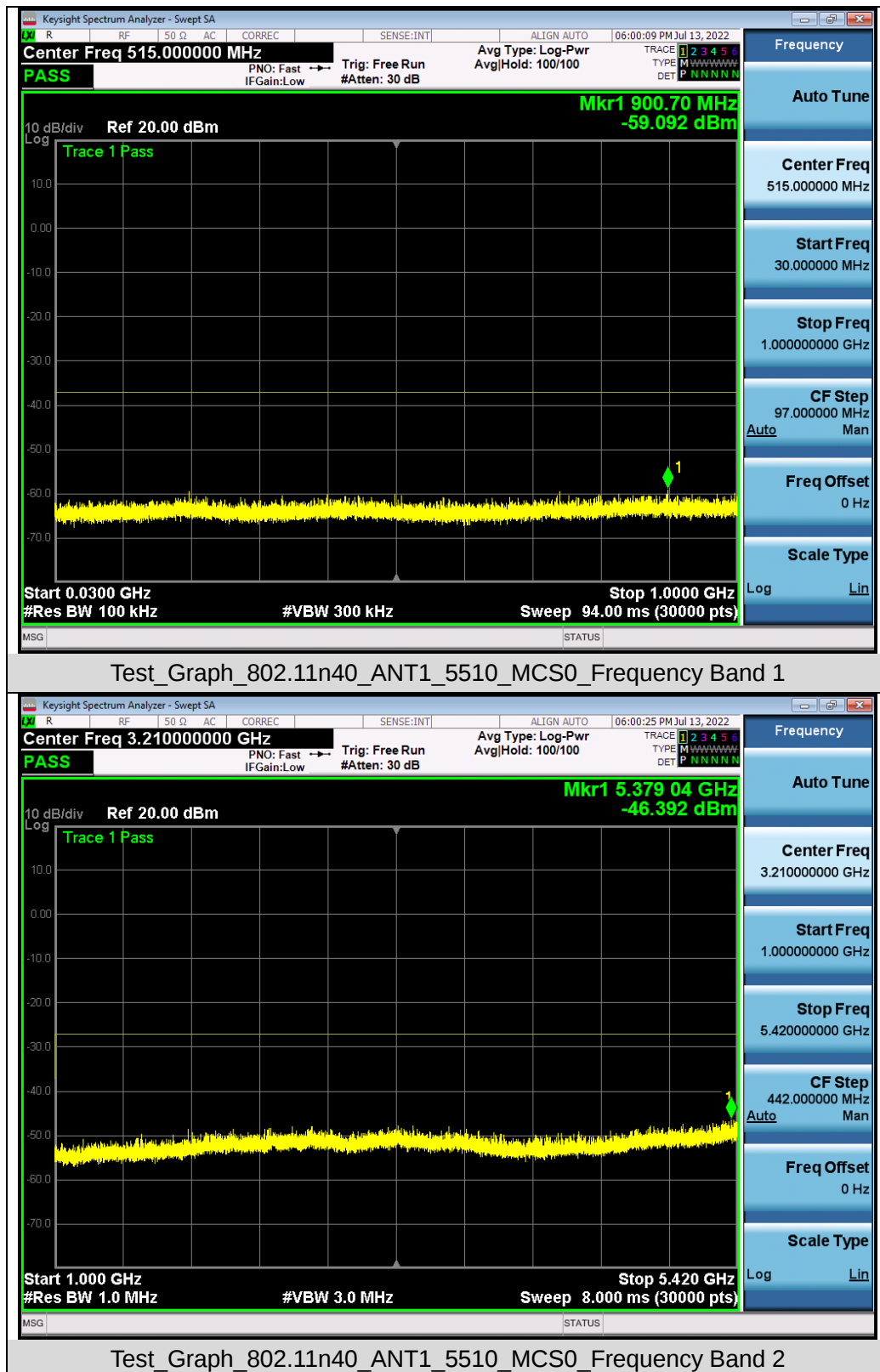
