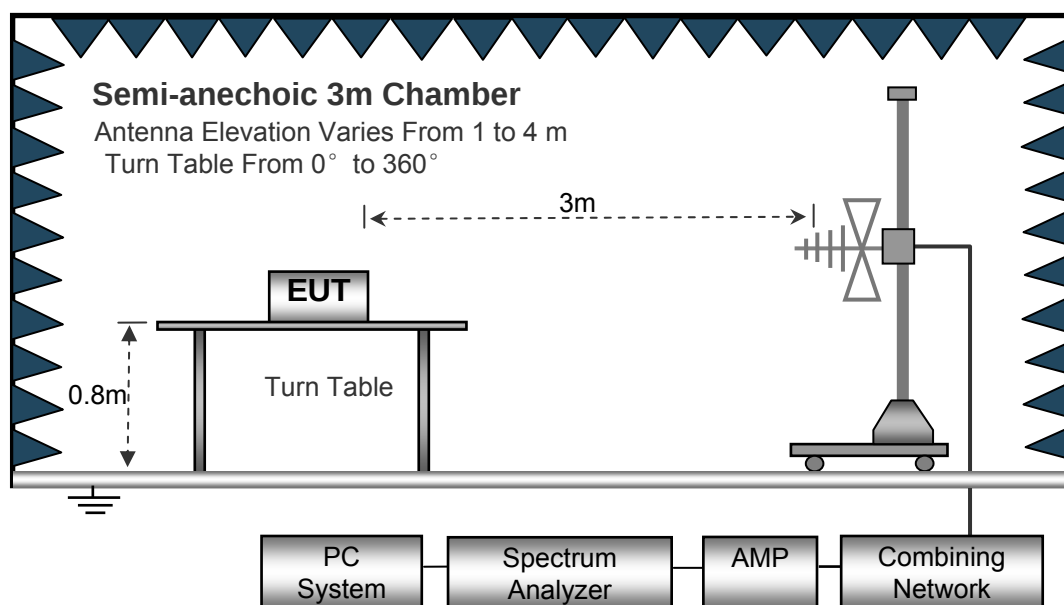

The radiated emission tests were performed in the 3m Semi- Anechoic Chamber test site, using the setup accordance with the ANSI C63.4.

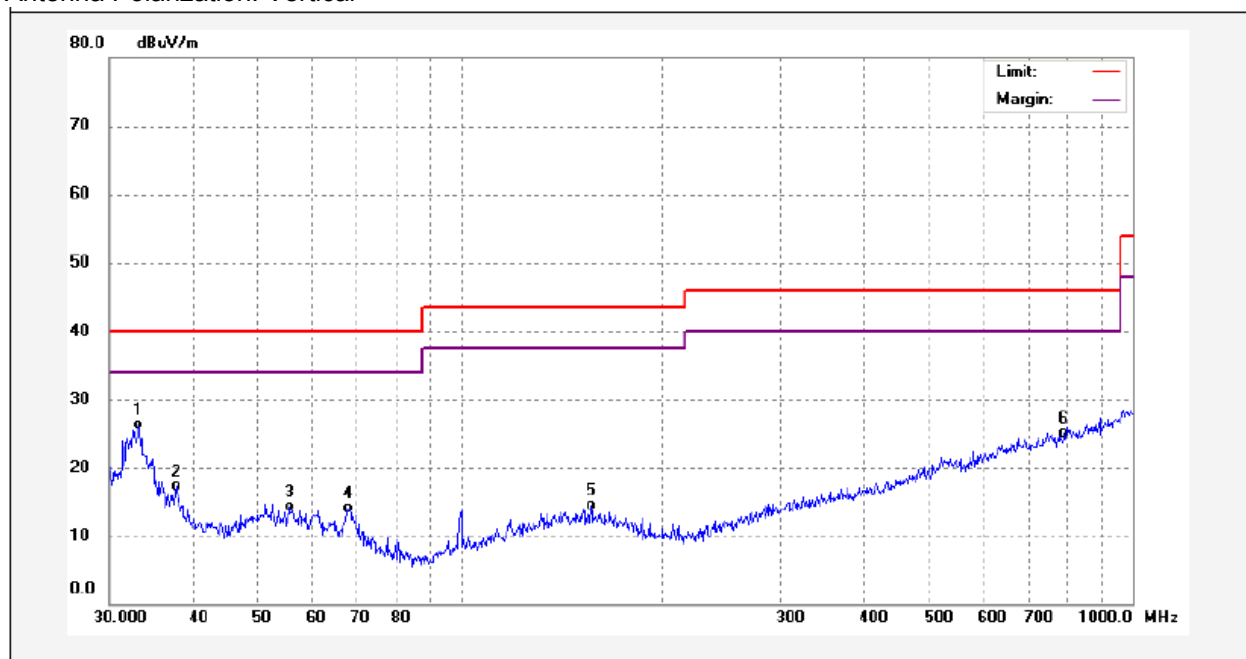


6.1.3 Measurement Data

The maximised peak emissions from the EUT was scanned and measured for both the Antenna Vertical Polarization and Antenna Horizontal Polarization. Quasi-peak measurements were performed if peak emissions were within 6dB of the Quasi-peak limit line.

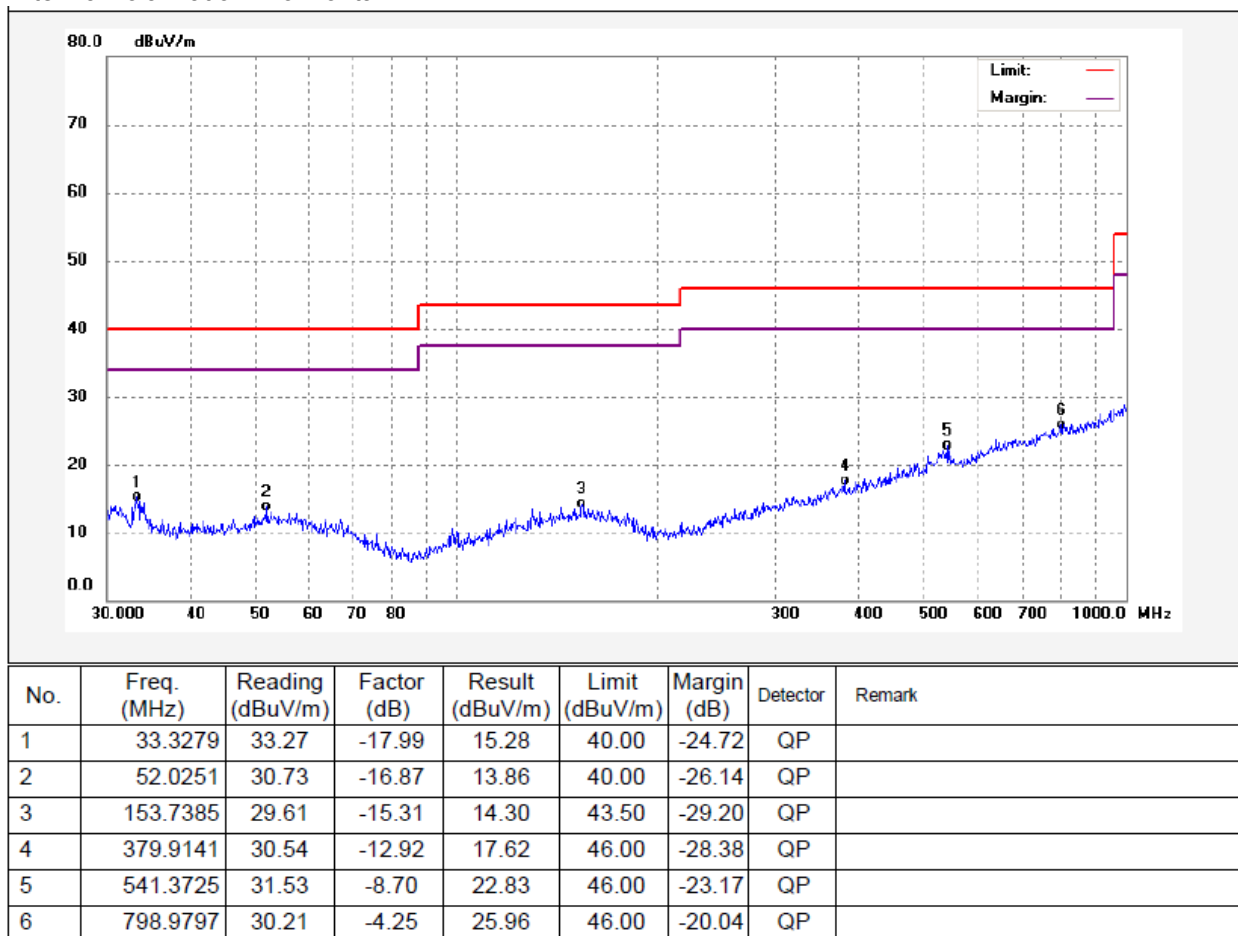

Antenna Polarization: Horizontal



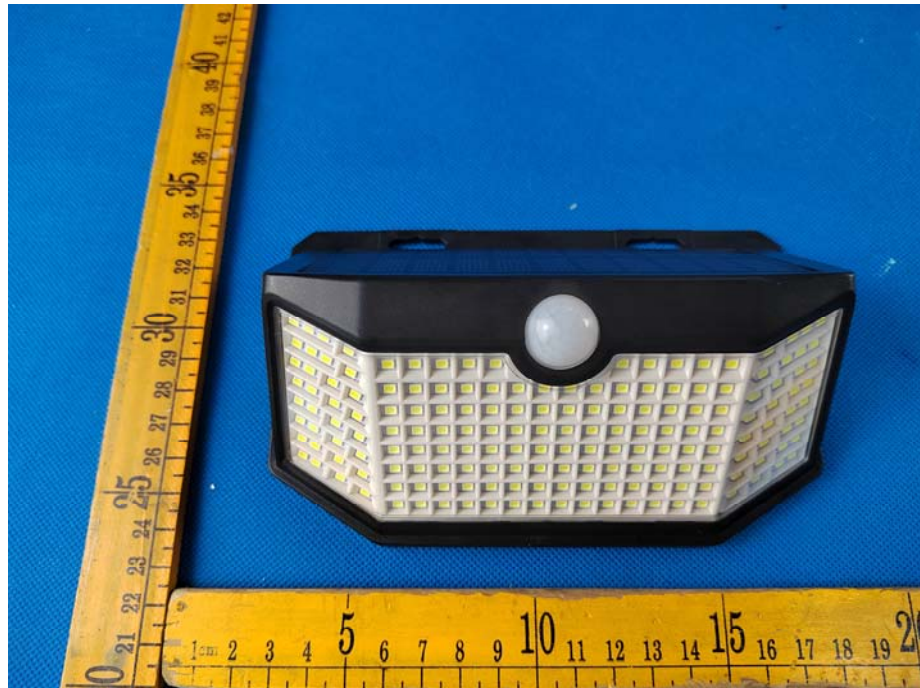

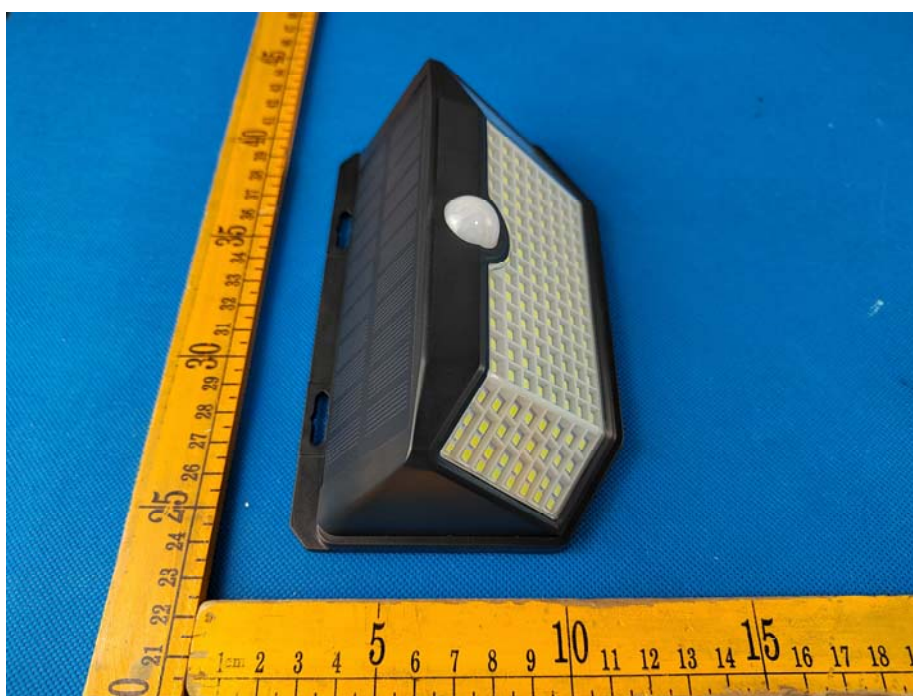
7.1 Photograph – Radiated Emission Test Setup For 30MHz-1000MHz

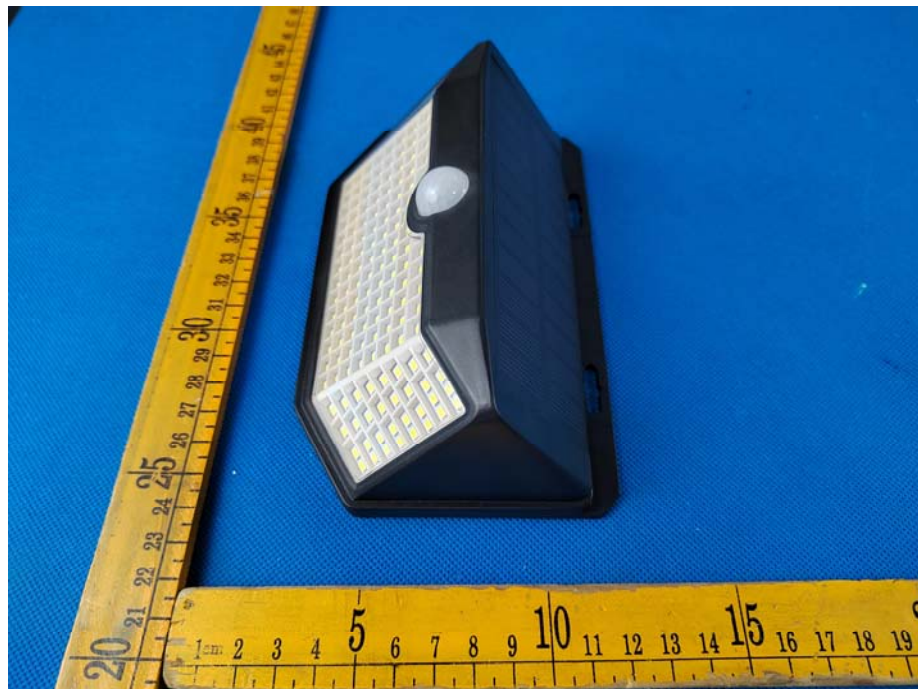
