Conducted Spurious Emission on Channel 4182

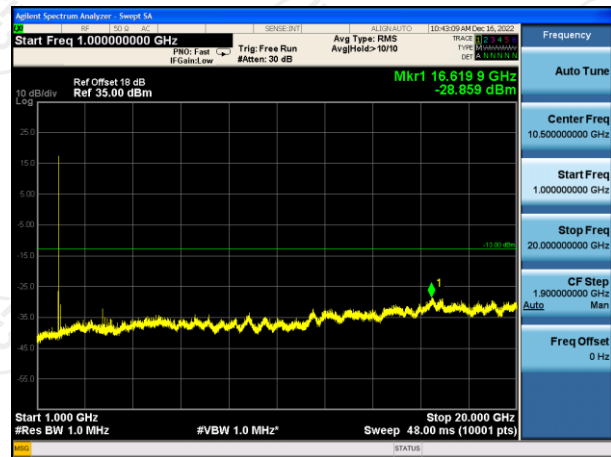
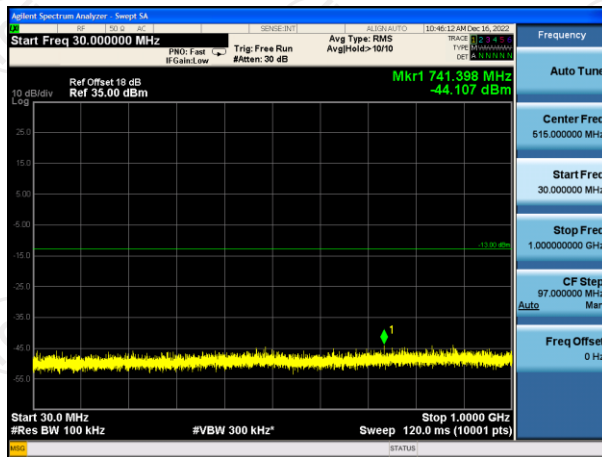

The radiated emission at the fundamental frequency was measured at 3 m with a test antenna and a spectrum analyzer with RMS detector per section 5. of KDB 971168 D01v03. - Key the transmitter, then rotate the EUT 360° azimuthally and record spectrum analyzer power level (LVL) measurements at angular increments that are sufficiently small to permit resolution of all peaks. 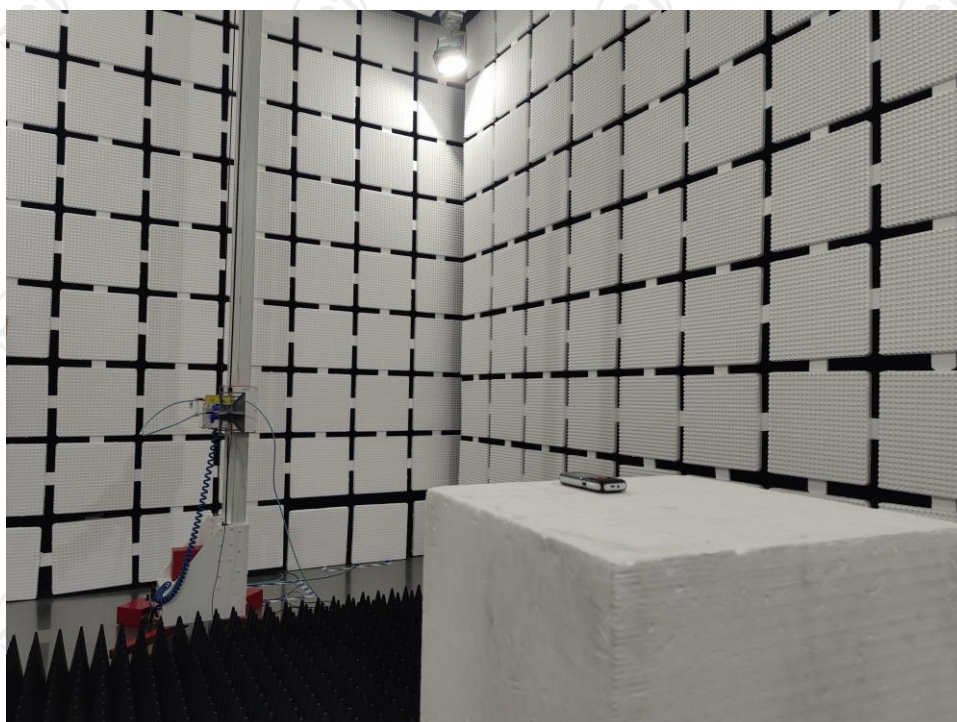
