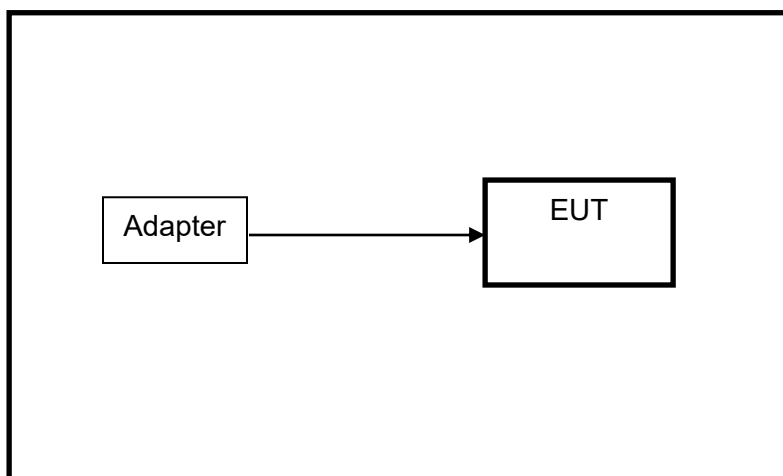

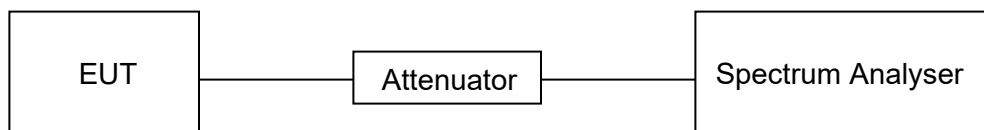

Set the center frequency of the instrument to the center frequency of the transmission. Set $RBW \geq EBW$ if possible; otherwise, set RBW to the largest available value. Set $VBW \geq RBW$. Set detector = peak or average. The zero-span measurement method shall not be used unless both RBW and VBW are $> 50/T$, where T is defined in II.B.1.a), and the number of sweep points across duration T exceeds 100. 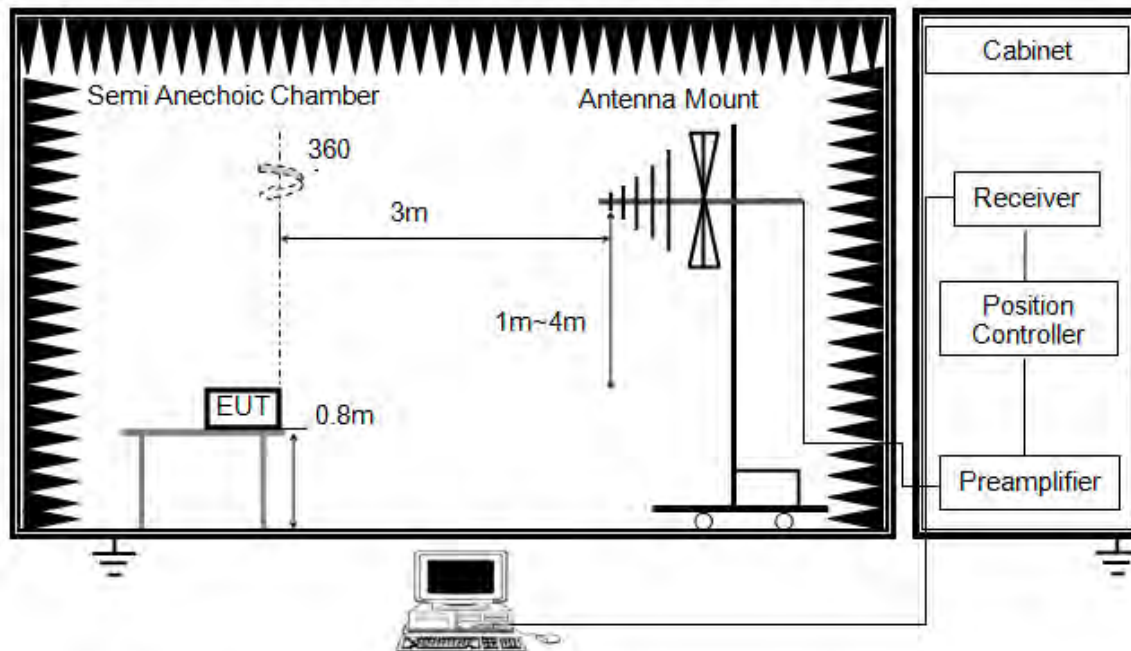

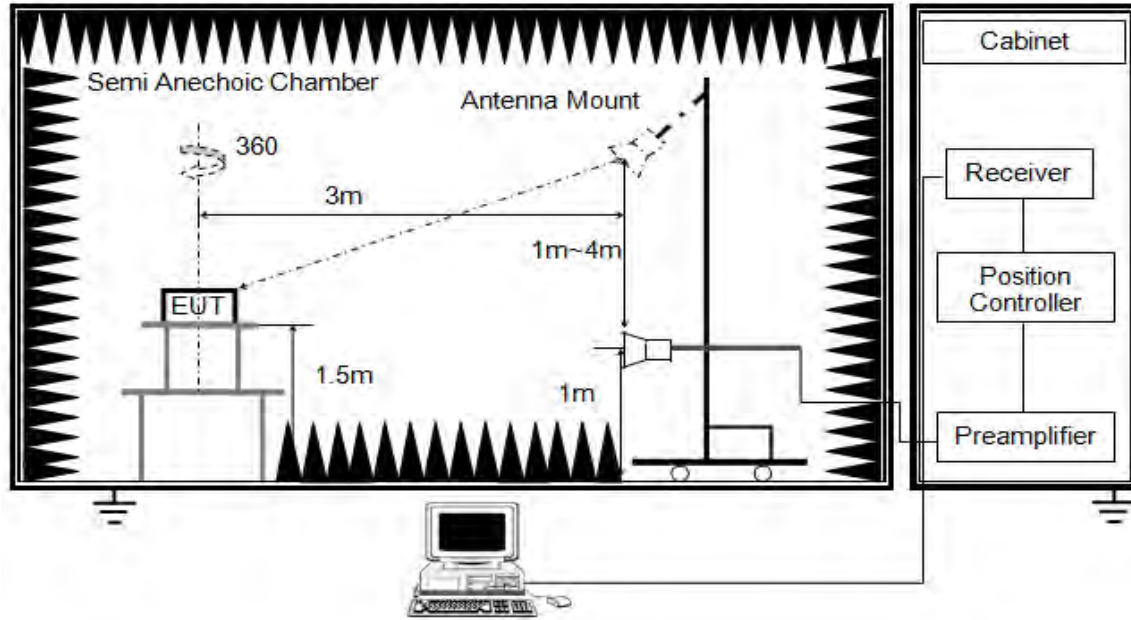

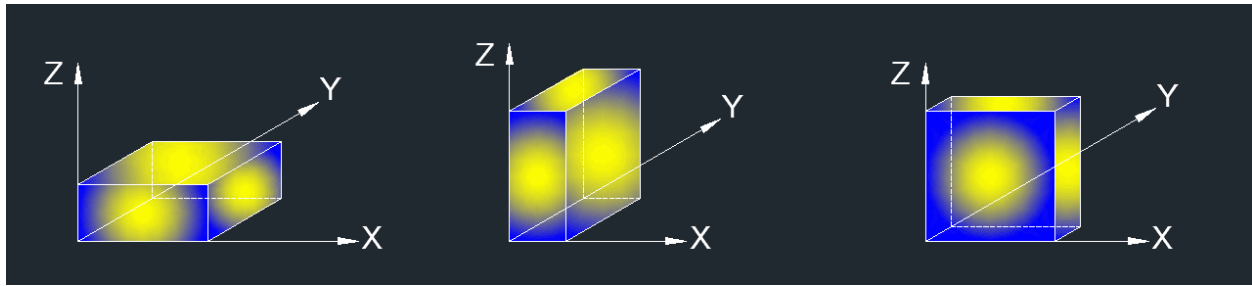
