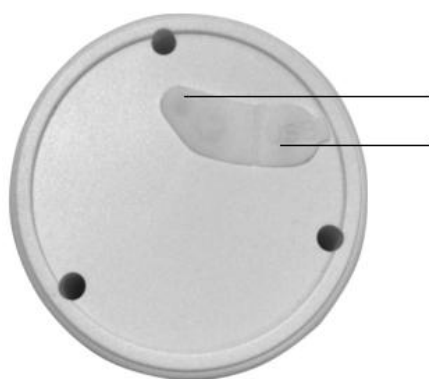

I Feature:

1. Version 5.0 intelligent bluetooth chip set with low power consumption,quick and stable connection.
2. Memorizing the item played last time automatically,breakpoint continuous.
3. Supporting function like wireless connection with mobile phone's general bluetooth, IPX6 water/spray proof.

II Operation of Bluetooth:

- 1.Long press the multi-function button for 3 seconds to turn on the speaker.
- 2.Open the Bluetooth of the device and click the pairing name for connection. If the device has been paired, it will automatically connect.



1	Multifunction Button (MFB): On/off, pause, play
2	Micro USB Charging Port

Note: If bluetooth is temporarily disconnected , the WF02 speaker automatically tries to restore the connection. If the connection cannot be restored after 3 seconds, try again by pressing the multifunctional button for 3 seconds.

3.During the music playing, you can short press the multifunction button to play/pause your music player.

4.The distance of barrier-free range of the bluetooth is about the 10 meters.

IV Charging the battery with Micro-USB cable:

- Step 1: Insert USB charging cable into USB port of PC.
- Step 2: Connect charging cable with the charging port of speaker.
- When the red light is on, the speaker is charging.
- When the light is off, the speaker is charged fully.
