2D POLAR RADIATION PATTERN

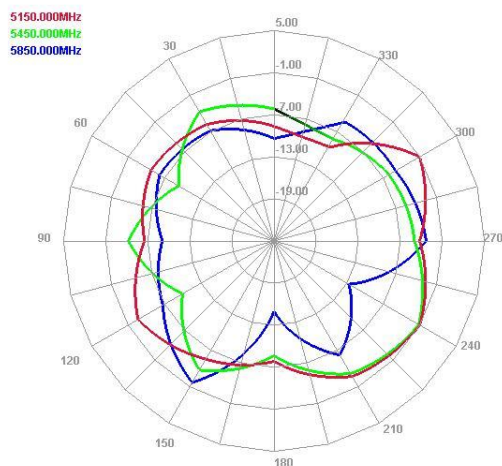
