Setting Up Your Tile App

To begin using your Tile, please follow these instructions:

1. Download the Tile app from the Apple App Store
2. Open the Tile app and register for an account
3. Enter your email address
4. Create and enter a password
5. Open your email and confirm your email address and newly created password
6. Open the app and log in with your email address and newly created password
7. Follow the prompts to allow Tile access to Bluetooth® and Location Finding so you can see your Tiles on a map

Linking Your Tiles to the App

Adding a Tile to your app is easy, just follow these quick instructions for each new Tile that you would like to use:

1. Add a Tile: select the + button to add a Tile

2. Press the "e" button firmly on the Tile until you hear it play a tune

3. Place the Tile on your device as directed by the app
