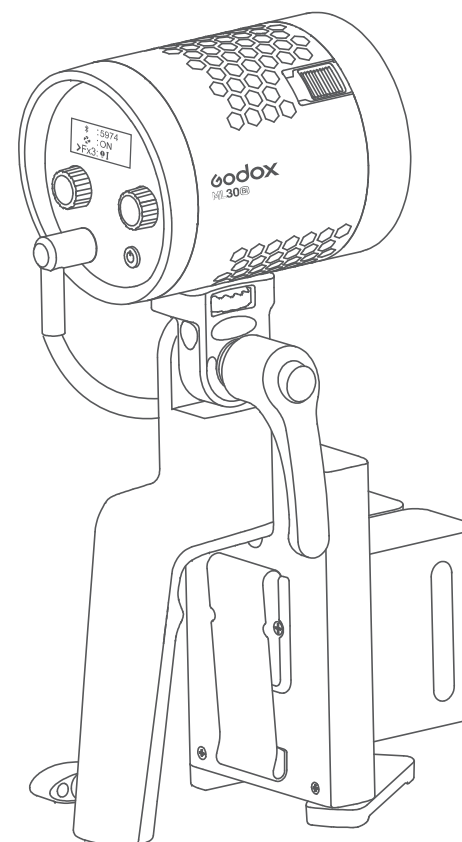

Do not disassemble. Should repairs become necessary, this product must be sent to an authorized maintenance center.

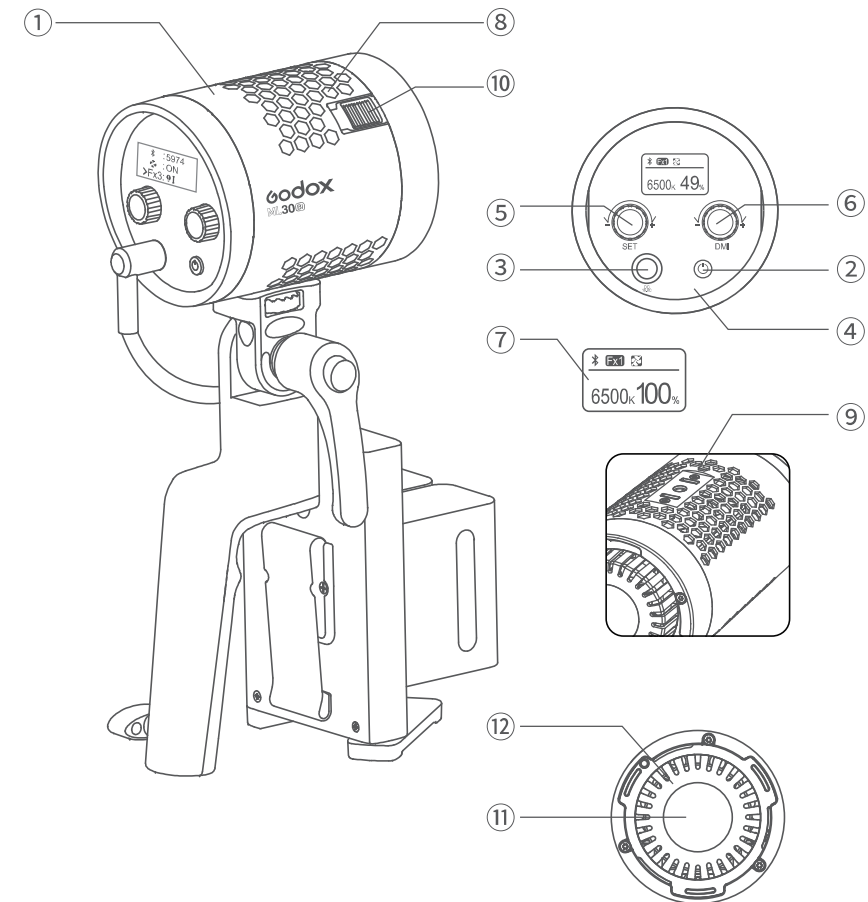

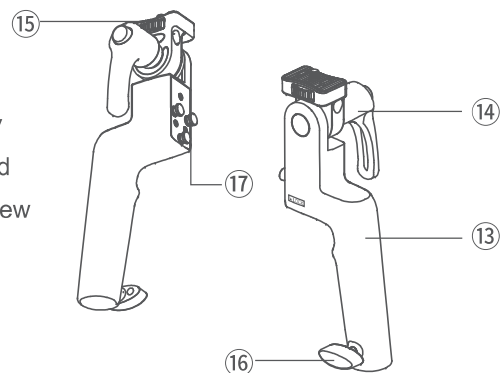

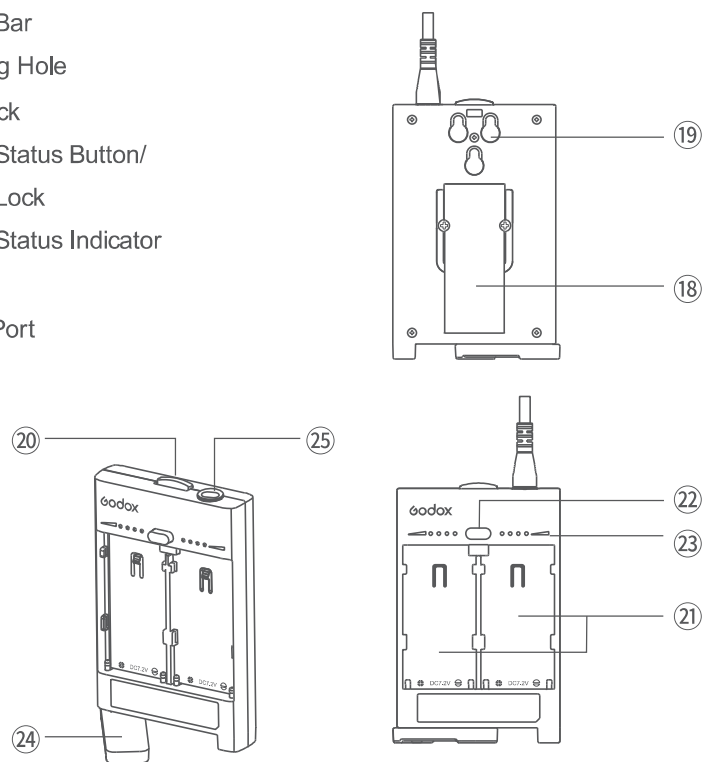

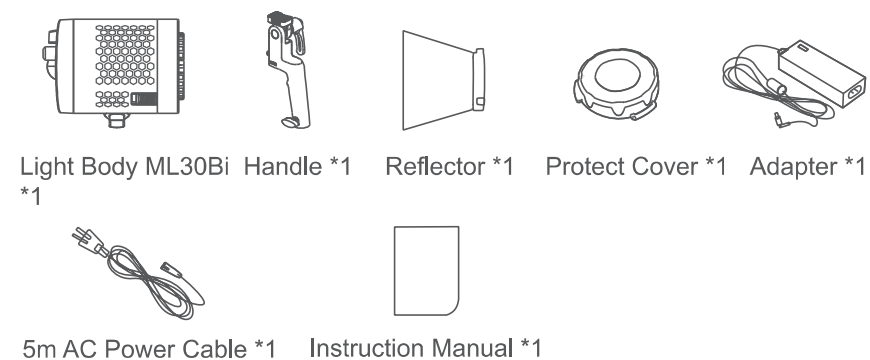

Power Management

Power supply

Adapter power supply: input: 100-240V~50/60Hz 2A, output: 16.8V 4.2A.

External battery power supply: install two NP-F970 batteries into the battery compartment. Then, use DC power cable to connect the battery case with the light body to achieve power supply.

The battery case can only offer battery discharging instead of charging. When powered by battery box, two batteries shall be used simultaneously. Please do not use one battery individually.

Operation

1. Power on

Press the power switch to control the ON/OFF of the light, and the OLED display will show the current information

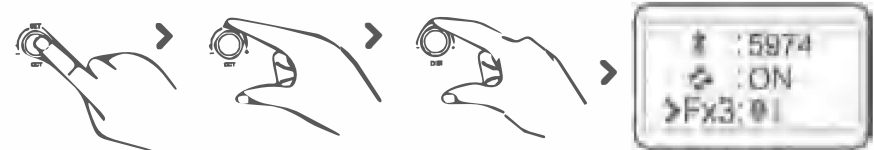

2. Mode selection: Bi-color mode/FX Special Effects mode

Color temperature mode: the main interface displays the color temperature mode

2.1.1 Color temperature adjustment: Rotate the CCT/SET knob on the main interface to adjust the color temperature (2800~6500K). Normally rotate 100 unit values, and quickly rotate 500 unit values.

2.1.2 Brightness adjustment: Select the DIM dial to adjust brightness from 0% to 100%
