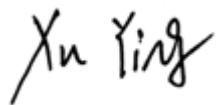

1. The EUT is sent from the applicant to TA and the information of the EUT is declared by the applicant.
2. This device support automatically discontinue transmission, while the device is not transmitting any information, the device can automatically discontinue transmission and become standby mode for power saving. The device can detect the controlling signal of ACK message transmitting from remote device and verify whether it shall resend or discontinue transmission.
3. (a) Manufacturers implements security features in any digitally modulated devices capable of operating in any of the U-NII bands, so that third parties are not able to reprogram the device to operate outside the parameters for which the device was certified. The software prevents the user from operating the transmitter with operating frequencies, output power, modulation types or other radio frequency parameters outside those that were approved for the device. 4. Test Configuration

Test Mode

The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application.

The radiated emission was measured in the following position: EUT stand-up position (Z axis), lie-down position (X, Y axis). The worst emission was found in stand-up position (X axis) and the worst case was recorded.

In order to find the worst case condition, Pre-tests are needed at the presence of different data rate. Preliminary tests have been done on all the configuration for confirming worst case. Data rate below means worst-case rate of each test item.

5. Test Case Results

5.1. Unwanted Emission

Ambient condition

Method of Measurement

The test set-up was made in accordance to the general provisions of ANSI C63.10. The Equipment Under Test (EUT) was set up on a non-conductive table in the semi-anechoic chamber. The test was performed at the distance of 3 m between the EUT and the receiving antenna. The radiated emissions measurements were made in a typical installation configuration.

Sweep the whole frequency band range from 9kHz to the 10th harmonic of the carrier, and the emissions less than 20 dB below the permissible value are reported.

During the test, the height of receive antenna shall be moved from 1 to 4 meters, and the antenna shall be performed under horizontal and vertical polarization. The turntable shall be rotated from 0 to 360 degrees for detecting the maximum of radiated spurious signal level. The measurements shall be repeated with orthogonal polarization of the test antenna. The data of cable loss and antenna factor has been calibrated in full testing frequency range before the testing.

Set the spectrum analyzer in the following:

9kHz~150 kHz

RBW=200Hz, VBW=1kHz/ Sweep=AUTO

150 kHz~30MHz

RBW=9KHz, VBW=30KHz,/ Sweep=AUTO

Below 1GHz

RBW=100kHz / VBW=300kHz / Sweep=AUTO

a) Peak emission levels are measured by setting the instrument as follows:

Above 1GHz

PEAK: RBW=1MHz VBW=3MHz/ Sweep=AUTO

b) Average emission levels are measured by setting the instrument as follows:

Above 1GHz

AVERAGE: RBW=1MHz / VBW=3MHz / Sweep=AUTO

c) Detector: The measurements employing a CISPR quasi-peak detector except for the frequency bands 9-90 kHz, 110-490 kHz and above 1000 MHz. Radiated emission limits in these three bands are based on measurements employing an average detector.

d) Averaging type = power (i.e., rms) (As an alternative, the detector and averaging type may be set for linear voltage averaging. Some instruments require linear display mode to use linear voltage averaging. Log or dB averaging shall not be used.)

e) Sweep time = auto.

f) Perform a trace average of at least 100 traces if the transmission is continuous. If the transmission

is not continuous, then the number of traces shall be increased by a factor of $1 / D$, where D is the duty cycle. For example, with 50% duty cycle, at least 200 traces shall be averaged. (If a specific emission is demonstrated to be continuous—i.e., 100% duty cycle—then rather than turning ON and OFF with the transmit cycle, at least 100 traces shall be averaged.)

g) If tests are performed with the EUT transmitting at a duty cycle less than 98%, then a correction factor shall be added to the measurement results prior to comparing with the emission limit, to compute the emission level that would have been measured had the test been performed at 100% duty cycle. The correction factor is computed as follows:

1) If power averaging (rms) mode was used in the preceding step e), then the correction factor is $[10 \log (1 / D)]$, where D is the duty cycle. For example, if the transmit duty cycle was 50%, then 3 dB shall be added to the measured emission levels.

2) If linear voltage averaging mode was used in the preceding step e), then the correction factor is $[20 \log (1 / D)]$, where D is the duty cycle. For example, if the transmit duty cycle was 50%, then 6 dB shall be added to the measured emission levels.

3) If a specific emission is demonstrated to be continuous (100% duty cycle) rather than turning ON and OFF with the transmit cycle, then no duty cycle correction is required for that emission.

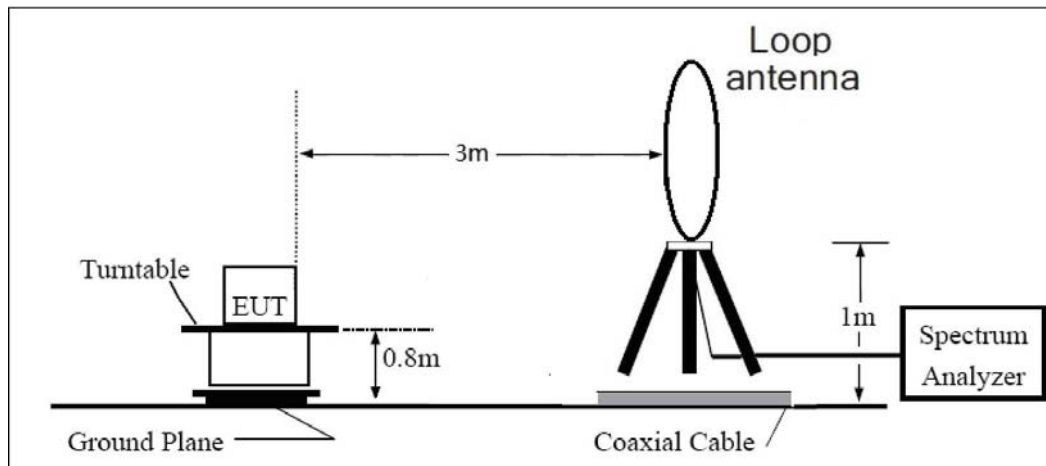
Reduce the video bandwidth until no significant variations in the displayed signal are observed in subsequent traces, provided the video bandwidth is no less than 1 Hz. For regulatory requirements that specify averaging only over the transmit duration (e.g., digital transmission system [DTS] and Unlicensed National Information Infrastructure [U-NII]), the video bandwidth shall be greater than $[1 / (\text{minimum transmitter on time})]$ and no less than 1 Hz.

The field strength of spurious emission was measured in the following position: EUT stand-up position (Z axis), lie-down position (X, Y axis). The worst emission was found in stand-up position (Z axis) and the loop antenna is vertical, others antenna are vertical and horizontal.

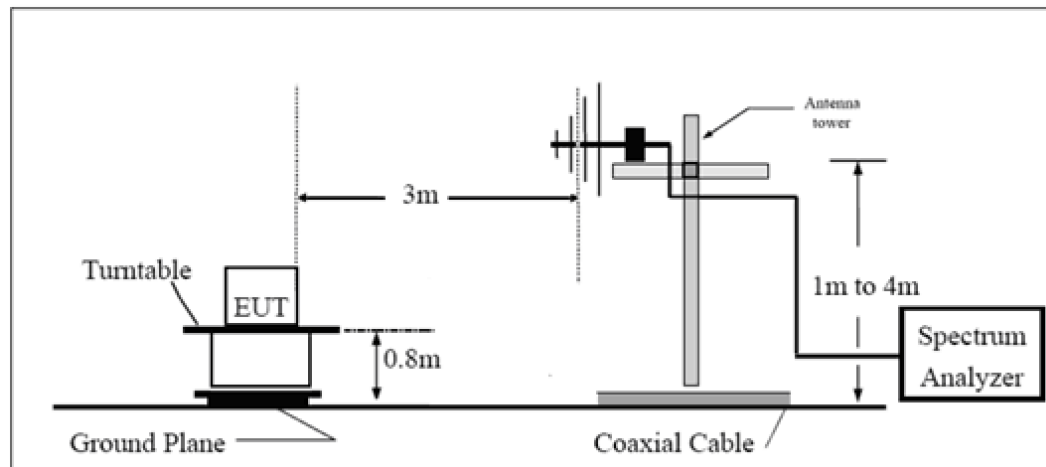

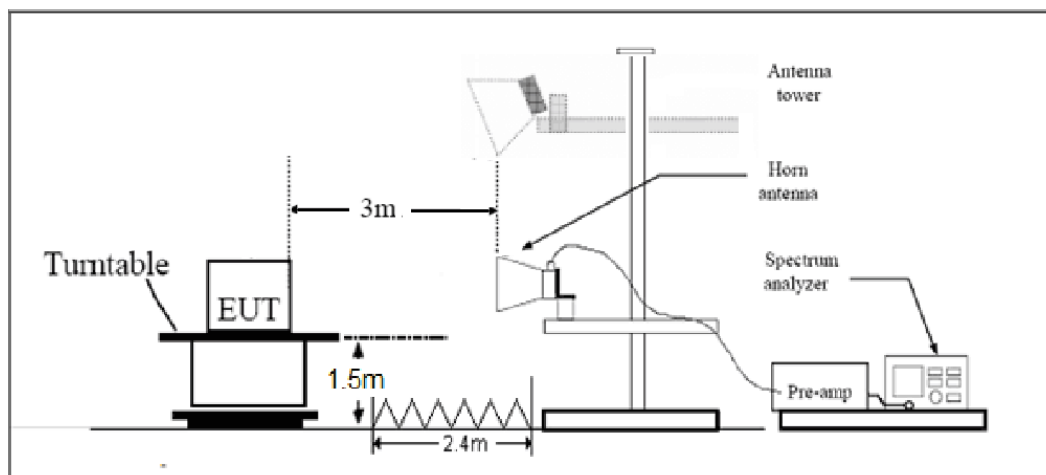

Limits

- (1) For transmitters operating in the 5725-5850 MHz band: All emissions shall be limited to a level of -27 dBm/MHz at 75 MHz or more above or below the band edge increasing linearly to 10 dBm/MHz at 25 MHz above or below the band edge, and from 25 MHz above or below the band edge increasing linearly to a level of 15.6 dBm/MHz at 5 MHz above or below the band edge, and from 5 MHz above or below the band edge increasing linearly to a level of 27 dBm/MHz at the band edge.
- (2) For transmitters operating in the 5.15-5.25 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz(68.2dBμV/m).
- (3) For transmitters operating in the 5.25-5.35 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz(68.2dBμV/m).
- (4) For transmitters operating in the 5.47-5.725 GHz band: All emissions outside of the 5.47-5.725 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz(68.2dBμV/m).

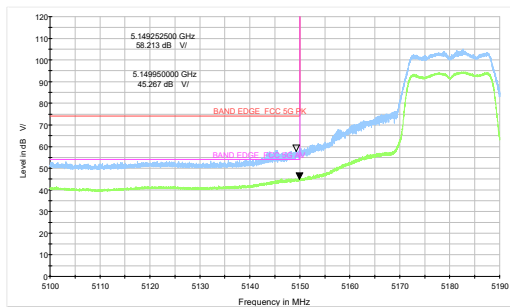

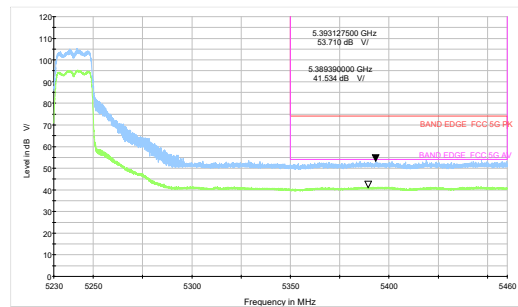

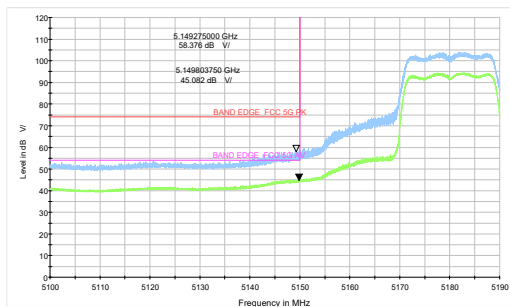
802.11a-Channel 36: Peak + Average



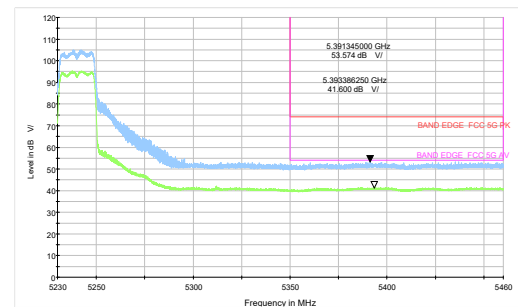
802.11a-Channel 48: Peak + Average



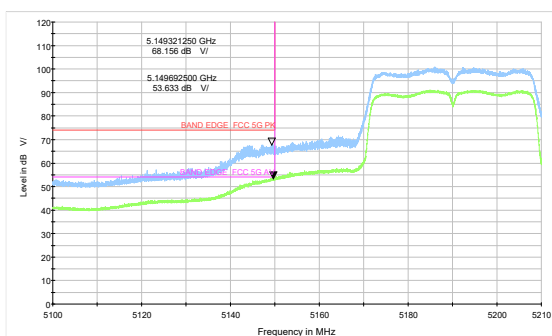
802.11n HT20-Channel 36: Peak + Average



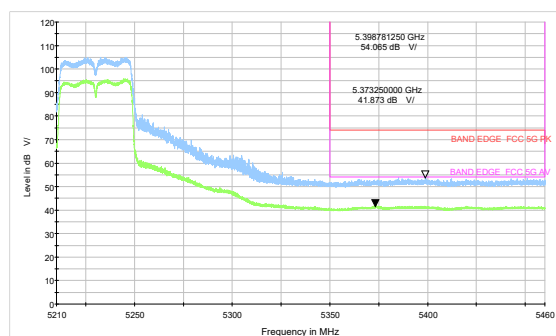

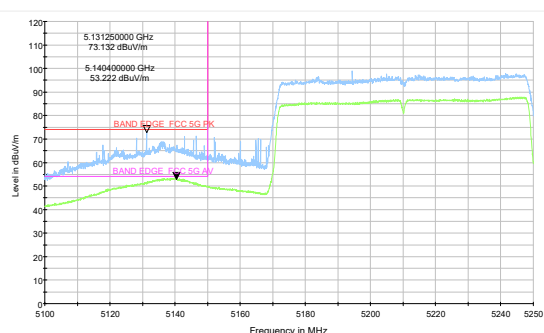
802.11n HT40-Channel 38: Peak + Average

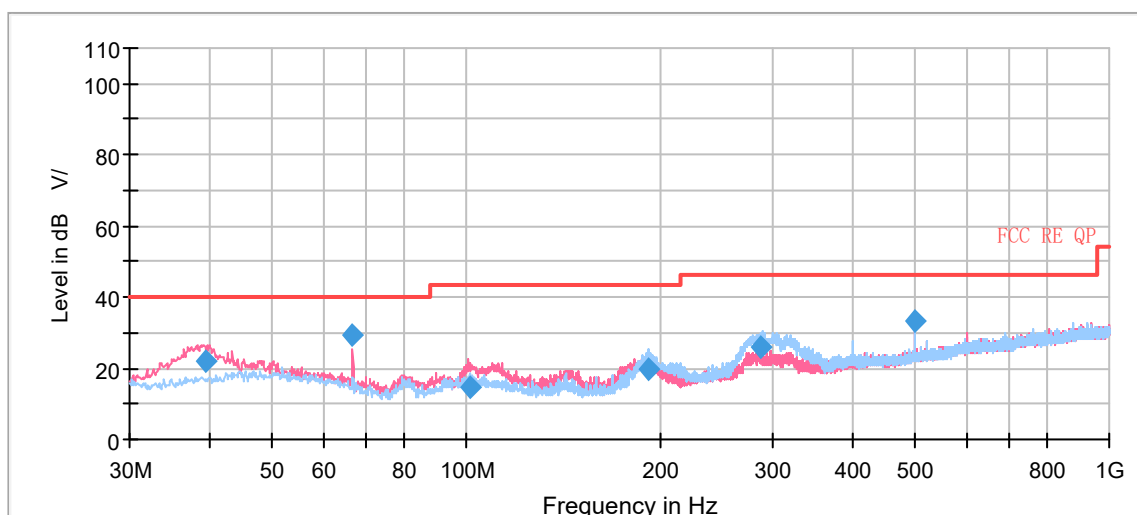
Sweep the whole frequency band through the range from 9kHz to the 10th harmonic of the carrier, the Emissions in the frequency band 9kHz-30MHz and 18GHz-40GHz are more than 20dB below the limit are not reported.

After the pretest, SISO Antenna 2 was selected as the worst antenna.

During the test, the Radiates Emission from 30MHz to 1GHz was performed in all modes with all channels, 802.11a CH36 are selected as the worst condition. The test data of the worst-case condition was recorded in this report.

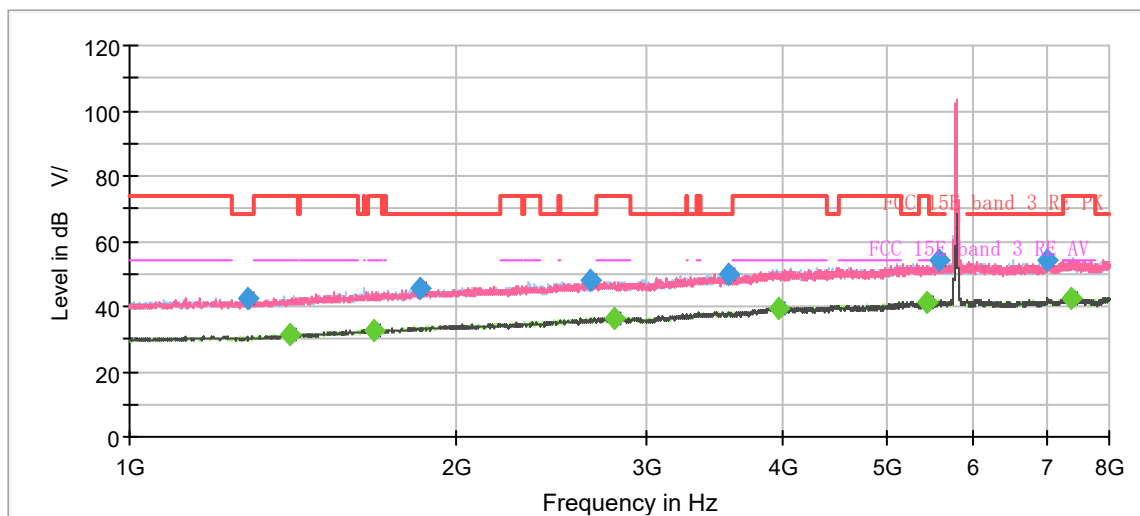
Radiates Emission from 8GHz to 18GHz

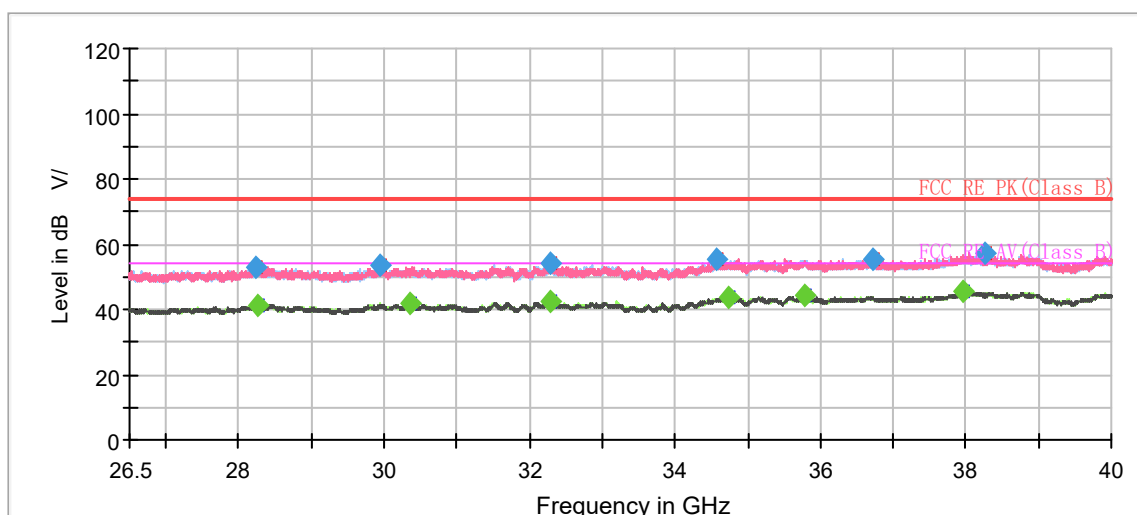
