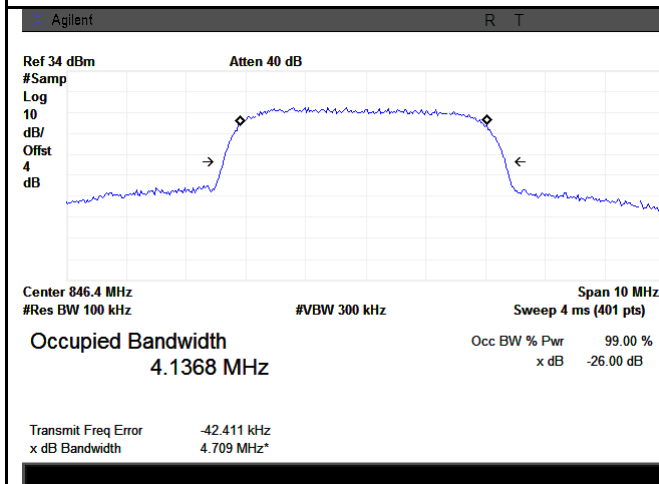




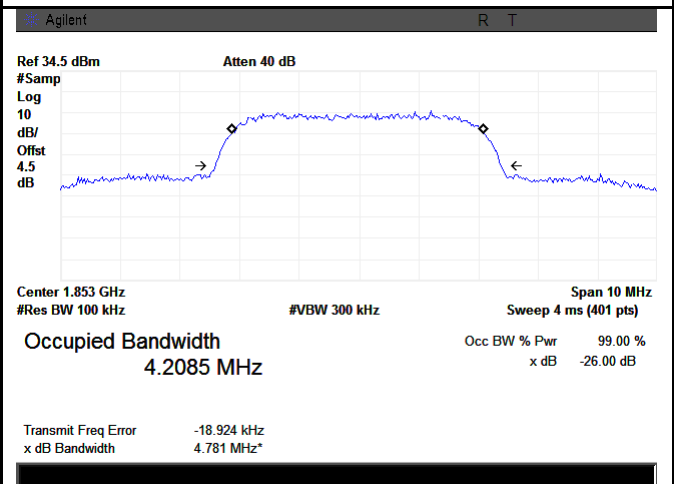
Band V BW - Low CH 826.6 MHz



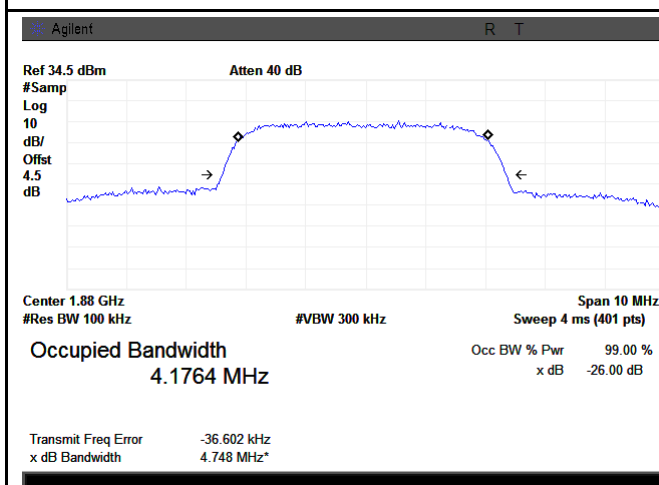
Band V BW - Mid CH 835.0 MHz



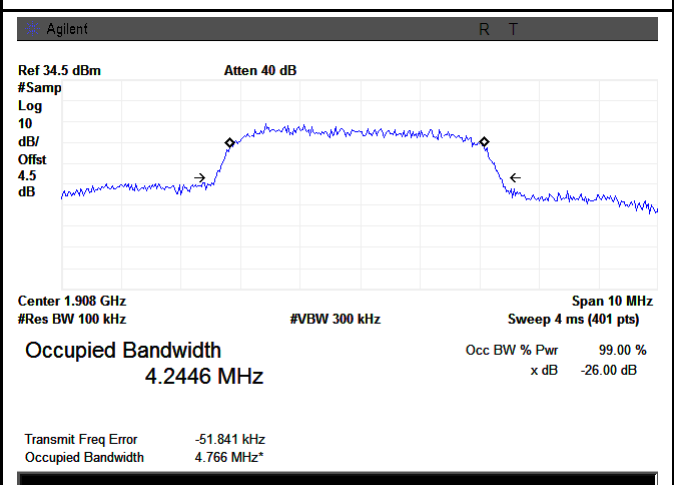
Band V BW - High CH 846.4 MHz

Band II BW - Mid CH 1880 MHz

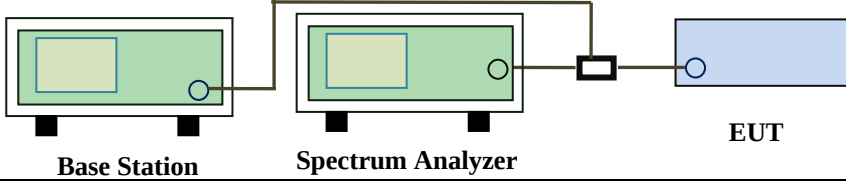


Band II BW - High CH 1907.6 MHz

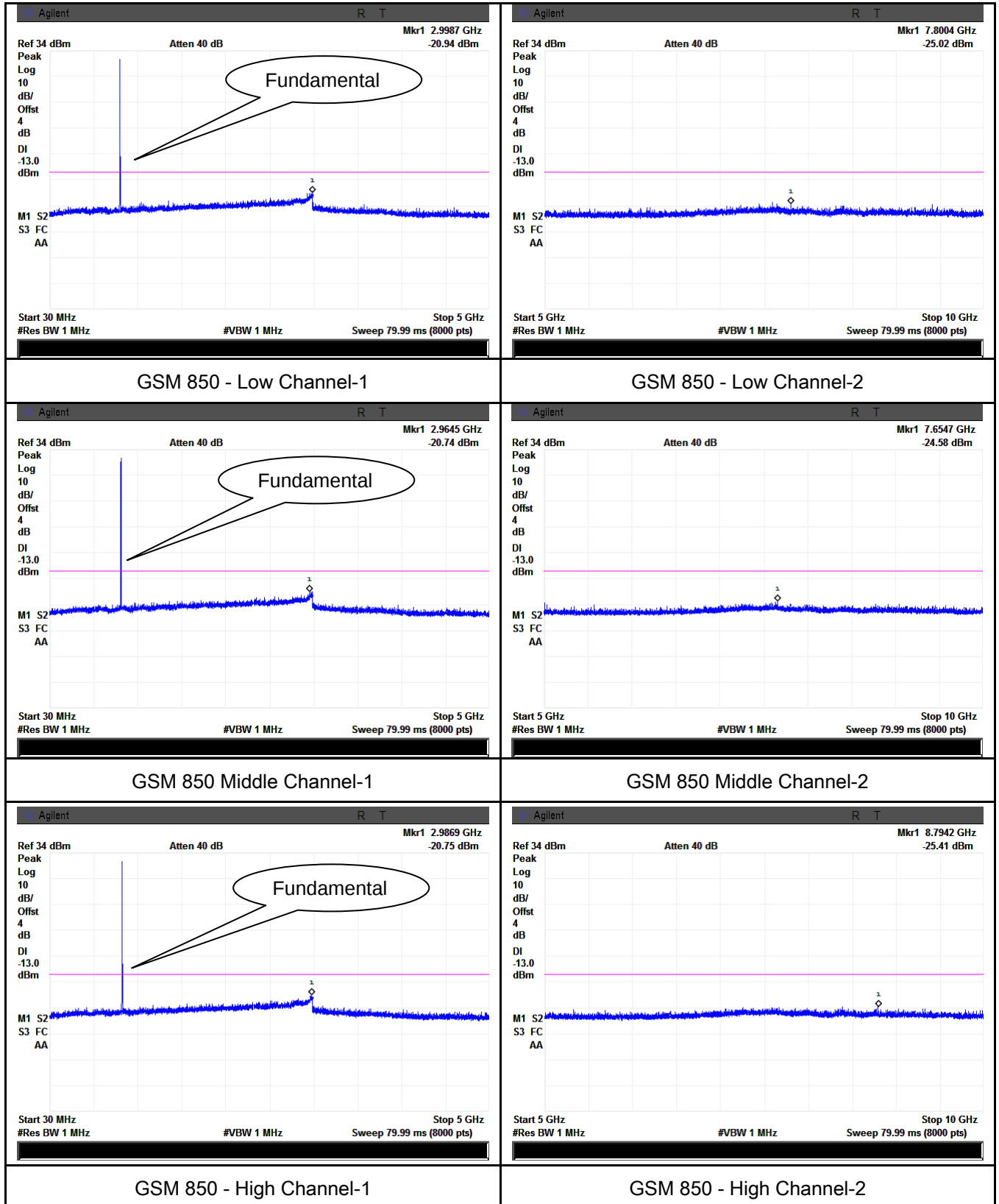

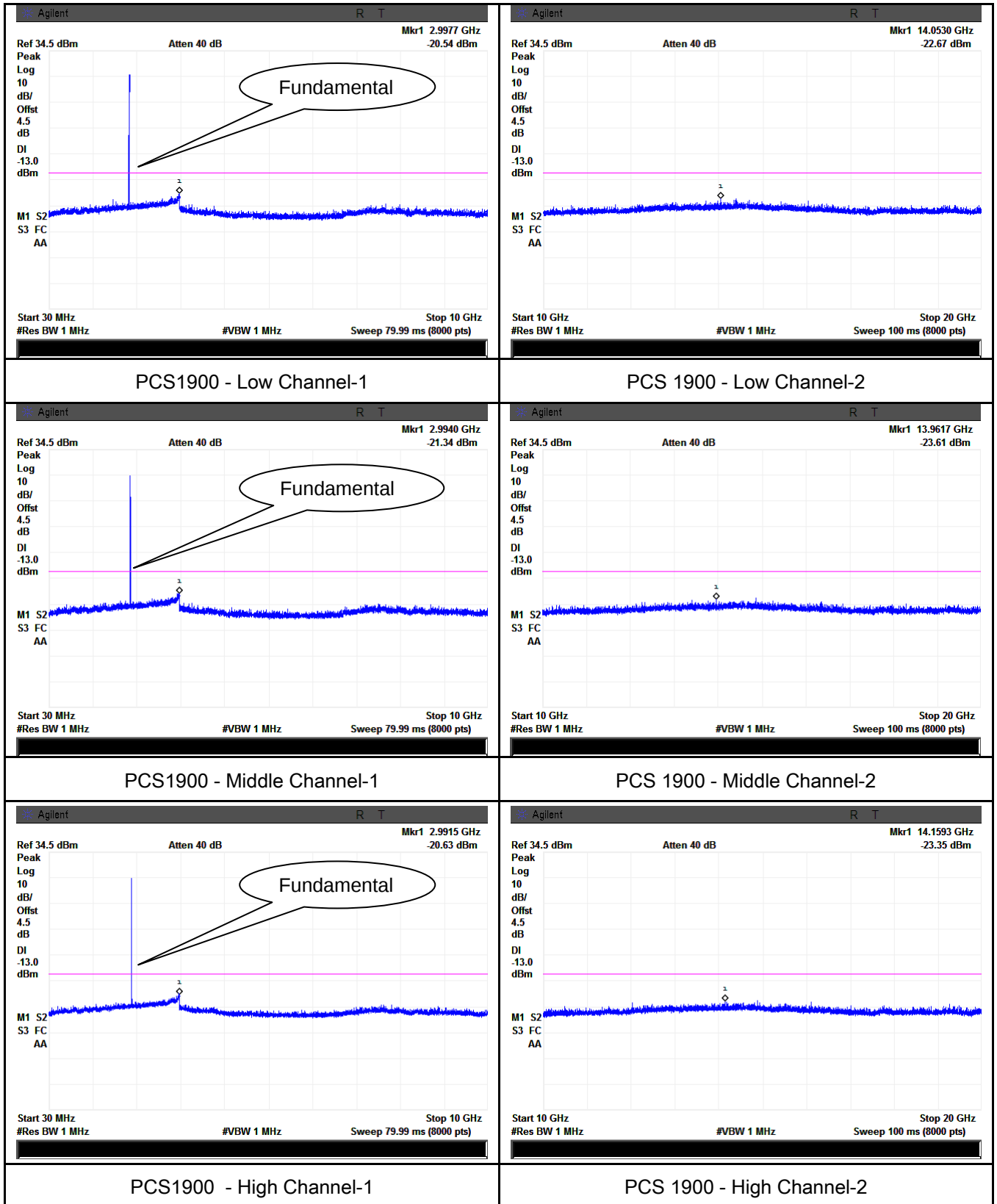

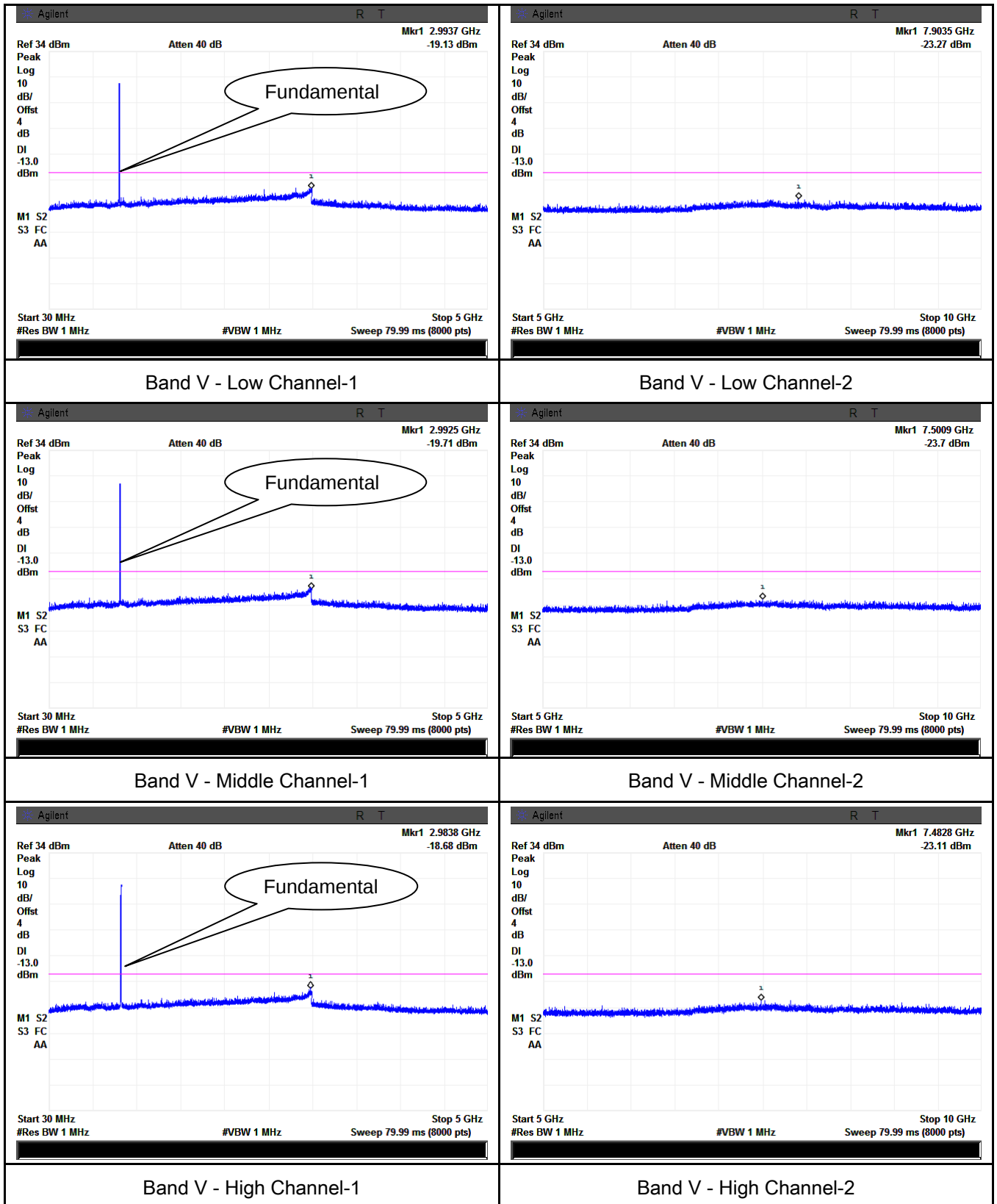
Cellular Band (Part 22H) result



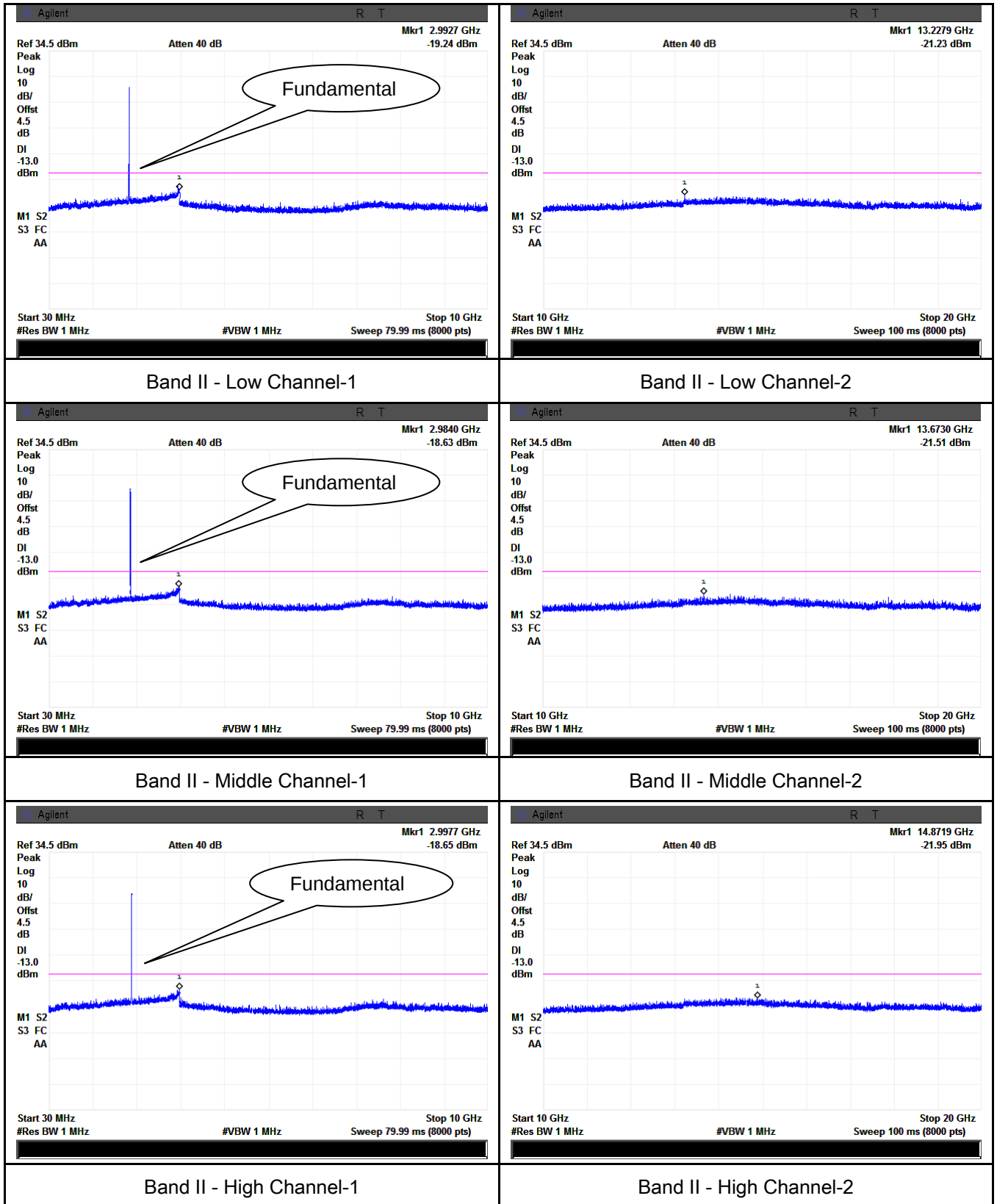
PCS Band (Part24E) result



UMTS-FDD Band V (Part 22H)



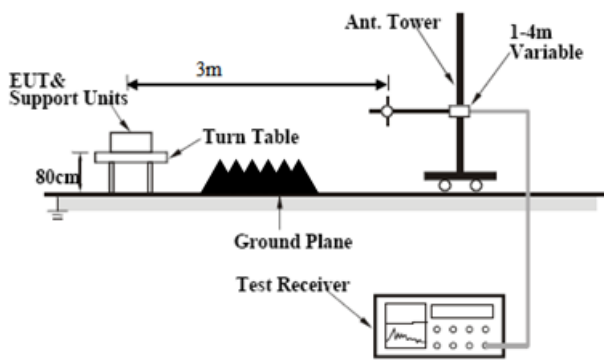
UMTS-FDD Band II (Part 24E)

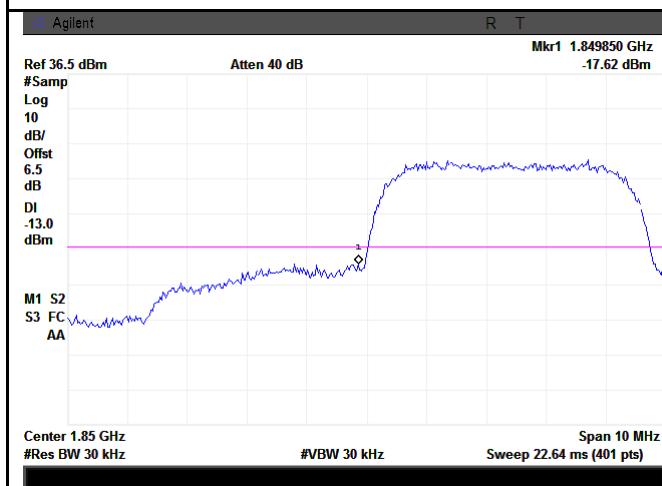
UMTS-FDD Band V - Low Channel

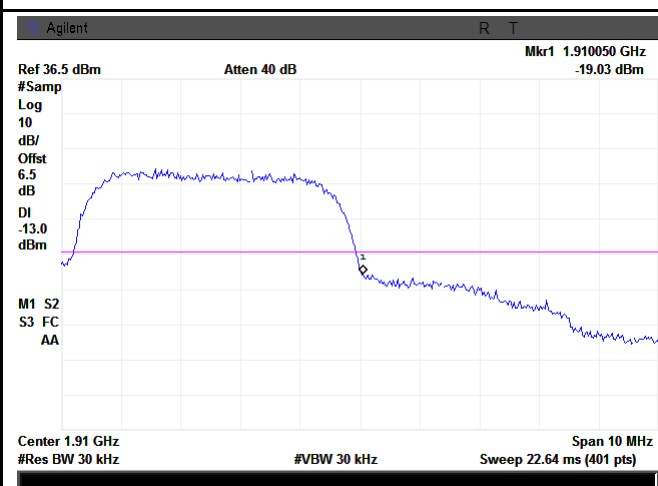
UMTS-FDD Band V - High Channel

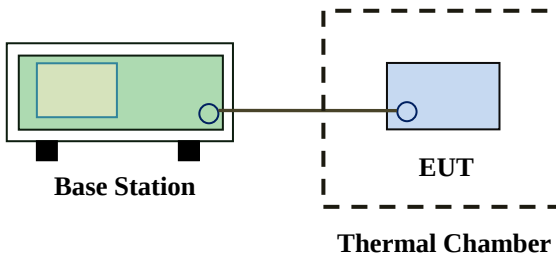
UMTS-FDD Band II - High Channel

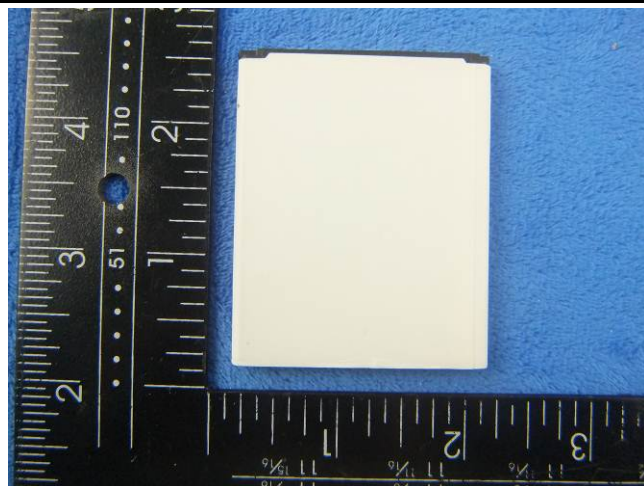

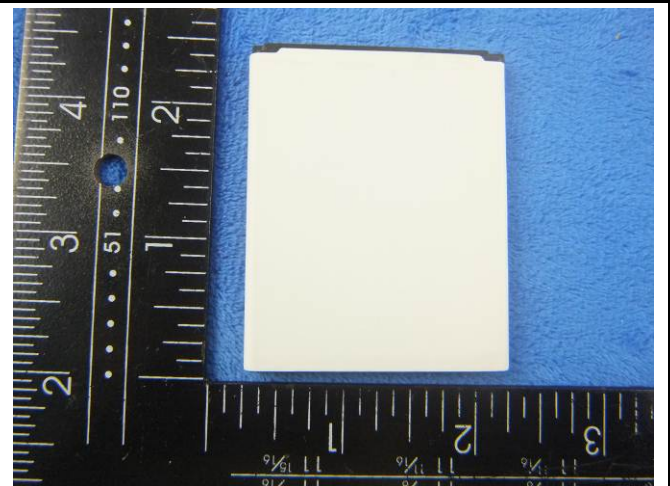

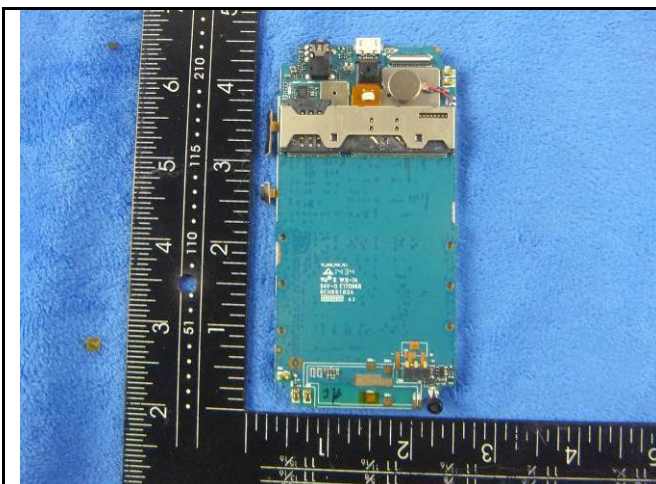

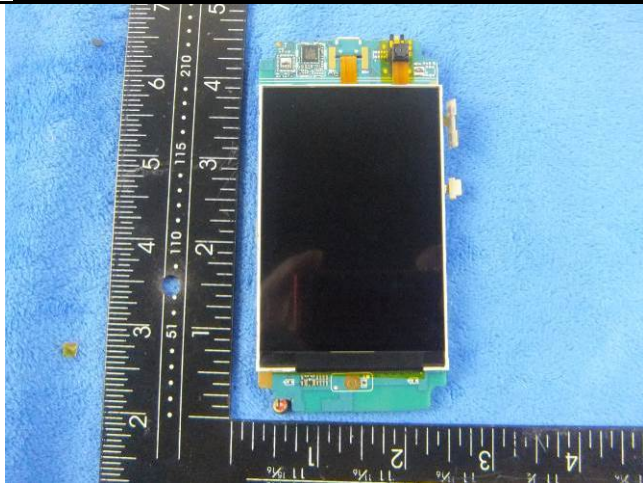

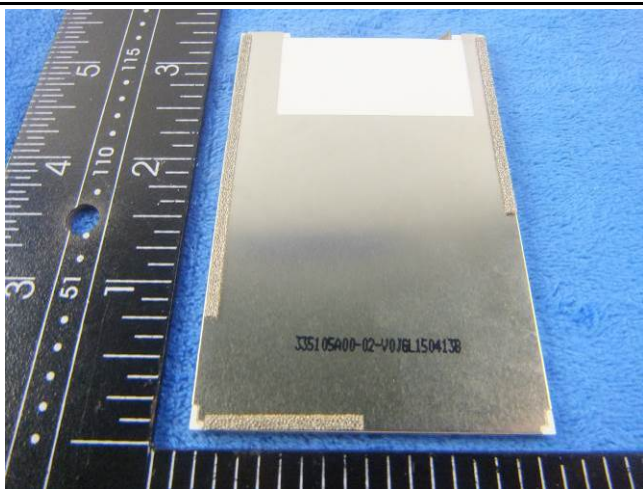

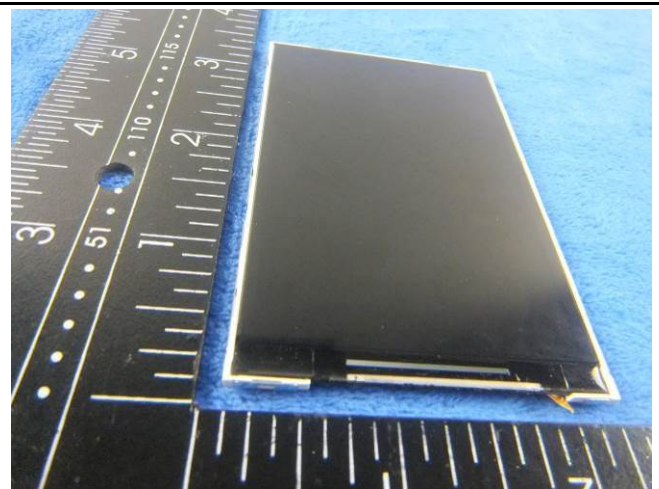

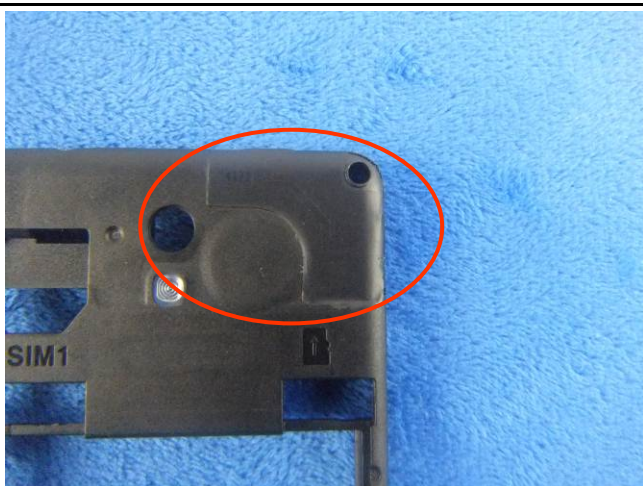

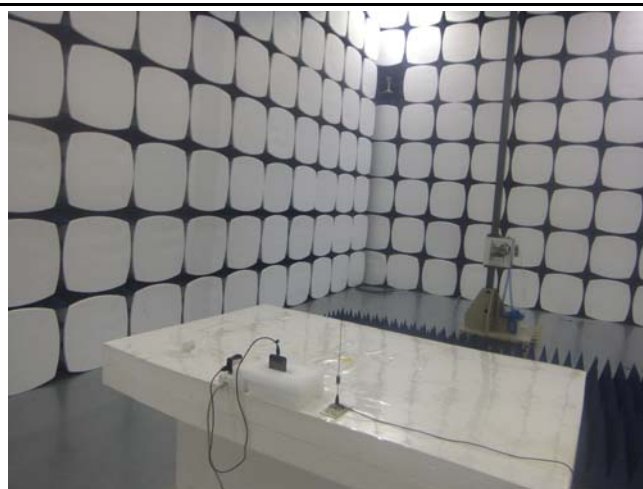

Radiated Spurious Emissions Test Setup Below 1GHz

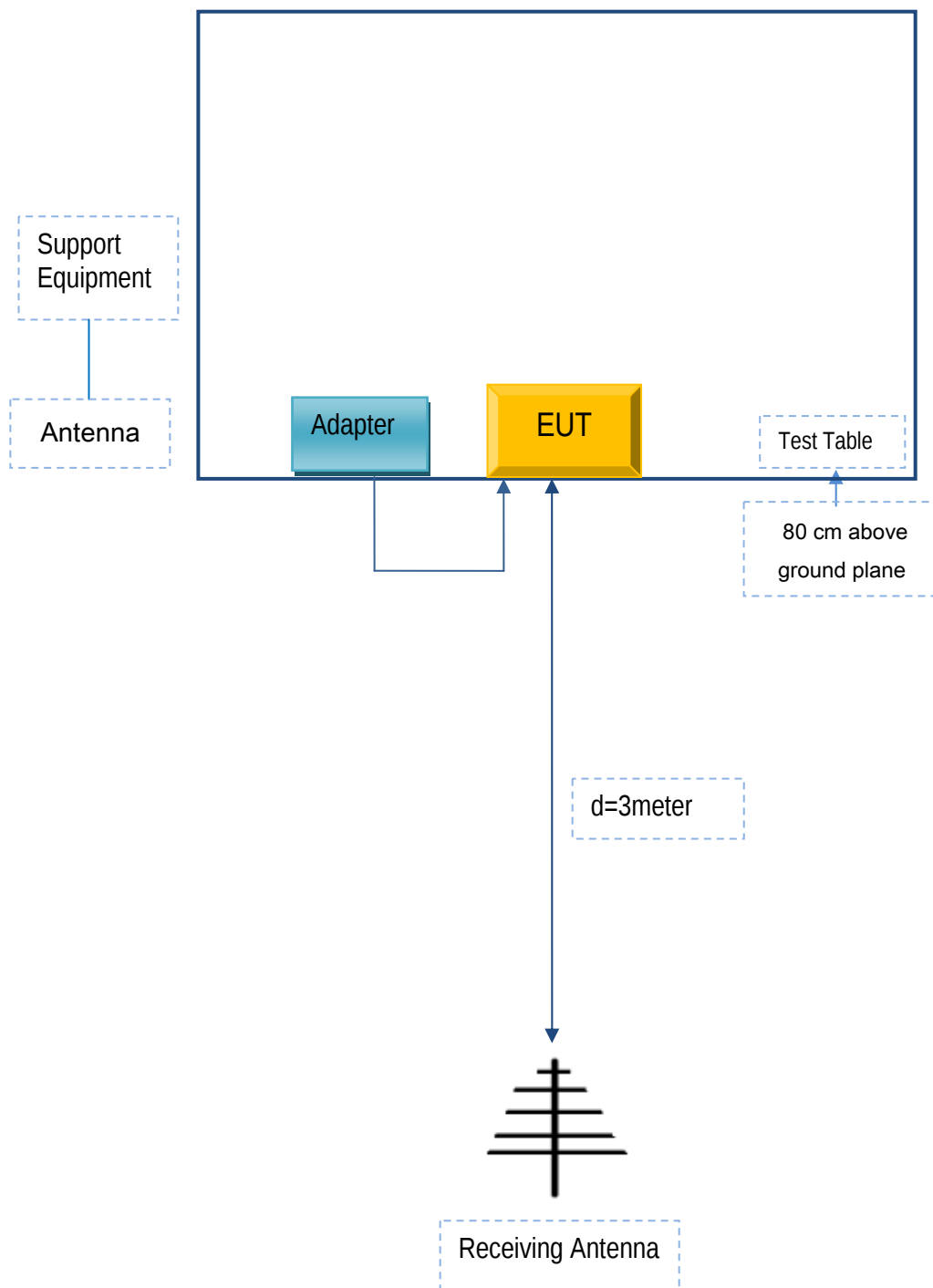


Radiated Spurious Emissions Test Setup Above
