

Radio Equipment Directive

The Desk Screen V3 contains the following radio transceivers:

- RFID reader operating in the 119 to 128.6 kHz band with maximum field strength of 10.5 dBμA/m at 3m
- RFID reader operating at 13.553-13.567 MHz band with maximum field strength of 4.4dBμA/m at 3m
- Bluetooth 4.0 operating in the 2400-2483.5 MHz band with maximum transmit power of 3.51 dBm EIRP
- WiFi operating in the **2412-2462** MHz band with maximum transmit power of **16.21** dBm EIRP and the 5150-5350 MHz, 5470-5725 MHz and 5725-5850MHz bands with maximum transmit power of 14.80 dBm EIRP.
