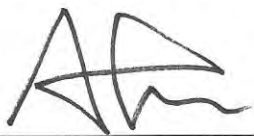

5. Test results

5.1 Antenna Requirement

5.1.1 Regulation

According to §15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

And according to §15.247(b)(4), the conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

5.1.2 Result

- Complied

The transmitter has a PCB type of antenna. The directional peak gain of the antenna is 0.88 dBi.

5.2 Maximum Peak Output Power

5.2.1 Regulation

According to §15.247(b)(3), For systems using digital modulation in the 902-928 MHz, 2 400-2 483.5 MHz, and 5 725-5 850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.

According to §15.247(b)(4) The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

5.2.2 Measurement Procedure

These test measurement settings are specified in section 9.0 of 558074 D01 DTS Meas Guidance.

5.2.2.1 Integrated band power method

This procedure may be used when the maximum available RBW of the measurement instrument is less than the DTS bandwidth.

- a) Set the RBW = 1 MHz.
- b) Set the VBW $\geq 3 \times$ RBW
- c) Set the span $\geq 1.5 \times$ DTS bandwidth.
- d) Detector = peak.
- e) Sweep time = auto couple.
- f) Trace mode = max hold.
- g) Allow trace to fully stabilize.
- h) Use the instrument's band/channel power measurement function with the band limits set equal to the DTS bandwidth edges (for some instruments, this may require a manual override to select peak detector).
If the instrument does not have a band power function, sum the spectrum levels (in linear power units) at intervals equal to the RBW extending across the DTS bandwidth.

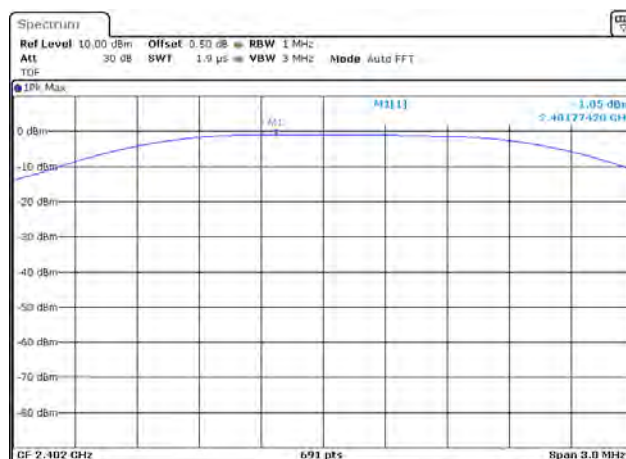

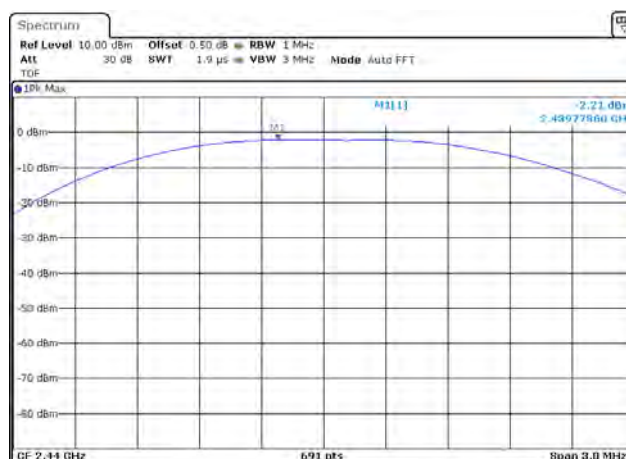

Figure 1. Plot of the Maximum Peak Output Power

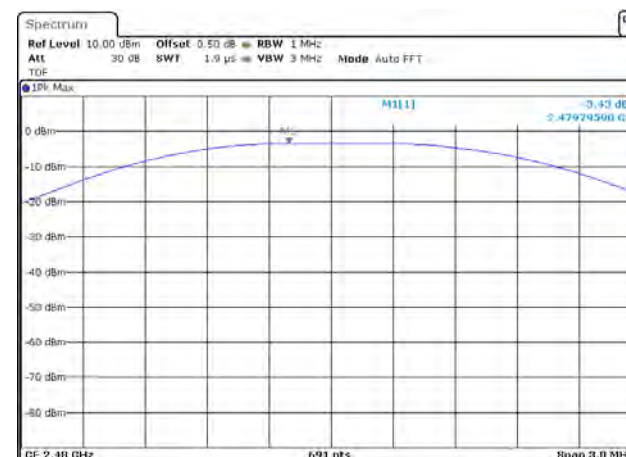
Lowest Channel

5.3 Peak Power Spectral Density

5.3.1 Regulation

According to §15.247(e), for digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.

5.3.2 Measurement Procedure

These test measurement settings are specified in section 10.0 of 558074 D01 DTS Meas Guidance.

5.3.2.1 Method PKPSD (peak PSD)

This procedure shall be used if maximum peak conducted output power was used to demonstrate compliance, and is optional if the maximum conducted (average) output power was used to demonstrate compliance.

- 1) Set analyzer center frequency to DTS channel center frequency.
- 2) Set the span to 1.5 times the DTS bandwidth.
- 3) Set the RBW to: $3 \text{ kHz} \leq \text{RBW} \leq 100 \text{ kHz}$.
- 4) Set the VBW $\geq 3 \times \text{RBW}$.
- 5) Detector = peak.
- 6) Sweep time = auto couple.
- 7) Trace mode = max hold.
- 8) Allow trace to fully stabilize.
- 9) Use the peak marker function to determine the maximum amplitude level within the RBW.
- 10) If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.

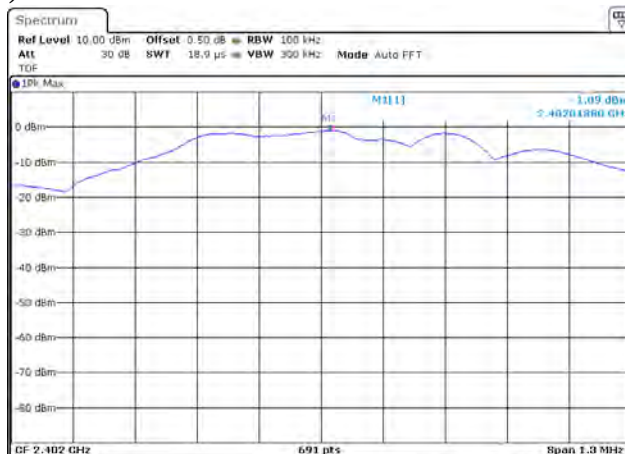

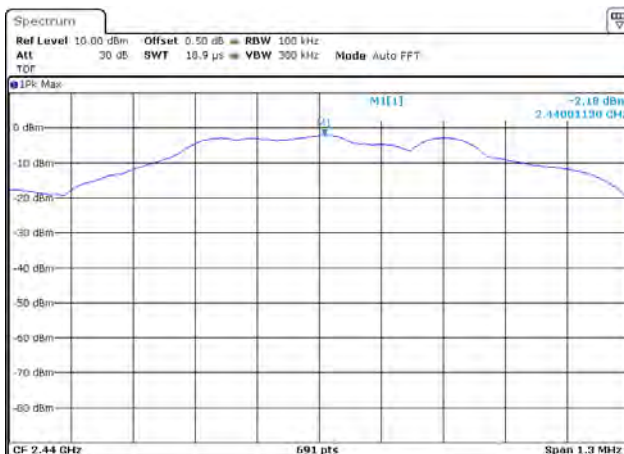

Figure 3. Plot of the Power Density

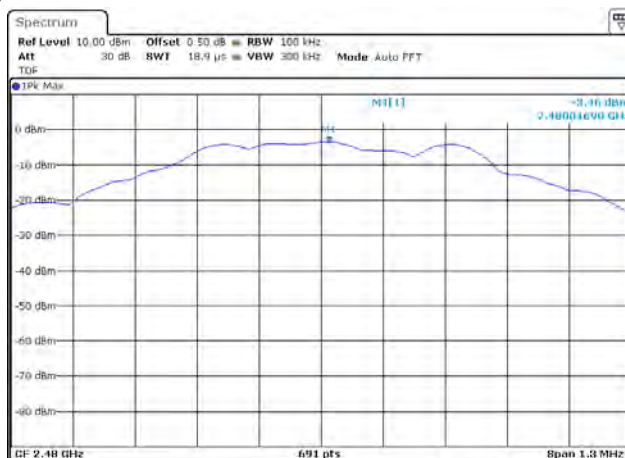
Lowest Channel(2 402 MHz)

5.4 6 dB Bandwidth(DTS Channel Bandwidth)

5.4.1 Regulation

According to §15.247(a)(2) Systems using digital modulation techniques may operate in the 902–928 MHz, 2 400–2 483.5 MHz, and 5 725–5 850 MHz bands. The minimum 6 dB bandwidth shall be at least 500 kHz.

5.4.2 Measurement Procedure

These test measurement settings are specified in section 8.0 of 558074 D01 DTS Meas Guidance.

5.4.2.1 DTS Channel Bandwidth-Option 1

- 1) Set RBW = 100 kHz.
- 2) Set the video bandwidth (VBW) $\geq 3 \times$ RBW.
- 3) Detector = Peak.
- 4) Trace mode = max hold.
- 5) Sweep = auto couple.
- 6) Allow the trace to stabilize.
- 7) Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.

5.4.2.2 DTS Channel Bandwidth Measurement Procedure-Option 2

The automatic bandwidth measurement capability of an instrument may be employed using the X dB bandwidth mode with X set to 6 dB, if the functionality described above (i.e., RBW = 100 kHz, VBW $\geq 3 \times$ RBW, peak detector with maximum hold) is implemented by the instrumentation function. When using this capability, care shall be taken so that the bandwidth measurement is not influenced by any intermediate power nulls in the fundamental emission that might be ≥ 6 dB.

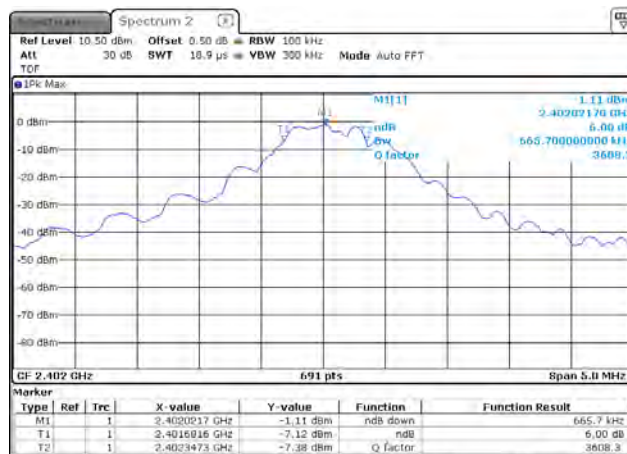

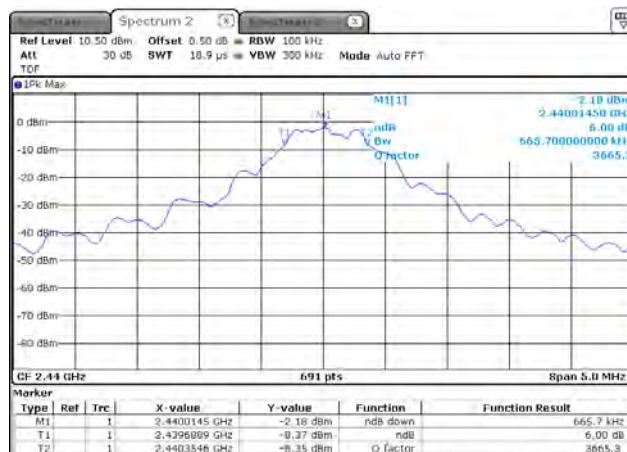
Figure 4. Plot of the 6dB Bandwidth & Occupied Bandwidth

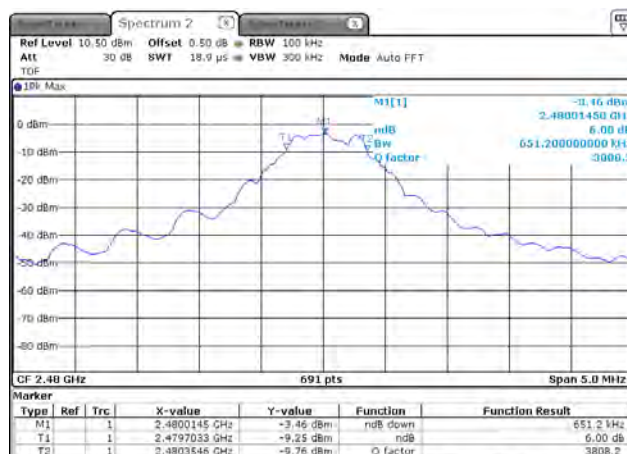
Lowest Channel (2 402 MHz)

Highest Channel (2 480 MHz)

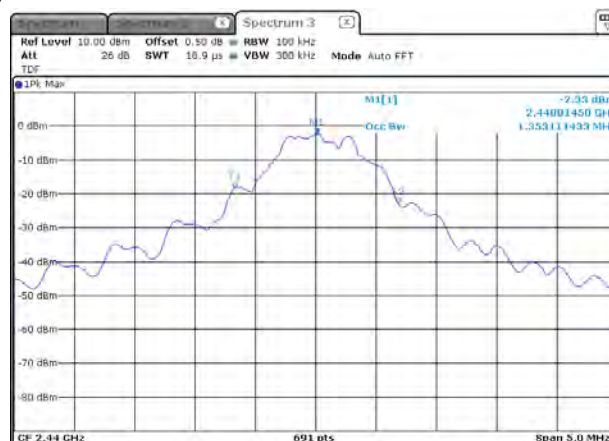

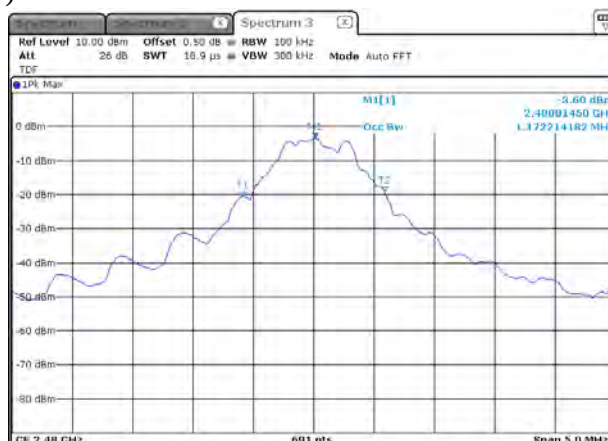
Lowest Channel (2 402 Mhz)

5.5 Spurious Emission, Band Edge, and Restricted bands

5.5.1 Regulation

According to §15.247(d), in any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in Section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in Section 15.205(a), must also comply with the radiated emission limits specified in Section 15.209(a) (see Section 15.205(c)).

According to §15.209(a), Except as provided elsewhere in this subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table:

**Except as provided in paragraph (g), fundamental emissions from intentional radiators operating under this section shall not be located in the frequency bands 54–72 MHz, 76–88 MHz, 174–216 MHz or 470–806 MHz. However, operation within these frequency bands is permitted under other sections of this part, e.g., §§15.231 and 15.241.

According to § 15.205(a) and (b), only spurious emissions are permitted in any of the frequency bands listed below:

The field strength of emissions appearing within these frequency bands shall not exceed the limits shown in §15.209. At frequencies equal to or less than 1 000 MHz, compliance with the limits in §15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector. Above 1 000 MHz, compliance with the emission limits in §15.209 shall be demonstrated based on the average value of the measured emissions. The provisions in §15.35 apply to these measurements.

5.5.2 Measurement Procedure

5.5.2.1 Band-edge Compliance of RF Conducted Emissions

5.5.2.1.1 Reference Level Measurement

Establish a reference level by using the following procedure:

- 1) Set instrument center frequency to DTS channel center frequency.
- 2) Set the span to ≥ 1.5 times the DTS bandwidth.
- 3) Set the RBW = 100 kHz.
- 4) Set the VBW $\geq 3 \times$ RBW.
- 5) Detector = peak.
- 6) Sweep time = auto couple.
- 7) Trace mode = max hold.
- 8) Allow trace to fully stabilize.
- 9) Use the peak marker function to determine the maximum PSD level.

5.5.2.1.2 Emissions Level Measurement

- 1) Set the center frequency and span to encompass frequency range to be measured.
- 2) Set the RBW = 100 kHz.
- 3) Set the VBW $\geq 3 \times$ RBW.
- 4) Detector = peak.
- 5) Ensure that the number of measurement points $\geq \text{span/RBW}$
- 6) Sweep time = auto couple.
- 7) Trace mode = max hold.
- 8) Allow trace to fully stabilize.
- 9) Use the peak marker function to determine the maximum amplitude level.

Ensure that the amplitude of all unwanted emissions outside of the authorized frequency band (excluding restricted frequency bands) are attenuated by at least the minimum requirements specified in 11.1 a) or 11.1 b).
Report the three highest emissions relative to the limit.

5.5.2.2 Conducted Spurious Emissions

Set the spectrum analyzer as follows:

- 1) Span = wide enough to capture the peak level of the in-band emission and all spurious emissions (e.g., harmonics) from the lowest frequency generated in the EUT up through the 10th harmonic.
Typically, several plots are required to cover this entire span.
- 2) RBW = 100 kHz
- 3) VBW $\geq$ RBW
- 4) Sweep = auto
- 5) Detector function = peak
- 6) Trace = max hold
- 7) Allow the trace to stabilize. Set the marker on the peak of any spurious emission recorded.
- 8) Each frequency found during preliminary measurements was re-examined and investigated.
The test-receiver system was set up to average, peak, and quasi-peak detector function with specified bandwidth.

5.5.2.3 Radiated Spurious Emissions

- 1) The preliminary and final radiated measurements were performed to determine the frequency producing the maximum emissions in at a 10m anechoic chamber. The EUT was tested at a distance 3 meters.
- 2) The EUT was placed on the top of the 0.8-meter height, 1 × 1.5 meter non-metallic table. To find the maximum emission levels, the height of a measuring antenna was changed and the turntable was rotated 360°.
- 3) The antenna polarization was also changed from vertical to horizontal. The spectrum was scanned from 9 kHz to 30 MHz using the loop antenna, and from 30 to 1 000 MHz using the TRILOG broadband antenna, and from 1 000 MHz to 26 500 MHz using the horn antenna.
- 4) Each frequency found during preliminary measurements was re-examined and investigated. The test-receiver system was set up to average, peak, and quasi-peak detector function with specified bandwidth.

- Sample calculation

The field strength is calculated adding the antenna Factor, cable loss and, Antenna pad adding, subtracting the amplifier gain from the measured reading.

** The sample calculation is as follow:

$$\text{Result} = \text{M.R} + \text{C.F}(\text{A.F} + \text{C.L} + 3 \text{ dB Att} - \text{A.G})$$

M.R = Meter Reading

C.F = Correction Factor

A.F = Antenna Factor

C.L = Cable Loss

A.G = Amplifier Gain

3 dB Att = 3 dB Attenuator

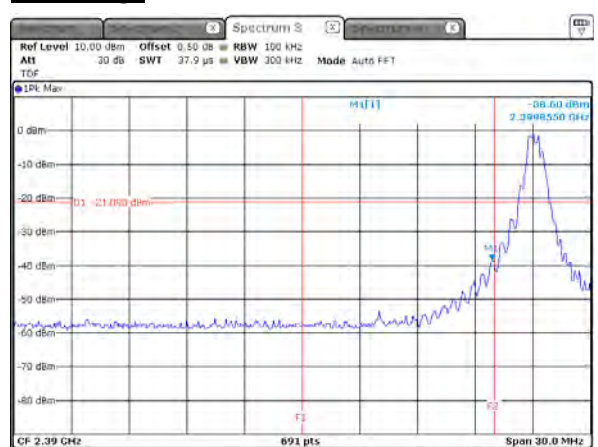
Figure 5. Plot of the Band-edge & Conducted Spurious Emissions

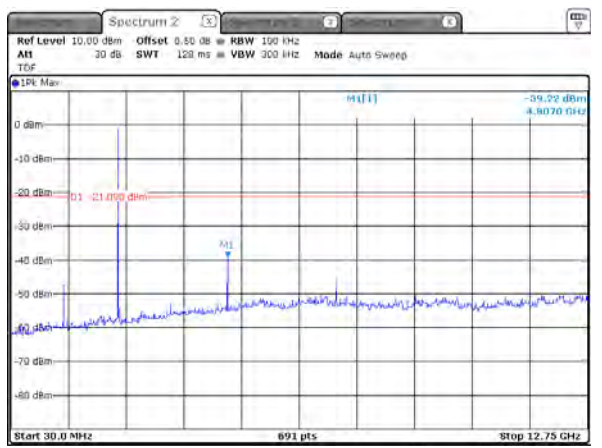

Conducted Spurious Emissions

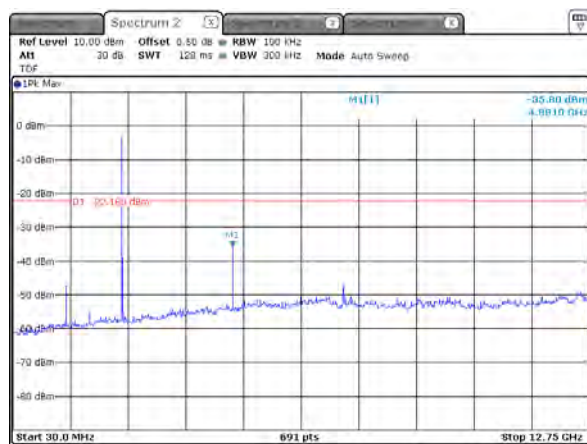


Middle Channel (2 440 MHz)

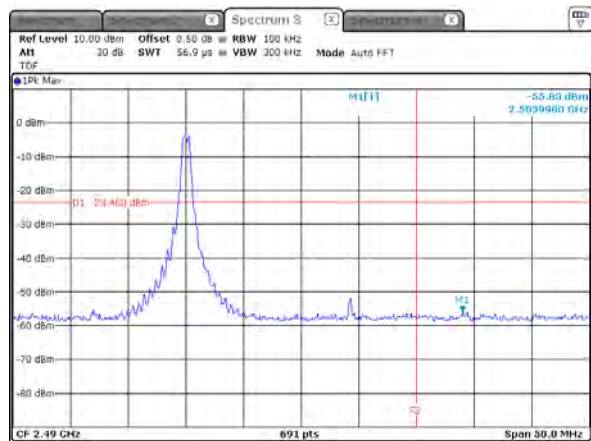

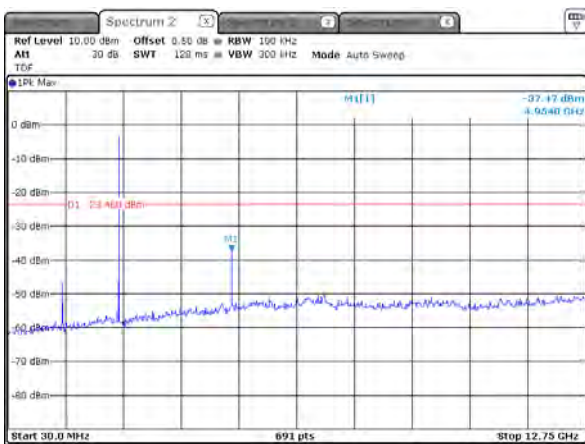

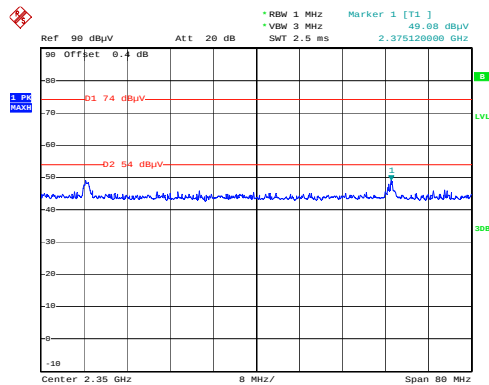

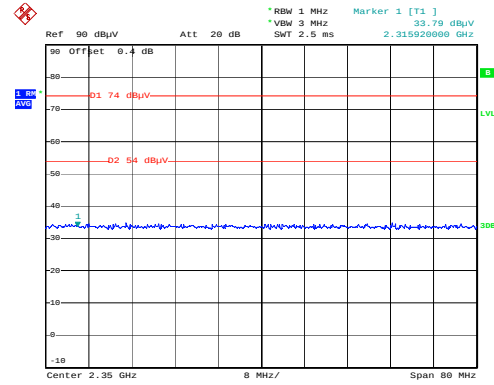

Figure 6. Plot of the Band Edge (Radiated Restricted Bands)

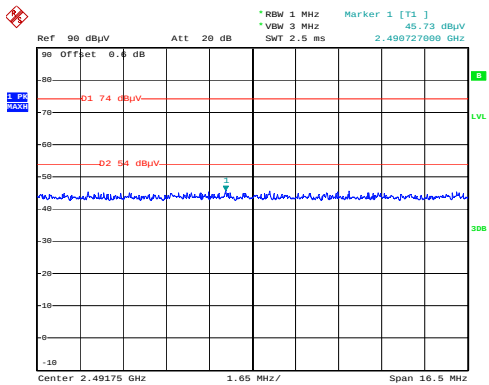
Lowest Channel(2 402 MHz): Peak



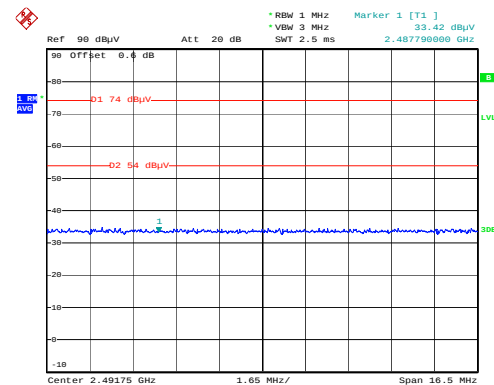
Lowest Channel(2 402 MHz): Average
