1.4 Measurement uncertainty

Tx (2440 MHz)



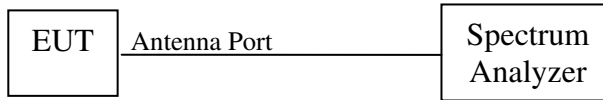

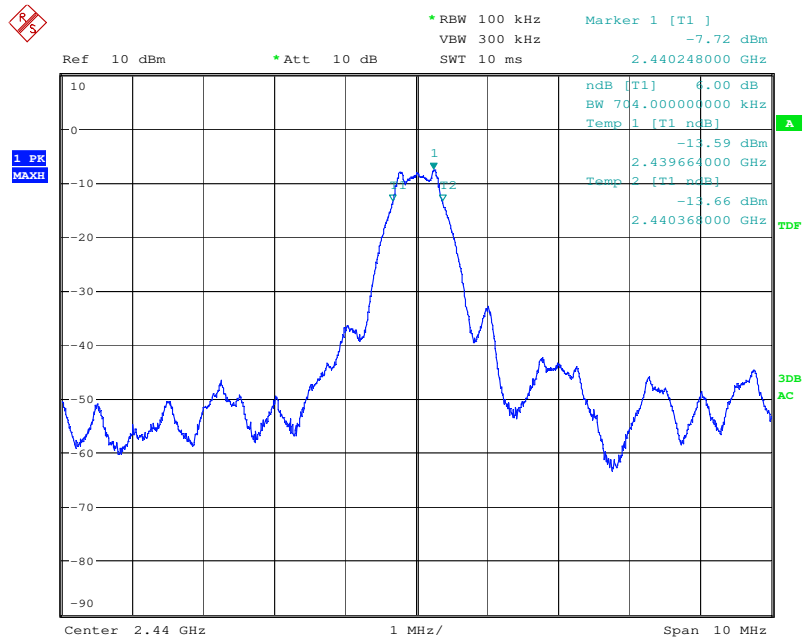

Tx 2440 MHz



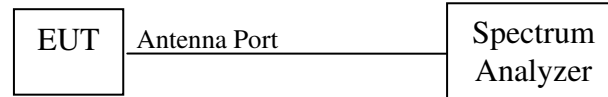

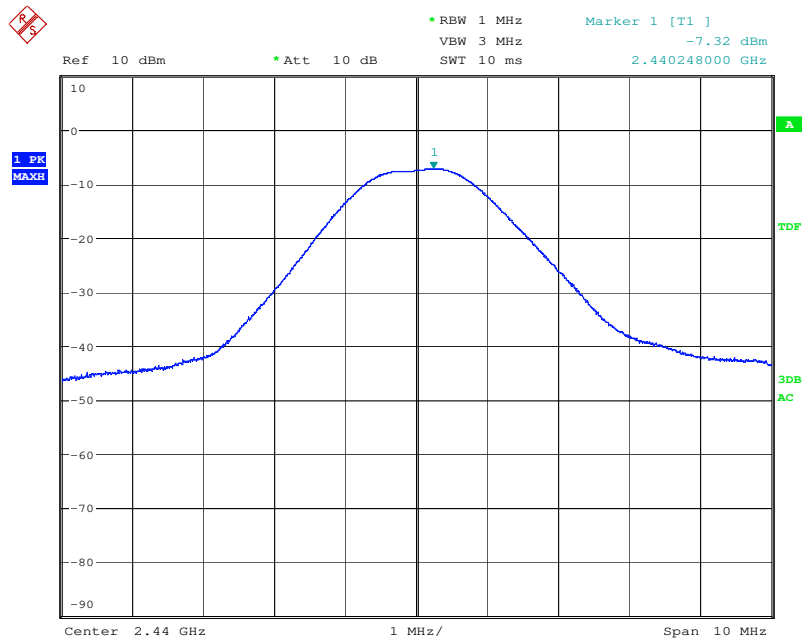

Tx 2440 MHz



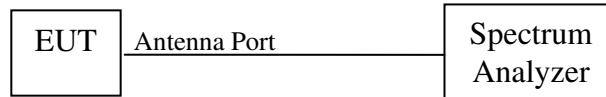

Tx 2440 MHz



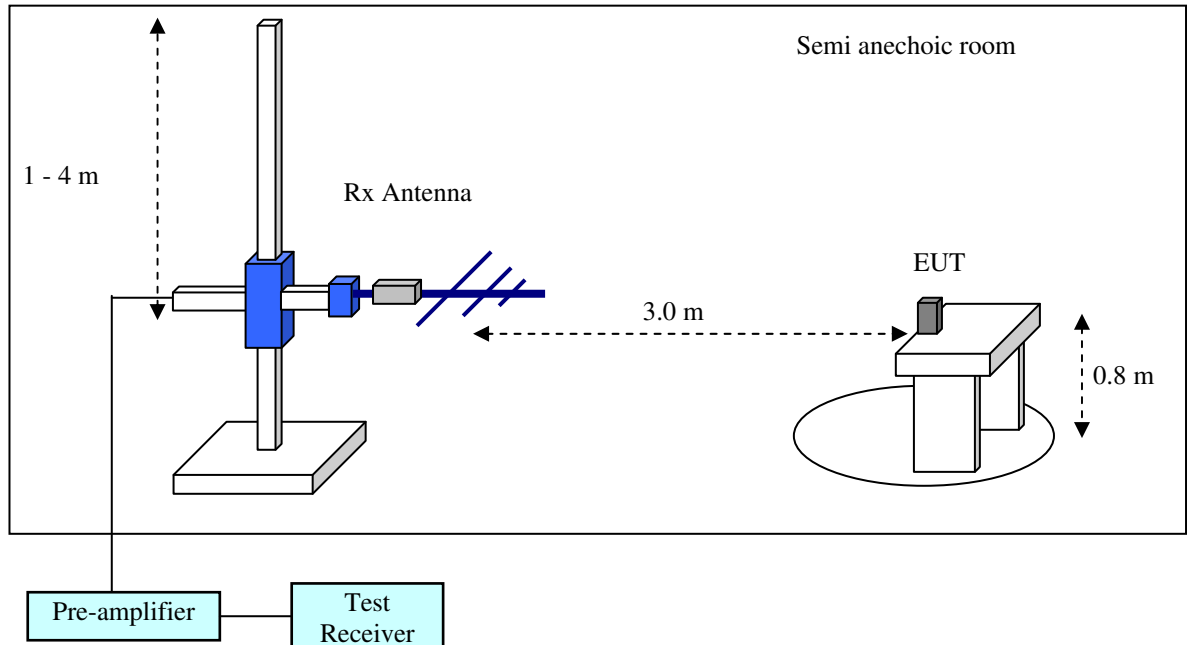

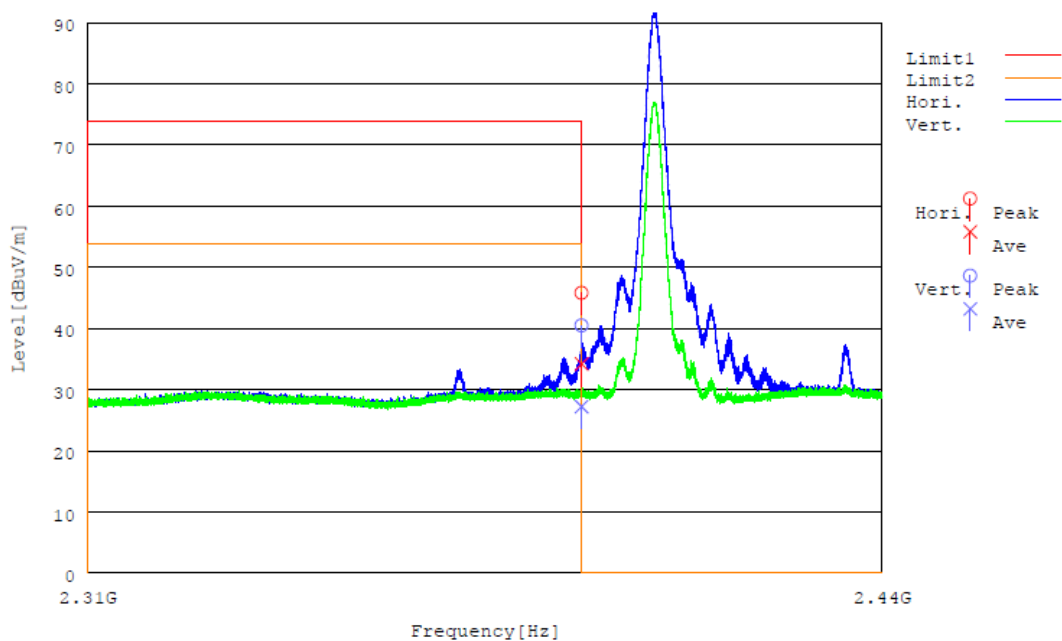

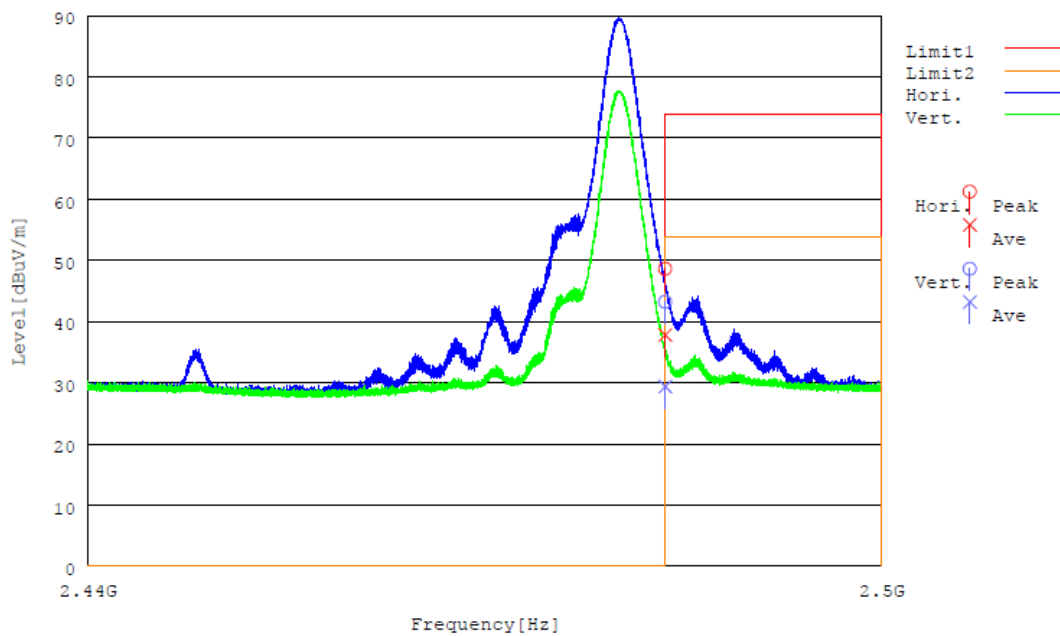

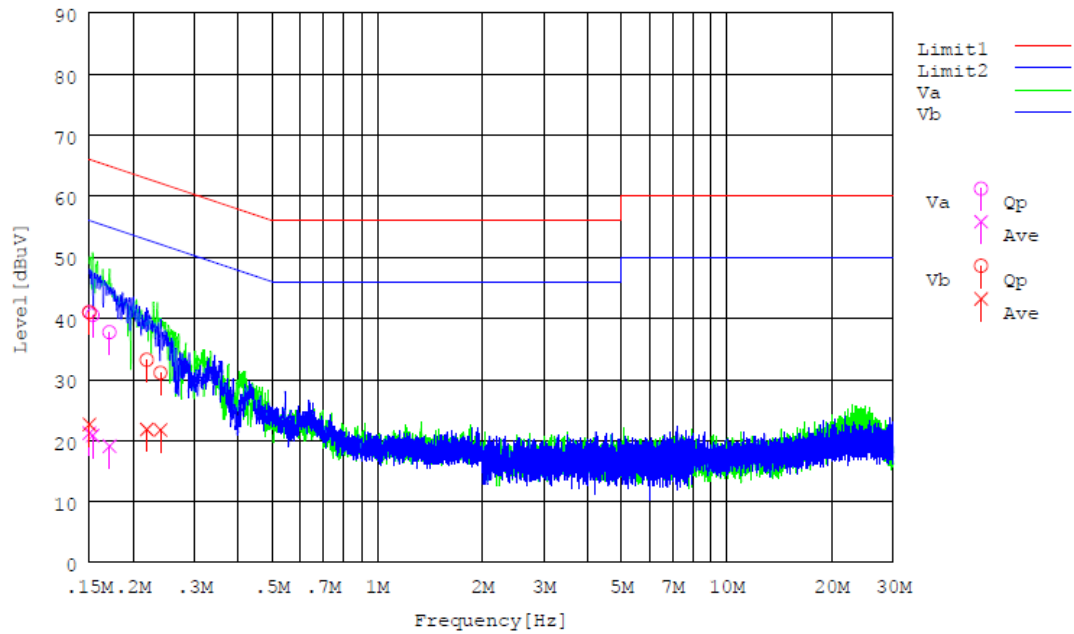
