2. System Test Configuration

2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

2.2 EUT Exercise

The Transmitter was operated in the normal operating mode. The TX frequency was fixed which was for the purpose of the measurements.

2.3 Test Procedure

2.3.1 Conducted Emissions

The EUT is a placed on as turn table which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4-2009 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-Peak and average detector mode.

2.3.2 Radiated Emissions

The EUT is a placed on as turn table which is 0.8 m above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter(EUT) was rotated through three orthogonal axes according to the requirements in Section 13.1.4.1 of ANSI C63.4-2009.

2.4 Limitation

(1) Channel Separation test

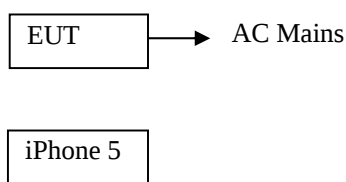

This Report Records BT4.0 DSS function test data ,We use software control the EUT, Let EUT hopping on and transmit with highest power, All the modes GFSK, 1/4Π-DQPSK, 8DPSK have been tested and the worst result was reported with modulation GFSK. 79 Channels are provided by EUT. The 3 channels of lower, medium and higher were chosen for test.

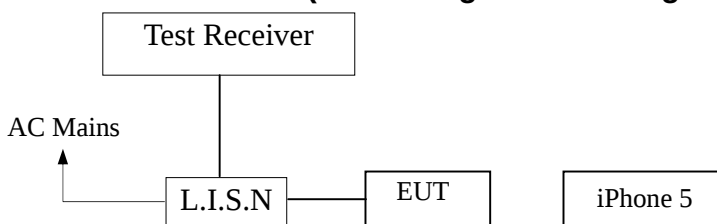

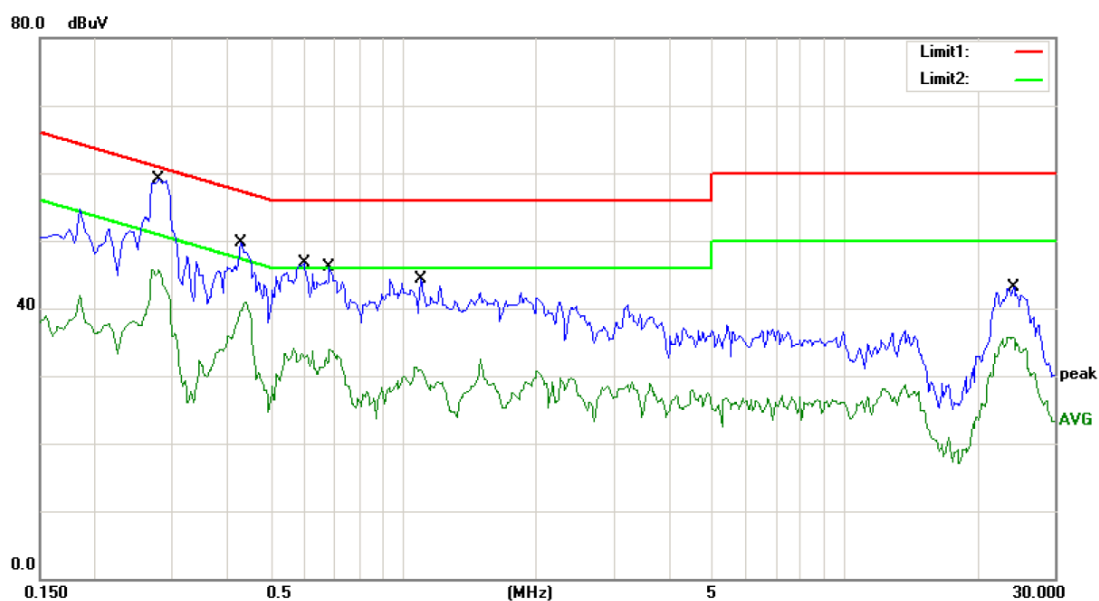

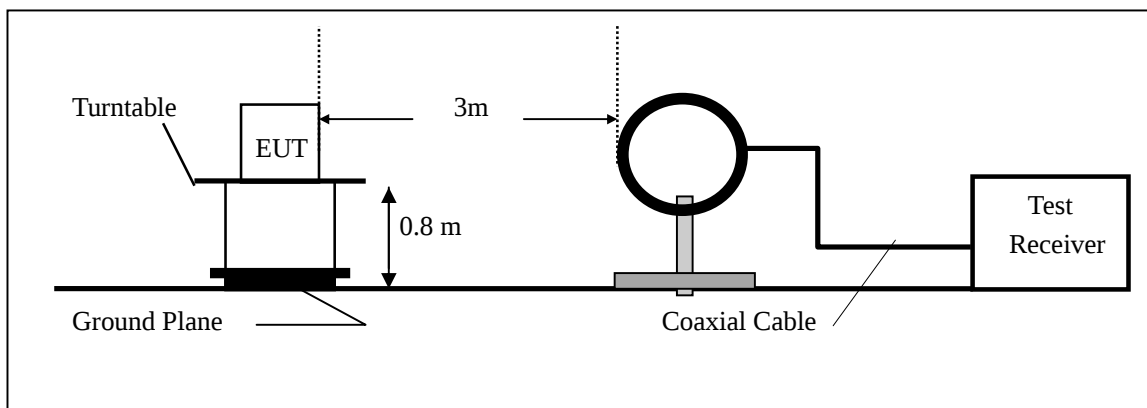

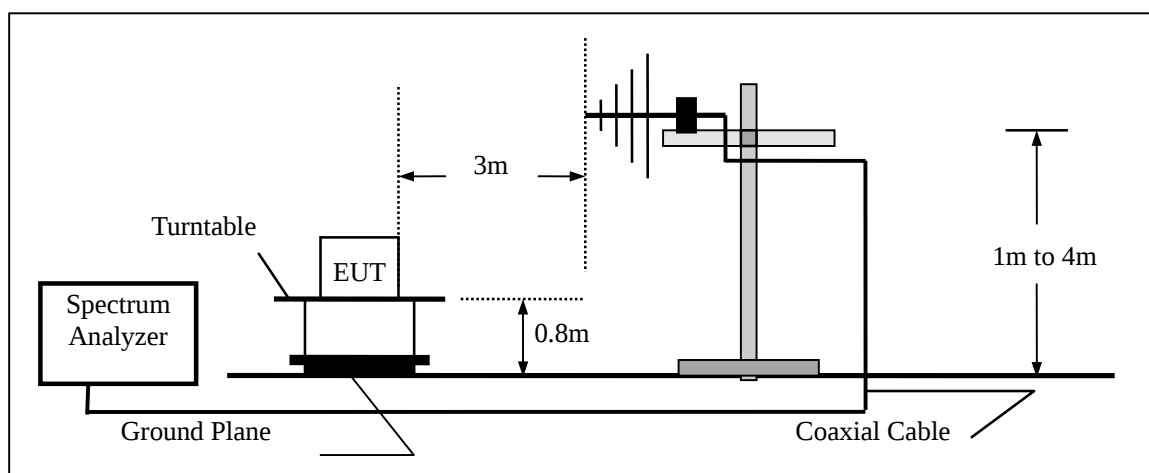

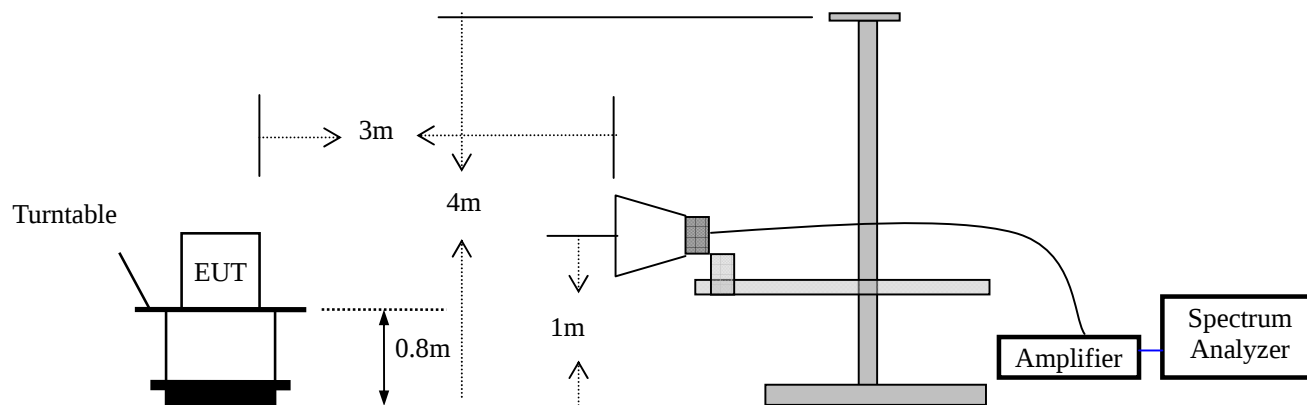
(A) Radiated Emission Test Set-Up, Frequency Below 30MHz

(C) Radiated Emission Test Set-Up, Frequency above 1000MHz

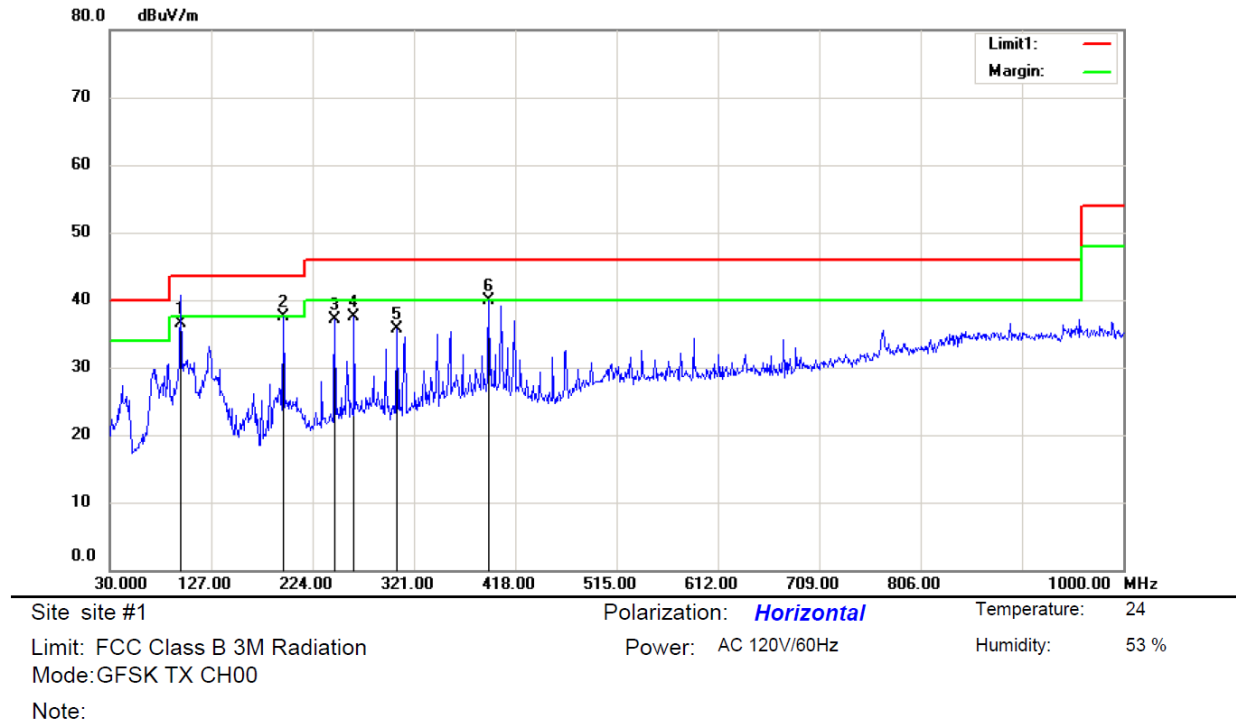

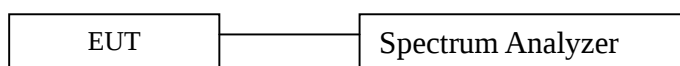


9. Time of Occupancy (Dwell Time) test

9.1 Measurement Procedure

- Check the calibration of the measuring instrument(SA) using either an internal calibrator or a known signal from an external generator.
- Turn on the EUT and connect its antenna terminal to measurement via a low loss cable. Then set it to any one measured frequency within its operating range and make sure the instrument is operated in its linear range.

11. Band EDGE test

11.1 Measurement Procedure

1. The testing follows the guidelines in Spurious Radiated Emissions of FCC Public Notice DA00-705 Measurement Guidelines.
2. The EUT was arranged to its worst case and then tune the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level.
3. The EUT was placed on a turntable with 0.8 meter above ground.
4. The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower.
5. For measurement below 1GHz, If the emission level of the EUT measured by the peak detector is 3 dB lower than the applicable limit, the peak emission level will be reported. Otherwise, the emission measurement will be repeated using the quasi-peak detector and reported.
6. Use the following spectrum analyzer settings:
 - (1) Span shall wide enough to fully capture the emission being measured;
 - (2) Set RBW=100 kHz for $f < 1$ GHz; $VBW \geq RBW$; Sweep = auto; Detector function = peak; Trace = max hold;
 - (3) Set RBW = 1 MHz, $VBW = 3$ MHz for $f \geq 1$ GHz for peak measurement.For average measurement:
The RBW of test receiver/spectrum analyzer is 1MHz and the VBW for Average detection (AV) of test receiver/spectrum analyzer is 10Hz above 1GHz.

The highest emission amplitudes relative to the appropriate limit were measured and recorded in this report.
