4.5 Test procedure

AC Power Line Conducted Emission

The EUT is connected to the power mains through a LISN which provides 50 Ω /50 μ H of coupling impedance for the measuring instrument. The test frequency range is from 150 kHz to 30 MHz. The maximum conducted interference is searched using Peak (PK), Quasi-peak (QP) and Average (AV) detectors; the emission levels that are more than the AV and QP limits, and that have narrow margins from the AV and QP limits will be re-measured with AV and QP detectors. Tests for both L phase and N phase lines of the power mains connected to the EUT are performed.

1. Level= Read Level+ Cable Loss+ LISN Factor
2. Margin=Level-Limit=Reading+factor-Limit

Radiated test method

1. The EUT was placed on the tabletop of a rotating table 1.5 m the ground at a 3 m semi anechoic chamber. The measurement distance from the EUT to the receiving antenna is 3 m.
2. EUT works in each mode of operation that needs to be tested, and having the EUT continuously working, respectively on 3 axis (X, Y & Z) and considered typical configuration to obtain worst position. The highest signal levels relative to the limit shall be determined by rotating the EUT from 0° to 360° and with varying the measurement antenna height between 1 m and 4 m in vertical and horizontal polarizations.
3. Open the test software to control the test antenna and test turntable. Perform the test, recorded the test results.
4. The substitution antenna shall be used to replace the equipment under test.
5. The reference point of the substitution antenna shall coincide with the volume centre of the UUT when its antenna is internal.
6. Set the required test frequency for the signal generator, adjust the emission level, until the spectrum analyzer reading on the receiving link is consistent with the recorded value in step 3, and the recorded signal generator emission level.
7. Final results = S.G. output (dBm) + Antenna Gain(dB/dBi) – Cable Loss (dB). This report only reflects the final results.

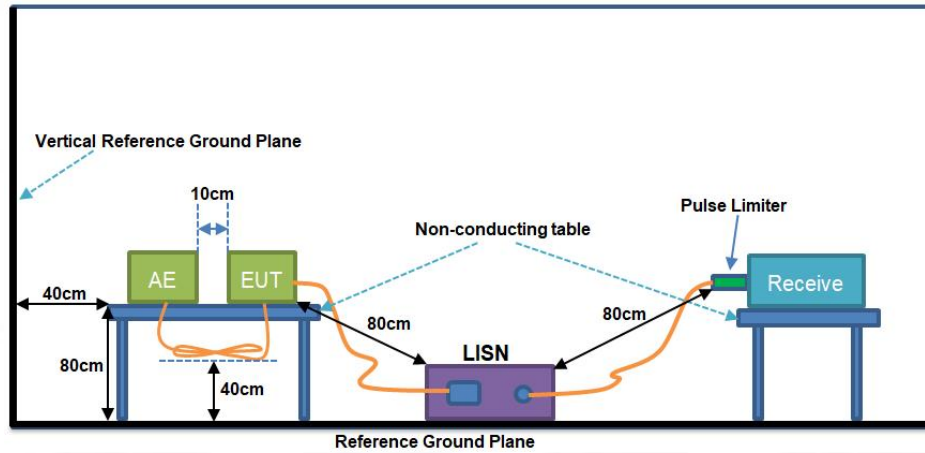

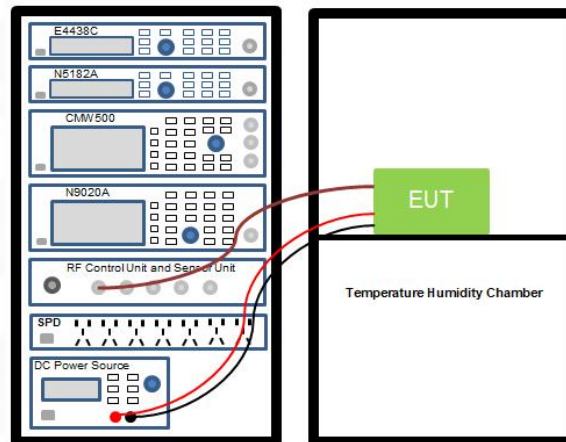
1. The WiFi antenna port of EUT was connected to the test port of the test system through an RF cable.
2. The EUT is keeping in continuous transmission mode and tested in all modulation modes.
3. Open the test software, prepare a test plan, and control the system through the software. After the test is completed, the test report is exported through the test software.

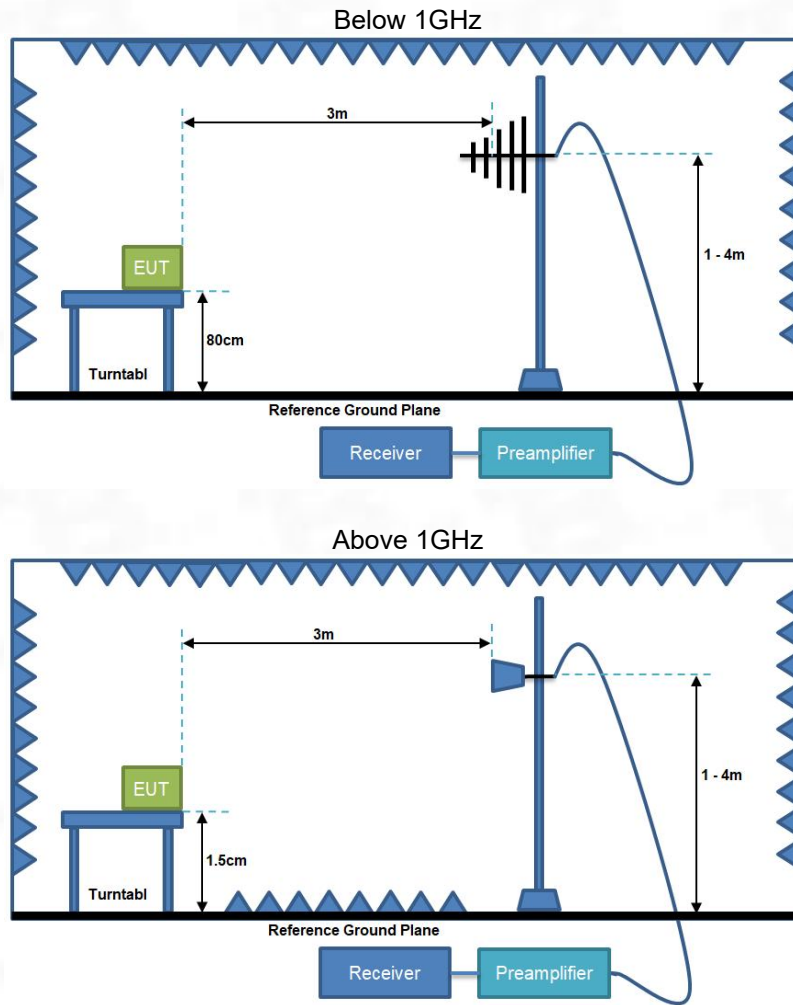

5 Technical requirements specification

5.1 Antenna Requirement

§15.203 requirement:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

§15.247(b) (4) requirement:

(4) The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

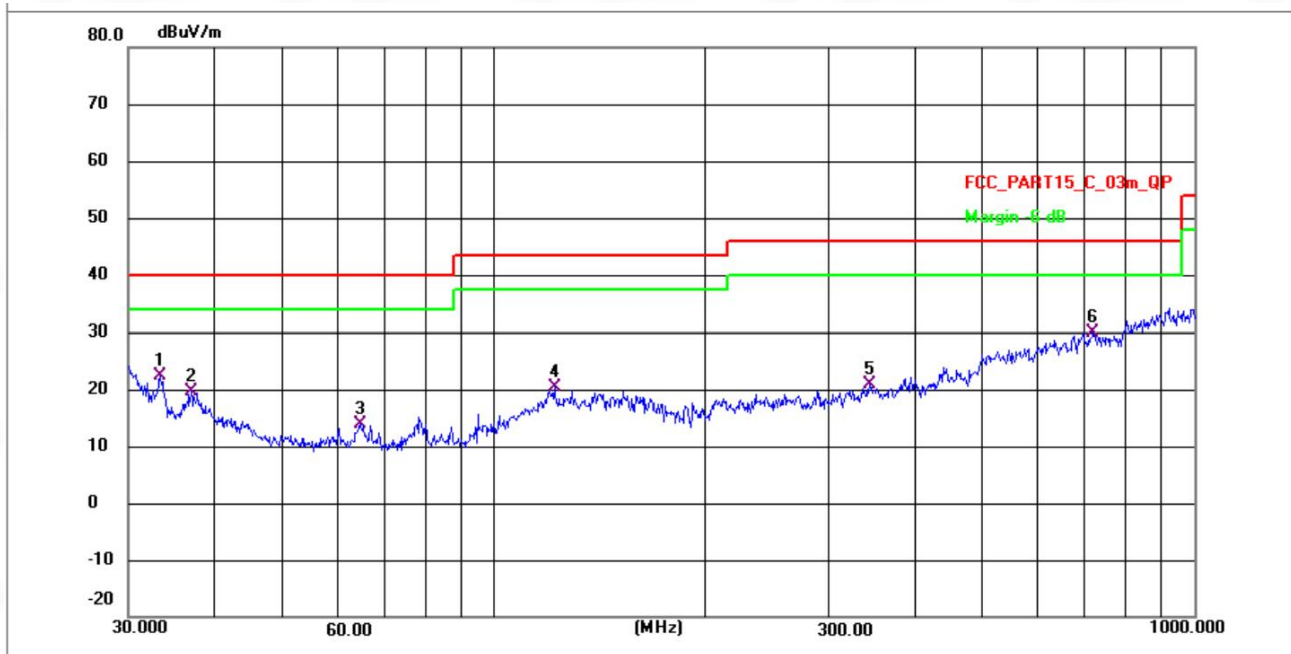
Test antenna polarization: Horizontal(30 MHz to 1 GHz)

Test Limit:	For an outdoor access point operating in the band 5.15-5.25 GHz, the maximum power spectral density shall not exceed 17 dBm in any 1 megahertz band. If transmitting antennas of directional gain greater than 6 dBi are used, the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi. For an indoor access point operating in the band 5.15-5.25 GHz, the maximum power spectral density shall not exceed 17 dBm in any 1 megahertz band. If transmitting antennas of directional gain greater than 6 dBi are used, the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi. For fixed point-to-point access points operating in the band 5.15-5.25 GHz, the maximum power spectral density shall not exceed 17 dBm in any 1 megahertz band. Fixed point-to-point U-NII devices may employ antennas with directional gain up to 23 dBi without any corresponding reduction in the maximum power spectral density. For the 5.25-5.35 GHz and 5.47-5.725 GHz bands, the maximum power spectral density shall not exceed 11 dBm in any 1 megahertz band. If transmitting antennas of directional gain greater than 6 dBi are used, the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi. For the band 5.725-5.850 GHz, the maximum power spectral density shall not exceed 30 dBm in any 500-kHz band. If transmitting antennas of directional gain greater than 6 dBi are used, the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi. However, fixed point-to-point U-NII devices operating in this band may employ transmitting antennas with directional gain greater than 6 dBi without any corresponding reduction in transmitter conducted power.

	Fixed, point-to-point operations exclude the use of point-to-multipoint systems, omnidirectional applications, and multiple collocated transmitters transmitting the same information. The operator of the U-NII device, or if the equipment is professionally installed, the installer, is responsible for ensuring that systems employing high gain directional antennas are used exclusively for fixed, point-to-point operations.
Procedure:	a) Create an average power spectrum for the EUT operating mode being tested by following the instructions in 12.3.2 for measuring maximum conducted output power using a spectrum analyzer or EMI receiver; that is, select the appropriate test method (SA-1, SA-2, SA-3, or their respective alternatives) and apply it up to, but not including, the step labeled, "Compute power..." (This procedure is required even if the maximum conducted output power measurement was performed using the power meter method PM.) b) Use the peak search function on the instrument to find the peak of the spectrum. c) Make the following adjustments to the peak value of the spectrum, if applicable: 1) If method SA-2 or SA-2A was used, then add $[10 \log (1 / D)]$, where D is the duty cycle, to the peak of the spectrum. 2) If method SA-3A was used and the linear mode was used in step h) of 12.3.2.7, add 1 dB to the final result to compensate for the difference between linear averaging and power averaging. d) The result is the PPSD. e) The procedure in item a) through item c) requires the use of 1 MHz resolution bandwidth to satisfy the 1 MHz measurement bandwidth specified by some regulatory authorities. This requirement also permits use of resolution bandwidths less than 1 MHz "provided that the measured power is integrated to show the total power over the measurement bandwidth" (i.e., 1 MHz). If measurements are performed using a reduced resolution bandwidth and integrated over 1 MHz bandwidth, the following adjustments to the procedures apply: 1) Set $RBW \geq 1 / T$, where T is defined in 12.2 a). 2) Set $VBW \geq [3 \times RBW]$. 3) Care shall be taken such that the measurements are performed during a period of continuous transmission or are corrected upward for duty cycle.

Test Limit:	The frequency tolerance shall be maintained within the band of operation frequency over a temperature variation of 0 degrees to 45 degrees C at normal supply voltage, and for a variation in the primary supply voltage from 85% to 115% of the rated supply voltage at a temperature of 20 degrees C.
Procedure:	The EUT was placed inside the environmental test chamber and powered by nominal AC/DC voltage. b. Turn the EUT on and couple its output to a spectrum analyzer. c. Turn the EUT off and set the chamber to the highest temperature specified. d. Allow sufficient time (approximately 30 min) for the temperature of the chamber to stabilize. e. Repeat step 2 and 3 with the temperature chamber set to the lowest temperature. f. The test chamber was allowed to stabilize at +20 degree C for a minimum of 30 minutes. The supply voltage was then adjusted on the EUT from 85% to 115% and the frequency record.
