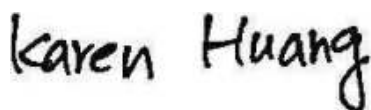

2. SYSTEM TEST CONFIGURATION

2.1. EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner which intends to maximize its emission characteristics in a continuous normal application.

2.2. EUT Exercise

The EUT (Transmitter) was operated in the continuous transmission mode employed with the simulator of the Base Station that fixates at test default channels to fix the Tx frequency which was for the purpose of the measurements.

2.3. Test Procedure

2.3.1 Conducted Measurement at Antenna Port

According to measurement procured TIA/EIA 603C, the EUT is placed on a turn table which is 0.8 m above ground plane. A low loss of RF cable was used to connect the antenna port of EUT to measurement equipment.

2.3.2 Radiated Emissions (ERP/EIRP)

According to measurement procured TIA/EIA 603C, The EUT is placed on a turn table which is 0.8 m above ground plane. The turn table shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both Horizontal and Vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes and measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made "while keeping the antenna in the 'cone of radiation' from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response." is still within the 3dB illumination BW of the measurement antenna according to the requirements in Section 8 and 13.

Fig. 2-1 Configuration of Tested System (Conducted)

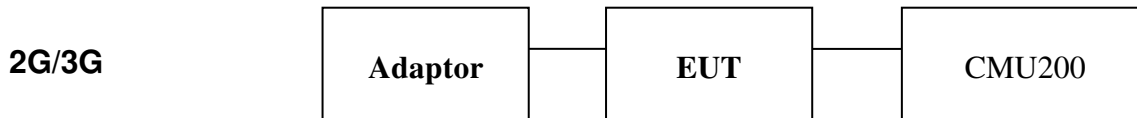


Fig. 2-2 Configuration of Tested System (Radiated)

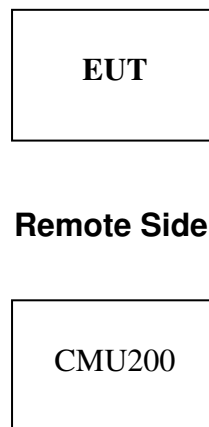

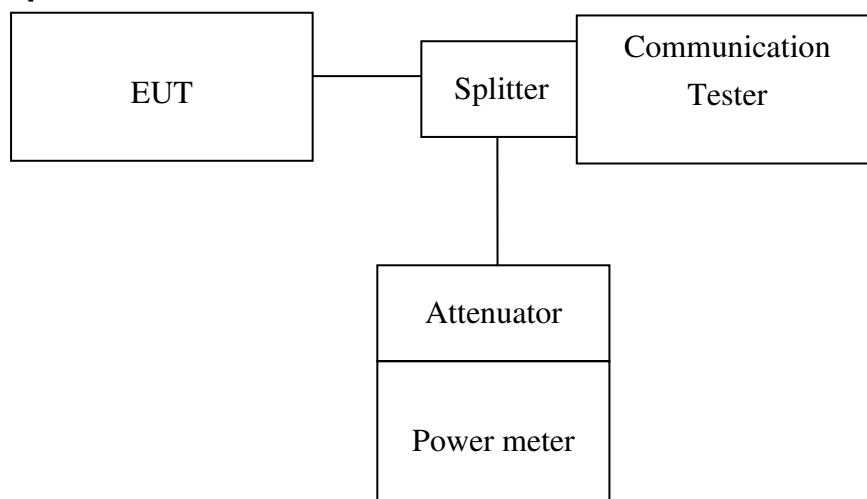

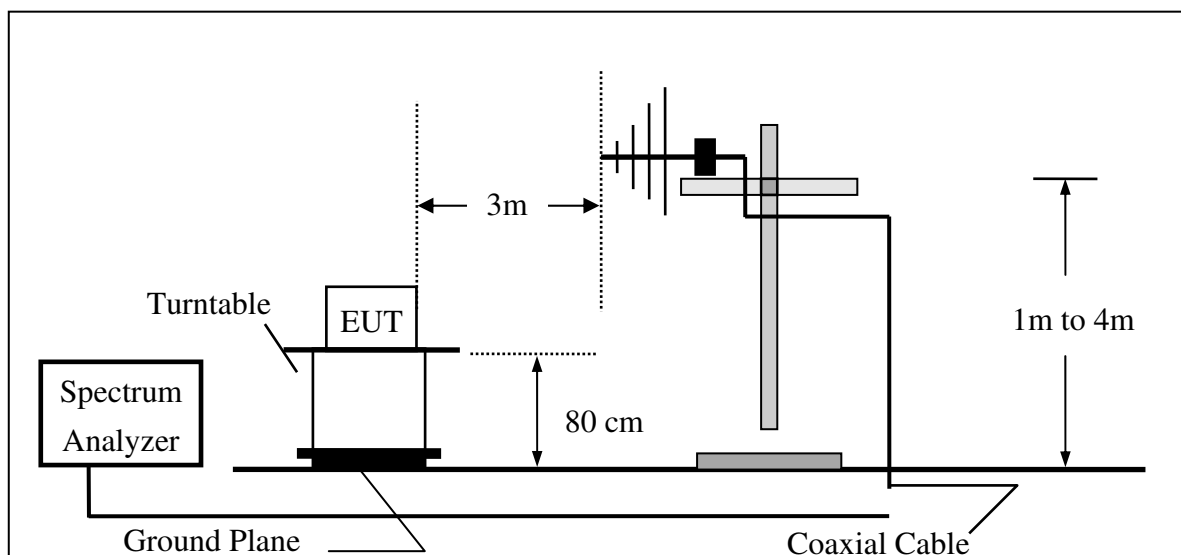

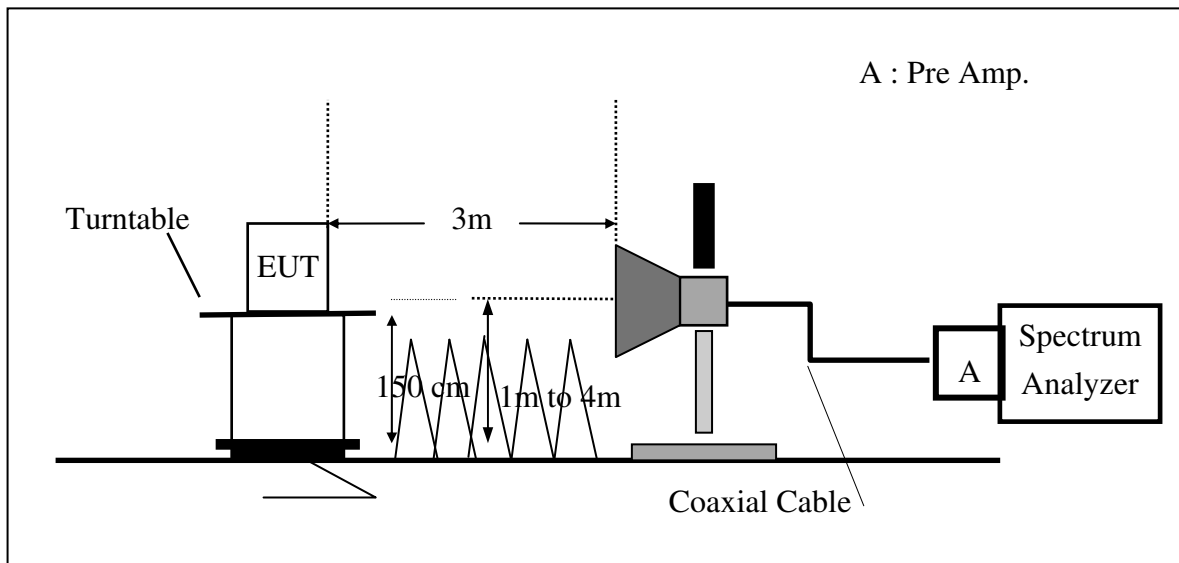

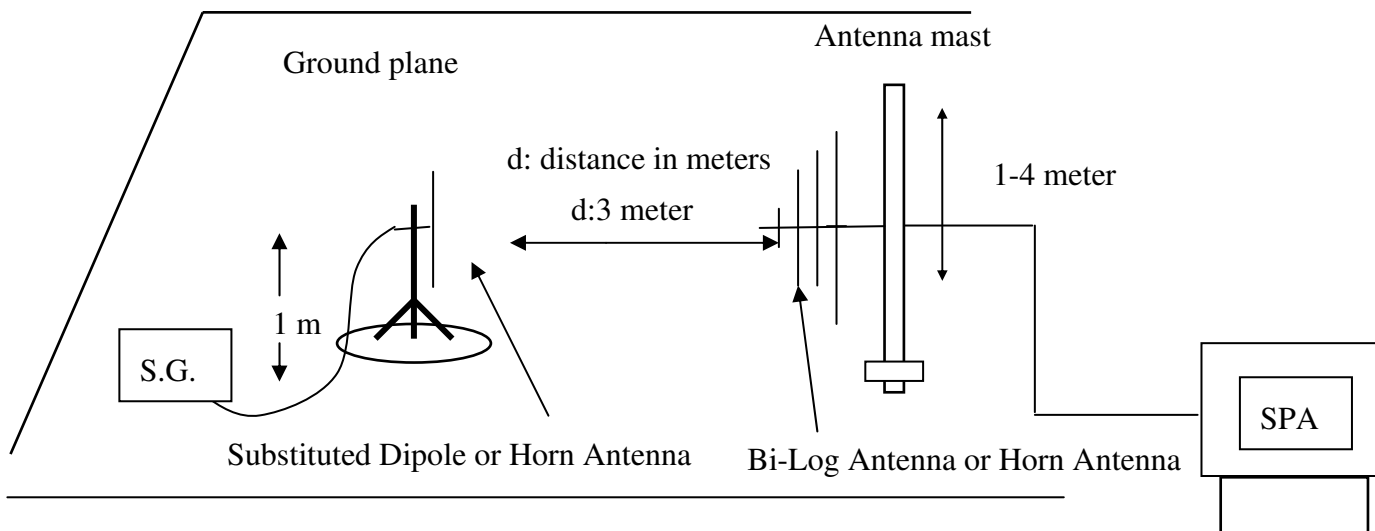

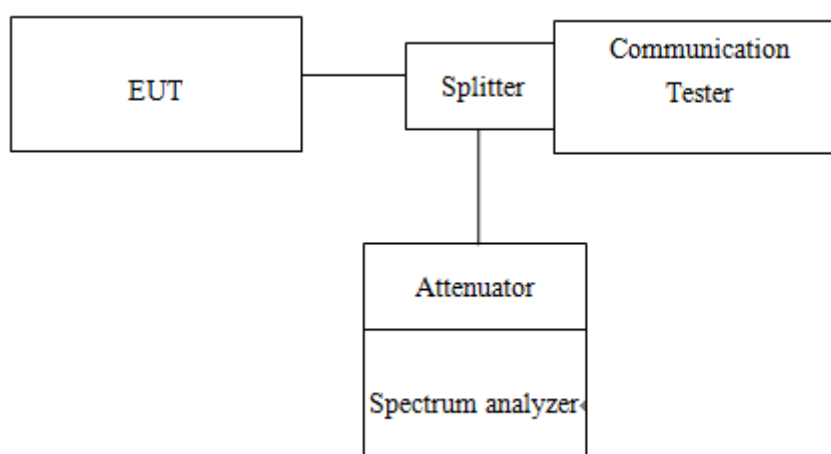

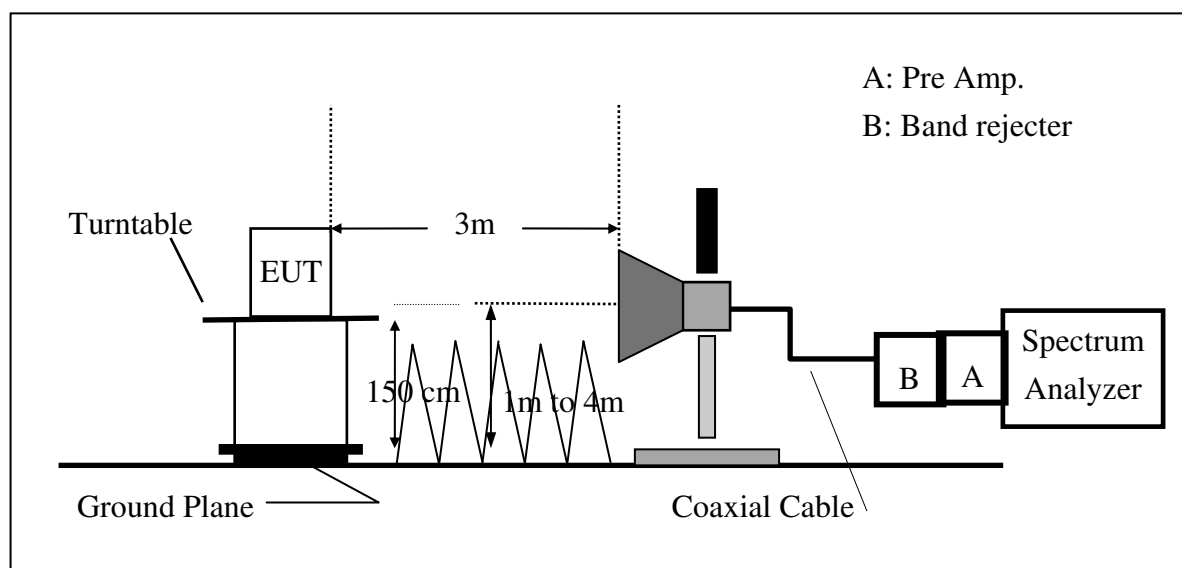

10.3. Measurement Procedure:

The EUT was placed on a non-conductive; the measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and the EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. This maximization process was repeated with the EUT positioned in each of its three orthogonal orientations.

The frequency range up to tenth harmonic was investigated for each of three fundamental frequencies (low, middle and high channels). Once spurious emission was identified, the power of the emission was determined using the substitution method.

The spurious emissions attenuation was calculated as the difference between radiated power at the fundamental frequency and the spurious emissions frequency.
