



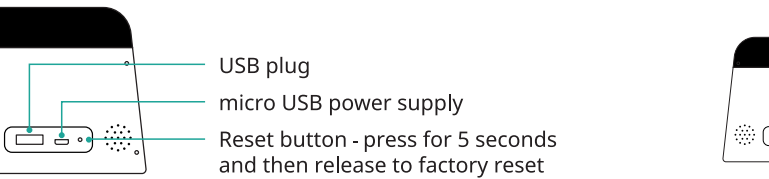
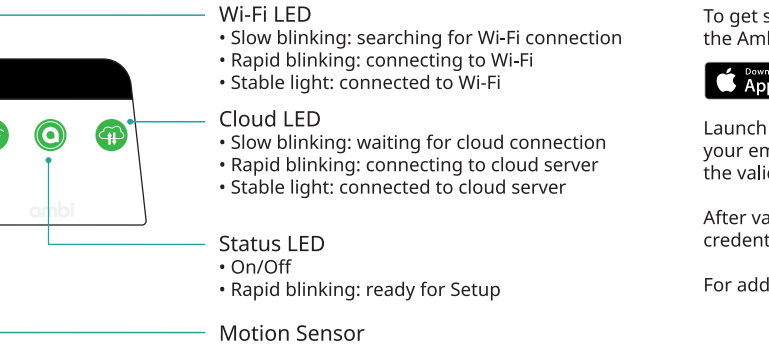

To get started, head to the App Store or Google Play Store and download the Ambi Climate app.

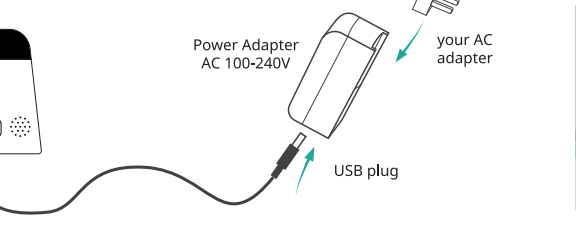


Launch the app. You will be prompted to sign up for an account. Enter your email address and password to create your account, then look for the validation email in your inbox.

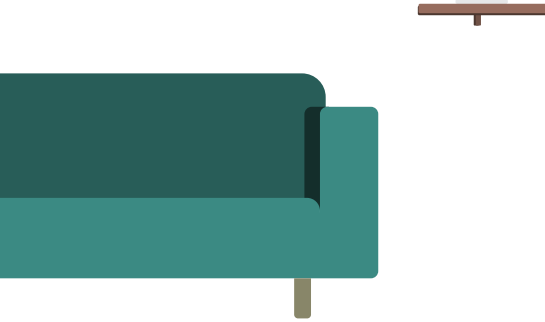
Assembling Ambi Climate



Finding The Perfect Place

To help your Ambi Climate get the most accurate readings from your room, please make sure:

- Your device can "see" your AC
- It sits on a non-insulating flat surface (fabric-covered surfaces are not recommended)
- You put it close to where you are normally in the room
- It isn't near something hot or cold (such as next to a heater, in direct sunlight, or right in front of the AC)
- receives a strong WiFi signal (preferably close to your router if possible)



Here's What You Can Do With Ambi Climate

Get fine-grain climate control and remote access to all your air conditioners with the Ambi Climate app. Improve your indoor comfort with these four modes:

Comfort Mode learns and controls your comfort automatically via artificial intelligence and machine learning while reducing wasted energy.

Temperature Mode keeps a target temperature by adjusting your AC automatically while optimizing your energy usage.

Away Mode maintains conditions in your room based on heating, cooling or humidity thresholds you set, switching on the AC only when needed.

Manual Mode replicates the simple functions of your remote control without any added smart features.

How to use Ambi Climate

Operating limits:

- Indoors
- In direct line of sight of your AC, within 2-4 m
- In an area with adequate ventilation
- - 40~40°C Normal: 25°C
- Not under direct sunlight
- Not in a high humidity environment (>90%)
- Not in or near water
- Not near other transmitting devices
- Do not cover
- Not near heat generating devices
- Keep out of reach of children and pets
- AC 100-240V, Normal: 230V
- Use only the accessories provided by the manufacturer

How to care for Ambi Climate

Care tips:

- Don't drop the device
- Do not disassemble
- Do not modify the product
- Do not put objects into the product
- Do not use with 3rd party USB power supplies/cables
- Do not use USB power supply for any other purpose
- Do not plug in unapproved USB devices
- Do not expose to high (>50C) or low (<-10C) temperatures

1. OUR WARRANTY FOR THE PRODUCT

1.1

Subject to the terms and conditions as otherwise agreed in the terms of sales of the website of Ambi Labs Limited ("Ambi") and the sales and purchase agreement (if any), these terms and conditions apply to the warranty provided by Ambi in respect of Ambi Climate ("Product") purchased from Ambi.

1.2

Ambi shall not in any circumstances be liable for a breach of the warranty unless:

(a)

You give written notice by email of the defect to Ambi at support@ambiclimate.com together with the email of the original purchase invoice sent by Ambi within seven days of the time when you discover or ought to have discovered the defect; and

(b)

After receiving the notice, Ambi is given a reasonable opportunity to examine such Product and you (if asked to do so by Ambi) return such Product to Ambi's place of business at 1903, 19/F, Loon Kee Building, 267-275 Des Voeux Road Central, Sheung Wan, Hong Kong for the examination to take place there.

1.3

We provide a warranty that on delivery, and for a period of 12 months from delivery (the "Warranty Period"), the Products shall be free from material defects. During the Warranty Period, Ambi undertakes, at its sole discretion, either to (a) repair or replace any Product or component which is found to be defective as a result of faulty materials or workmanship; or (b) accept the return of the Product and refund the purchase price paid by the original purchaser for the Product. Repair or replacement may be made with new or refurbished product or components, at the sole discretion of Ambi. This warranty does not apply in the circumstances described in clause 1.4.

1.4

The warranty in clause 1.3 does not apply to any defect in the Products arising from:

(a)

fair wear and tear of the Product and parts, which does not affect the functionality or performance of the Product;

(b)

malfunction, loss or damage to the Product caused by you or by any third party arising from or in connection with:

(i)

abuse, tampering, modification and disassembly of the Product;

(ii)

negligence and/or failure to operate or use the Product in accordance with user instructions;

(iii)

wilful damage, abnormal storage or working conditions;

(iv)

hardware and/or software installation (including virus infection) of the Product; or

(v)

alteration made by you or a third party who is not one of our authorised repairers.

(c)

malfunction, loss or damage to Product caused by acts of god or any other force majeure event;

(d)

Product with its serial number removed, defaced, damaged or altered; or

(e)

your breach of these Terms and Conditions, terms of sale of Ambi's website, or any provisions of the sales and purchase agreement (if any) of the Product.

1.5

The warranty provided in these Terms and Conditions are in lieu of all other warranties expressed or implied including merchantability, satisfactory quality, and fitness for a particular purpose and all such other warranties of the Product. Ambi does not make any other warranty or condition of any kind.

2. DISCLAIMERS OF LIABILITY

2.1

Ambi only supplies the Products for domestic and private use. You agree not to use the product for any commercial and/or business purpose.

2.2

Nothing in these Terms and Conditions limits or excludes our liability for:

(a)

death or personal injury caused by our negligence; and

(b)

fraud or fraudulent misrepresentation.

2.3

Subject to clause 2.2, Ambi will under no circumstances whatsoever be liable to you, whether in contract, tort (including negligence), breach of statutory duty, or otherwise, arising under or in connection with the Terms and Conditions, terms of sales on Ambi's website and sales and purchase agreement for:

(a)

any loss of profits, sales, business, or revenue;

(b)

loss or corruption of data, information or software;

(c)

loss of business opportunity;

(d)

loss of anticipated savings;

(e)

loss of goodwill; or

(f)

any indirect or consequential loss.

2.4

Subject to clause 2.2, our total liability to you in respect of all losses arising under or in connection with the Terms and Conditions, terms of sales of Ambi's website and sales and purchase agreement (if any), whether in contract, tort (including negligence), breach of statutory duty, or otherwise, shall in no circumstances exceed the purchase price paid by the original purchaser for the Product.

3. GOVERNING LAW

These Terms and Conditions and any disputes or claims arising out of or in connection with it or its subject matter or formation (including without limitation disputes or claims) are governed by and construed in accordance with the law of Hong Kong.

4. JURISDICTION

Each party irrevocably agrees that the courts of Hong Kong shall have exclusive jurisdiction to settle any dispute or claim arising out of or in connection with the Terms and Conditions or its subject matter or formation (including noncontractual disputes or claims).
