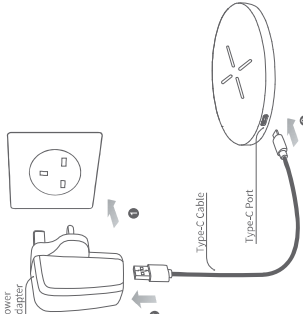
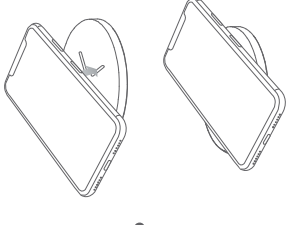

You need to buy power adapter separately/Type-C to Type-C charging cable and power adapter need to buy separately.	Charging Mode  ① Make sure the wireless charger dock connect to the power supply. If the power supply is not the power supply of the power supply, the indicator light turns on and the phone is not charged. The charger is in standby mode when take away the phone from charging pad. Note: When Samsung phones which are built-in wireless charging function get fully charged with this product, it don't move the phone in a long time, the battery power keeps in fully charged status(supplementary charge).
