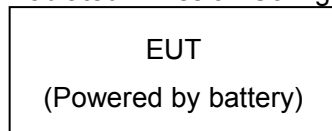

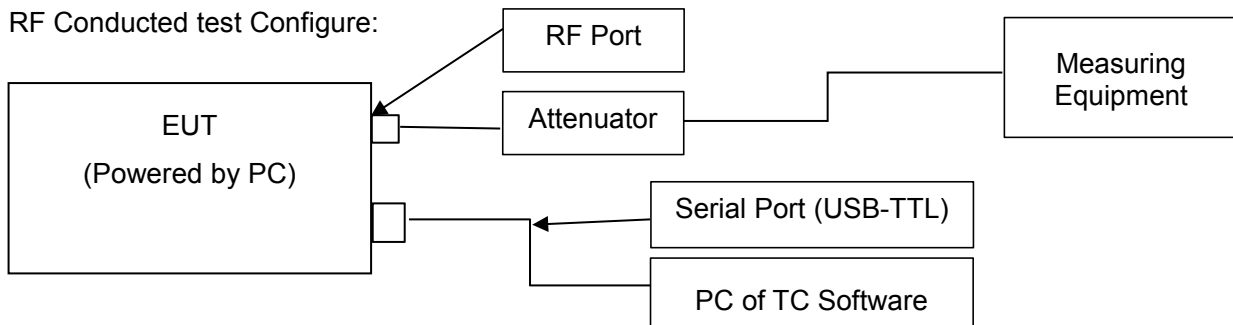

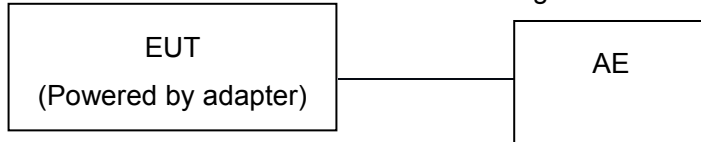
Radiated Emission Configure:

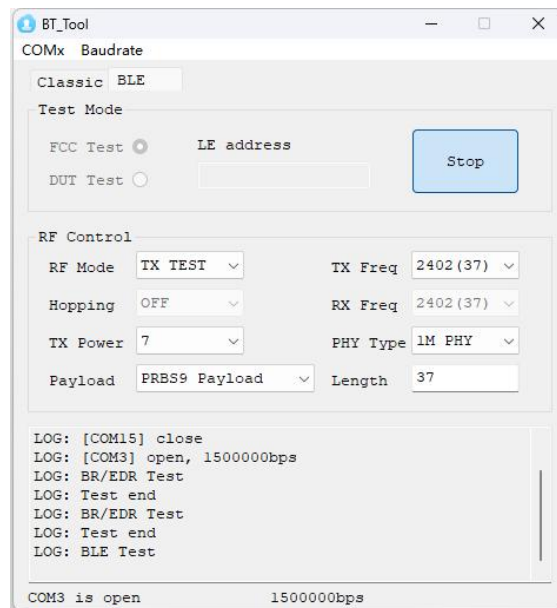

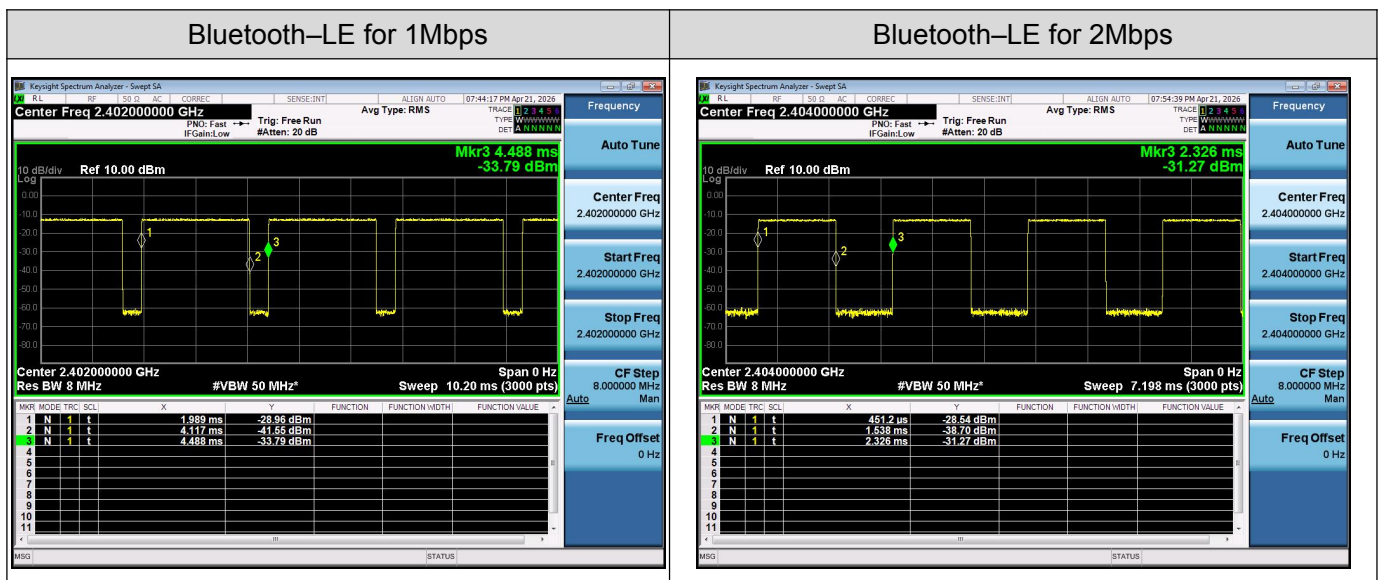
6. Duty Cycle Measurement

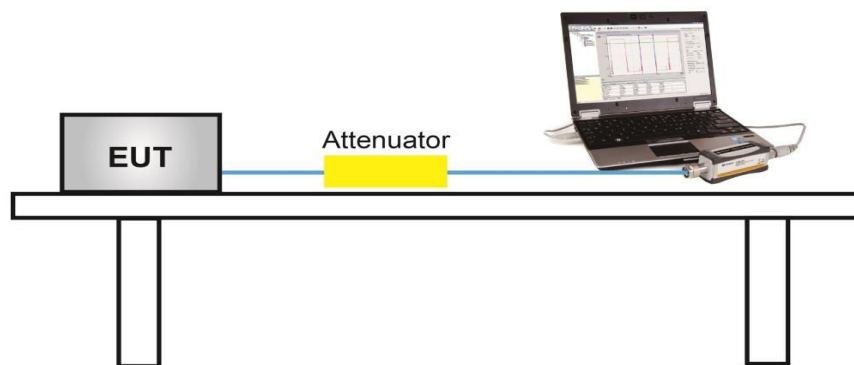

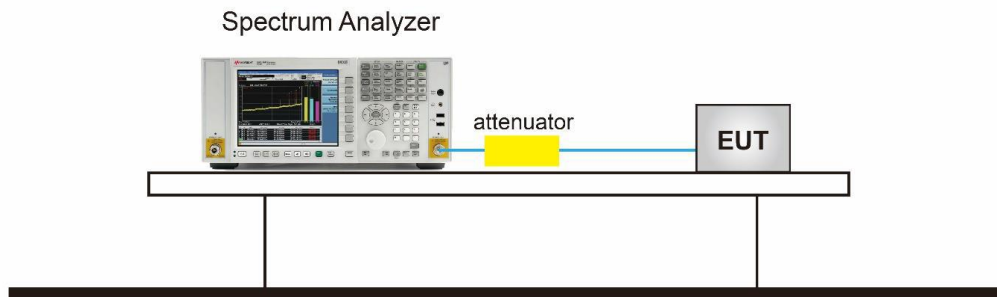

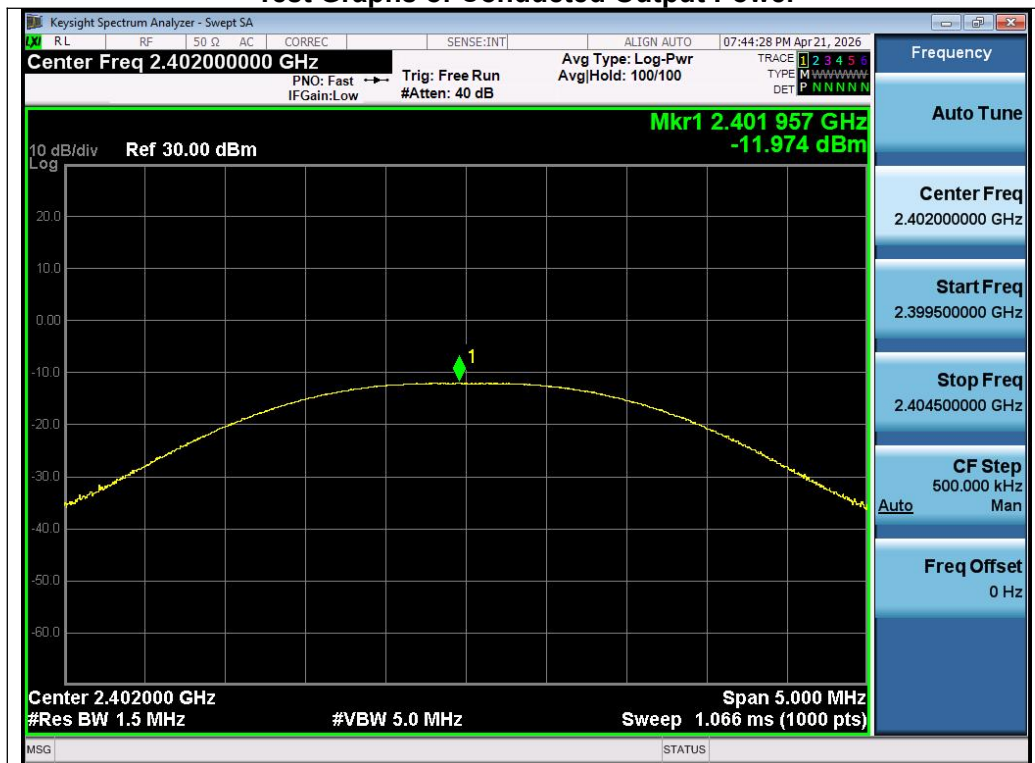

Test Graphs of Conducted Output Power

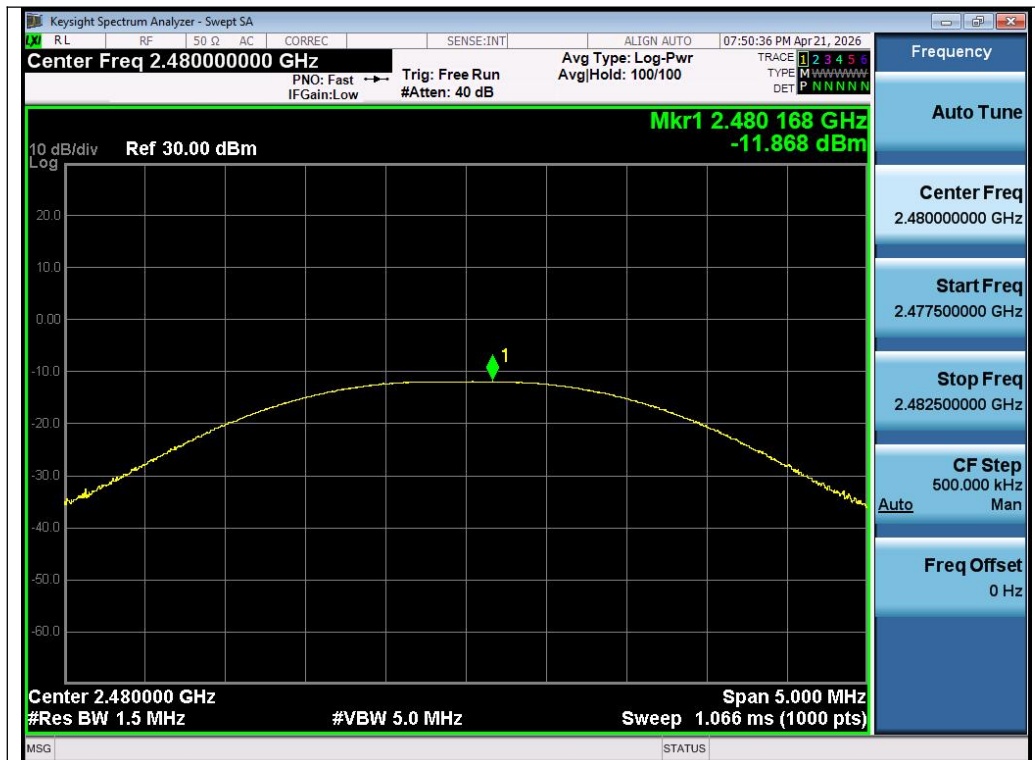


Test_Graph_LE1M_ANT1_2402_1Mbps_Peak Power

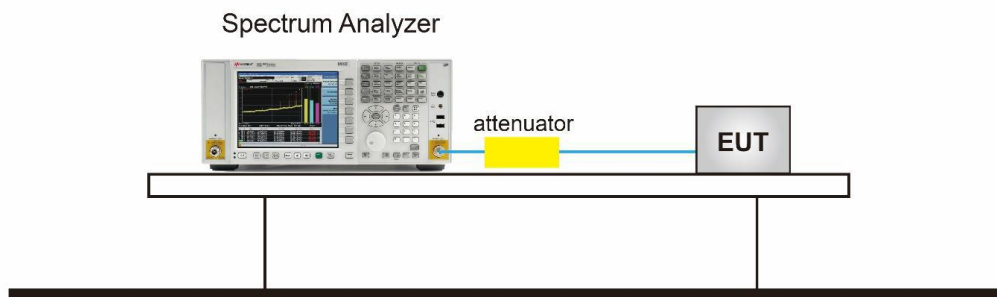

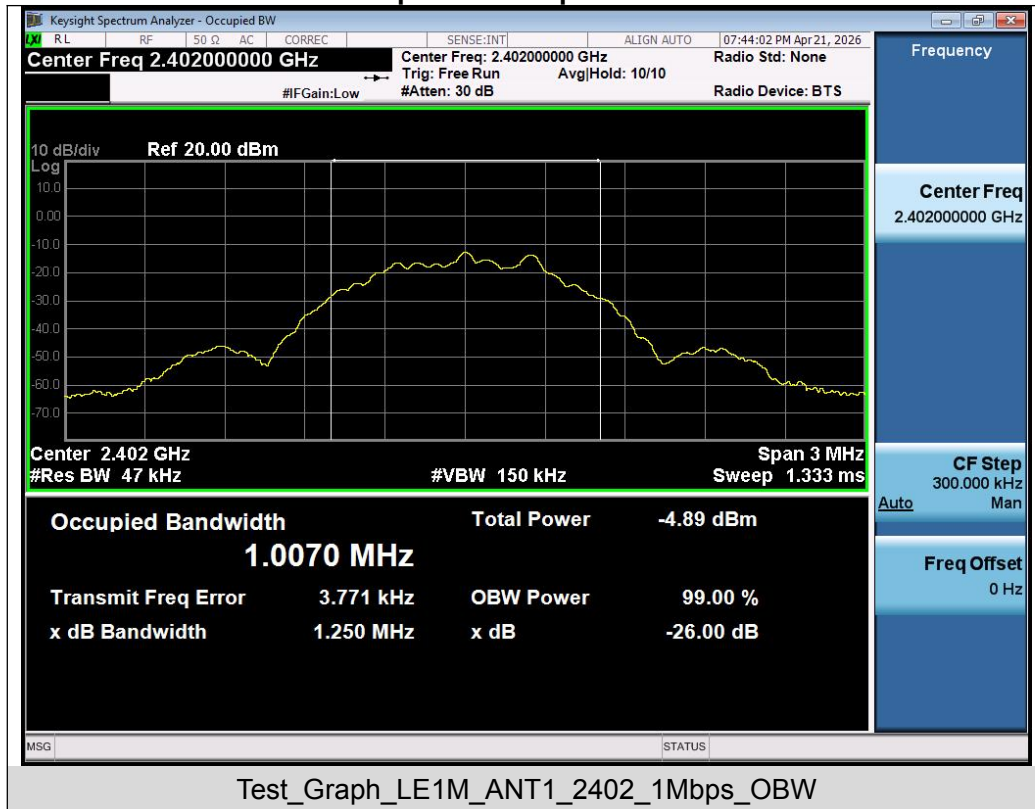

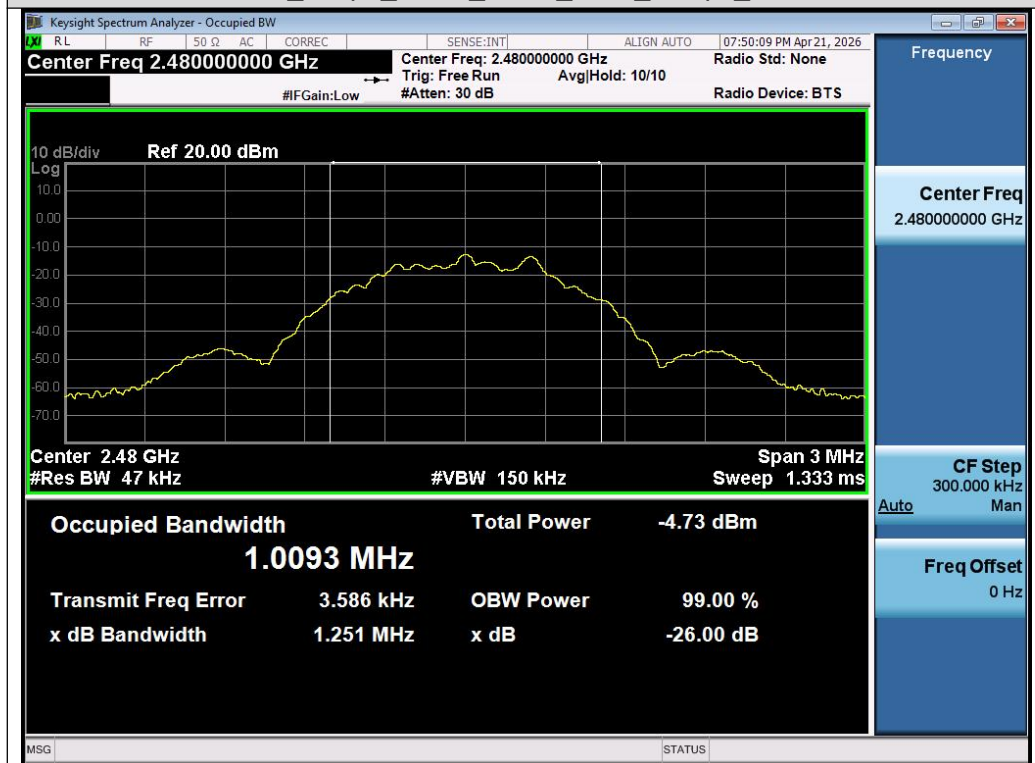
Test Graphs of Occupied Bandwidth

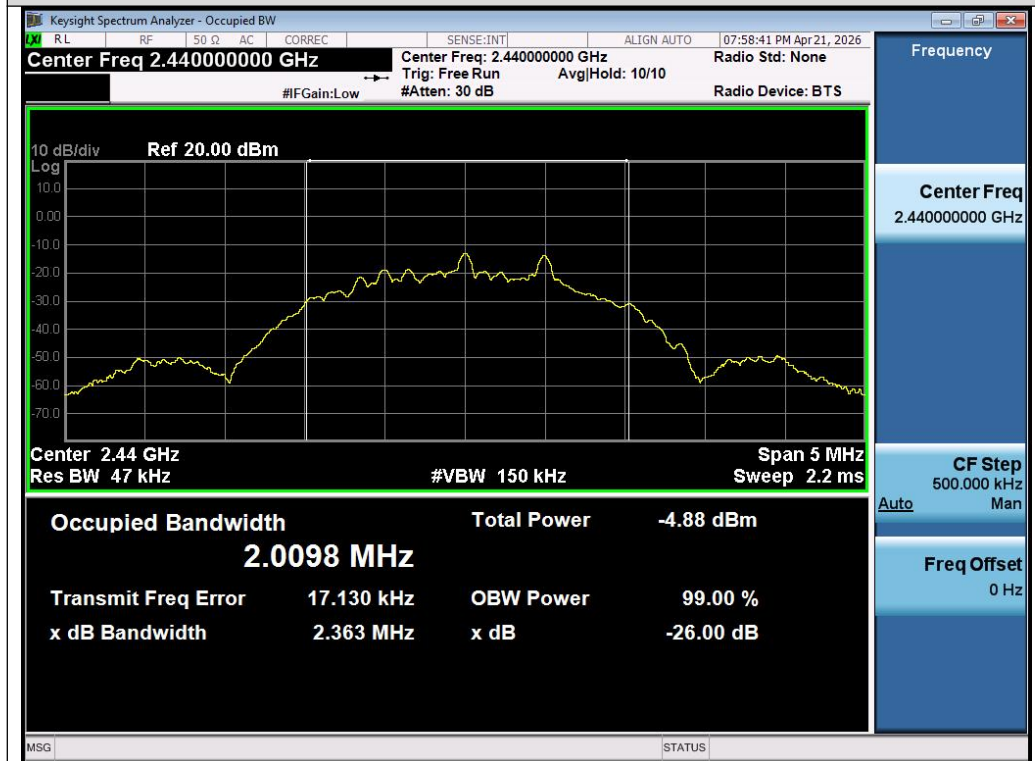

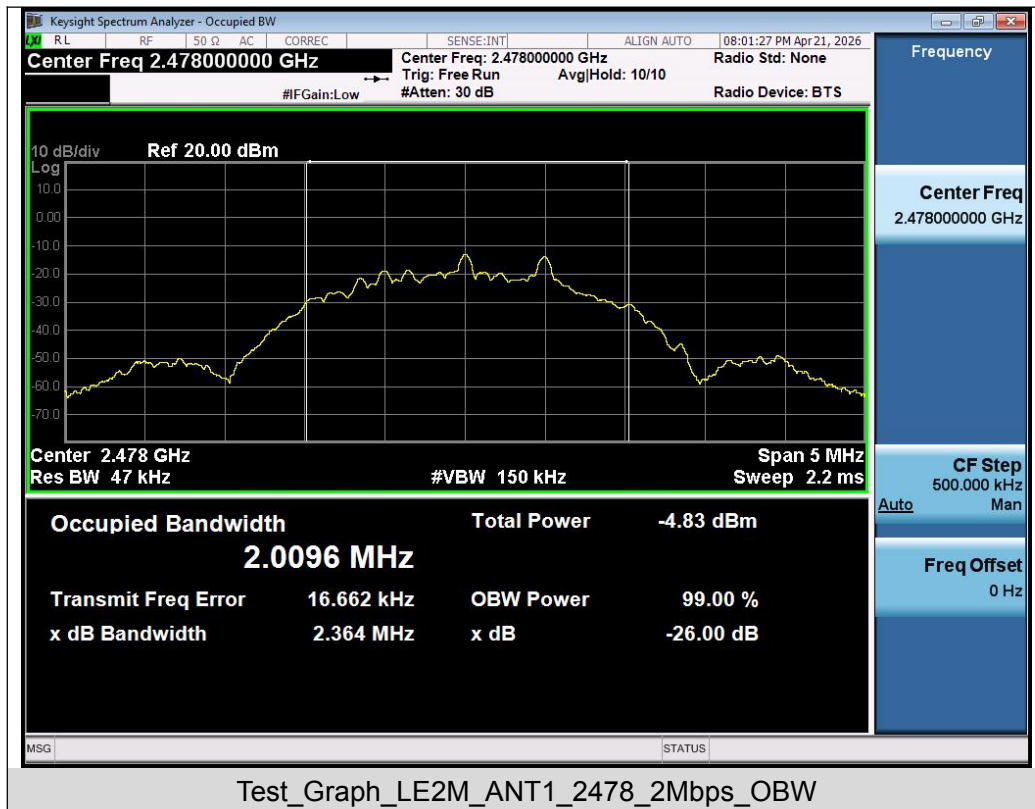


Test_Graph_LE2M_ANT1_2404_2Mbps_OBW

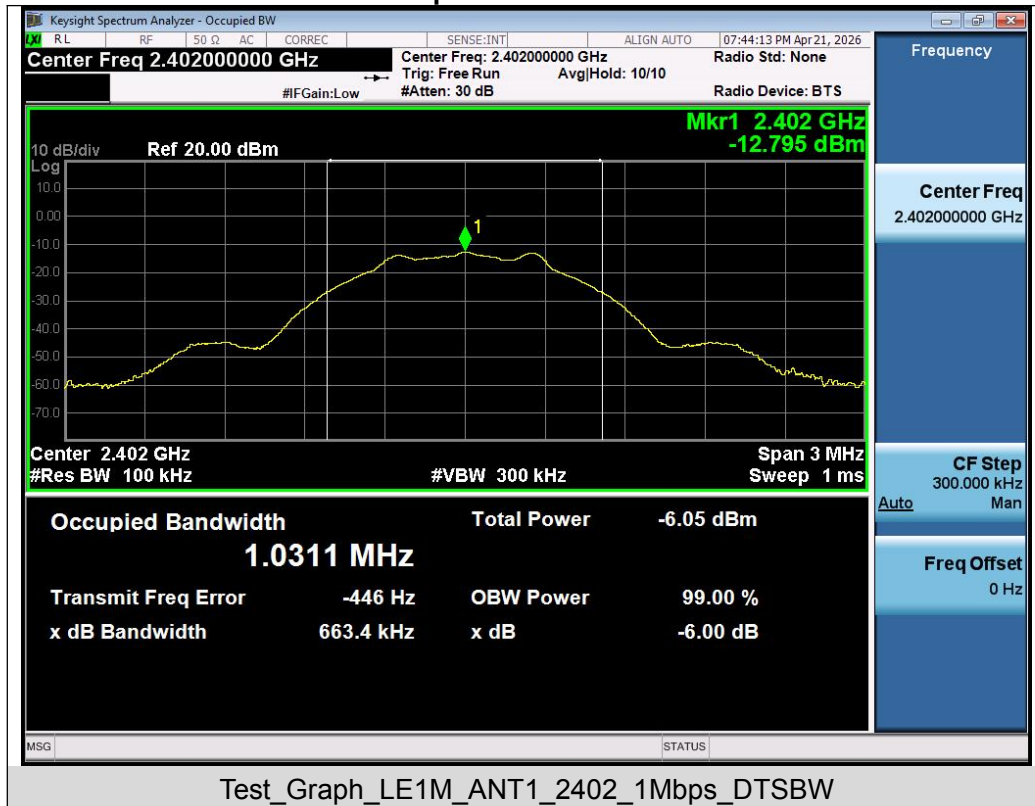


Test_Graph_LE2M_ANT1_2440_2Mbps_OBW

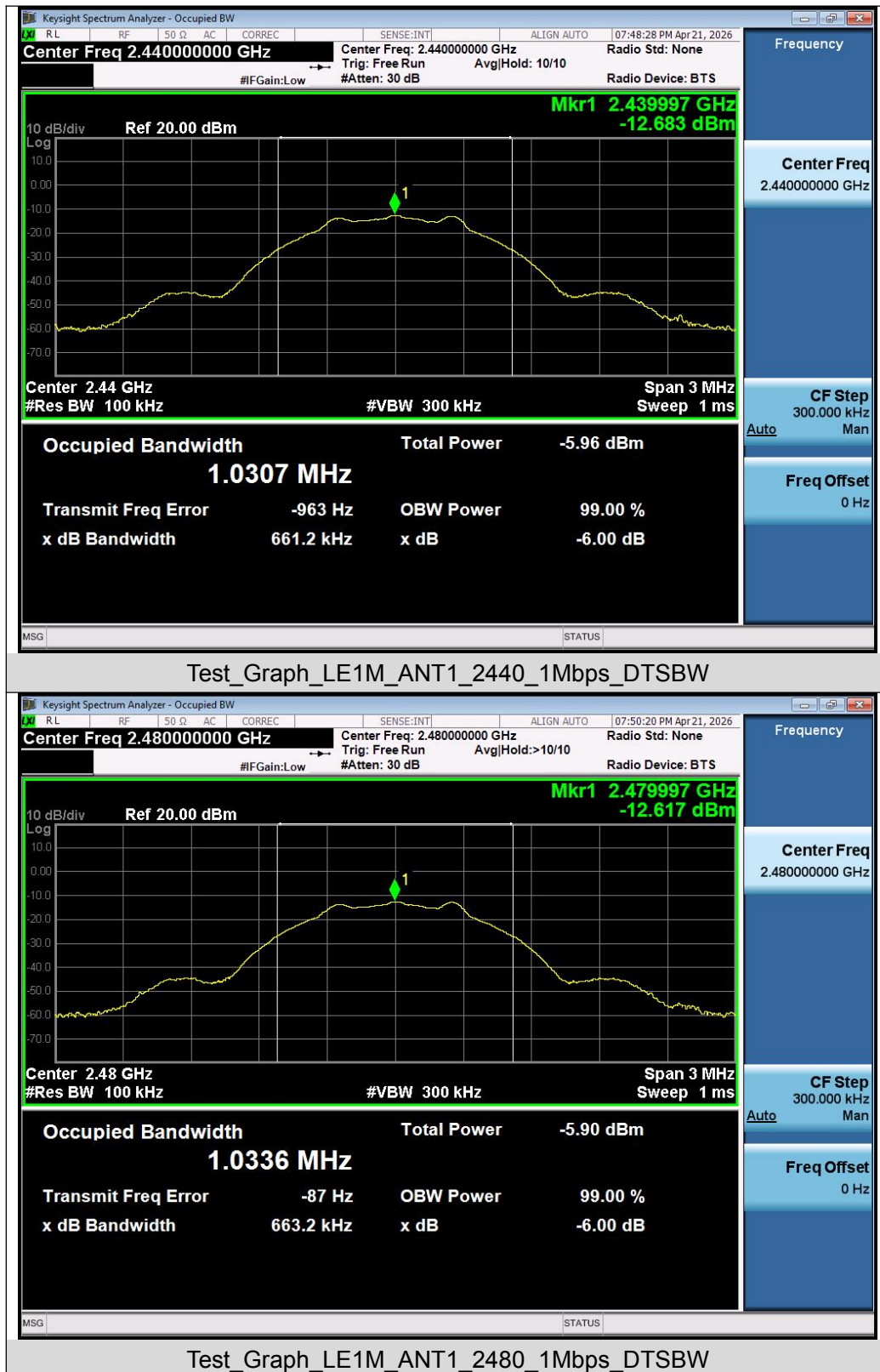


Test Graphs of DTS Bandwidth

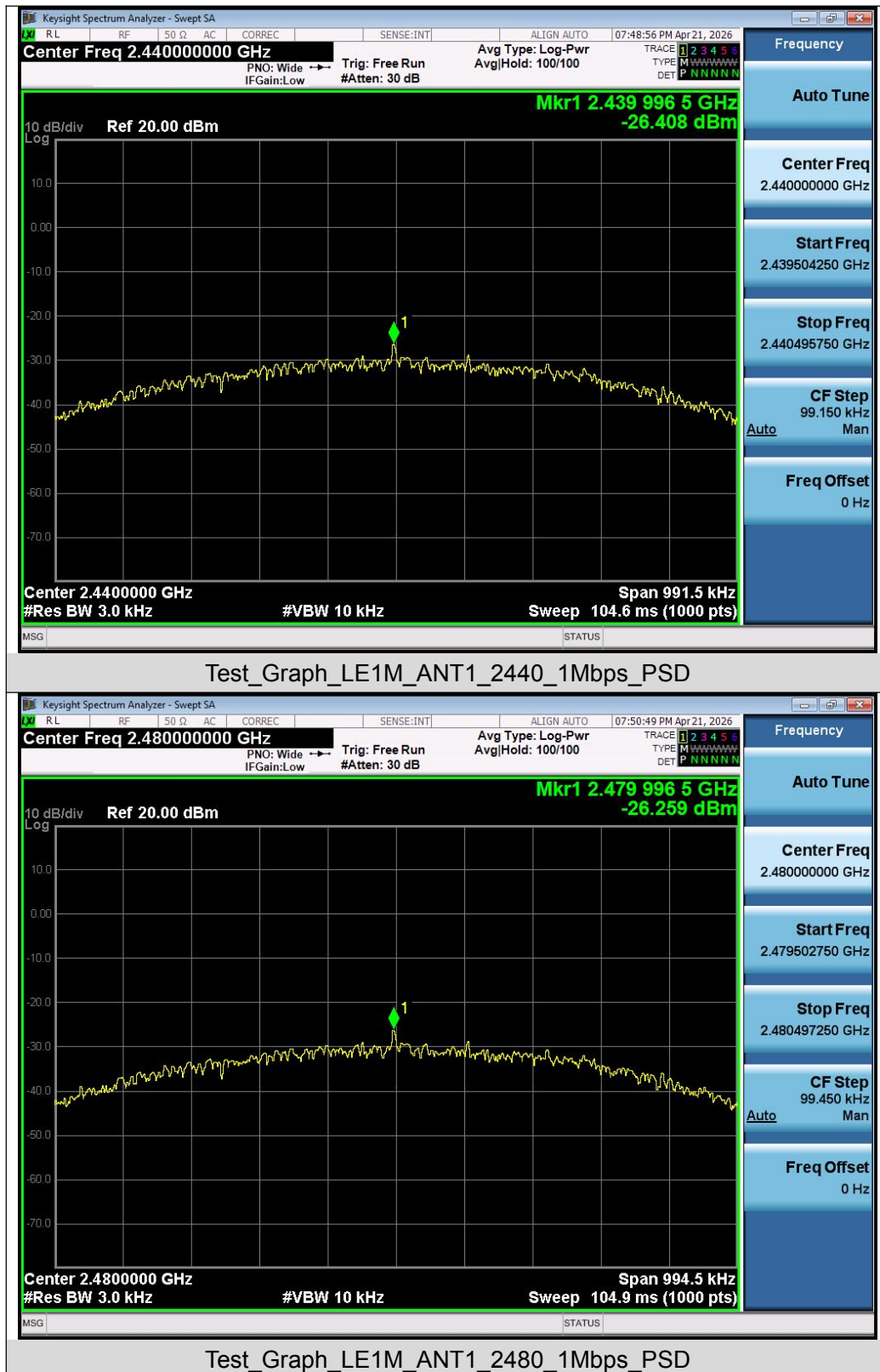

Test_Graph_LE1M_ANT1_2440_1Mbps_Lower Band Emissions



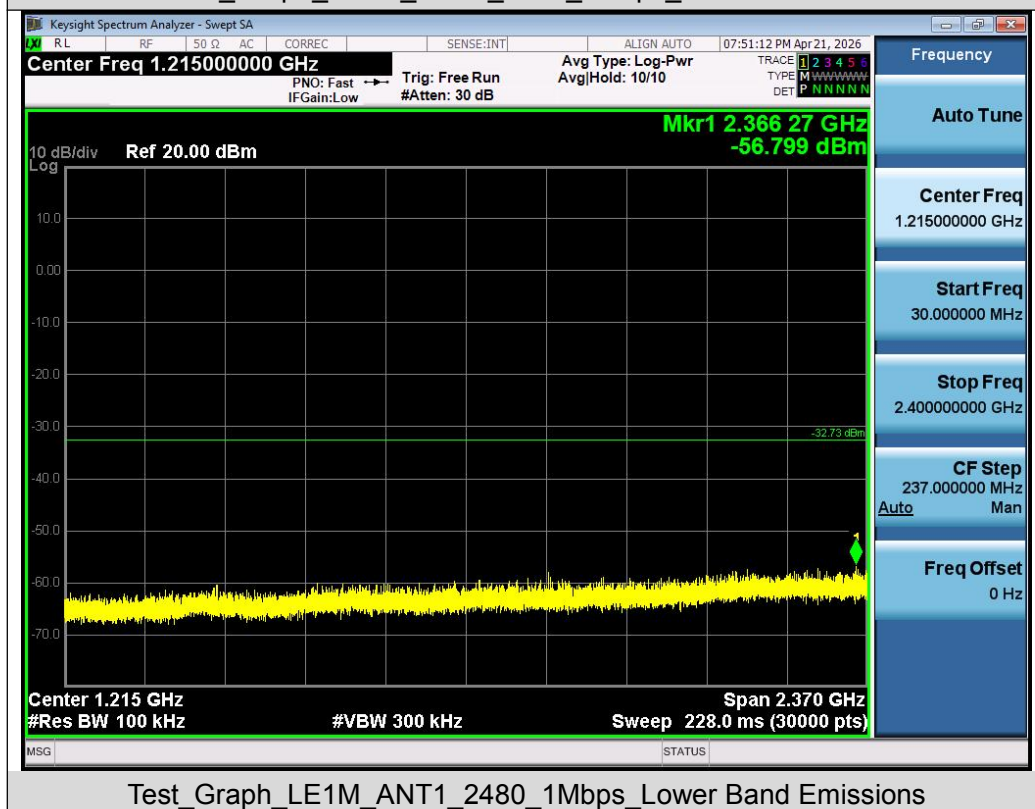

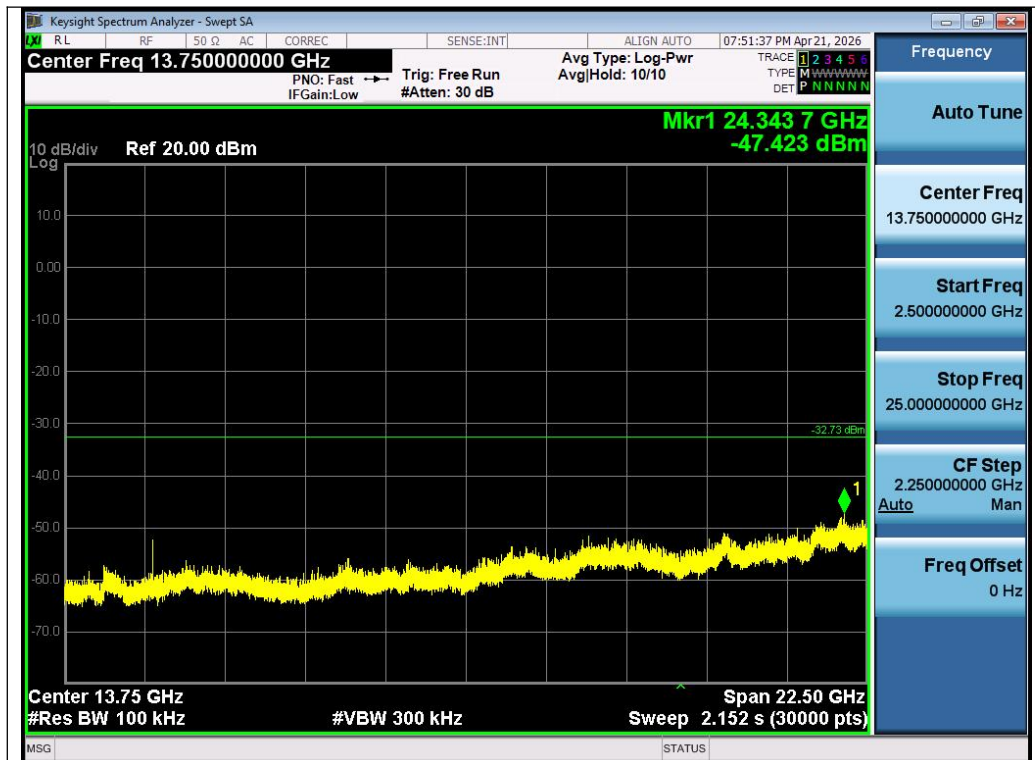
