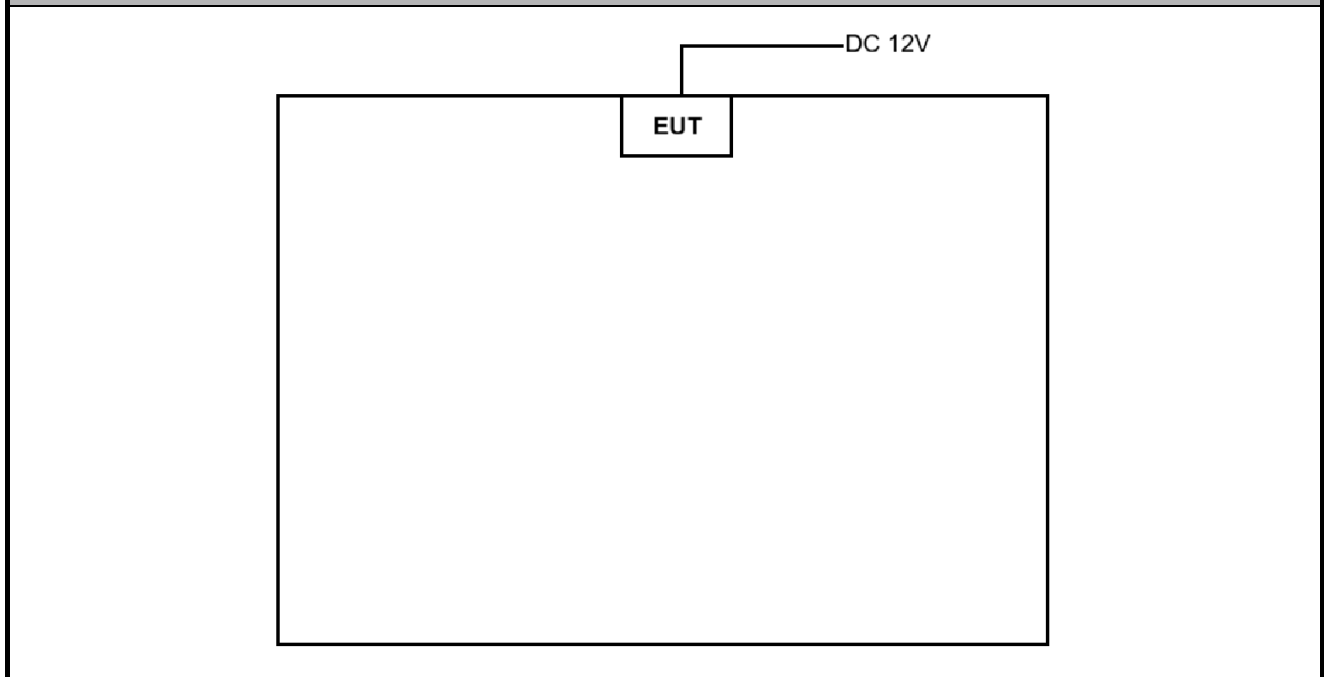

6.2. 6 dB Bandwidth Measurement

6.2.1. Test Limit

The minimum 6 dB bandwidth shall be at least 500 kHz.

6.2.2. Test Procedure

6.2.3. Test Setting

1. The Spectrum's automatic bandwidth measurement capability was used to perform the 6 dB bandwidth measurement. The "X" dB bandwidth parameter was set to $X = 6$. The bandwidth measurement was not influenced by any intermediate power nulls in the fundamental emission.
2. RBW = 1% to 5% of the OBW, but not less than 100 kHz
3. VBW $\geq 3 \times$ RBW
4. Detector = Peak
5. Trace mode = Max hold
6. Sweep = Auto couple
7. Allow the trace to stabilize

6.3. Output Power Measurement

6.3.1. Test Limit

The maximum output power shall be less 1 Watt (30 dBm).

The conducted output power limit specified in paragraph FCC Part 15.247(b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. If transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs FCC Part 15.247(b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

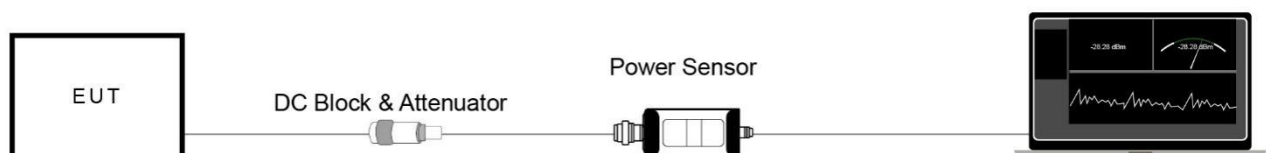
Method PKPM1 (Peak Power Measurement of Signals with DTS BW $\leq$ 50 MHz)

Peak power measurements were performed only when the EUT was transmitting at its maximum power control level using a broadband power meter with a pulse sensor. The pulse sensor employs a VBW = 50 MHz so this method was only used for signals whose DTS bandwidth was less than or equal to 50 MHz.

Average Power Measurement

Average power measurements were performed only when the EUT was transmitting at its maximum power control level using a broadband power meter with a pulse sensor. The power meter implemented triggering and gating capabilities which were set up such that power measurements were recorded only during the ON time of the transmitter.

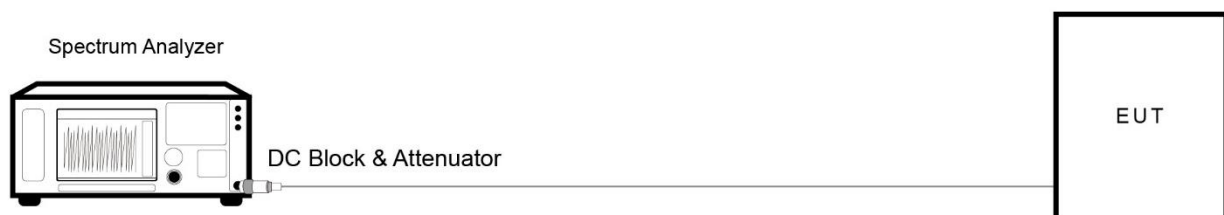

The limit for out-of-band spurious emissions at the band edge is 20 dB below the fundamental emission level, as determined from the in-band power measurement of the DTS channel performed in a 100 kHz bandwidth per the PSD procedure.

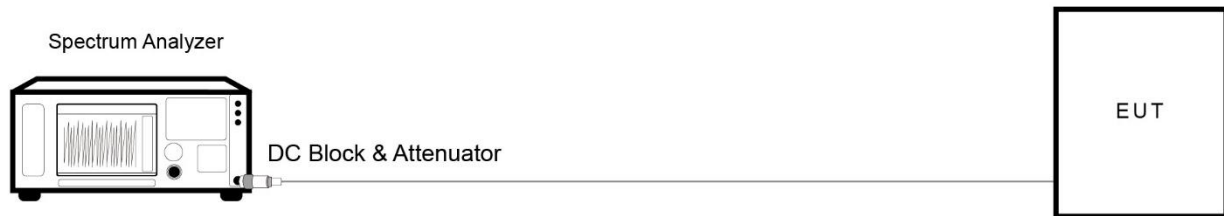

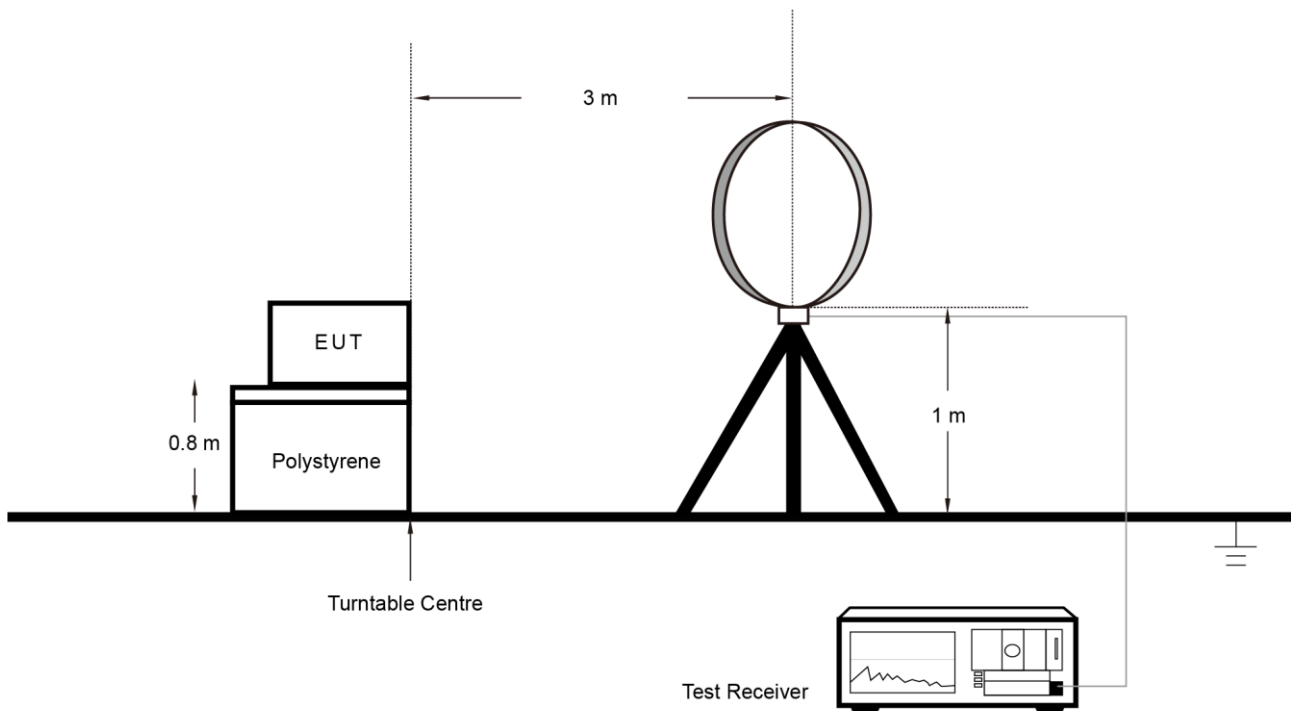

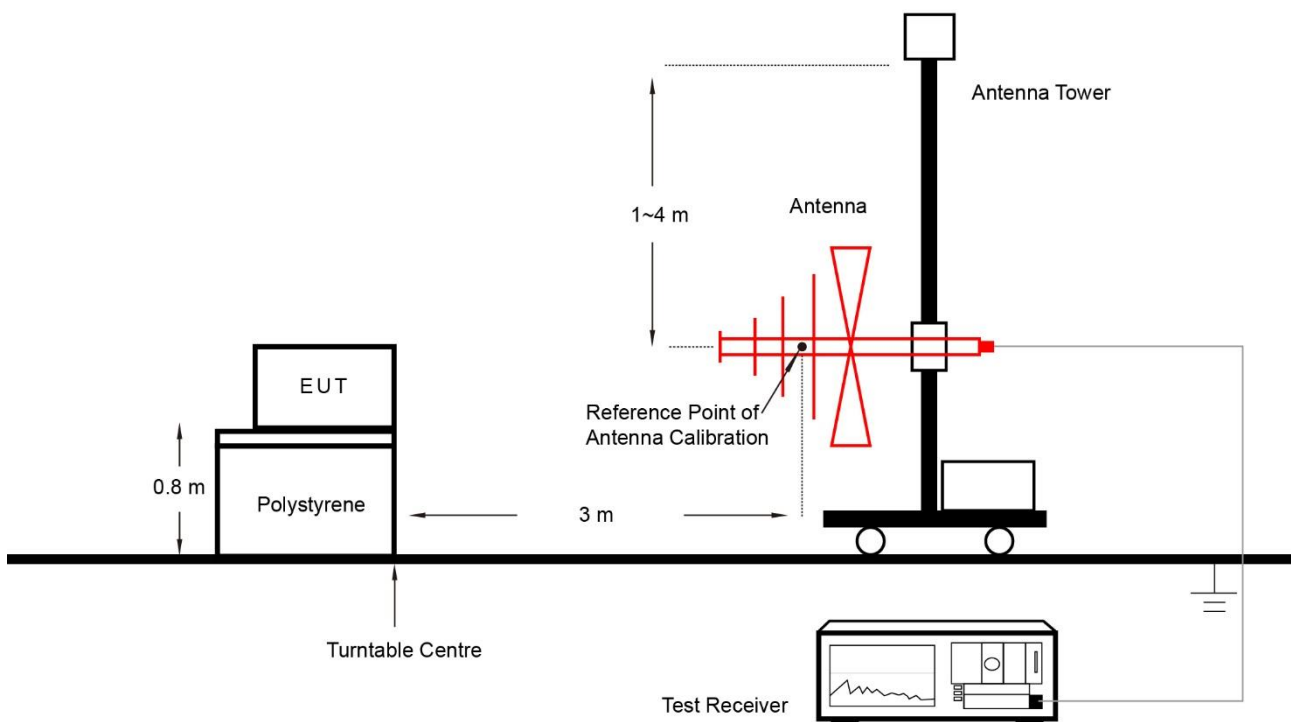

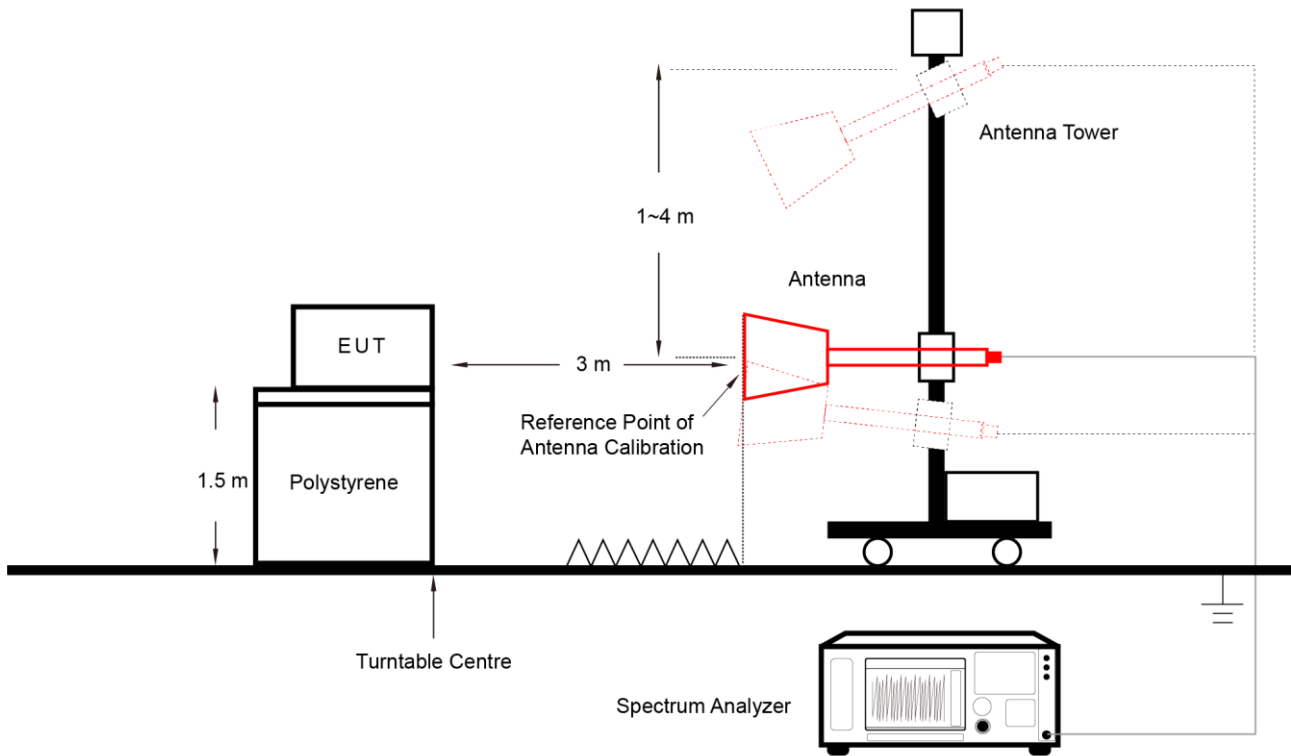

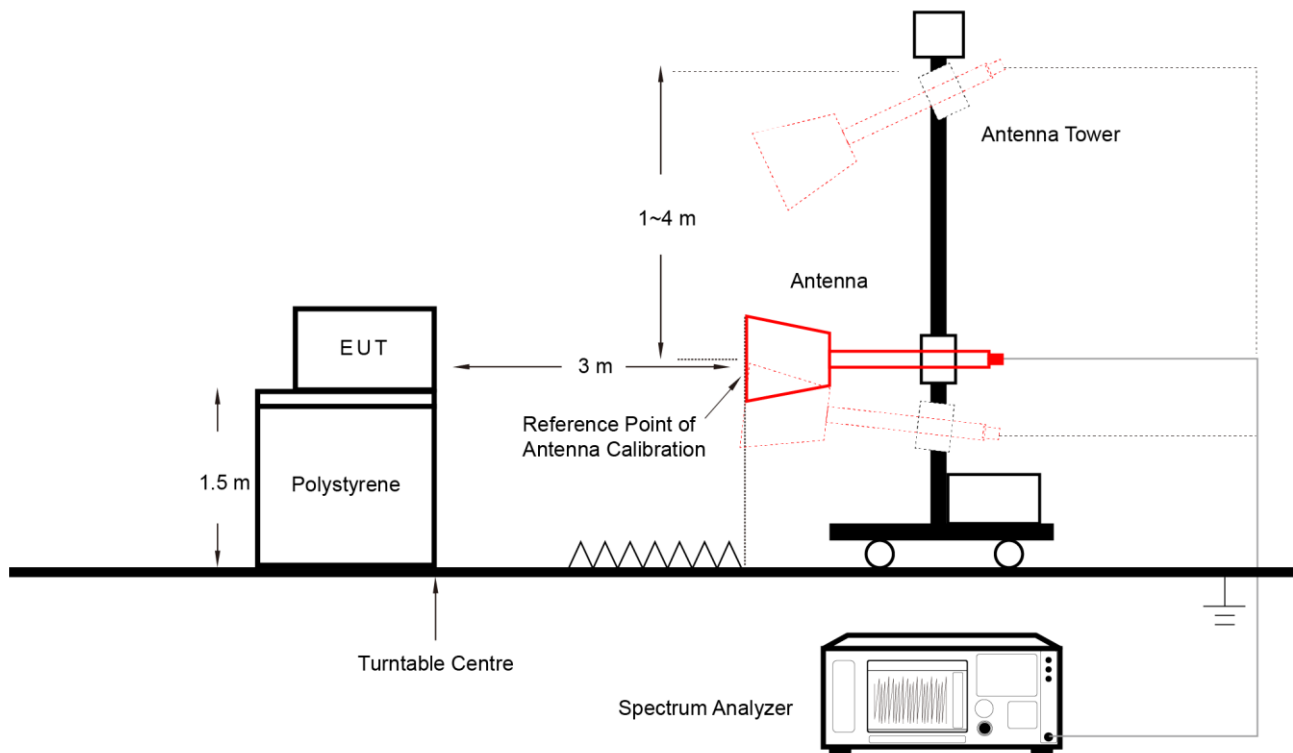

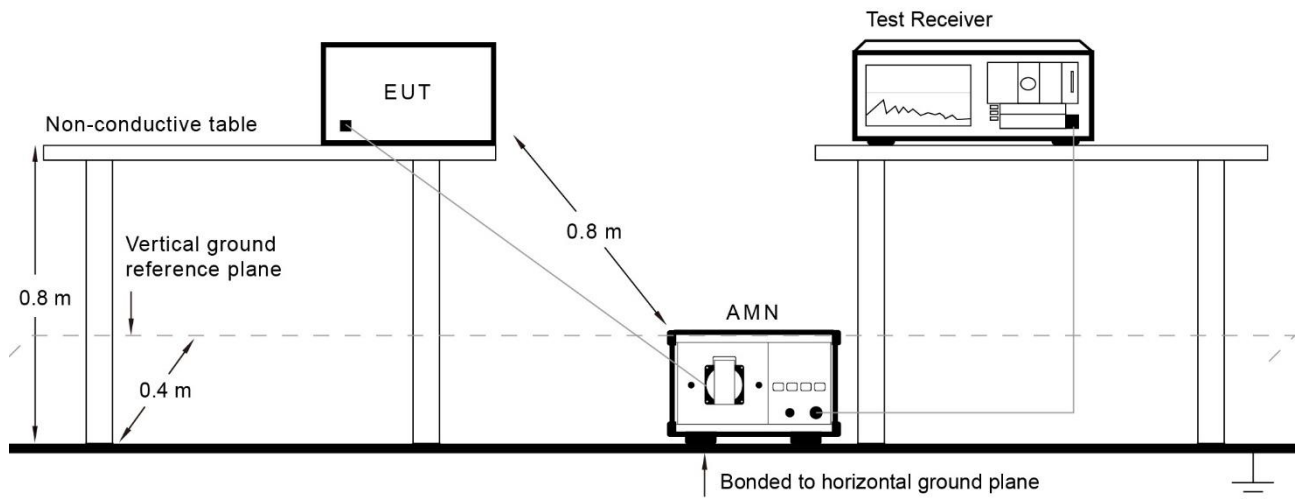

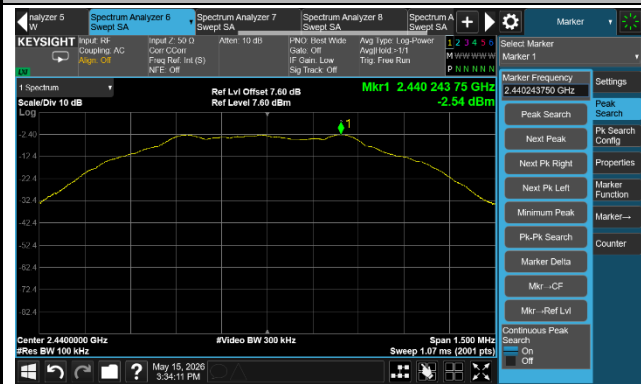

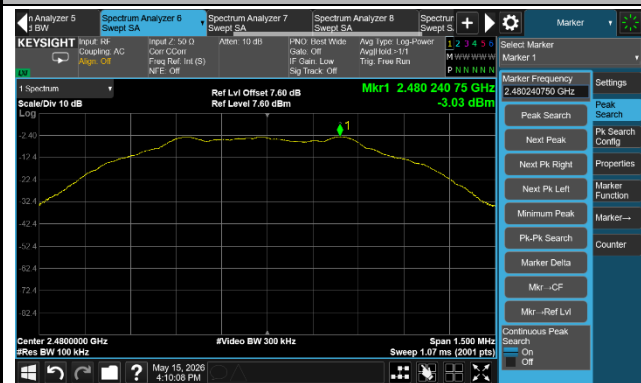

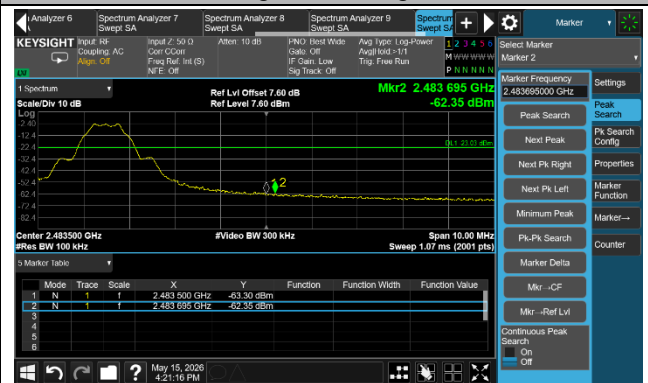

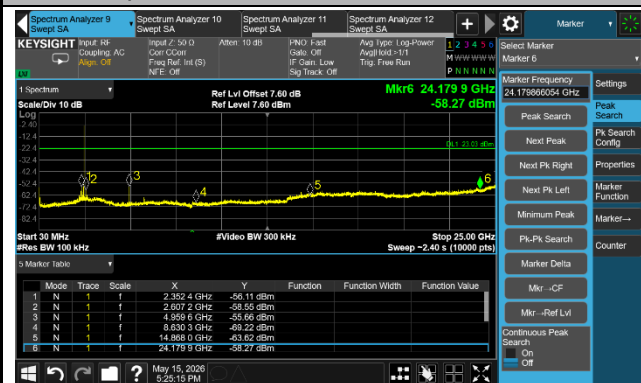
