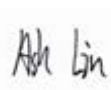

Objective

This report is prepared on behalf of *Xiamen New Sound Technology Co., Ltd* in accordance with Part 2-Subpart J, Part 15-Subparts A and C of the Federal Communication Commission's rules.

The tests were performed in order to determine compliance with FCC Part 15, Subpart C, and section 15.203, 15.205, 15.209 and 15.247 rules.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.10-2020, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices.

And KDB 558074 D01 15.247 Meas Guidance v05r02.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Xiamen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Test Facility

The test site used by Bay Area Compliance Laboratories Corp. (Xiamen) to collect test data is located on the Unit 102, No. 902 Meifeng South Road, Binhai West Avenue, Science and Technology Innovation Park, Torch High tech Zone XiaMen.

Bay Area Compliance Laboratories Corp. (Xiamen) Lab is accredited to ISO/IEC 17025 by A2LA (Certificate Number: 7134.01) and the lab has been recognized as the FCC accredited lab under the KDB 974614 D01, the FCC Designation No. : CN1384.

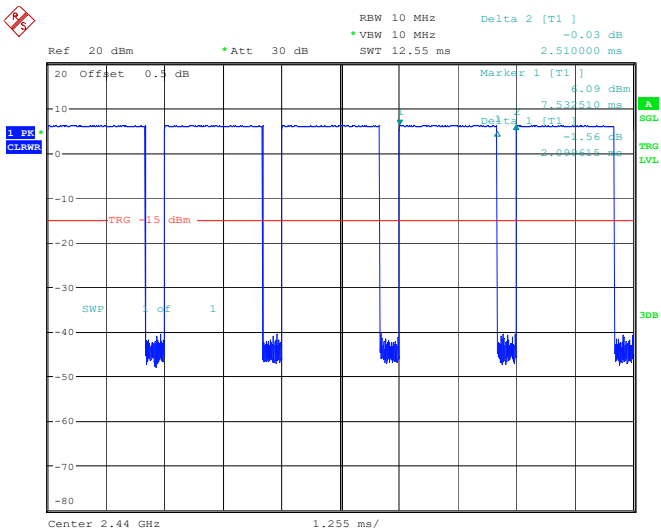

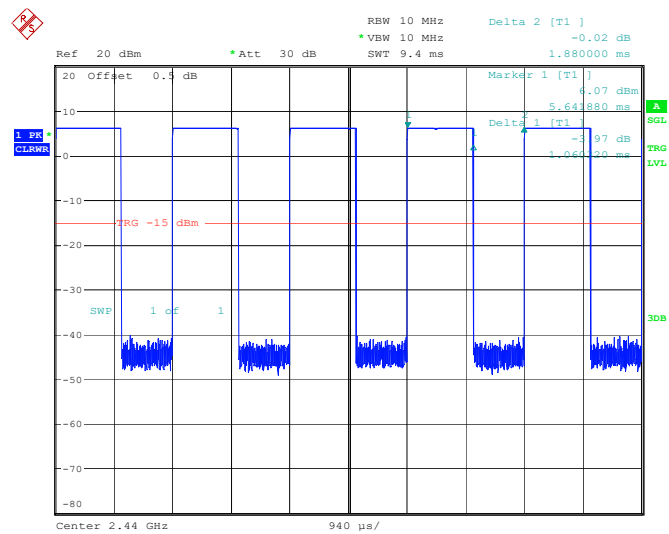

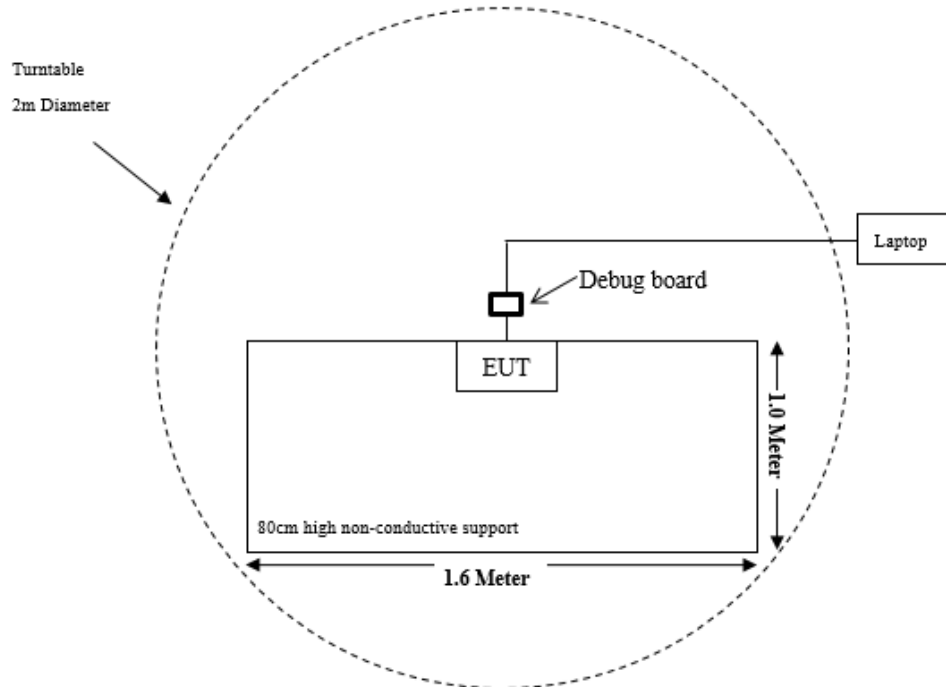

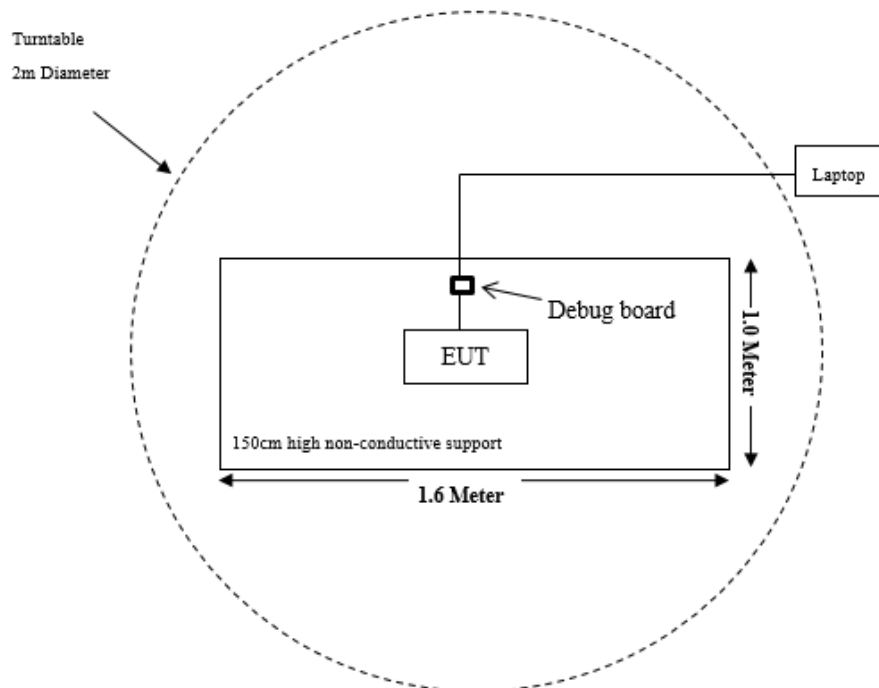

FCC §15.203 - ANTENNA REQUIREMENT

Applicable Standard

According to § 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the user of a standard antenna jack or electrical connector is prohibited. The structure and application of the EUT were analyzed to determine compliance with section §15.203 of the rules. §15.203 state that the subject device must meet the following criteria:

- a. Antenna must be permanently attached to the unit.
- b. Antenna must use a unique type of connector to attach to the EUT.

Unit must be professionally installed, and installer shall be responsible for verifying that the correct antenna is employed with the unit.

And according to FCC 47 CFR section 15.247 (b), if the transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

Antenna Connector Construction

The EUT has one FPC antenna arrangement for BLE, which was permanently attached and the antenna gain is 1.66 dBi, fulfill the requirement of this section. Please refer to the EUT photos.

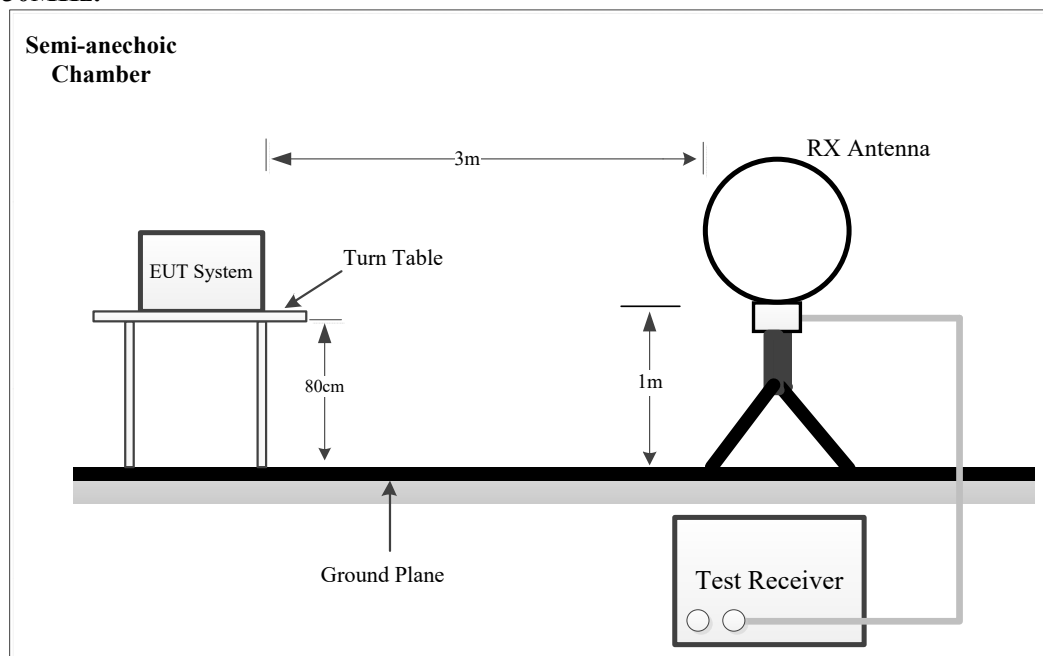

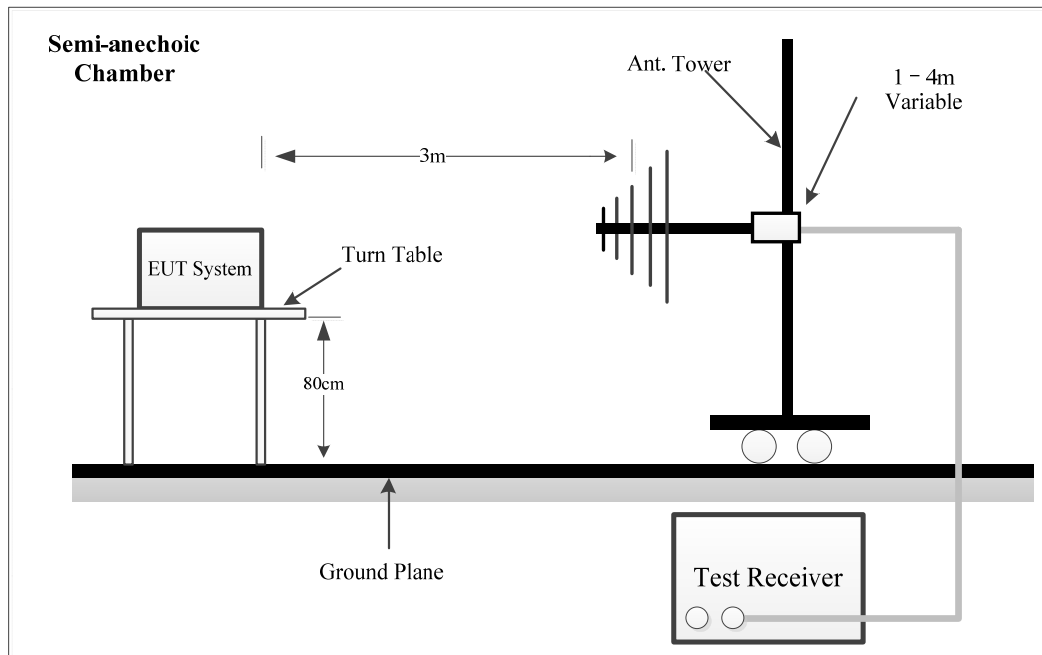
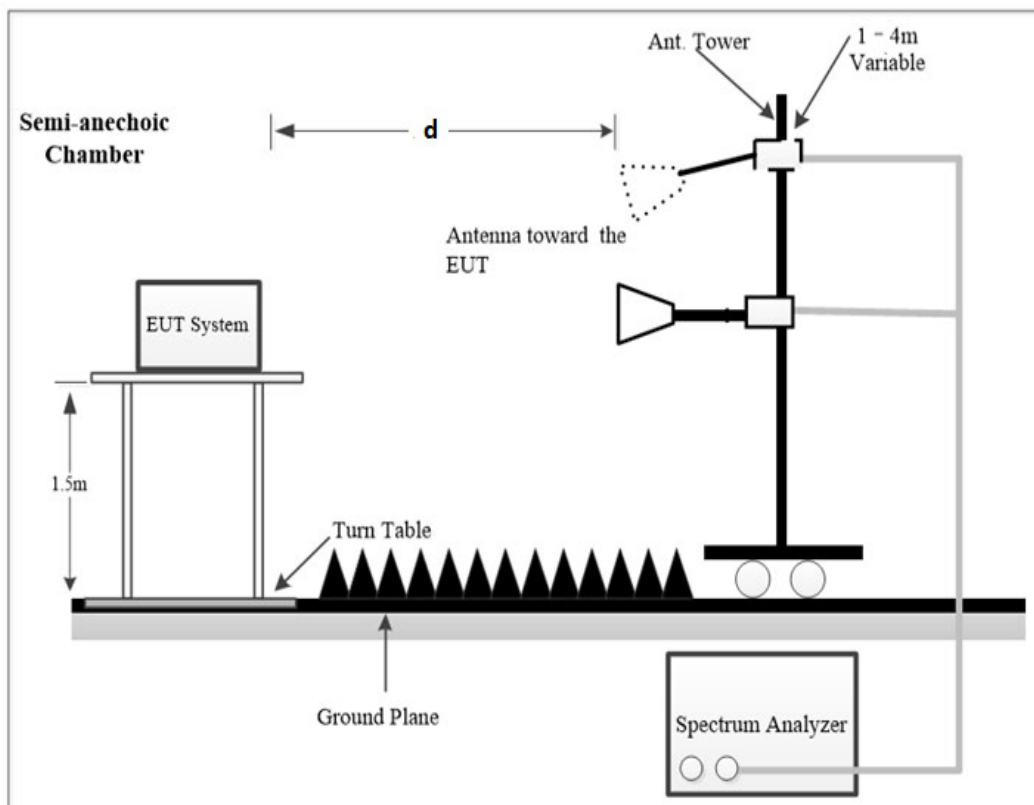

(d) In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

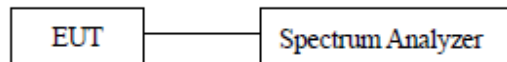

For Radiated Emission test (18GHz-25GHz), which was performed at 1.5 m distance, according to ANSI C63.10-2020, the test result shall be extrapolated to the specified distance using an extrapolation Factor of 20dB/decade from 3m to 1.5m.

Distance extrapolation Factor = $20 \log (\text{specific distance [3m]}/\text{test distance [1.5m]})$ dB = 6 dB

Test Procedure

Radiated Emissions:

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

For each measurement antenna alignment, the EUT shall be rotated through 0° to 360° on a turntable. The report shall list the six emissions with the smallest margin relative to the limit, for each of the three antenna orientations (parallel, perpendicular, and ground parallel) unless the margin is greater than 20 dB, then the following statement shall be made: "all emissions were greater than 20 dB below the limit."

Below 1GHz, if the measured peak level of the emissions that the measuring receiver reading level plus corrected factor is at least 6 dB below the QP emission limit, there's no need to record the measured QP level of the emissions in the report.

Above 1GHz, if the measured peak level of the emissions that the measuring receiver reading level plus corrected factor is below the AV emission limit, there's no need to record the measured AV level of the emissions in the report.

Antenna-port conducted emission:

Connect the primary antenna port through an attenuator to the spectrum analyzer input; in the results, account for all losses between the unlicensed wireless device output and the spectrum analyzer. The frequency range of testing shall span 30 MHz to 10 times the operating frequency and this may be done in a single sweep or, to aid resolution, across a number of sweeps. The resolution bandwidth shall be 100 kHz, video bandwidth 300 kHz, and a coupled sweep time with a peak detector.

The limit is based on the highest in-band level across all channels measured using the same instrument settings (resolution bandwidth of 100 kHz, video bandwidth of 300 kHz, and a coupled sweep time with a peak detector). To help clearly demonstrate compliance a display line may be set at the required offset (typically 20 dB) below the highest in-band level. Where the highest in-band level is not clearly identified in the out-of-band measurements a separate spectral plot showing the in-band level shall be provided.

When conducted measurements cannot be made (for example a device with integrated, non-removable antenna) radiated measurements shall be used. The reference level for determining the limit shall be established by maximizing the field strength from the highest power channel and measuring using the resolution and video bandwidth settings and peak detector as described above. The field strength limit for spurious emissions outside of restricted-bands shall then be set at the required offset (typically 20 dB) below the highest in-band level. Radiated measurements will follow the standards measurement procedures described in Clause 6 with the exception that the resolution bandwidth shall be 100 kHz, video bandwidth 300 kHz, and a coupled sweep time with a peak detector. Note that use of wider measurement bandwidths are acceptable for measuring the spurious emissions provided that the peak detector is used and that the measured value of spurious emissions are compared to the highest in-band level measured with the 100 kHz / 300 kHz bandwidth settings to determine compliance.

Result & Margin Calculation

The Result is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

For 9 kHz to 18GHz Radiated emission test and Bandedge emissions test

Factor (dB/m) = Antenna Factor (dB/m) + Cable Loss (dB) - Amplifier Gain (dB)

For 18GHz to 25GHz Radiated emission test

Factor (dB/m) = Antenna Factor (dB/m) + Cable Loss (dB) - Amplifier Gain (dB) - Extrapolation factor (dB)

Extrapolation factor = 6dB (distance = 1.5m)

Result (dBμV/m) = Reading (dBμV) + Factor (dB/m)

The “**Margin**” column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7dB means the emission is 7dB below the limit. The equation for margin calculation is as follows:

Margin (dB) = Limit (dBμV/m) – Result (dBμV/m)

Applicable Standard

According to FCC §15.247(b) (3), for systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. FCC §15.247(d) – 100 kHz BANDWIDTH OF FREQUENCY BAND EDGE**Applicable Standard**

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits.
