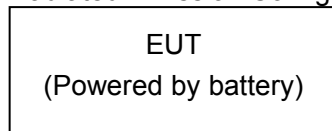

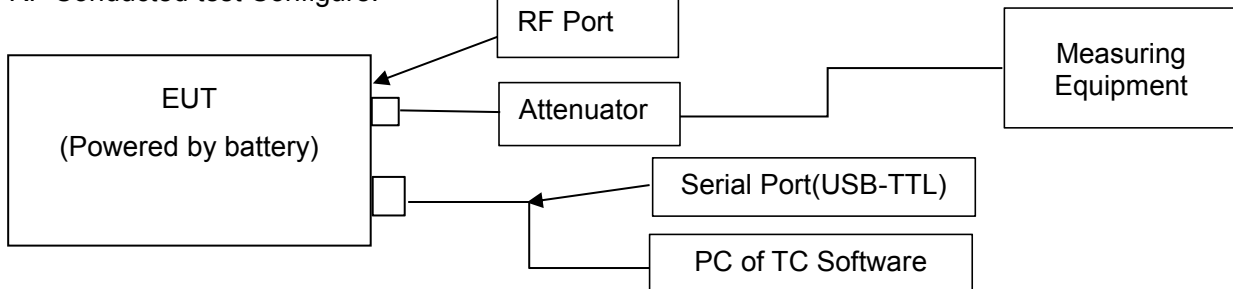

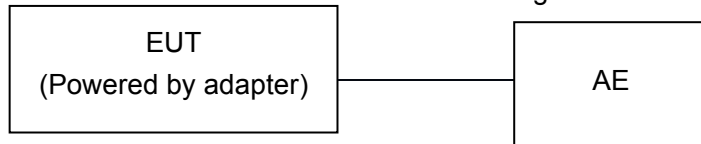
Radiated Emission Configure:

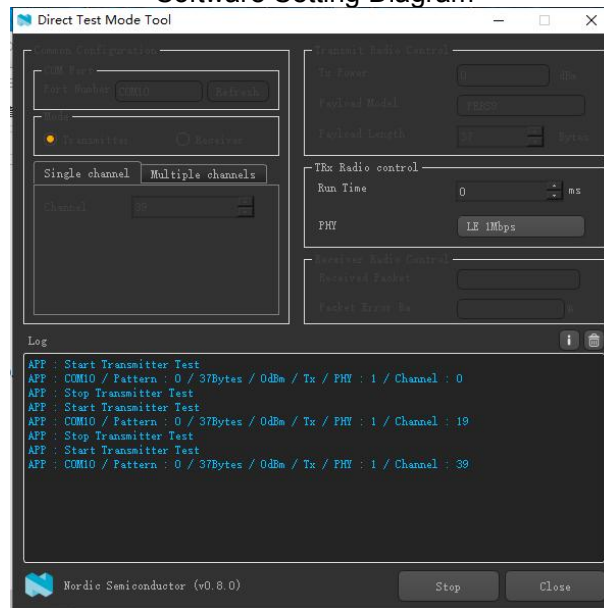

5. The manufacturer of RF external cable claims that the cable loss is 0.5dB, and the cable loss and attenuator have been compensated into the Corrections Configuration of measuring equipment.
6. Input correction factor includes external cable loss and attenuator amplitude compensation. The formula is:
Input compensation coefficient (dB) = Cable Loss (dB) + Attenuator attenuation value (dB)

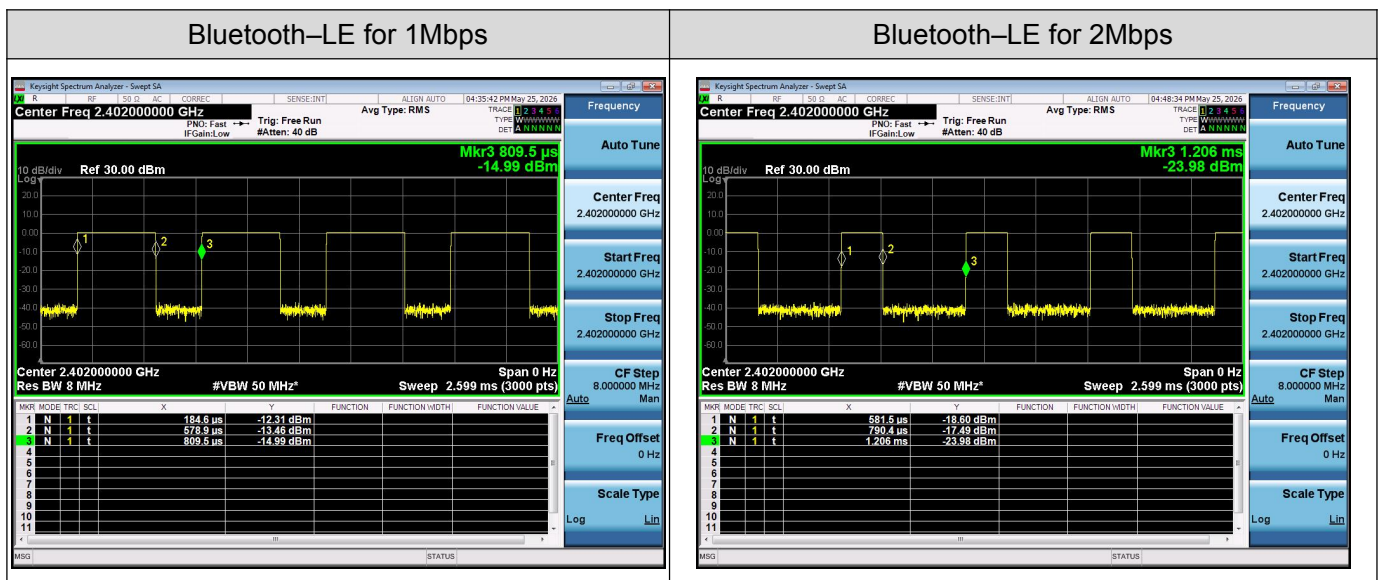
6. Duty Cycle Measurement

The maximum achievable duty cycles for all modes were determined based on measurements performed on a spectrum analyzer in zero-span mode with RBW = 8MHz, VBW = 50MHz, and detector =RMS. 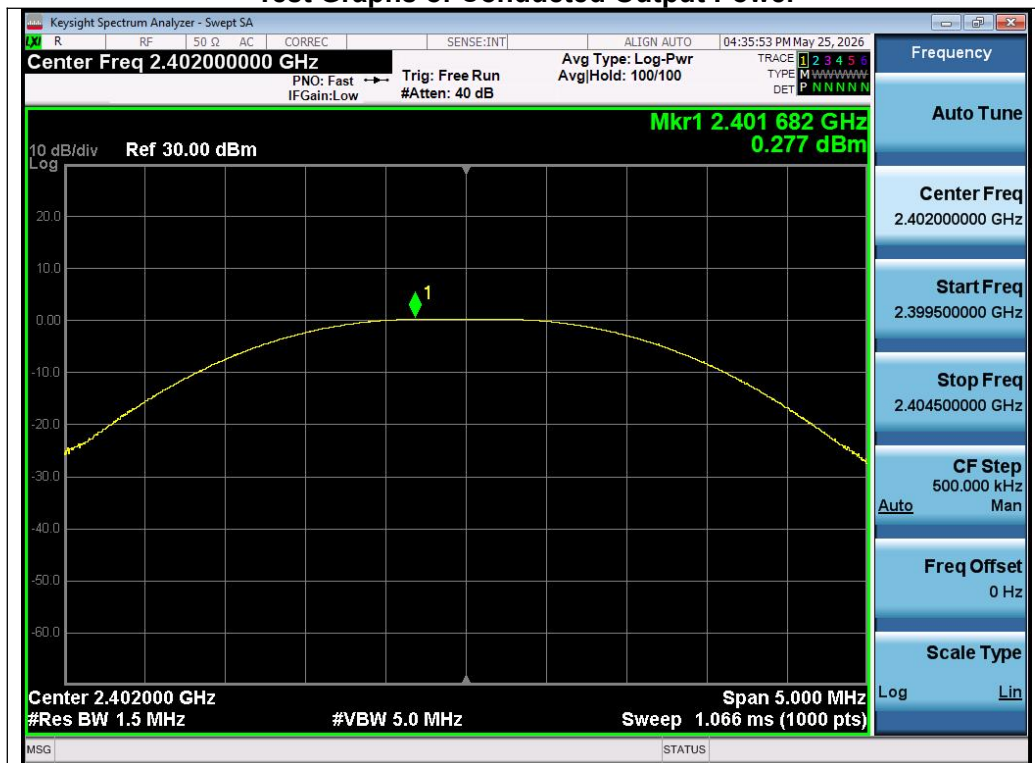

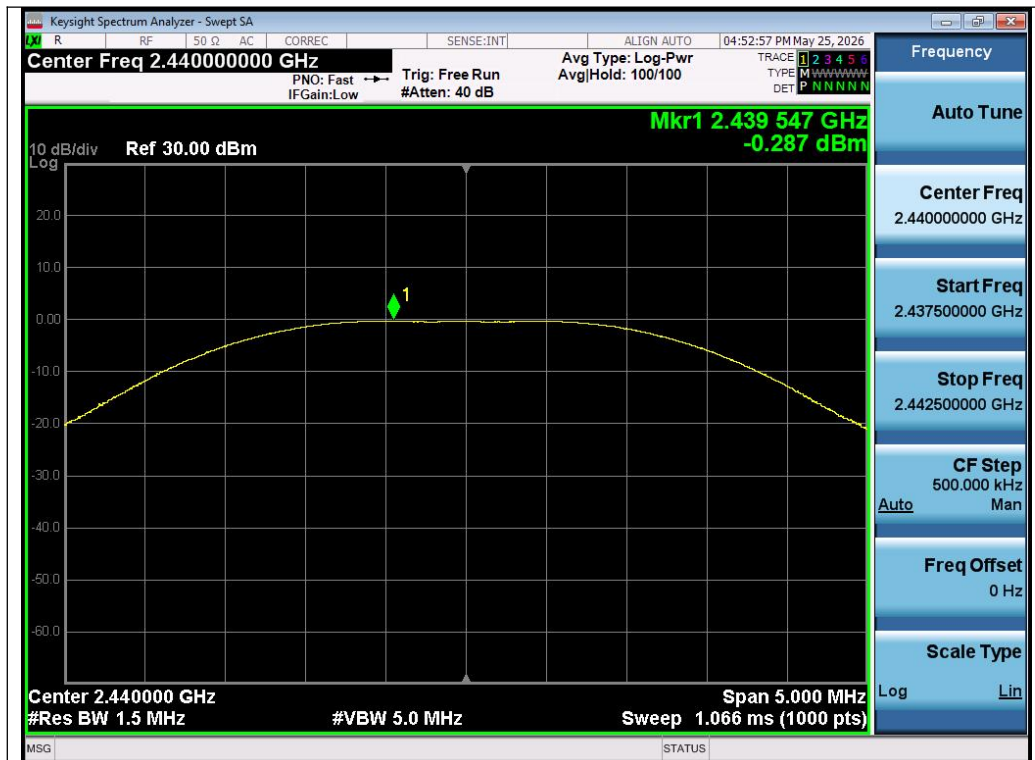
Test_Graph_LE1M_ANT1_2480_1Mbps_Peak Power

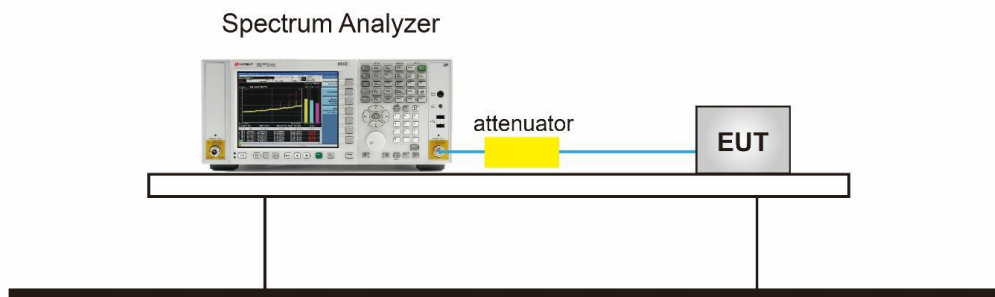

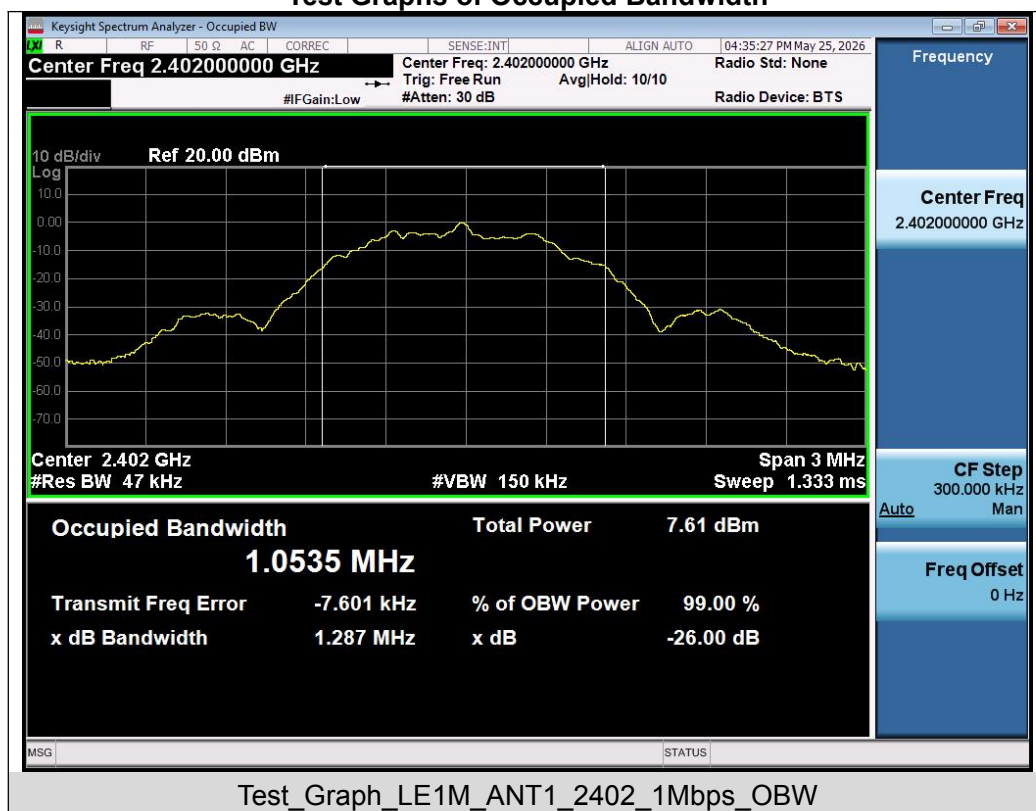

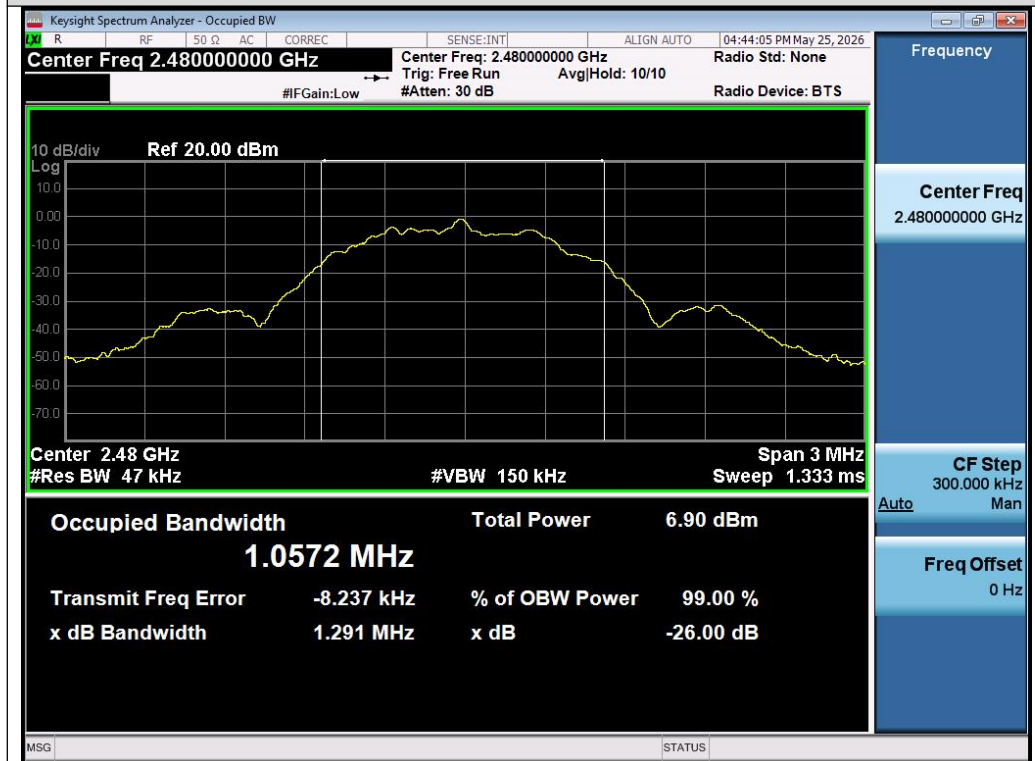
Test Graphs of Occupied Bandwidth

Test_Graph_LE1M_ANT1_2440_1Mbps_OBW

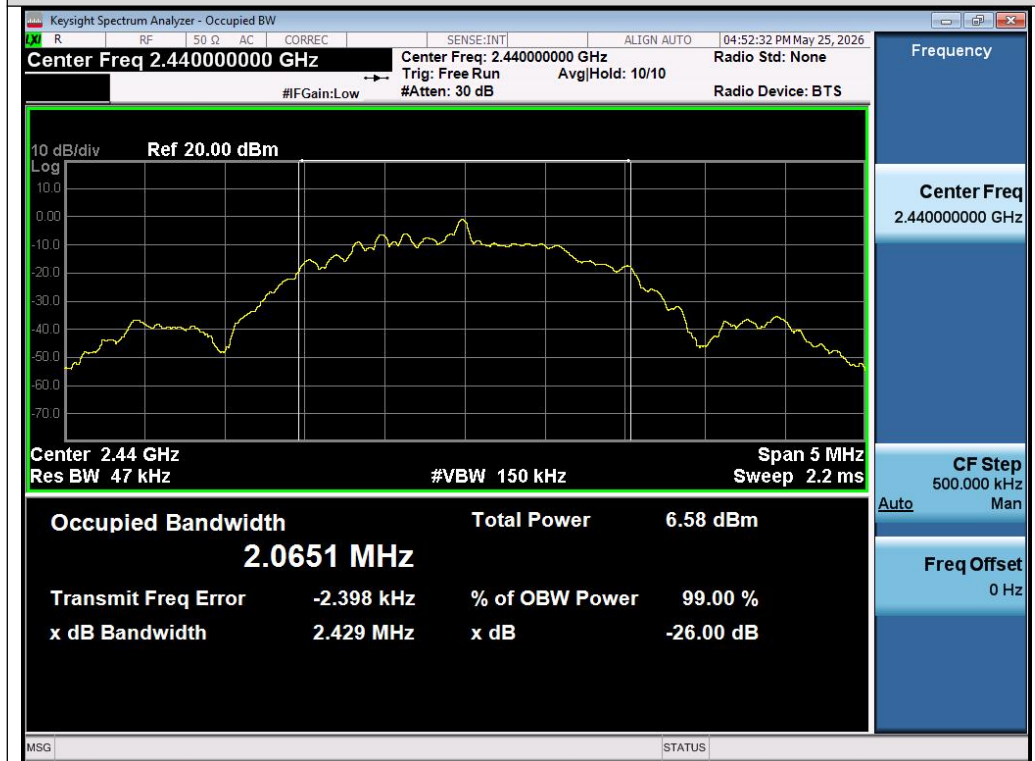

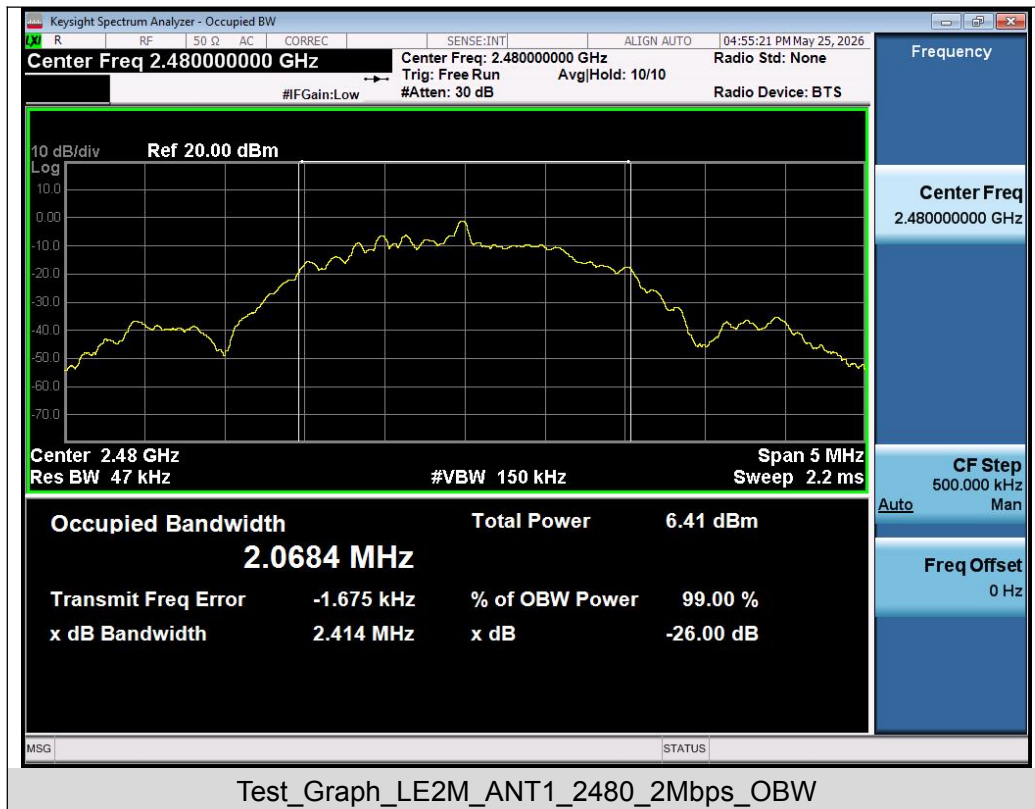


Test_Graph_LE2M_ANT1_2402_2Mbps_OBW

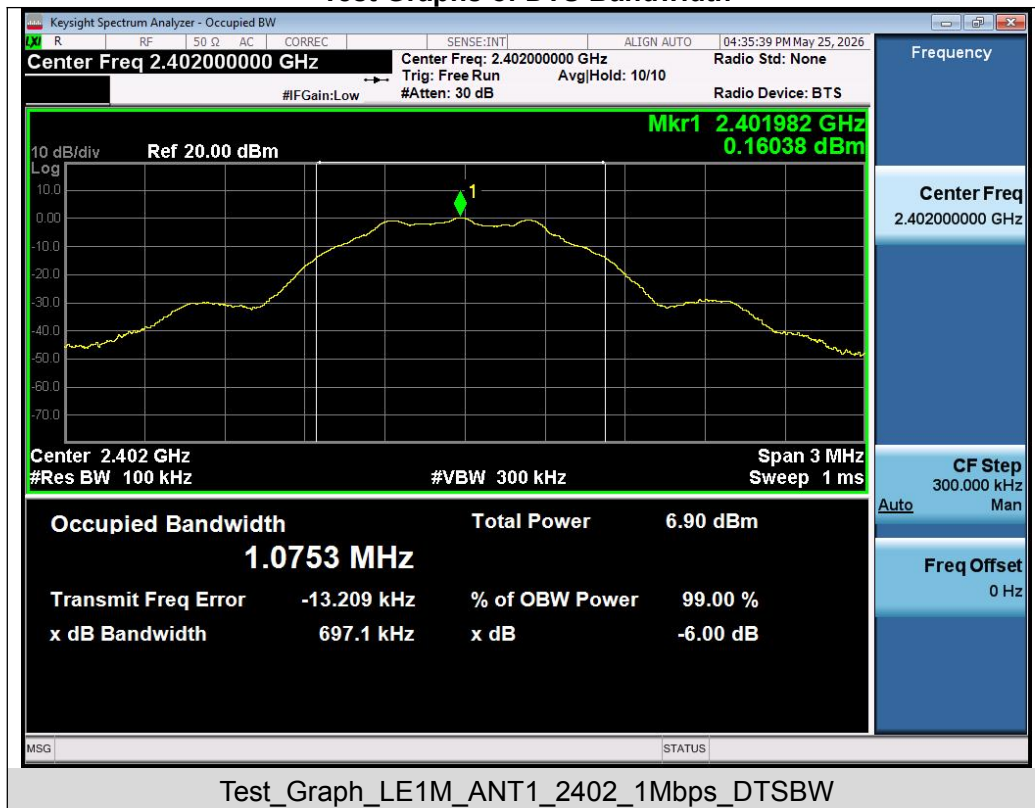

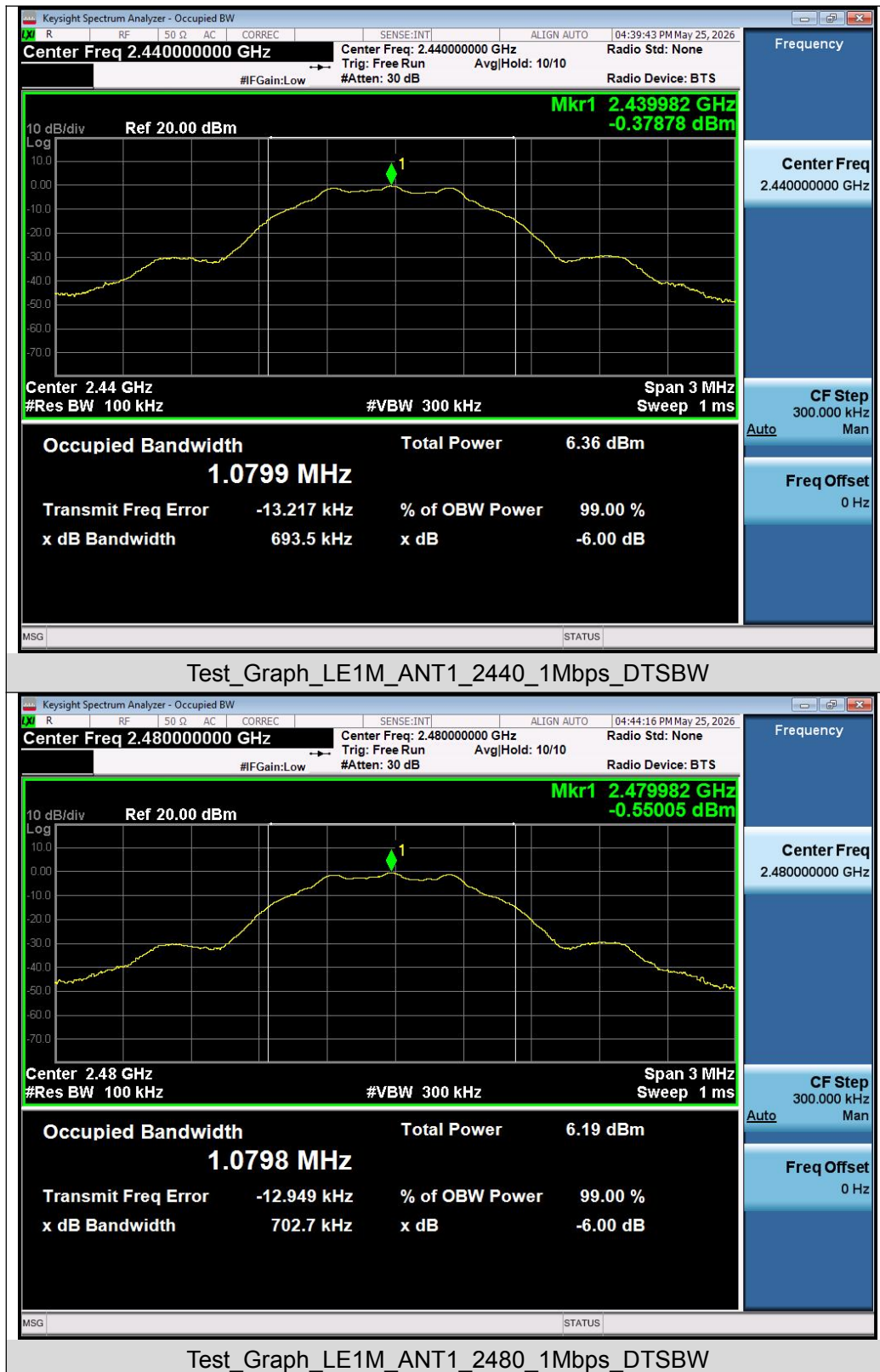

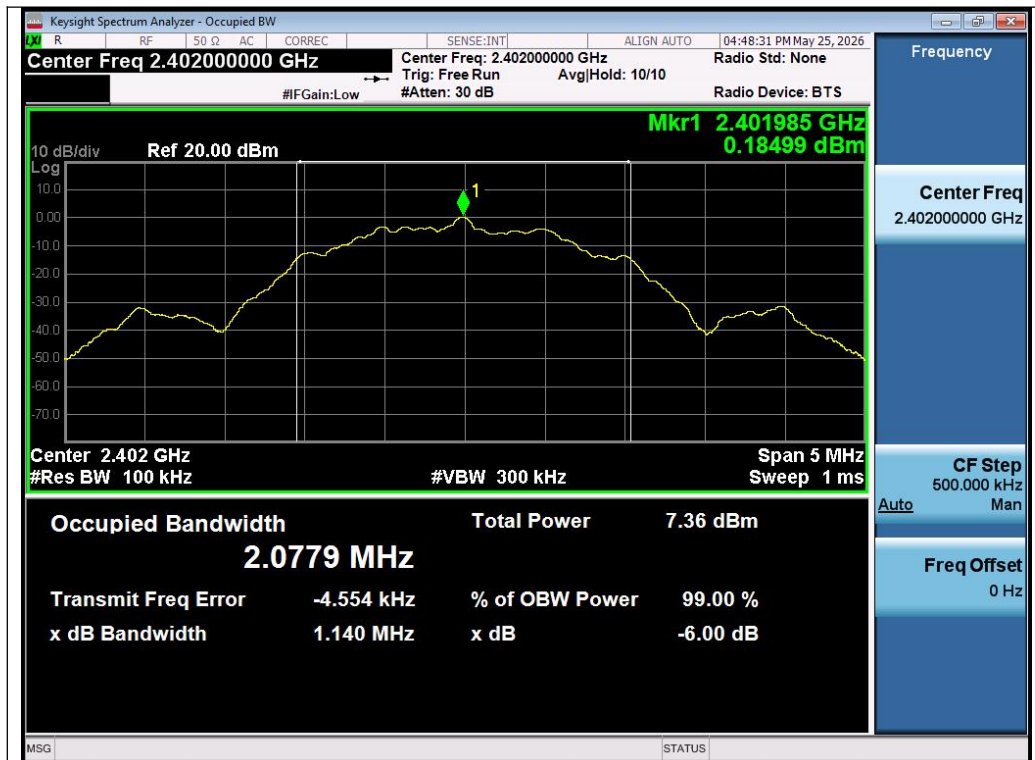
Test Graphs of DTS Bandwidth



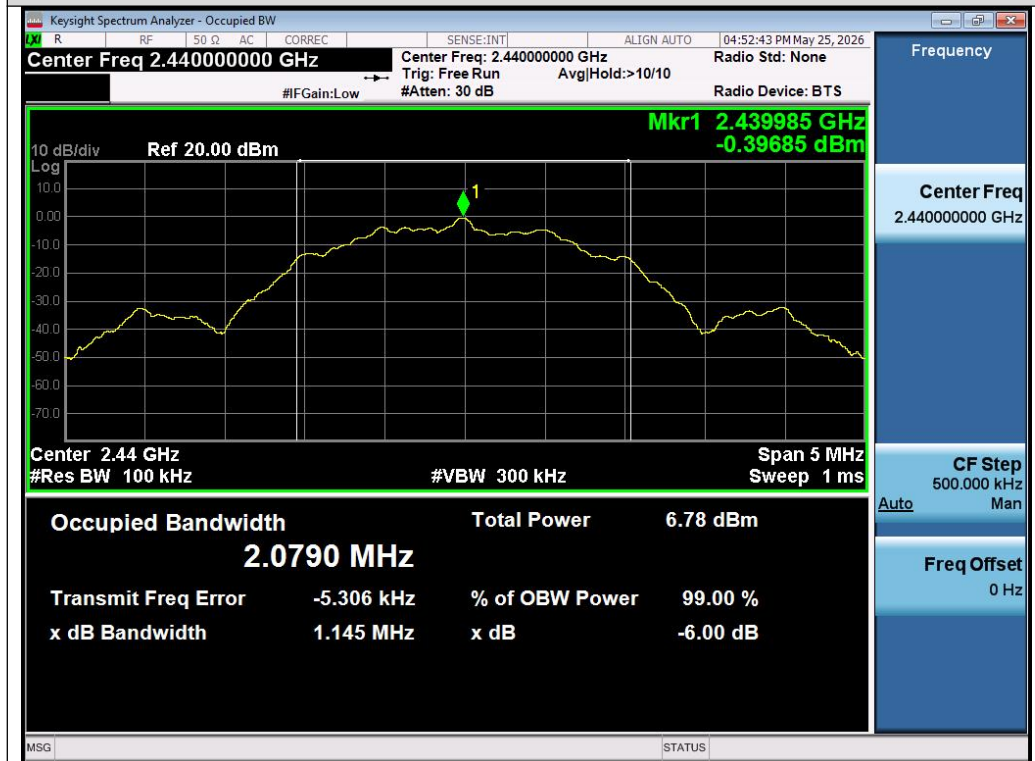

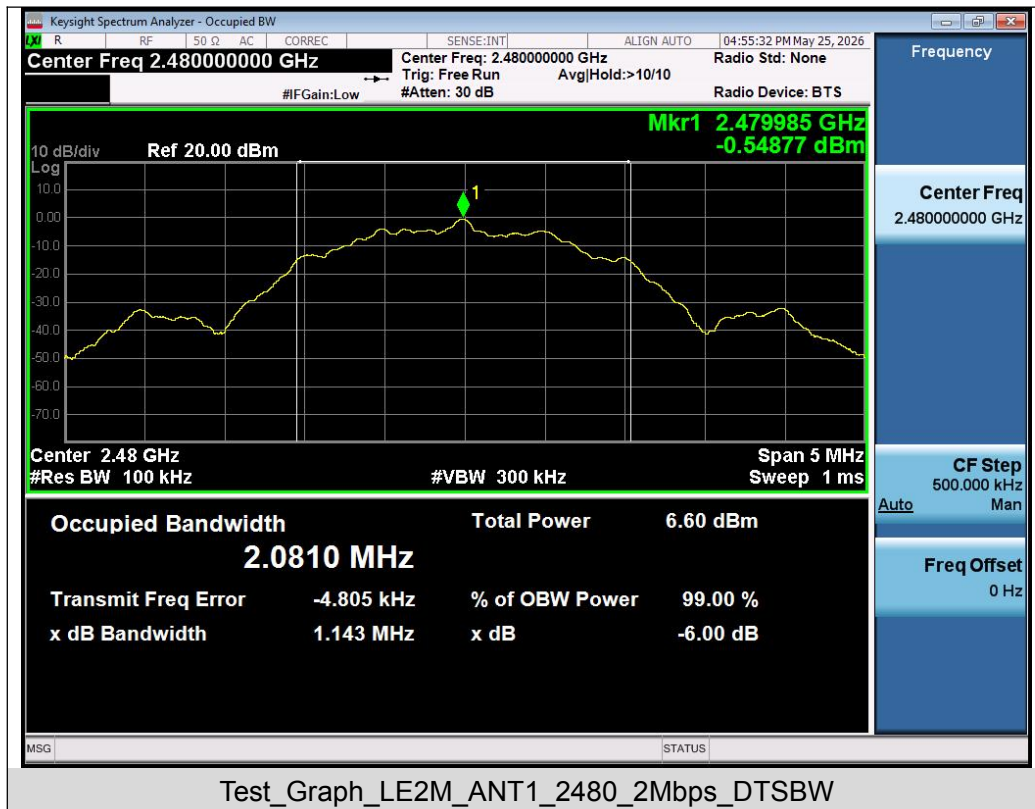


Test_Graph_LE2M_ANT1_2402_2Mbps_DTSBW

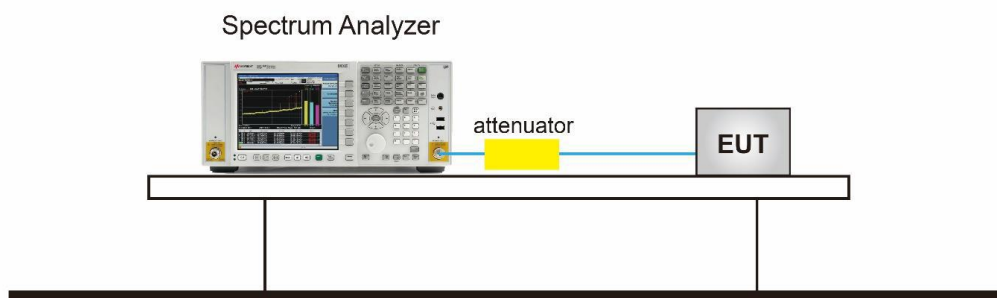

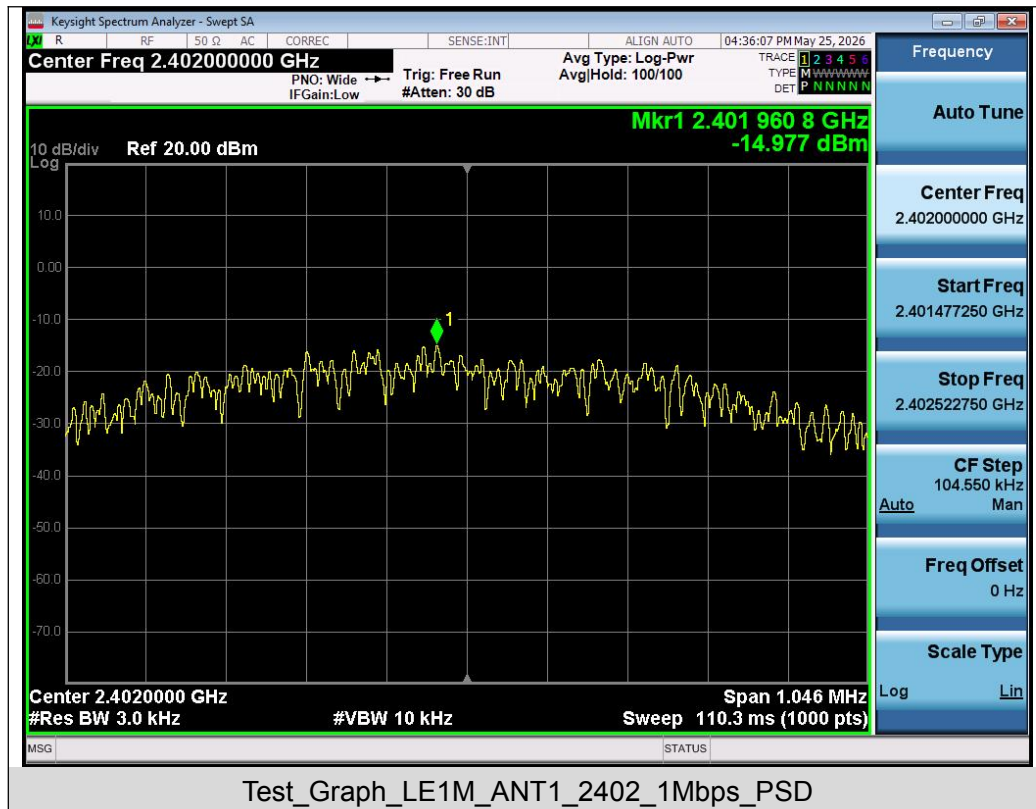

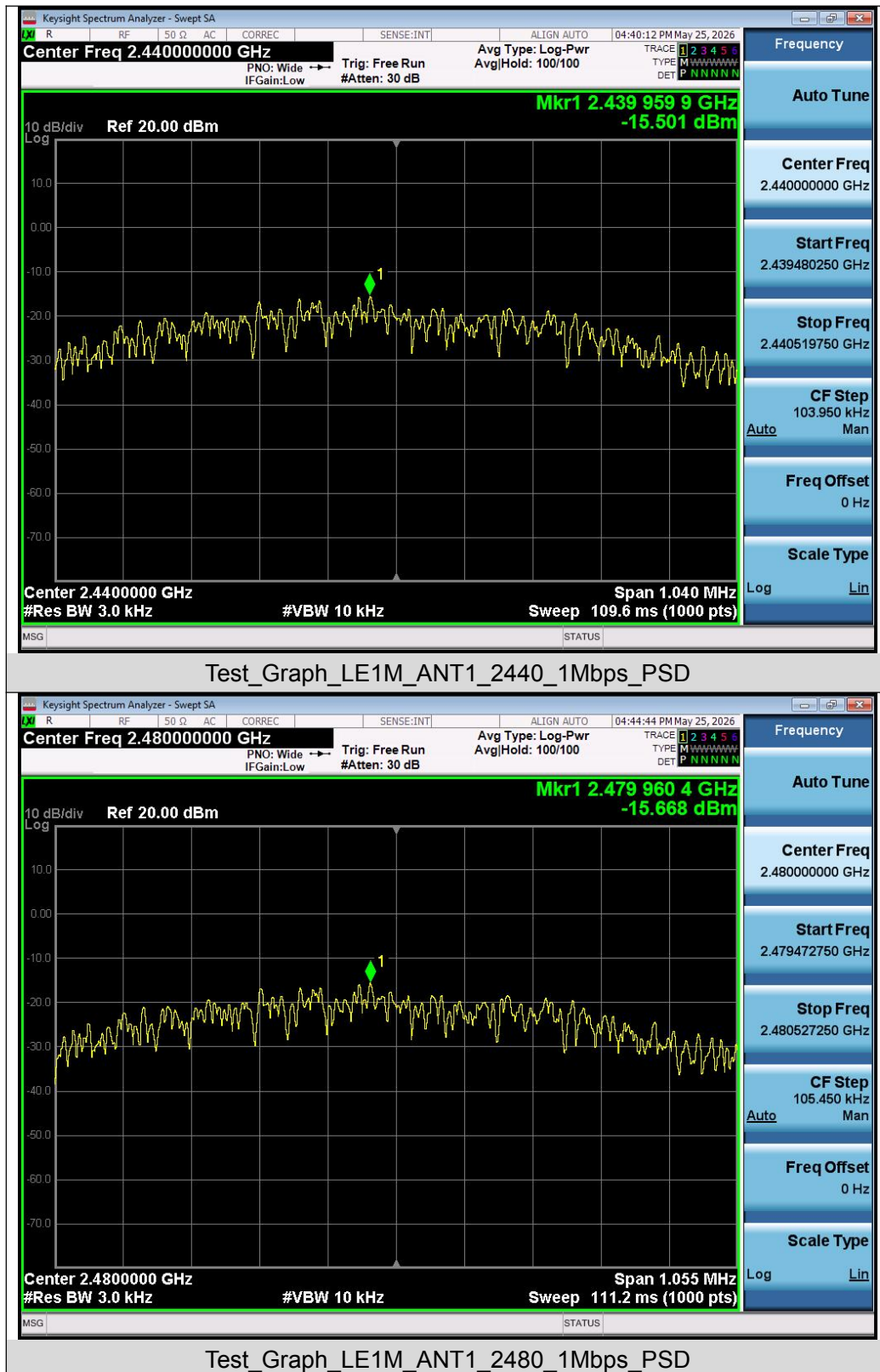

Test Graphs of Conducted Output Power Spectral Density

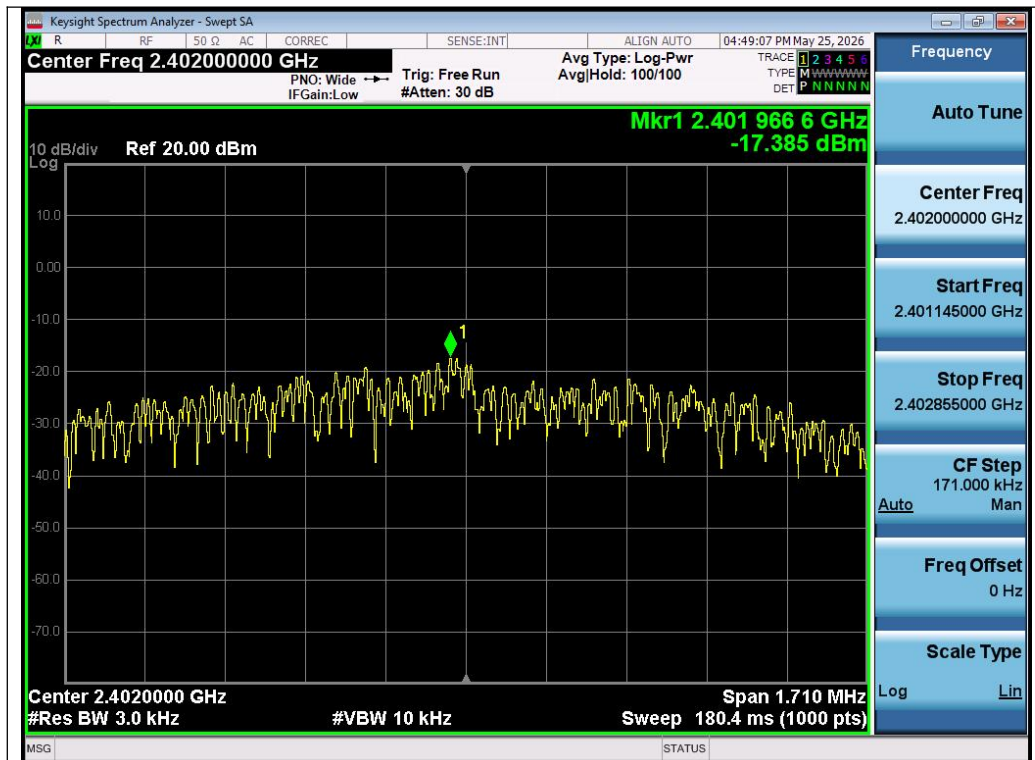

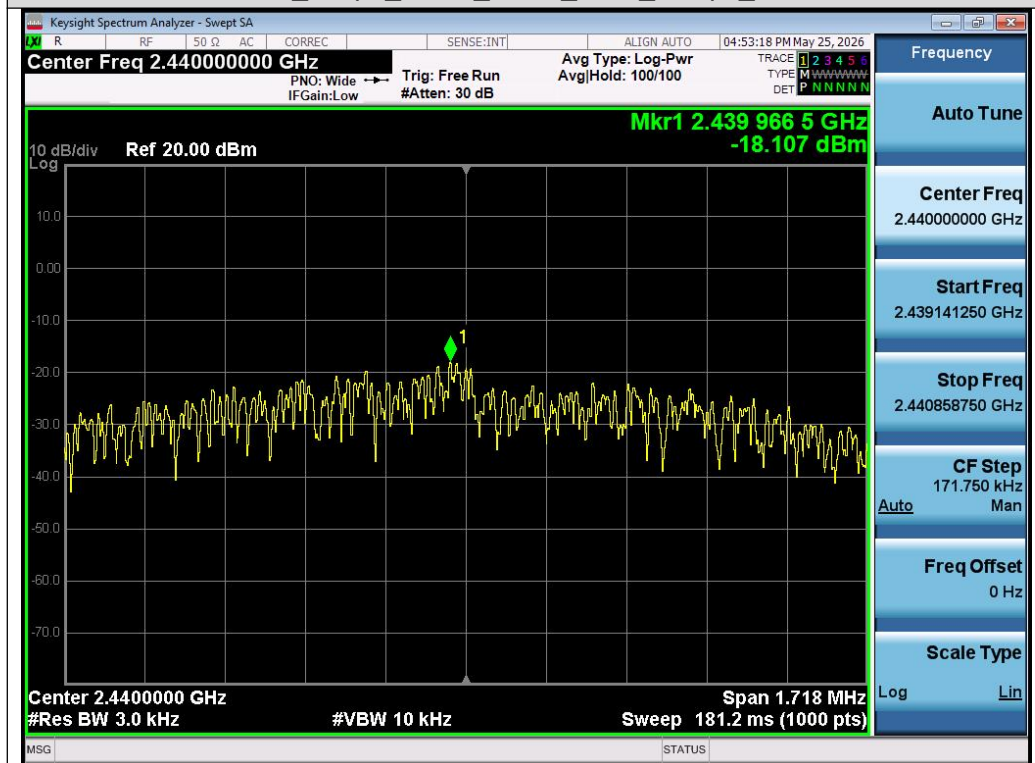

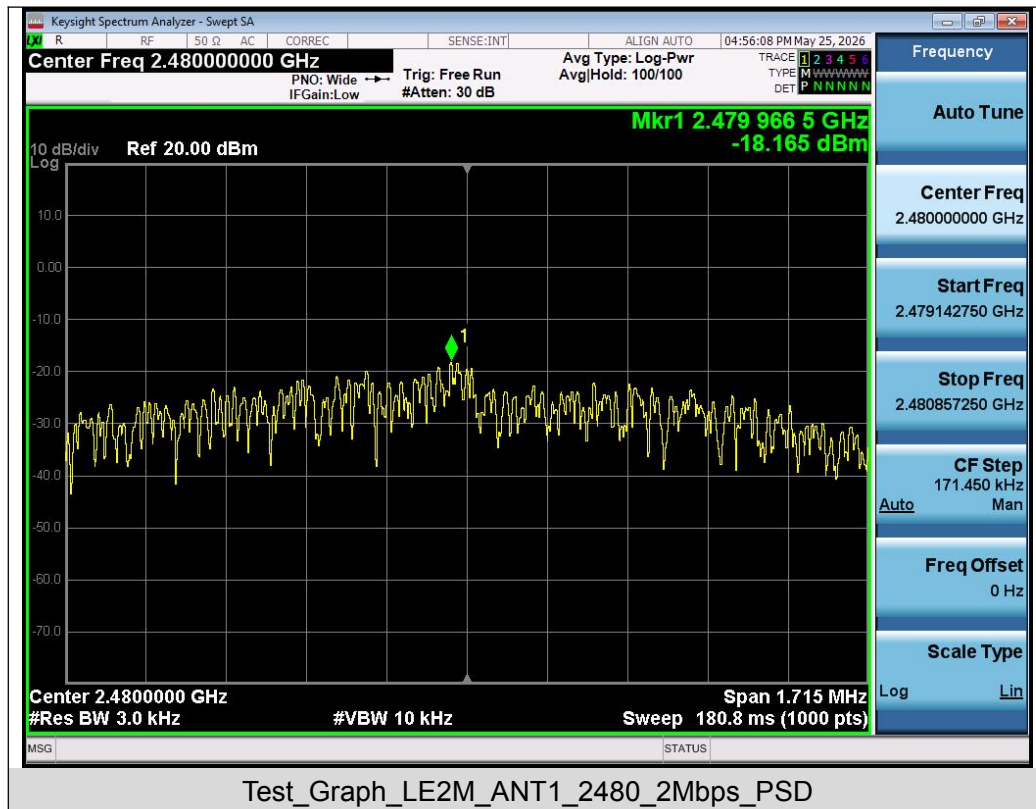
Test_Graph_LE2M_ANT1_2402_2Mbps_PSD

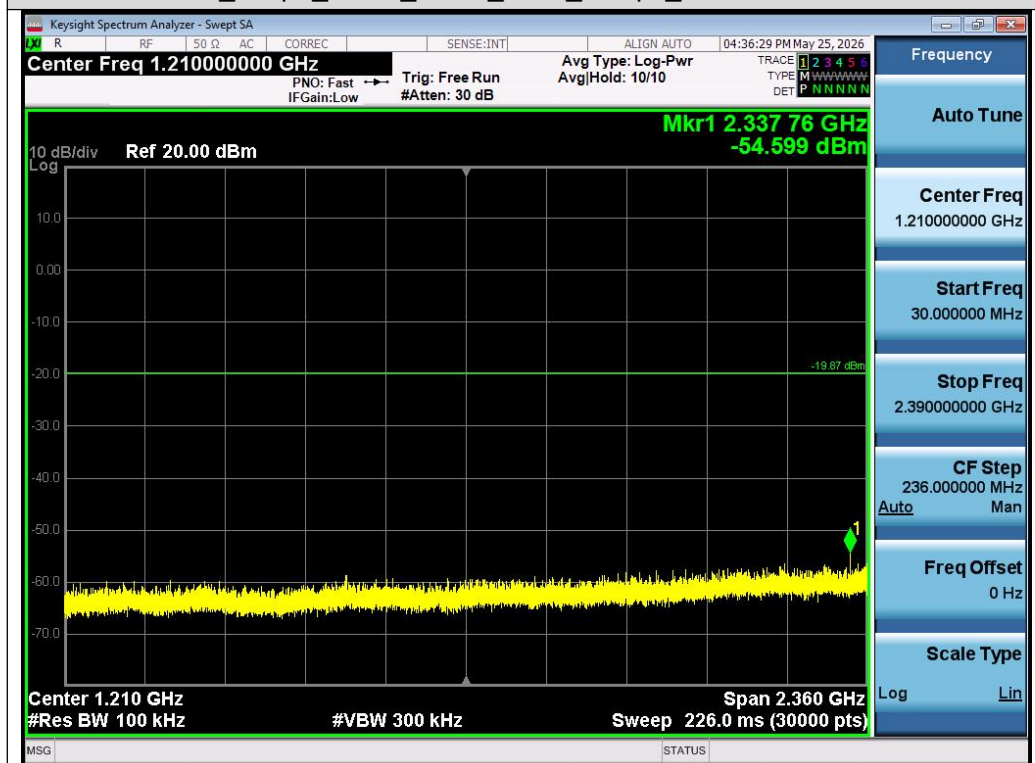

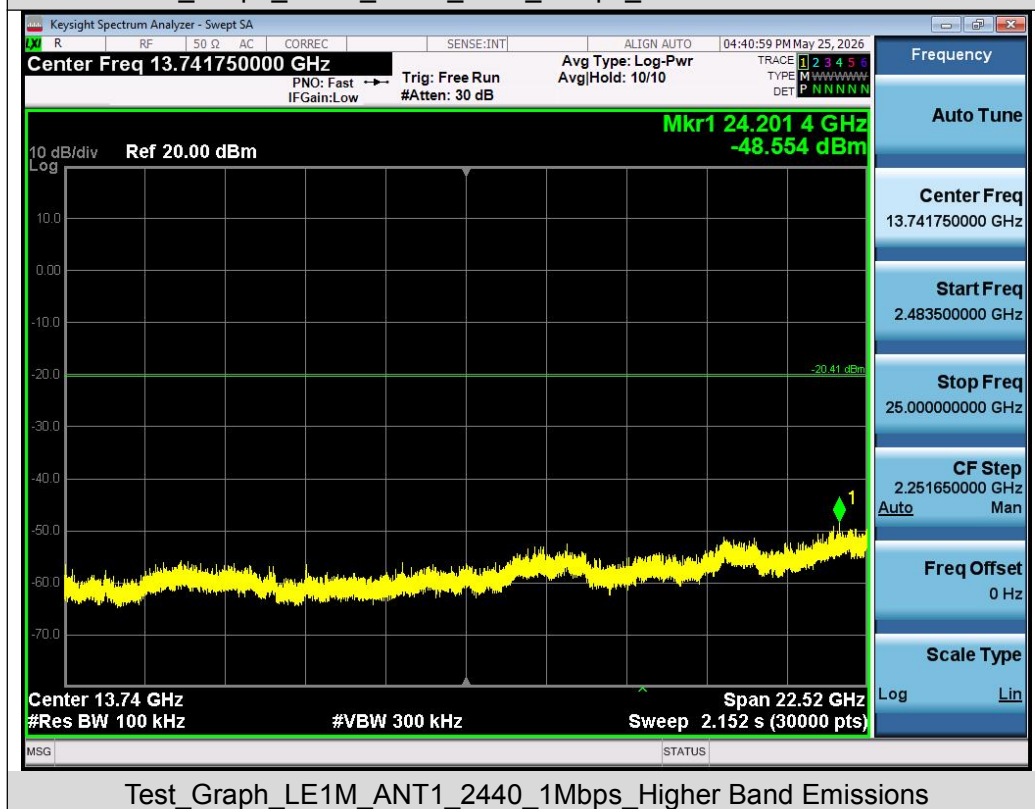
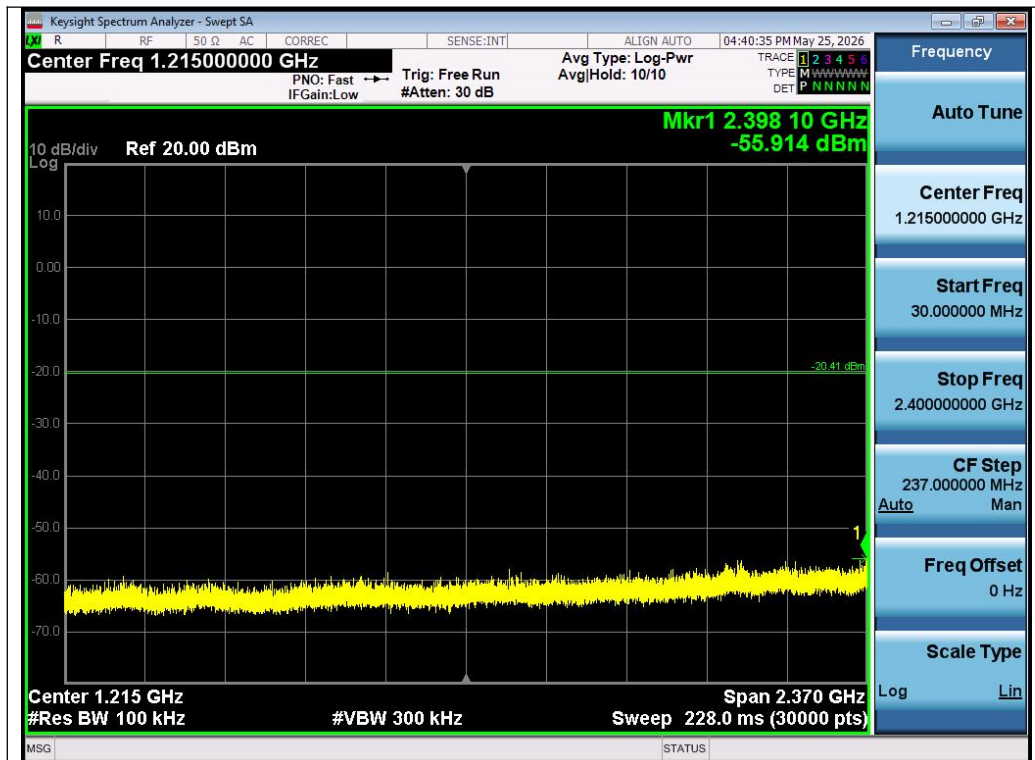
Test_Graph_LE1M_ANT1_2402_1Mbps_Higher Band Emissions

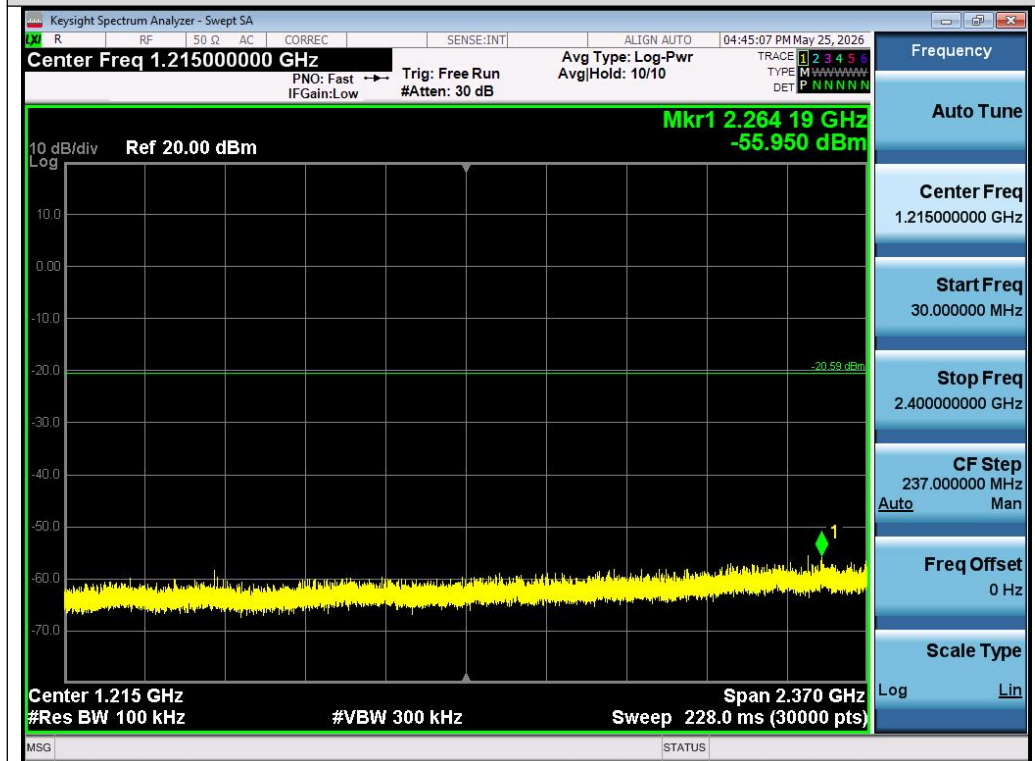
