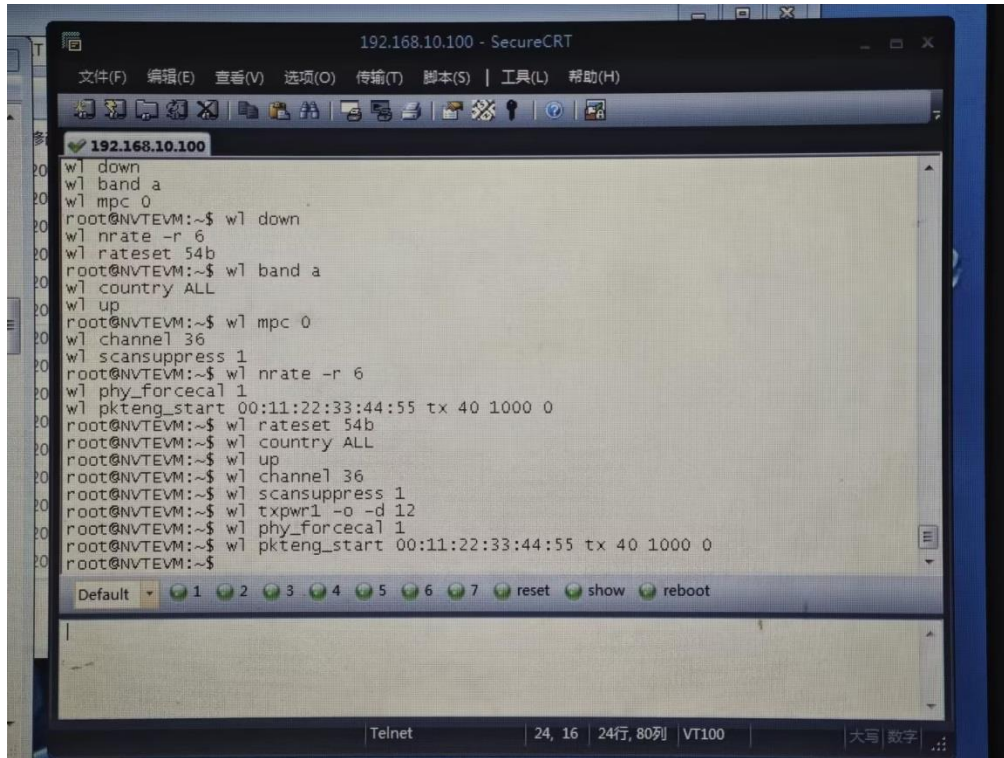

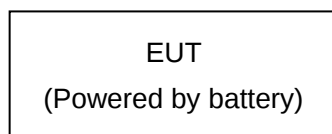

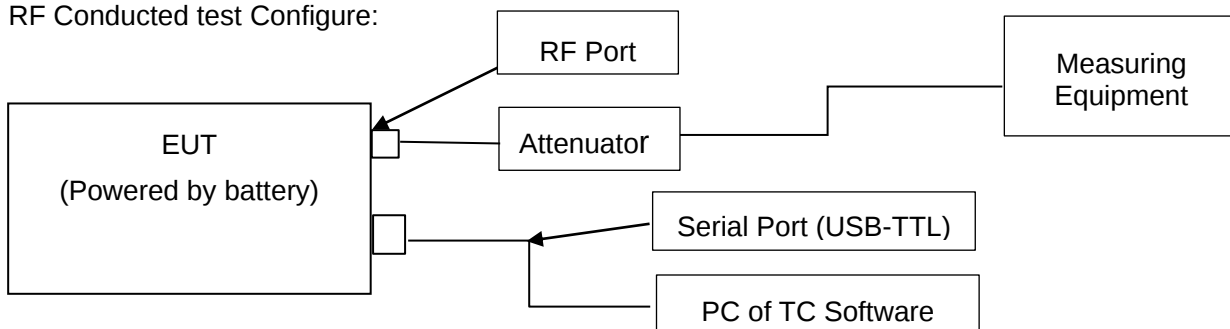

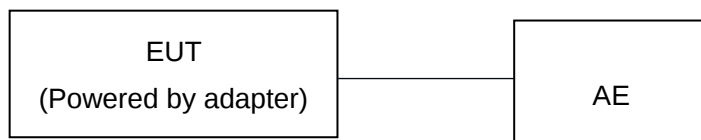
Radiated Emission Configure:

Test Graphs of DTS Bandwidth

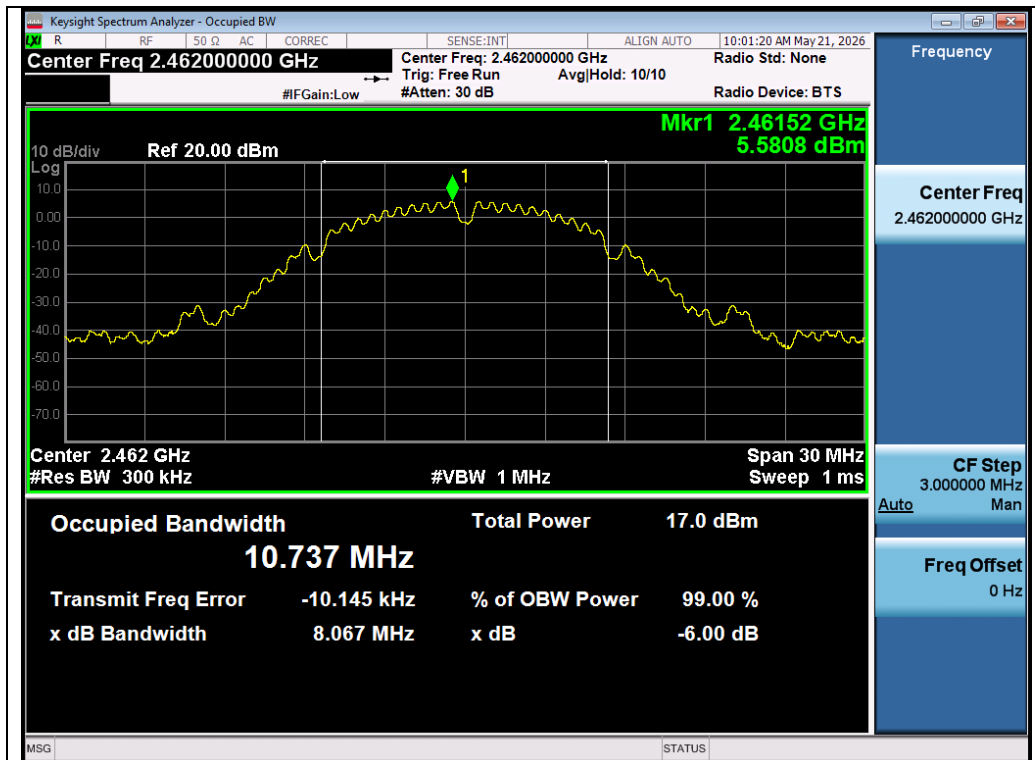


Test_Graph_802.11b_Chain A_2412_1Mbps_DTSBW

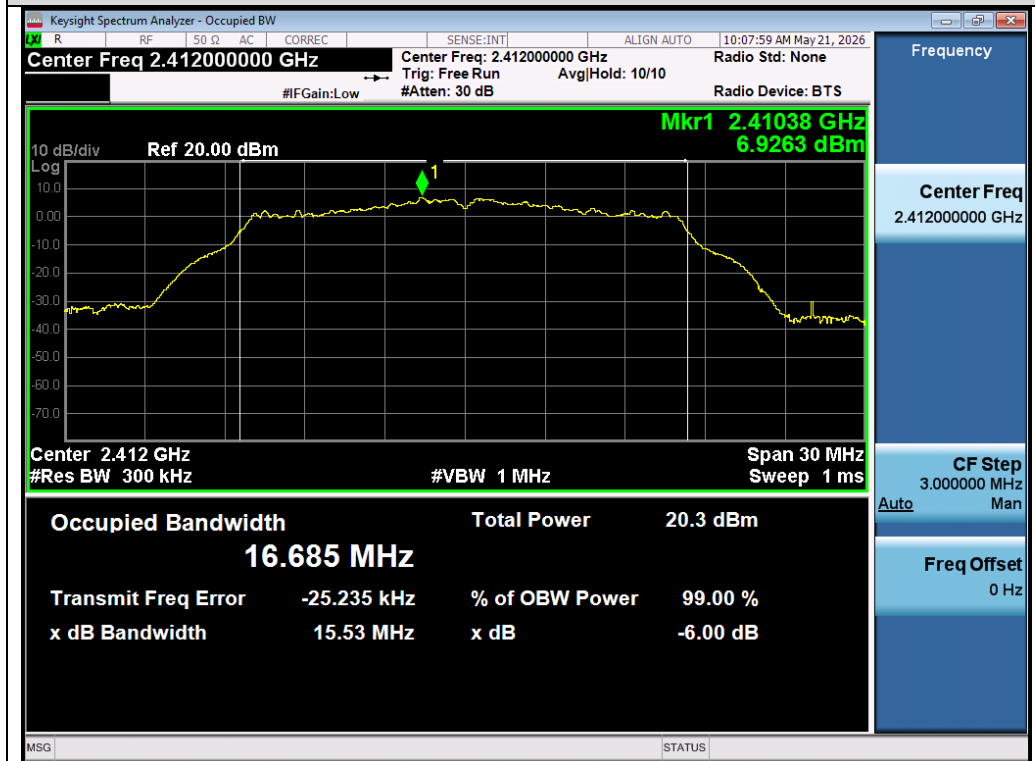

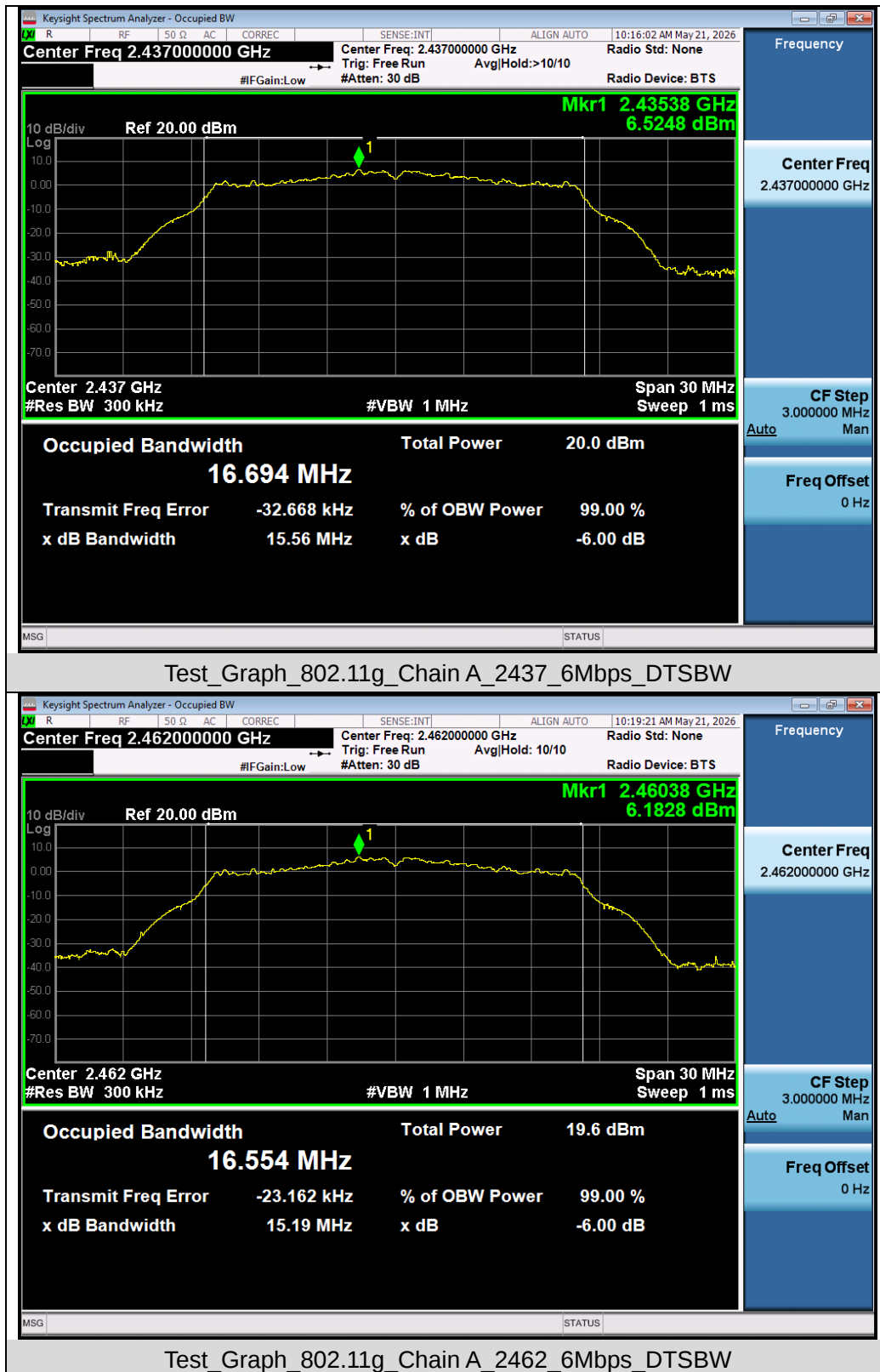


Test_Graph_802.11b_Chain A_2462_1Mbps_DTSBW



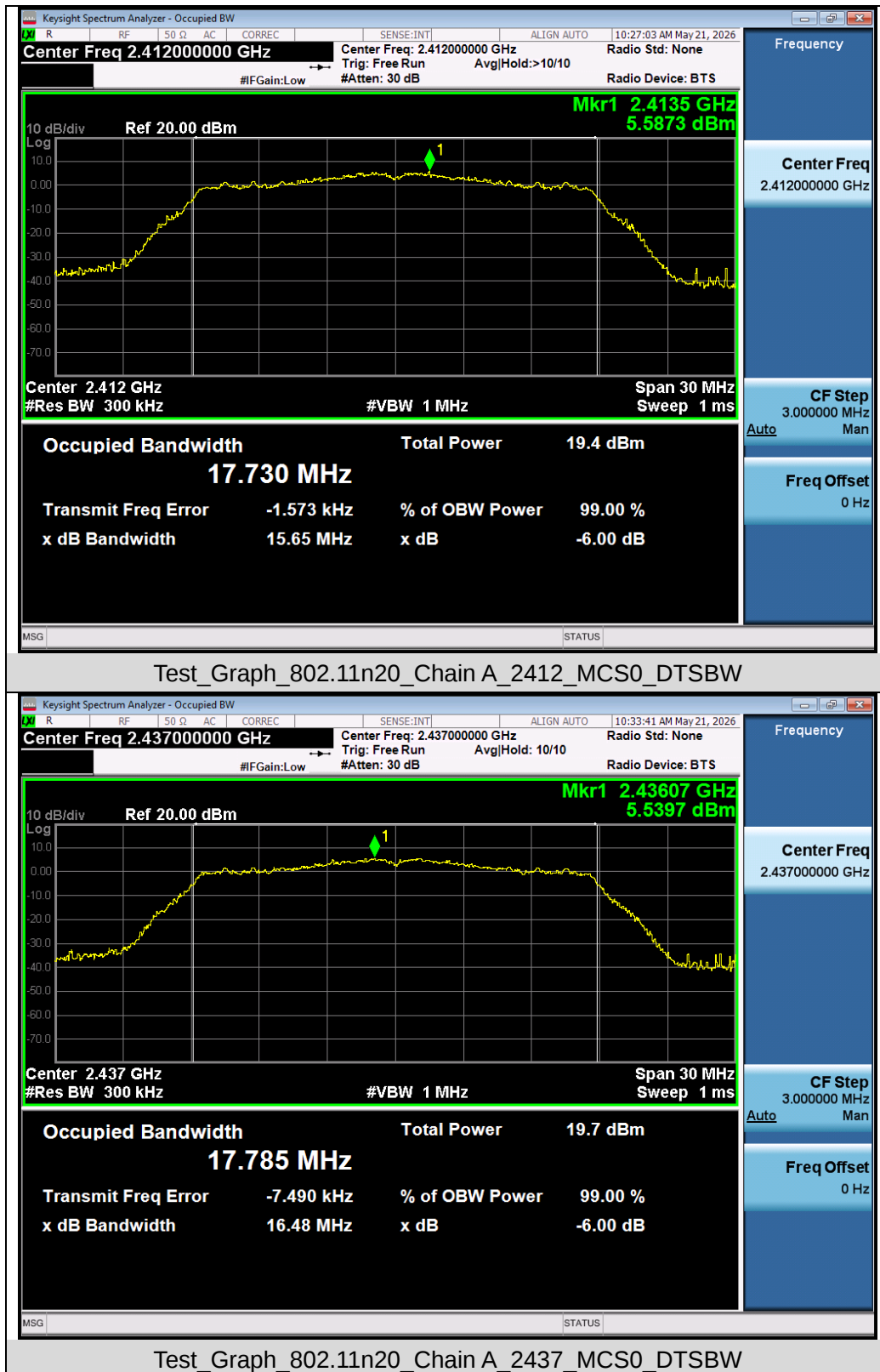

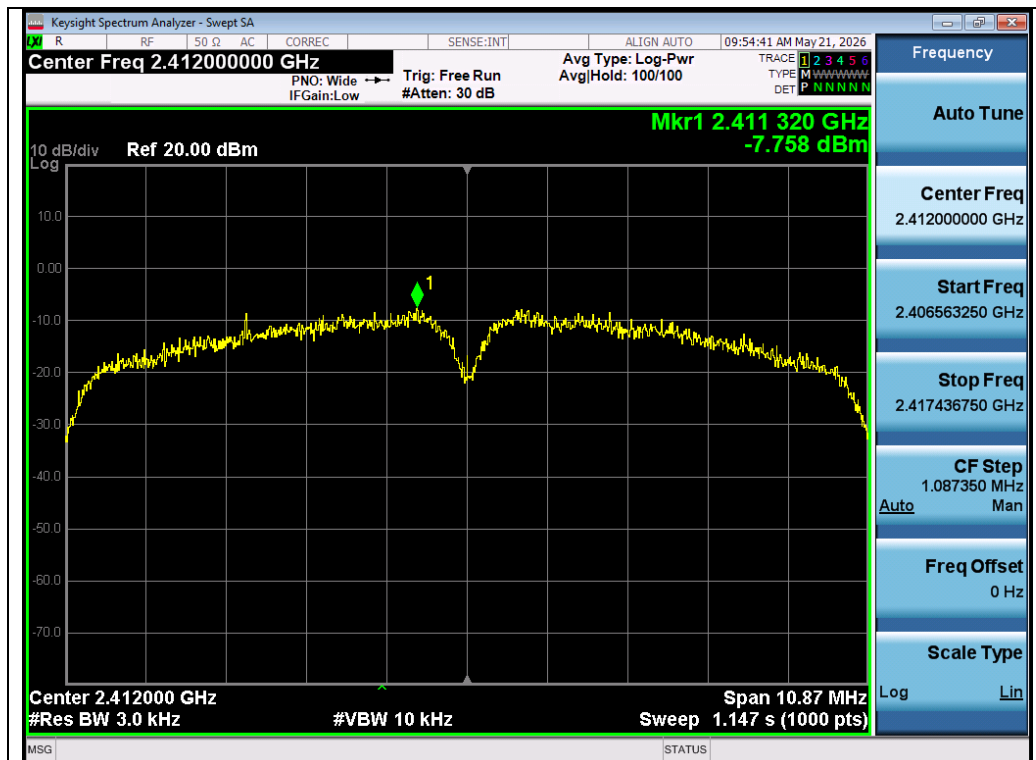

Test Graphs of Conducted Output Power Spectral Density



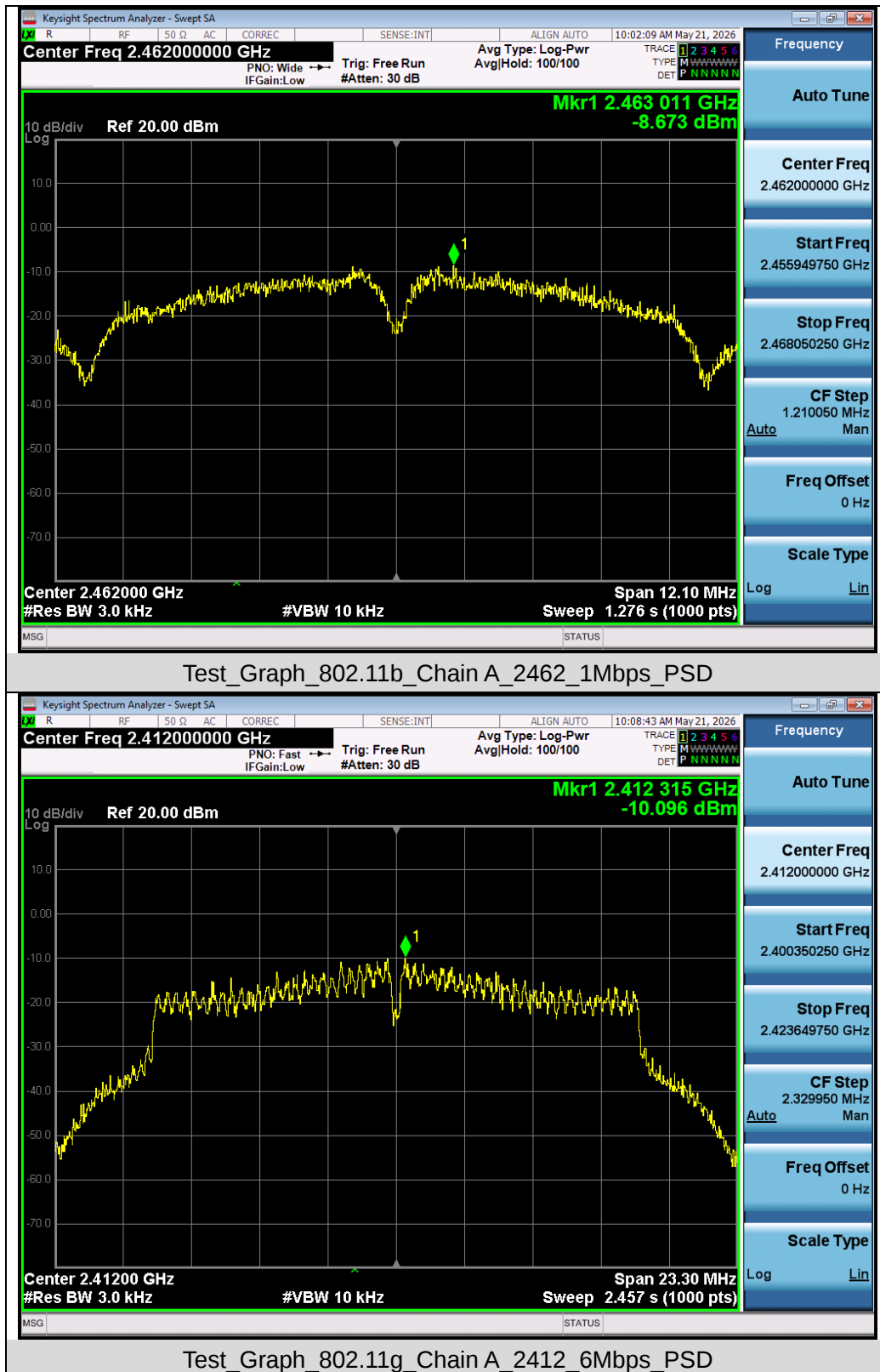
Test_Graph_802.11b_Chain A_2412_1Mbps_PSD

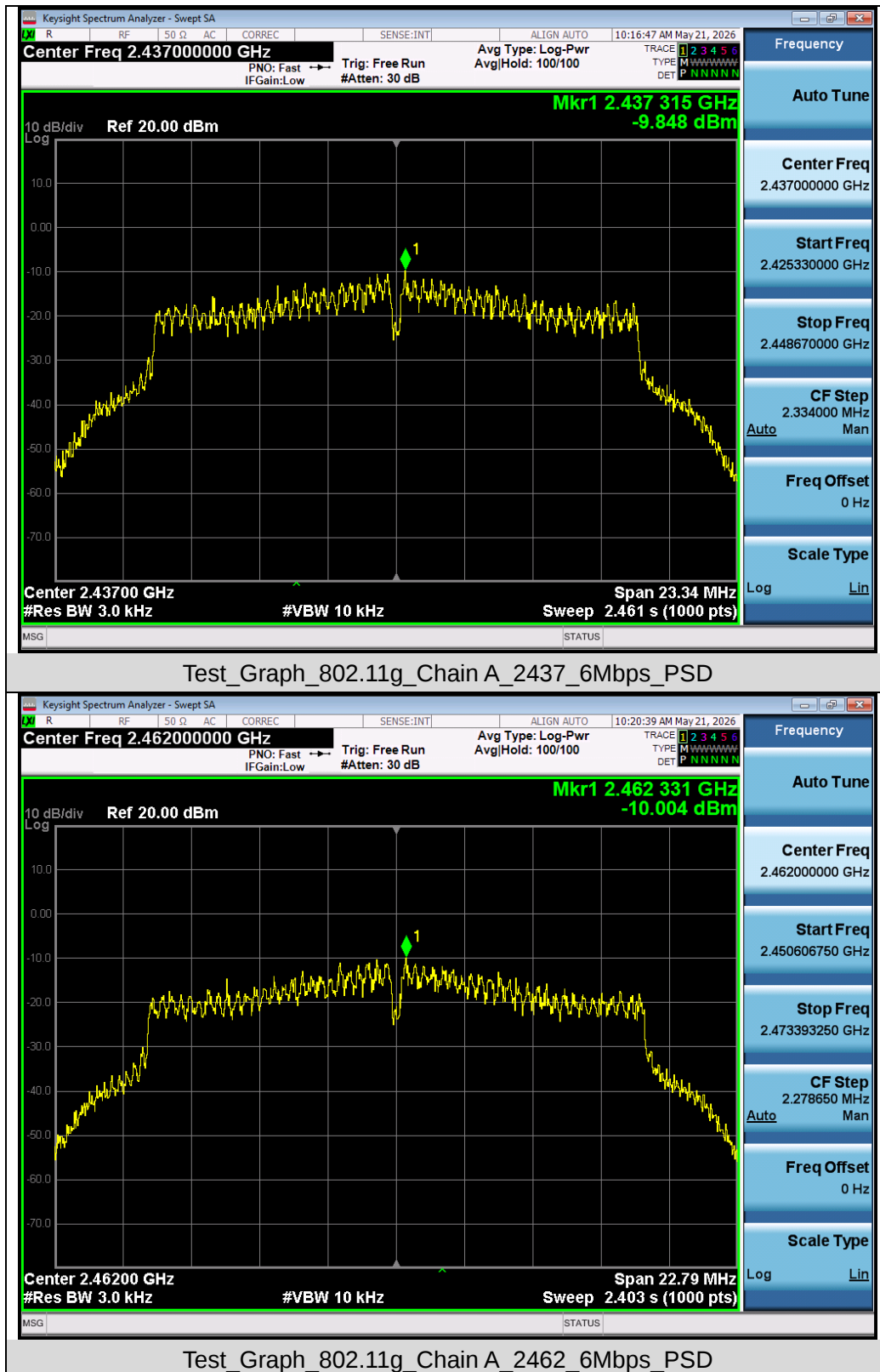

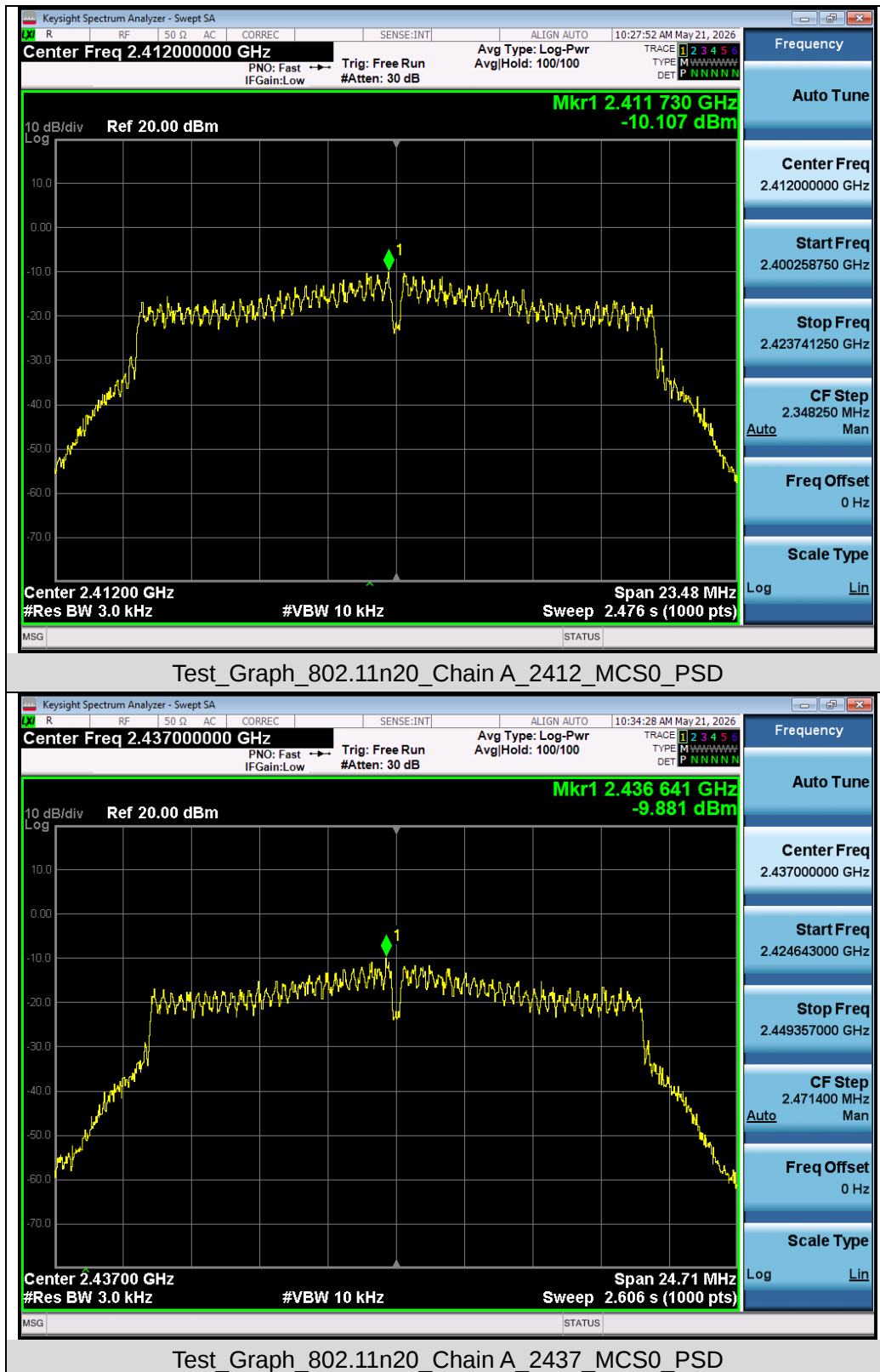

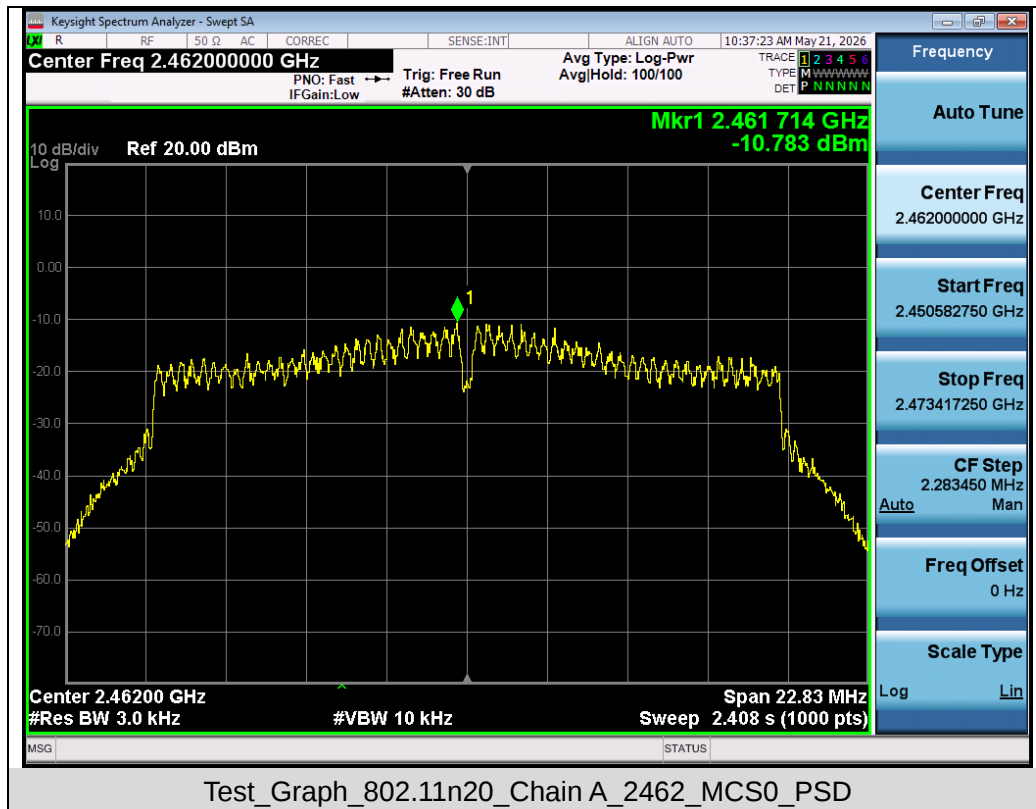

10. Conducted Band Edge and Out-of-Band Emissions

10.1 Provisions Applicable

In any 100kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power.

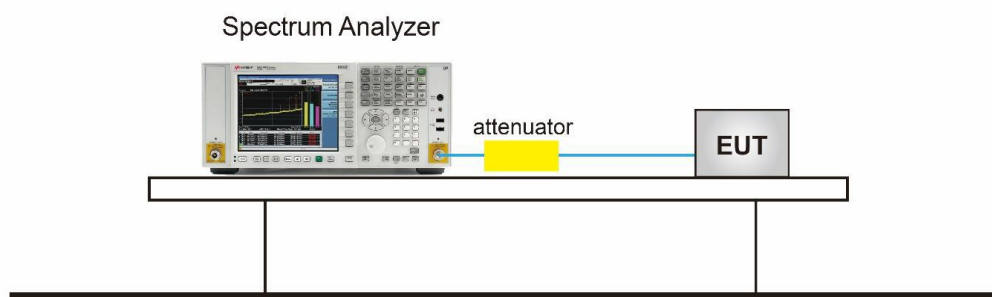

 7. Trace mode = max hold.
 8. Allow trace to fully stabilize.
 9. Use the peak marker function to determine the maximum PSD level.
 10. Note that the channel found to contain the maximum PSD level can be used to establish the reference level.
 11. For reference level values, please refer to DTS bandwidth test.
- Step 2: Measurement Procedure Out of Band Emission
 1. Set RBW = 100 kHz.
 2. Set VBW ≥ 300 kHz.
 3. Detector = peak.
 4. Sweep = auto couple.
 5. Trace Mode = max hold.
 6. Allow trace to fully stabilize.
 7. Use the peak marker function to determine the maximum amplitude level.

Note: The cable loss and attenuator loss were offset into measure device as an amplitude offset.

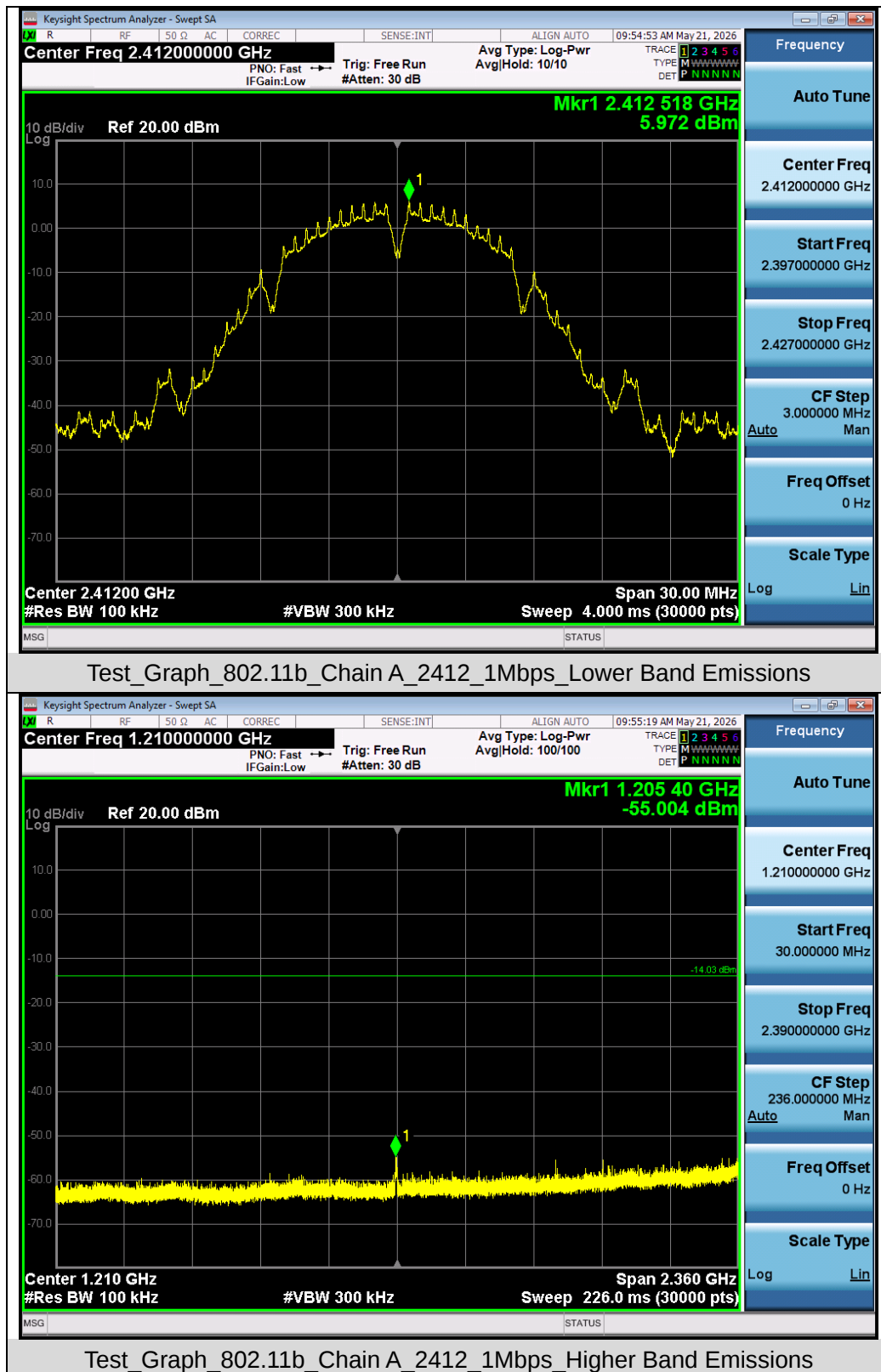

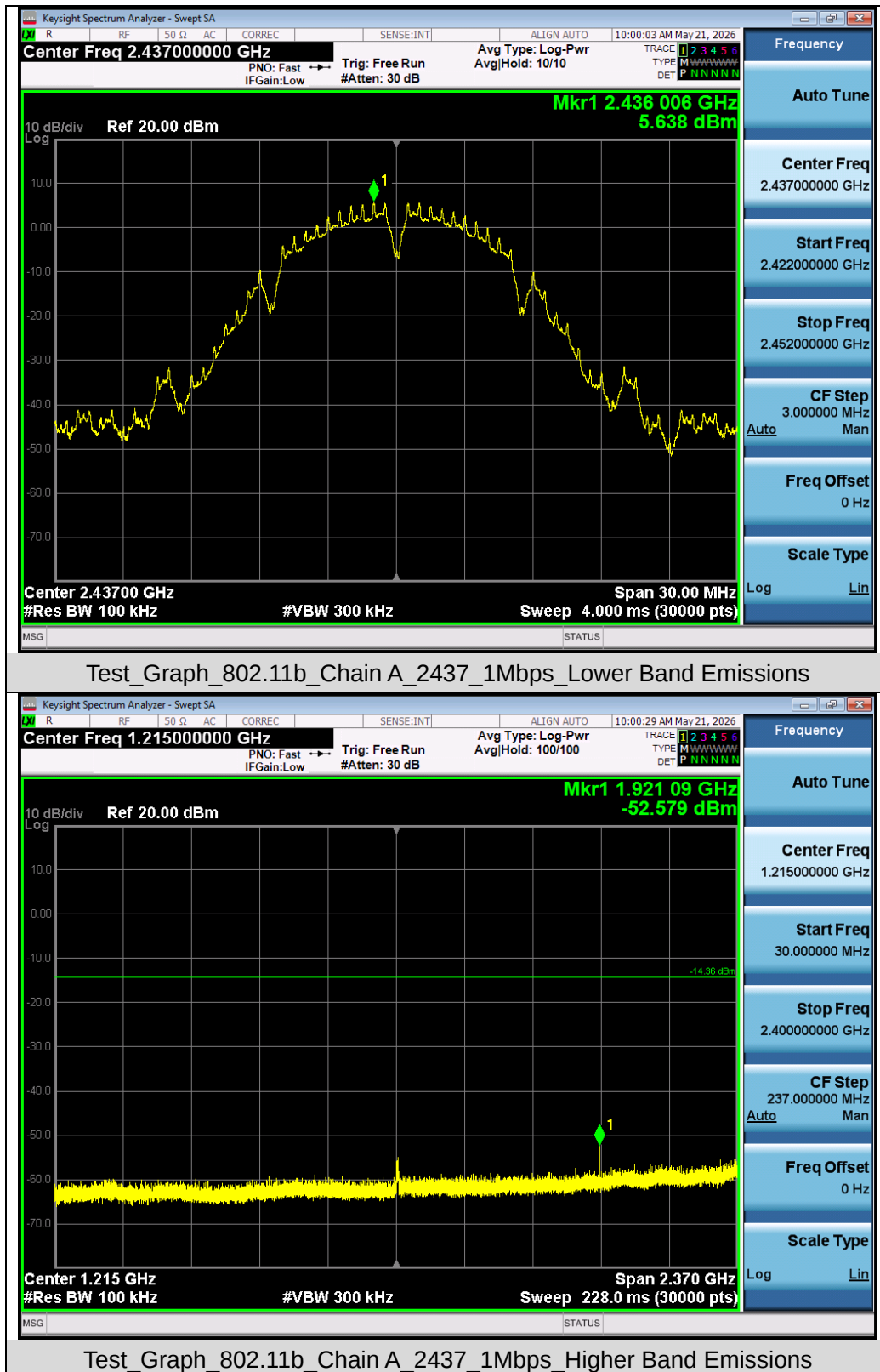

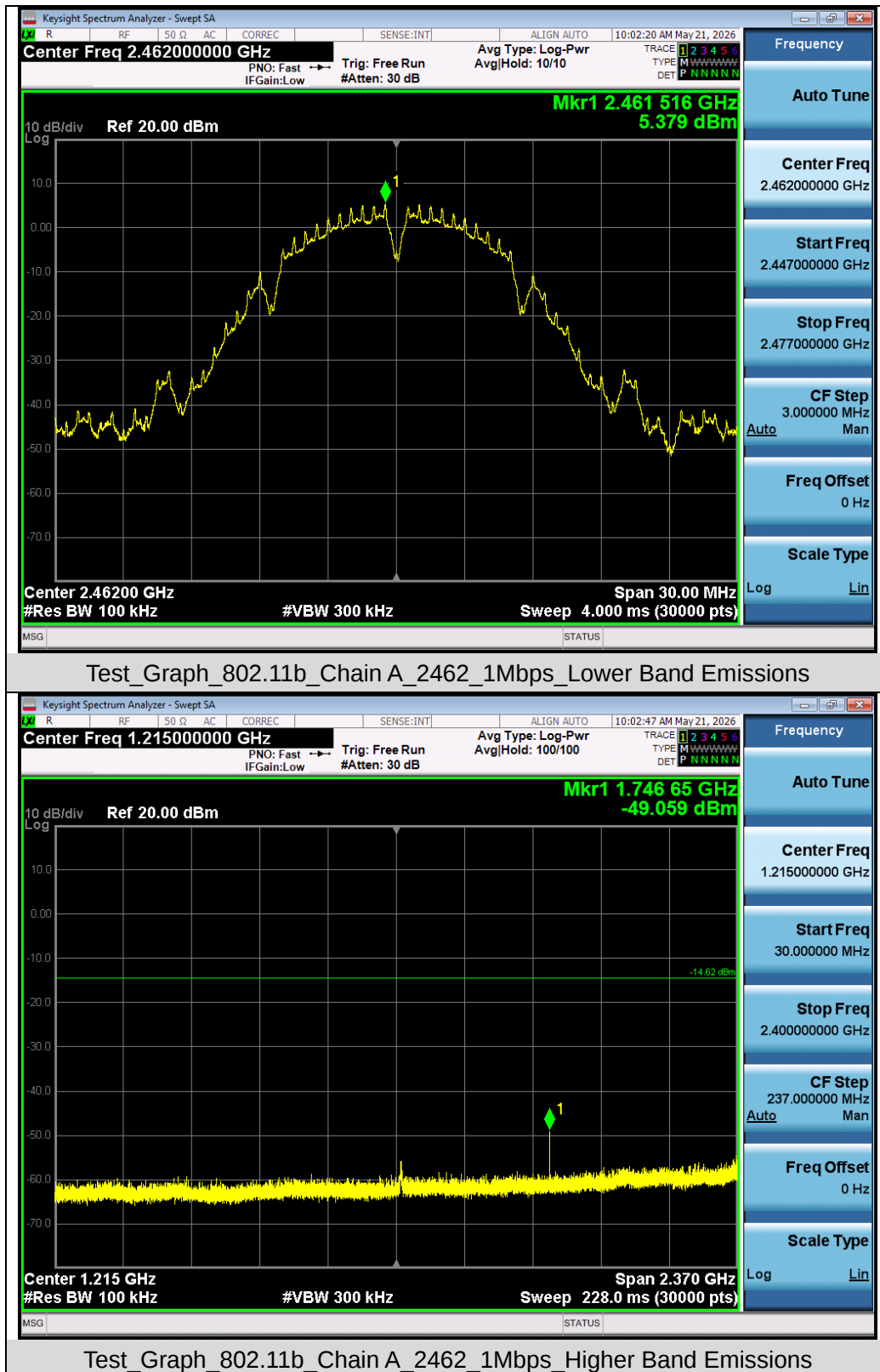
Test Graphs of Spurious Emissions in Non-Restricted Frequency Bands



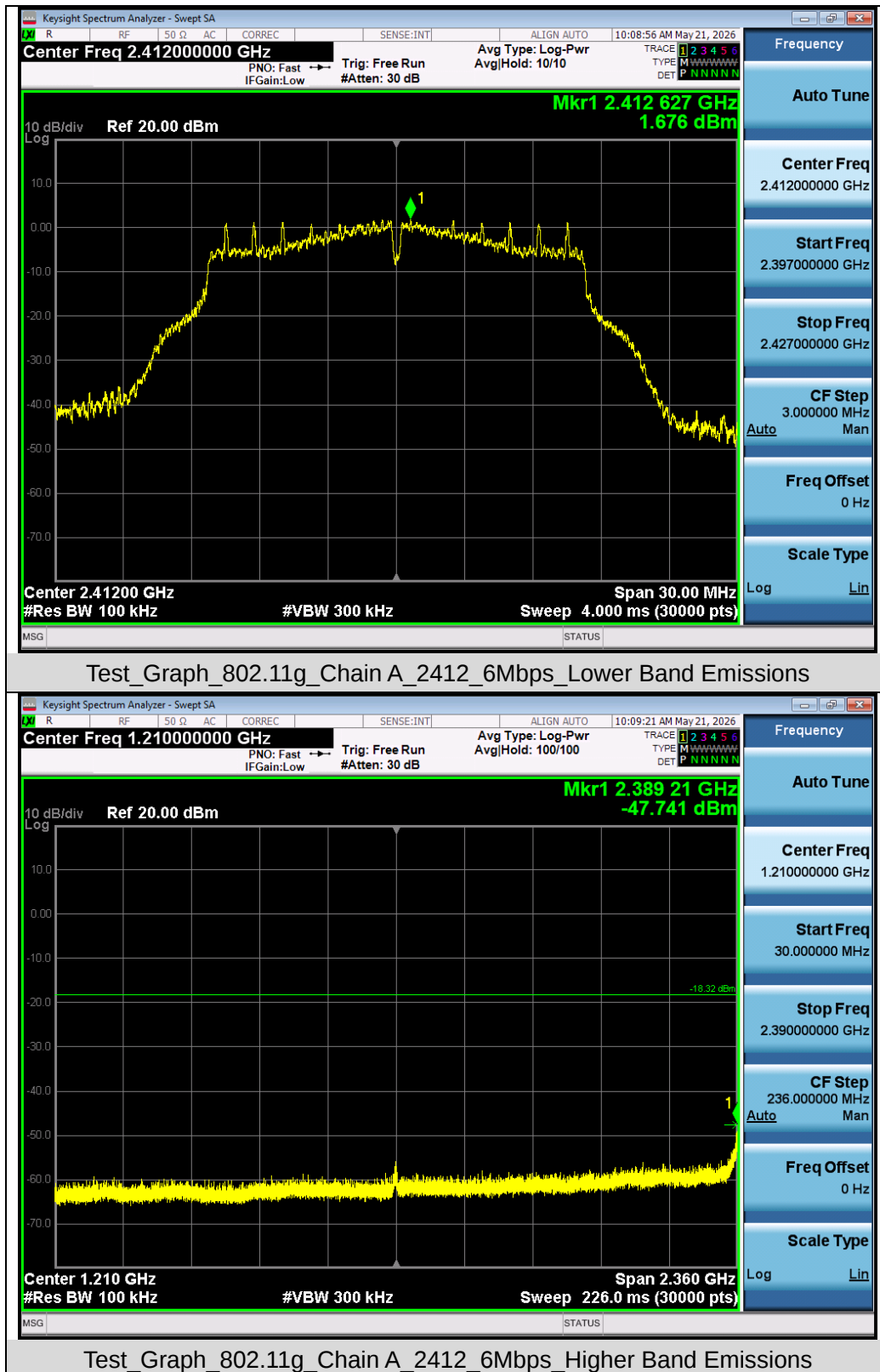

Test Graphs of Band Edge Emissions in Non-Restricted Frequency Bands



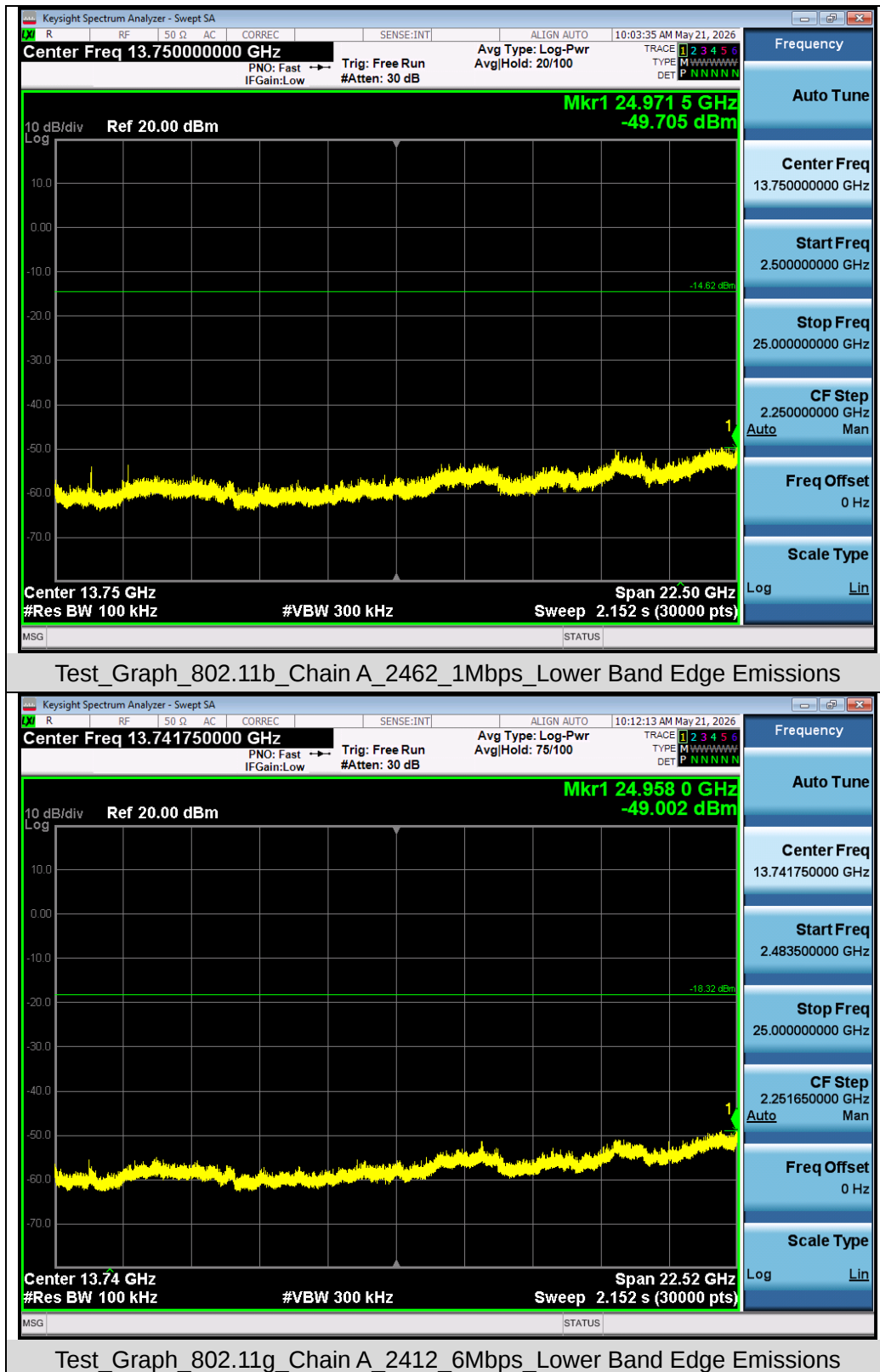
Test_Graph_802.11b_Chain A_2412_1Mbps_Lower Band Edge Emissions



Test_Graph_802.11b_Chain A_2437_1Mbps_Lower Band Edge Emissions

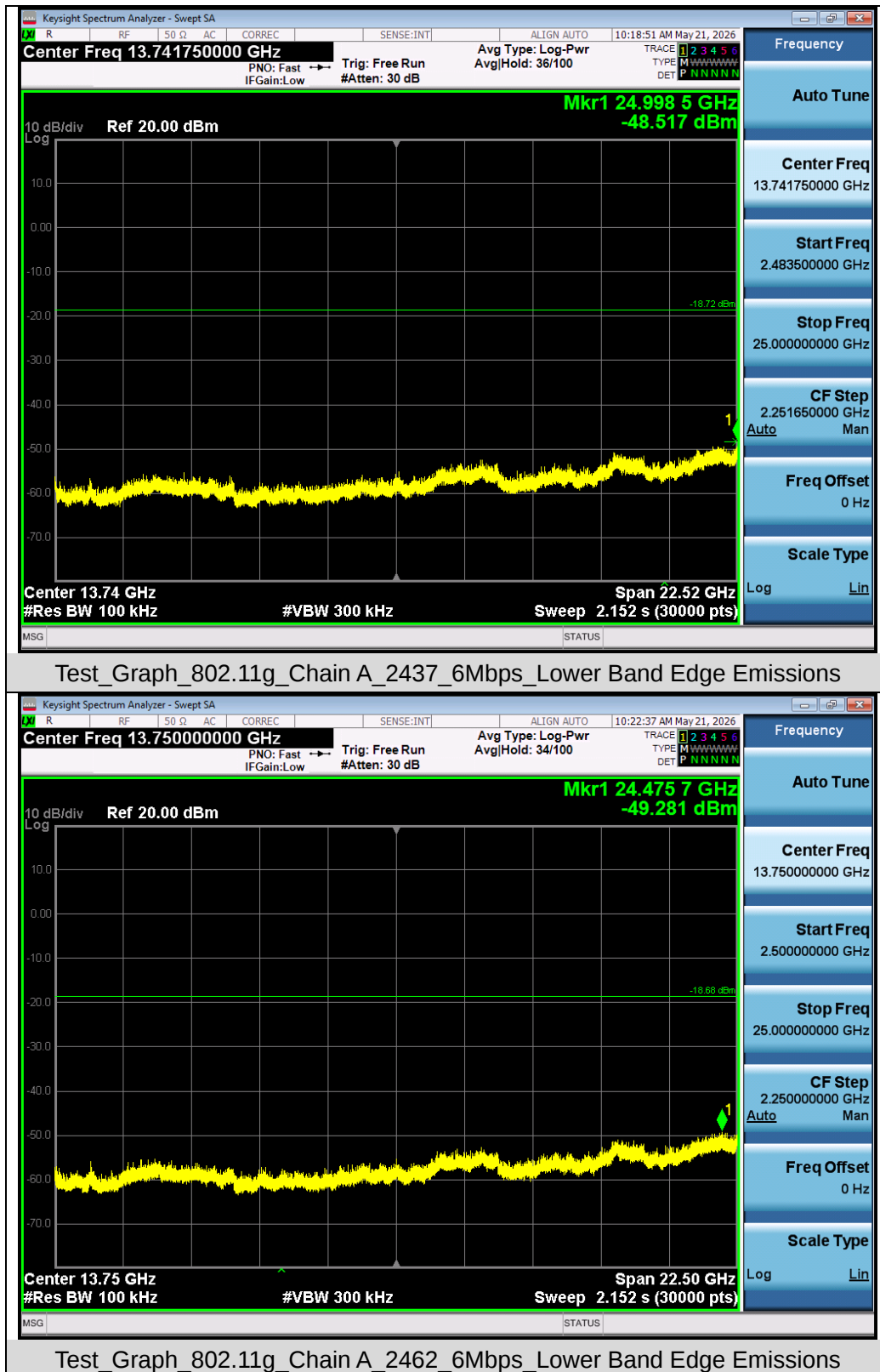

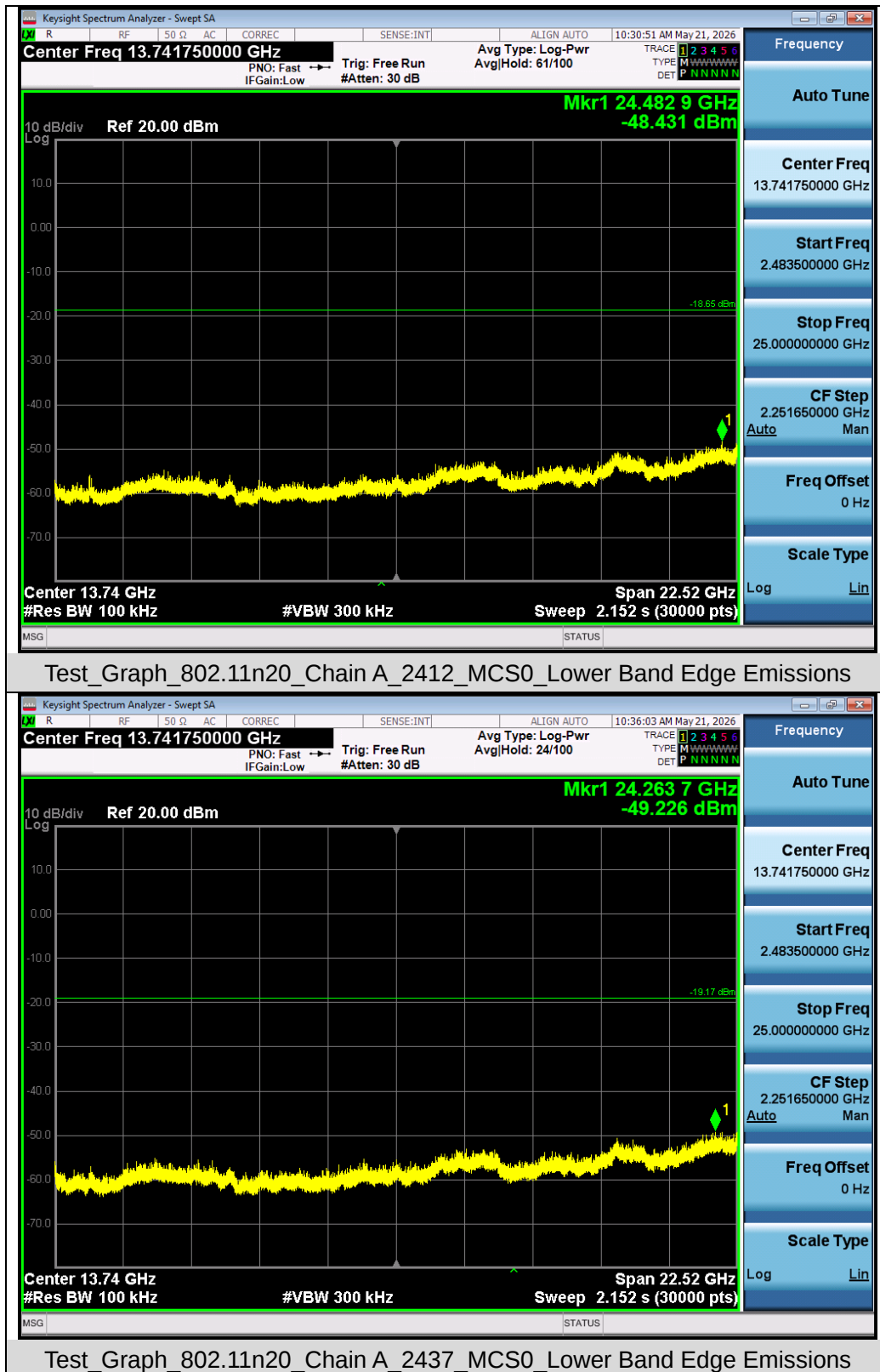

11.1 Measurement Limits

Note: All modes were tested for restricted band radiated emission, the test records reported below are the worst result compared to other modes.

11.2 Measurement Procedure

- The EUT was placed on the top of the turntable 0.8 or 1.5 meter above ground. The phase center of the receiving antenna mounted on the top of a height-variable antenna tower was placed 3 meters far away from the turntable.
- Power on the EUT and all the supporting units. The turntable was rotated by 360 degrees to determine the position of the highest radiation.
- The height of the broadband receiving antenna was varied between one meter and four meters above ground to find the maximum emissions field strength of both horizontal and vertical polarization.
- For each suspected emission, the antenna tower was scan (from 1 M to 4 M) and then the turntable was rotated (from 0 degree to 360 degrees) to find the maximum reading.
- Set the test-receiver system to Peak or CISPR quasi-peak Detect Function with specified bandwidth under Maximum Hold Mode.
- For emissions above 1GHz, insert the 2.4G filter between the receiving antenna and the Pre-amplifier(only for Radiated Spurious Emission). Use 1MHz RBW and 3MHz VBW for peak reading. Place the measurement antenna away from each area of the EUT determined to be a source of emissions at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT, depending on the radiation pattern of the emission and staying aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation for maximum emissions shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane.
- When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds.

As an alternative (provided the transmitter operates for longer than 0.1 seconds) or in cases where the pulse train exceeds 0.1 seconds, the measured field strength shall be determined from the average absolute voltage during a 0.1 second interval during which the field strength is at its maximum values.

8. If the emissions level of the EUT in peak mode was 3 dB lower than the average limit specified, then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions which do not have 3 dB margin will be repeated one by one using the quasi-peak method for below 1GHz.
9. For testing above 1GHz, the emissions level of the EUT in peak mode was lower than average limit (that means the emissions level in peak mode also complies with the limit in average mode), then testing will be stopped and peak values of EUT will be reported, otherwise, the emissions will be measured in average mode again and reported.
10. In case the emission is lower than 30MHz, loop antenna has to be used for measurement and the recorded data should be QP measured by receiver. High - Low scan is not required in this case.

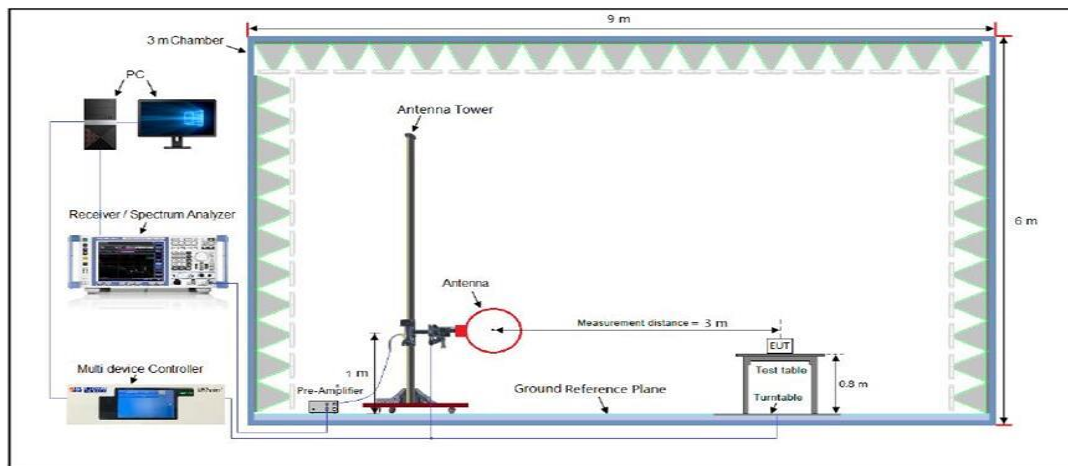

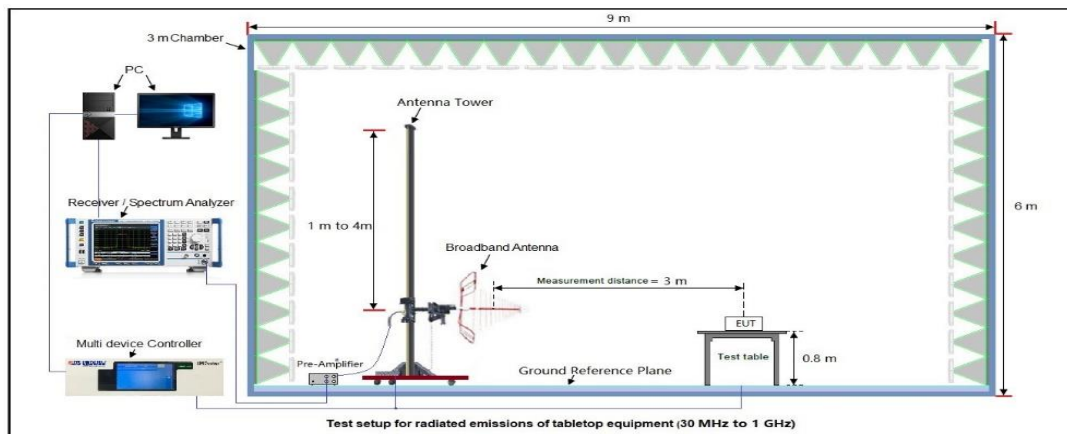

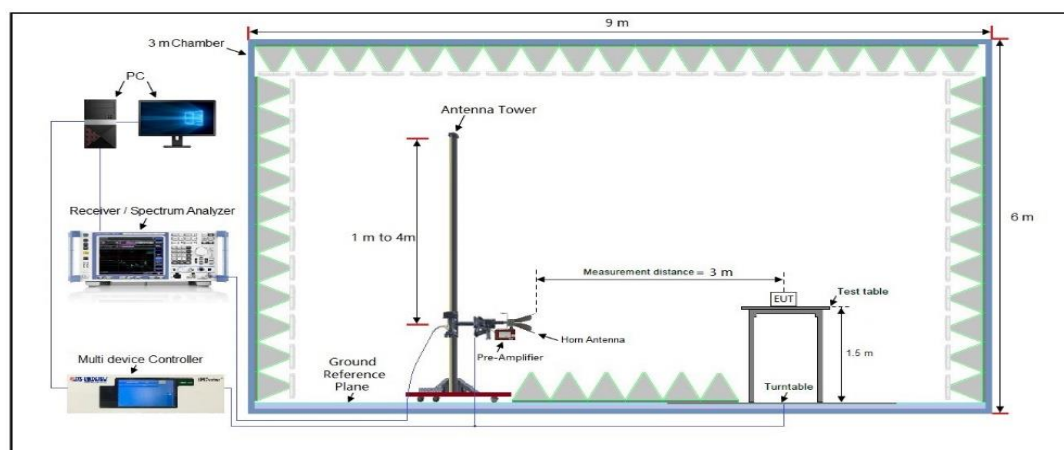
Radiated Emission Test Setup 9kHz-30MHz

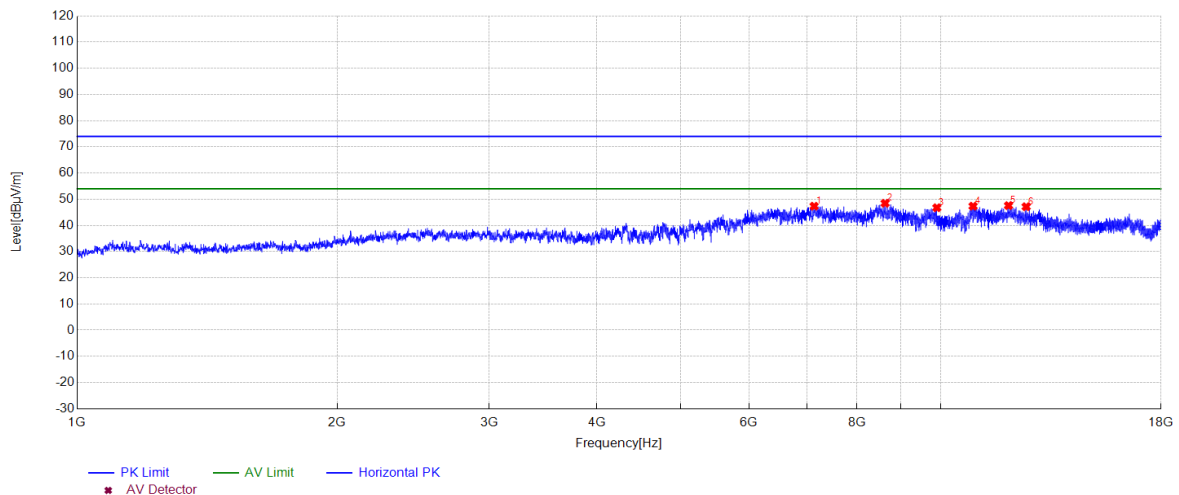

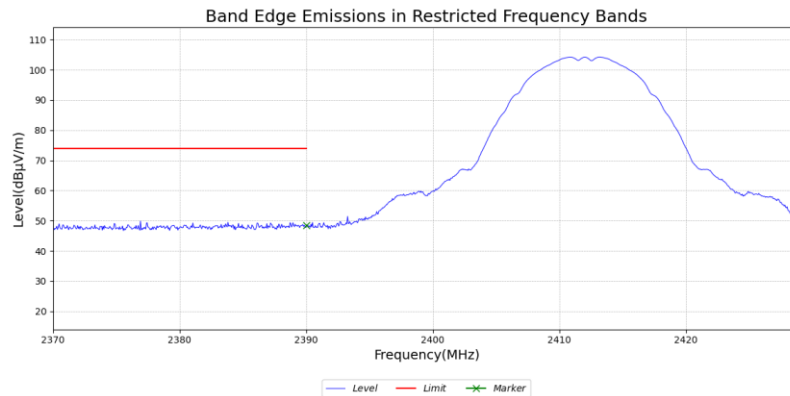

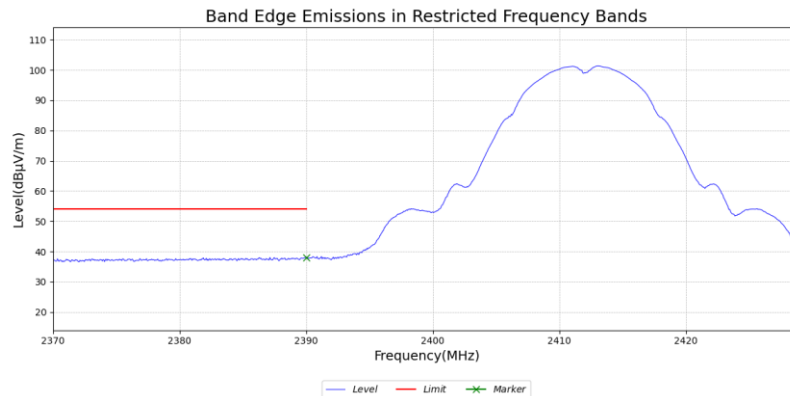

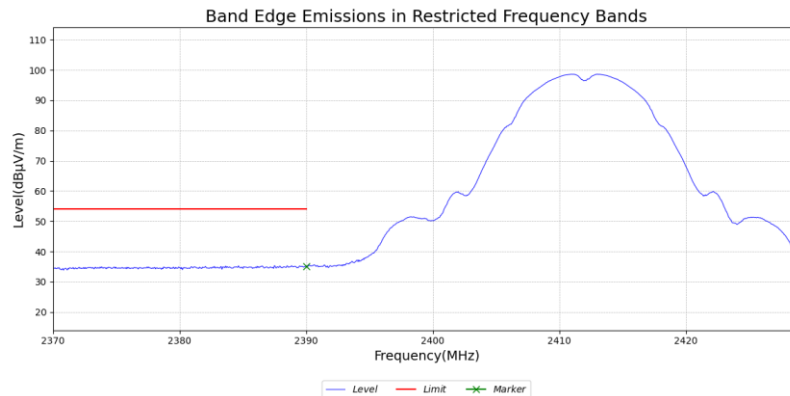

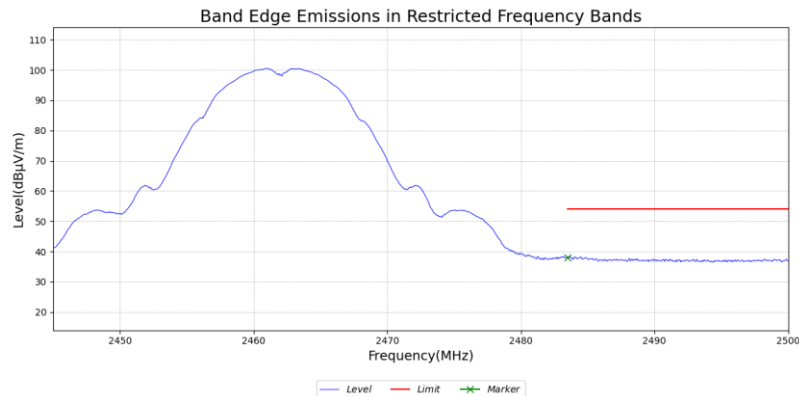
