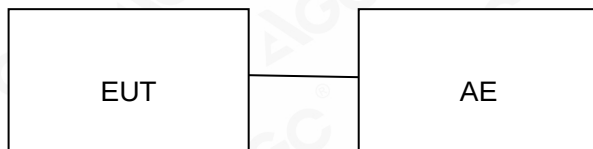

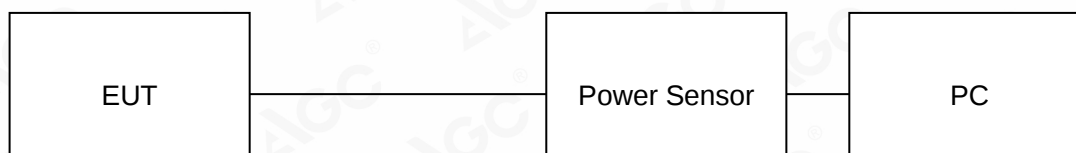
7.1. MEASUREMENT PROCEDURE

1. Connect EUT RF output port to power sensor through an RF attenuator.
2. Connect the power sensor to the PC.
3. Set the EUT Work on the top, the middle and the bottom operation frequency individually.
4. Record the maximum power from the software.

Test_Graph_802.11b_ANT1_2462_1Mbps_OBW

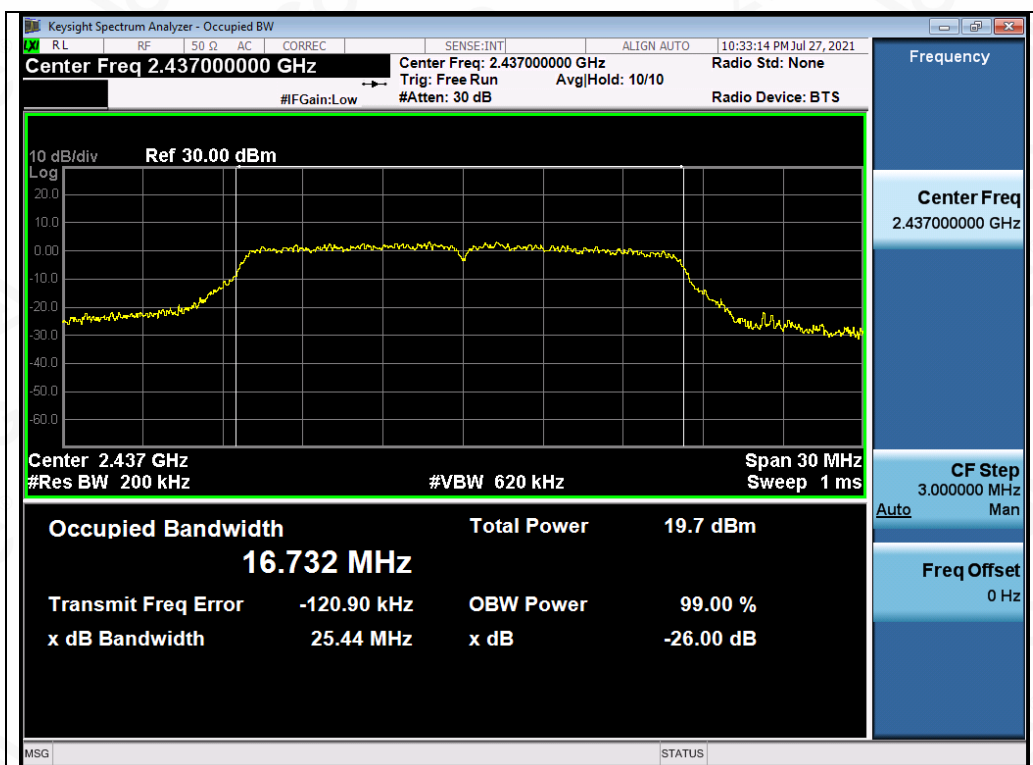

Owing to satisfy the requirements of the number of measurement points, we set the RBW=1MHz, VBW > RBW, scan up through 10th harmonic, and consider the tested results as the worst case, if the tested results conform to the requirement, we can deem that the real tested results(set the RBW=100KHz, VBW > RBW) are conform to the requirement.

Test_Graph_802.11b_ANT1_2462_1Mbps_Lower Band Emissions

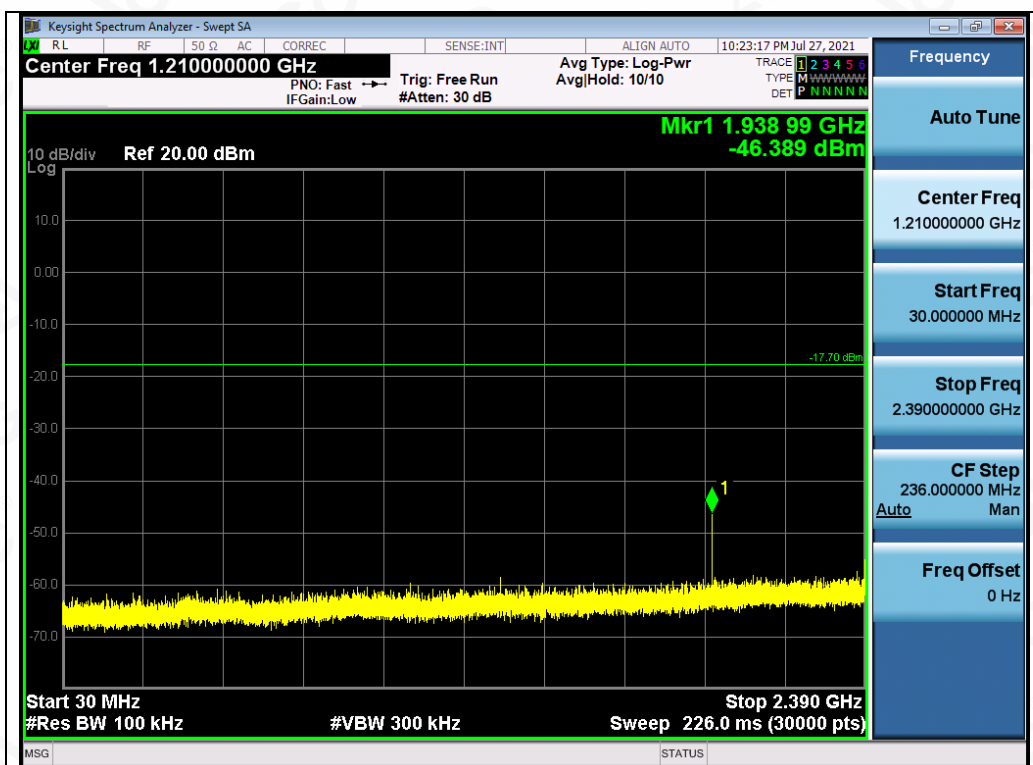

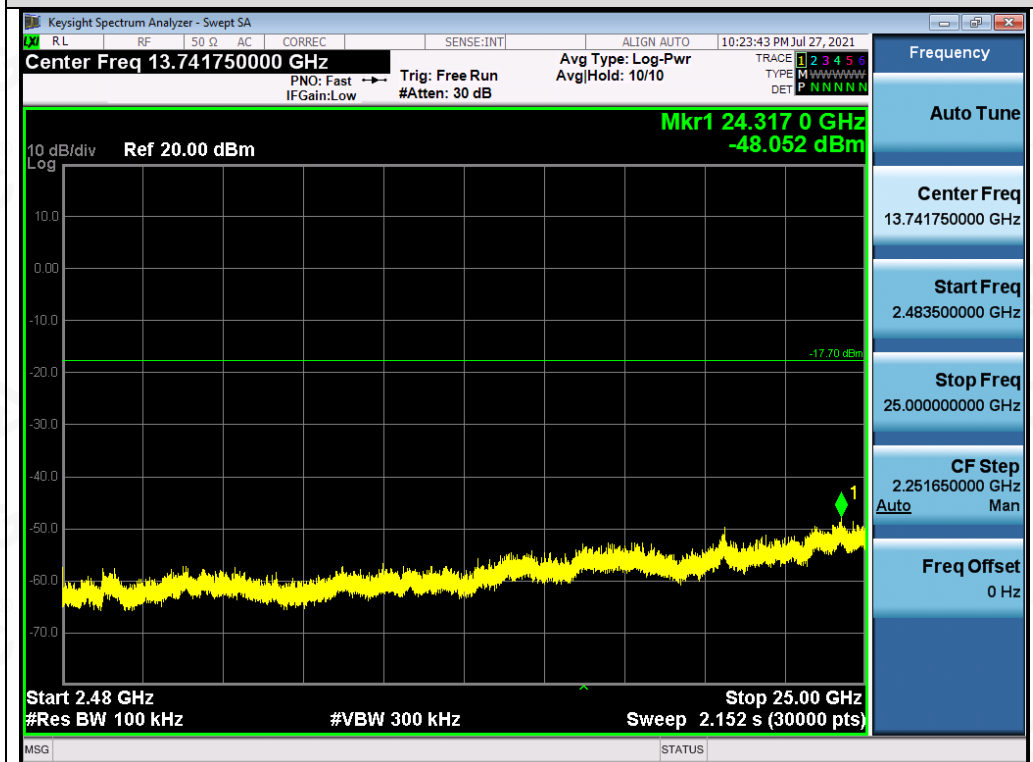

Test_Graph_802.11g_ANT1_2412_6Mbps_Lower Band Emissions

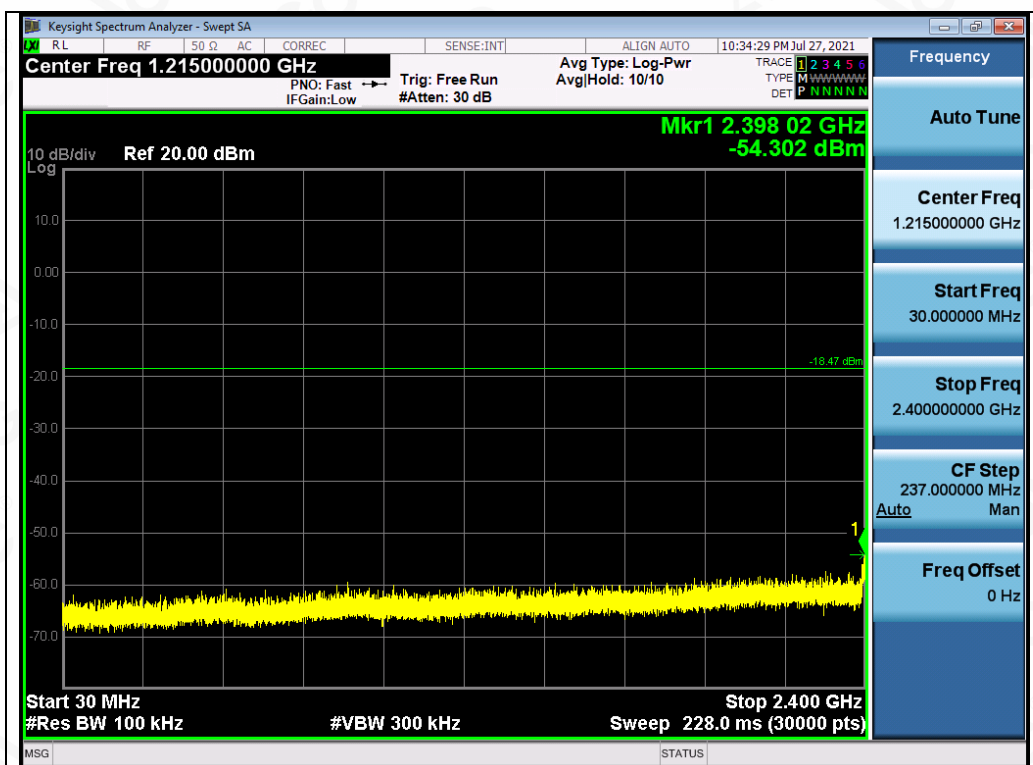


Test_Graph_802.11g_ANT1_2412_6Mbps_Higher Band Emissions

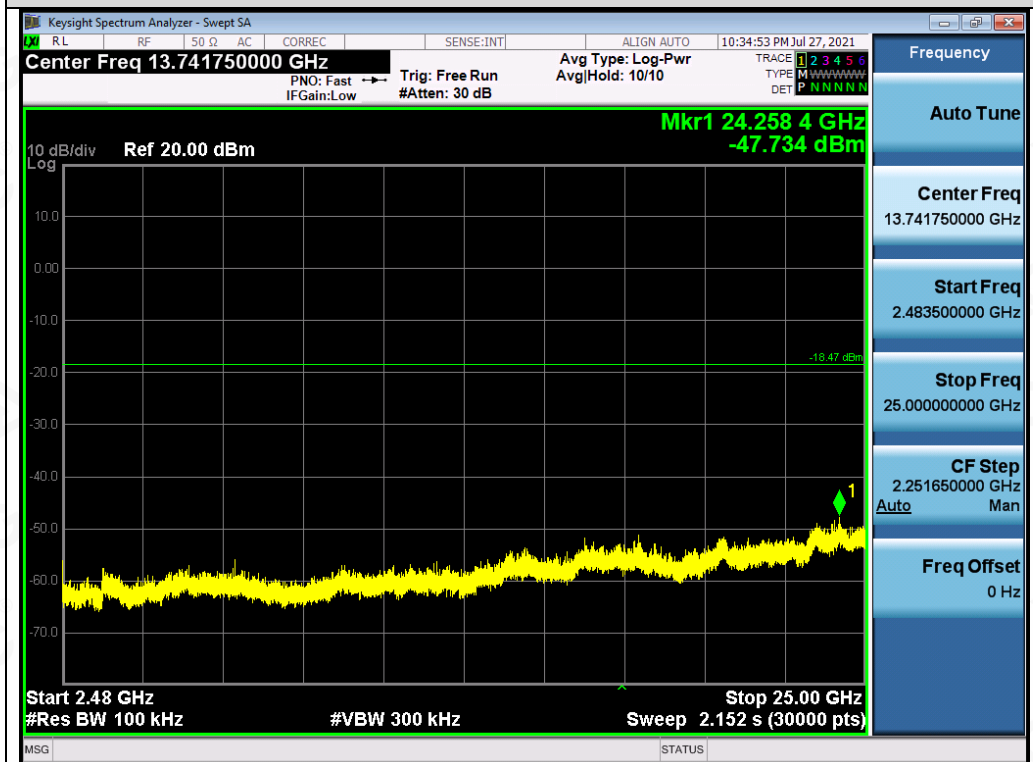

Test_Graph_802.11g_ANT1_2437_6Mbps_Lower Band Emissions

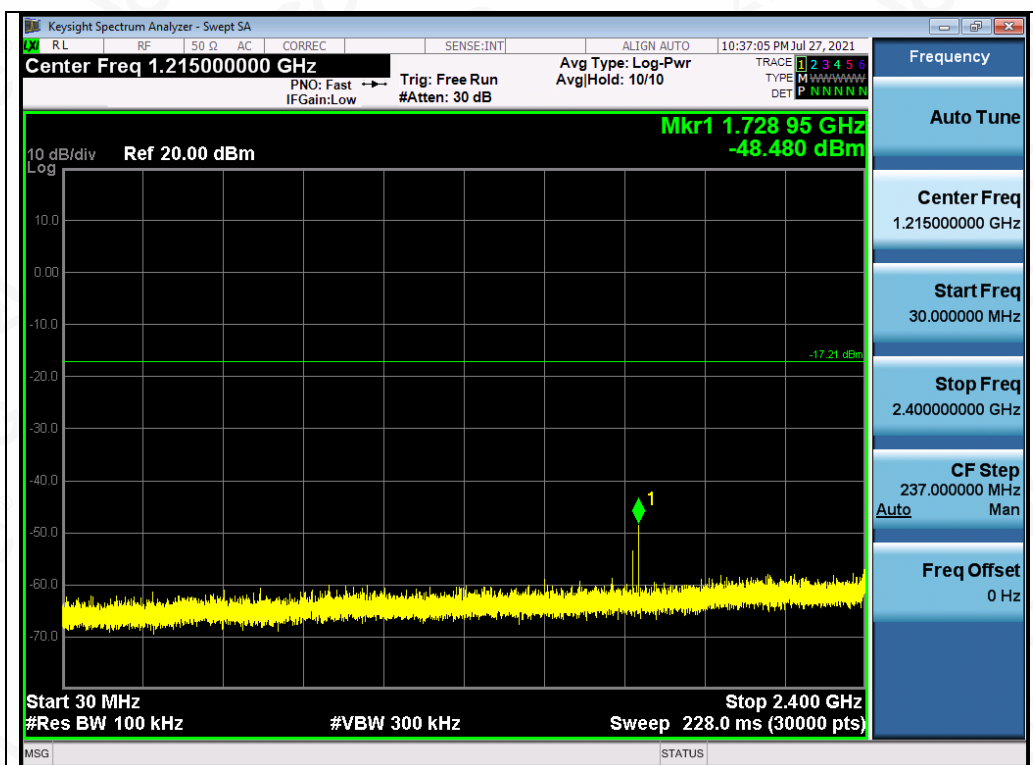

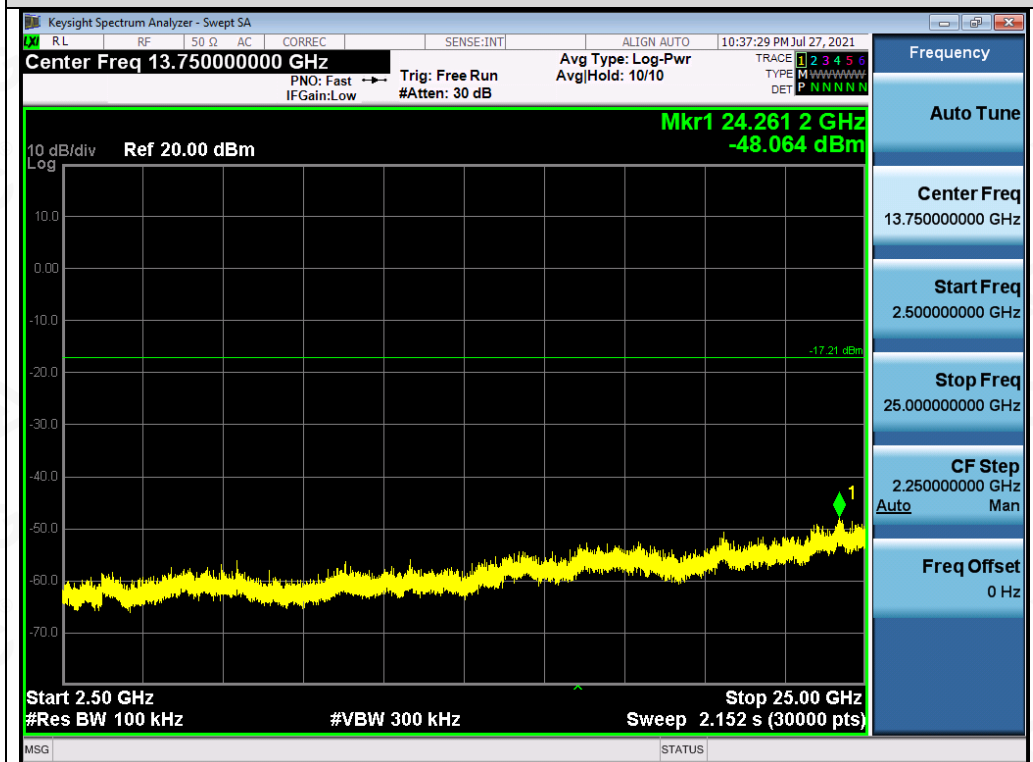

Test_Graph_802.11g_ANT1_2462_6Mbps_Lower Band Emissions

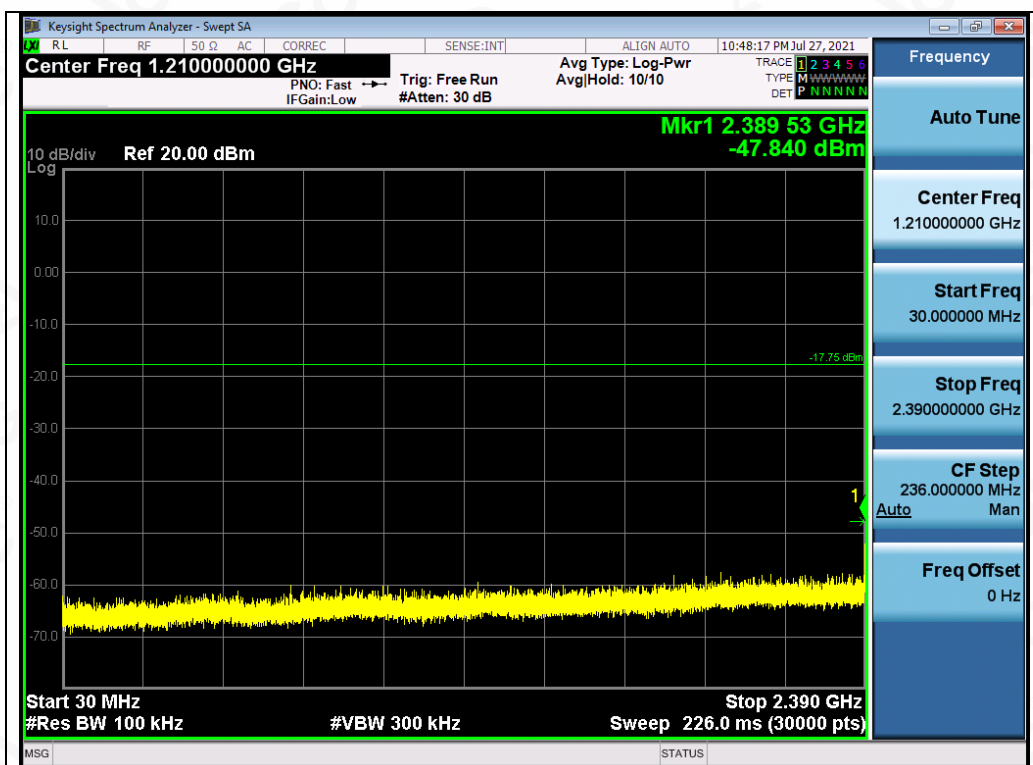

Test_Graph_802.11n20_ANT1_2412_MCS0_Lower Band Emissions

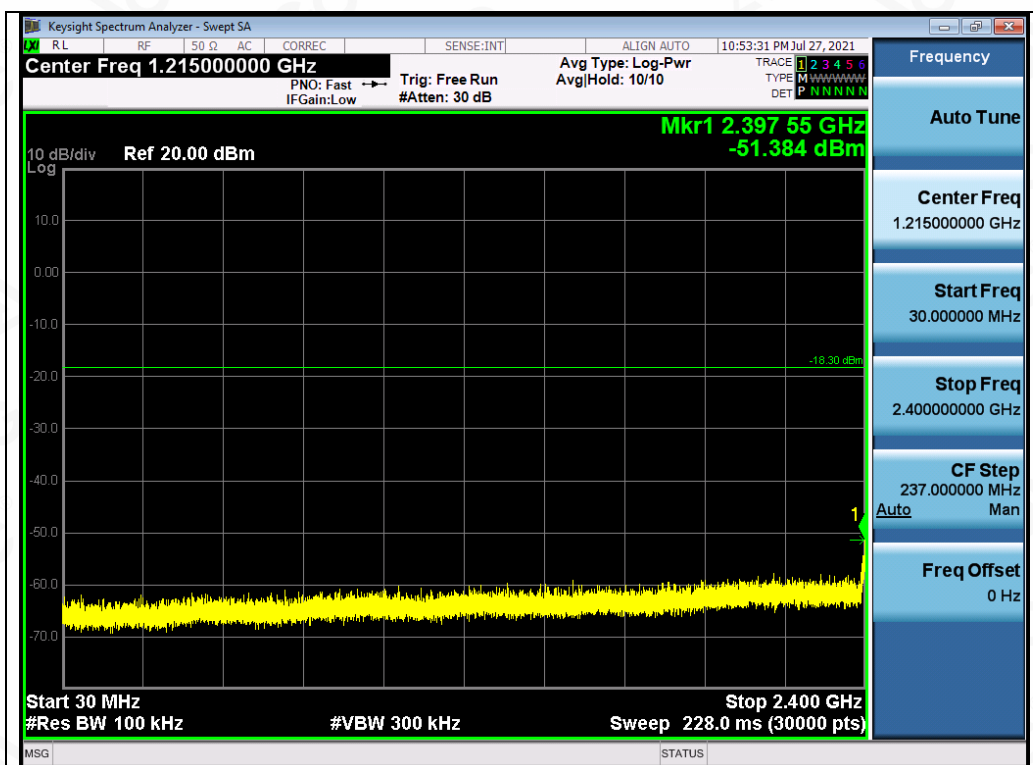

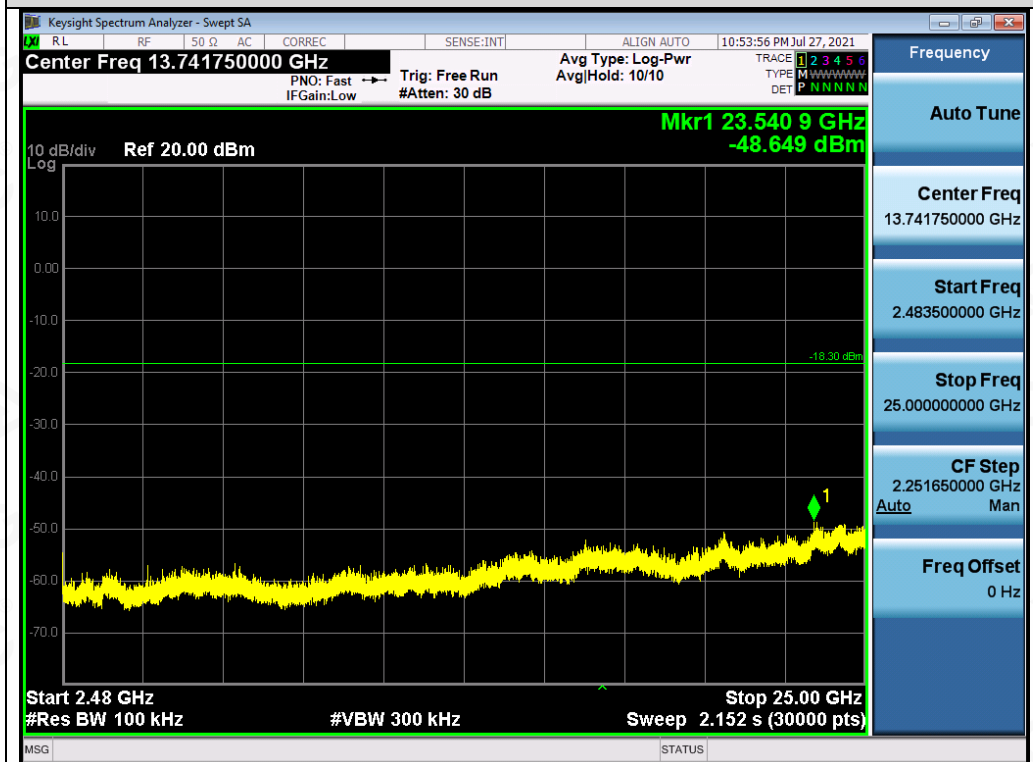

Test_Graph_802.11n20_ANT1_2437_MCS0_Lower Band Emissions

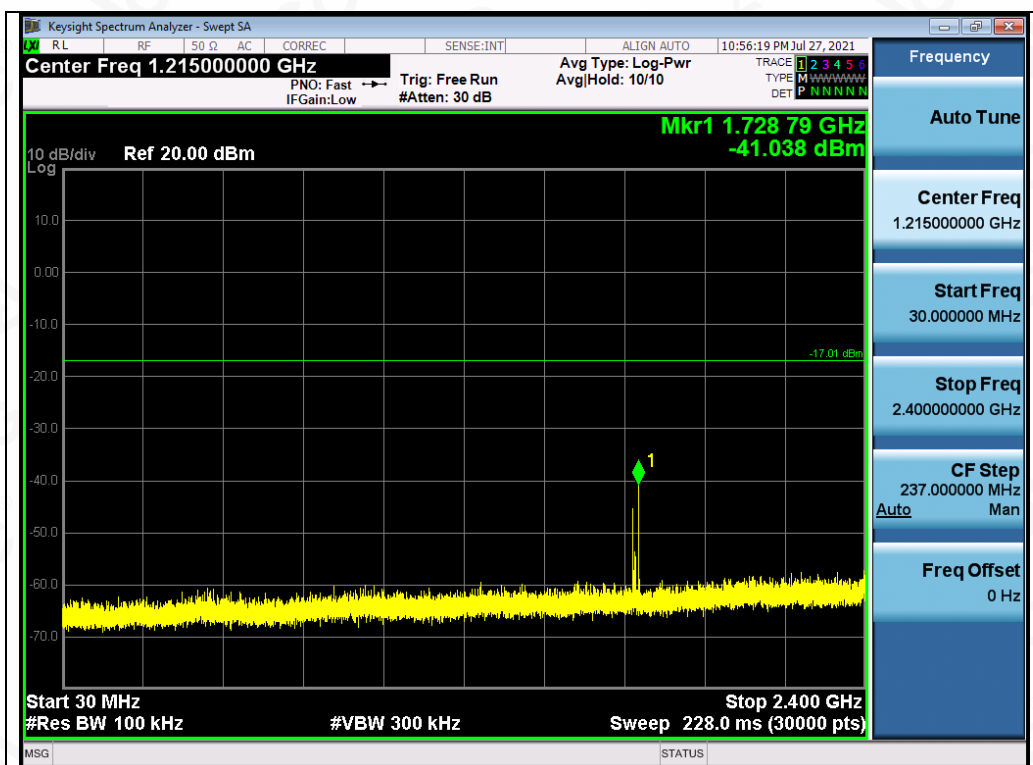

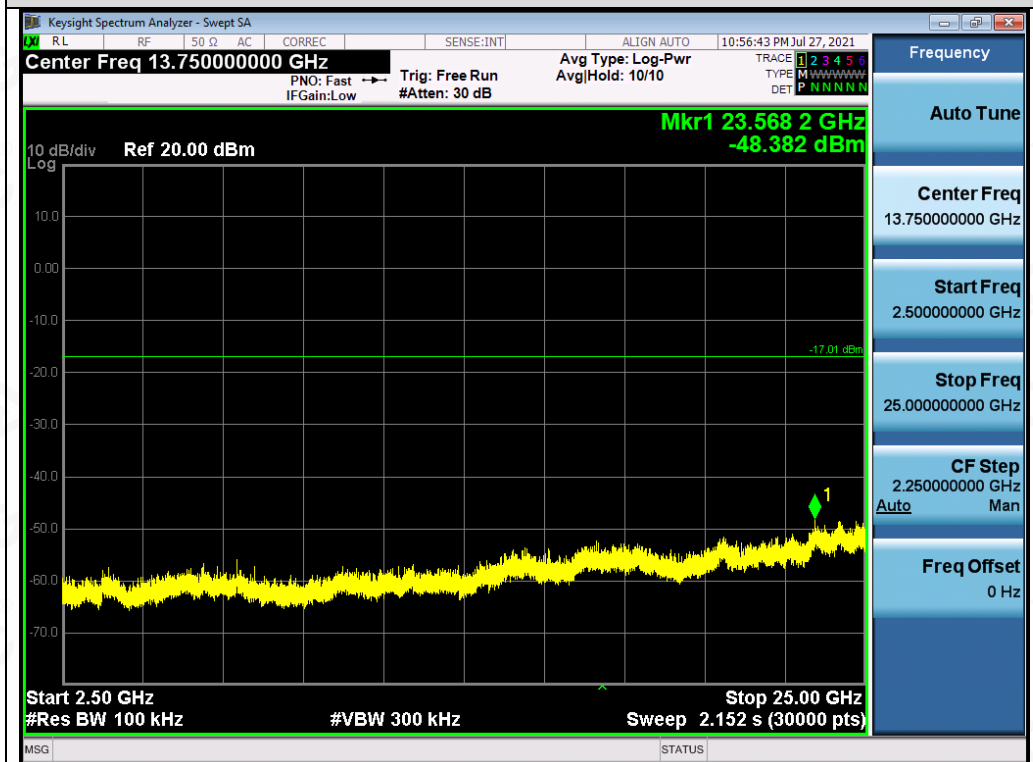

Test_Graph_802.11n20_ANT1_2462_MCS0_Lower Band Emissions

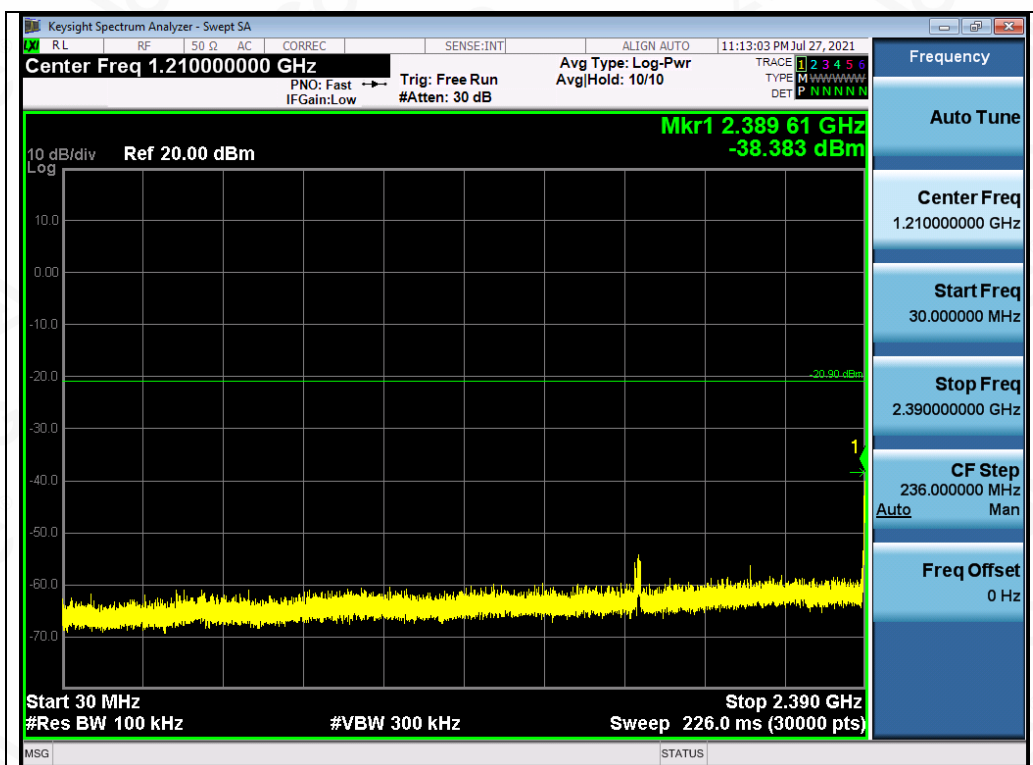

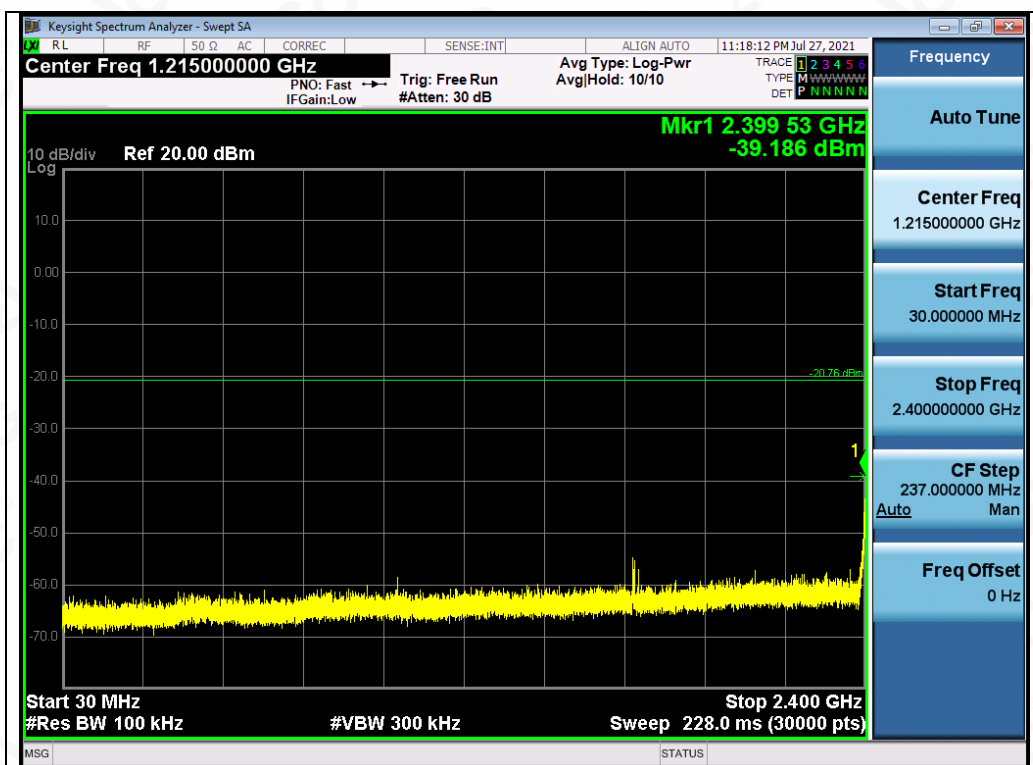

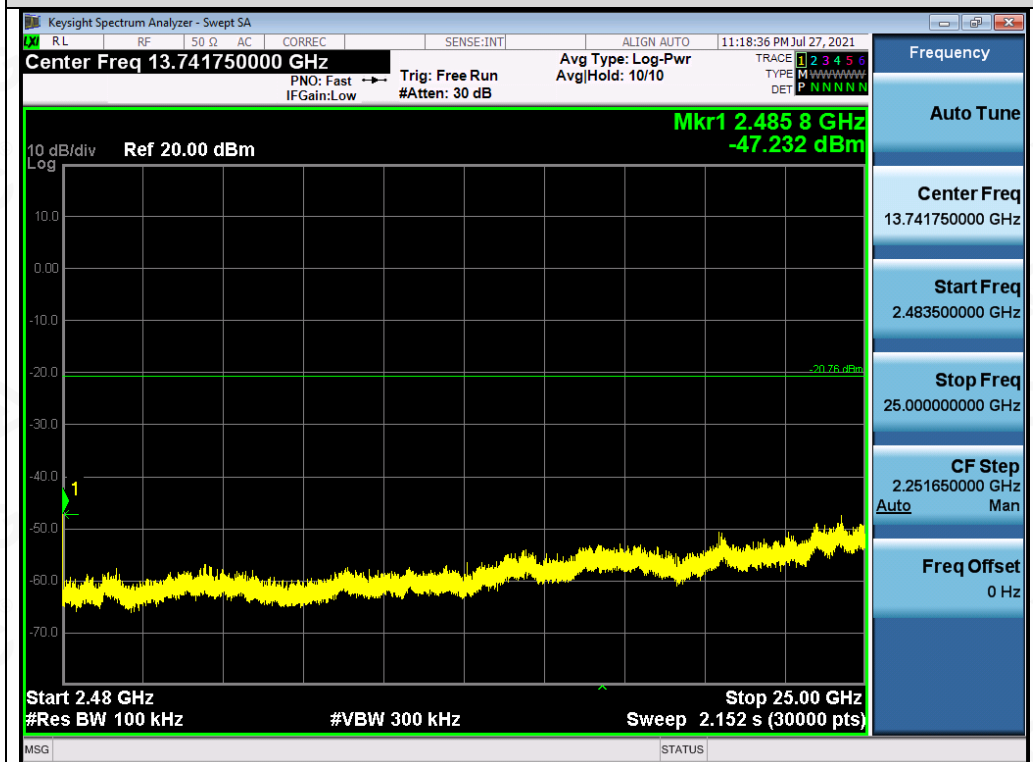

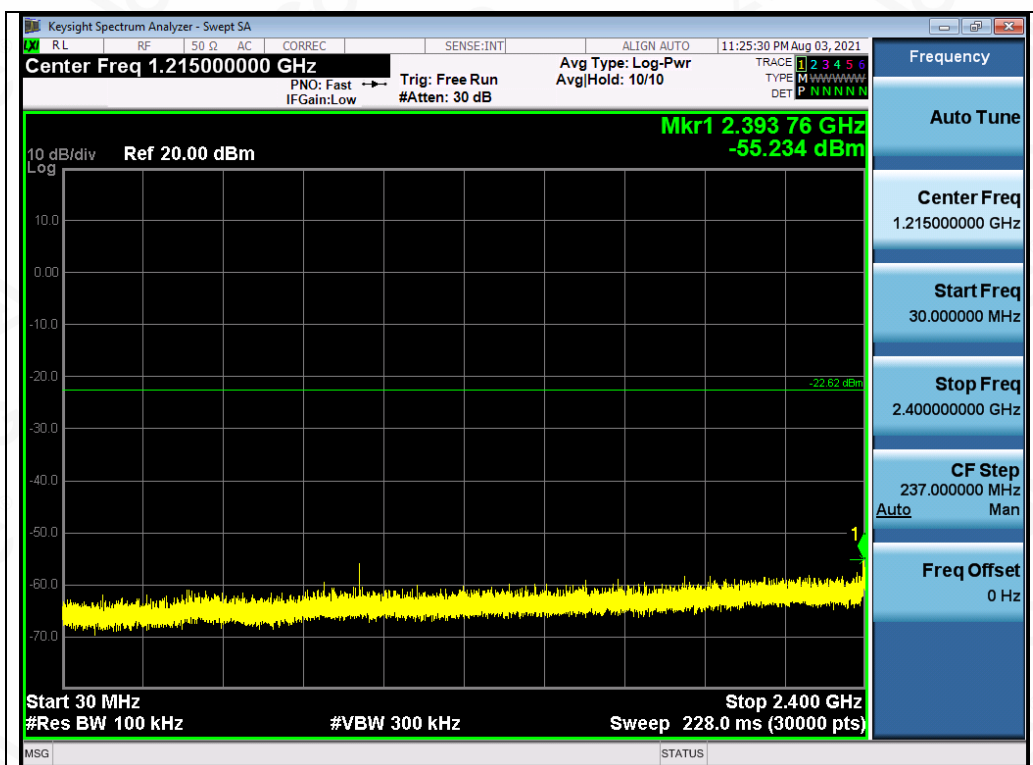
