Note:

TR3S NC-DA, TR3S NC+DA, TR3S NO-DA, TR3S NO+DA (-DA represents On behalf of a magnetron is not installed, +DA represents a magnetron. NC is using the telephone socket, NO is using an audio socket). Magnetron is a magnetic switch. The switch will close when a magnet is placed closely on it. Or the switch will be open in case without a magnet. A magnetron is installed in TR3S to detect the presence or absence of a magnetic pull cord.

Besides magnetic pull cord, TR3S has two kinds of pads used as input. They are sensor pad and wetting pad. Sensor pad has a telephone wire and telephone plug, while wetting pad has a PVC wire with a 5.5mm phone plug. Thus TR3S has either a telephone socket or 5.5mm phone socket on its side wall. Telephone socket is used to connect to sensor pad, while 5.5mm phone socket is used to connect wetting pad.

Telephone socket meaning: This product is the telephone socket of this component, but we call it NC socket (or plug) in the finished machine for detection the status of external medical pad. In case of patient fall off, no body weight and pressure on medical pad, Alarm alerts.

The models TR3S NC-DA, TR3S NC+DA, TR3S NO-DA, TR3S NO+DA are identical to each other except for the magnetron, the model name, the telephone socket and the audio socket.

All tests were performed on the models TR3S NC+DA as representative.

5.2 Antenna requirement

Standard requirement

15.203 requirement:

For intentional device. According to 15.203. an intentional radiator shall be designed to Ensure that no antenna other than that furnished by the responsible party shall be used with the device.

15.247(c) (1)(i) requirement:

(i) Systems operating in the 2400-2483.5 MHz bands that are used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6 dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.

The antenna is a 2.4G Built-in nickel-plated brass antenna and no consideration of replacement. The best case gain of the antenna is 2dBi.

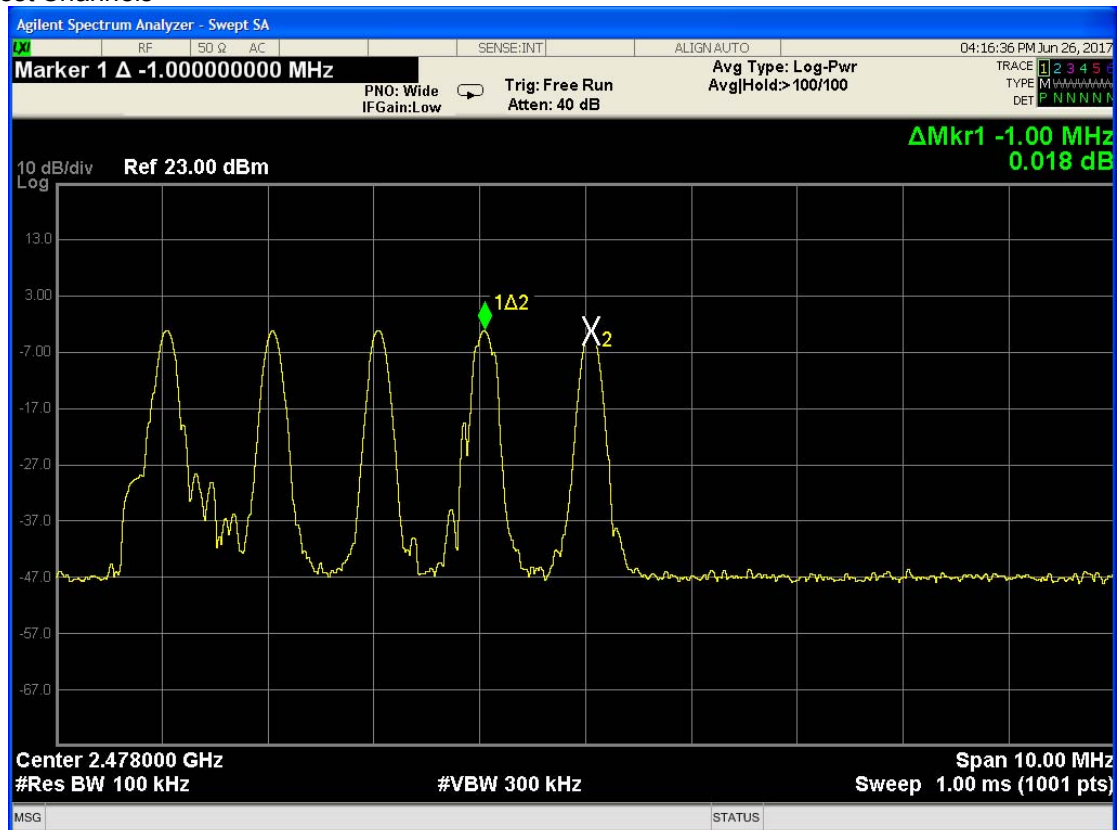
