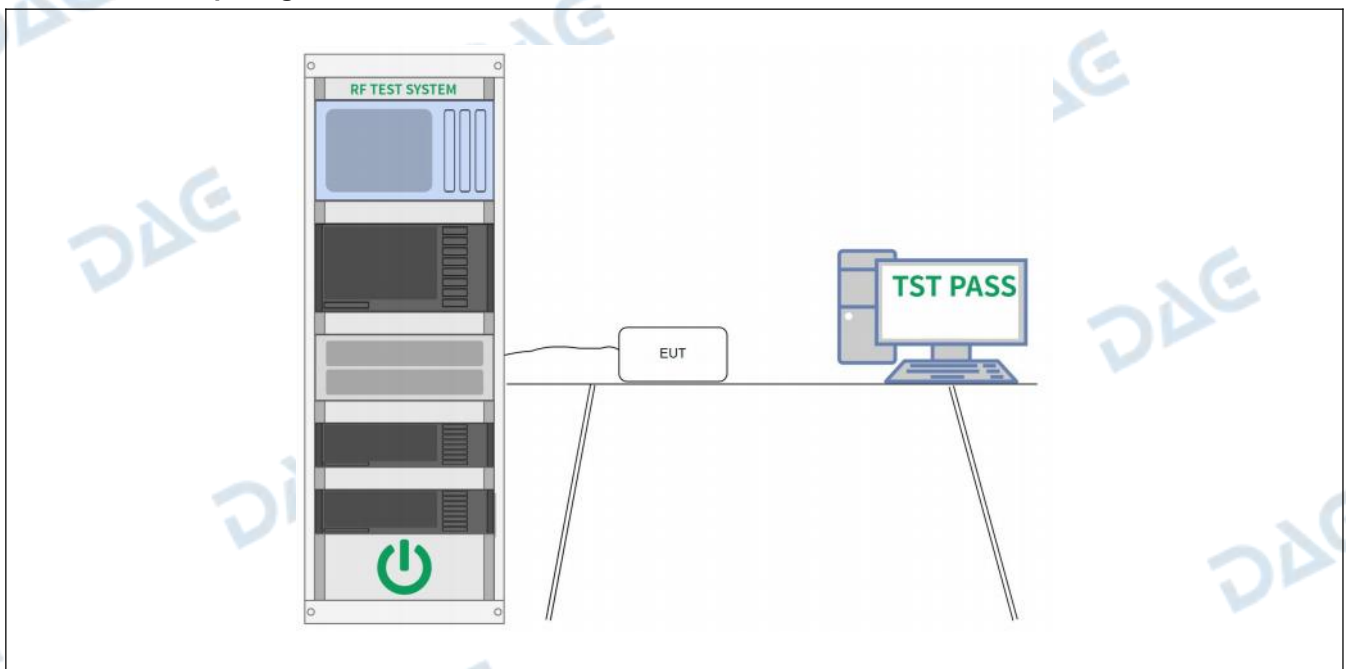
4.4 Power Spectral Density

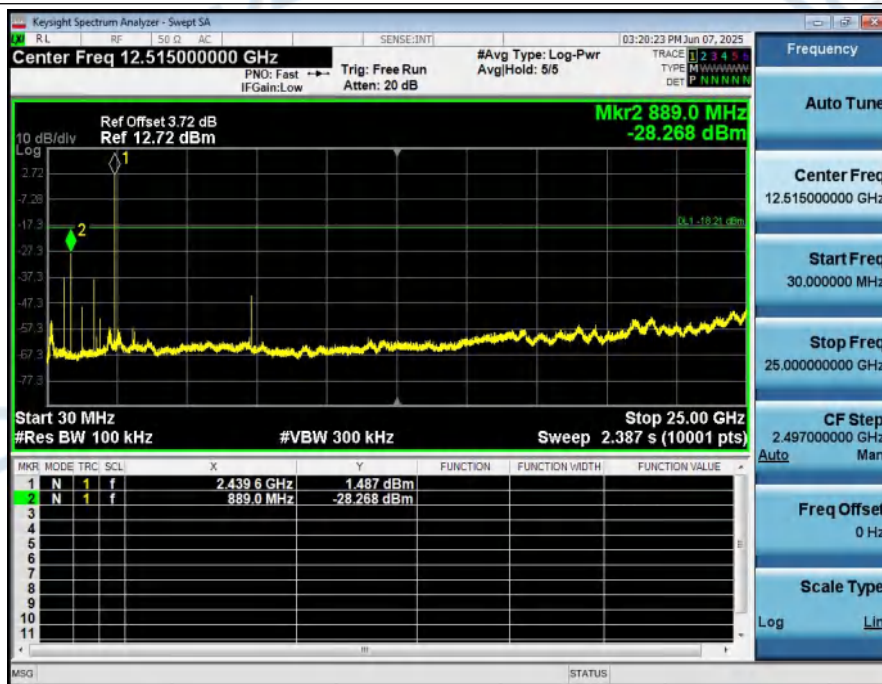
