### Product Description for Equipment under Test (EUT)

The *Epik One America Corporation*'s product, model number: *K534 (FCC ID: 2AO6ZK534)* or the "EUT" in this report was a *Smart Phone*, which was measured approximately: 146.7 mm (L) × 72.0 mm (W) × 10.15 mm (H), rated with input voltage: DC 3.8V from rechargeable Li-ion battery or DC 5.0V from adapter.

### Objective

This type approval report is prepared on behalf of *Epik One America Corporation* in accordance with Part 2, Part 22-Subpart H, Part 24-Subpart E of the Federal Communication Commission's rules.

All tests and measurements indicated in this document were performed in accordance with the Code of Federal Regulations Title 47 Part 2, Sub-Part J as well as the following parts:

Part 24 Subpart E - Personal Communication Services

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

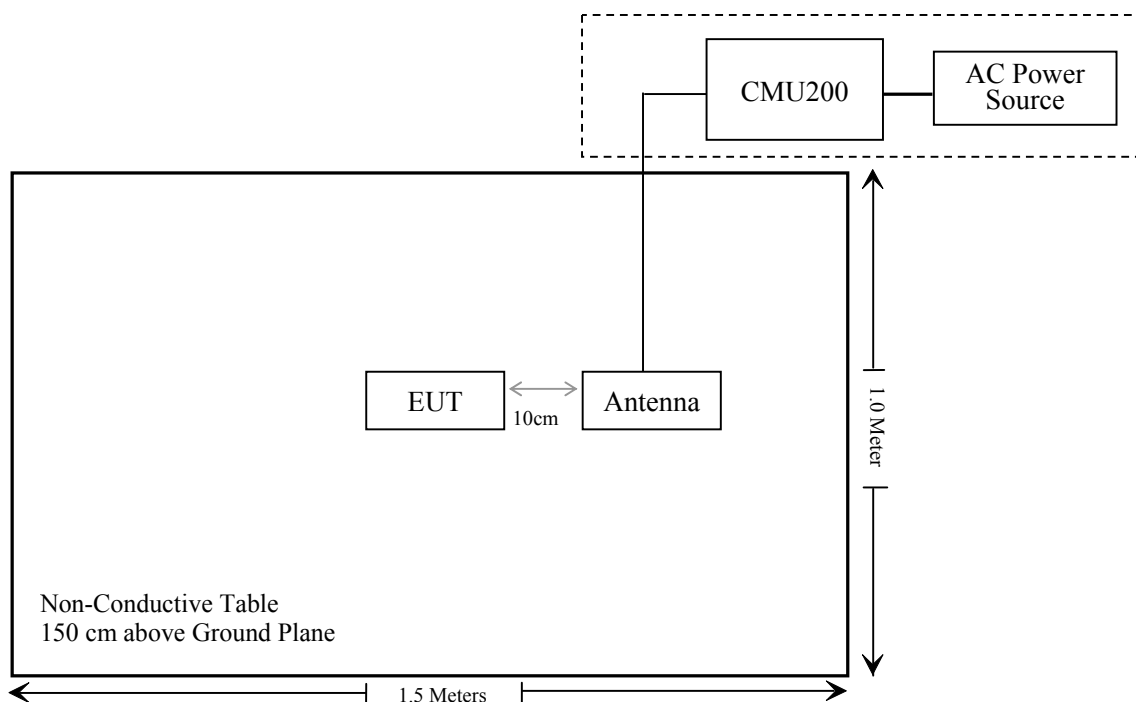

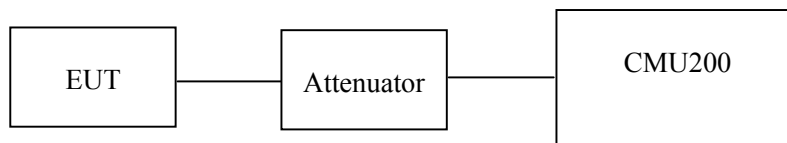

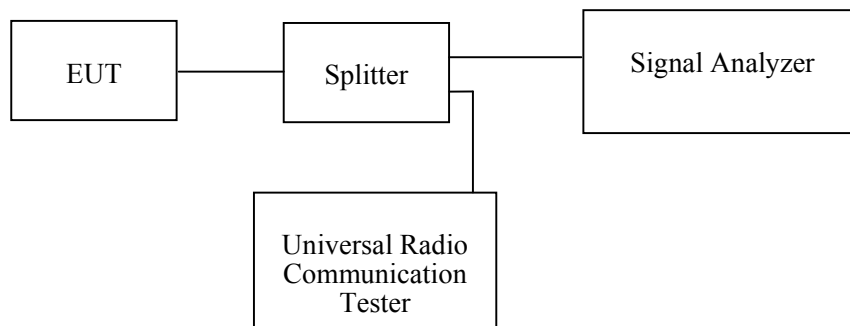

**Test Procedure**

The RF output of the transmitter was connected to the simulator and the spectrum analyzer through sufficient attenuation.

The resolution bandwidth of the spectrum analyzer was set at 5 kHz (GSM) & 100 kHz (WCDMA) and the 26 dB & 99% bandwidth was recorded.

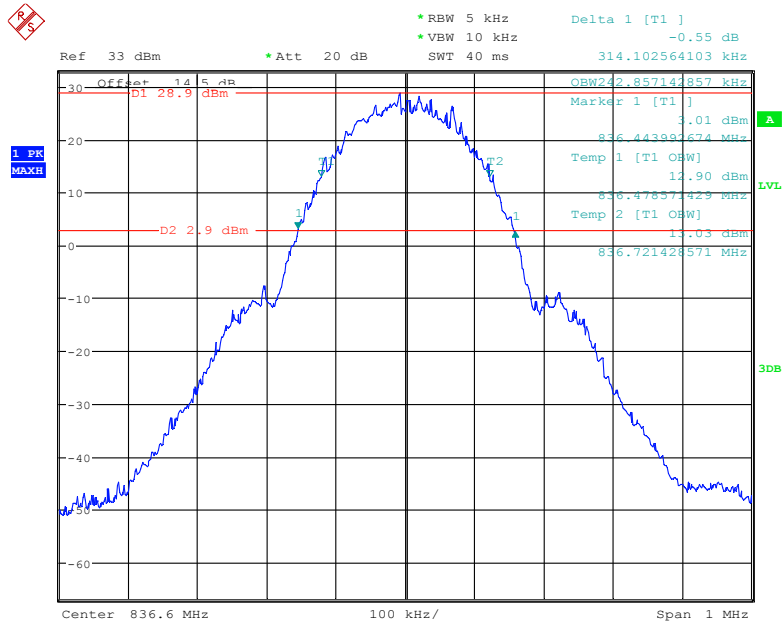

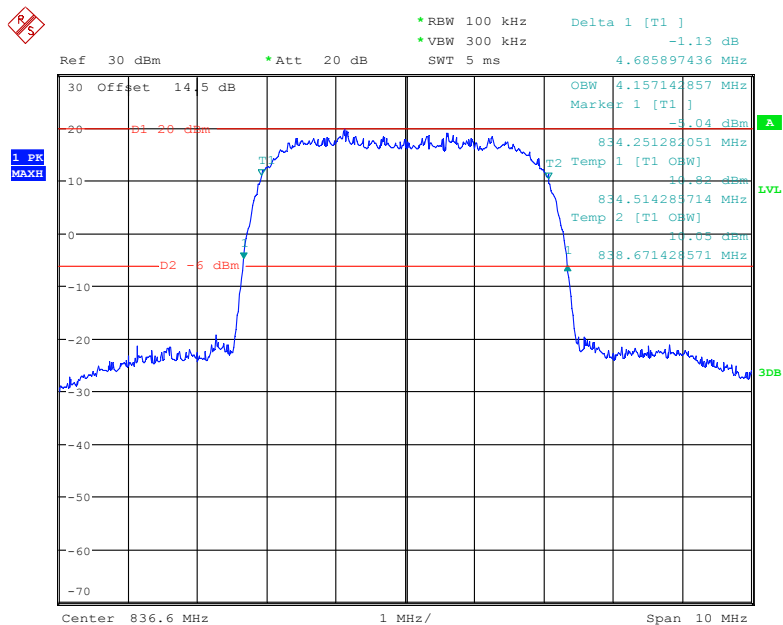

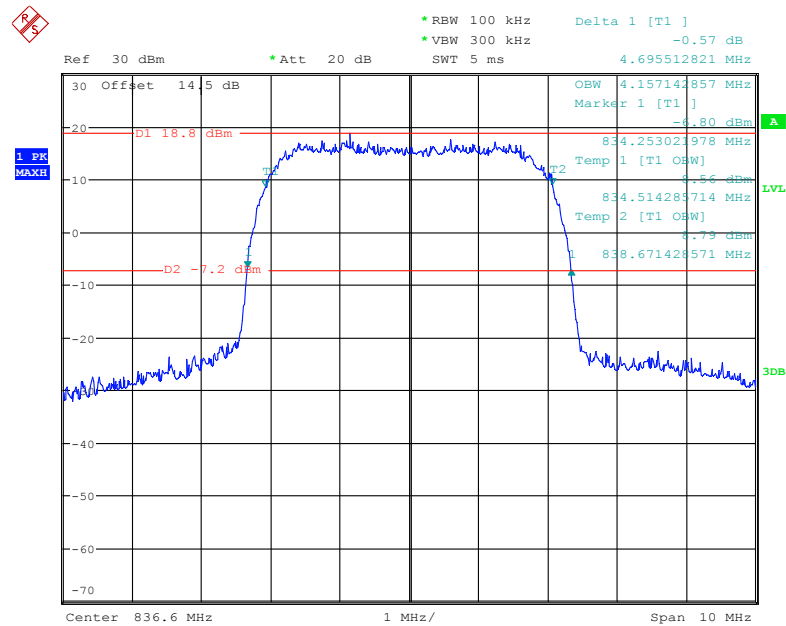

## 26 dB Emissions &amp; 99% Occupied Bandwidth for RMC (BPSK) Mode



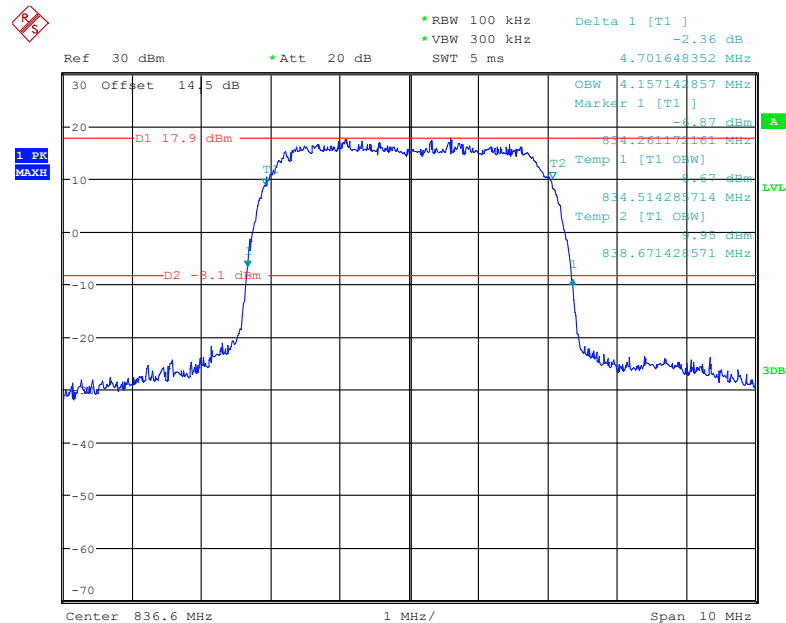

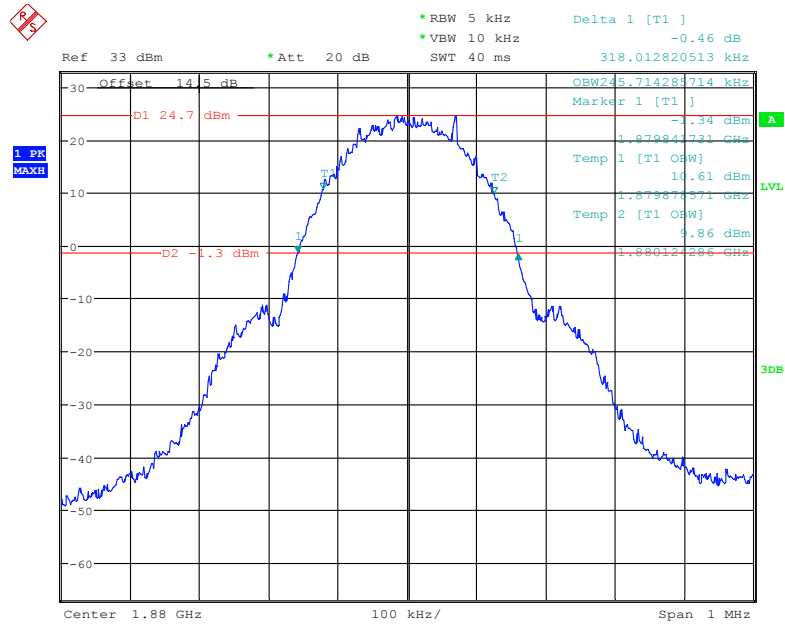
## 26 dB Emissions & 99% Occupied Bandwidth for HSDPA (16QAM) Mode

### Cellular Band, Right Band Edge for GSM (GMSK) Mode



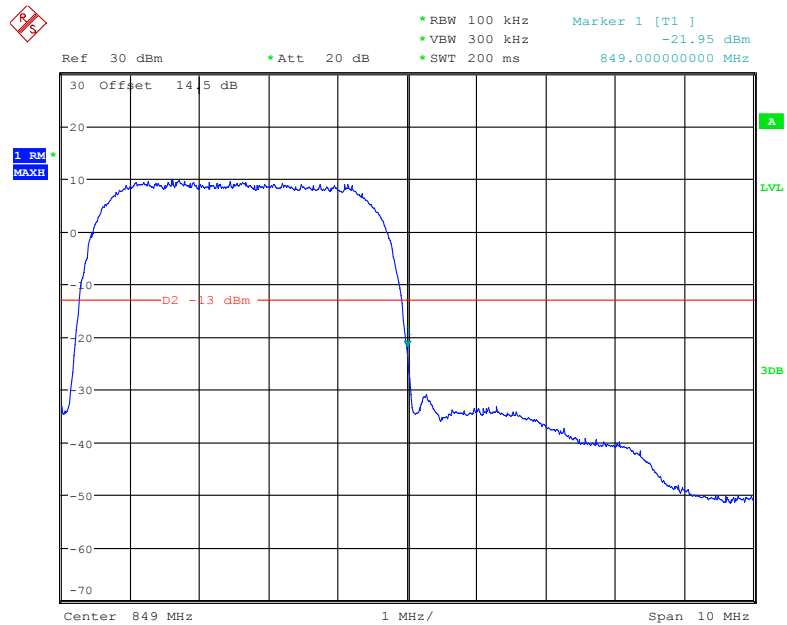
