The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

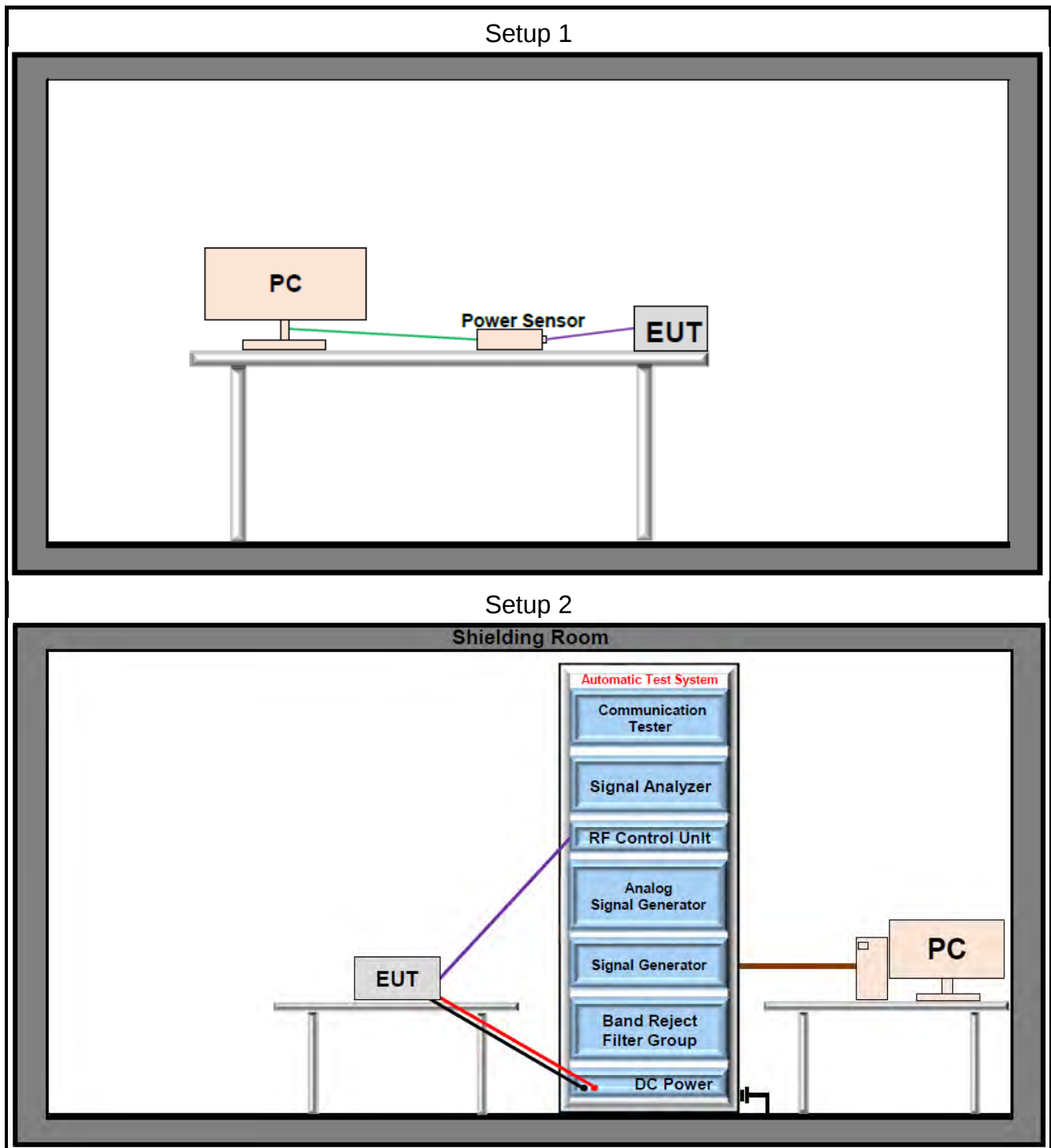

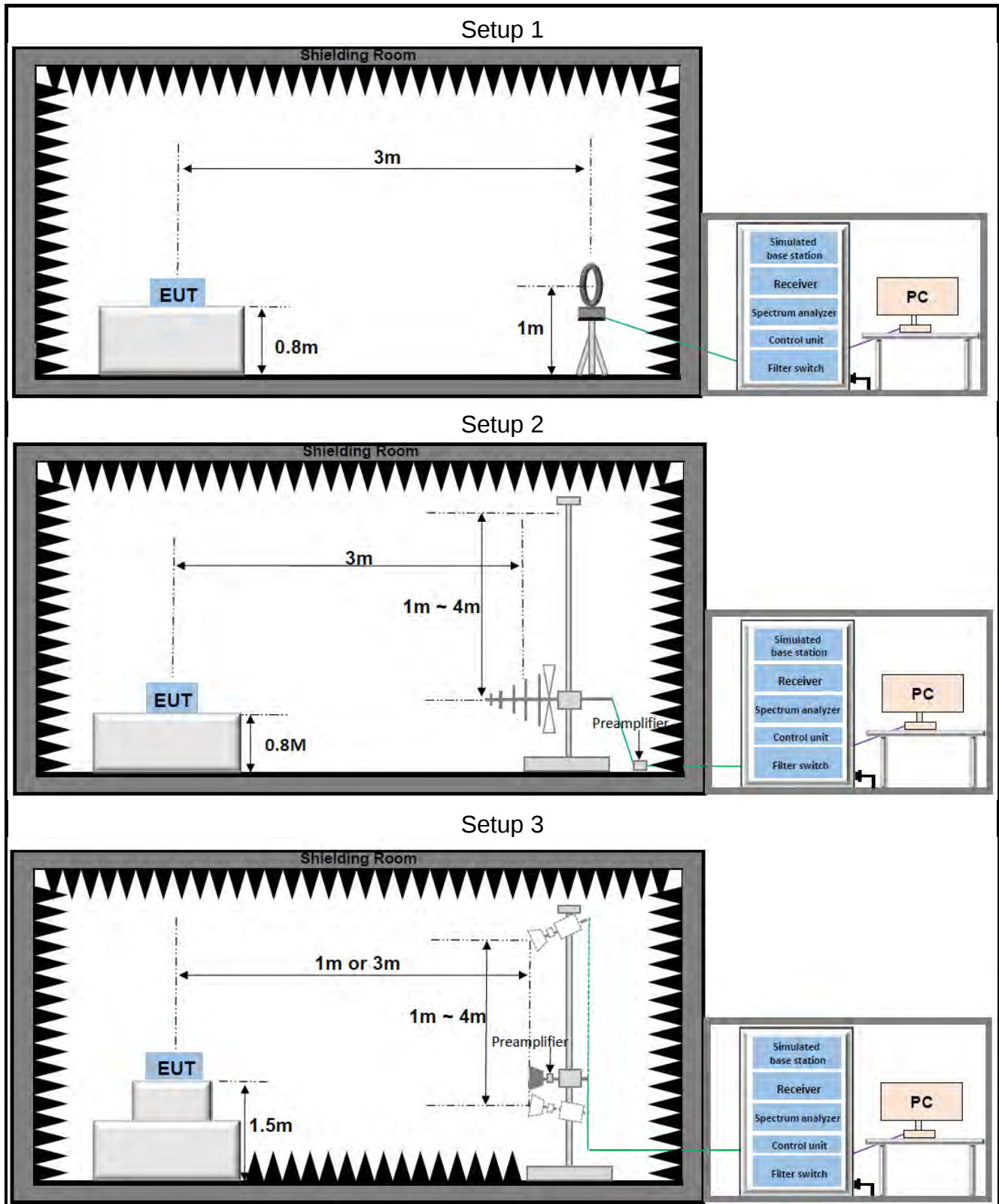

4 Test Results

4.1 Antenna Requirement

Standard Applicable:	47 CFR Part 15C Section 15.203 /247(b)
15.203 requirement: An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. 15.247(b) (4) requirement: The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.	
The antenna gain and type as provided by the manufacturer are as follows: The antenna Type is On-board PCB Antenna. With Antenna gain is 1.69dBi. Antenna Anti-Replacement Construction: An embedded-in antenna design is used.

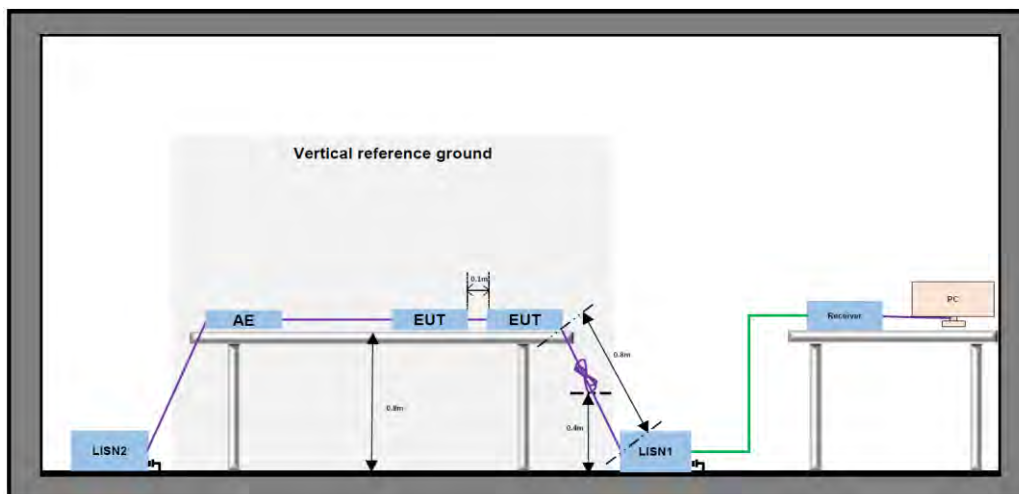
Test Procedure

ANSI C63.10-2020+Cor. 1-2023+C63.10a-2024 + Errata to C63.10a-2024, Section 6.2.

Test Settings

1. The EUT was connected to AC power source through a LISN 1 (Line Impedance Stabilization Network) which provides a $50\Omega/50\mu\text{H} + 5\Omega$ linear impedance. The power cables of all other units of the EUT were connected to a second LISN 2, which was bonded to the ground reference plane in the same way as the LISN 1 for the unit being measured. A multiple socket outlet strip was used to connect multiple power cables to a single LISN provided the rating of the LISN was not exceeded.
2. The tabletop EUT was placed upon a non-metallic table 0.8m above the ground reference plane. And for floor-standing arrangement, the EUT was placed on the horizontal ground reference plane.
3. The test was performed with a vertical ground reference plane. The rear of the EUT shall be 0.4 m from the vertical ground reference plane. The vertical ground reference plane was bonded to the horizontal ground reference plane. The LISN 1 was placed 0.8 m from the boundary of the unit under test and bonded to a ground reference plane for LISNs mounted on top of the ground reference plane. This distance was between the closest points of the LISN 1 and the EUT. All other units of the EUT and associated equipment was at least 0.8 m from the LISN 2.
4. The receiver is set to a resolution bandwidth of 9kHz. Peak detection is used netless otherwise noted as quasi-peak or average.
5. AC Power Line Conducted Emissions, the channel with the highest output power was tested.
6. Both sides of AC line are checked for maximum conducted interference. In order to find the maximum emission, the relative positions of equipment and all of the interface cables must be changed according to ANSI C63.10 on conducted measurement.

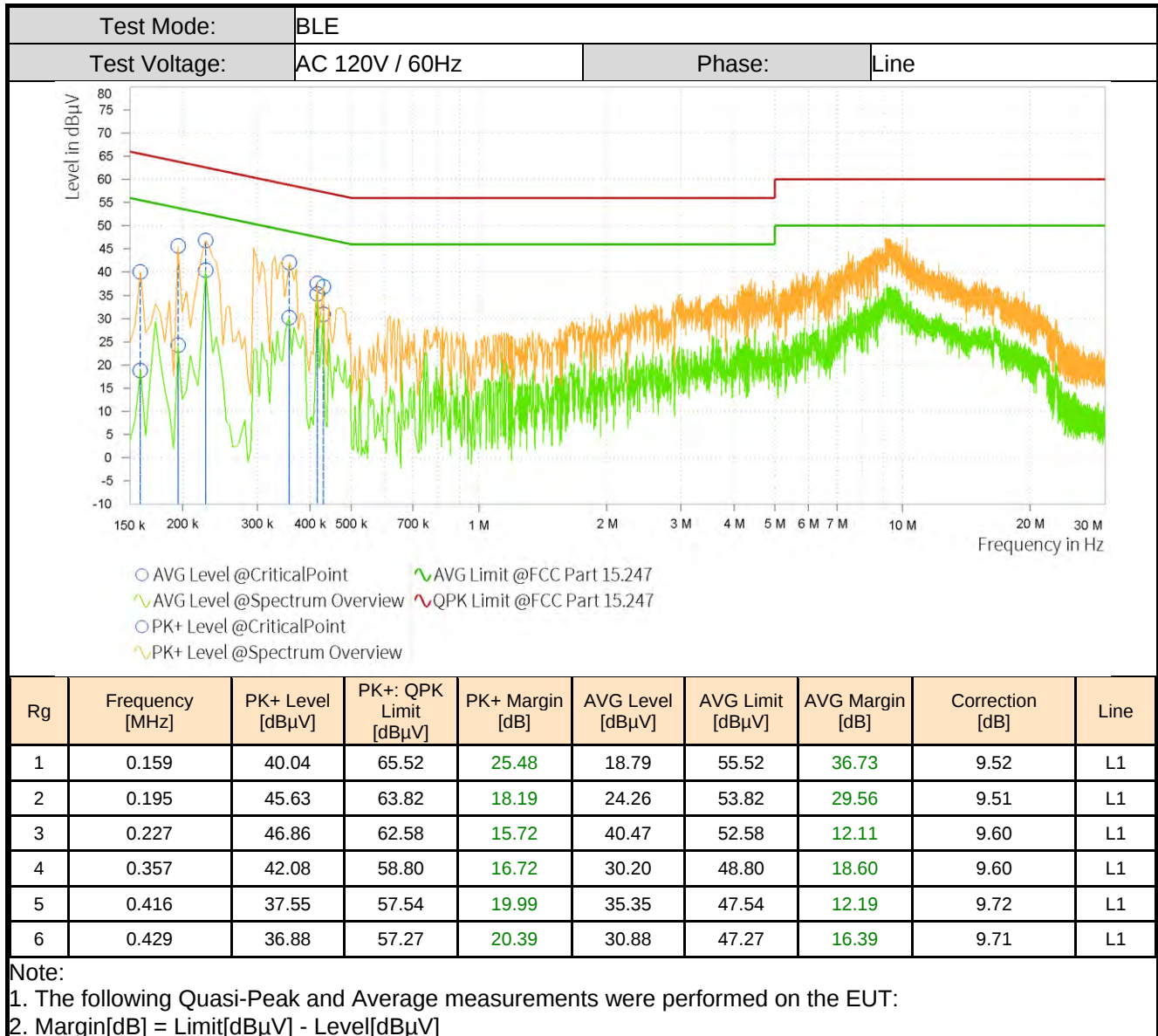

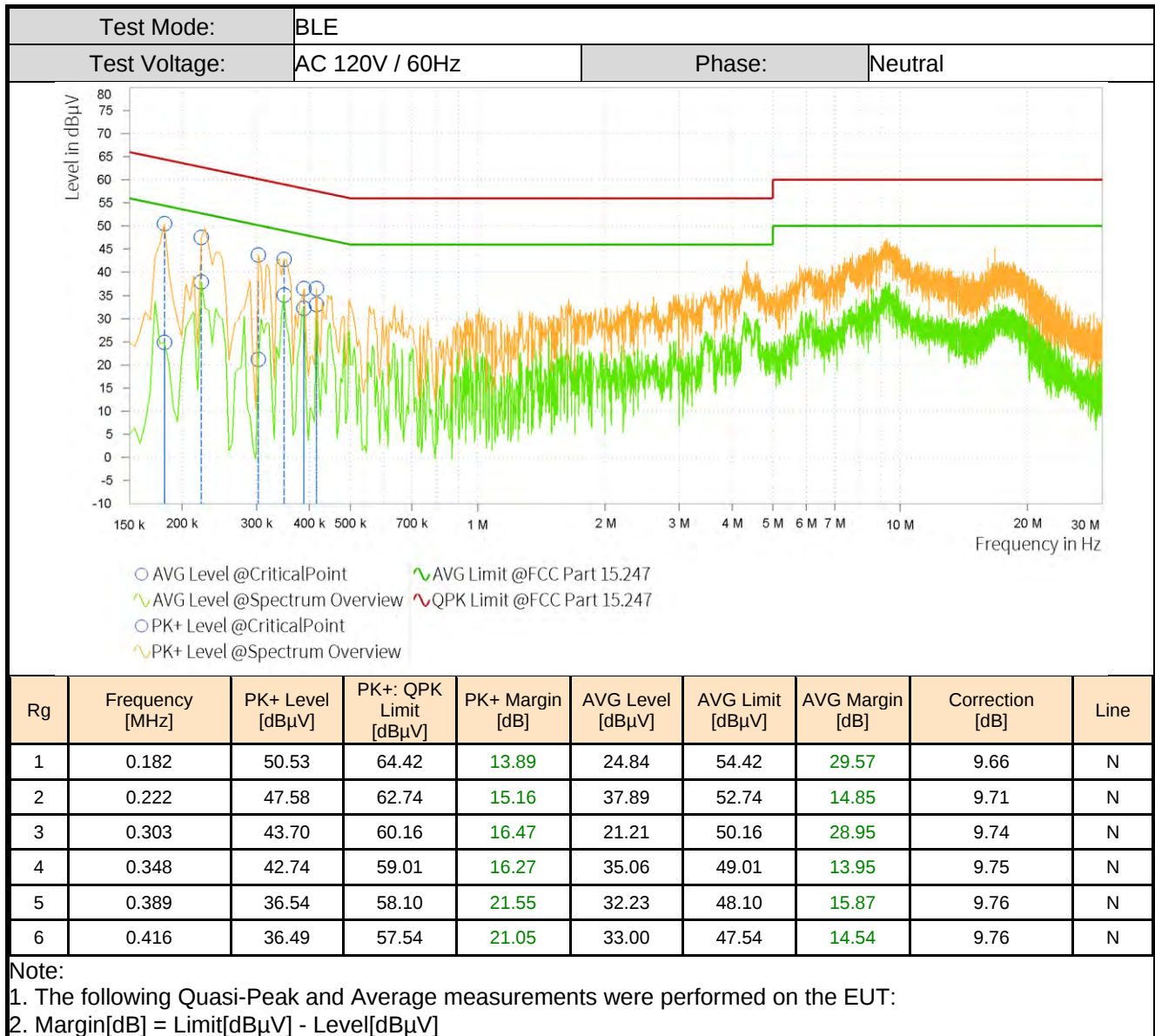

2. The power output was measured on the EUT antenna port using RF Cable with an attenuator connected to a power sensor. Output power was read directly from the power sensor.

Test Notes

DTS: The signal analyzers' automatic bandwidth measurement capability of the spectrum analyzer was used to perform the 6dB bandwidth measurement. The "X" dB bandwidth parameter was set to X= 6. The bandwidth measurement was not influenced by any intermediate power nulls in the fundamental emission.

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits.

If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph 15.247(b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.

If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph 15.247(b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.

The measurement antenna shall be varied from 1m to 4m in height above the reference ground in a search for the relative positioning that produces the maximum radiated signal level (i.e, field strength or received power), when orienting the measurement antenna in vertical polarization, the minimum height of the lowest element of the antenna shall clear the site reference ground plane by at least 25cm.
- For each suspected emission, the EUT was ranged its worst case and then tune the antenna tower(from 1~4m) and turntable(from 0~360°) find the maximum reading. Preamplifier and a high pass filter are used for the test in order get better signal level comply with the guidelines.
- Set to the maximum power setting and enable the EUT transmit continuously.
- The emission limits shown in the above table are based on measurements employing a CISPR quasi-peak detector except for the frequency bands 9-90 kHz, 110-490 kHz and above 1000 MHz. Radiated emission limits in these three bands are based on measurements employing an average detector.
- spectrum analyzer setting:

Measurements Below 1000MHz: RBW = 120 kHz; VBW $\geq$ 300 kHz; Detector = Peak

Measurements Above 1000MHz: RBW = 1 MHz; VBW $\geq$ 3 MHz; Detector = Peak

Average Measurements Above 1000MHz:

RBW = 1 MHz; VBW $\geq$ 3 MHz; Detector = RMS; Trace (RMS) averaging was performed over at least 100 traces.

8. The field strength is calculated by adding the Antenna Factor, Cable Factor. The basic equation with a sample calculation is as follows:

Level = Reading(dB μ V) + Factor(dB):

Factor = Cable Factor(dB) + AF(dB/m) - Preamplifier gain(dB)

AF = Antenna Factor(dB/m)

Margin = Limit(dB μ V/m) – Level(dB μ V/m)

9. Repeat above procedures until all frequencies measured was complete.
10. Measure and record the results in the test report.

Test Notes

1. Emissions below 18GHz were measured at a 3-meter test distance while emissions above 18GHz were measured at a 1-meter test distance with the application of a distance correction factor.
2. Radiated spurious emissions were investigated from 9kHz to 30MHz, 30MHz-1GHz and above 1GHz. the disturbance between 9kHz to 30MHz and 18GHz to 40GHz was very low. The amplitude of spurious emissions from the radiator which are attenuated more than 20dB below the limit need not be recorded, so only the harmonics had been displayed.
3. These frequencies which near "-" should be ignored because they are Fundamental frequency.

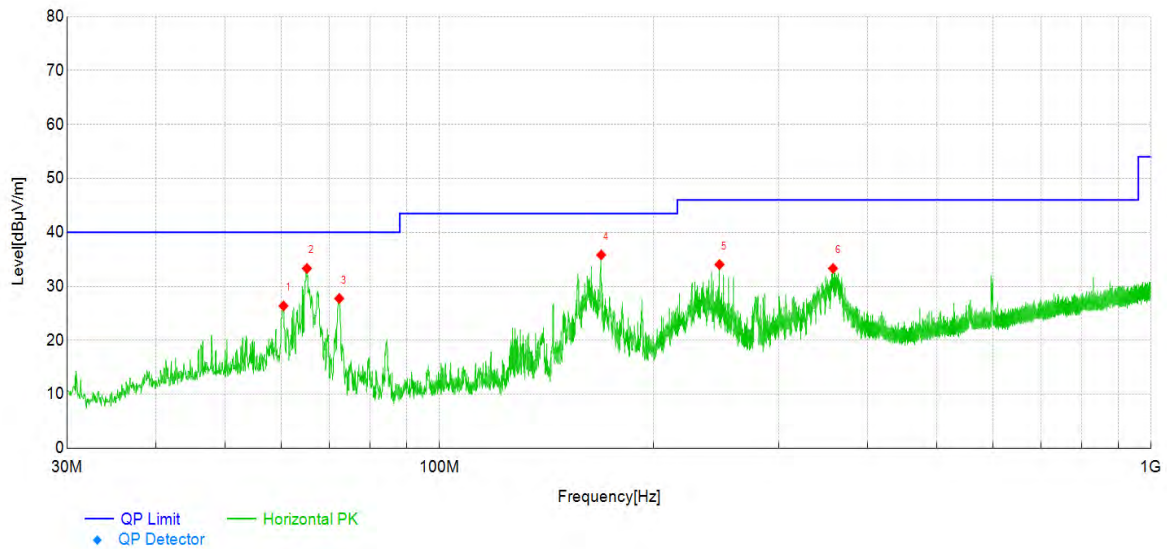


Radiated Spurious Emissions
