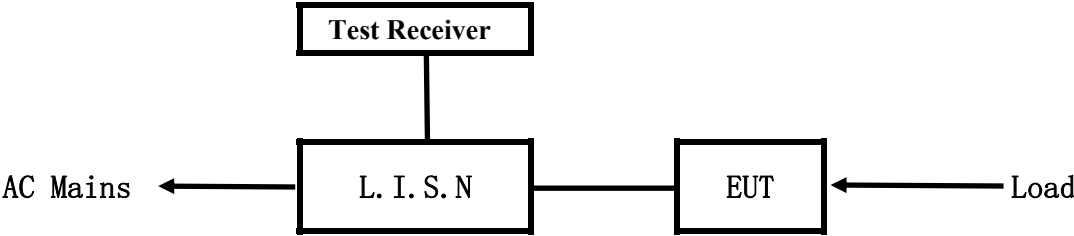

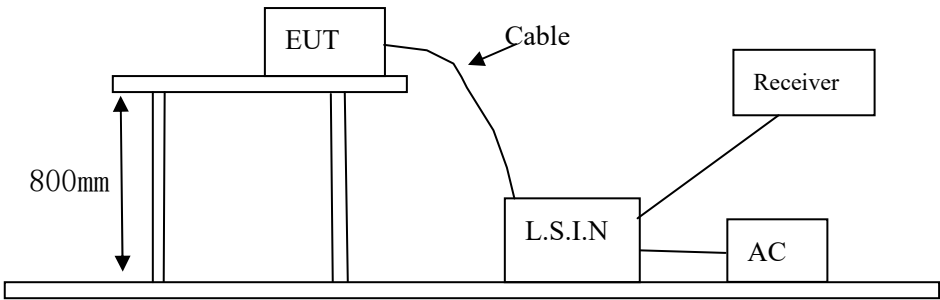

A: Conducted Emission on Live Terminal (150kHz to 30MHz)

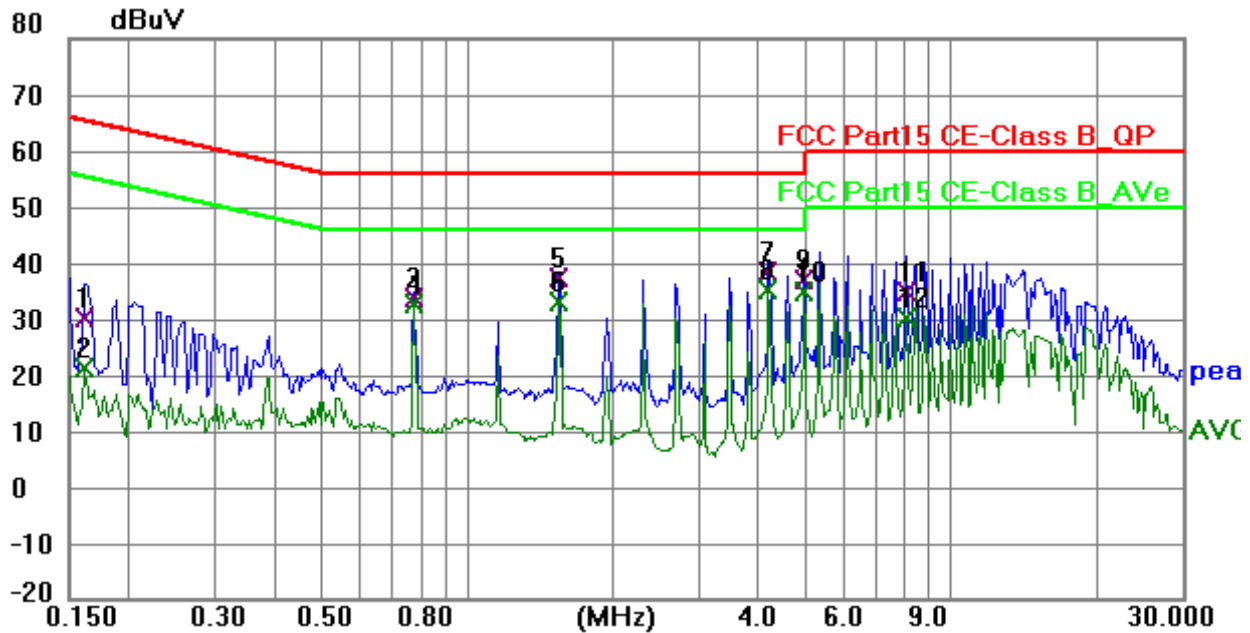

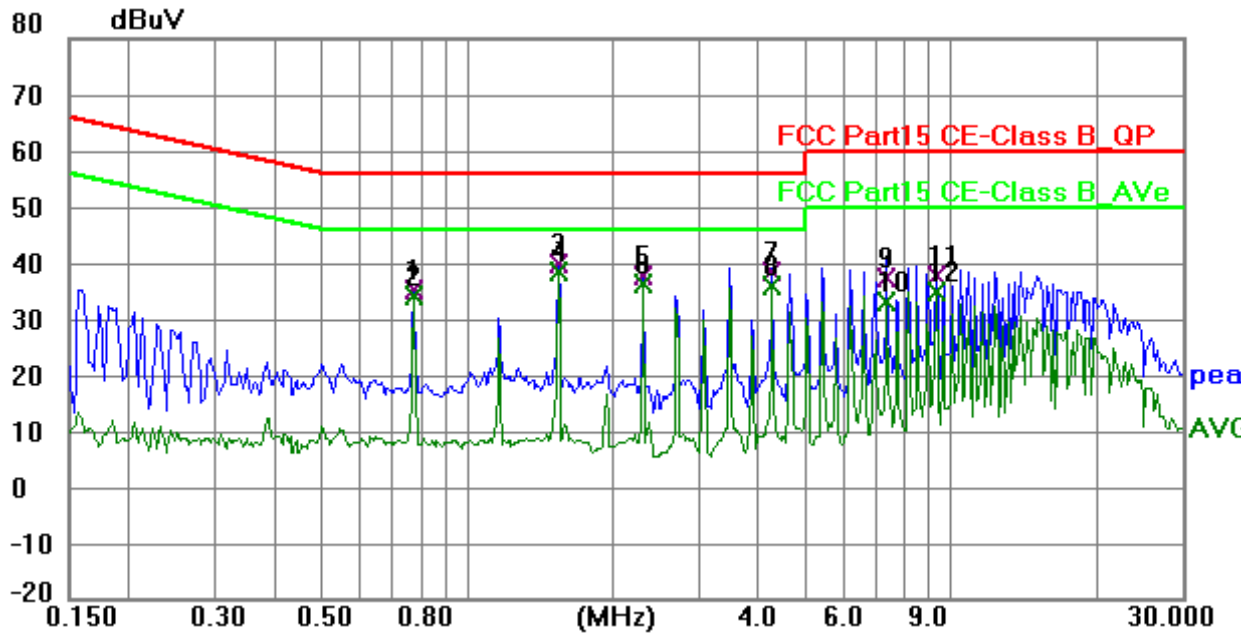

6 Radiated Emission Test

6.1 Test Method and test Procedure:

- (1) The EUT was tested according to ANSI C63.10-2020+Cor 1-2023+C63.10a-2024 + Errata to C63.10a-2024. The radiated test was performed at Timeway EMC Laboratory. This site is on file with the FCC laboratory division, Registration No. 744189
- (2) The EUT, peripherals were put on the turntable which table size is 1m x 1.5 m, table high 0.8 m. All set up is according to ANSI C63.10-2020+Cor 1-2023+C63.10a-2024 + Errata to C63.10a-2024.
- (3) The frequency spectrum from 9kHz to 25 GHz was investigated. The frequency spectrum is set as follows:

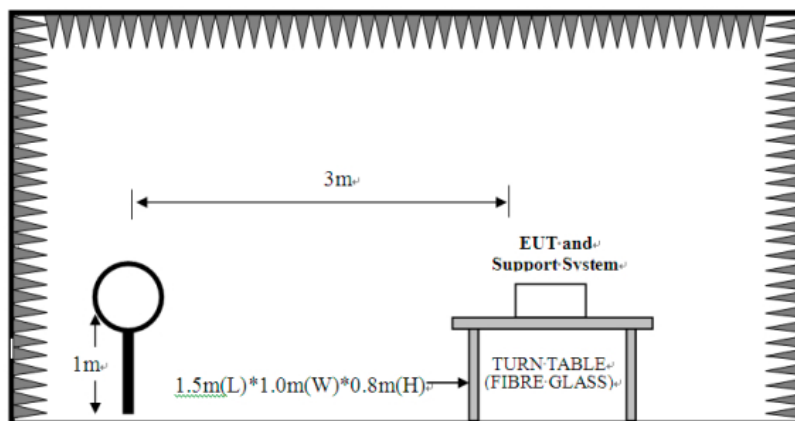

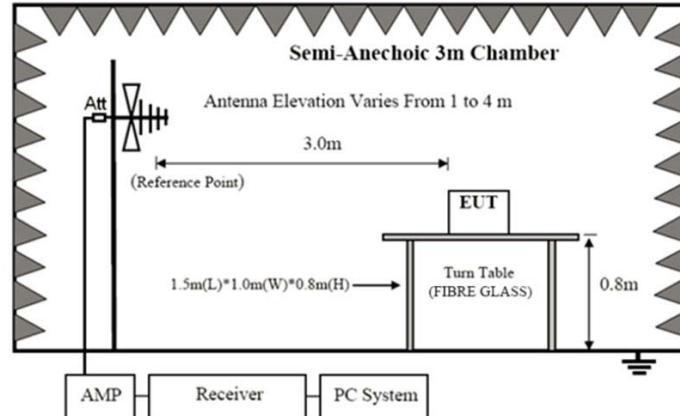

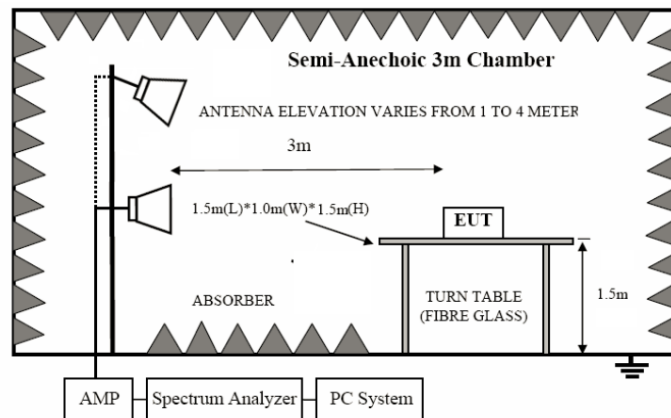
