4.2 Channel List

The EUT has been tested under its typical operating condition. Pre-defined engineering program for regulatory testing used to control the EUT for staying in continuous transmitting. Only the worst case data were reported.

The EUT has been associated with peripherals pursuant to ANSI C63.10-2020+Cor.1-2023 and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: radiation (9 KHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower).

The details of test channels and bandwidth were for RF conductive measurement.

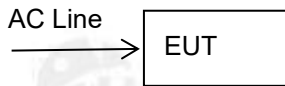

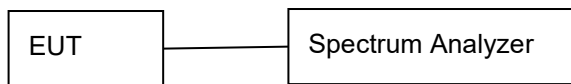
Radiated Emission

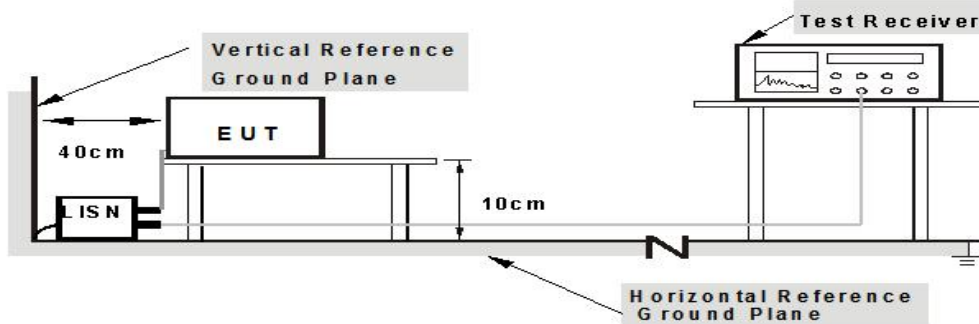

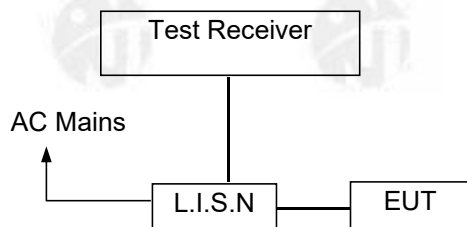

6.4 Measurement Procedure

1. The EUT was placed 0.1 meters from the horizontal ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipments powered from additional LISN(s). The LISN provide 50 Ohm/ 50uH of coupling impedance for the measuring instrument.
2. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 to 40 cm long.
3. I/O cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.
4. LISN at least 80 cm from nearest part of EUT chassis.
5. For the actual test configuration, please refer to the related Item – EUT Test Photos.

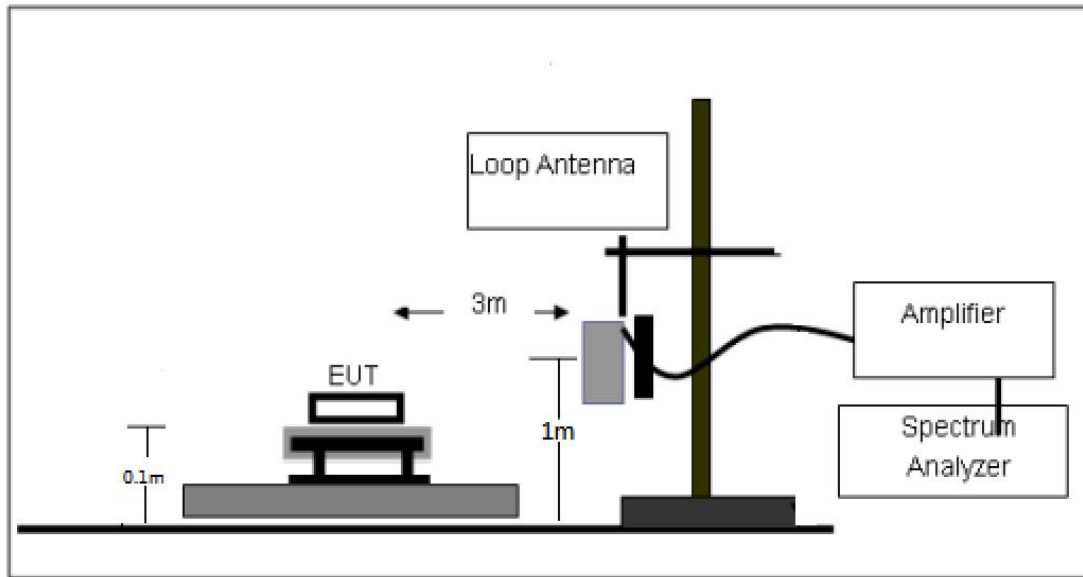

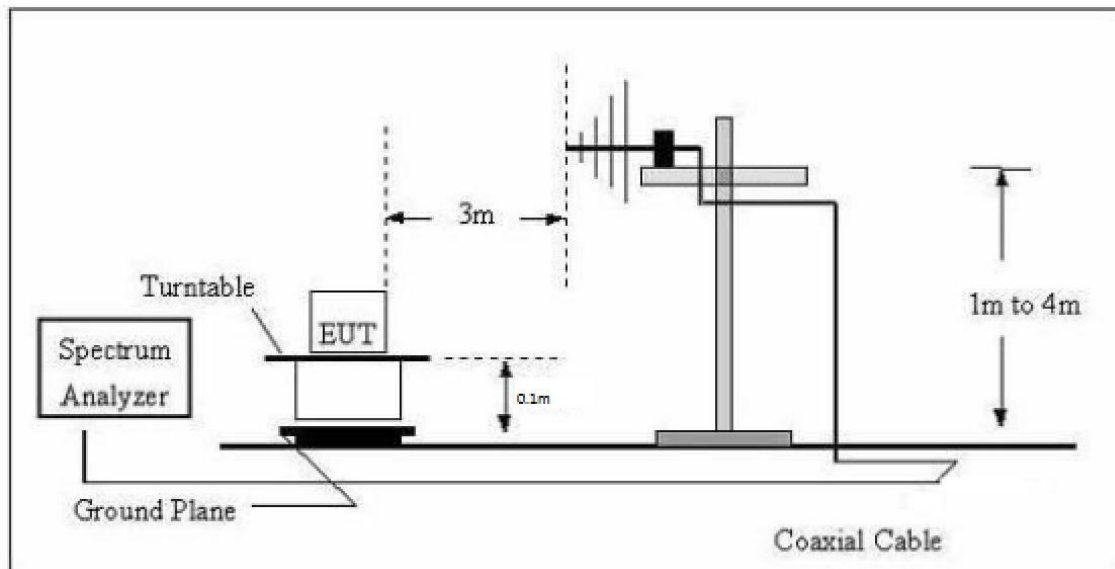

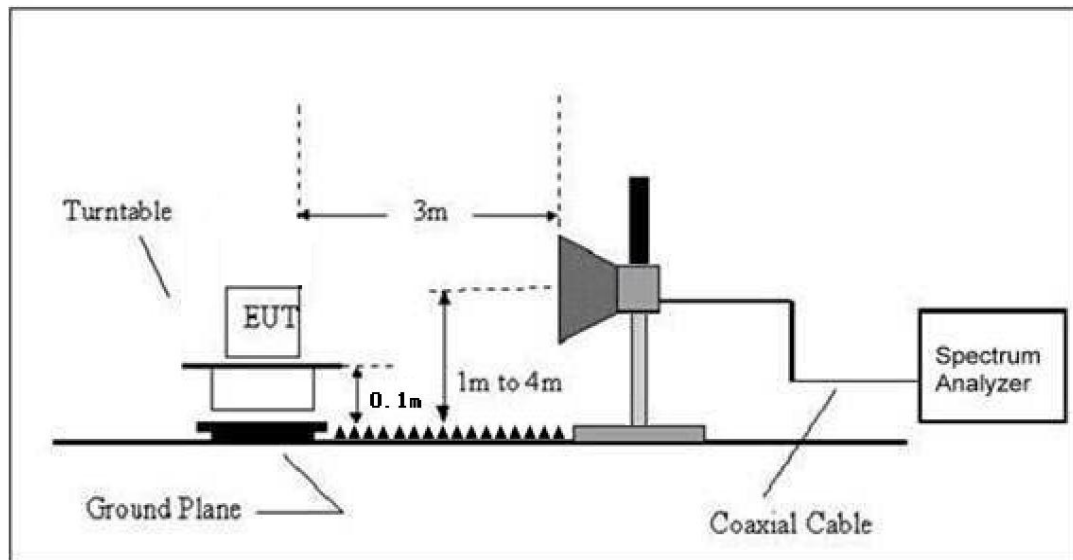
The test setup for emission measurement below 30MHz

7.4 Test Procedure

- The testing follows the guidelines in Spurious Radiated Emissions of ANSI C63.10-2020+Cor.1-2023.
- Below 1000MHz, The EUT was placed on a turn table which is 0.1m above ground plane. And above 1000MHz, The EUT was placed on a styrofoam table which is 0.1m above ground plane.
- The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower.
- For each suspected emission, the EUT was arranged to its worst case and then tune the Antenna tower (From 1m to 4m) and turntable (from 0 degree to 360 degree) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level to comply with the guidelines.
- Set to the maximum power setting and enable the EUT transmit continuously.
- Final measurement (Above 1GHz): The frequency range will be divided into different sub ranges depending of the frequency range of the used horn antenna. The EMI Receiver set to peak and average mode and a resolution bandwidth of 1MHz. The measurement will be performed in horizontal and vertical polarization of the measuring antenna and while rotating the EUT in its vertical axis in the range of 0 degree to 360 degree in order to have the antenna inside the cone of radiation.
- Test Procedure of measurement (For Above 1GHz):
 - Monitor the frequency range at horizontal polarization and move the antenna over all sides of the EUT(if necessary move the EUT to another orthogonal axis).
 - Change the antenna polarization and repeat 1) with vertical polarization.
 - Make a hardcopy of the spectrum.
 - Measure the frequency of the detected emissions with a lower span and resolution bandwidth to increase the accuracy and note the frequency value.
 - Change the analyzer mode to Clear/ Write and found the cone of emission.
 - Rotate and move the EUT, so that the measuring distance can be enlarged to 3m and the antenna will be still inside the cone of emission.
 - Measure the level of the detected frequency with the correct resolution bandwidth, with the antenna polarization and azimuth and the peak and average detector, which causes the maximum emission.
 - Repeat steps 1) to 7) for the next antenna spot if the EUT is larger than the antenna beamwidth.
- The radiation measurements are tested under 3-axes(X,Y,Z) position(X denotes lying on the table, Y denotes side stand and Z denotes vertical stand), After pre-test, It was found that the worse radiation emission was get at the X position. So the data shown was the X position only.

For Average Measurement:



VBW=10Hz, when duty cycle is no less than 98 percent.

VBW $\geq$ 1/T, when duty cycle is less than 98 percent where T is the minimum transmission duration over which the transmitter is on and is transmitting at its maximum power control level for the tested mode of operation.

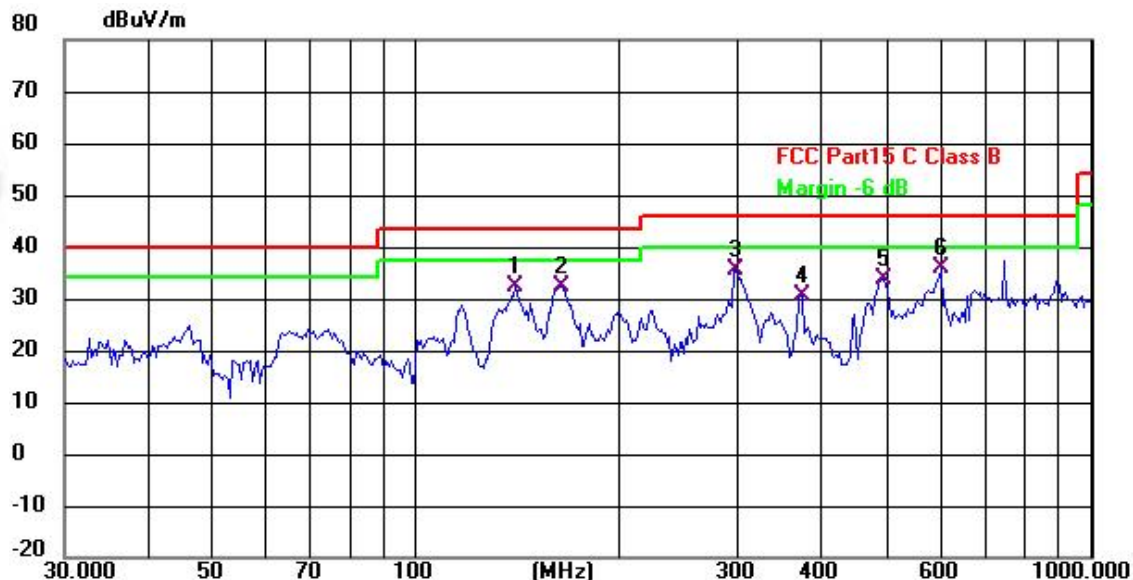

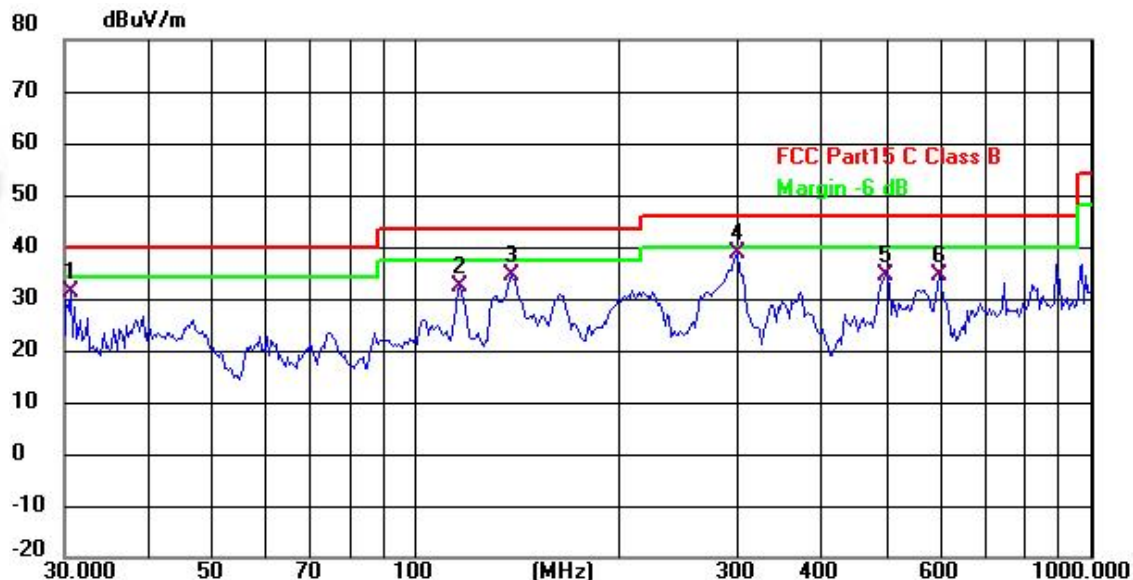

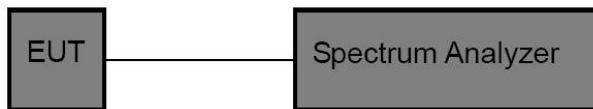

8 Conduct Band Edge And Spurious Emissions Measurement

Test Requirement	: Section 15.247(d) In addition, radiated emissions which fall in the restricted bands. as defined in Section 15.205(a), must also comply with the radiated emission limits specified in Section 15.209(a) (see Section 15.205(c)).
Test Method	: ANSI C63.10-2020+Cor.1-2023
Test Limit	: Regulation 15.247 (d),In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the Radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

8.2 Test Procedure

For Spurious Emissions:

1. Remove the antenna from the EUT and then connect a low RF cable from the antenna port to the spectrum;
2. Set the spectrum analyzer:
 - a) Set instrument center frequency to DTS channel center frequency.
 - b) Set the span to _ 1.5 times the DTS bandwidth.
 - c) Set the RBW = 100 kHz.
 - d) Set the VBW _ [3 × RBW].
 - e) Detector = peak.
 - f) Sweep time = auto couple.
 - g) Trace mode = max hold.
 - h) Allow trace to fully stabilize.
 - i) Use the peak marker function to determine the maximum PSD level.

Note that the channel found to contain the maximum PSD level can be used to establish the reference level.



For Band Edge:

1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
2. Position the EUT without connection to measurement instrument. Turn on the EUT and connect its antenna terminal to measurement instrument via a low loss cable. Then set it to any one measured frequency within its operating range, and make sure the instrument is operated in its linear range.
3. Set RBW to 100 kHz and VBW of spectrum analyzer to 300 kHz with a convenient frequency span including 100 kHz bandwidth from band edge.
4. Measure the highest amplitude appearing on spectral display and set it as a reference level. Plot the graph with marking the highest point and edge frequency.
5. Repeat above procedures until all measured frequencies were complete.

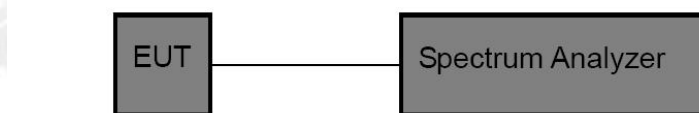

Test Limit : Systems using digital modulation techniques may operate in the 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz bands. The minimum 6 dB bandwidth shall be at least 500 kHz.

9.2 Test Procedure

For 6dB Bandwidth Measurement

1. Remove the antenna from the EUT and then connect a low RF cable from the antenna port to the spectrum;
2. The automatic bandwidth measurement capability of an instrument may be employed using the X dB bandwidth mode with X set to 6 dB, if the functionality described in 11.8.1 (i.e., $RBW = 100\text{ kHz}$, $VBW > 3 \times RBW$, and peak detector with maximum hold) is implemented by the instrumentation function. When using this capability, care shall be taken so that the bandwidth measurement is not influenced by any intermediate power nulls in the fundamental emission that might be $\geq 6\text{ dB}$.
3. The steps for the first option are as follows:
 - a. Set RBW shall be in the range of 1% to 5% of the OBW but not less than 100 kHz.
 - b. Set the $VBW[3 \times RBW]$.
 - c. Detector = peak
 - d. Trace mode = max-hold.
 - e. Sweep = No faster than coupled (auto) time.
 - f. Allow the trace to stabilize.
 - g. Measure the maximum width of the emission by placing two markers, one at the lowest frequency and the other at the highest frequency of the envelope of the spectral display, such that each marker is at or slightly below the "-6 dB down amplitude". If a marker is below this "-6 dB down amplitude?" value, then it shall be as close as possible to this value.

For 99% Bandwidth Measurement

1. Remove the antenna from the EUT and then connect a low RF cable from the antenna port to the spectrum;
2. Set the spectrum analyzer: $RBW = 1\%-5\% \text{ OBW}$, $VBW \geq 3RBW$

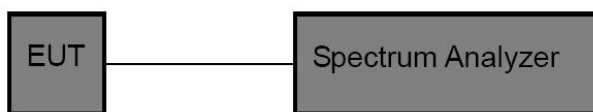

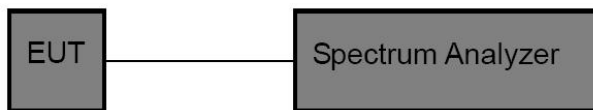

12 Antenna Application

12.1 Antenna Requirement

15.203 requirement:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

15.247(b)(4) requirement:

The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

The antenna is Internal Antenna, the Max gain of the antennas is 2.38 dBi, reference to the attachment for details.
