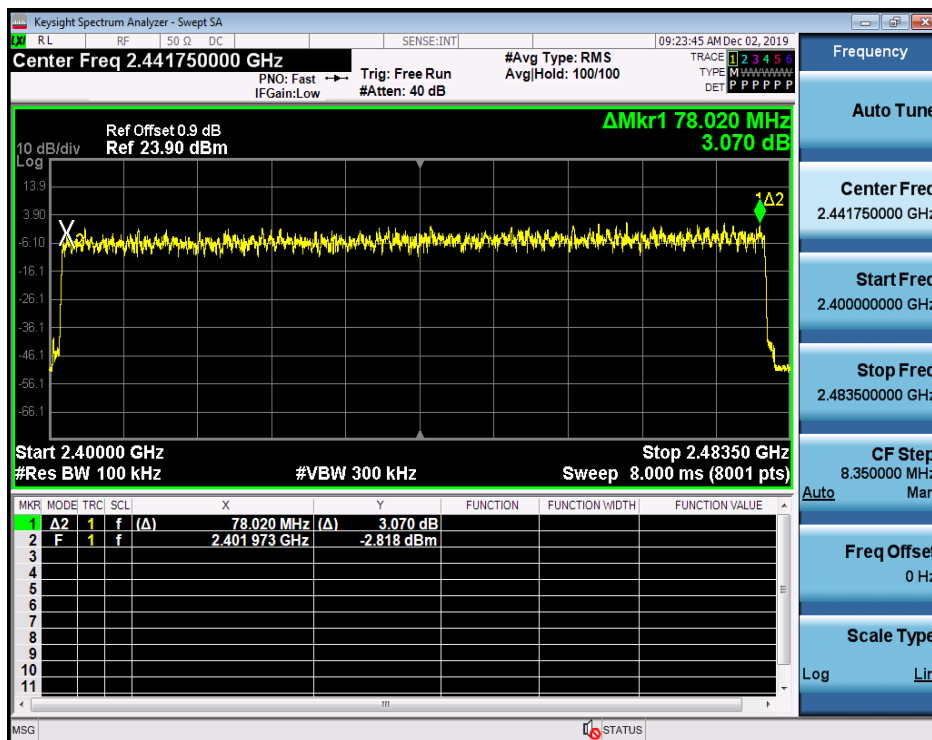

Conducted Peak Output Power_DH5_2402



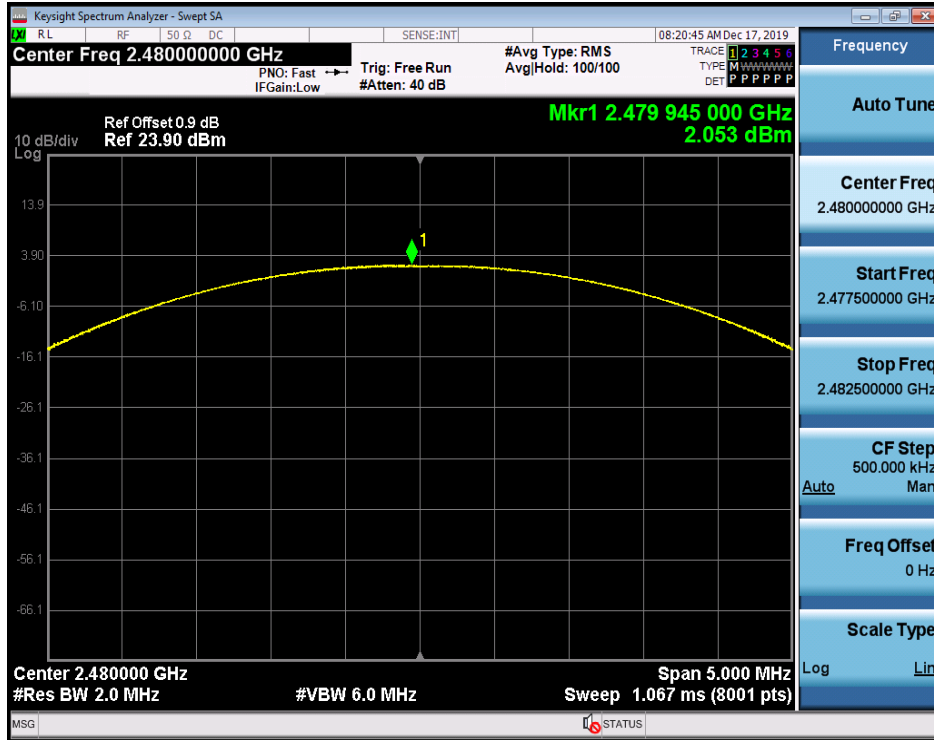

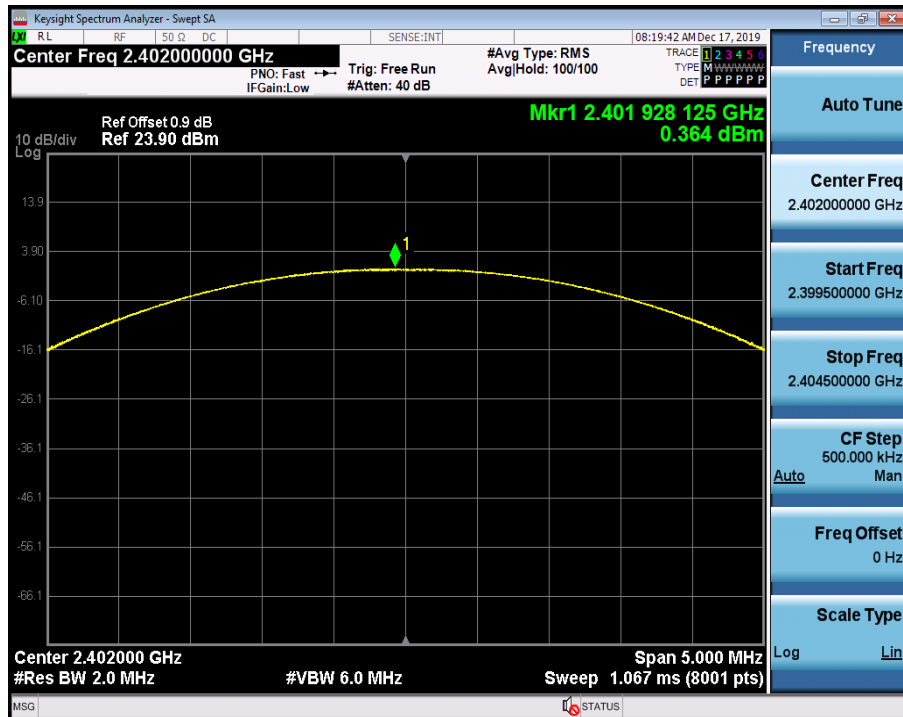

Conducted Peak Output Power_DH5_2480



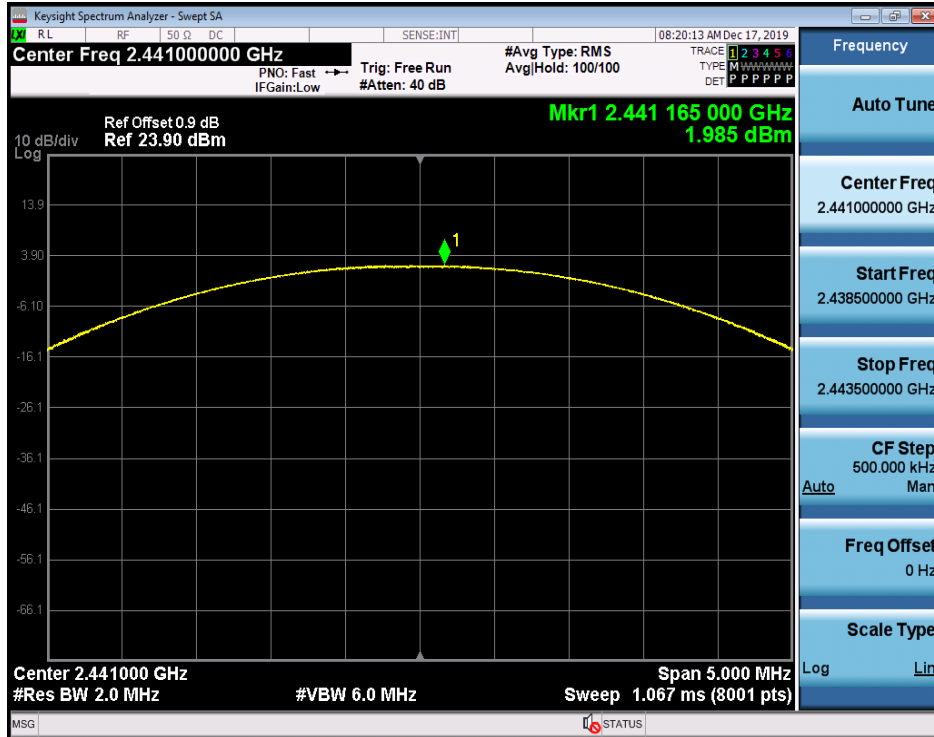
