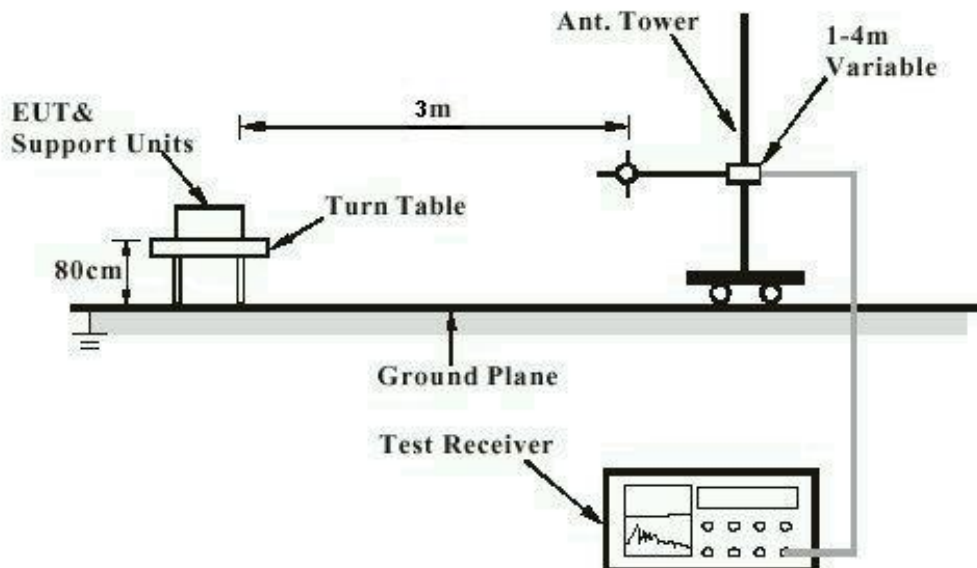

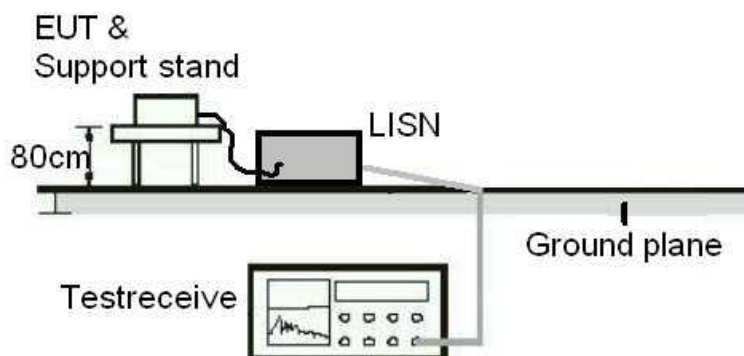

Diagram of Measurement Equipment Configuration for Conduction Measurement





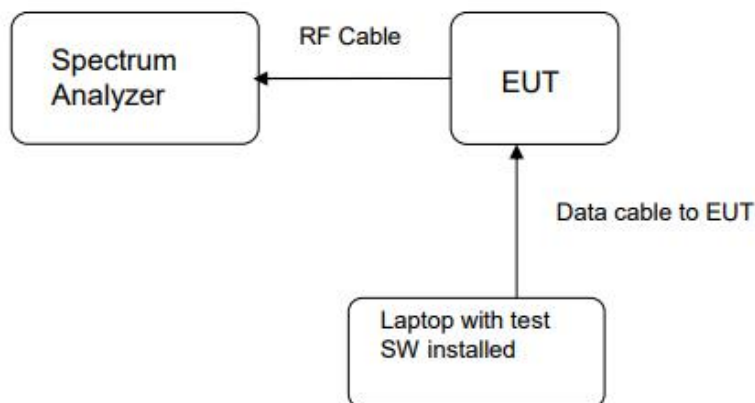

Figure 1: 6dB Bandwidth, 802.11b, 2412MHz

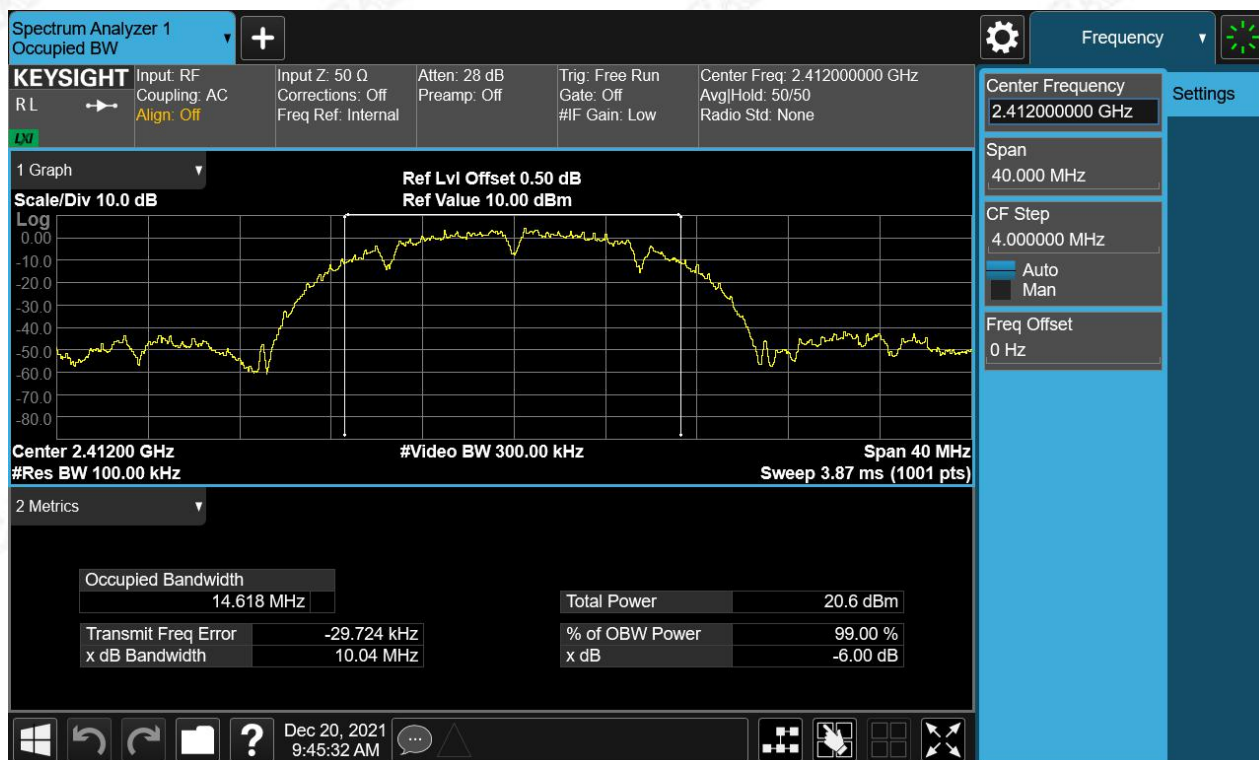


Figure 2: 6dB Bandwidth, 802.11b, 2437MHz

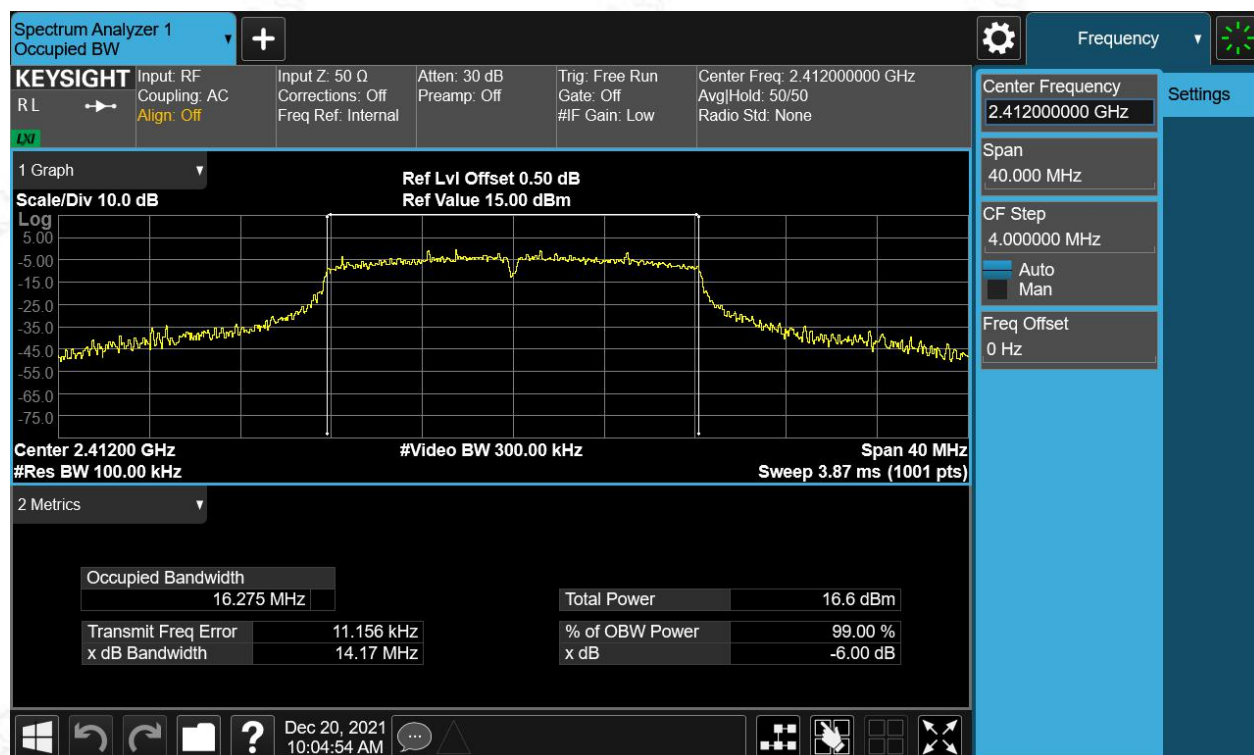

Figure 7: 6dB Bandwidth, 802.11n(HT20), 2412MHz

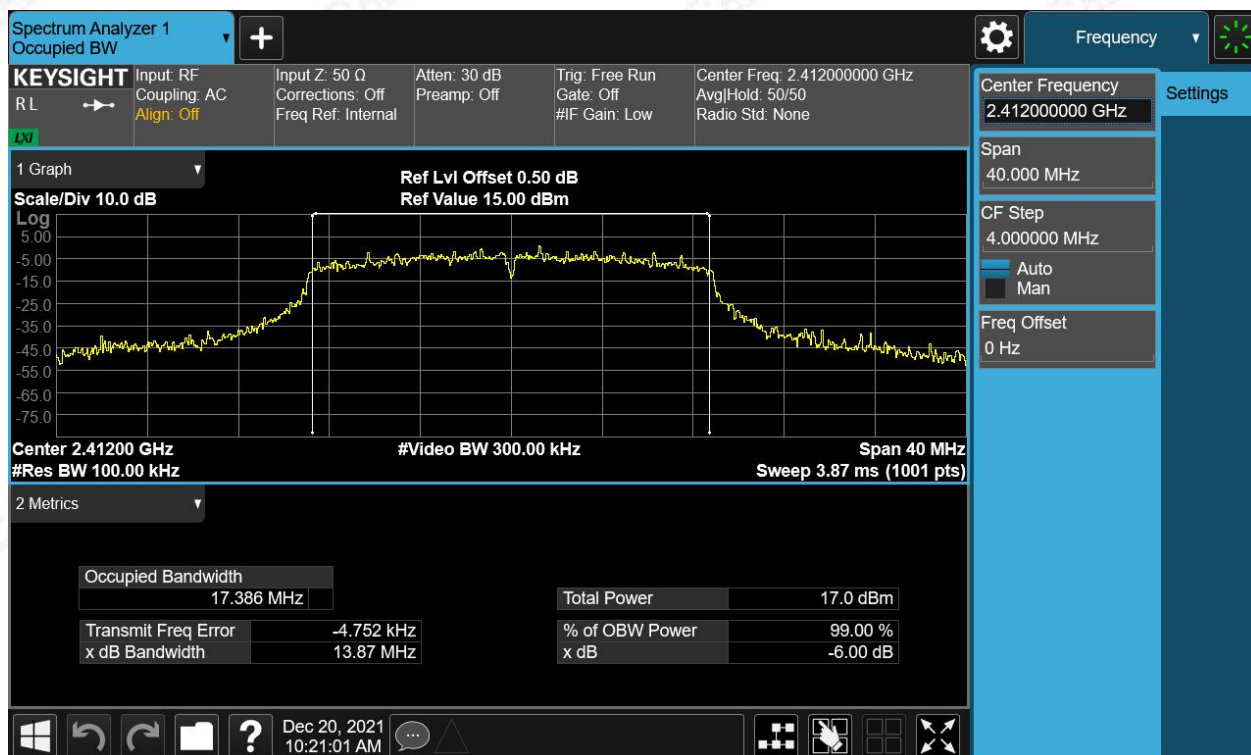


Figure 8: 6dB Bandwidth, 802.11n(HT20), 2437MHz

Figure 9: 6dB Bandwidth, 802.11n(HT20), 2462MHz

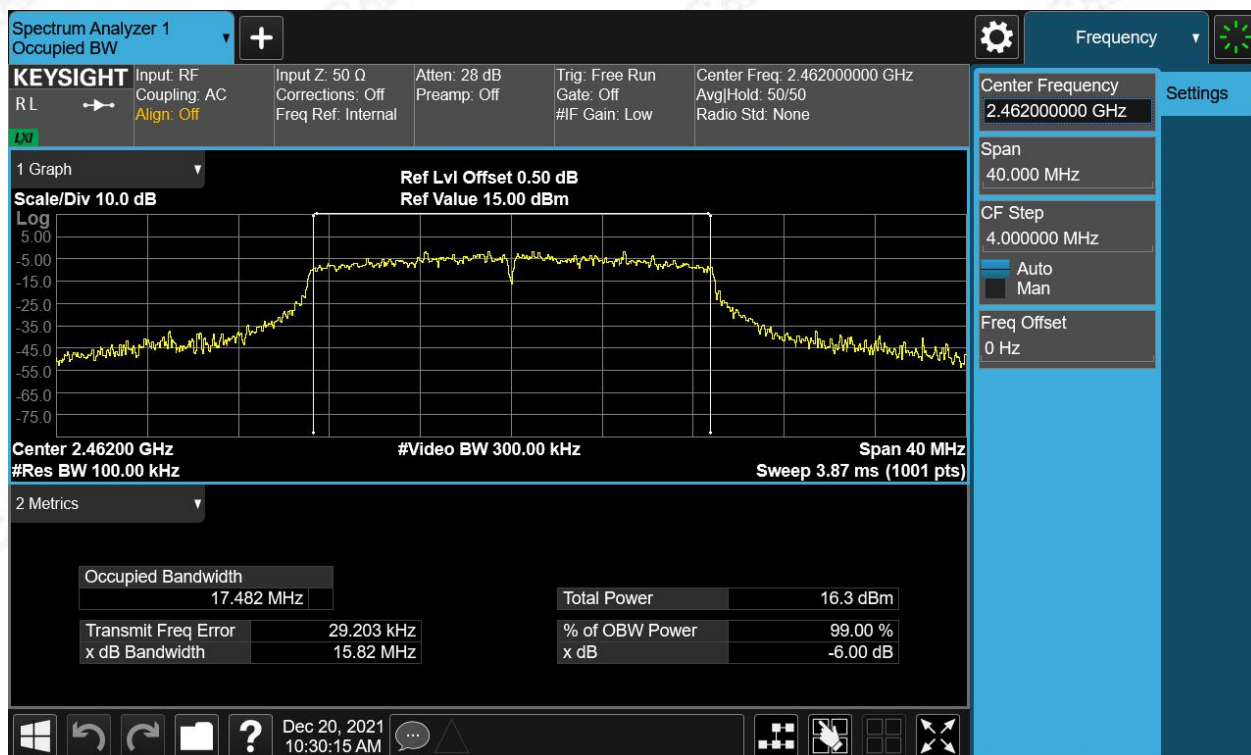
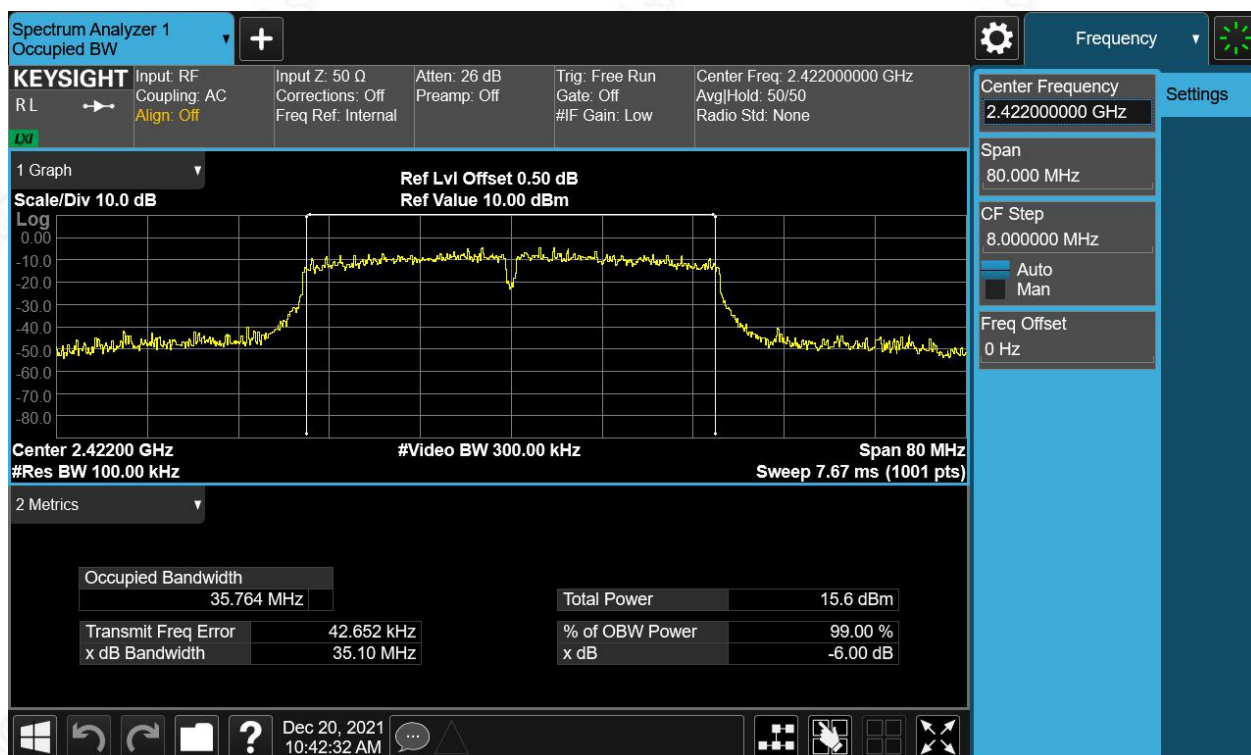


Figure 10: 6dB Bandwidth, 802.11n(HT40), 2422MHz

Figure 11: 6dB Bandwidth, 802.11n(HT40), 2437MHz

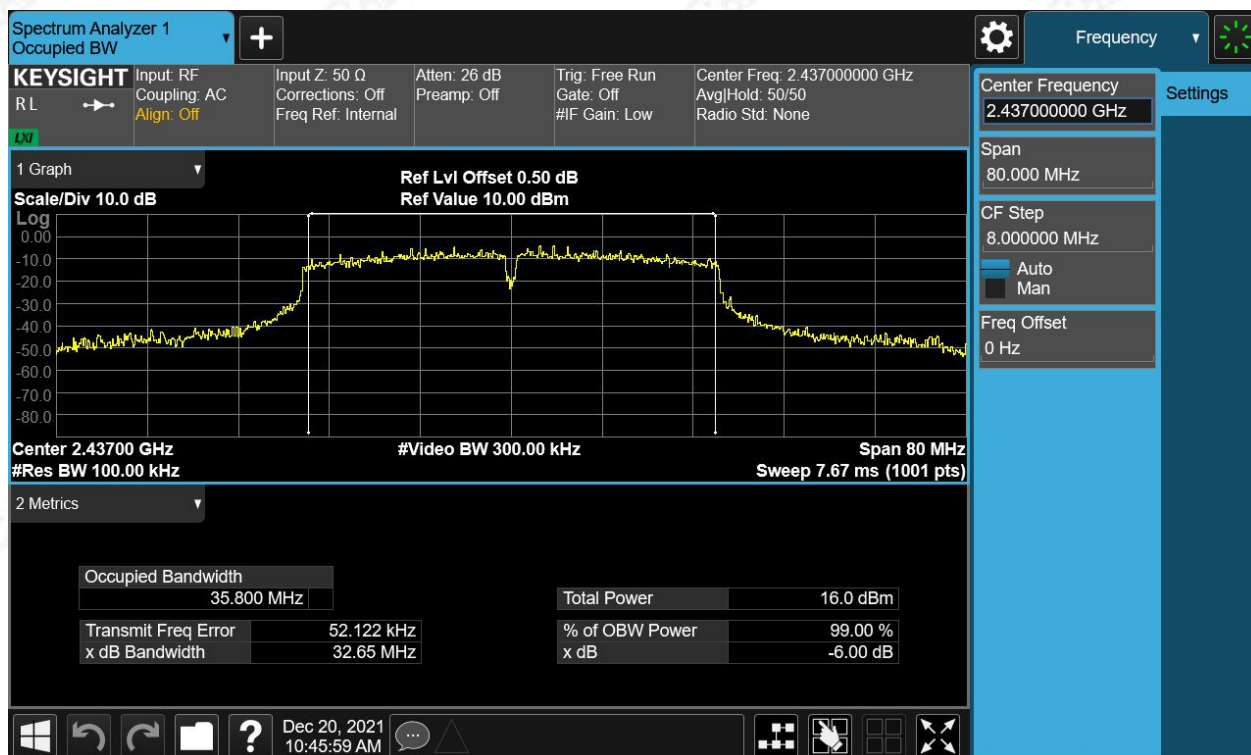
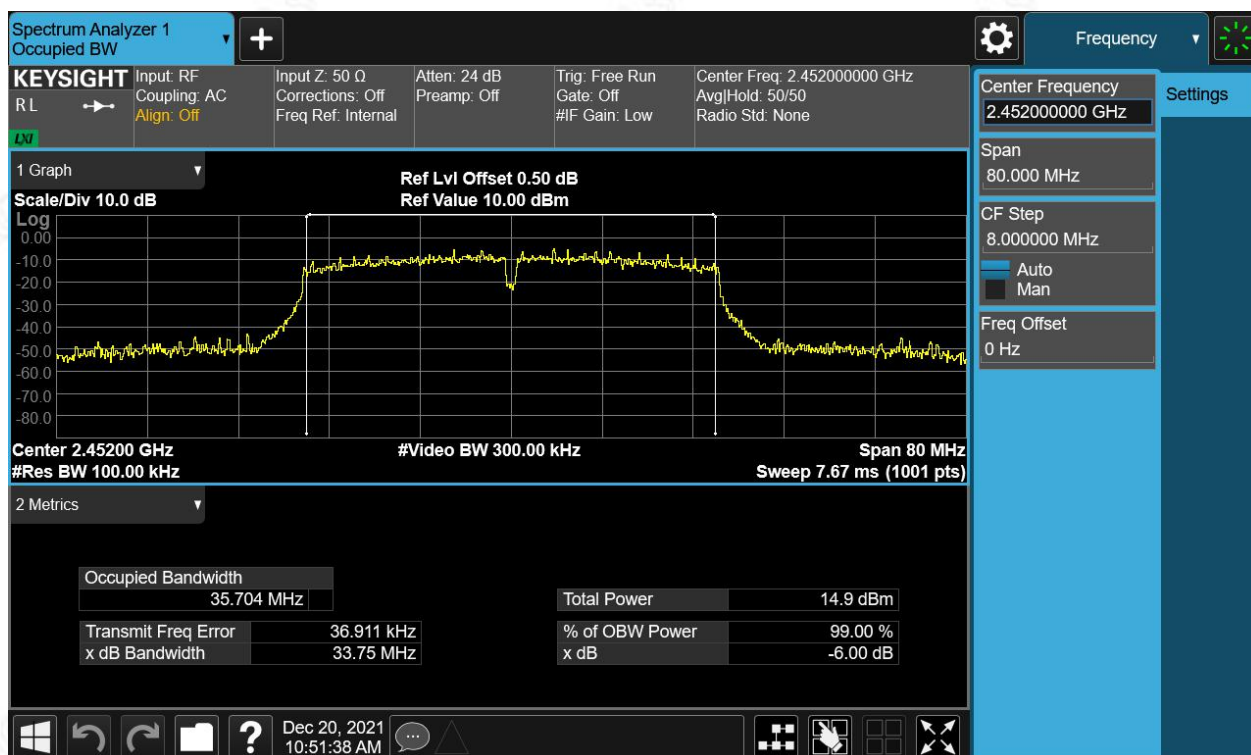


Figure 12: 6dB Bandwidth, 802.11n(HT40), 2452MHz

Figure 15: Power Spectral Density, 802.11b, 2462MHz

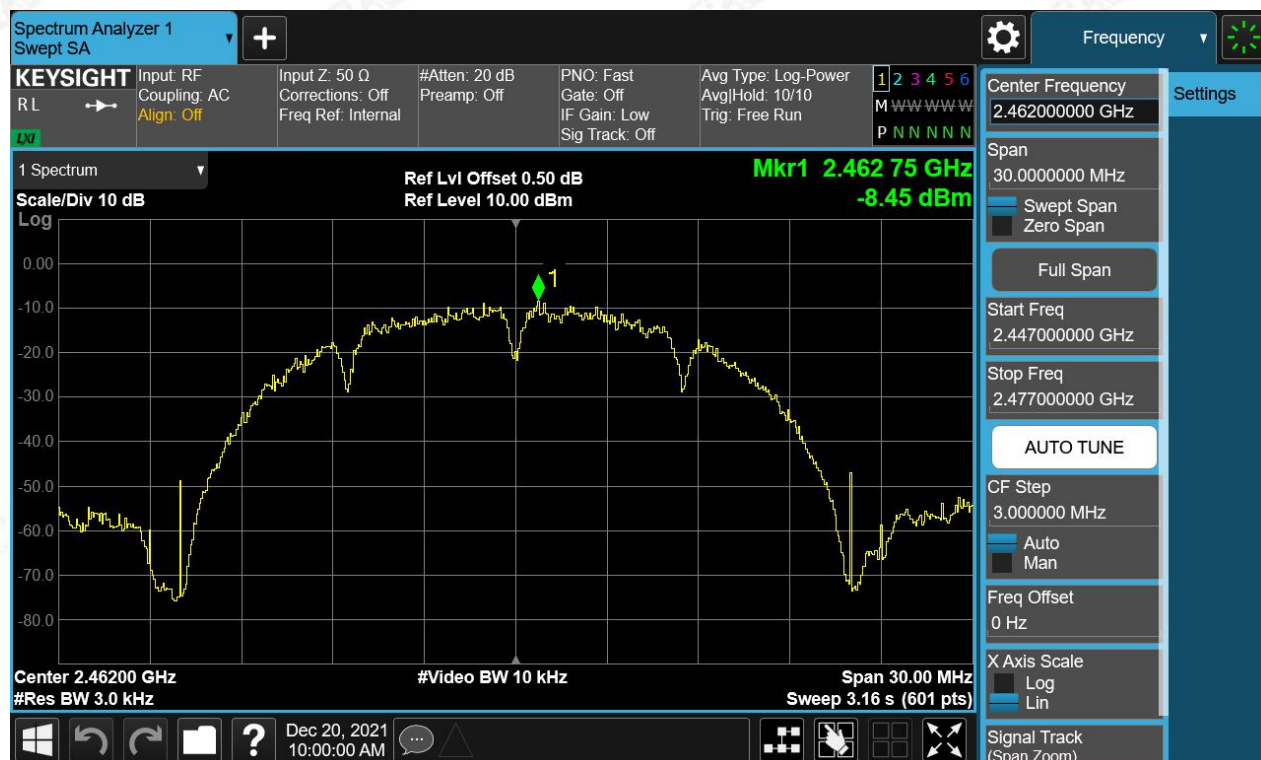
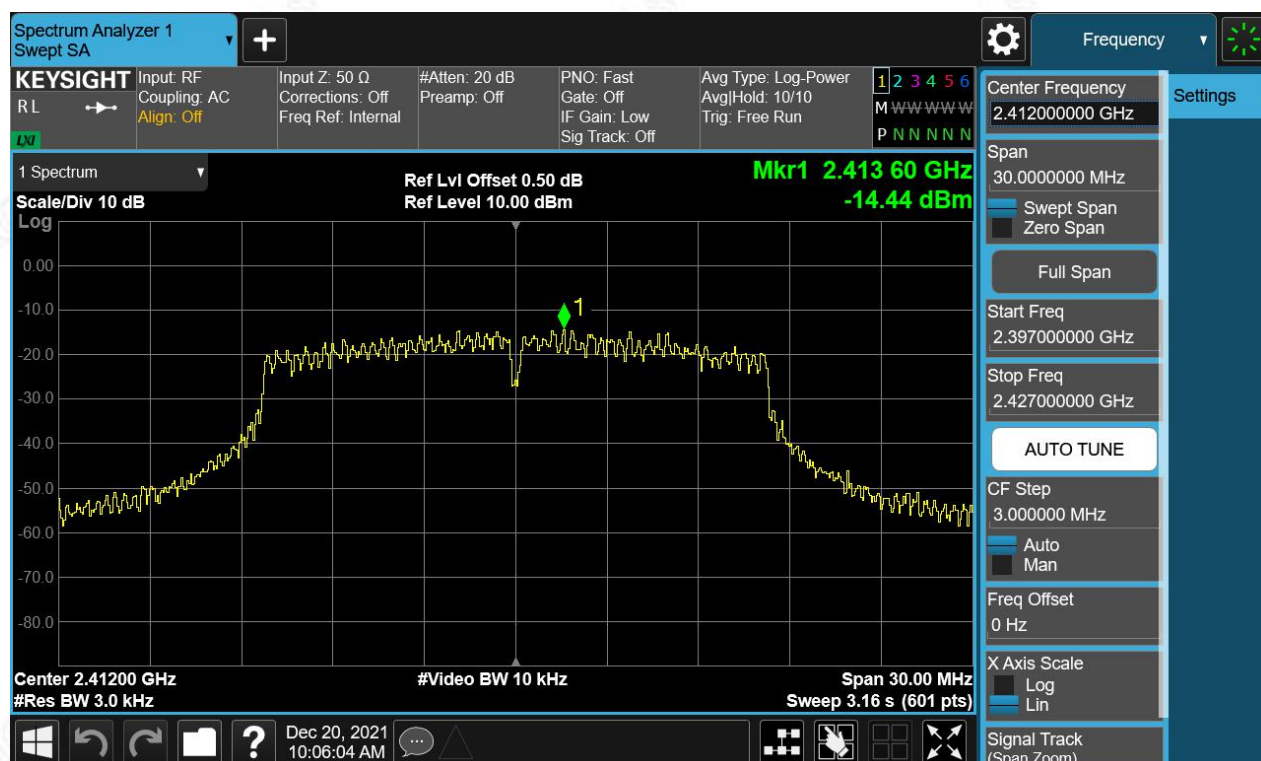


Figure 16: Power Spectral Density, 802.11g, 2412MHz

Figure 17: Power Spectral Density, 802.11g, 2437MHz

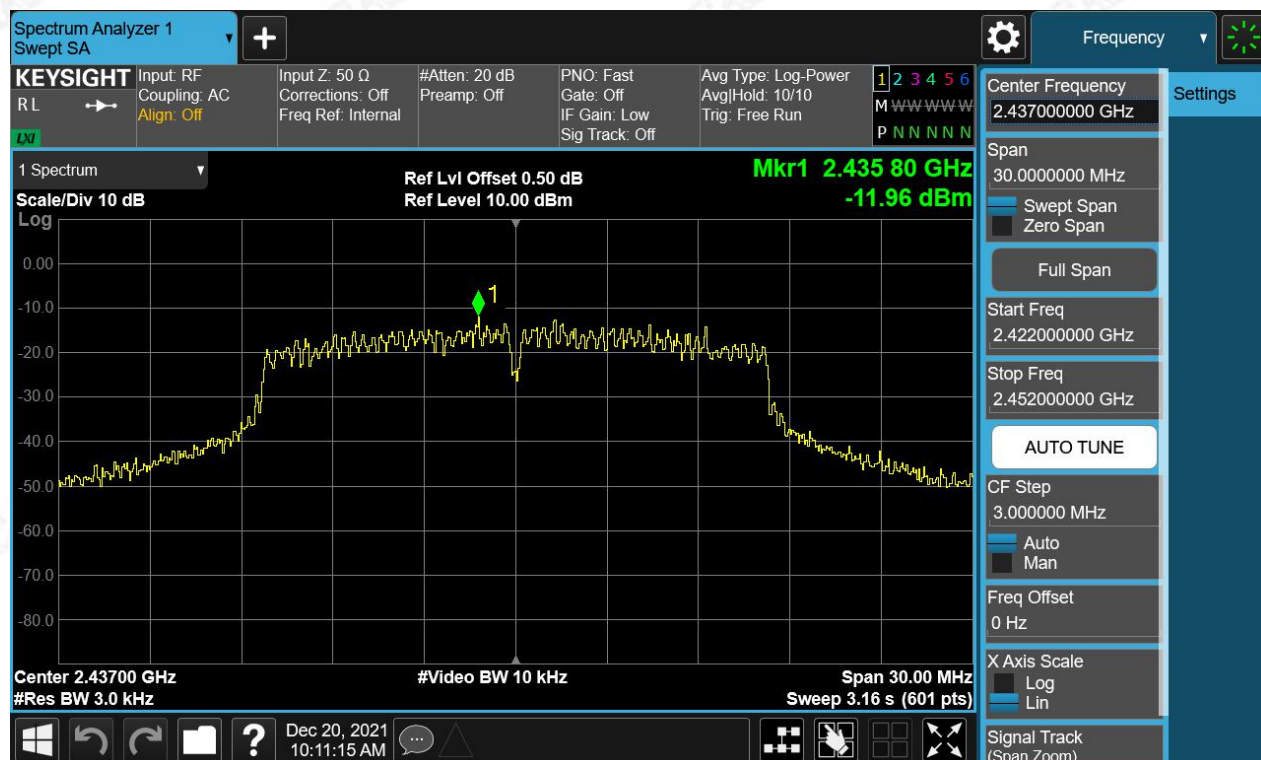
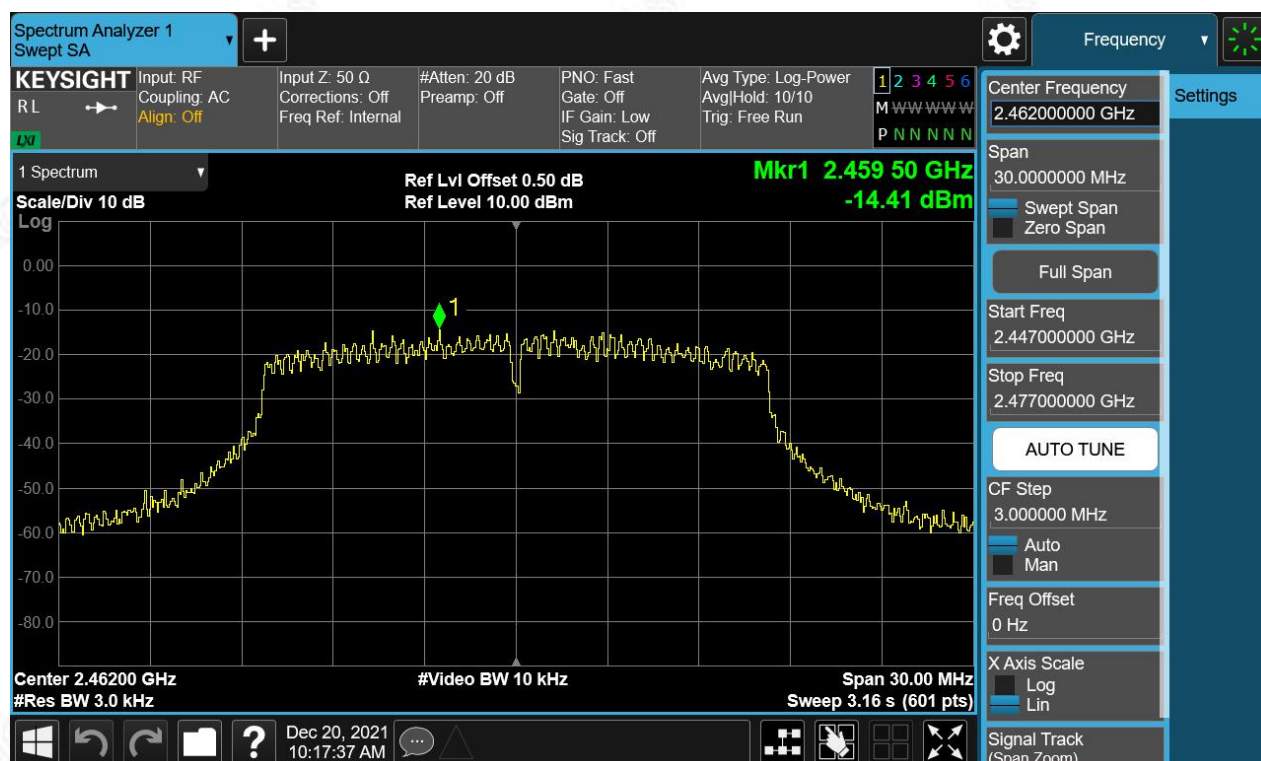


Figure 18: Power Spectral Density, 802.11g, 2462MHz

Figure 19: Power Spectral Density, 802.11n(HT20), 2412MHz

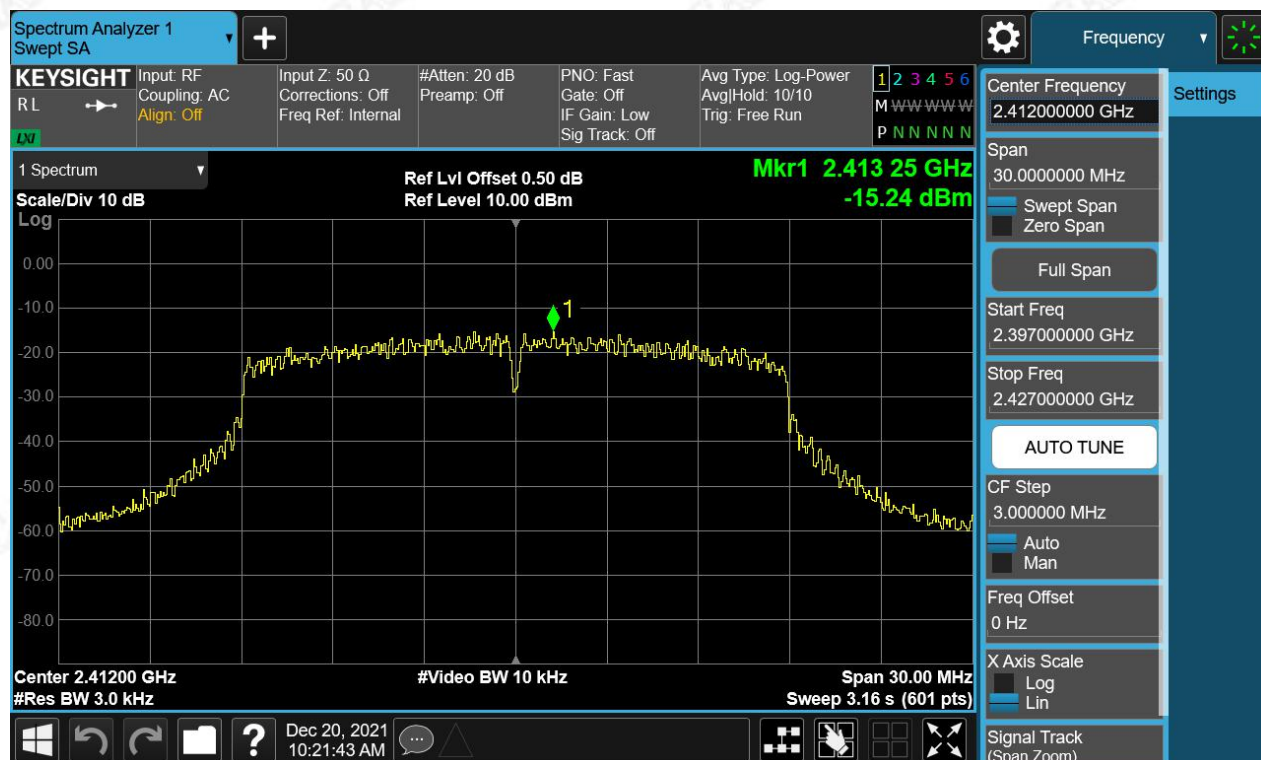
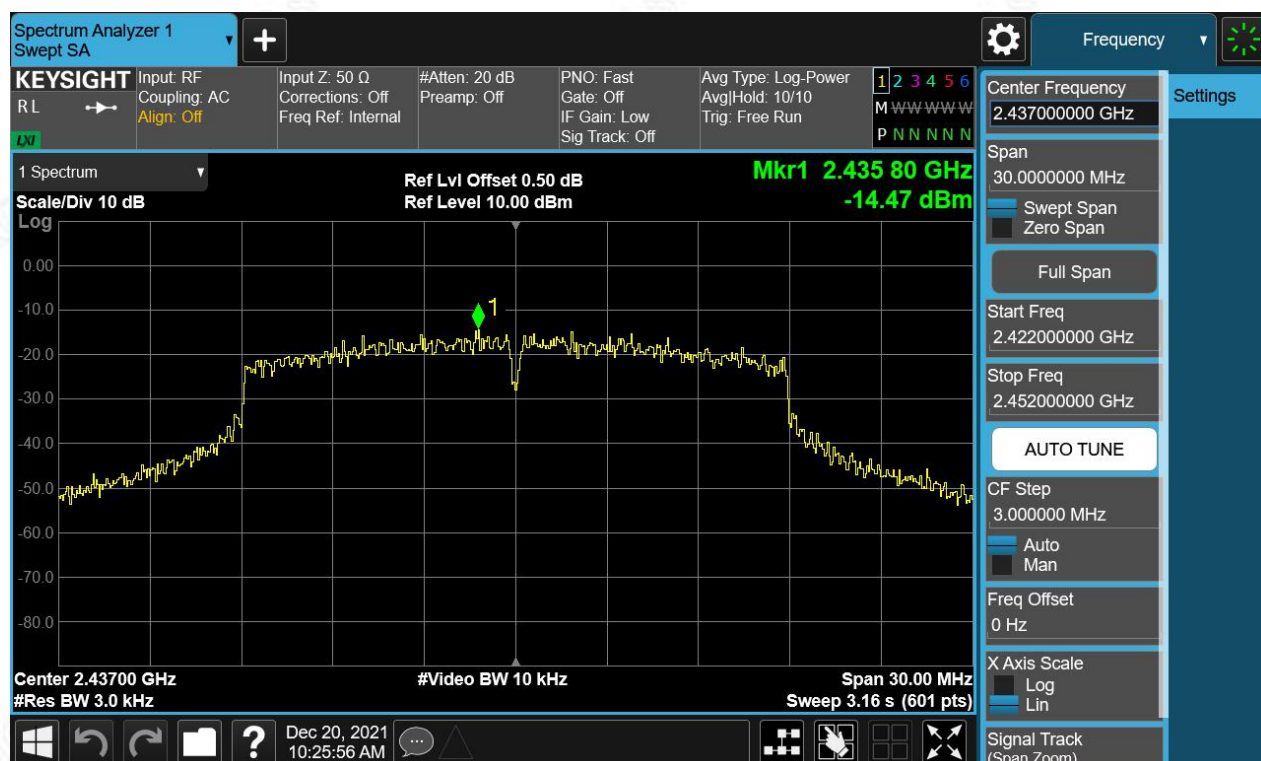


Figure 20: Power Spectral Density, 802.11n(HT20), 2437MHz

Figure 21: Power Spectral Density, 802.11n(HT20), 2462MHz

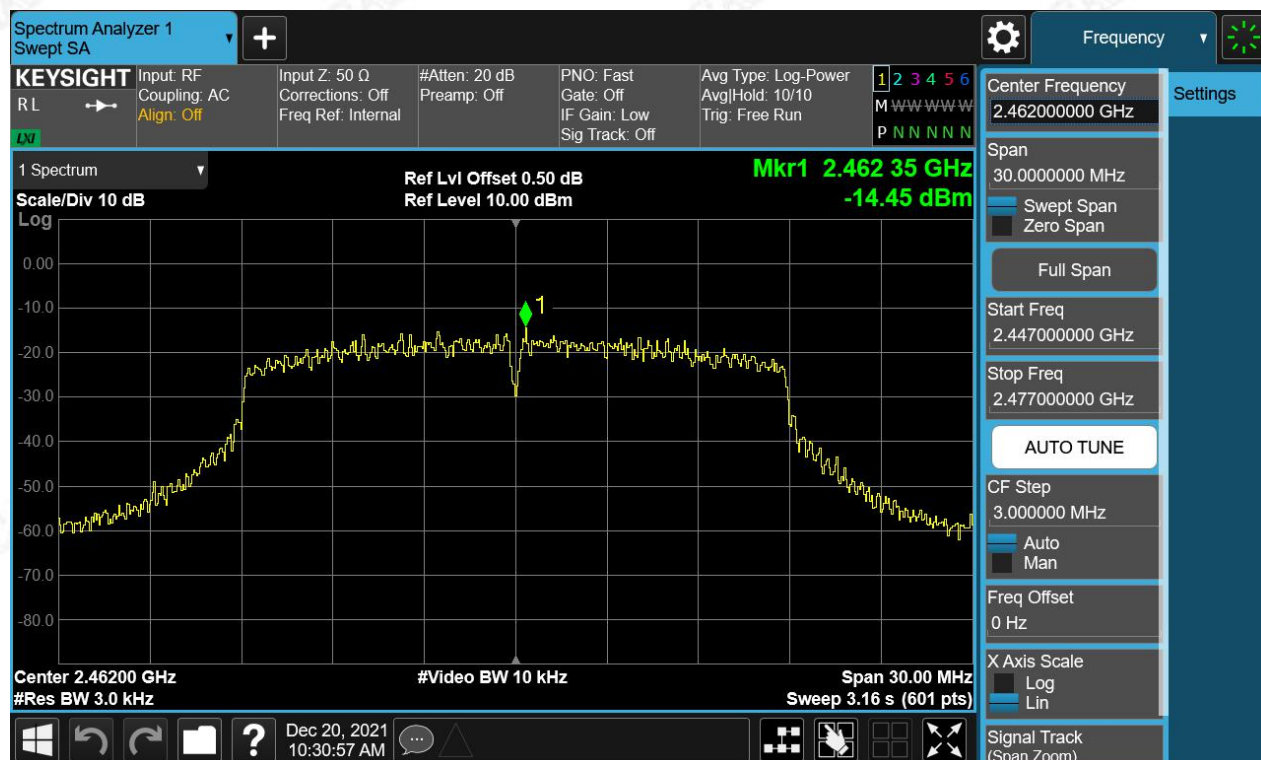


Figure 22: Power Spectral Density, 802.11n(HT40), 2422MHz

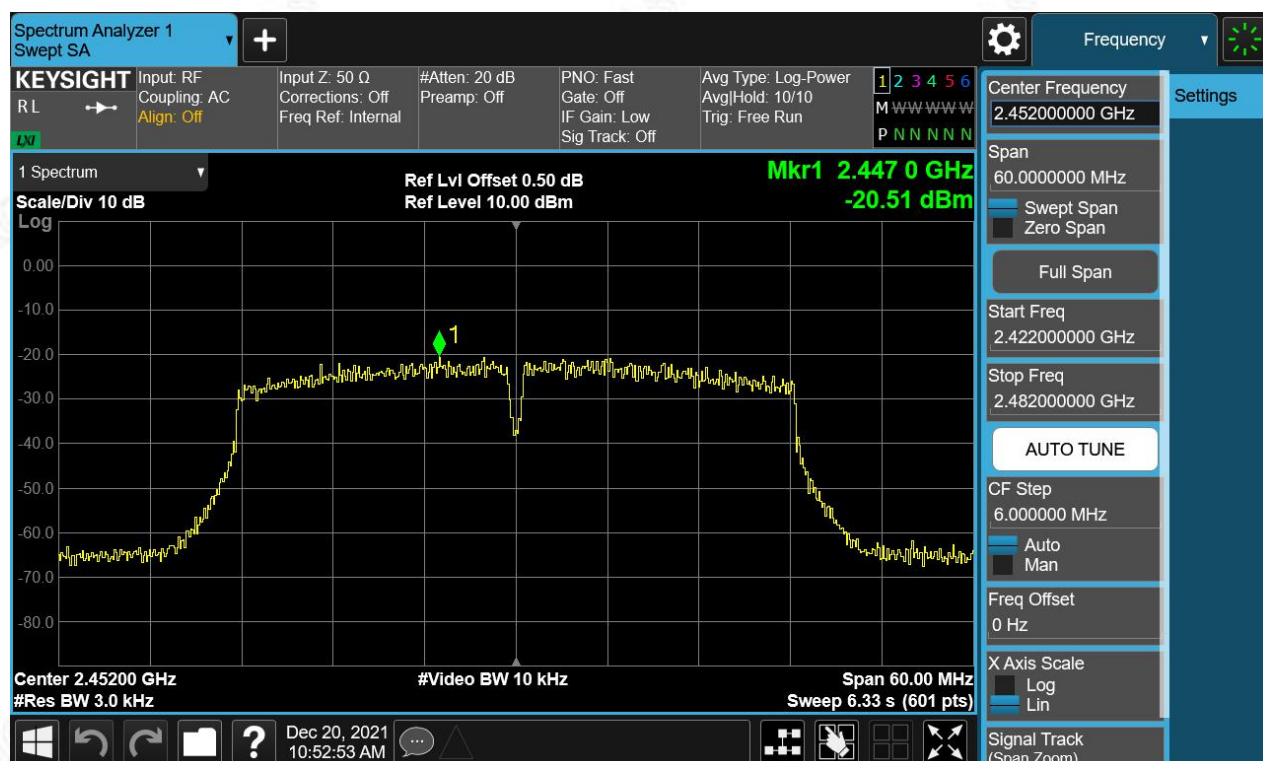

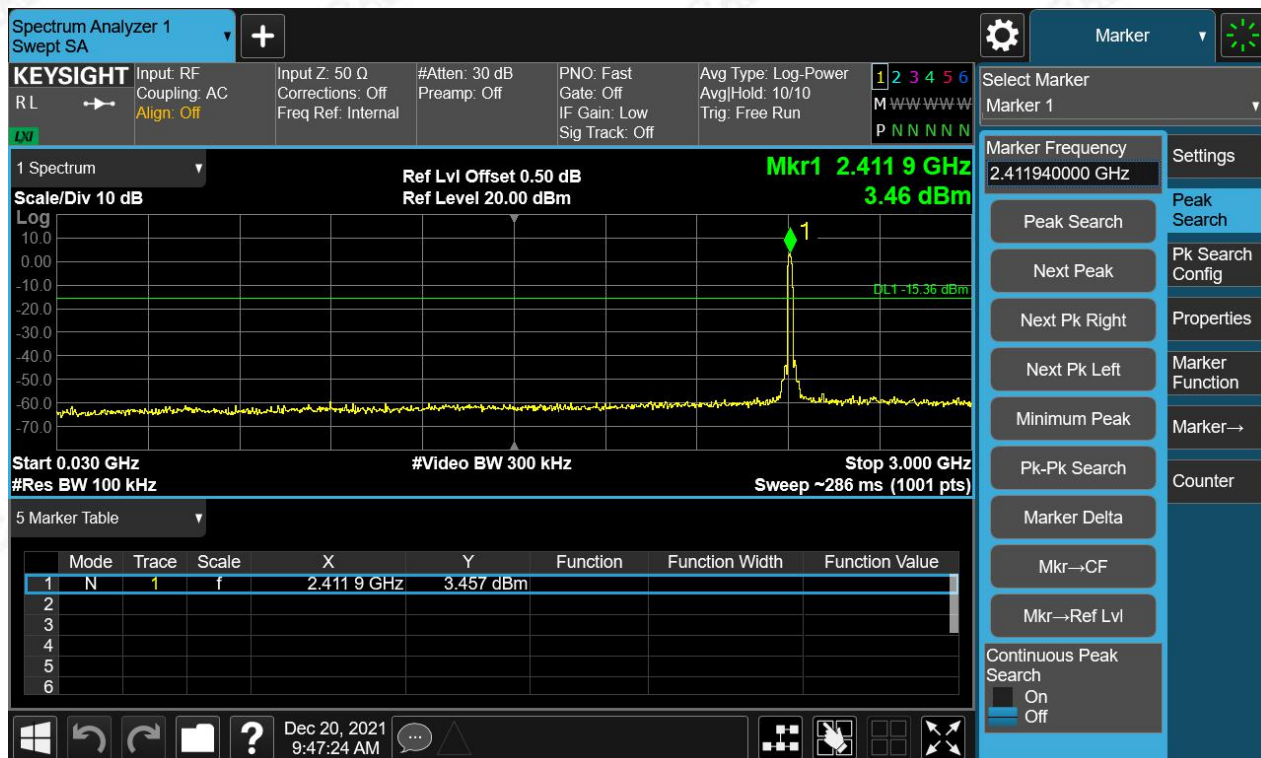

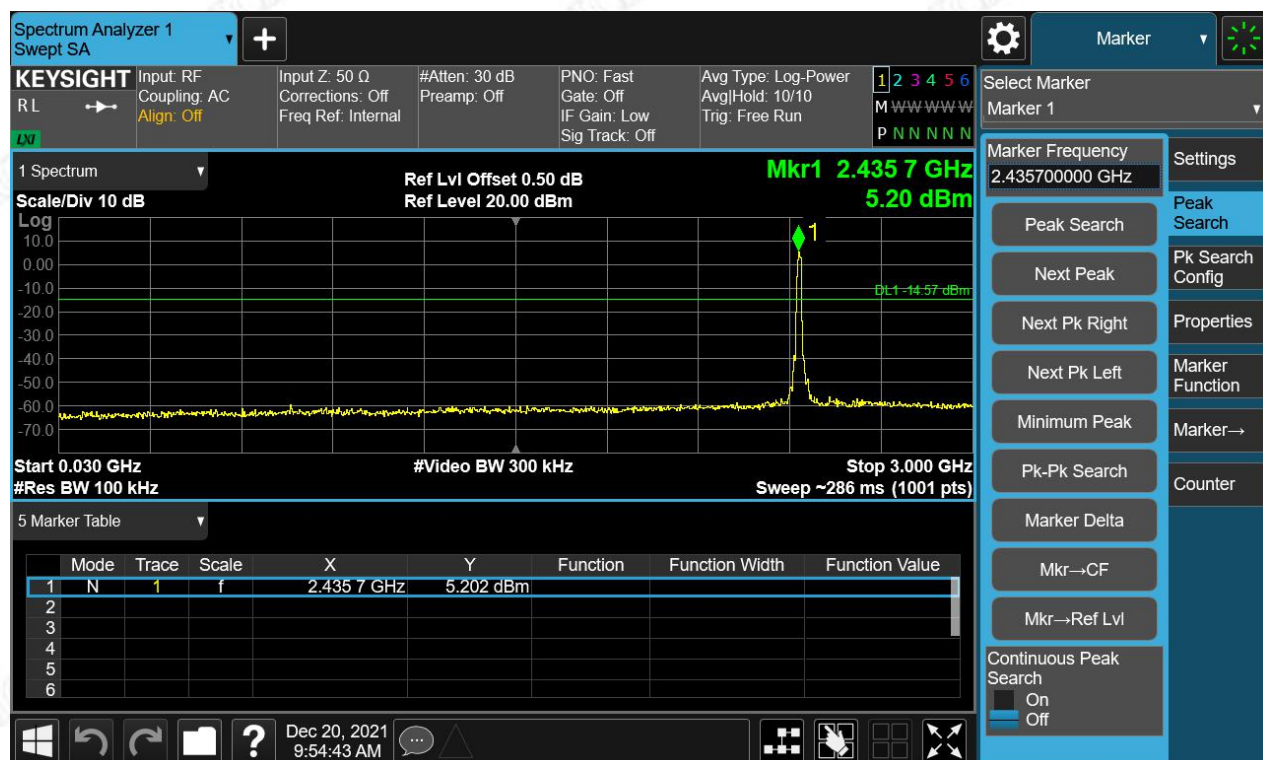

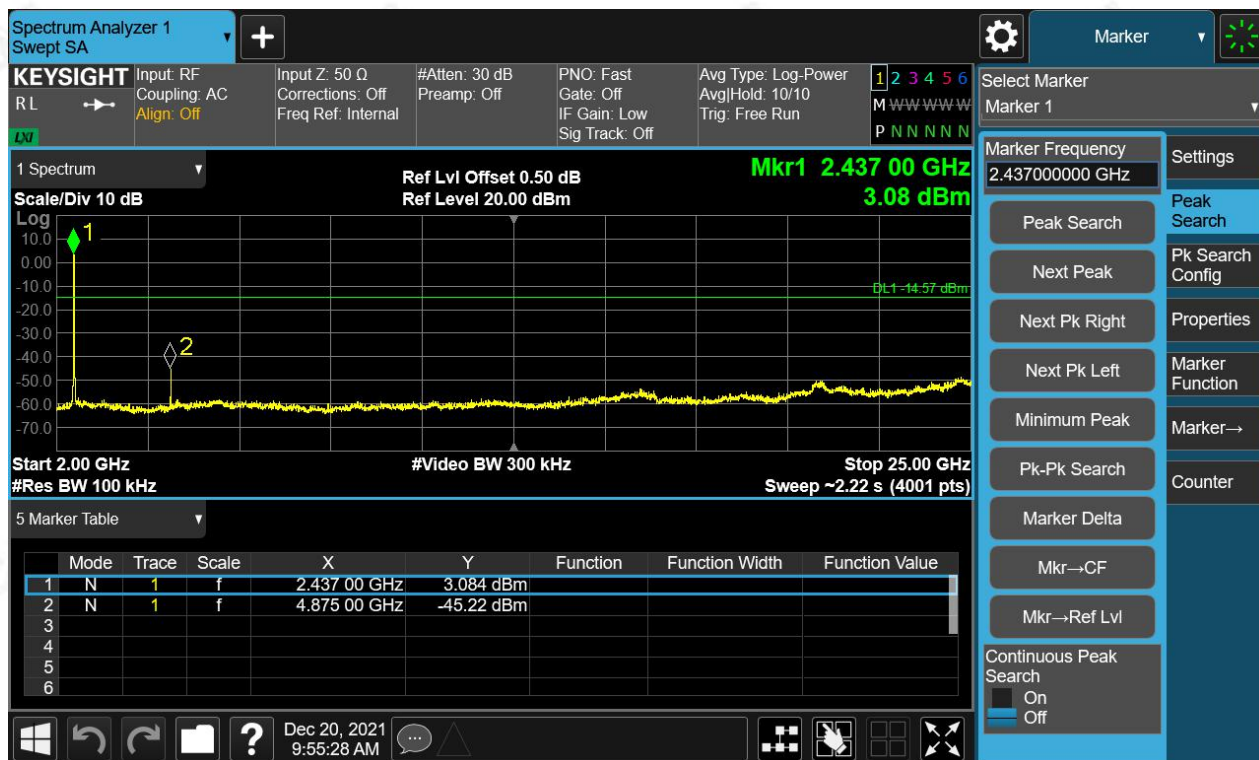


Figure 27: Conducted Spurious Emission & Authorized-band band-edge, 802.11b, 2462MHz Carrier Level
