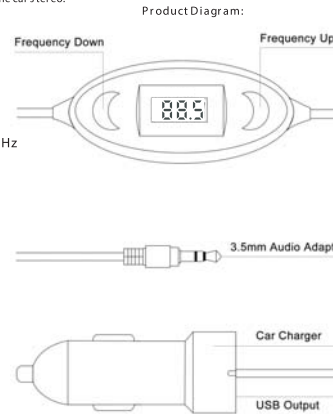


USER MANUAL

 5. Now you can enjoy your music through the car stereo.

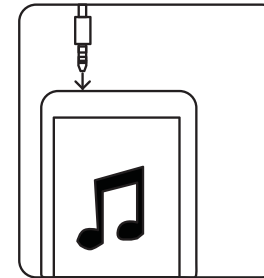

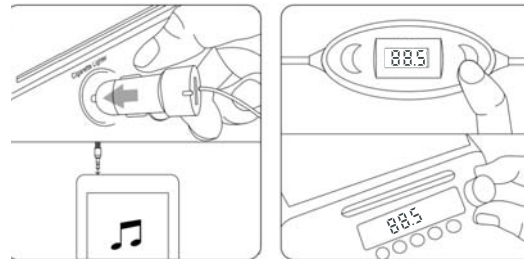
