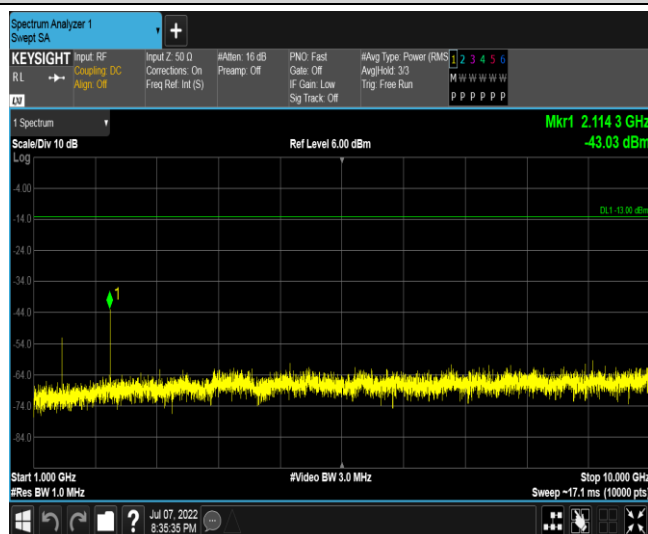
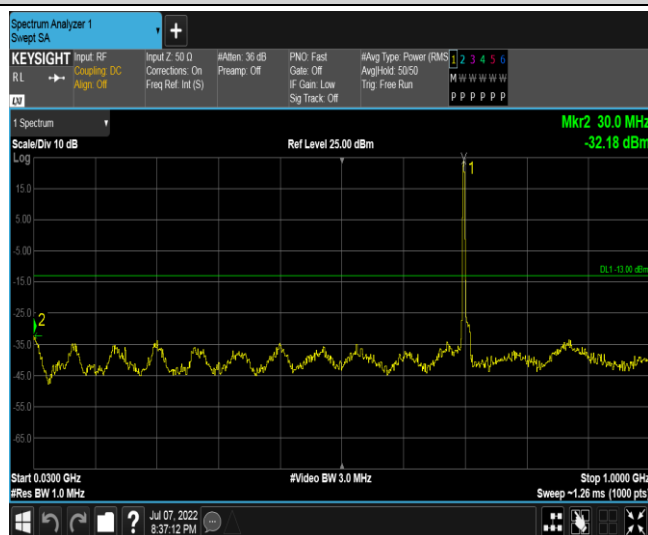

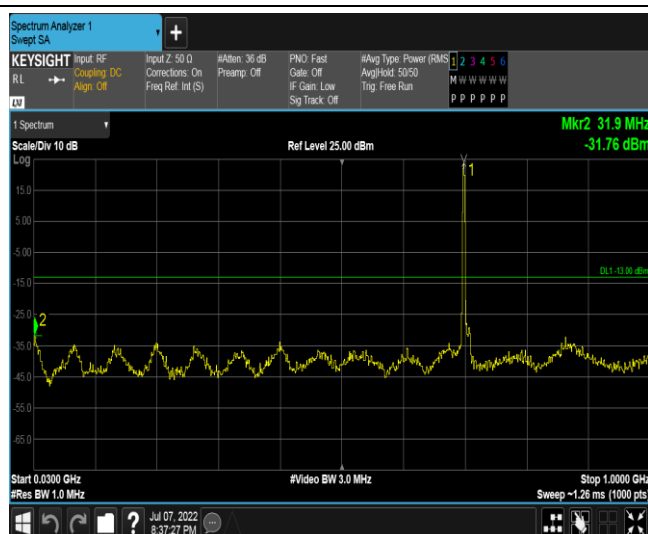


Band17-10MHz-QPSK-23790-1RB#0-Range1:30~1000MHz

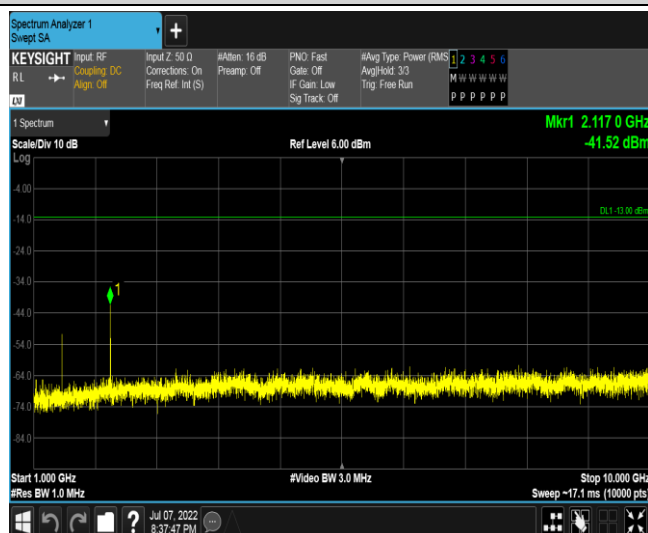

Band17-10MHz-16QAM-23800-1RB#0-Range2:30~1000MHz



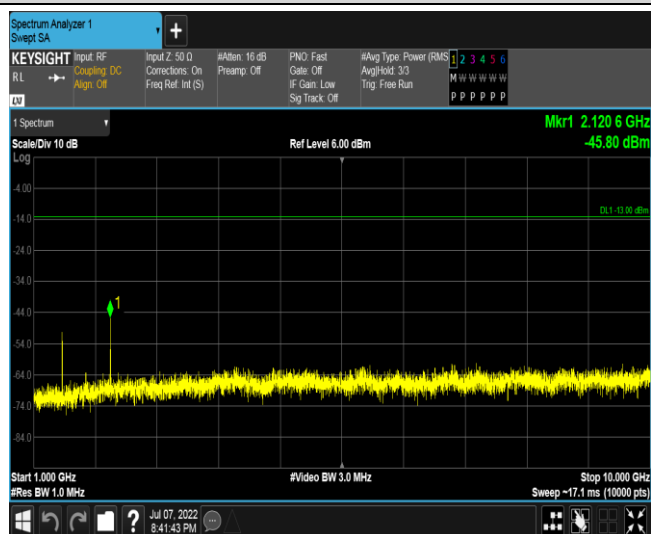
