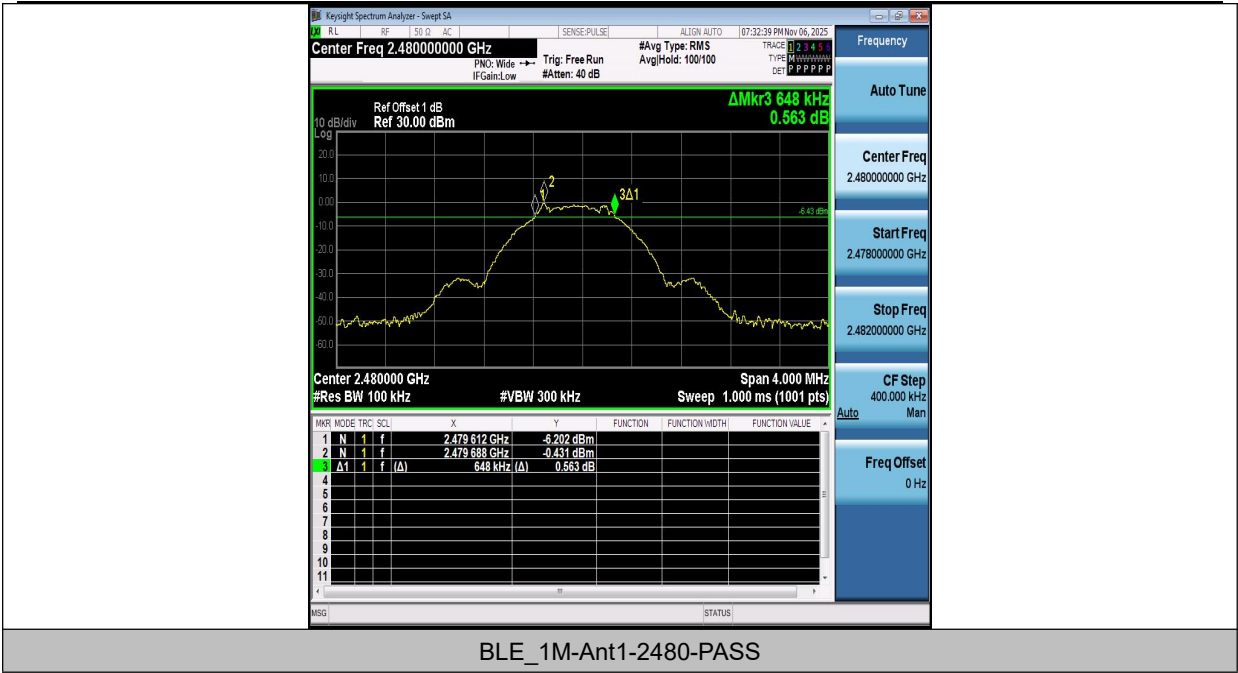

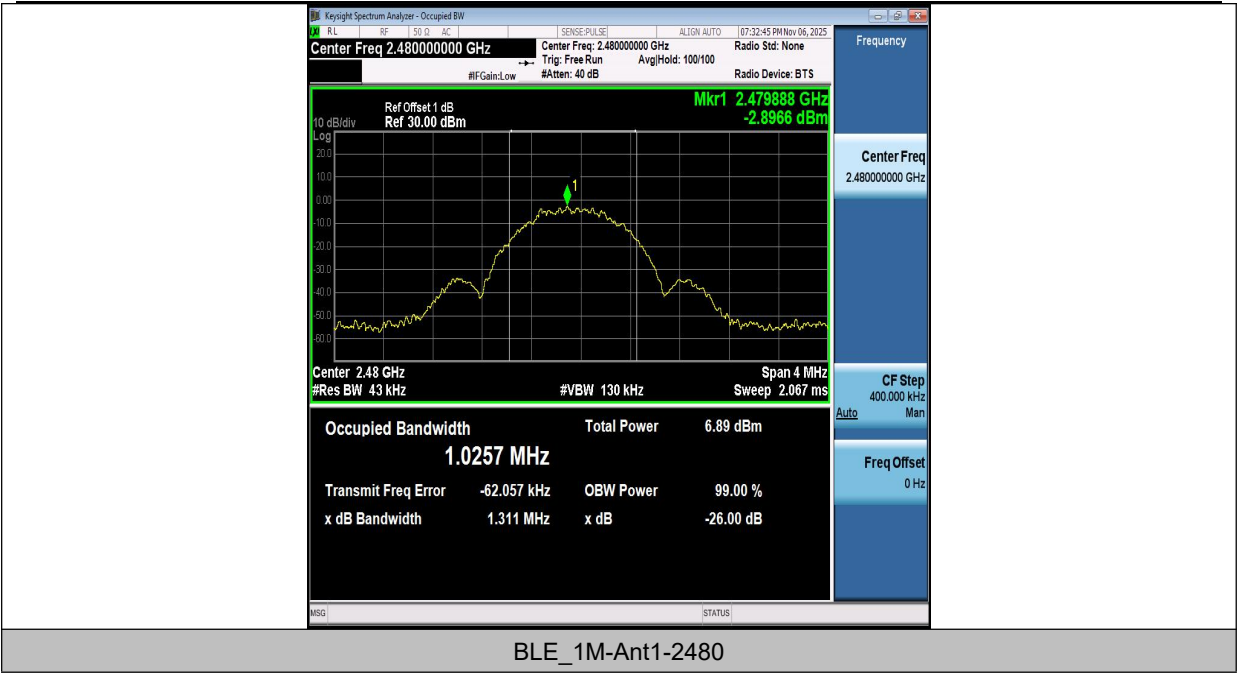

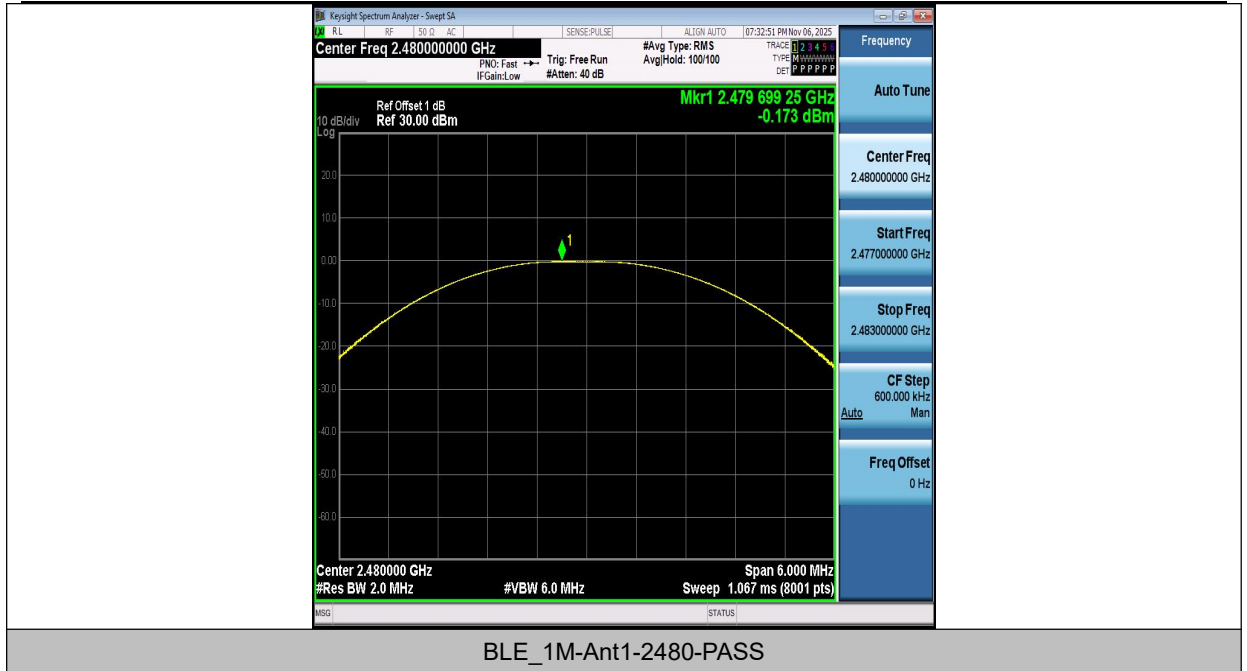
Test Graphs Peak
