1.7 Description of Test Modes

Bluetooth operates in the unlicensed ISM Band at 2.4GHz. With basic data rate feature, the data rates can be up to 1 Mb/s by modulating the RF carrier using GFSK techniques. The EUT works in the X-axis, Y-axis, Z-axis. The following operating modes were applied for the related test items. All test modes were tested, only the result of the worst case was recorded in the report.

Worst-case mode and channel used for 150 KHz-30 MHz power line conducted emissions was determined to be TX (3Mbps-Middle Channel).

Worst-case mode and channel used for 9 KHz-1000 MHz radiated emissions was determined to be TX (3Mbps-Middle Channel).

Pre-test AC conducted emission at charge from High Channel mode, recorded worst case.

Pre-test AC conducted emission at both voltage AC 120V/60Hz and AC 240V/50Hz, recorded worst case at AC 120V/60Hz.

AC conducted emission pre-test at power adapter modes, recorded worst case;





2. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.10-2020, FCC CFR PART 15C 15.207, 15.209 and 15.247.

2.1 EUT Configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

2.2 EUT Exercise

The EUT was operated in the normal operating mode for Hopping Numbers and Dwell Time test and a continuous transmits mode for other tests.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209, 15.247 under the FCC Rules Part 15 Subpart C.

2.3 General Test Procedures

2.3.1 Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 6.2.1 of ANSI C63.10-2020 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

2.3.2 Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane below 1GHz and 1.5 m above ground plane above 1GHz. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10-2020.

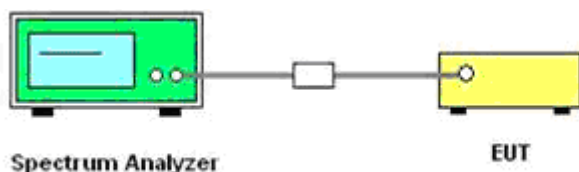
6. MEASUREMENT RESULTS

6.1. Frequency Separation and 20 dB Bandwidth

6.1.1 Limit

According to §15.247(a), Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW.

6.1.2 Block Diagram of Test Setup



6.1.3 Test Procedure

Frequency separation test procedure :

- 1). Place the EUT on the table and set it in transmitting mode.
- 2). Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the Spectrum Analyzer.
- 3). Set center frequency of Spectrum Analyzer = middle of hopping channel.
- 4). Set the Spectrum Analyzer as RBW = 30 kHz, VBW = 100 kHz, Span = wide enough to capture the peaks of two adjacent channels, Sweep = auto.
- 5). Max hold, mark 2 peaks of hopping channel and record the 2 peaks frequency.

20dB bandwidth test procedure :

- 1). Span = approximately 2 to 3 times the 20 dB bandwidth, centered on a hopping channel.
- 2). RBW $\geq 1\%$ of the 20 dB bandwidth, VBW $\geq$ RBW.
- 3). Detector function = peak.
- 4). Trace = max hold.

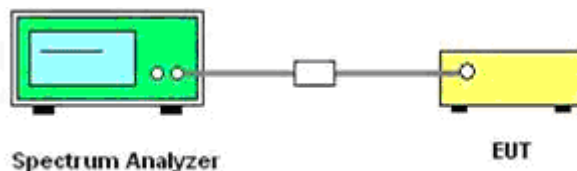

6.2.1 Block Diagram of Test Setup



6.2.2 Limit

According to §15.247(b)(1), For frequency hopping systems operating in the 2400–2483.5 MHz band employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5725–5850 MHz band: 1 watt. For all other frequency hopping systems in the 2400–2483.5 MHz band: 0.125 watts.

6.2.3 Test Procedure

The transmitter output is connected to the spectrum.

6.2.4. Test Procedures

- 1) Span: Approximately five times the 20 dB bandwidth, centered on a hopping channel.
- 2) RBW > 20 dB bandwidth of the emission being measured.
- 3) VBW $\geq$ RBW.
- 4) Sweep: Auto.
- 5) Detector function: Peak.
- 6) Trace: Max hold.

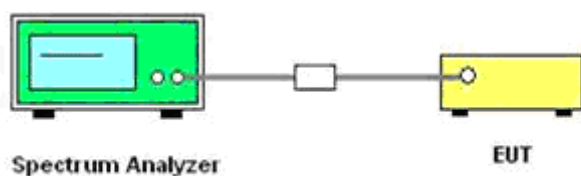


6.3. Time of Occupancy (Dwell Time)

6.3.1 Limit

According to §15.247(a)(1), Frequency hopping systems operating in the 2400MHz- 2483.5 MHz bands. The average time of occupancy on any channels shall not greater than 0.4 s within a period 0.4 s multiplied by the number of hopping channels employed.

6.3.2 Block Diagram of Test Setup



6.3.3 Test Procedure

- 1). Place the EUT on the table and set it in transmitting mode.
- 2). Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the Spectrum Analyzer.
- 3). Set center frequency of Spectrum Analyzer = operating frequency.
- 4). Set the Spectrum Analyzer as RBW=1MHz, VBW=3MHz, Span = 0Hz, Sweep = auto.
- 5). Repeat above procedures until all frequency measured was complete.

The Dwell Time=Burst Width*Total Hops.

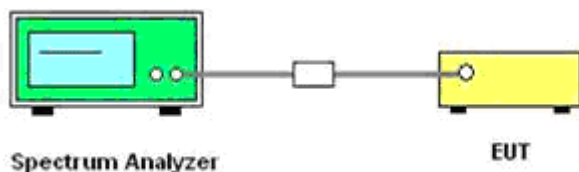


6.4. Number of Hopping Frequency

6.4.1 Limit

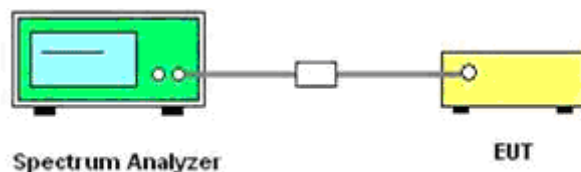


6.5. Band Edges Measurements and Conducted Spurious Emissions Test

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. 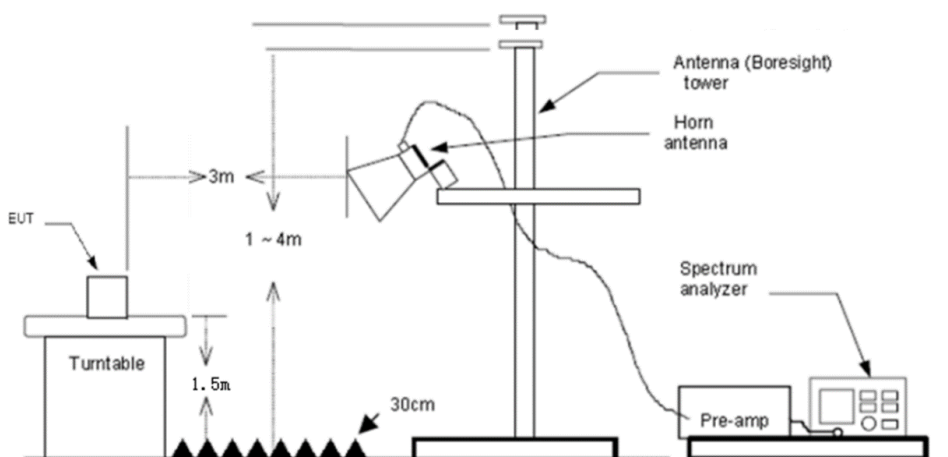

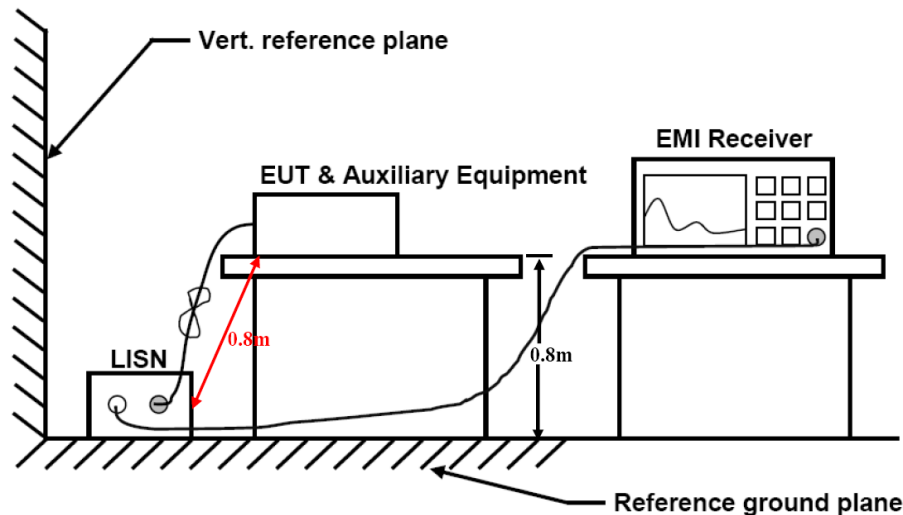
6.7.1 Standard Applicable

According to §15.207 (a): For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). 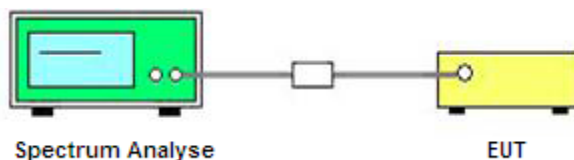

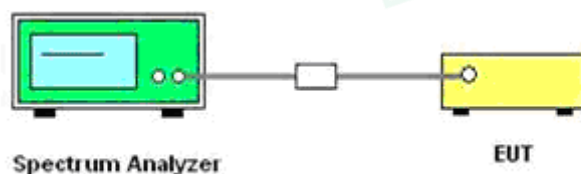


6.9. Emissions in Restricted Band

6.9.1 Standard Applicable

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

6.9.4. Test Procedures

According to KDB 412172 section 1.1 Field Strength Approach (linear terms):

$$\text{eirp} = p_t \times g_t = (E \times d)^2 / 30$$

Where:

p_t = transmitter output power in watts,

g_t = numeric gain of the transmitting antenna (unitless),

E = electric field strength in V/m,

d = measurement distance in meters (m).

$$\text{erp} = \text{eirp} / 1.64 = (E \times d)^2 / (30 \times 1.64)$$

Where all terms are as previously defined.

1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
2. Remove the antenna from the EUT and then connect to a low loss RF cable from the antenna port to a EMI test receiver, then turn on the EUT and make it operate in transmitting mode. Then set it to Middle Channel and High Channel within its operating range, and make sure the instrument is operated in its linear range.
3. Set both RBW and VBW of spectrum analyzer to 100 kHz with a convenient frequency span including 100kHz bandwidth from band edge, for Radiated emissions restricted band RBW=1MHz, VBW=3MHz for peak detector and RBW=1MHz, VBW=1/T for Peak detector.
4. Measure the highest amplitude appearing on spectral display and set it as a reference level. Plot the graph with marking the highest point and edge frequency.
5. Repeat above procedures until all measured frequencies were complete.
6. Measure the conducted output power (in dBm) using the detector specified by the appropriate regulatory agency for guidance regarding measurement procedures for determining quasi-peak, peak, and average conducted output power, respectively).

7. Add the maximum transmit antenna gain (in dBi) to the measured output power level to determine the EIRP level (see 12.2.5 for guidance on determining the applicable antenna gain)
8. Add the appropriate maximum ground reflection factor to the EIRP level (6 dB for frequencies ≤ 30 MHz, 4.7 dB for frequencies between 30 MHz and 1000 MHz, inclusive and 0 dB for frequencies > 1000 MHz).
9. For devices with multiple antenna-ports, measure the power of each individual chain and sum the EIRP of all chains in linear terms (e.g., Watts, mW).
10. Compare the resultant electric field strength level to the applicable regulatory limit.
11. Perform radiated spurious emission test duress until all measured frequencies were complete.

1. Measured at difference Packet Type for each mode and recorded worst case for each mode.
2. Worst case data at DH5 for GFSK, 2DH5 for $\pi/4$ -DQPSK, 3DH5 for 8-DPSK modulation type;
3. Measured at Hopping and Non-Hopping mode, recorded worst at Non-Hopping mode.
4. The other emission levels were very low against the limit.
5. The average measurement was not performed when the peak measured data under the limit of average detection.
6. Detector AV is setting spectrum/receiver. RBW=1MHz/VBW=1/T/Sweep time=Auto/Detector=Peak;
7. Since the out-of-band characteristics of the EUT transmit antenna will often be unknown, the use of a conservative antenna gain value is necessary. Thus, when determining the EIRP based on the measured conducted power, the upper bound on antenna gain for a device with a single RF output shall be selected as the maximum in-band gain of the antenna across all operating bands, or 2 dBi, whichever is greater. However, for devices that operate in multiple frequency bands while using the same transmit antenna, the highest gain of the antenna within the operating band nearest in frequency to the restricted band emission being measured may be used in lieu of the overall highest gain when the emission is at a frequency that is within 20 percent of the nearest band edge frequency, but in no case shall a value less than 2 dBi be used.

6.10. Pseudorandom Frequency Hopping Sequence

6.10.1 Standard Applicable

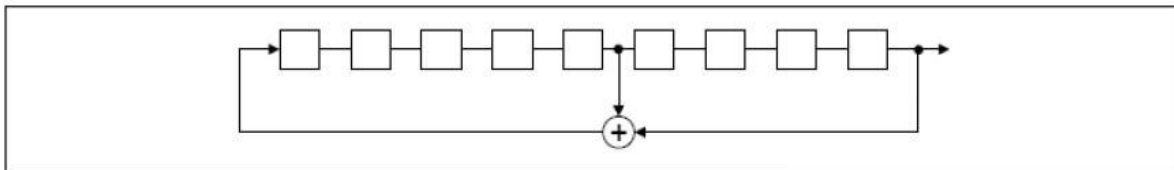
For 47 CFR Part 15C sections 15.247 (a) (1) requirement:

Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hop-ping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400–2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW. The system shall hop to channel frequencies that are selected at the system hopping rate from a pseudo randomly ordered list of hopping frequencies. Each frequency must be used equally on the average by each transmitter. The system receivers shall have input bandwidths that match the hop-ping channel bandwidths of their corresponding transmitters and shall shift frequencies in synchronization with the transmitted signals.

6.10.2 EUT Pseudorandom Frequency Hopping Sequence Requirement

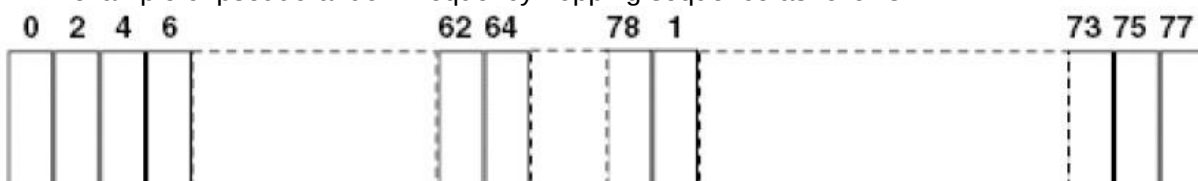
The pseudorandom frequency hopping sequence may be generated in a nine-stage shift register whose 5th first stage. The sequence begins with the first one of 9 consecutive ones, for example: the shift register is initialized with nine ones.

- Number of shift register stages:9
- Length of pseudo-random sequence:29-1=511 bits
- Longest sequence of zeros:8(non-inverted signal)

Each frequency used equally one the average by each transmitter.
The system receiver have input bandwidths that match the hopping channel bandwidths of their corresponding transmitter and shift frequencies in synchronization with the transmitted signals.





6.11. Antenna Requirement

6.11.1 Standard Applicable

According to antenna requirement of §15.203.

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be re-placed by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.

And according to §15.247(4)(1), system operating in the 2400-2483.5MHz bands that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.

6.11.2 Antenna Connected Construction

6.11.2.1. Standard Applicable

According to § 15.203 & RSS-Gen, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

6.11.2.2. Antenna Connector Construction

The directional gains of antenna used for transmitting is 1.7dBi(Max), and the antenna is an PCB Antenna connect to PCB board and no consideration of replacement. Please see EUT photo for details.
