## 4. Test Set-up and Operation Modes

### 4.1 Principle of Configuration Selection

The test modes were adapted accordingly in reference to the instructions for use.

During testing, Channel and Power Controlling Software provided by the customer was used to control the operating channel as well as the output power level. The RF output power selection is for the setting of RF output expected by the customer and is going to be fixed on the firmware of the final end product.

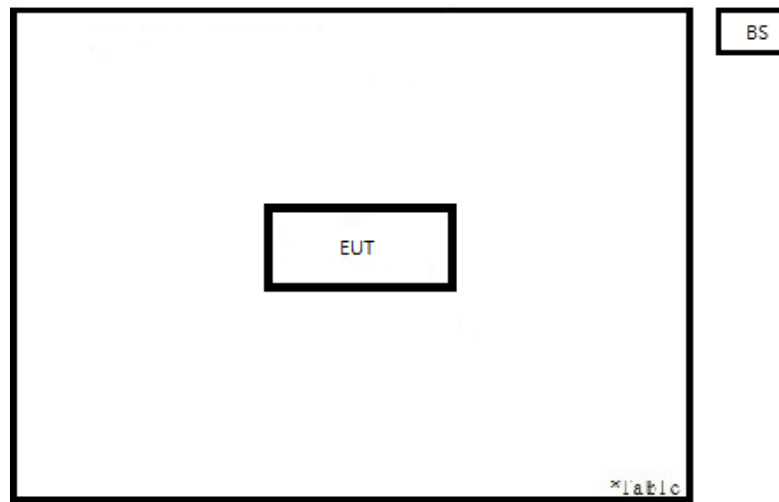

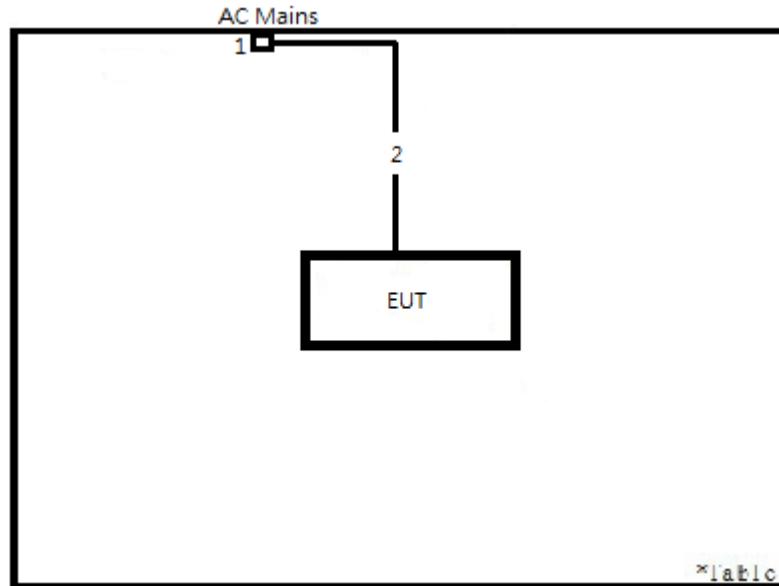

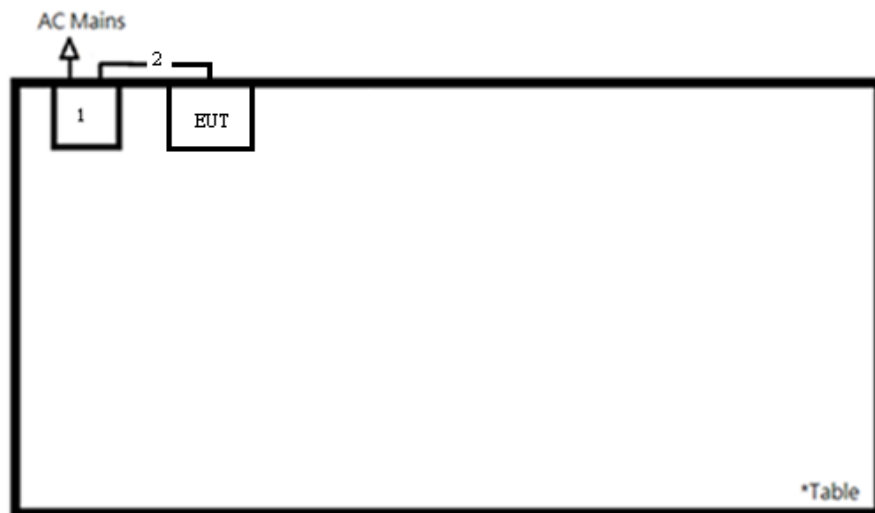
<Radiated Spurious Emissions Mode>

## 4.6 Duty Cycle of Test Signal

Based on the BT hopping rate 1600/s, the transmission time would be  $6/1600 = 3.75\text{ms}$

$3.75\text{ms} \times 79 = 296.25 > 100\text{ms}$ , thus, 1 time appear on 100ms.

Duty Cycle Factor on DH5:  $20\log(3.75 \times 5 / 6 \times 1 / 100) = -30.1$

## 5. Test Results

### 5.1 Transmitter Requirement & Test Suites

#### 5.1.1 Antenna Requirement

**Requirement** Use of approved antennas only

According to the manufacturer declaration, the EUT has an antenna with a directional gain of 1.73 dBi. The antenna is a Chip Antenna soldered to the PCB with no possibility of replacement with a non-approved antenna by the end-user. Therefore, the EUT is considered to comply with this provision. Refer to EUT photo for details.

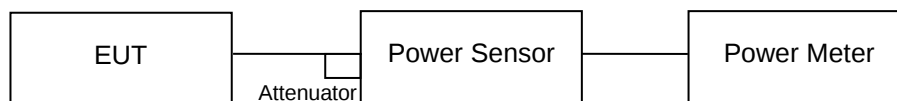

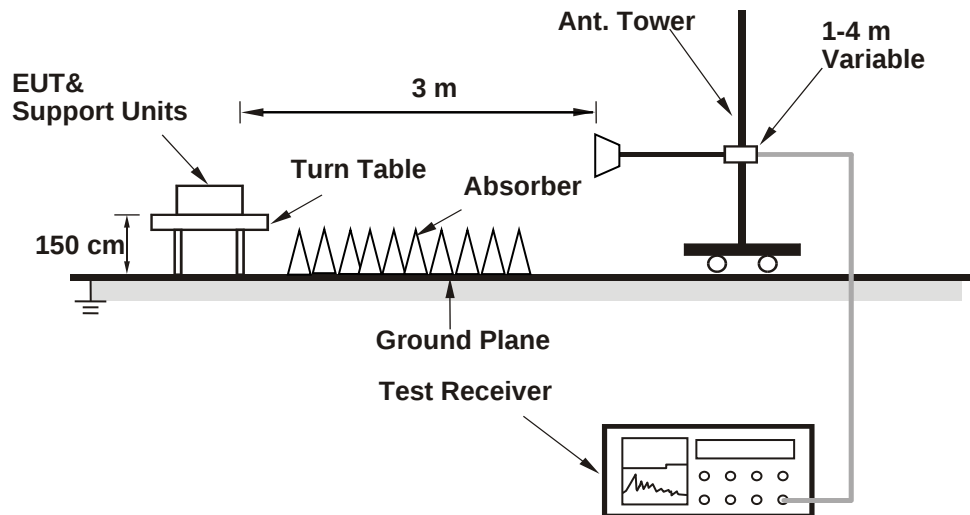
#### <Radiated Emissions below 30 MHz>

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter chamber room. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. Parallel (OPEN), perpendicular (CLOSE), and ground-parallel (GROUND) orientations of the antenna are set to make the measurement.

- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
