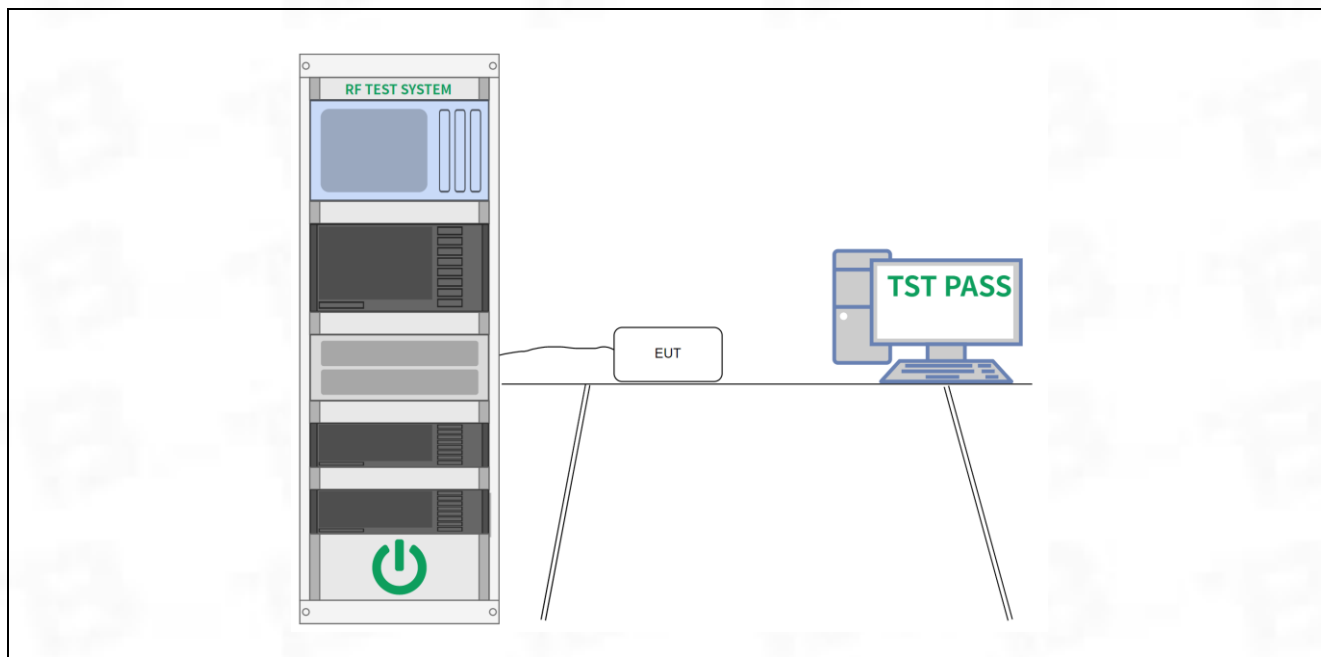

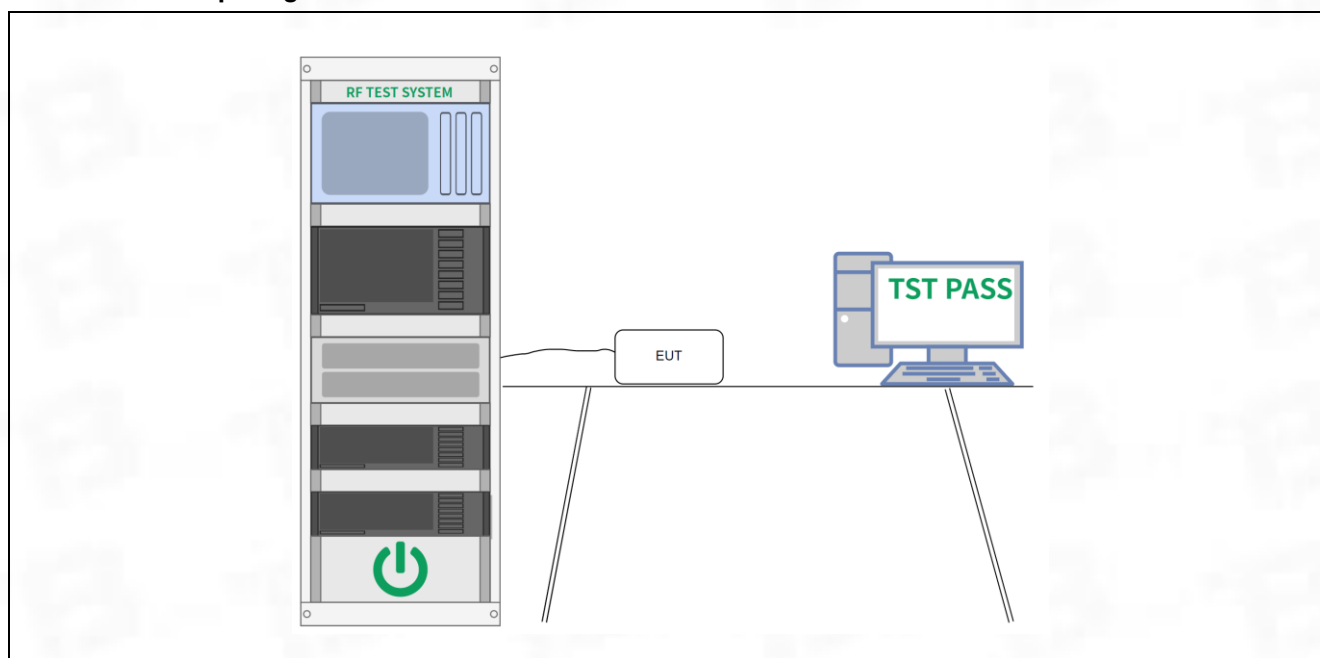

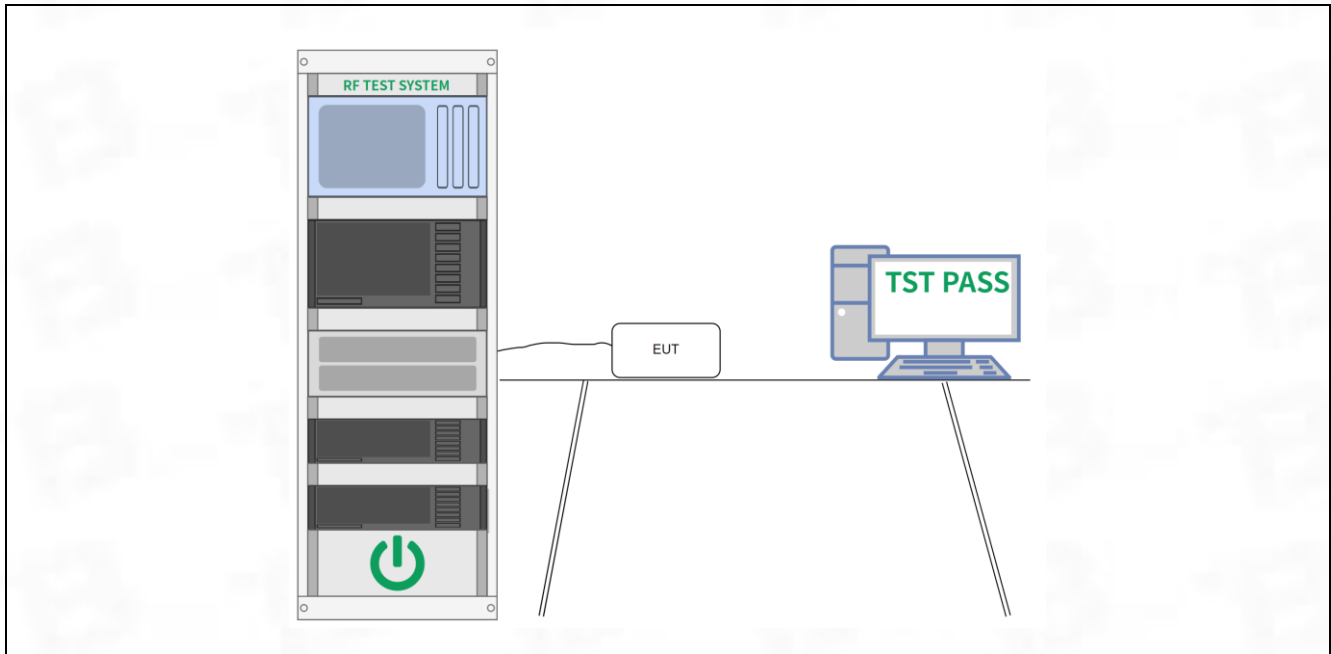

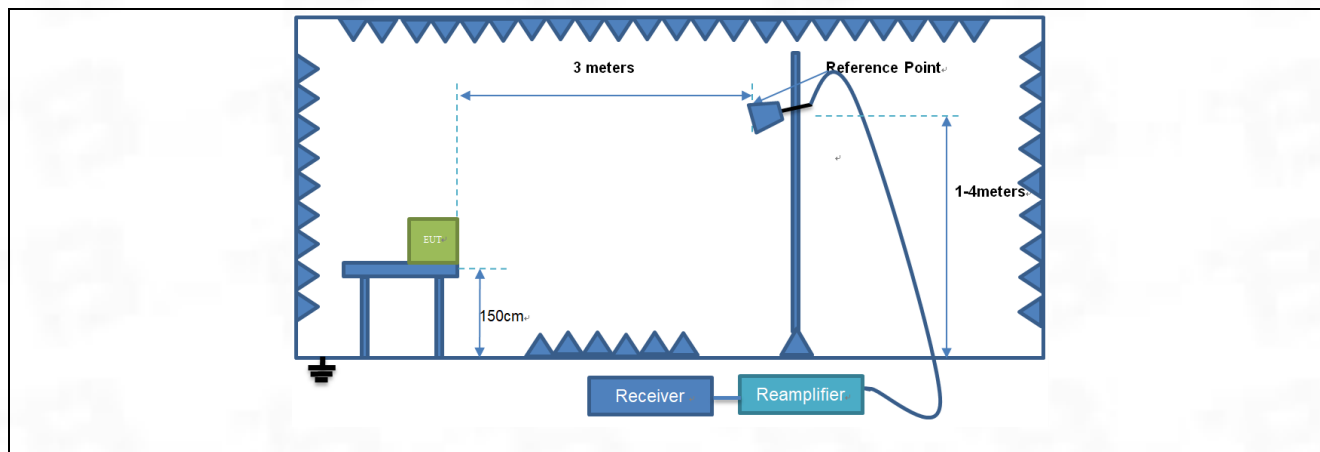

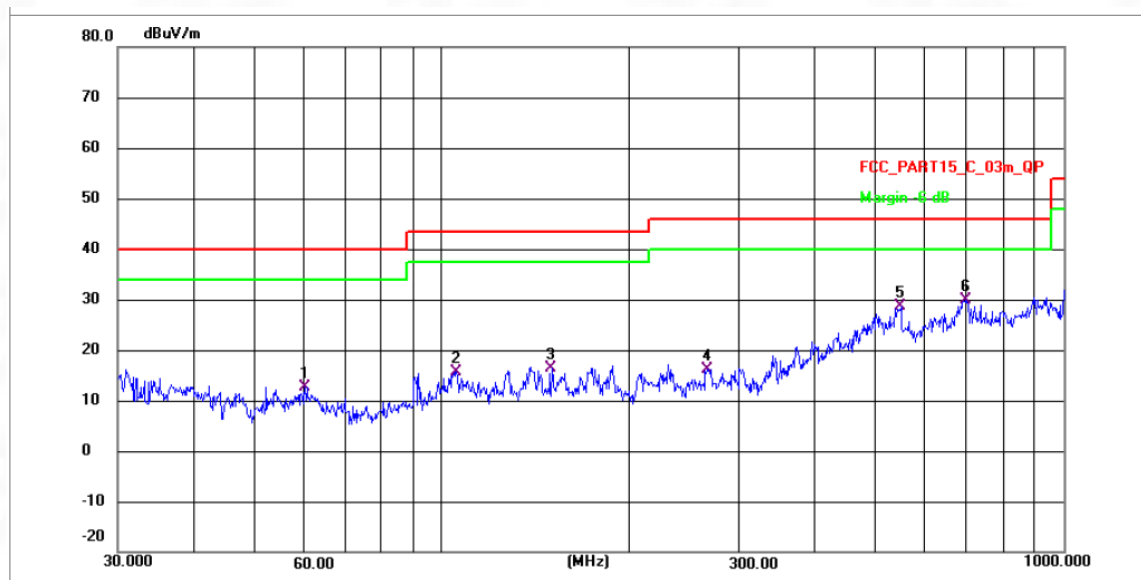

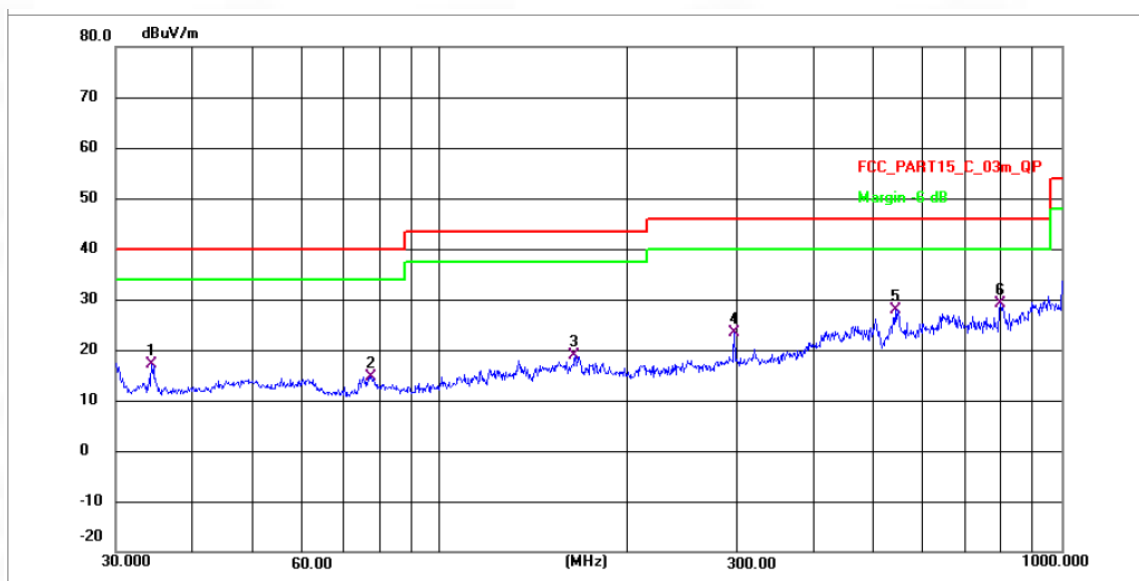

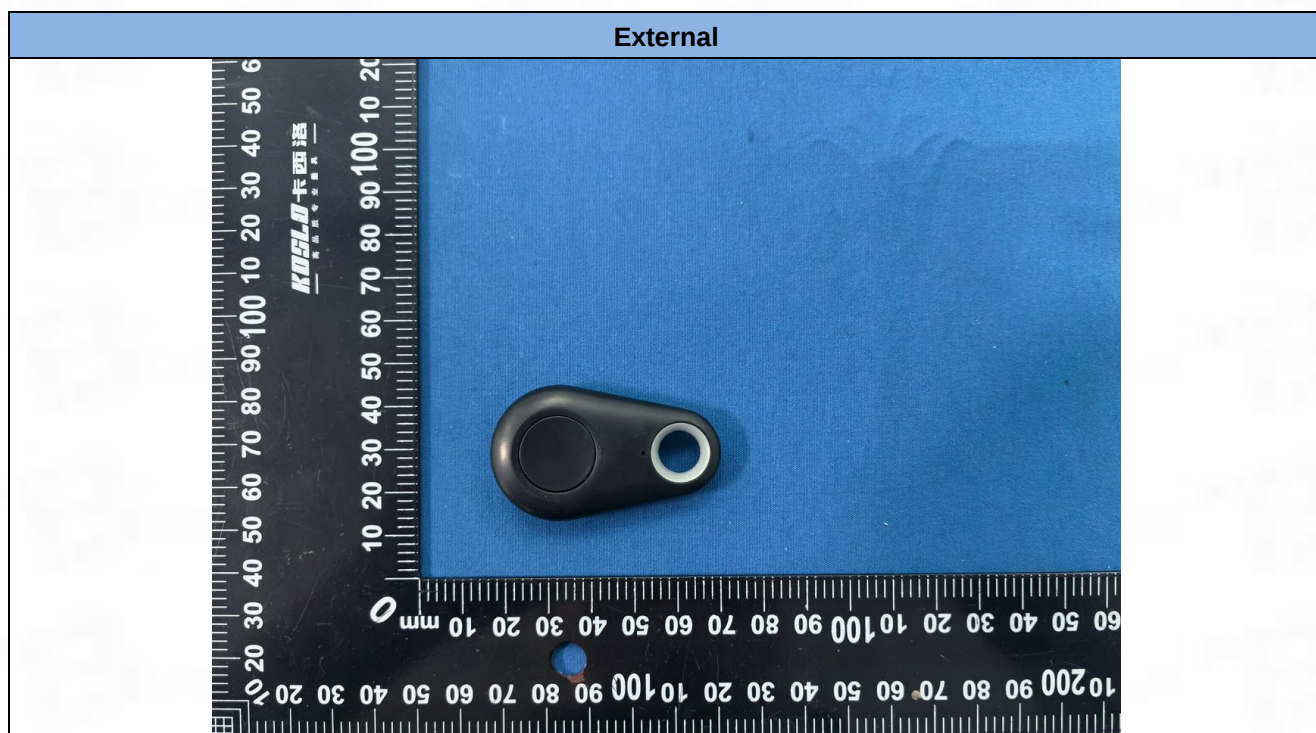
Band edge emissions (Radiated)

Emissions in frequency bands (below 1GHz)

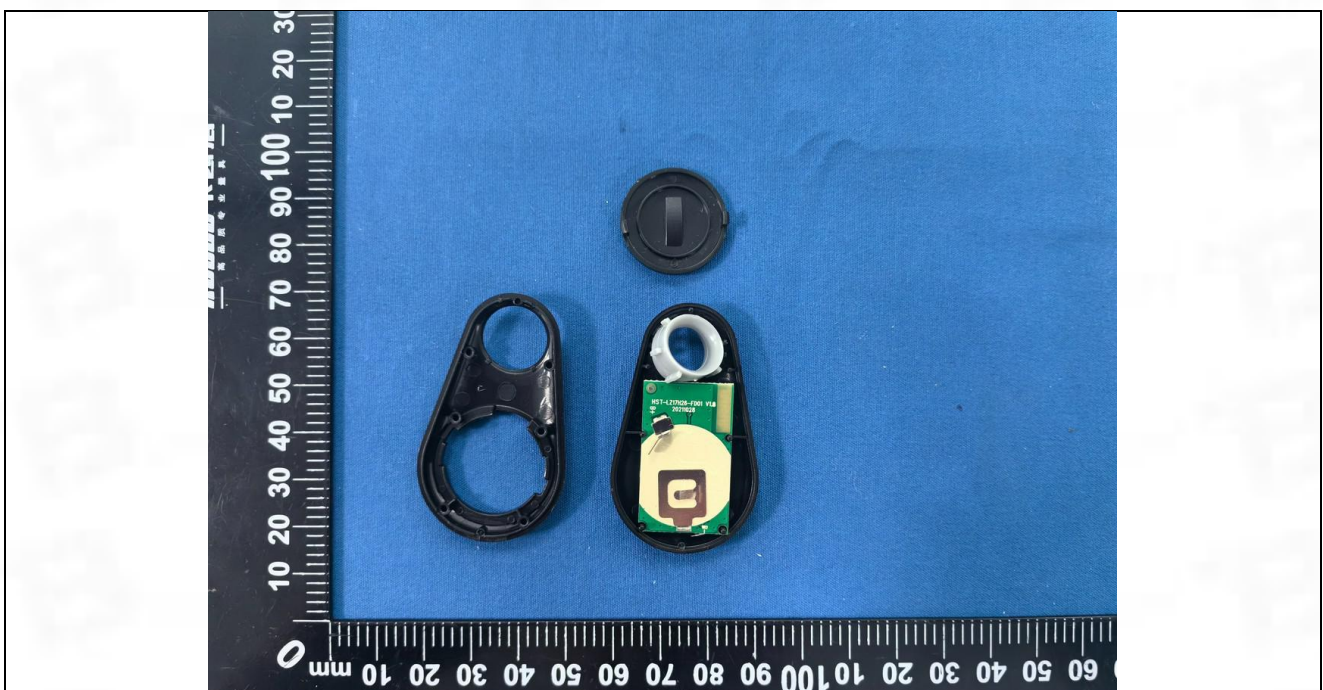


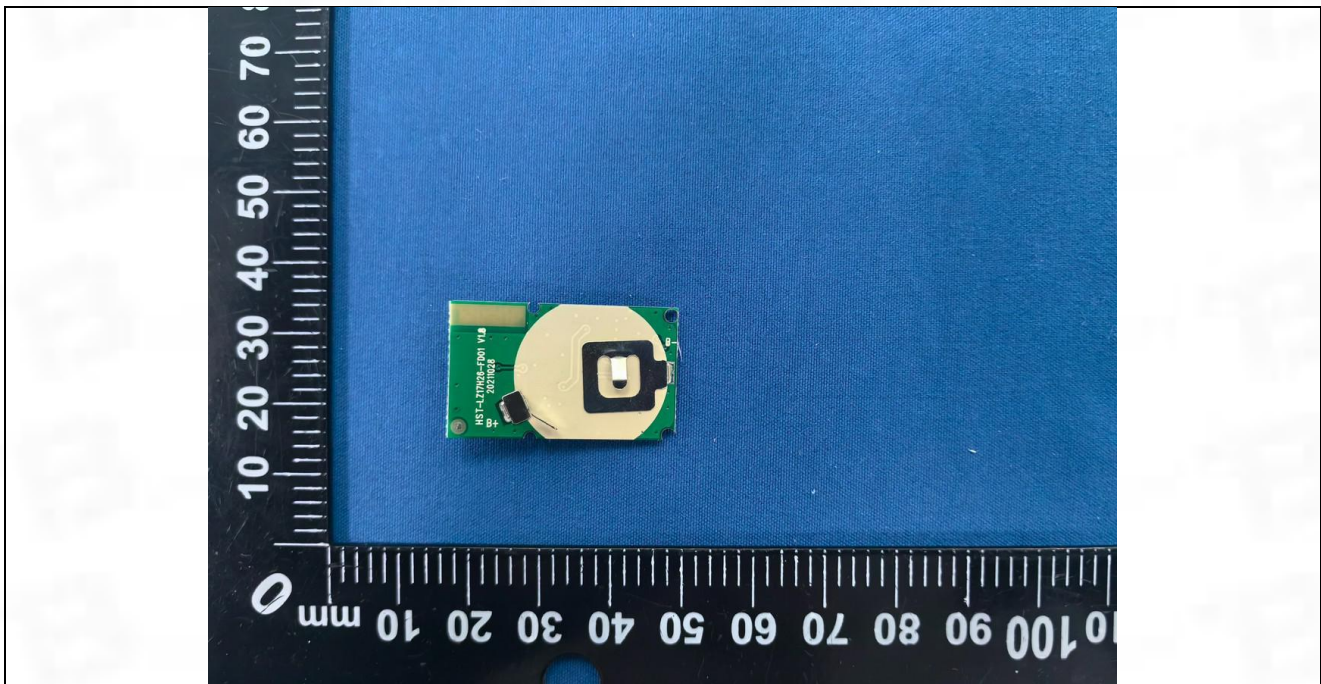
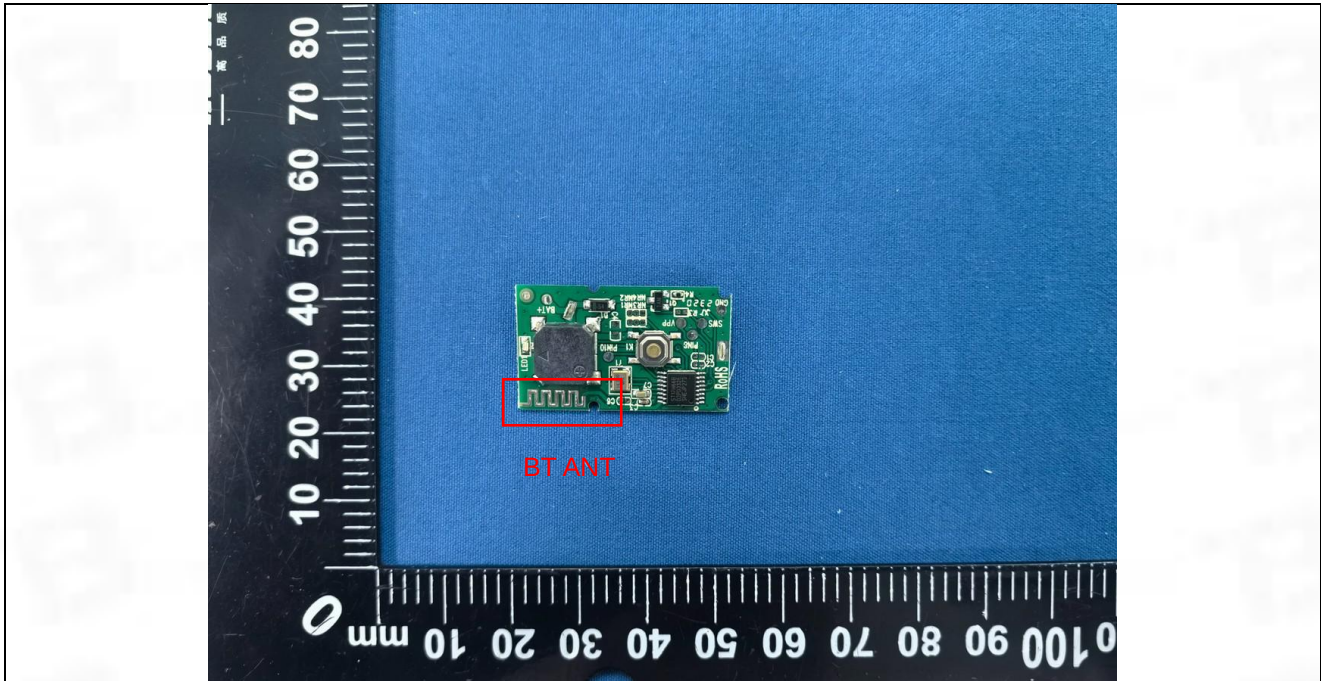

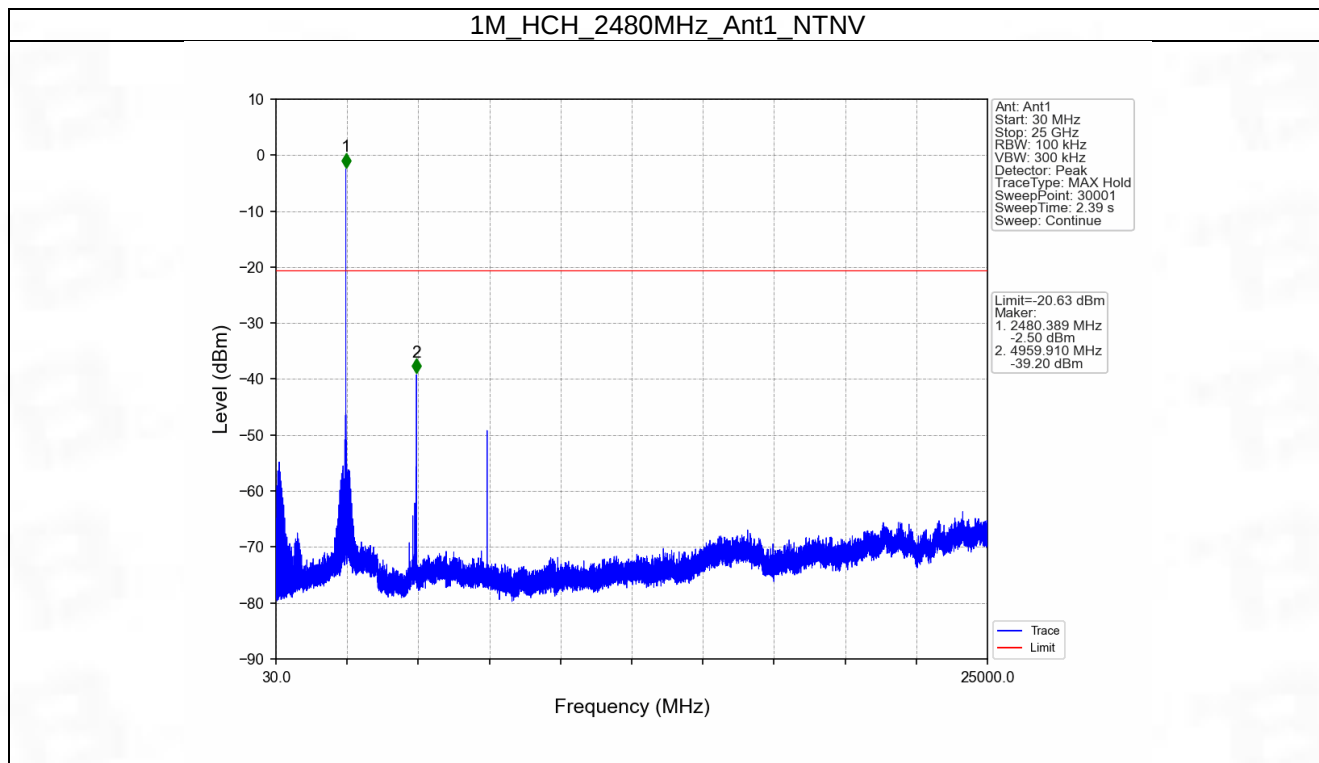


1M_MCH_2440MHz_Ant1_NTNV
