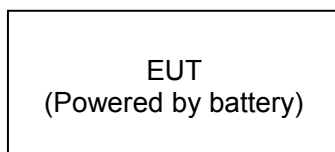

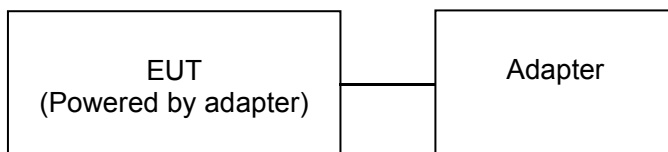

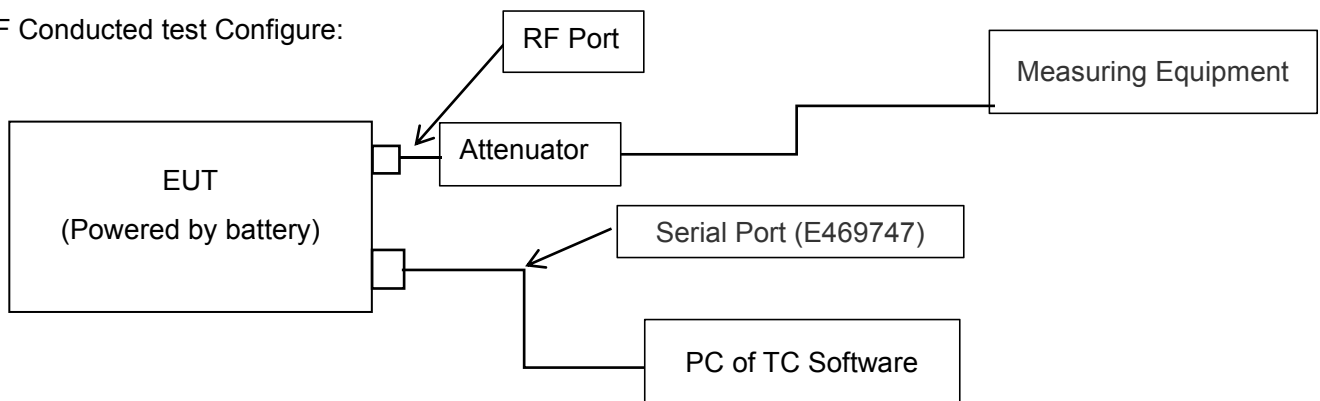
Radiated Emission Configure:

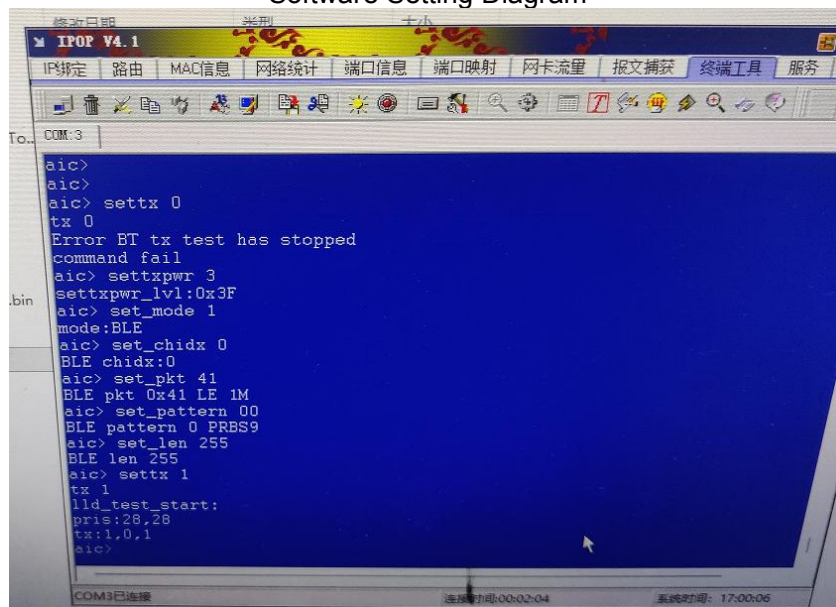

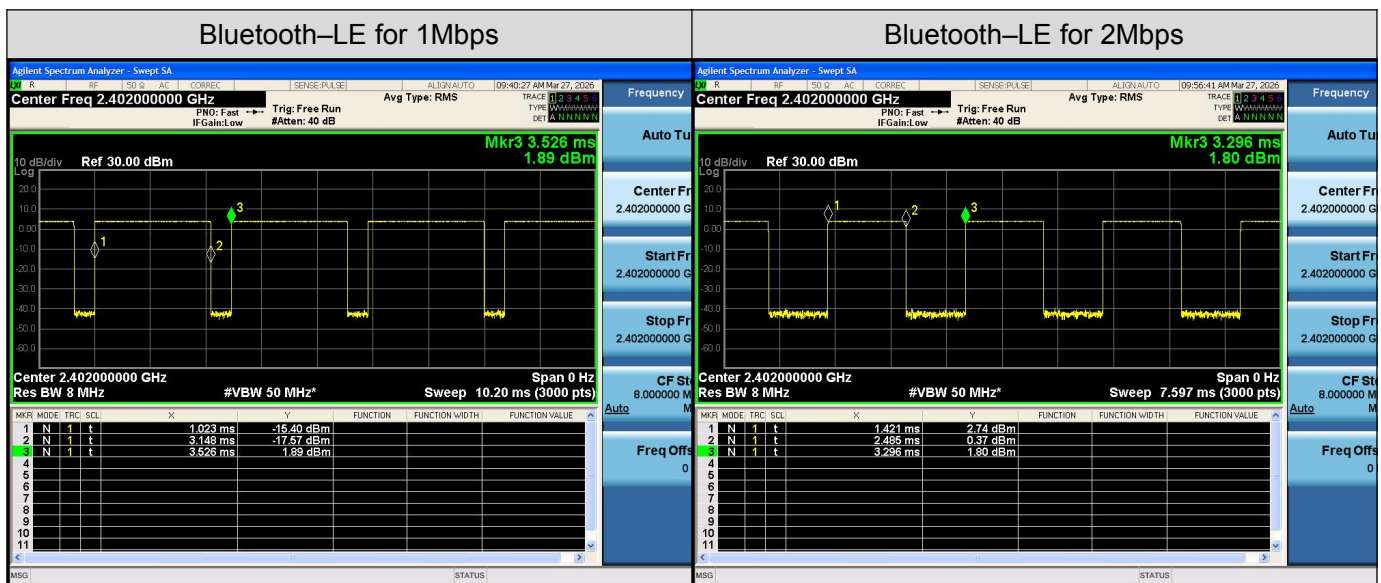
6. Duty Cycle Measurement

The maximum achievable duty cycles for all modes were determined based on measurements performed on a spectrum analyzer in zero-span mode with RBW = 8MHz, VBW = 50MHz, and detector = Peak. 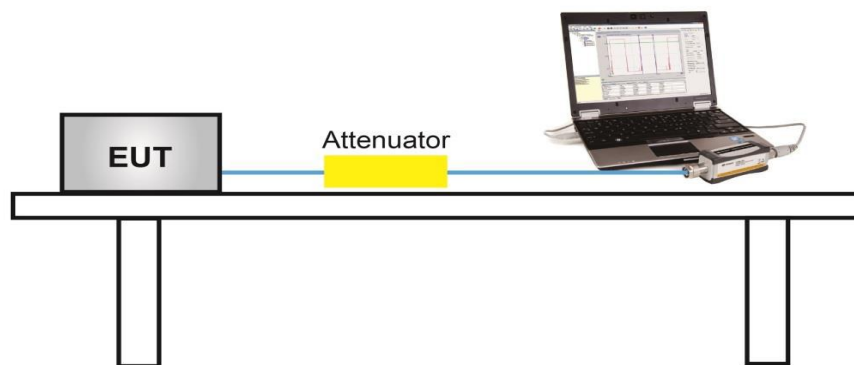

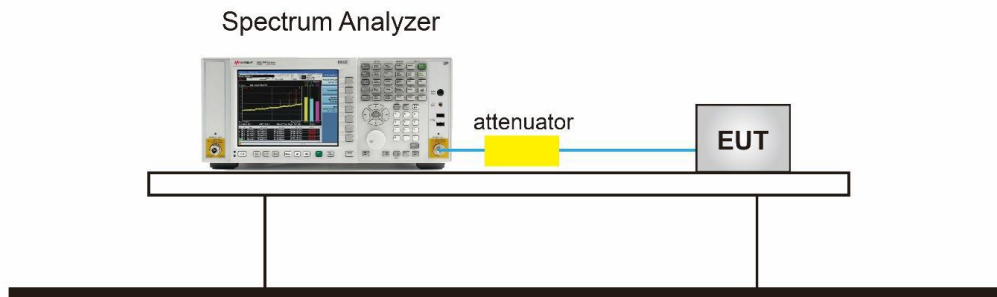

Test Graphs of Conducted Output Power

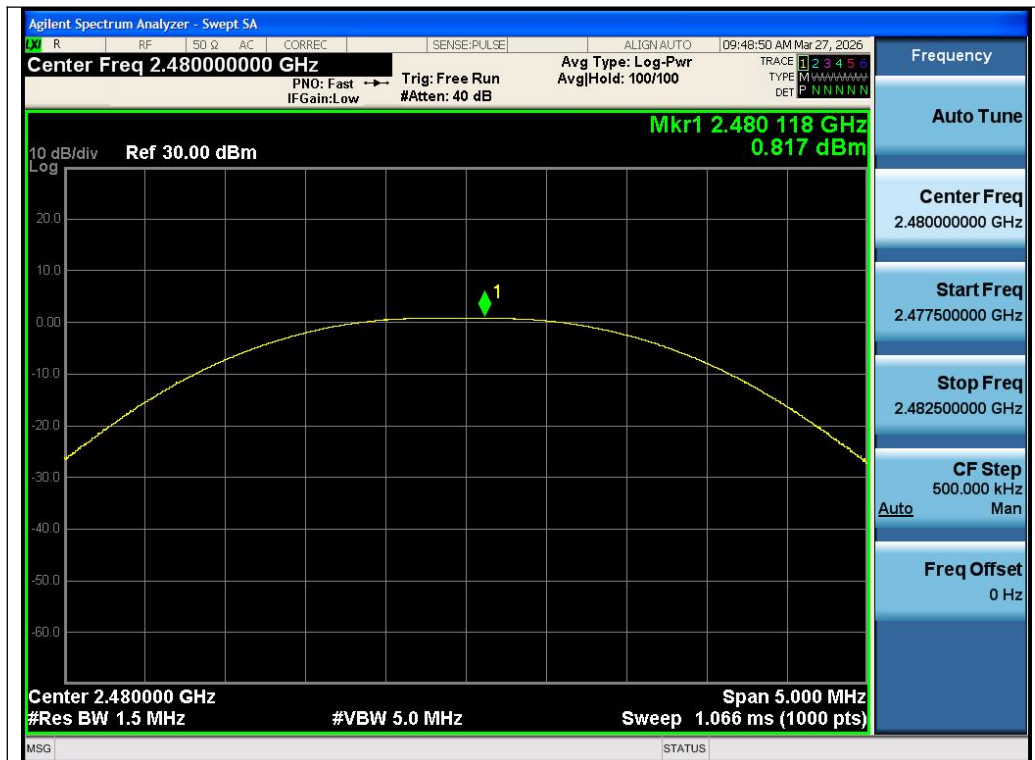


Test_Graph_LE1M_ANT1_2402_1Mbps_Peak Power

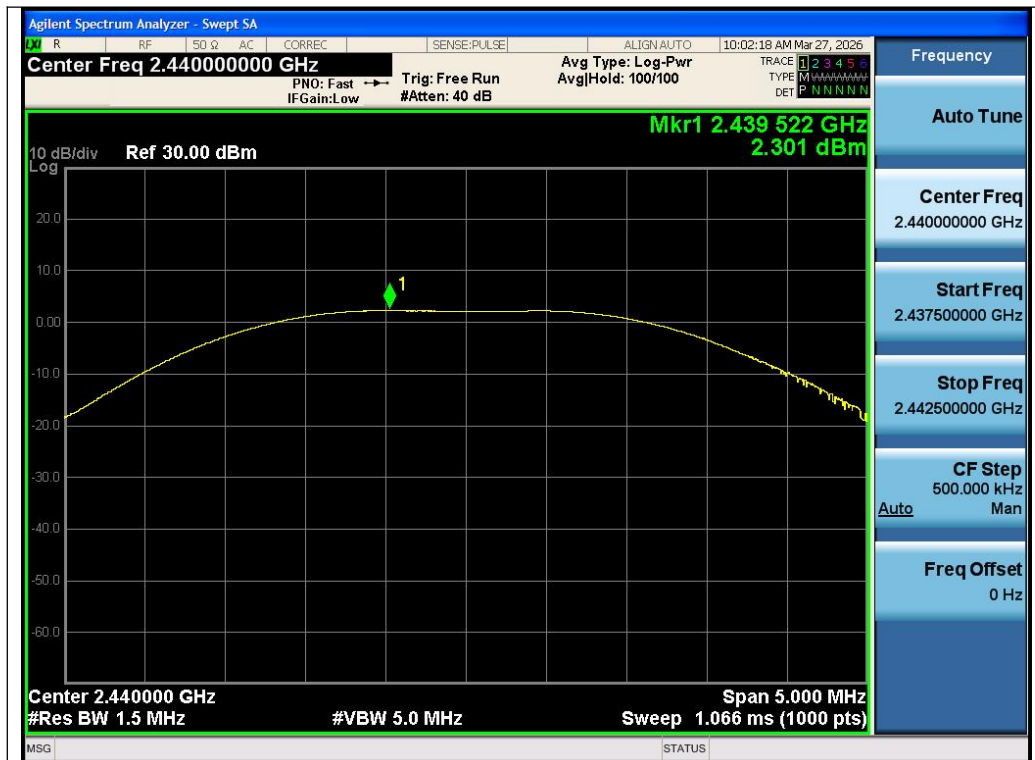


Test_Graph_LE1M_ANT1_2480_1Mbps_Peak Power

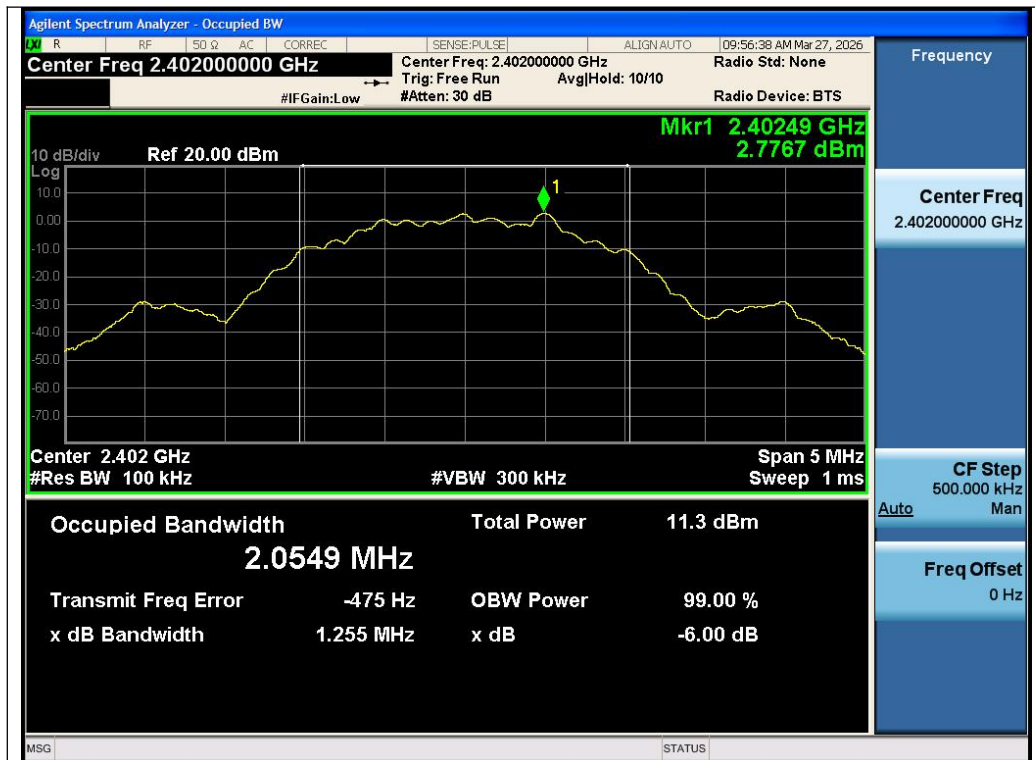


Test_Graph_LE1M_ANT1_2440_1Mbps_DTSBW

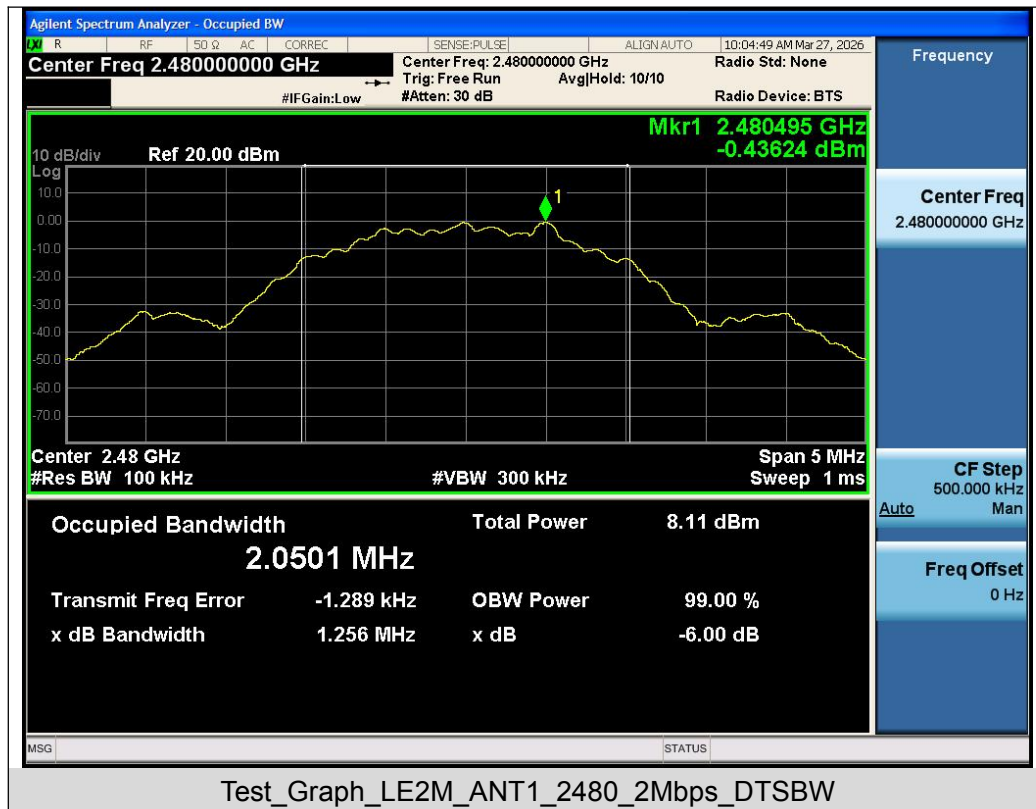

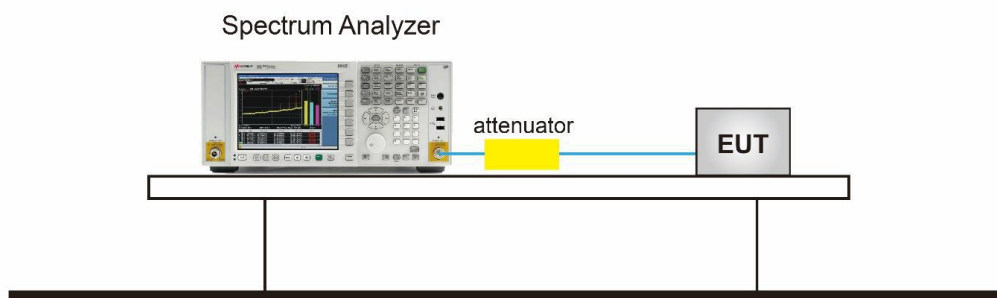

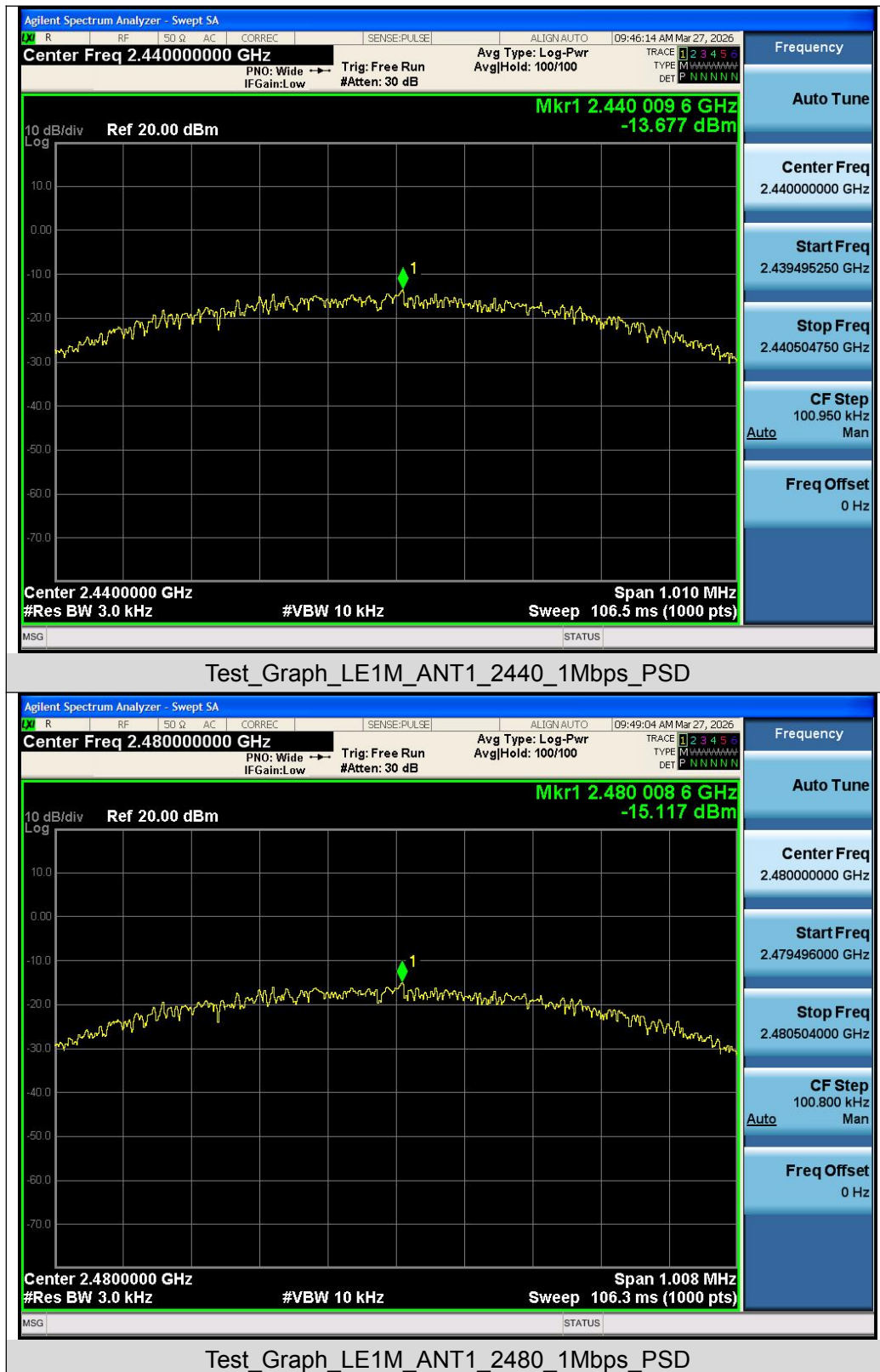

Test Graphs of Conducted Output Power Spectral Density

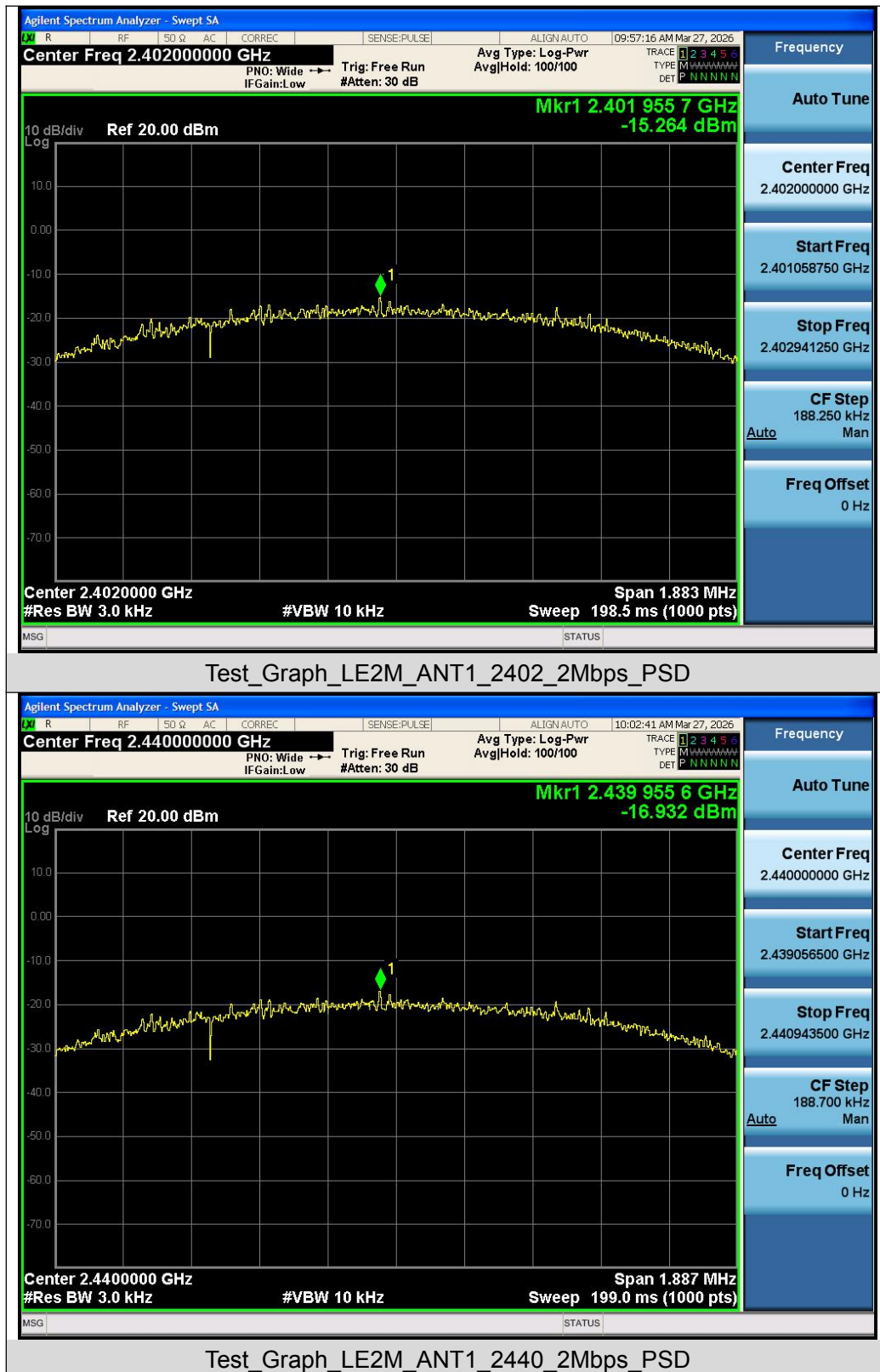

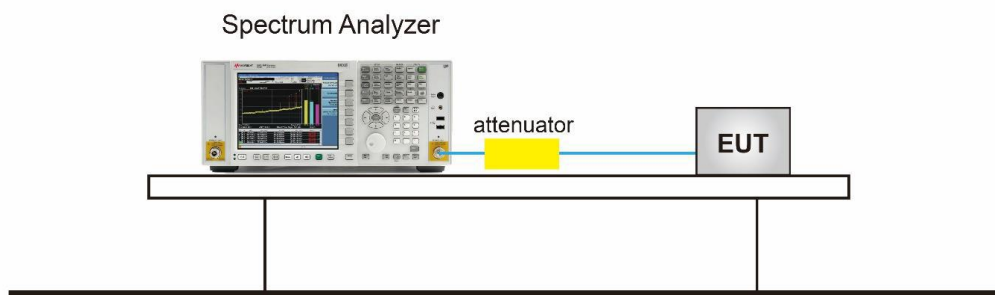

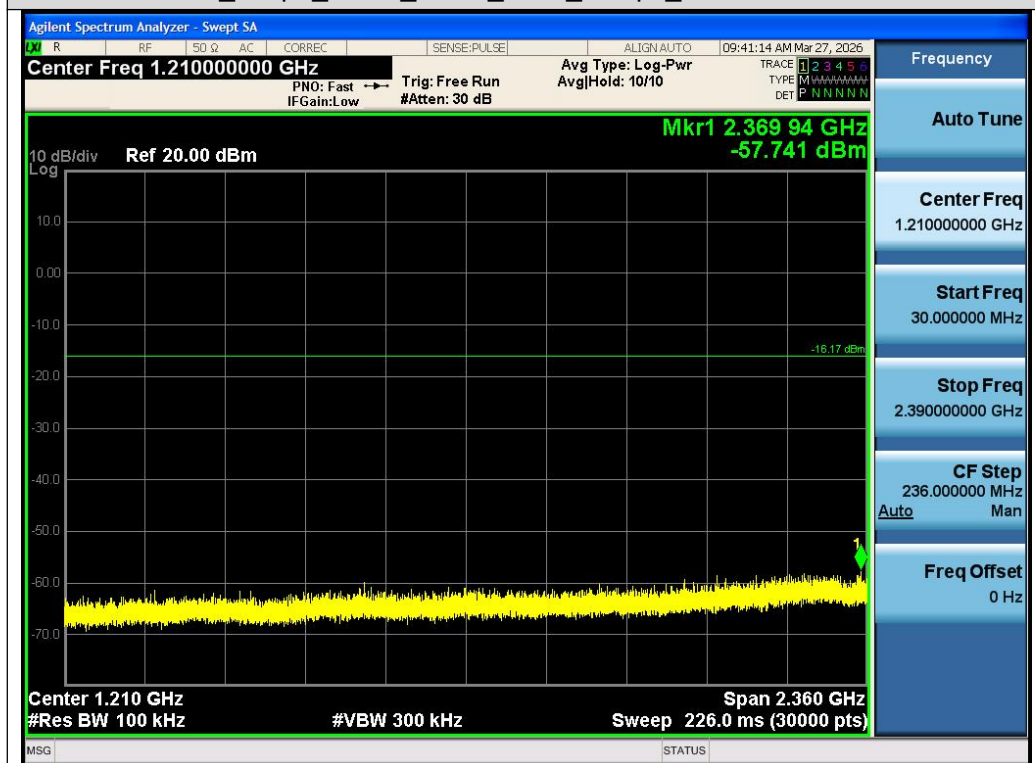

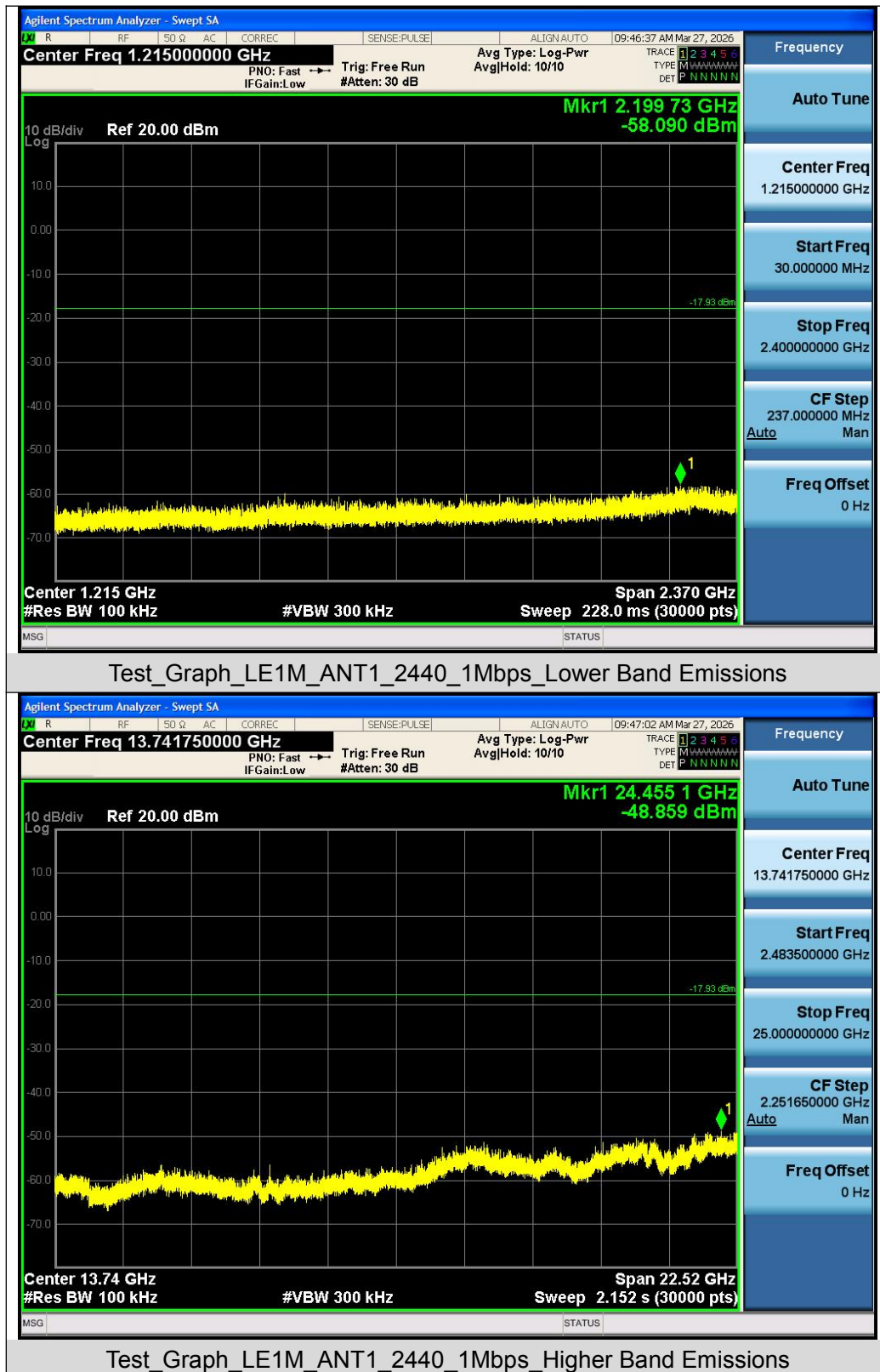


Test_Graph_LE1M_ANT1_2402_1Mbps_Higher Band Emissions

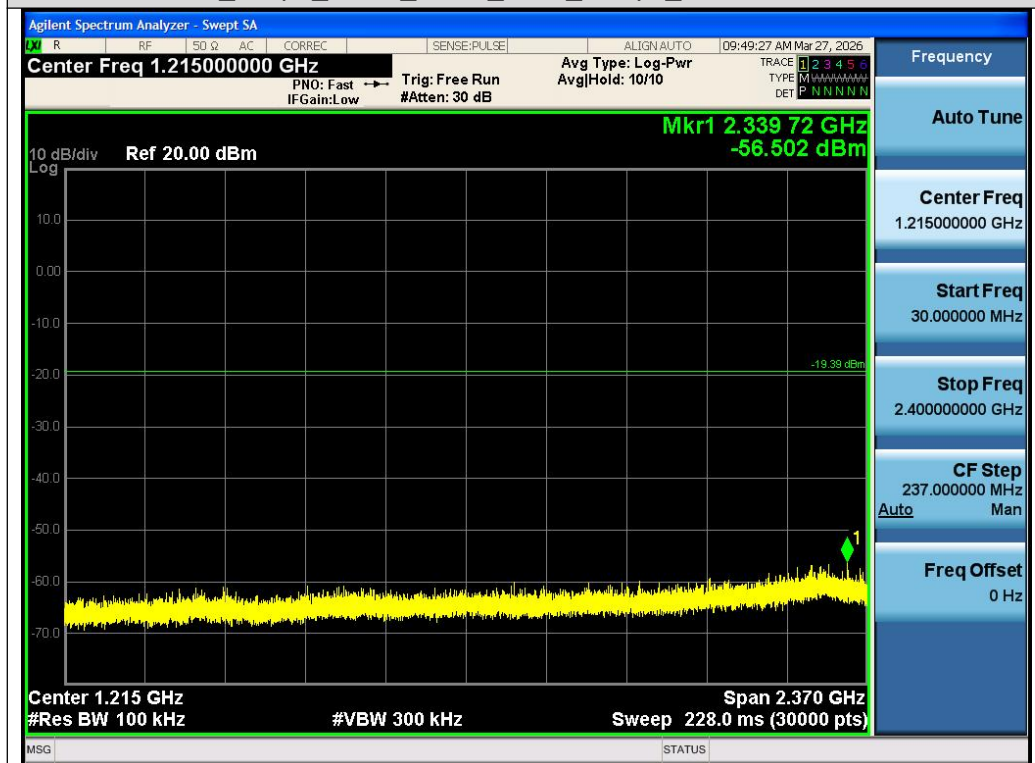
