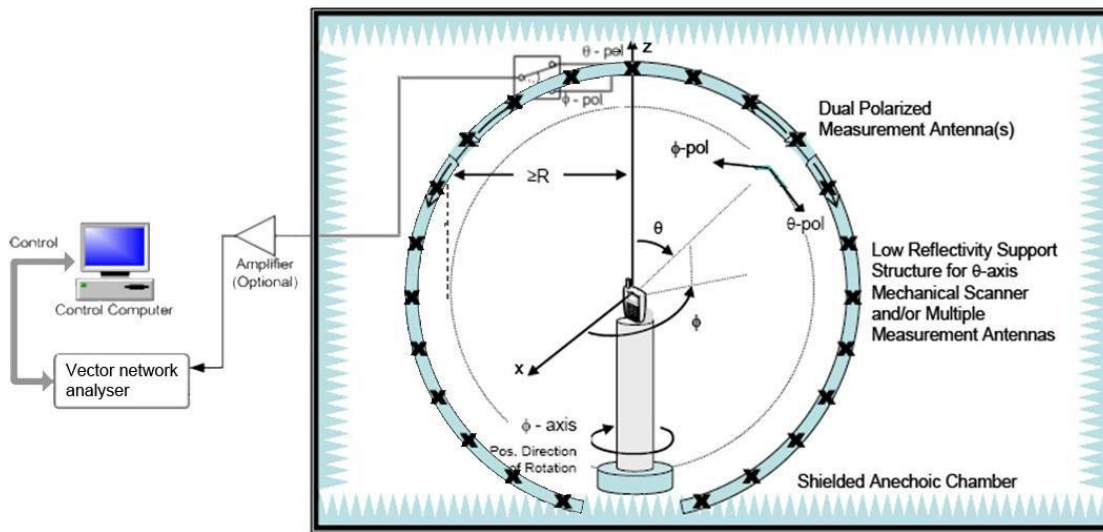

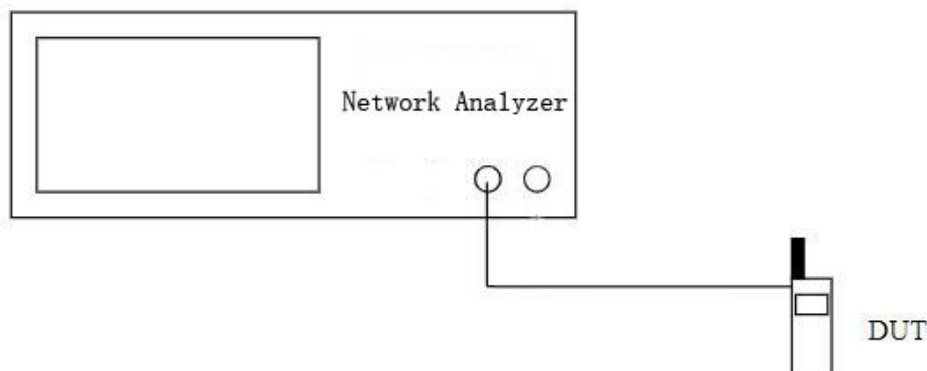

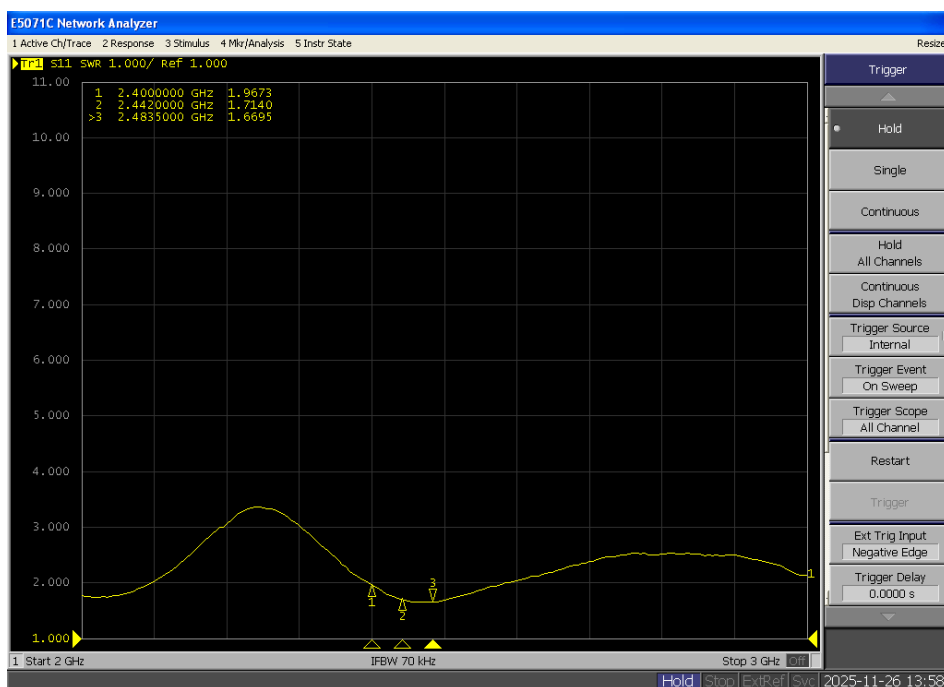

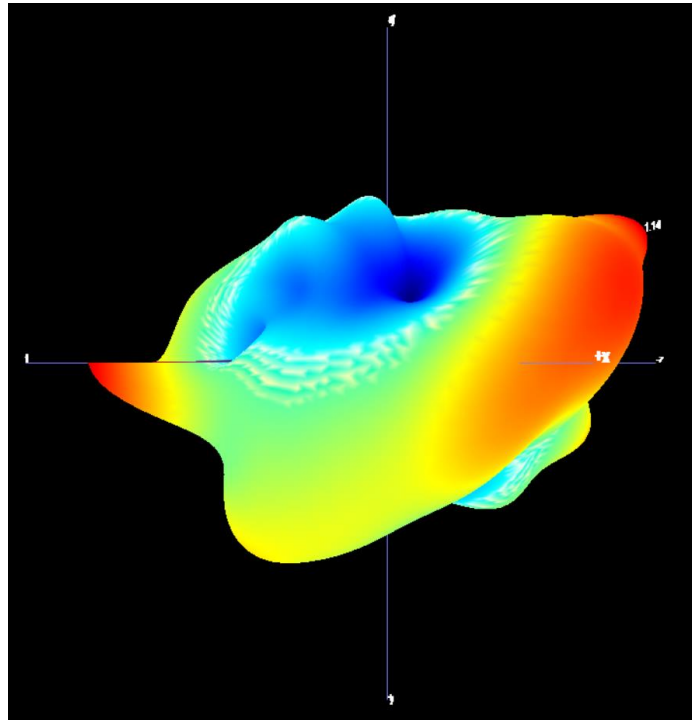

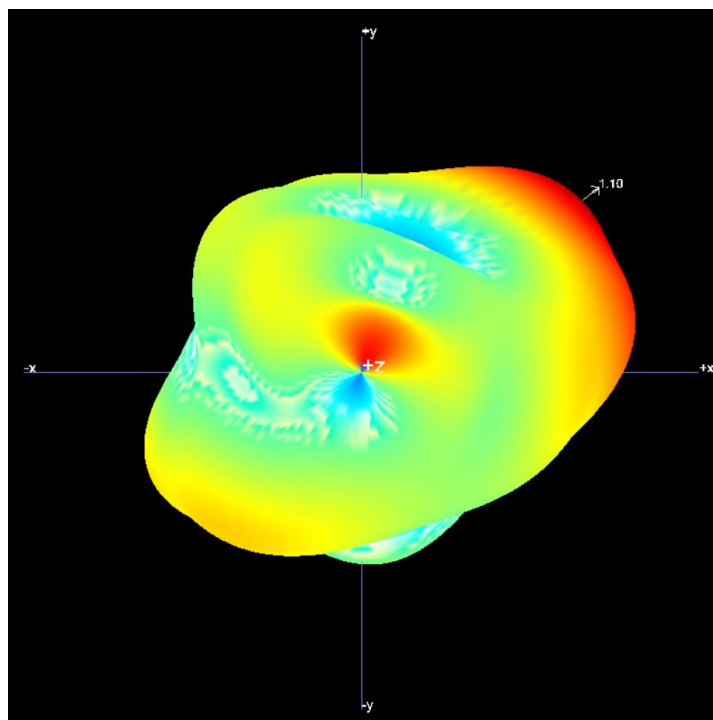

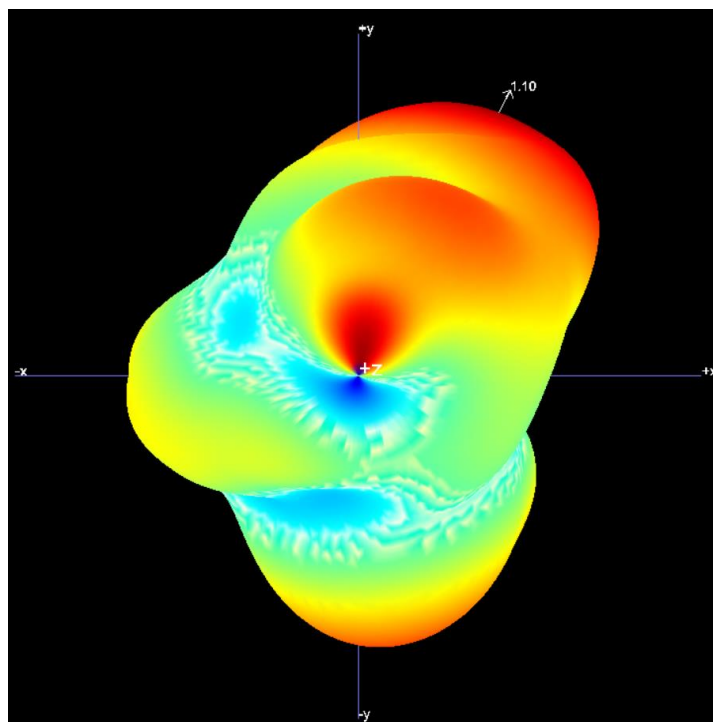
B1.1 3D Pattern for 2400MHz



B1.2 3D Pattern for 2442MHz



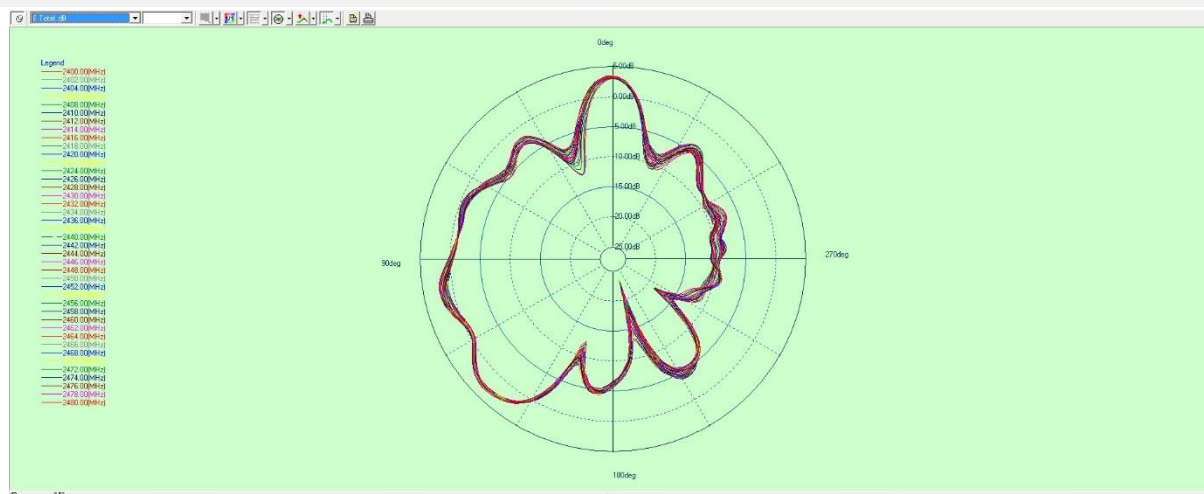
B1.3 3D Pattern for 2483.5MHz



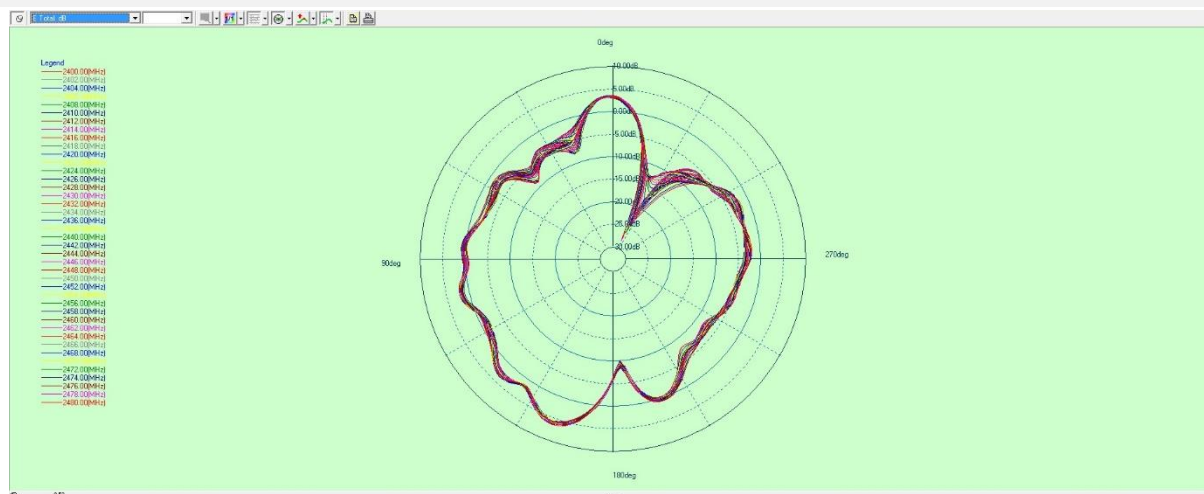
B.2 1D Radiation Pattern

2400-2480 MHz

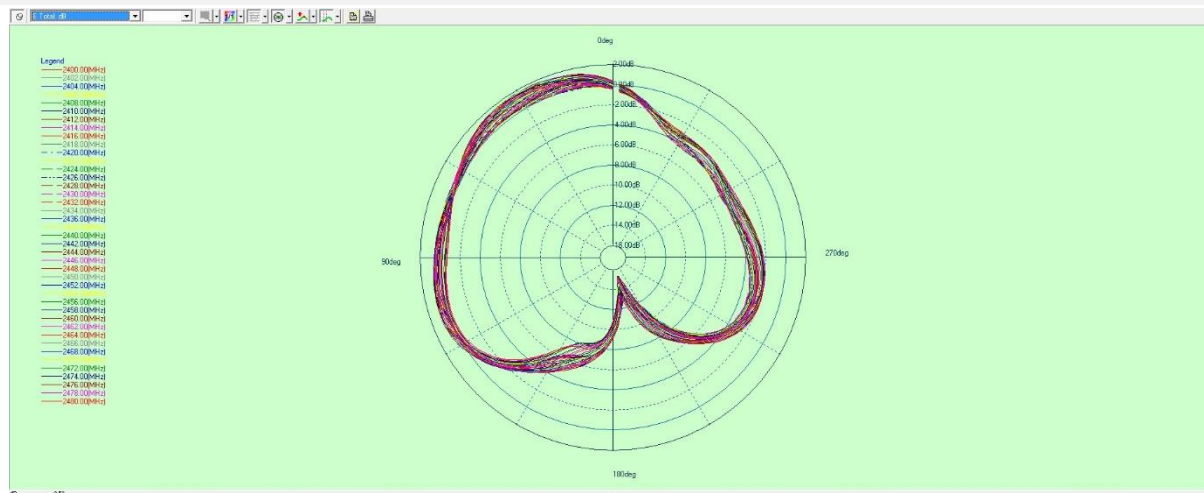
