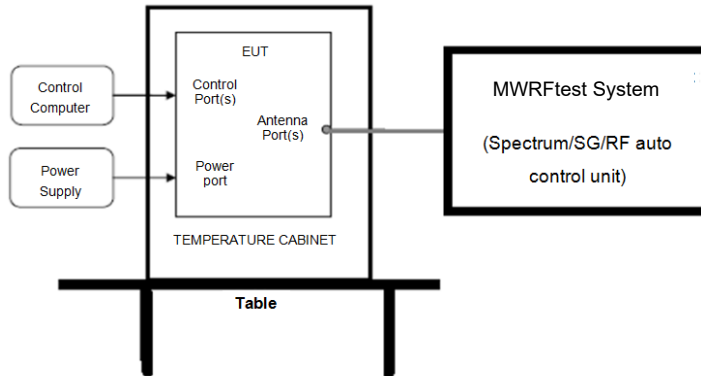

4.2. Limits

Intentional radiators operating under the alternative provisions to the general emission limits, as contained in § 15.217 through 15.257 and in Subpart E of this part, must be designed to ensure that the 20 dB bandwidth of the emission, or whatever bandwidth may otherwise be specified in the specific rule section under which the equipment operates, is contained within the frequency band designated in the rule section under which the equipment is operated.

4.3. Test procedure

(1) Connect EUT's antenna output to spectrum analyzer by RF cable.

(2) 99% Bandwidth set the spectrum analyzer as follows:

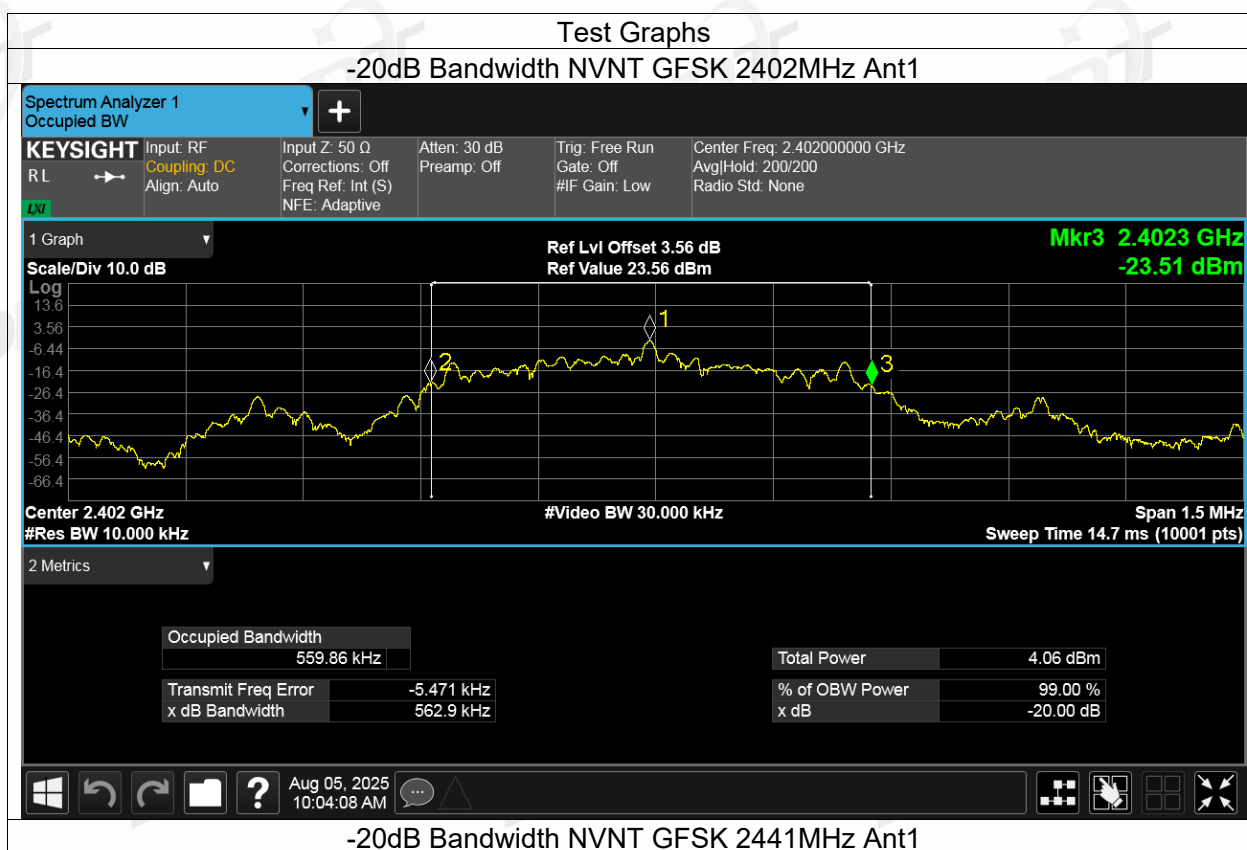

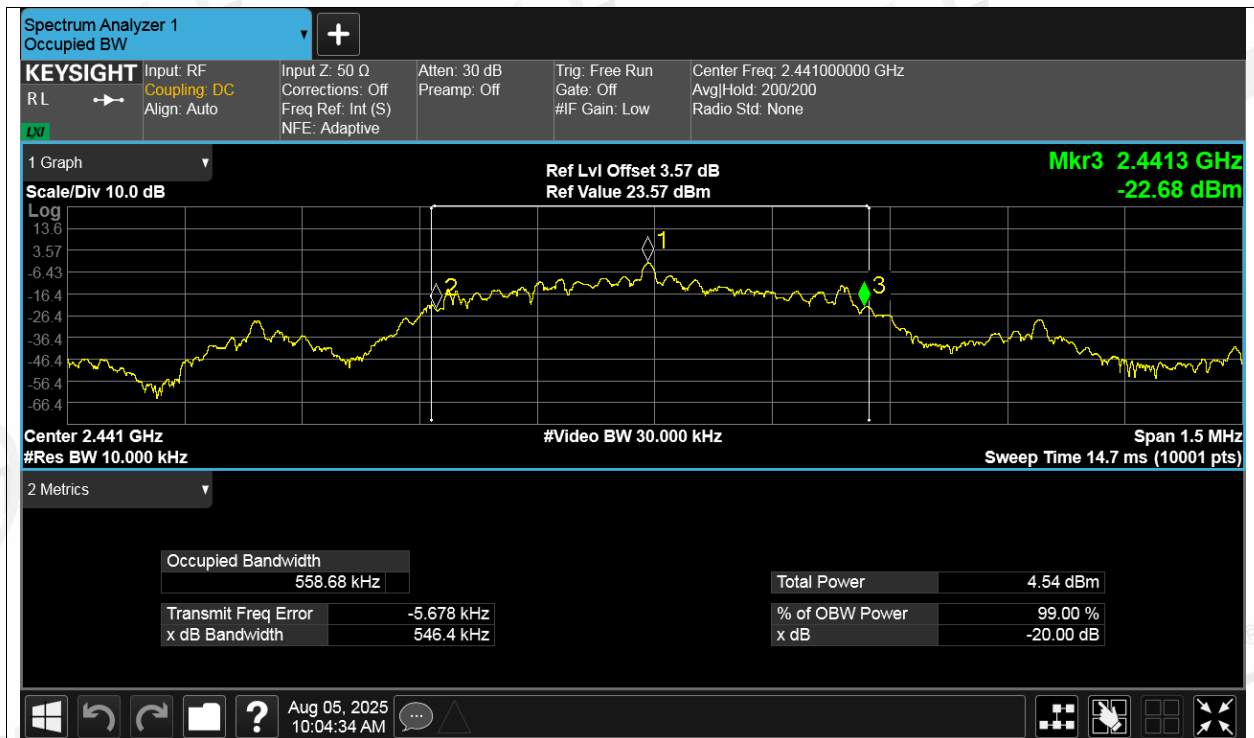

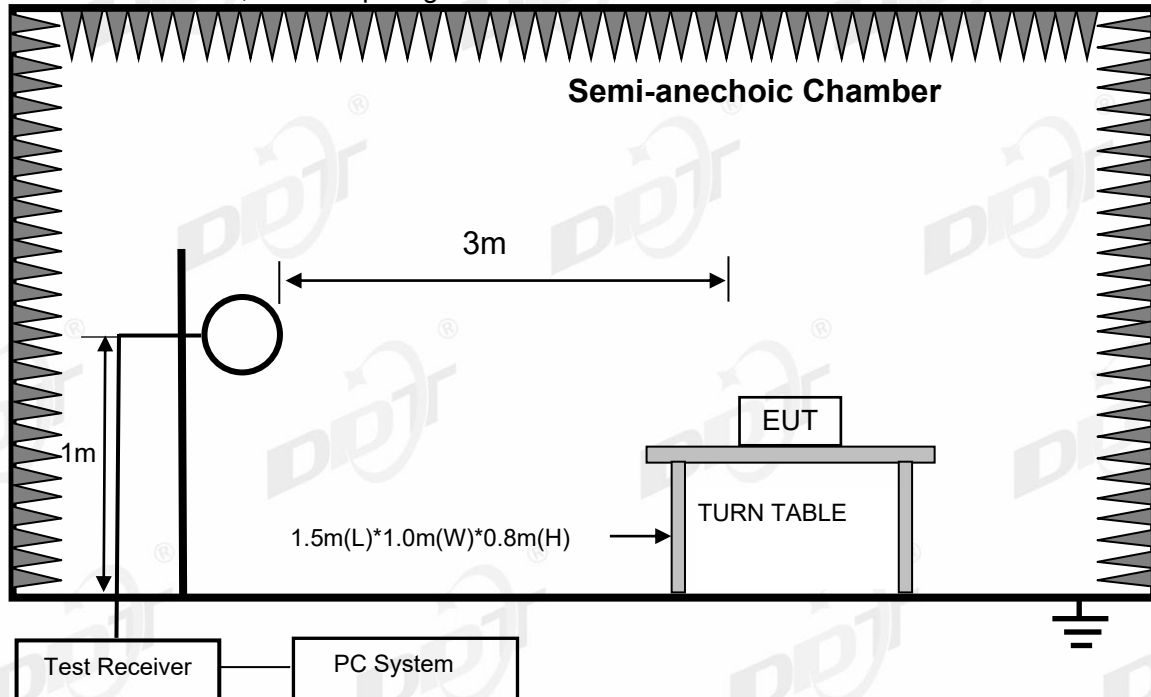
-20dB Bandwidth NVNT GFSK 2480MHz Ant1



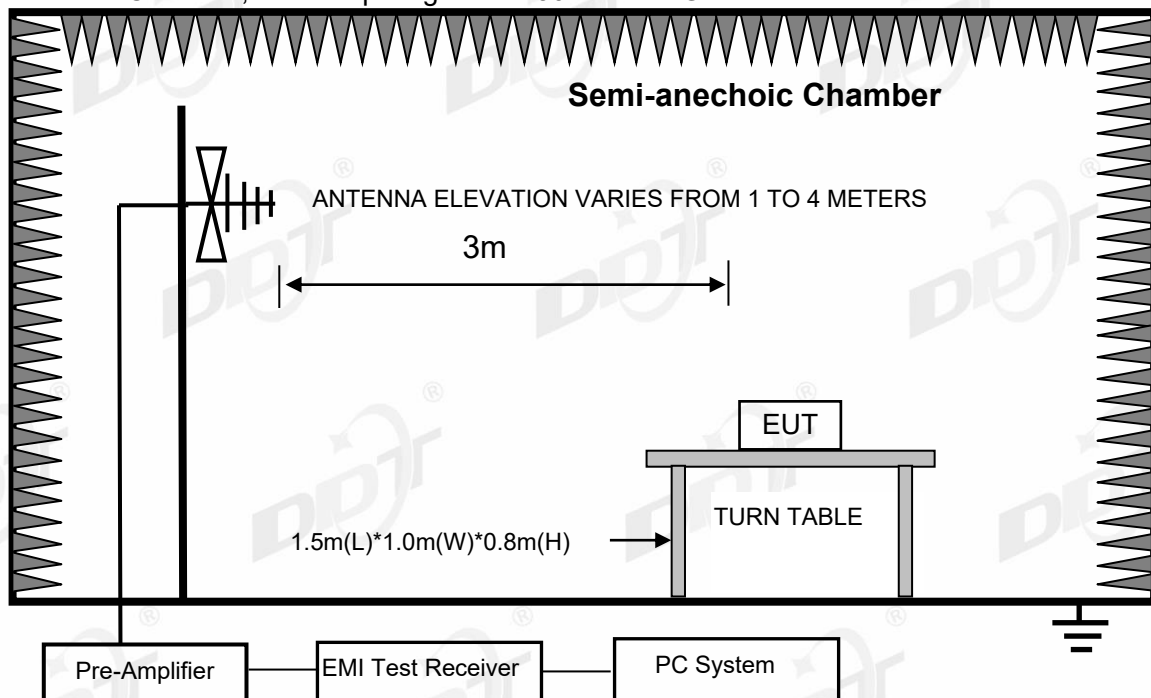

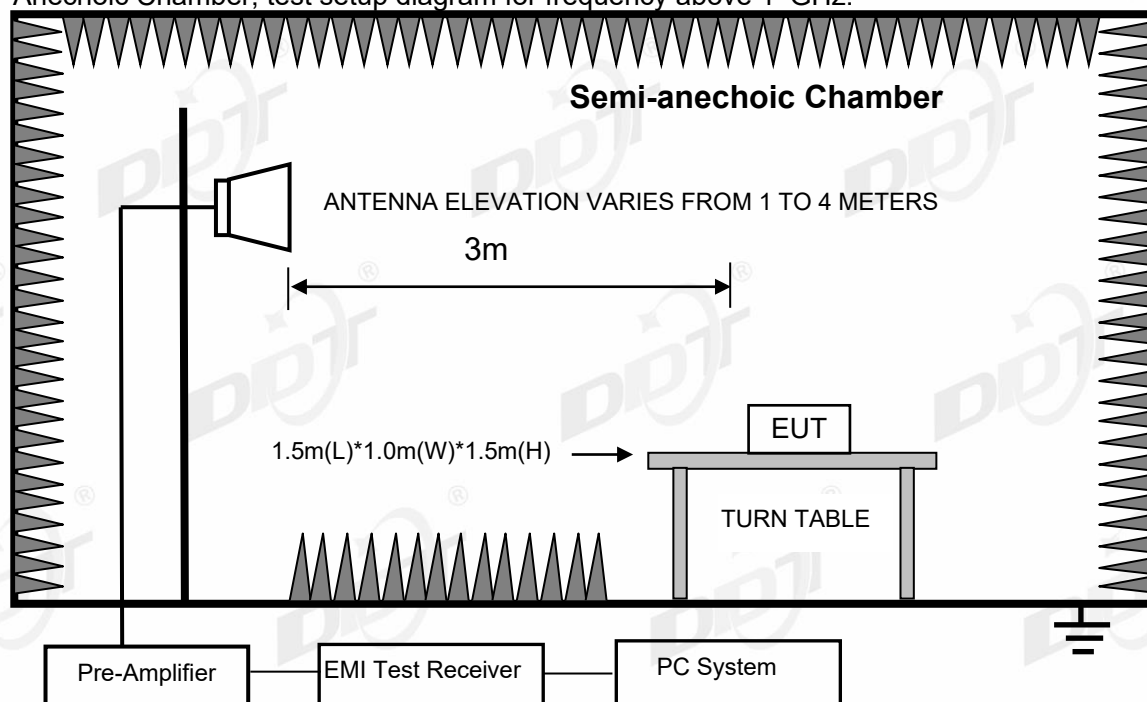
Anechoic Chamber, test setup diagram for 9 kHz - 30 MHz:

Note: (1) The emission limits shown in the above table are based on measurements employing a CISPR QP detector except for the frequency bands 9 - 90 kHz, 110 - 490 kHz and above 1000 MHz, radiated emissions limits in these three bands are based on measurements employing an average detector.

(2) At frequencies below 30 MHz, measurement may be performed at a distance closer than that specified, and the limit at closer measurement distance can be extrapolated by below formula:

$$\text{Limit}_{3\text{m}}(\text{dB}\mu\text{V}/\text{m}) = \text{Limit}_{30\text{m}}(\text{dB}\mu\text{V}/\text{m}) + 40\log(30\text{m}/3\text{m})$$

(3) Limit for this EUT

All the emissions appearing within 15.205 restricted frequency bands shall not exceed the limits shown in 15.209, all the other emissions shall be at least 20dB below the fundamental emissions or comply with 15.209 limits.

5.3. Test Procedure

(1) EUT was placed on a non-metallic table, 80 cm above the ground plane inside a semi-anechoic chamber for below 1G and 150 cm above the ground plane inside a fully-anechoic chamber for above 1G.

(2) Test antenna was located on an adjustable mast, the distance from test antenna to EUT and the antenna used as below table.

According ANSI C63.10:2020 clause 6.4.4.2 and 6.5.3, for measurements below 30 MHz, the loop antenna was positioned with its plane vertical from the EUT and rotated about its vertical axis for maximum response at each azimuth position around the EUT. And the loop antenna also is positioned with its plane horizontal at the specified distance from the EUT. The center of the loop is 1 m above the ground. Measurements were made with the antenna positioned in both the horizontal and vertical planes of Polarization, and the measurement antenna was varied from 1 m to 4 m. in height above the reference ground plane to obtain the maximum signal strength.

(3) Below pre-scan procedure was first performed in order to find prominent frequency spectrum radiated emissions from 9 kHz to 25 GHz:

(a) Scanning the peak frequency spectrum with the antenna specified in step (3), and the EUT was rotated 360 degree, the antenna height was varied from 1 m to 4 m (Except loop antenna, it's fixed 1 m above ground.)

(b) Change work frequency or channel of device if practicable.

(c) Change modulation type of device if practicable.

(d) Change power supply range from 85% to 115% of the rated supply voltage

(e) Rotated EUT though three orthogonal axes to determine the attitude of EUT arrangement produces highest emissions.

Spectrum frequency from 9 kHz to 25 GHz (tenth harmonic of fundamental frequency) was investigated, and no any obvious emission were detected from 18 GHz to 25 GHz, so below final test was performed with frequency range from 9 kHz to 18 GHz.

(4) For final emissions measurements at each frequency of interest, the EUT was rotated and the antenna height was varied between 1 m and 4 m in order to maximize the emission. Measurements in both horizontal and vertical polarities were made and the data was recorded. In order to find the maximum emission, the relative positions of equipment and all of the interface cables were changed according to ANSI C63.10:2020 on Radiated Emission test.

(5) The emissions from 9 kHz to 1 GHz were measured based on CISPR QP detector except for the frequency bands 9 - 90 kHz, 110 - 490 kHz, for emissions from 9 kHz - 90 kHz, 110 kHz - 490 kHz and above 1 GHz were measured based on average detector, for emissions above 1 GHz, peak emissions also be measured and need comply with Peak limit.

(6) The emissions from 9 kHz to 1 GHz, QP or average values were measured with EMI receiver with below RBW.

- (7) For emissions above 1GHz, both Peak and Average level were measured with Spectrum Analyzer, and the RBW is set at 1 MHz, VBW is set at 3 MHz for Peak measure; According ANSI C63.10:2020 clause 4.1.5.2.3 and 4.1.5.2.5 procedure for average measure.
- (8) X axis, Y axis, Z axis are tested, and worse setup X axis is reported.

5.4. Test result

Pass. (See below detailed test result)

All the emissions except fundamental emission from 9 kHz to 25 GHz were comply with 15.209 limits.

Note1: For emissions below 1 GHz and above 18 GHz, according exploratory explorer test, when change Tx mode and channel, have no distinct influence on emissions level, so for emissions below 1 GHz, the final test was only performed with EUT working in GFSK Ant1 2402MHz transmission mode.

Note 2: Scan with all modes, the worst case was recorded in this report.

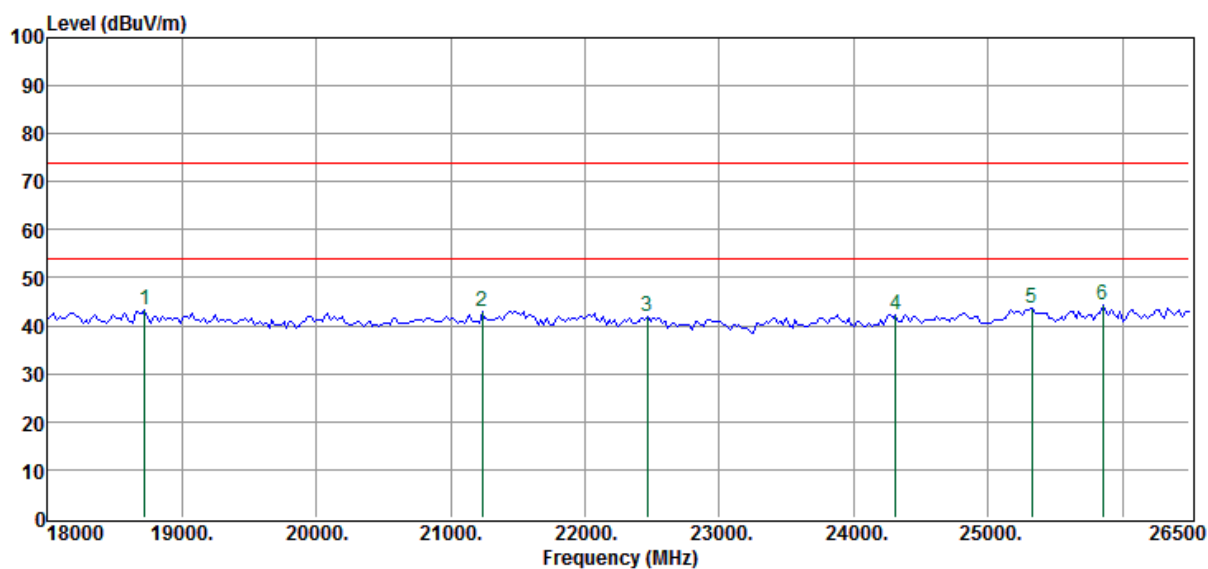

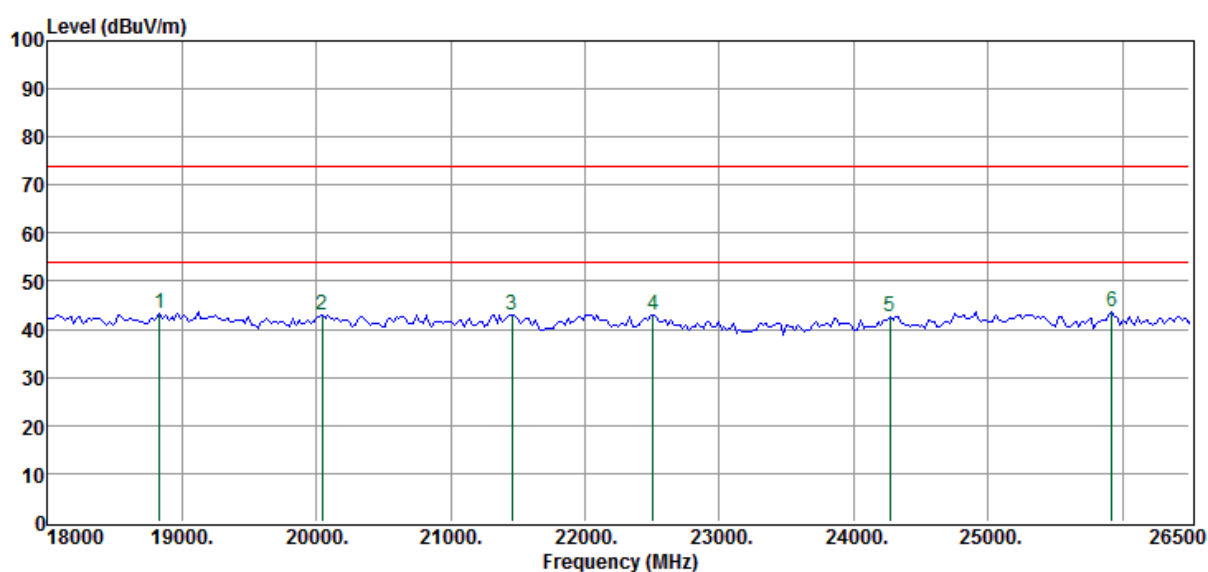

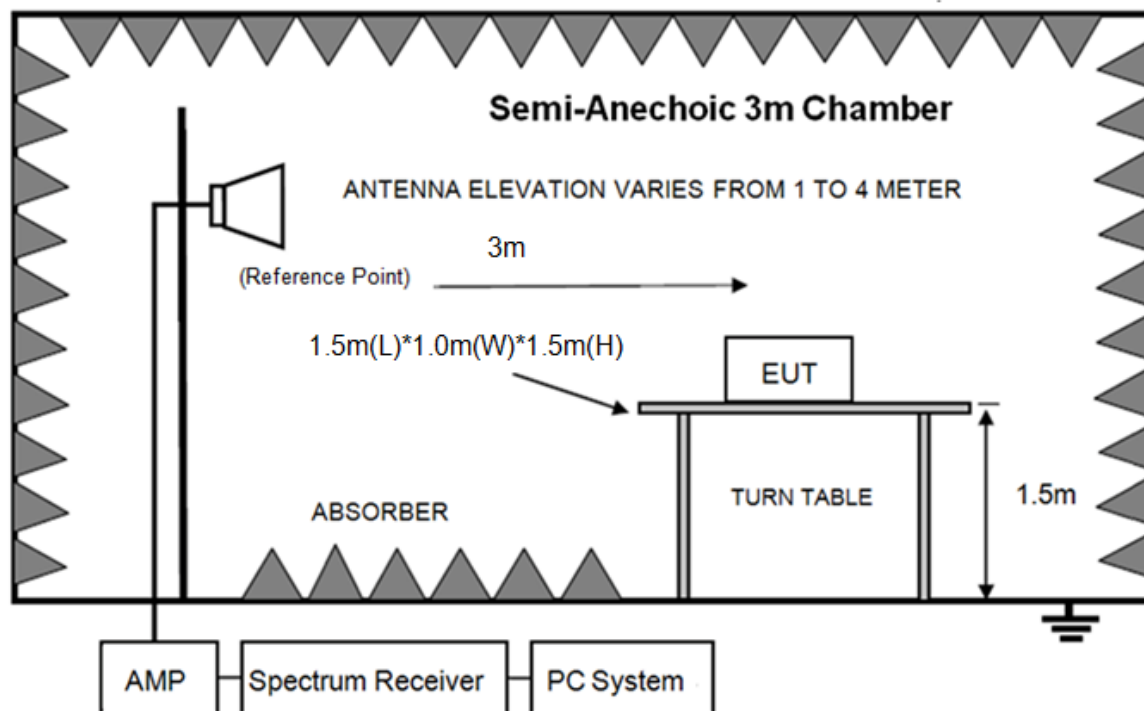

All the lower and upper band-edges emissions appearing within 2310 MHz to 2390 MHz and 2483.5 MHz to 2500 MHz restricted frequency bands shall not exceed the limits shown in 15.209, all the other emissions radiated outside of the specified frequency bands, except for harmonics, shall be attenuated by at least 50 dB below the level of the fundamental or to the general radiated emission limits in §15.209, whichever is the lesser attenuation.

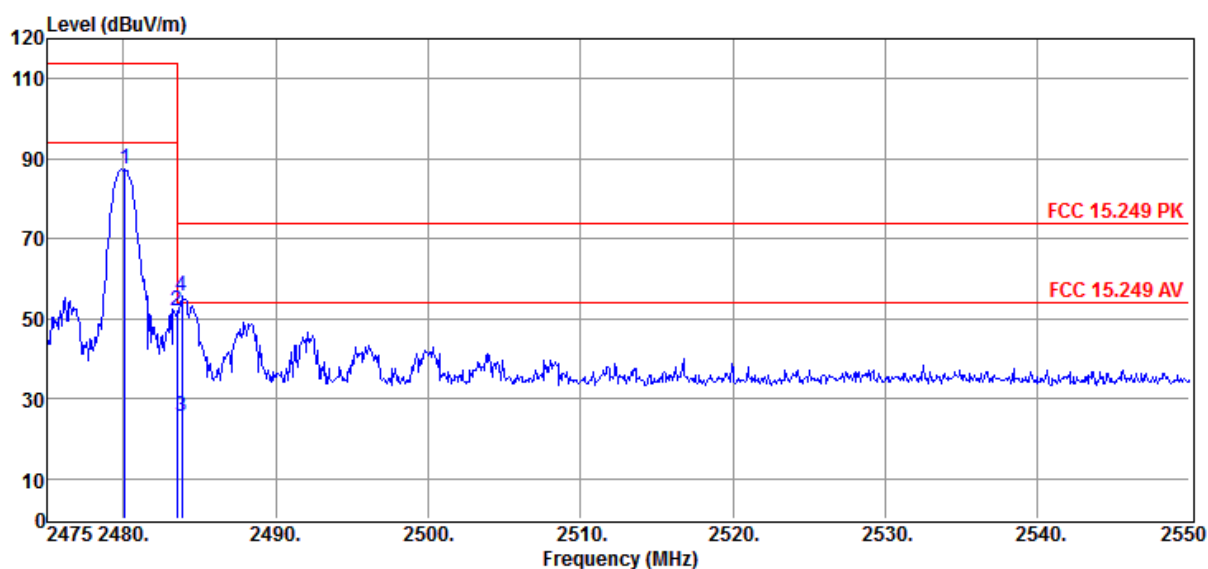

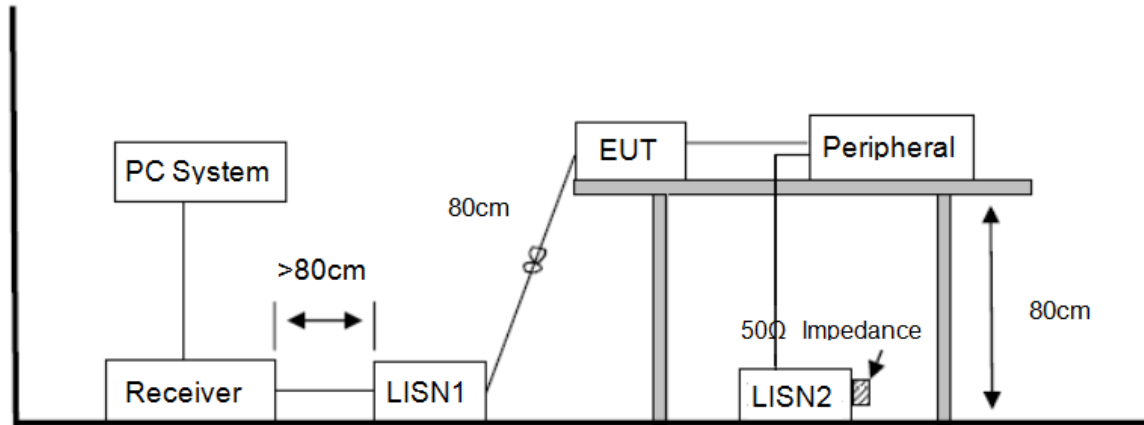

7.3. Test procedure

The EUT and Support equipment, if needed, were put placed on a non-metallic table, 80 cm above the ground plane.

Configuration EUT to simulate typical usage as described in clause 2.4 and test equipment as described in clause 3.0 of this report.

All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10.

All support equipment power received from a second LISN.

Emissions were measured on each current carrying line of the EUT using an EMI Test Receiver connected to the LISN powering the EUT.

The Receiver scanned from 150 kHz to 30 MHz for emissions in each of the test modes.

During the above scans, the emissions were maximized by cable manipulation.

The test mode(s) described in clause 2.4 were scanned during the preliminary test.

After the preliminary scan, we found the test mode producing the highest emission level.

The EUT configuration and worse cable configuration of the above highest emission levels were recorded for reference of the final test.

EUT and support equipment were set up on the test bench as per the configuration with highest emission level in the preliminary test.

A scan was taken on both power lines, Neutral and Line, recording at least the six highest emissions.

Emission frequency and amplitude were recorded into a computer in which correction factors were used to calculate the emission level and compare reading to the applicable limit.

The test data of the worst-case condition(s) was recorded.

The bandwidth of test receiver is set at 9 kHz.
