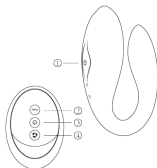

- ① Power button(on/off)/Frequency change button (Product)
- ② Vibration mode
- ③ Power button(on/off) (Remote control)
- ④ One-button orgasm mode

Operation guide:

Single Control Mode Functions:

- ◆ Press and hold ① button for 2 seconds: The dual motors will vibrate once, the indicator light will turn on, and the device will enter standby state.
- ◆ Press ① button: The two motors will start vibrating in sync (the indicator light will turn off), press ① button again to switch to the second vibration frequency, with a total of 10 vibration frequencies cycling in sequence..
- ◆ Press and hold ① button for 2 seconds to turn off the product, and the motors will stop vibrating.

Remote Control Mode Functions:

- ◆ Press and hold the remote control ③ button for 2 seconds: the remote control mode will be activated and the indicator light will turn on.
- ◆ Press the ④ button: The one-button orgasm mode will be activated (the strongest third gear). Press the ④ button again: The one-button orgasm mode will be deactivated, and the indicator light will turn off.
- ◆ Press ② button: The two motors will start vibrating in sync (the indicator light will turn on), press ② button again to switch to the second vibration frequency, with a total of 10 vibration frequencies cycling in sequence..
- ◆ Press and hold ② button for 1 second: The dual motors will stop vibrating, and the indicator light will turn off.
- ◆ Press and hold the ③ button for 2 seconds: The remote control mode will be deactivated, and the indicator light will turn off. The product indicator light will turn on, entering standby state.

Precautions:

- ◆ Charge the product before use.
- ◆ Please disinfect the product before each use with warm water and antibacterial soap, then gently dry it with a towel or soft cloth.
- ◆ Do not use massage oil, hand cream, cleaning agents, gasoline, or acetone as a lubricant.

Cleaning instructions:

- ◆ After use, due to the presence of a large amount of secretions and lubricant residue, if not cleaned for a long time, bacteria can easily breed. Please clean it as soon as possible after use.
- ◆ When cleaning, you can wipe it with warm water and soap. It is recommended to use a special cleaner for adult toys, disinfectant, or 75° alcohol for disinfection. However, long-term use of alcohol is not recommended, as it can corrode the product's surface and accelerate its aging.
- ◆ Store the product in a dust-free place and avoid contact with items of other materials.
