1.8. DESCRIPTION OF TEST MODES

System Test Configuration:

For emissions testing, the equipment under test (EUT) setup to transmit continuously to simplify the measurement methodology. Care was taken to ensure proper power supply voltages during testing. During testing, radiated emission were performed with the EUT set to transmit at the channel with highest output power as worst-case scenario. It was powered by a 3.85Vdc battery. Only the worst case data were recorded in this test report.

Pre-Scan has been conducted to determine the worst-case mode from all possible combinations between available modulations, data rates, X/Y/Z axis, and antenna ports.

All readings are extrapolated back to the equivalent three meter reading using inverse scaling with distance. Analyzer resolution is 100 kHz or greater for frequencies below 1000MHz. The resolution is 1 MHz or greater for frequencies above 1000MHz. The spurious emissions more than 20 dB below the permissible value are not reported.

Radiated emission measurement were performed from the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower.

4. CONDUCTED OUTPUT POWER AND MAXIMUM ERP/EIRP

4.1. LIMIT

According to FCC section 2.1046(a), for transmitters other than single sideband, independent sideband and controlled carrier radiotelephone, power output shall be measured at the RF output terminals when the transmitter is adjusted in accordance with the tune-up procedure to give the values of current and voltage on the circuit elements specified in FCC section 2.1033(c)(8).

According to FCC section 24.232 (c) for LTE Band 2, Mobile and portable stations are limited to 2 watts E.I.R.P. and the equipment must employ a means for limiting power to the minimum necessary for successful communications.

According to FCC section 27.50 (d)(4) for LTE Band 4/66, Fixed, mobile and portable (hand-held) stations in the 1710-1755MHz band are limited to 1wat E.I.R.P.

According to FCC section 22.913 (a)(2) for LTE Band 5, the E.R.P. of mobile transmitters and auxiliary test transmitters must not exceed 7 watts.

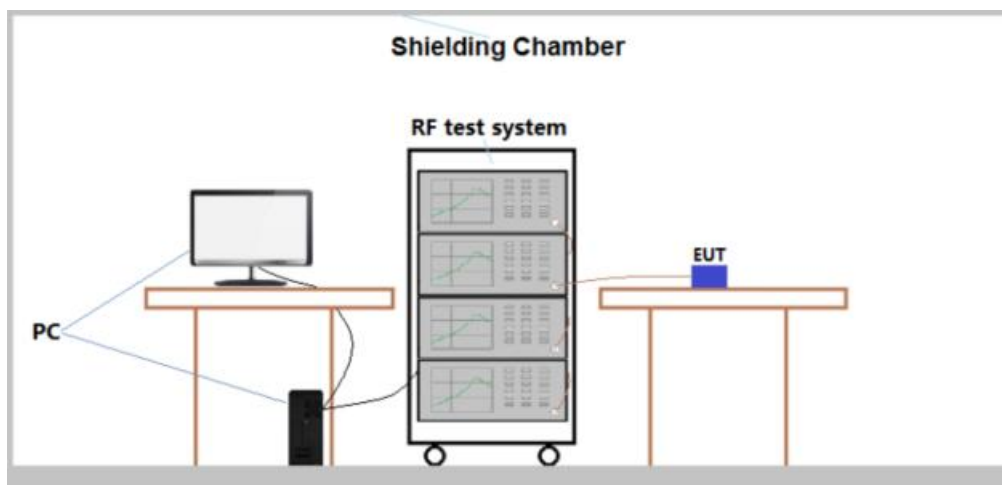
Limit requirement for LTE Band 12/17: For operations in the 600 MHz band and the 698–746 MHz band, the power of any emission outside a licensee's frequency band(s) of operation shall be attenuated below the transmitter power (P) within the licensed band(s) of operation, measured in watts, by at least $43 + 10 \log (P)$ dB. This calculated to be -13dBm.

Limit requirement for LTE Band 13: According to FCC section 27.53(c)(2), any frequency outside the 776-788 MHz band, the power of any emission shall be attenuated outside the band below the transmitter power (P) by at least $43 + 10 \log (P)$ dB in a 100kHz bandwidth. However, in the 100 kHz bands immediately outside and adjacent to the frequency block, a resolution bandwidth of at least 30 kHz may be employed. This calculated to be -13dBm.

According to FCC section 27.50 (a)(3) for LTE Band 40, Mobile and portable stations transmitting in the 2305-2315 MHz band or the 2350-2360 MHz band, the average E.I.R.P. must not exceed 50 mill watts within any 1 megahertz of authorized bandwidth.

According to FCC section 27.50 (h)(2) for LTE Band 7/38/41, Mobile and other user stations. Mobile stations are limited to 2 watts E.I.R.P. All user stations are limited to 2 watts transmitter output power.

For Conducted Output Power Measurement:

Refer to KDB 971168 D01v03r01 & ANSI C63.26-2015 for test method.

The EUT was set up for the maximum power with LTE and link up with simulator (CMW500). Set the EUT to transmit under low, middle and high channel and record the power level.

Note: The cable loss and attenuator loss were offset into measure device as an amplitude offset.

For ERP/EIRP:

According to KDB 412172 D01 Power Approach,

- $ERP \text{ or } EIRP = PT + GT - LC$
- $ERP = EIRP - 2.15$

where

- PT = transmitter output power, expressed in dBW, dBm, or PSD;
- GT = gain of the transmitting antenna, in dBd (ERP) or dBi (EIRP);
- LC = signal attenuation in the connecting cable between the transmitter and antenna, in dB.

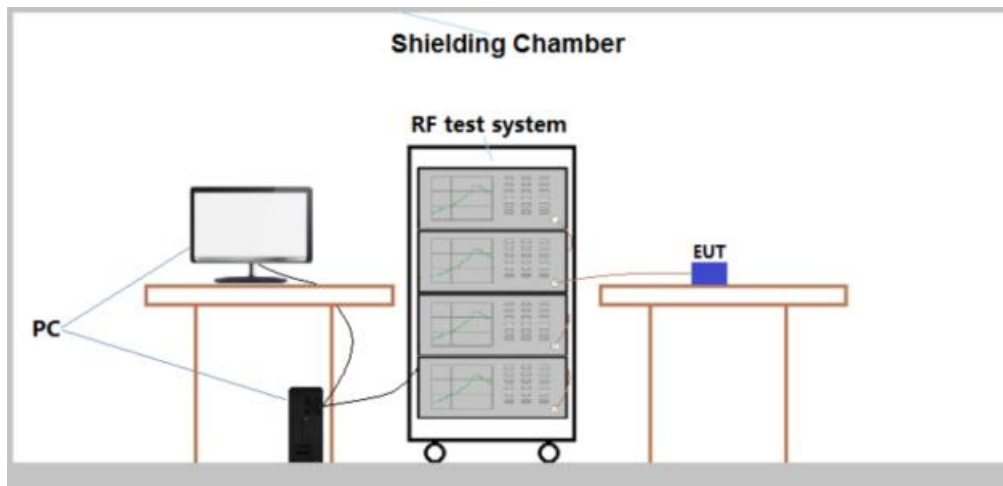

- Record the maximum PAPR level associated with a probability of 0.1 %

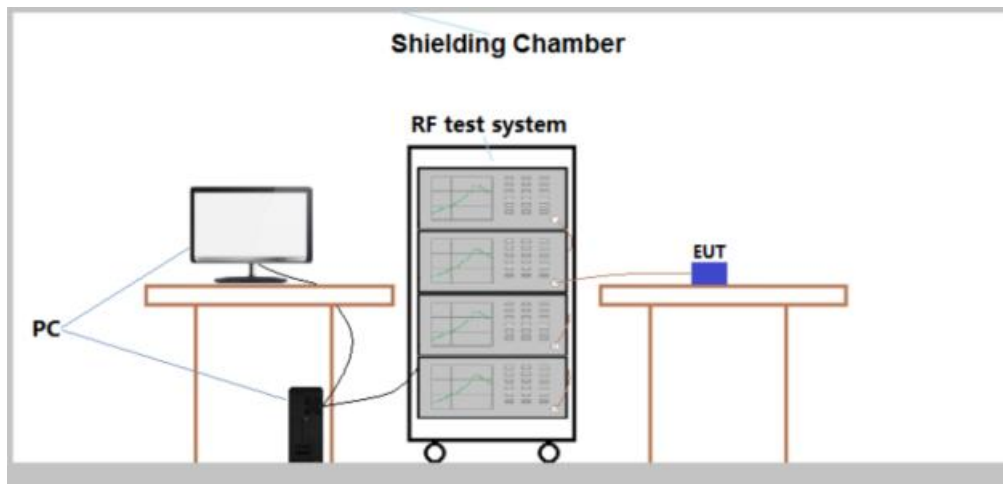

The transmitter output was connected to the RF test system. The occupied bandwidth was measured with the spectrum analyzer at the low, middle and high channel in each band. The 99% and -26dB bandwidths was also measured and recorded.

7. BAND EDGE AT ANTENNA TERMINALS

7.1. LIMIT

Band 2

According to FCC section 24.238(a), for operations in the 1850–1910MHz bands, the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least $43 + 10 \log(P)$ dBm a 1MHz bandwidth. However, in the 1 MHz bands immediately outside and adjacent to the licensee's frequency block, a resolution bandwidth of at least one percent of the emission bandwidth of the fundamental emission of the transmitter may be employed.

Band 4, 66

According to FCC section 27.53(h), for operations in the 1710–1755MHz bands, the power of any emission outside a licensee's frequency block shall be attenuated below the transmitter power (P) by at least $43 + 10 \log_{10}(P)$ dBm 1MHz bandwidth. However, in the 1 MHz bands immediately outside and adjacent to the licensee's frequency block, a resolution bandwidth of at least one percent of the emission bandwidth of the fundamental emission of the transmitter may be employed.

Band 5

According to FCC section 22.917(a), for operations in the 824–849MHz bands, the power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least $43 + 10 \log(P)$ dBm a 100kHz bandwidth. However, in the 1 MHz bands immediately outside and adjacent to the licensee's frequency block, a resolution bandwidth of at least one percent of the emission bandwidth of the fundamental emission of the transmitter may be employed.

Band 12, 17

According to FCC section 27.53(g), for operations in the 600 MHz band and the 698-746 MHz band, the power of any emission outside a licensee's frequency band(s) of operation shall be attenuated below the transmitter power (P) within the licensed band(s) of operation, measured in watts, by at least $43 + 10 \log(P)$ dB. Compliance with this provision is based on the use of measurement instrumentation employing a resolution bandwidth of 100 kilohertz or greater. However, in the 100 kilohertz bands immediately outside and adjacent to a licensee's frequency block, a resolution bandwidth of at least 30 kHz may be employed.

Band 13

According to FCC section 27.53(c)(2), any frequency outside the 776-788 MHz band, the power of any emission shall be attenuated outside the band below the transmitter power (P) by at least $43 + 10 \log(P)$ dB in a 100kHz bandwidth. However, in the 100 kHz bands immediately outside and adjacent to the frequency block, a resolution bandwidth of at least 30 kHz may be employed.

Band 40

According to FCC section 27.53(a) (4), for mobile and portable stations operating in the 2305-2315 MHz and 2350-2360 MHz bands:

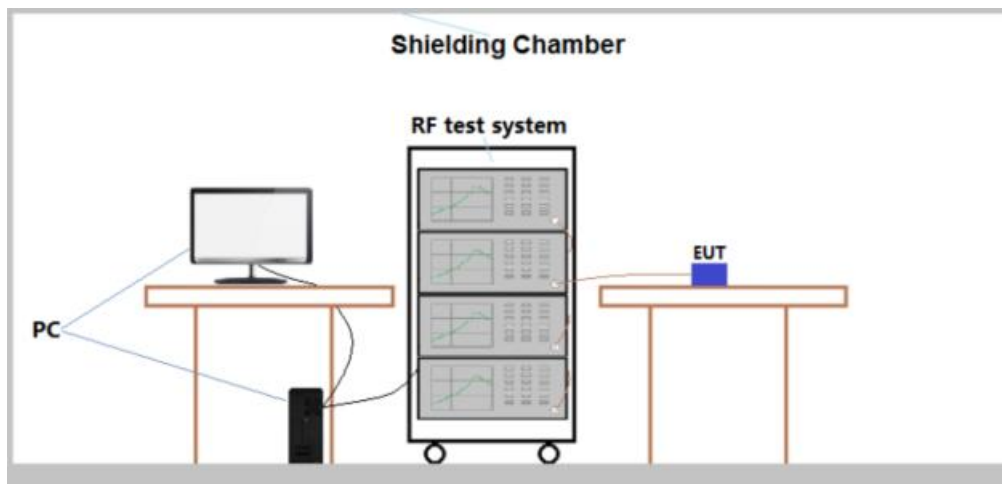
- (i) By a factor of not less than: $43 + 10 \log(P)$ dB on all frequencies between 2305 and 2320 MHz and on all frequencies between 2345 and 2360 MHz that are outside the licensed band(s) of operation, not less than $55 + 10 \log(P)$ dB on all frequencies between 2320 and 2324 MHz and on all frequencies between 2341 and 2345 MHz, not less than $61 + 10 \log(P)$ dB on all frequencies between 2324 and 2328 MHz and on all frequencies between 2337 and 2341 MHz, and not less than $67 + 10 \log(P)$ dB on all frequencies between 2328 and 2337 MHz;
- (ii) By a factor of not less than $43 + 10 \log(P)$ dB on all frequencies between 2300 and 2305 MHz, $55 + 10 \log(P)$ dB on all frequencies between 2296 and 2300 MHz, $61 + 10 \log(P)$ dB on all frequencies between 2292 and 2296 MHz, $67 + 10 \log(P)$ dB on all frequencies between 2288 and 2292 MHz, and $70 + 10 \log(P)$ dB below 2288 MHz;
- (iii) By a factor of not less than $43 + 10 \log(P)$ dB on all frequencies between 2360 and 2365 MHz, and not less than $70 + 10 \log(P)$ dB above 2365 MHz.

Band 7, 38, 41

According to FCC section 27.53(m) (4), for mobile digital stations, the attenuation factor shall be not less than $40 + 10 \log(P)$ dB on all frequencies between the channel edge and 5 megahertz from the channel edge, $43 + 10 \log(P)$ dB on all frequencies between 5 megahertz and X megahertz from the channel edge, and $55 + 10 \log(P)$ dB on all frequencies more than X megahertz from the channel edge, where X is the greater of 6 megahertz or the actual emission bandwidth as defined in paragraph (m)(6) of this section. In addition, the attenuation factor

shall not be less than $43 + 10 \log (P)$ dB on all frequencies between 2490.5 MHz and 2496 MHz and $55 + 10 \log (P)$ dB at or below 2490.5 MHz Mobile Satellite Service licensees operating on frequencies below 2495 MHz may also submit a documented interference complaint against BRS licensees operating on channel BRS Channel 1 on the same terms and conditions as adjacent channel BRS or EBS licensees.

For each band edge measurement:

- 1) Set the spectrum analyzer span to include the block edge frequency.
- 2) Set a marker to point the corresponding band edge frequency in each test case.
- 3) Set display line at -13 dBm
- 4) Set resolution bandwidth to at least 1% of emission bandwidth.
- 5) Set spectrum analyzer with RMS detector.
- 6) Record the max trace plot into the test report

Note: The cable loss and attenuator loss were offset into measure device as an amplitude offset.

Additional requirement for LTE Band 2:

The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least $43 + 10 \log(P)$ dB. This calculated to be -13dBm.

Additional requirement for LTE Band 4/66:

The power of any emission outside a licensee's frequency block shall be attenuated below the transmitter power (P) in watts by at least $43 + 10 \log(P)$ dB. This calculated to be -13dBm.

Additional requirement for LTE Band 5:

The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least $43 + 10 \log(P)$ dB. This calculated to be -13dBm.

Limit requirement for LTE Band 12/17: For operations in the 600 MHz band and the 698–746 MHz band, the power of any emission outside a licensee's frequency band(s) of operation shall be attenuated below the transmitter power (P) within the licensed band(s) of operation, measured in watts, by at least $43 + 10 \log(P)$ dB. This calculated to be -13dBm.

Limit requirement for LTE Band 13: According to FCC section 27.53(c)(2), any frequency outside the 776-788 MHz band, the power of any emission shall be attenuated outside the band below the transmitter power (P) by at least $43 + 10 \log(P)$ dB in a 100kHz bandwidth. However, in the 100 kHz bands immediately outside and adjacent to the frequency block, a resolution bandwidth of at least 30 kHz may be employed. This calculated to be -13dBm.

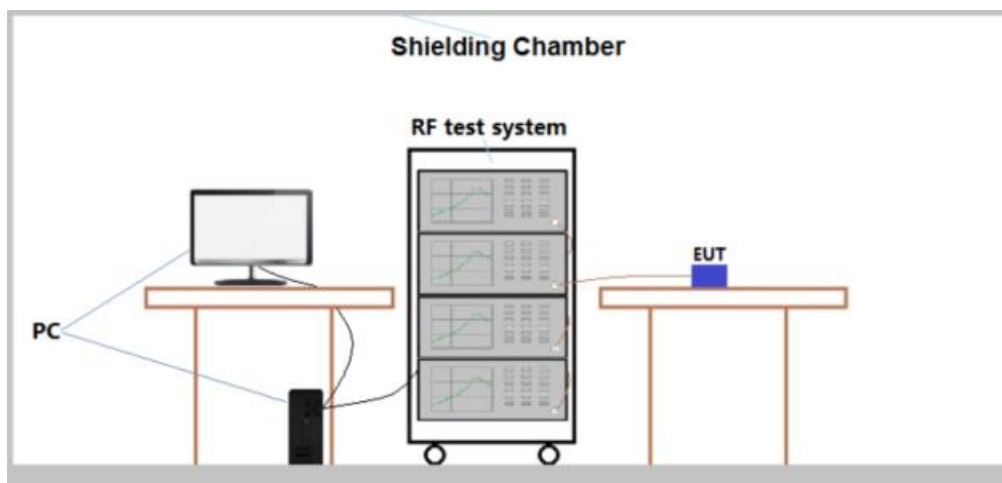

The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least $43 + 10 \log(P)$ dB. This calculated to be -13dBm.

Additional requirement for LTE Band 4/66:

The power of any emission outside a licensee's frequency block shall be attenuated below the transmitter power (P) in watts by at least $43 + 10 \log(P)$ dB. This calculated to be -13dBm.

Additional requirement for LTE Band 5:

The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least $43 + 10 \log(P)$ dB. This calculated to be -13dBm.

Limit requirement for LTE Band 12/17: For operations in the 600 MHz band and the 698–746 MHz band, the power of any emission outside a licensee's frequency band(s) of operation shall be attenuated below the transmitter power (P) within the licensed band(s) of operation, measured in watts, by at least $43 + 10 \log(P)$ dB. This calculated to be -13dBm.

Limit requirement for LTE Band 13: According to FCC section 27.53(c)(2), any frequency outside the 776-788 MHz band, the power of any emission shall be attenuated outside the band below the transmitter power (P) by at least $43 + 10 \log(P)$ dB in a 100kHz bandwidth. However, in the 100 kHz bands immediately outside and adjacent to the frequency block, a resolution bandwidth of at least 30 kHz may be employed. This calculated to be -13dBm.

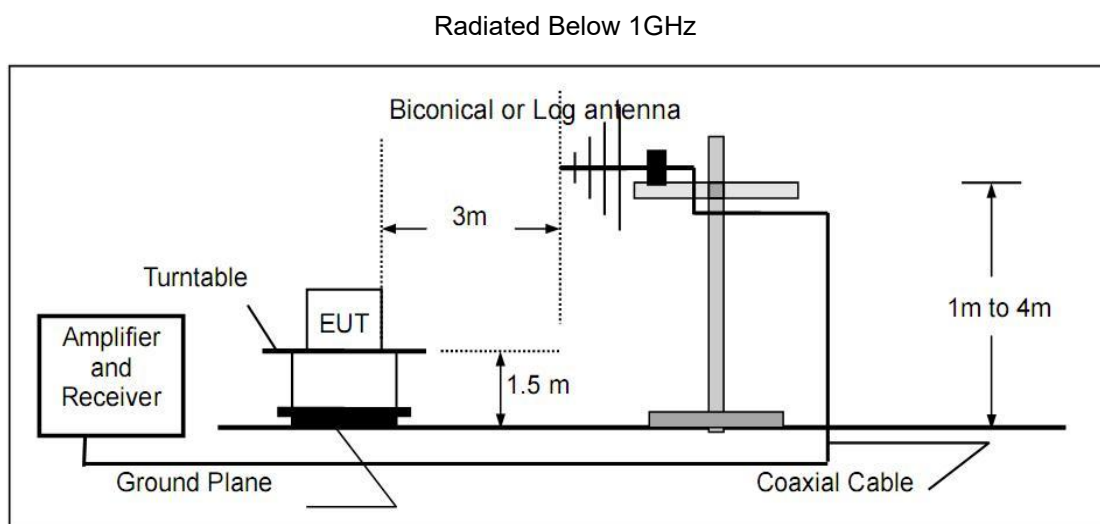

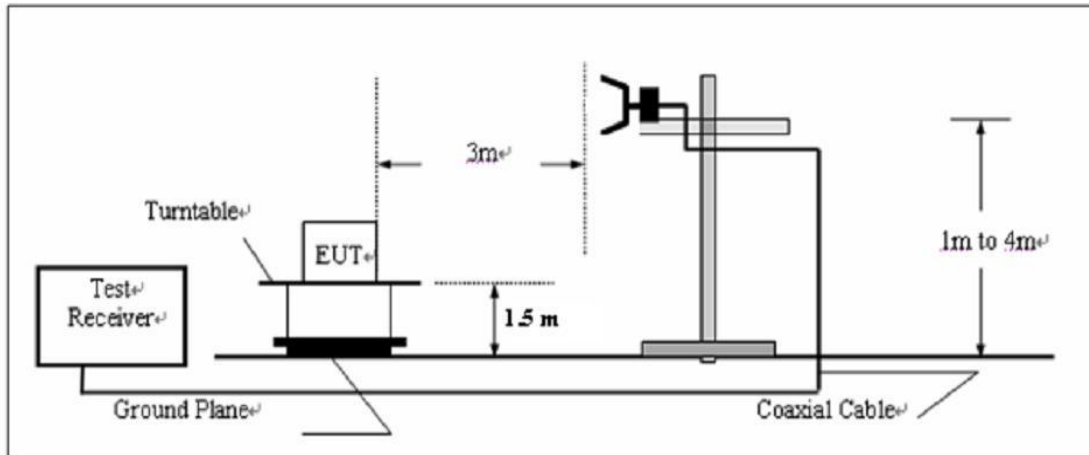

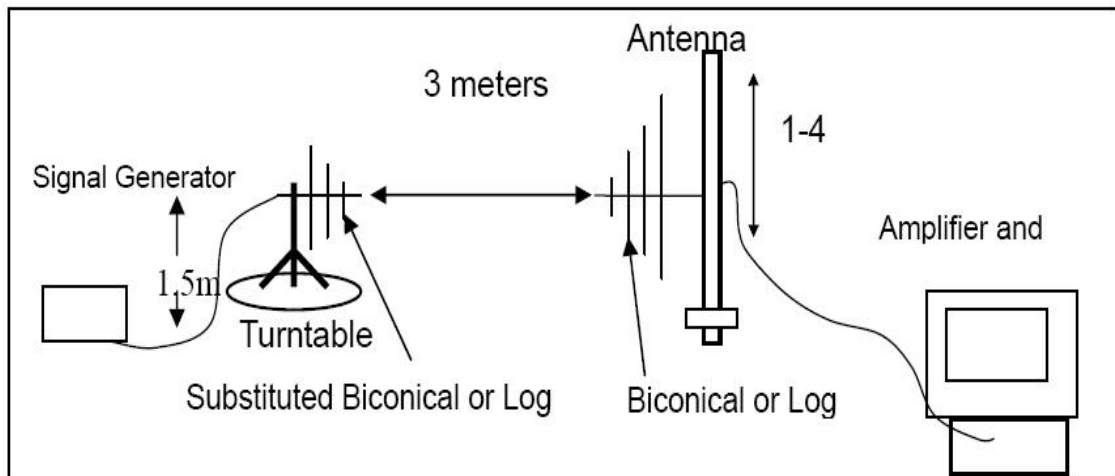


Radiated Above 1GHz

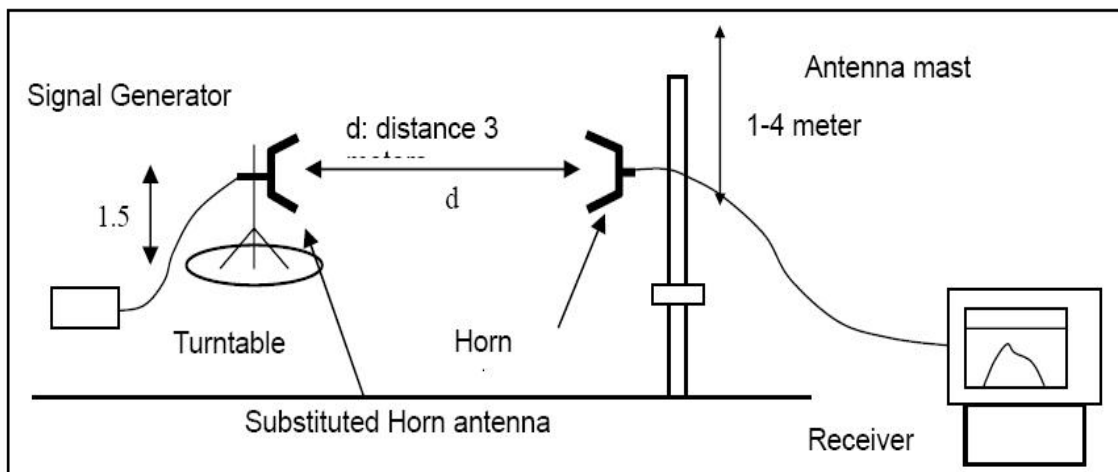


Substitution Method

9.3. TEST PROCEDURE

Refer to KDB 971168 D01 v03r01 Section 7 for test method.

- (1) EUT was placed on a 1.50 meter high non-conductive stand at a 3 meter test distance from the receive antenna. A receiving antenna was placed on the antenna mast 3 meters from the EUT for emission measurements. The height of receiving antenna is 1.50m. Detected emissions were maximized at each frequency by rotating the EUT through 360° and adjusting the receiving antenna polarization. The radiated emission measurements of all transmit frequencies in three channels (High, Middle, Low) were measured with peak detector.
- (2) A log-periodic antenna or double-ridged waveguide horn antenna shall be substituted in place of the EUT. The log-periodic antenna will be driven by a signal generator and the level will be adjusted till the same power value on the spectrum analyzer or receiver. The level of the spurious emissions can be calculated through the level of the signal generator, cable loss, the gain of the substitution antenna and the reading of the spectrum analyzer or receiver.
- (3) The EUT is then put into continuously transmitting mode at its maximum power level during the test. Set Test Receiver or Spectrum RBW=1MHz, VBW=3MHz, and the maximum value of the receiver should be recorded as (P_r).
- (4) The EUT shall be replaced by a substitution antenna. In the chamber, an substitution antenna for the frequency band of interest is placed at the reference point of the chamber. An RF Signal source for the frequency band of interest is connected to the substitution antenna with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A power (P_{Mea}) is applied to the input of the substitution antenna, and adjusts the level of the signal generator output until the value of the receiver reach the previously recorded (P_r). The power of signal source (P_{Mea}) is recorded. The test should be performed by rotating the test item and adjusting the receiving antenna polarization.
- (5) An amplifier should be connected to the Signal Source output port. And the cable should be connecting between the Amplifier and the Substitution Antenna. The cable loss (P_{cl}), the Substitution Antenna Gain (G_a) and the Amplifier Gain (P_{Ag}) should be recorded after test.
- (6) The measurement results are obtained as described below:
$$\text{Power(EIRP)} = P_{Mea} - P_{Ag} - P_{cl} + G_a$$

We used signal generator which signal level can up to 33dBm,so we not used power Amplifier for substitution test;
The measurement results are amend as described below:
$$\text{Power(EIRP)} = P_{Mea} - P_{cl} + G_a$$
- (7) This value is EIRP since the measurement is calibrated using an antenna of known gain (2.15 dBi) and known input power.
ERP can be calculated from EIRP by subtracting the gain of the dipole, $ERP = EIRP - 2.15\text{dBi}$.
- (8) Test frequency range should extend to 10th harmonic of highest fundamental frequency.

- a) By preliminary testing and verifying three axis (X, Y and Z) position of EUT transmitted status, it was found that "Y axis" position was the worst, and test data recorded in this report.
- b) Pre-scan all modes and recorded the worst case in this report.
- c) Radiated spurious emission test from 9KHz to 10th harmonic of fundamental was verified, and the emission levels from 9kHz to 30MHz are attenuated 20dB below the limit and not recorded in report.

10. FREQUENCY STABILITY

10.1. LIMIT

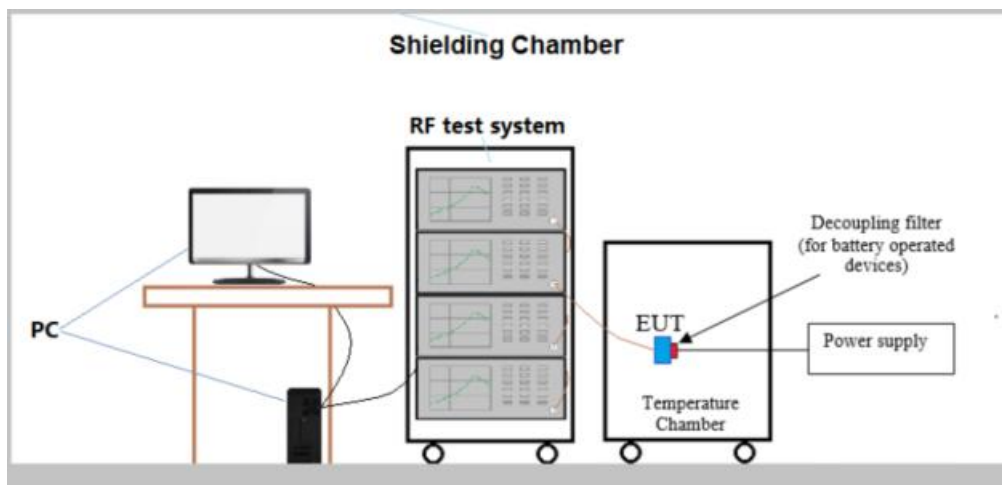
FCC 47 CFR Part 22.355,

The carrier frequency shall not depart from the reference frequency in excess of ± 2.5 ppm for mobile stations.

FCC 47 CFR Part 24.235, FCC 47 CFR Part 27.54

The frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block.

10.3. TEST PROCEDURE

Refer to ANSI C63.26-2015 & KDB 971168 D01v03r01 for test method.

1) The transmitter output was connected to the RF test system.

a) Temp. = -30° to $+50^{\circ}\text{C}$

b) Voltage = low voltage, Normal voltage and High voltage.

2) Frequency Stability vs Temperature:

The EUT is placed inside a temperature chamber. The temperature is set to 20°C and allowed to stabilize. After sufficient soak time, the transmitting frequency error is measured. The temperature is increased by 10 degrees, allowed to stabilize and soak, and then the measurement is repeated. This is repeated until $+50^{\circ}\text{C}$ is reached.

3) Frequency Stability vs Voltage:

The peak frequency error is recorded (worst-case).
