1.0 INTRODUCTION

1.1 Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Innovation, Science and Economic Development Canada.

1.2 Element Test Location

Measurements were conducted at the Element laboratory(ies) indicated in Section 1.3 below. All measurement facilities are compliant with the test site requirements specified in ANSI C63.4:2014 and KDB 414788 D01 v01r01.

1.3 Test Facility / Accreditations

Measurements were performed at Element lab located in Columbia, MD 21046, U.S.A.

The EUT was tested per the guidance of ANSI C63.26:2015. See Section 7.0 of this test report for a description of the radiated and antenna port conducted emissions tests.

2.4 Duty Cycle Information

For all 5G NR and LTE operations in FDD mode, the EUT duty cycle was set to 100%.

For LTE TDD operation, a call box was used to force maximum transmission for each band. For LTE TDD bands, the maximum duty cycle is 63.3% for PC3 and 43.3% for PC2.

2.5 Software and Firmware

Testing was performed on device(s) using software/firmware version A576U1UEU0AYJ1 installed on the EUT.

2.6 EMI Suppression Device(s)/Modifications

No EMI suppression device(s) were added and no modifications were made during testing.

3.0 DESCRIPTION OF TESTS

3.1 Evaluation Procedure

The measurement procedures described in the “American National Standard for Compliance Testing of Transmitters Used in Licensed Radio Services” (ANSI C63.26:2015) were used in the measurement of the EUT.

Deviation from Measurement Procedure.....None

3.2 Radiated Power and Radiated Spurious Emissions

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. The test site inside the chamber is a 6m x 5.2m elliptical, obstruction-free area in accordance with Figure 5.7 of Clause 5 in ANSI C63.4:2014. Absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections for measurements above 1GHz. For measurements below 1GHz, the absorbers are removed. A raised turntable is used for radiated measurement. The turn table is a continuously rotatable, remote-controlled, metallic turntable and 2 meters (6.56 ft.) in diameter. The turn table is flush with the raised floor of the chamber in order to maintain its function as a ground plane. An 80cm tall test table made of Styrodur is placed on top of the turn table. A Styrodur pedestal is placed on top of the test table to bring the total table height to 1.5m.

The equipment under test was transmitting while connected to its integral antenna and is placed on a turntable 3 meters from the receive antenna. The receive antenna height is adjusted between 1 and 4 meter height, the turntable is rotated through 360 degrees, and the EUT is manipulated through all orthogonal planes representative of its typical use to achieve the highest reading on the receive spectrum analyzer.

For radiated power measurements, substitution method is used per the guidance of ANSI C63.26:2015. For emissions below 1GHz, a half-wave dipole is substituted in place of the EUT. For emissions above 1GHz, a horn antenna is substituted in place of the EUT. The substitute antenna is driven by a signal generator with the level of the signal generator being adjusted to obtain the same receive spectrum analyzer level previously recorded from the spurious emission from the EUT. The power of the emission is calculated using the following formula:

$$P_d \text{ [dBm]} = P_g \text{ [dBm]} - \text{cable loss [dB]} + \text{antenna gain [dBd/dBi]};$$

where P_d is the dipole equivalent power, P_g is the generator output into the substitution antenna, and the antenna gain is the gain of the substitute antenna used relative to either a half-wave dipole (dBd) or an isotropic source (dBi). The substitute level is equal to $P_g \text{ [dBm]} - \text{cable loss [dB]}$.

For radiated spurious emissions measurements, the field strength conversion method is used per the formulas in Section 5.2.7 of ANSI C63.26:2015. Field Strength (EIRP) is calculated using the following formulas:

$$E_{\text{[dB}\mu\text{V/m]}} = \text{Measured amplitude level}_{\text{[dBm]}} + 107 + \text{Cable Loss}_{\text{[dB]}} + \text{Antenna Factor}_{\text{[dB/m]}}$$

And

$$\text{EIRP}_{\text{[dBm]}} = E_{\text{[dB}\mu\text{V/m]}} + 20\log D - 104.8; \text{ where } D \text{ is the measurement distance in meters.}$$

All radiated measurements are performed in a chamber that meets the site requirements per ANSI C63.4:2014. Additionally, radiated emissions below 30MHz are also validated on an Open Area Test Site to assert correlation with the chamber measurements per the requirements of KDB 414788 D01 v01r01.

Radiated power and radiated spurious emission levels are investigated with the receive antenna horizontally and vertically polarized per ANSI C63.26:2015.

4.0 MEASUREMENT UNCERTAINTY

The measurement uncertainties shown below were calculated in accordance with the requirements of ANSI C63.4:2014. All measurement uncertainty values are shown with a coverage factor of $k = 2$ to indicate a 95% level of confidence. The measurement uncertainty shown below meets or exceeds the U_{CISPR} measurement uncertainty values specified in CISPR 16-4-2 and, thus, can be compared directly to specified limits to determine compliance.

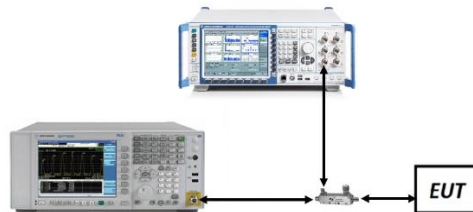


Figure 7-1. Test Instrument & Measurement Setup

7.3 Occupied Bandwidth

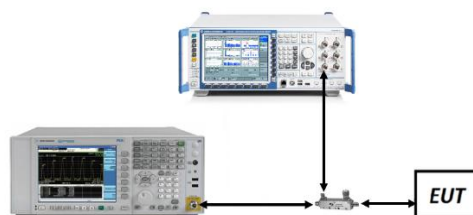


Figure 7-2. Test Instrument & Measurement Setup

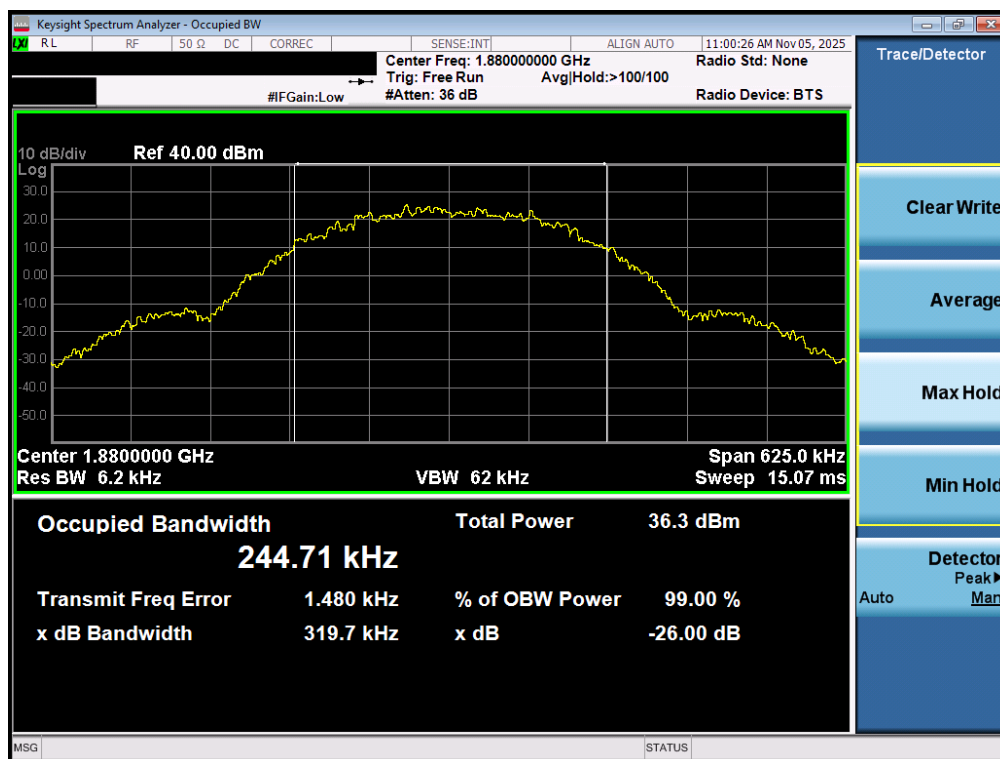

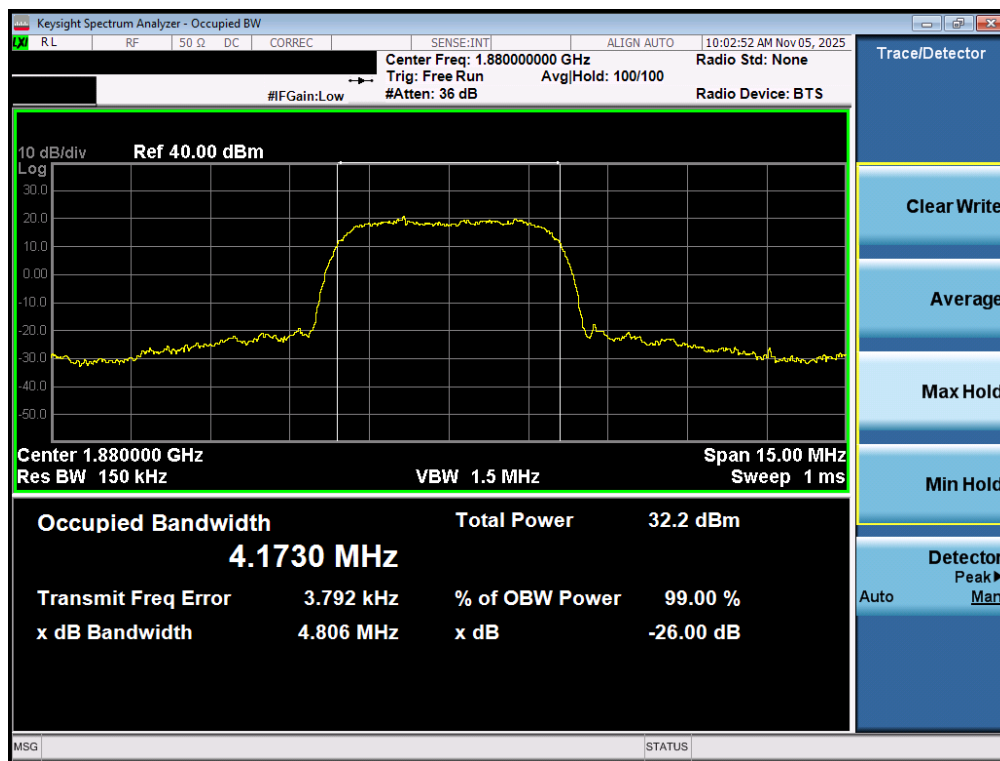
Plot 7-1. Occupied Bandwidth Plot (GPRS, Ch. 661 - Ant1)

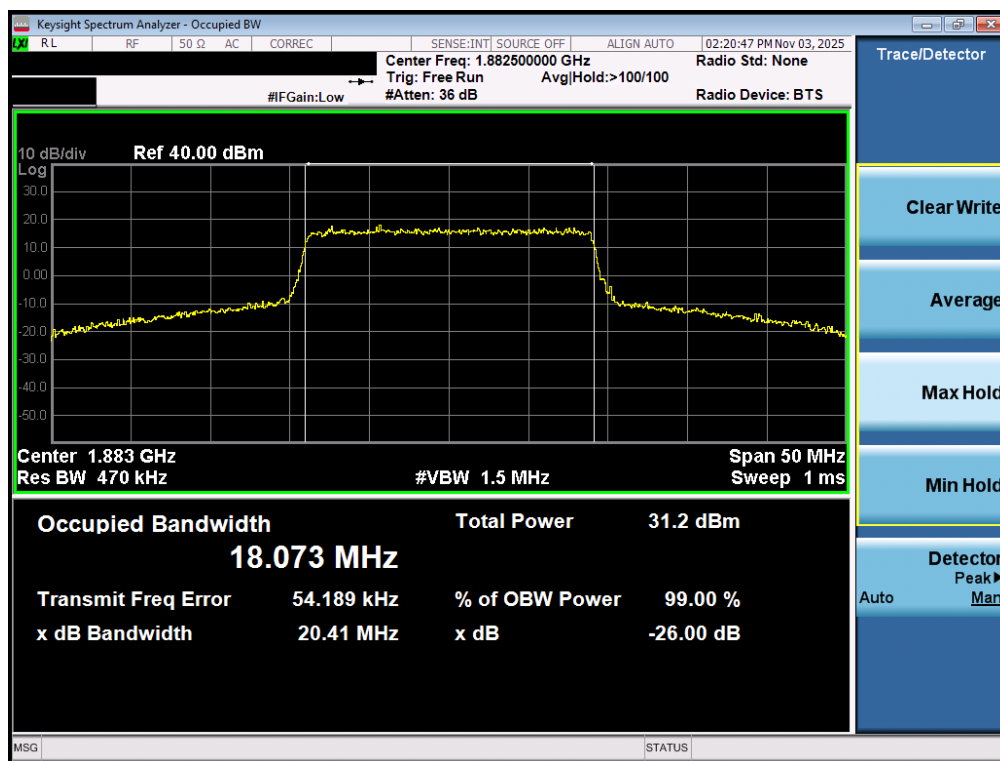

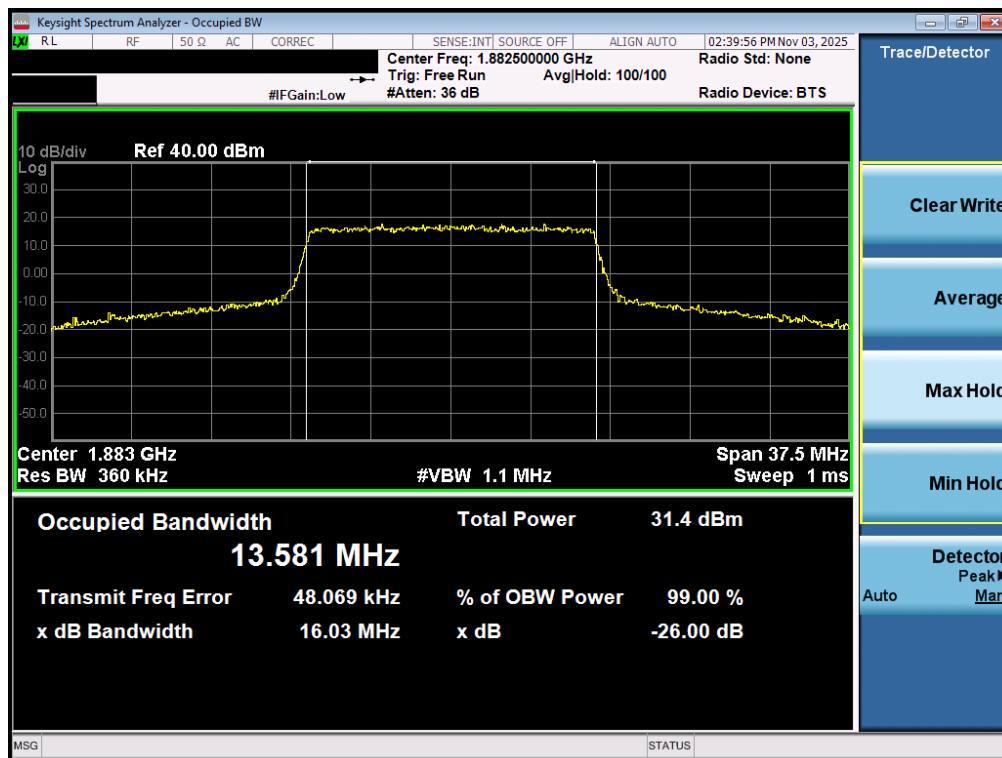


Plot 7-4. Occupied Bandwidth Plot (LTE Band 25/2 - 20MHz QPSK - Full RB - Ant1)

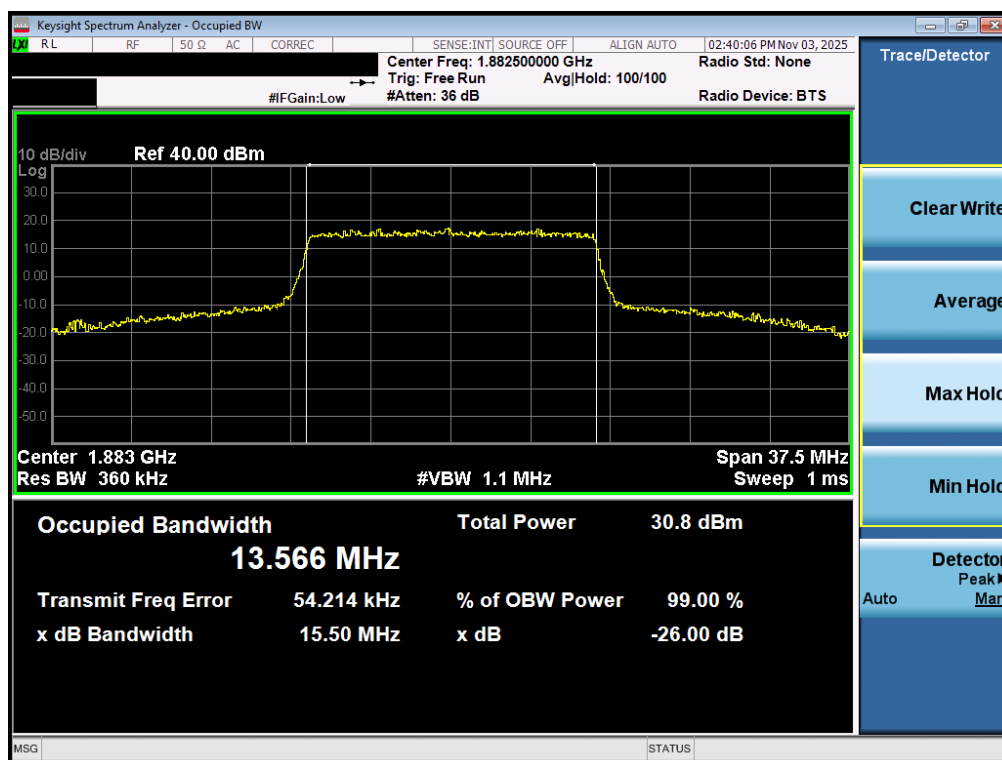


Plot 7-5. Occupied Bandwidth Plot (LTE Band 25/2 - 20MHz 16-QAM - Full RB - Ant1)

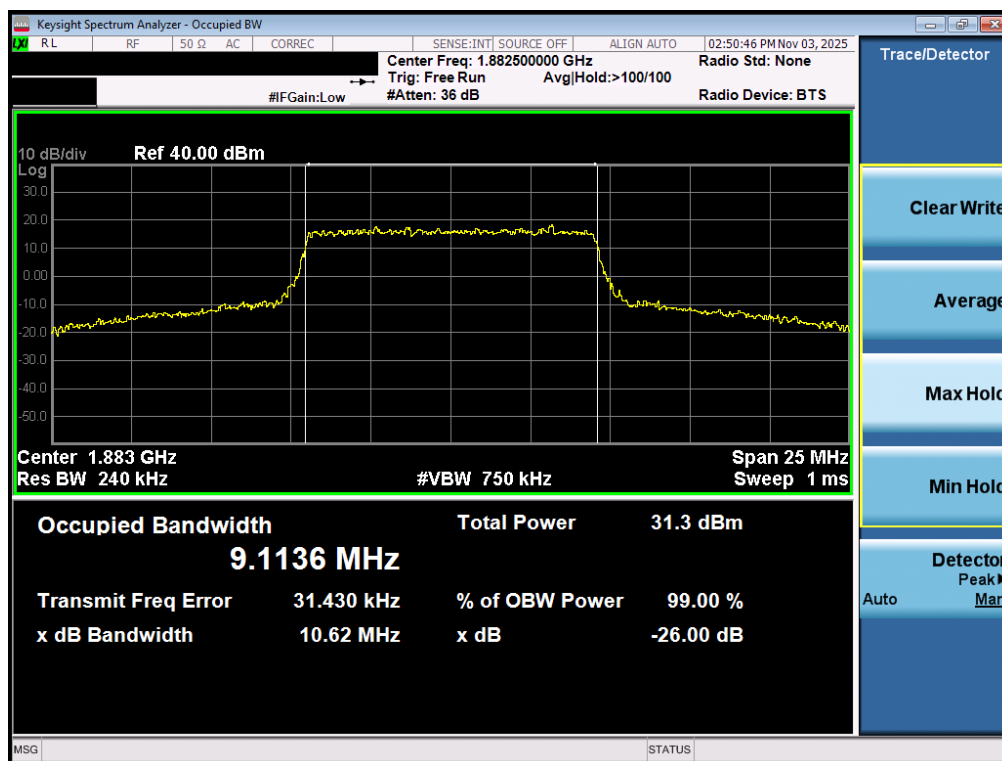


Plot 7-6. Occupied Bandwidth Plot (LTE Band 25/2 - 15MHz QPSK - Full RB - Ant1)

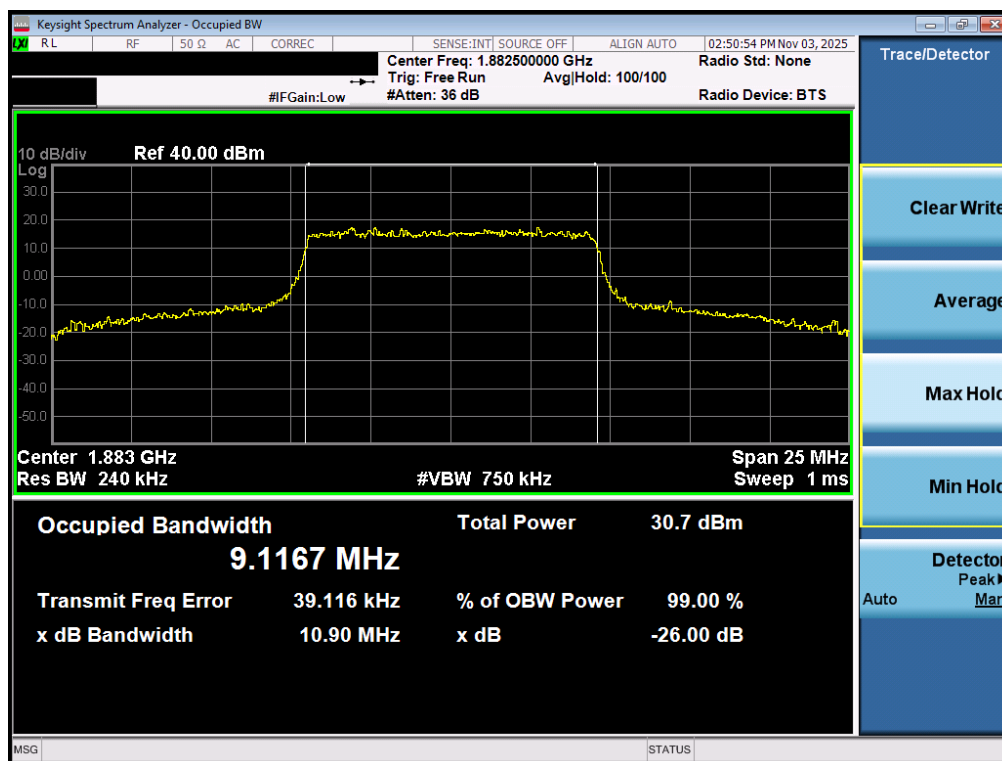


Plot 7-7. Occupied Bandwidth Plot (LTE Band 25/2 - 15MHz 16-QAM - Full RB - Ant1)

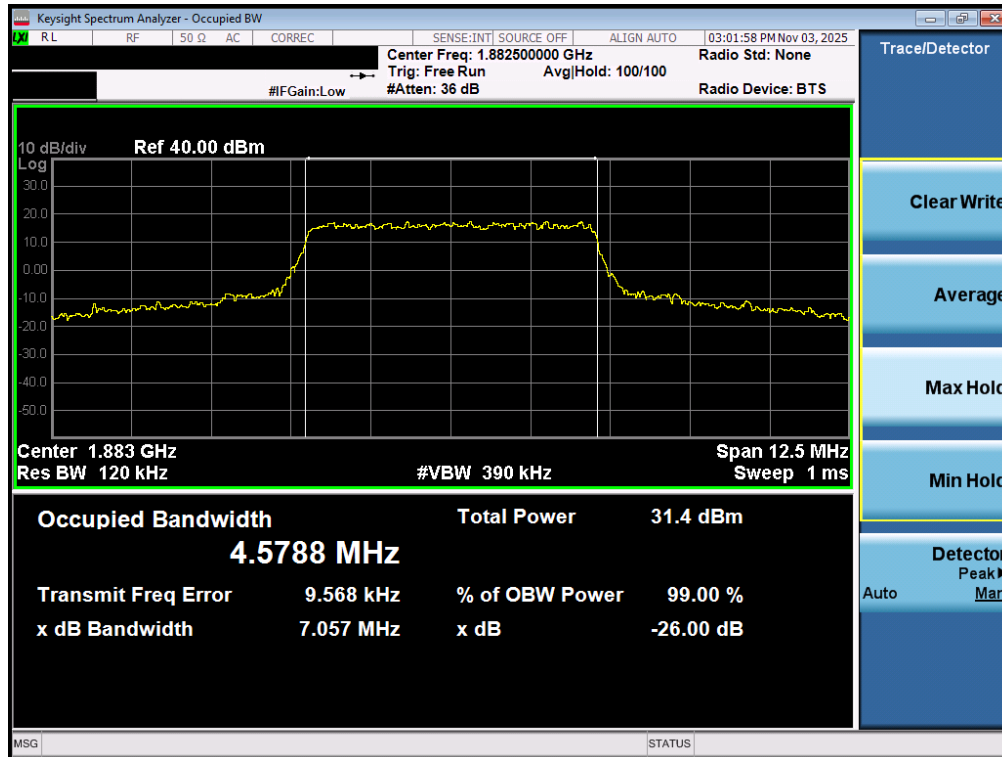


Plot 7-8. Occupied Bandwidth Plot (LTE Band 25/2 - 10MHz QPSK - Full RB - Ant1)

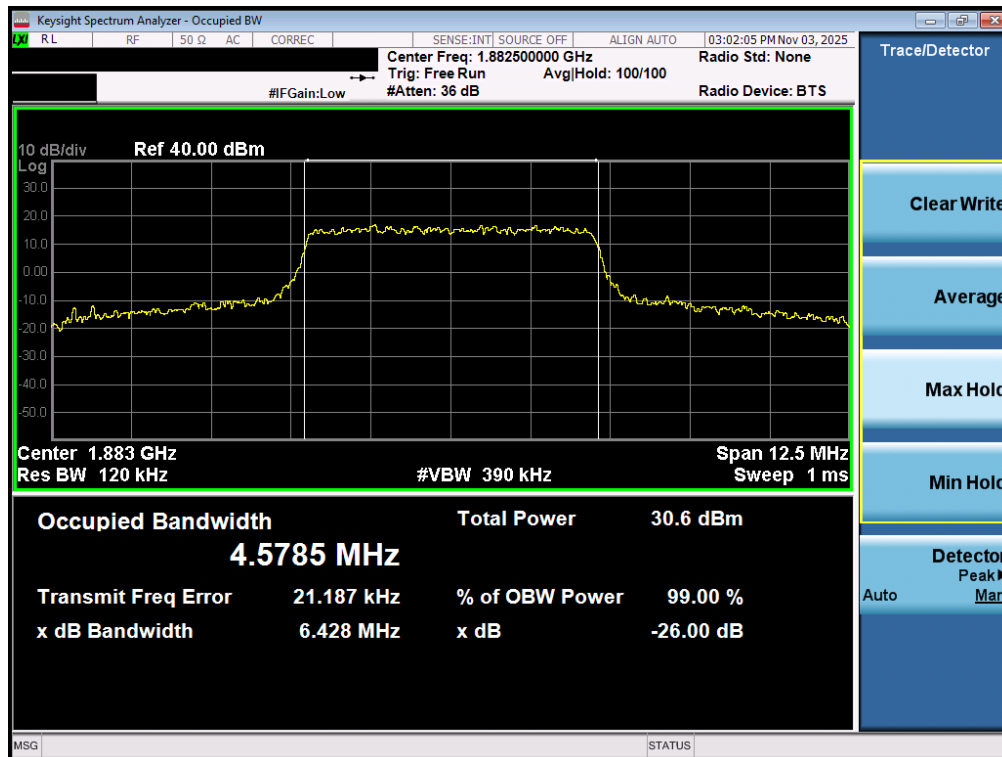


Plot 7-9. Occupied Bandwidth Plot (LTE Band 25/2 - 10MHz 16-QAM - Full RB - Ant1)

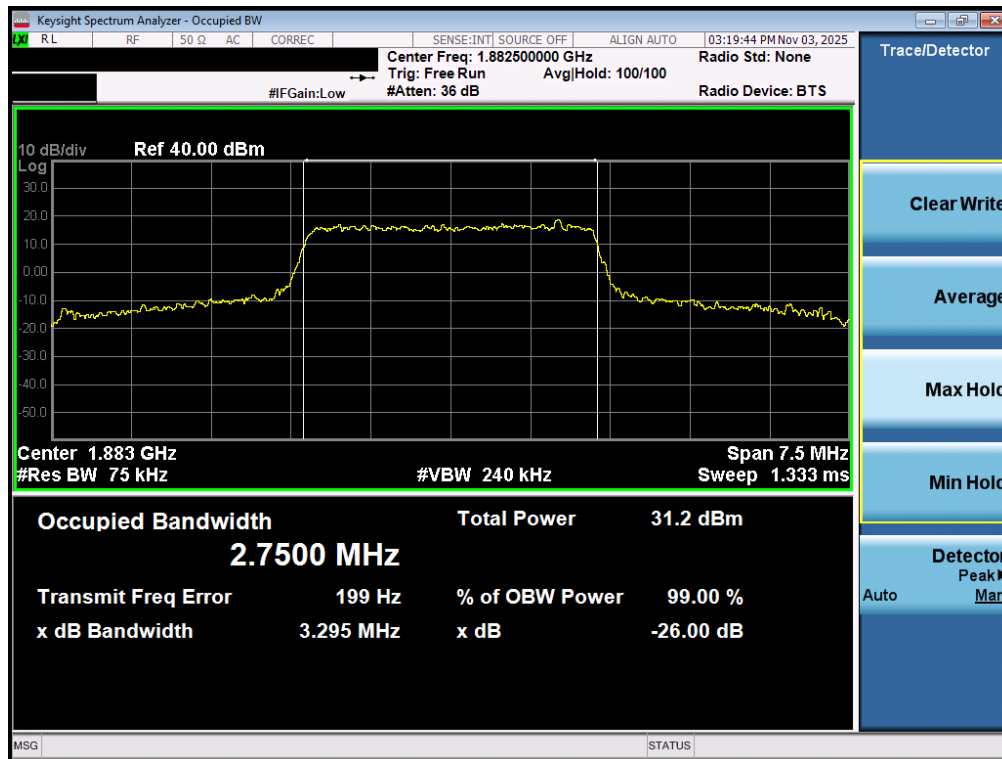


Plot 7-10. Occupied Bandwidth Plot (LTE Band 25/2 - 5MHz QPSK - Full RB - Ant1)

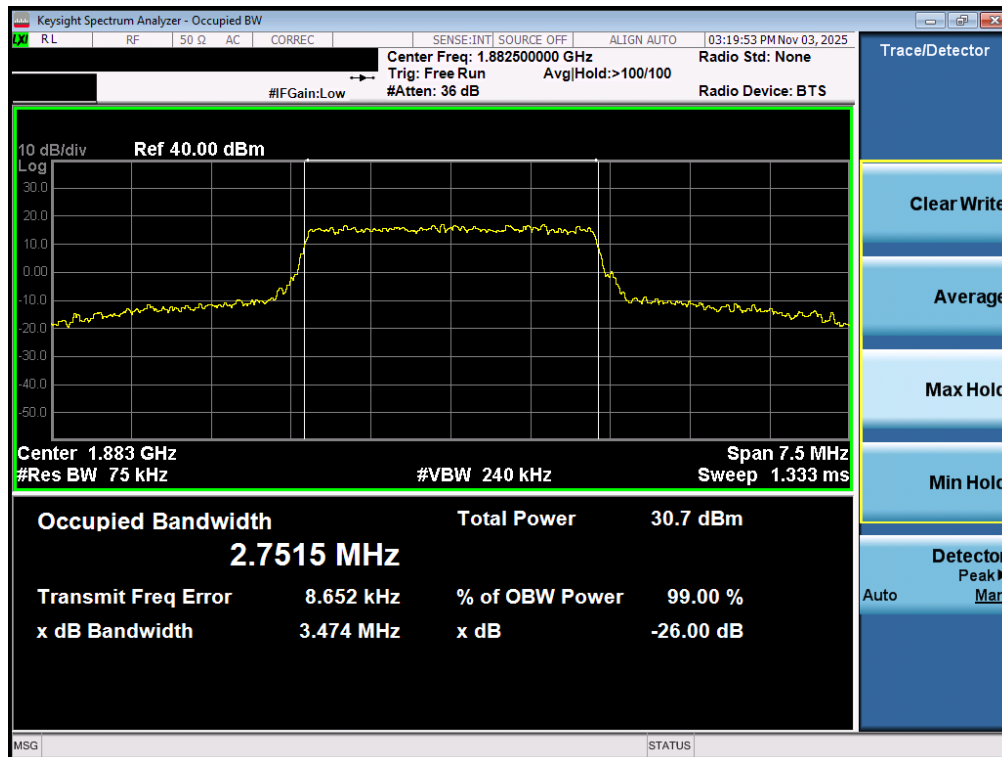


Plot 7-11. Occupied Bandwidth Plot (LTE Band 25/2 - 5MHz 16-QAM - Full RB - Ant1)

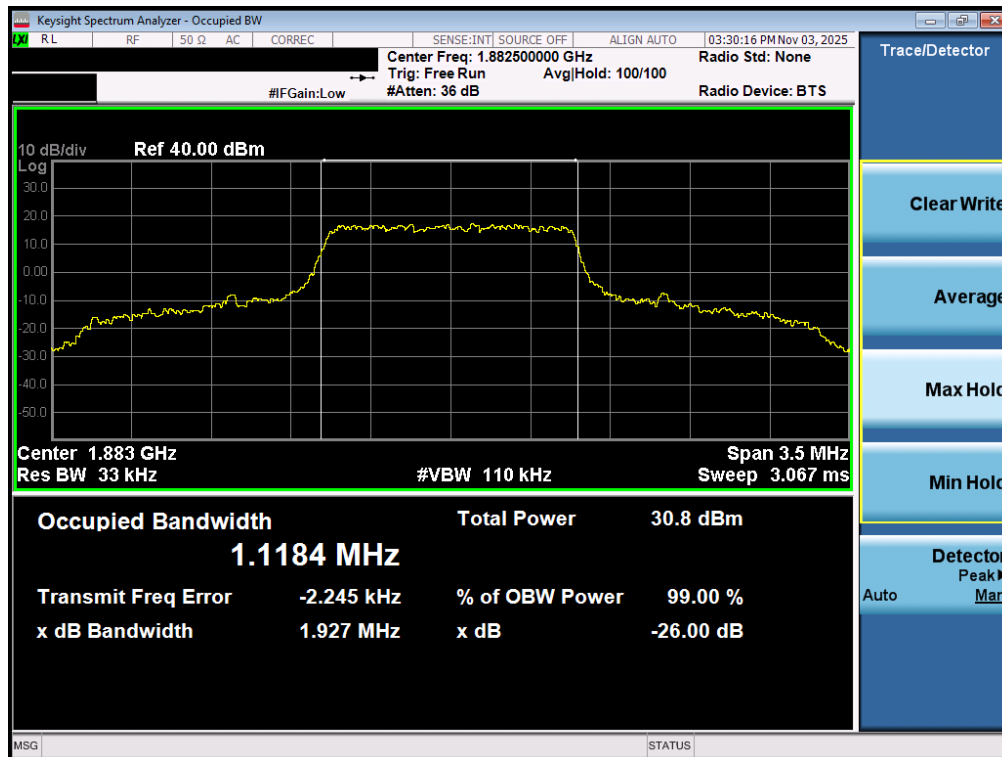


Plot 7-12. Occupied Bandwidth Plot (LTE Band 25/2 - 3MHz QPSK - Full RB - Ant1)

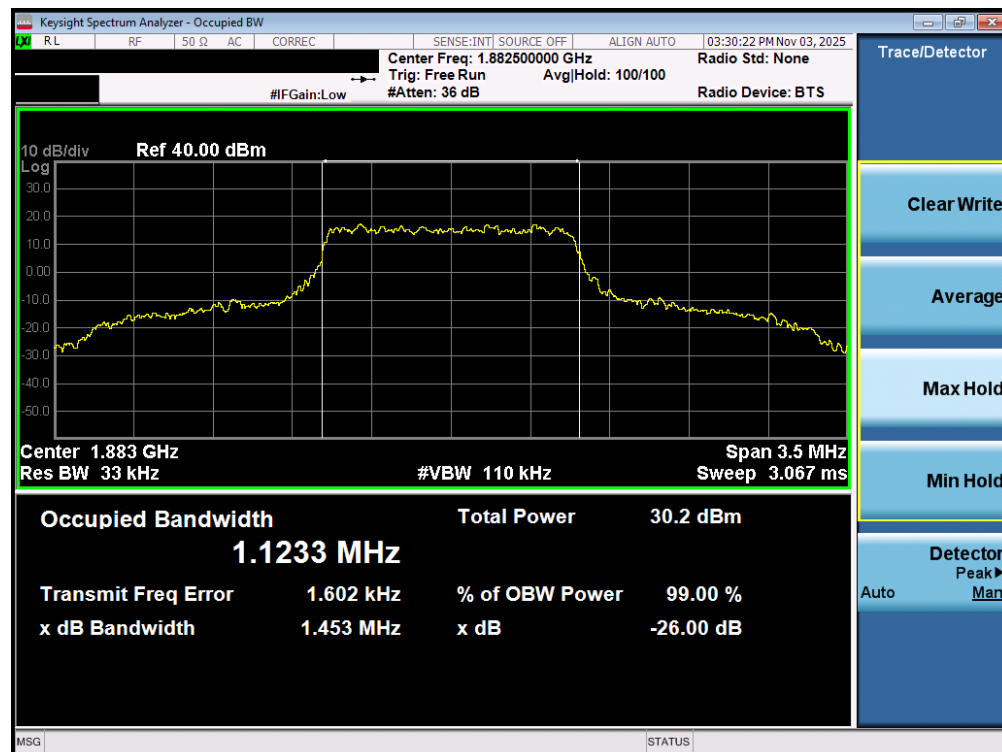


Plot 7-13. Occupied Bandwidth Plot (LTE Band 25/2 - 3MHz 16-QAM - Full RB - Ant1)

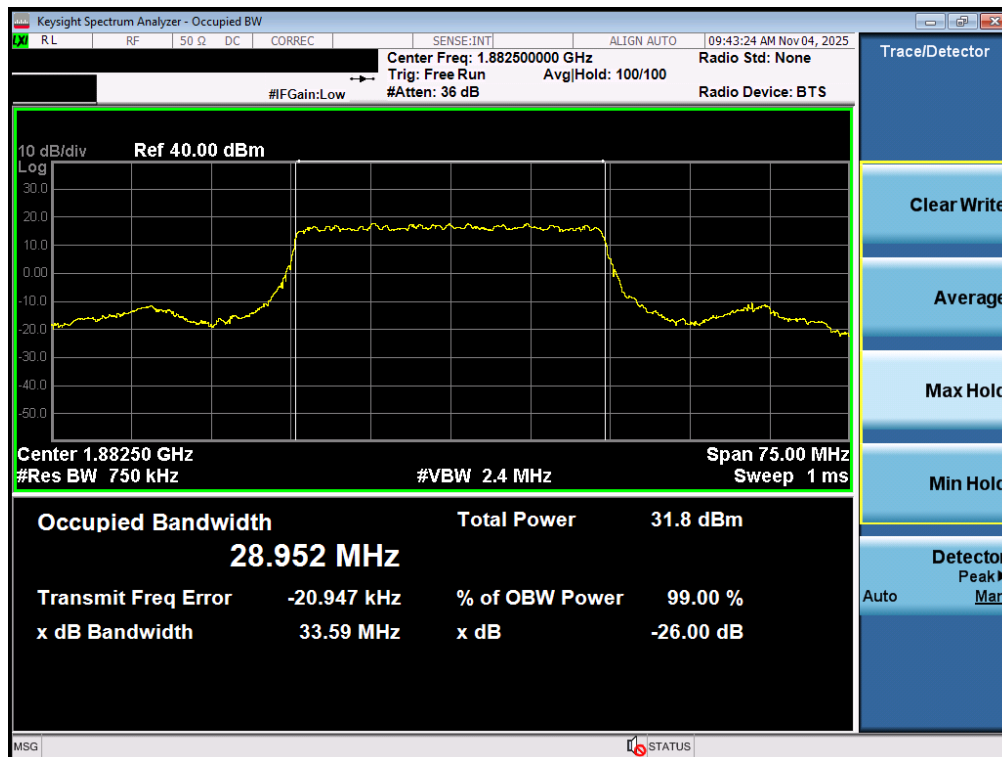

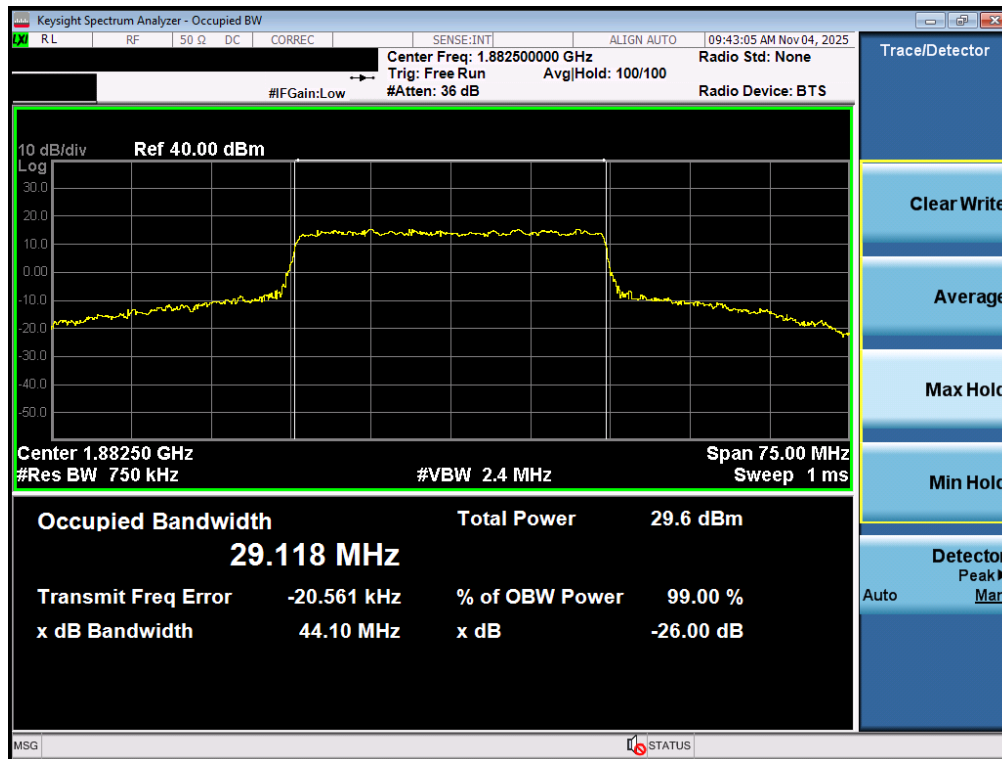

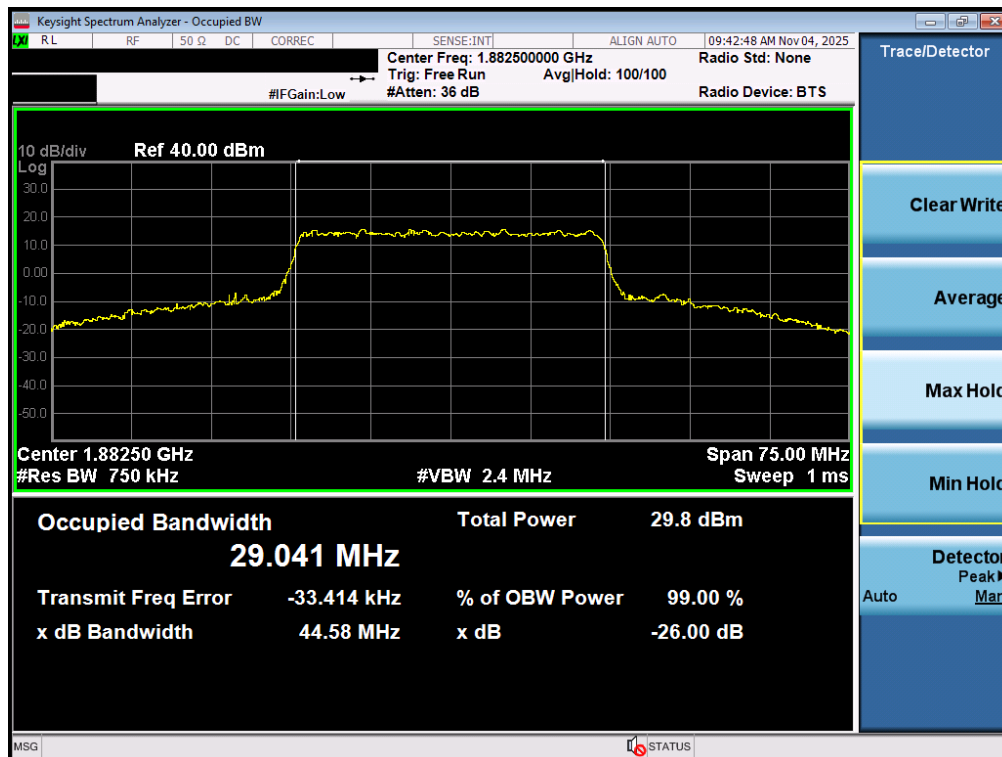

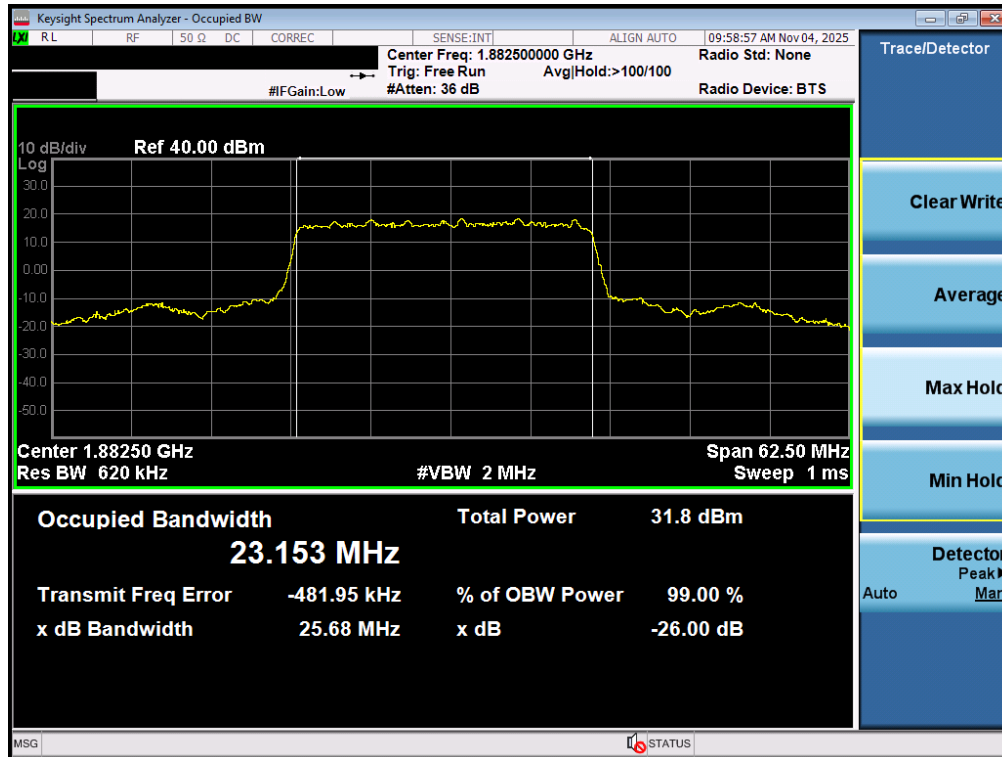

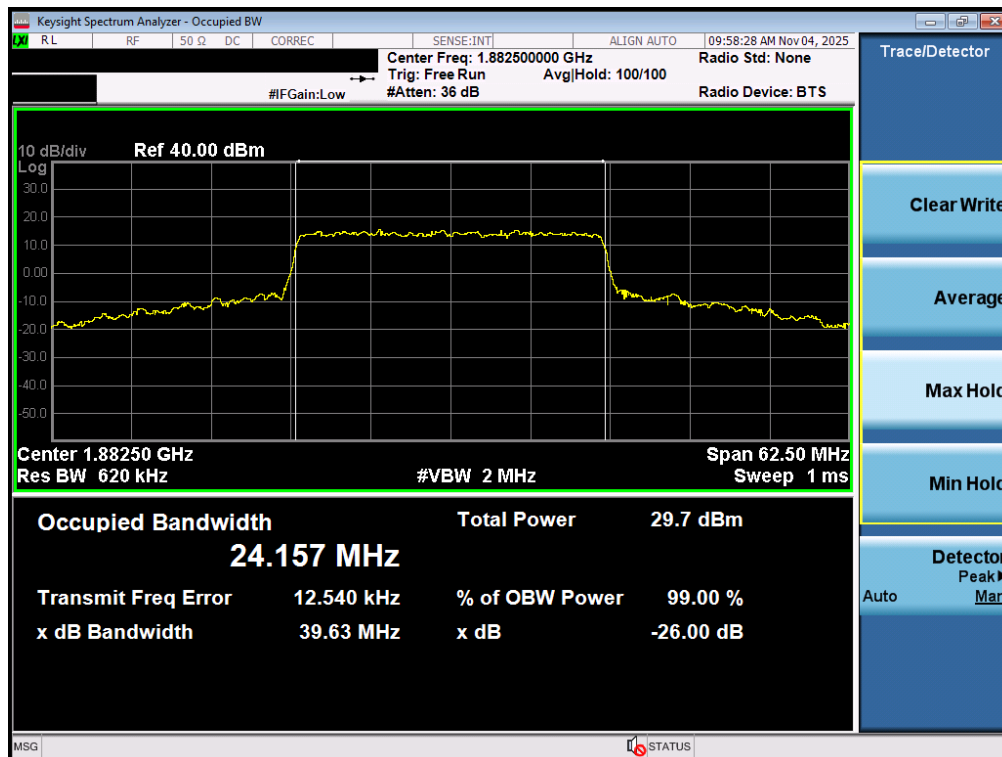

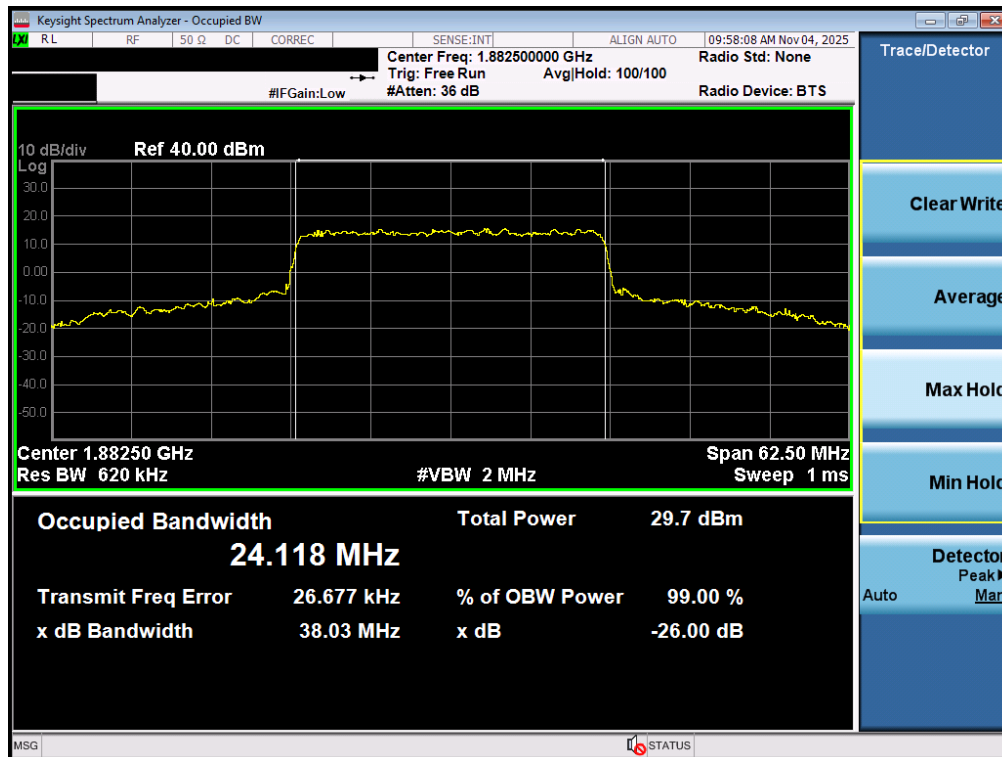

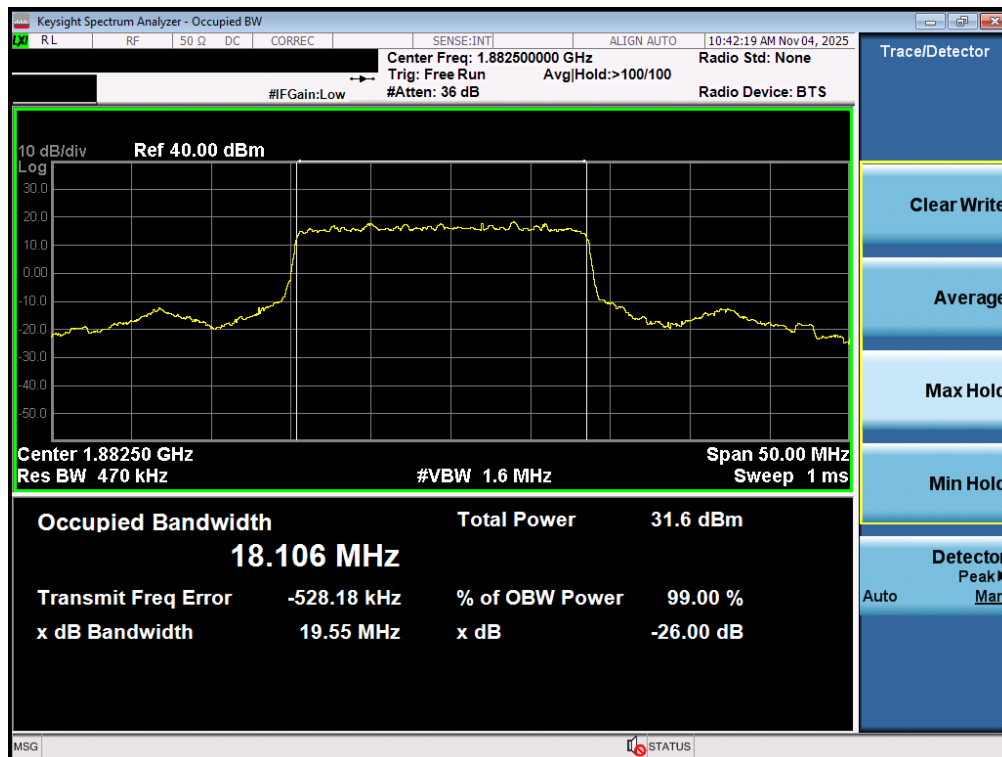

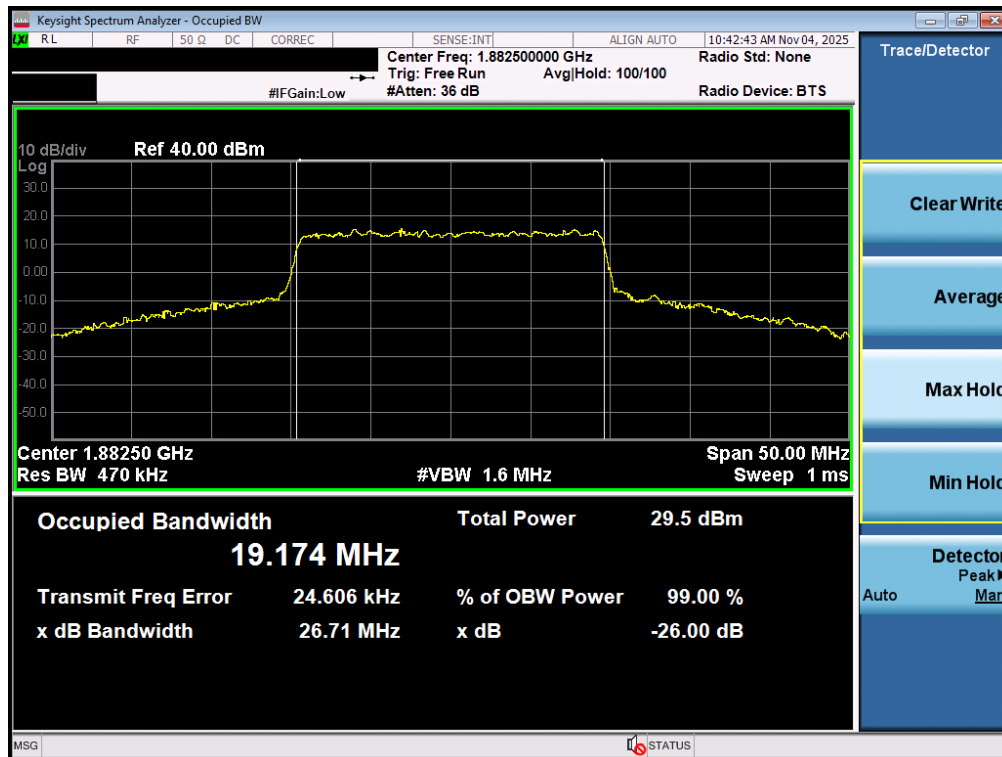

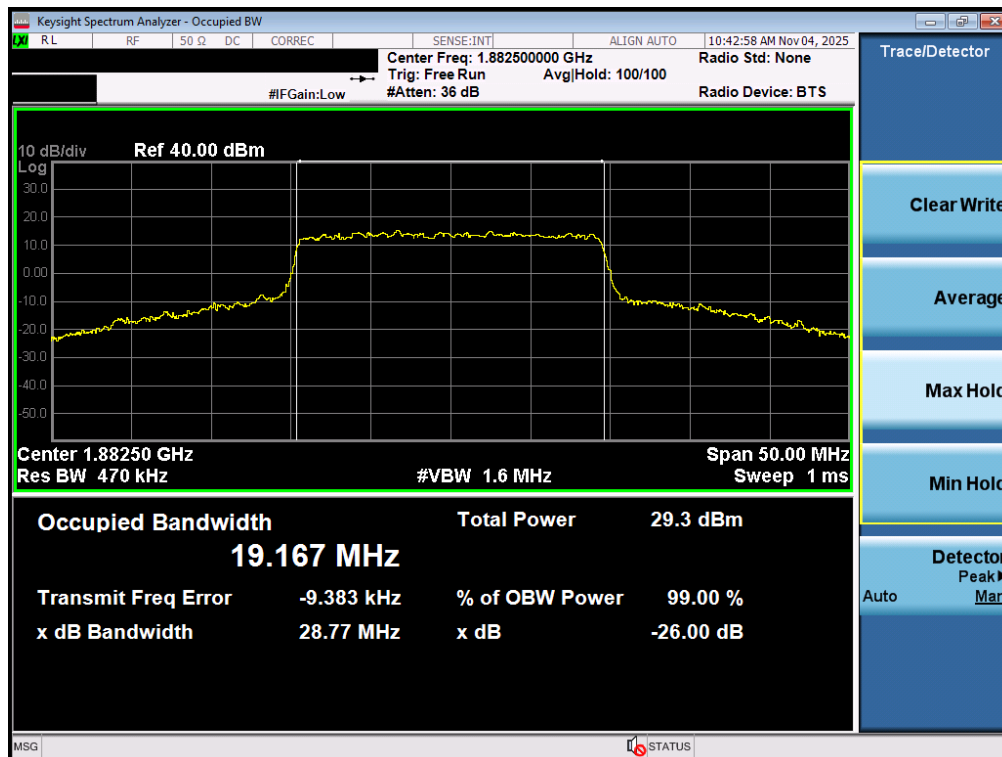

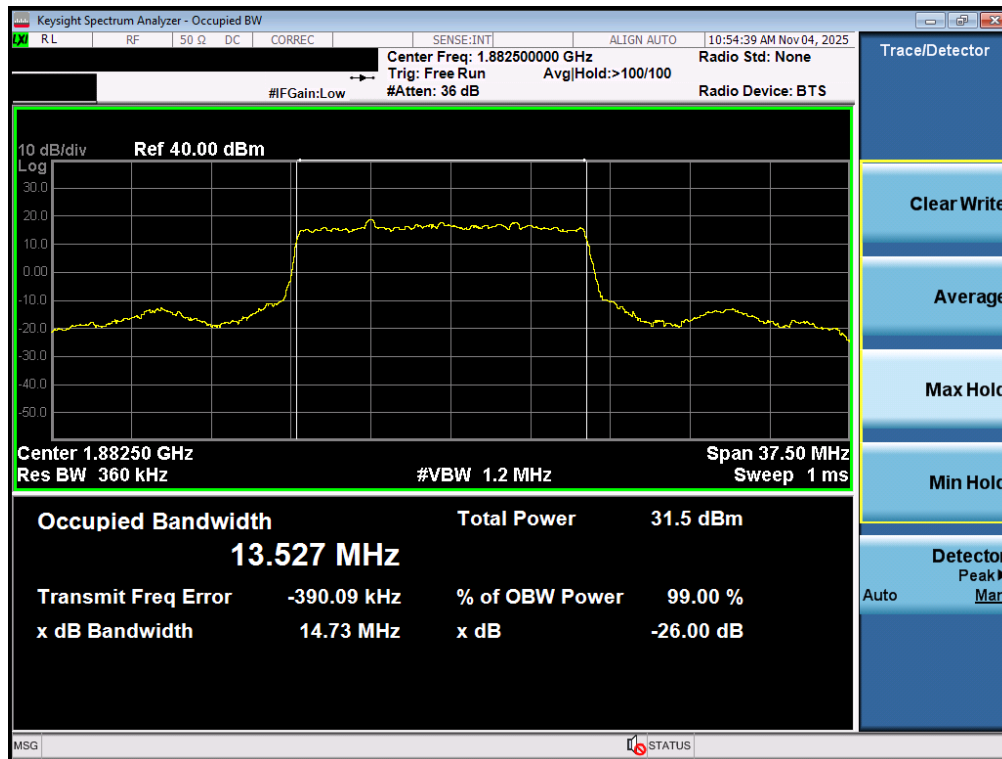

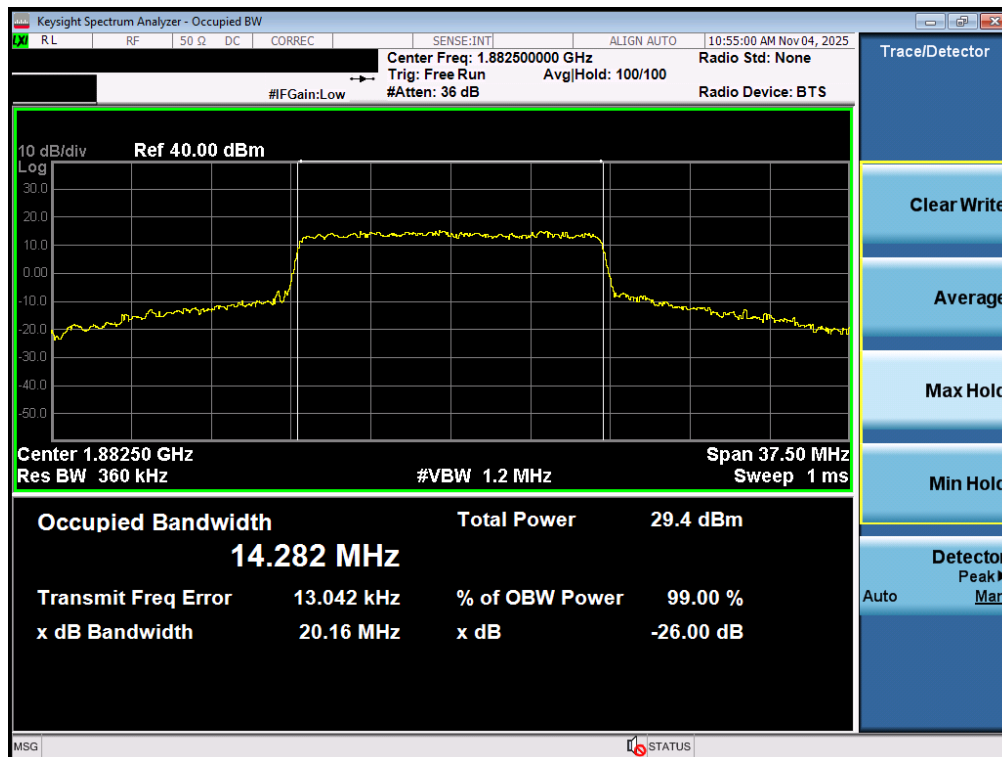

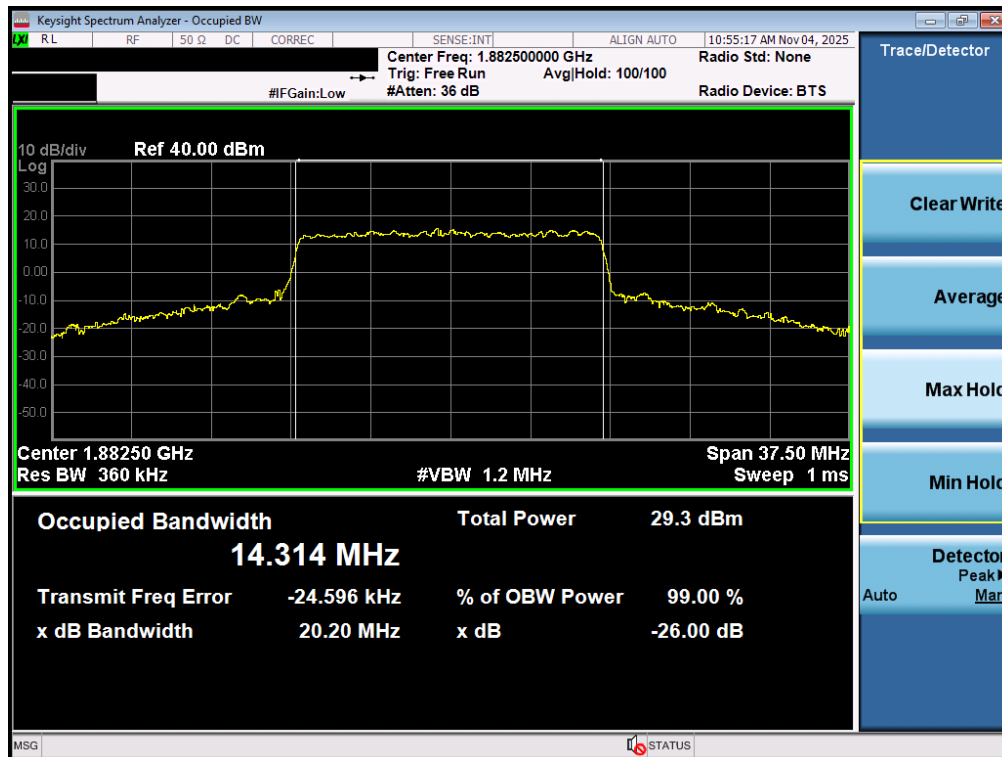

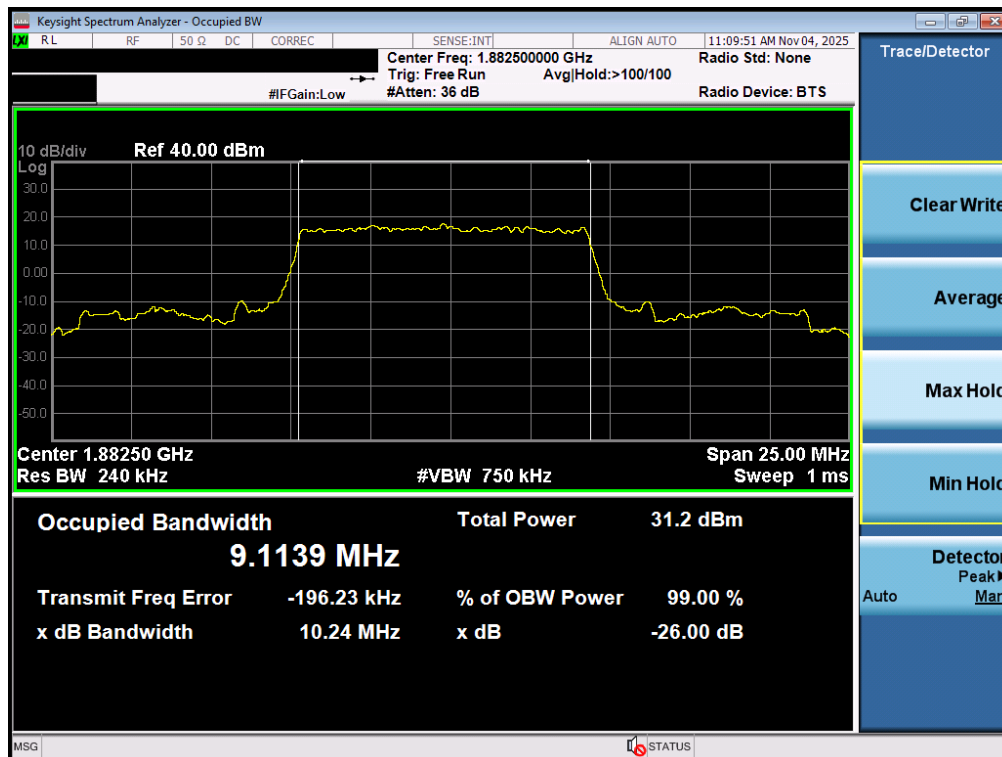

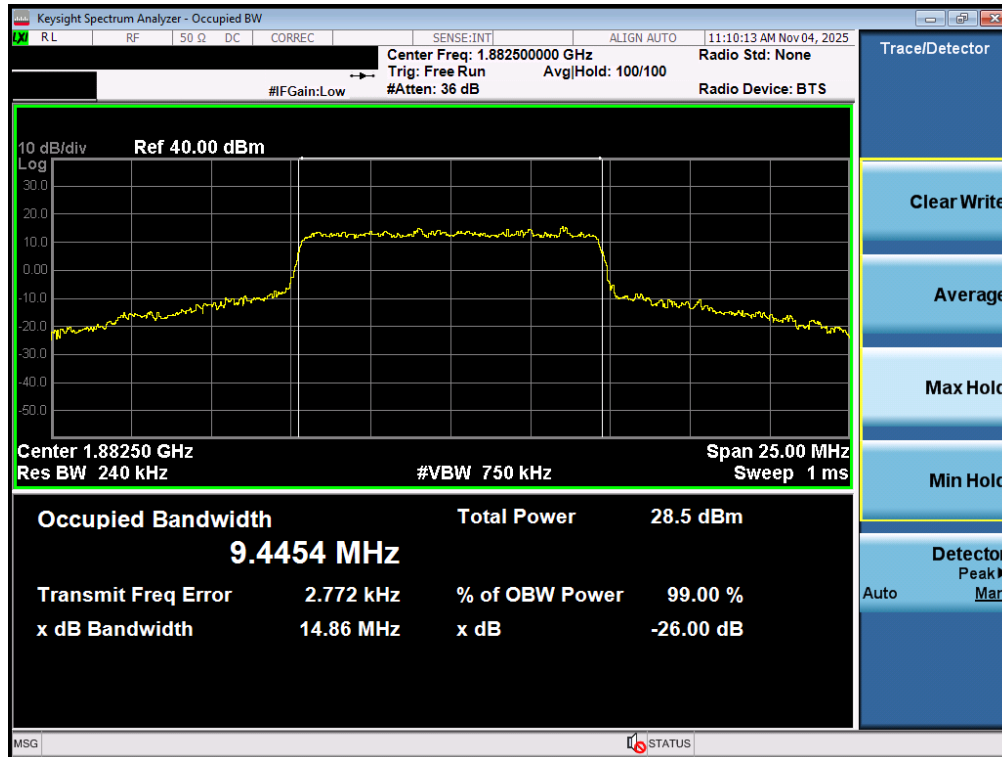

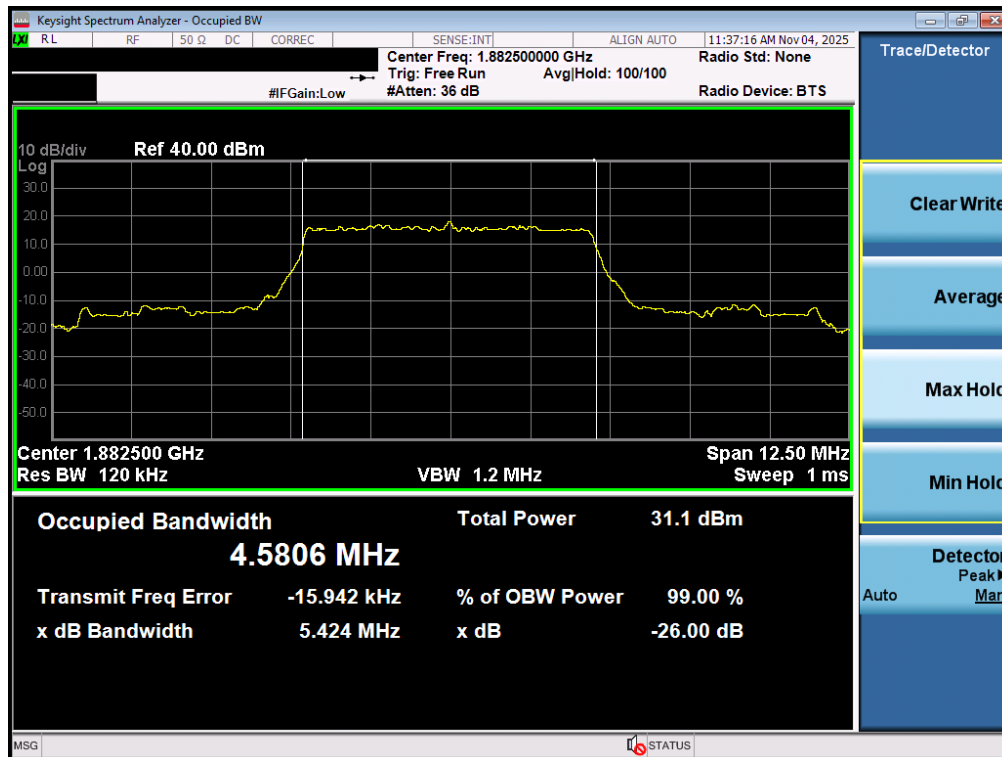

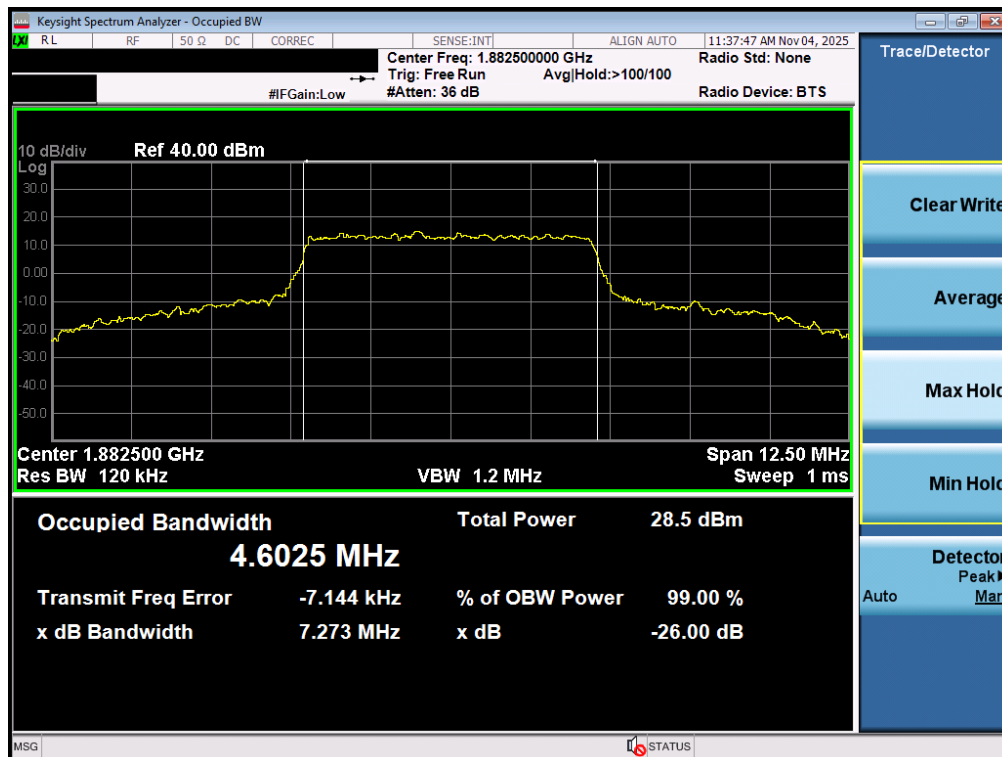

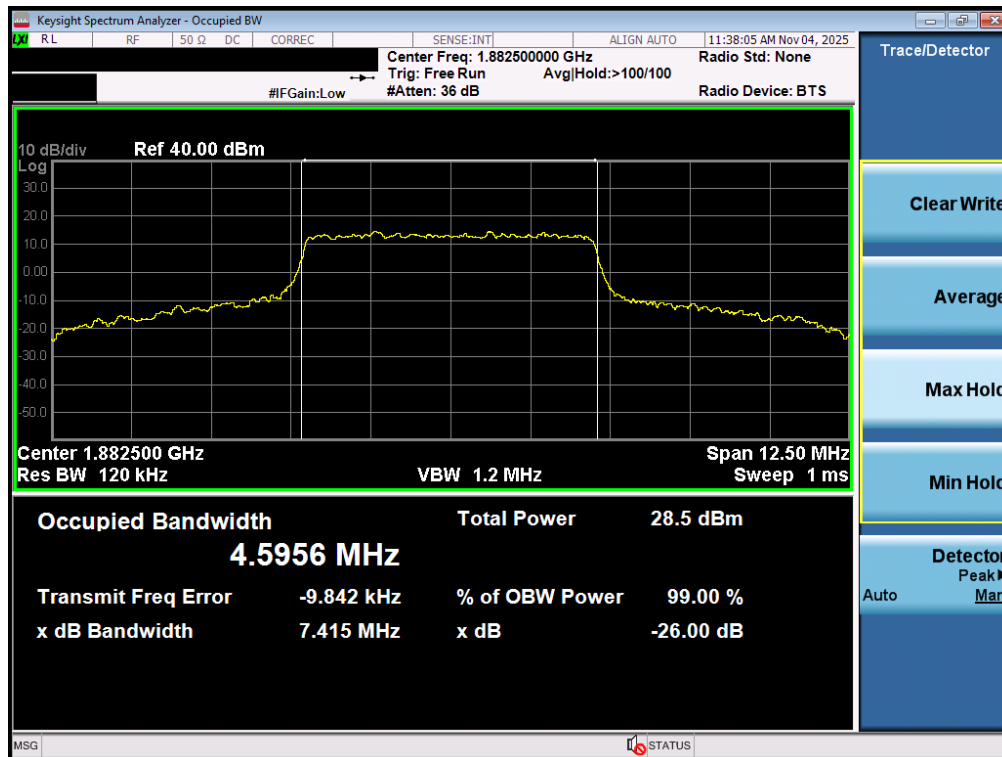

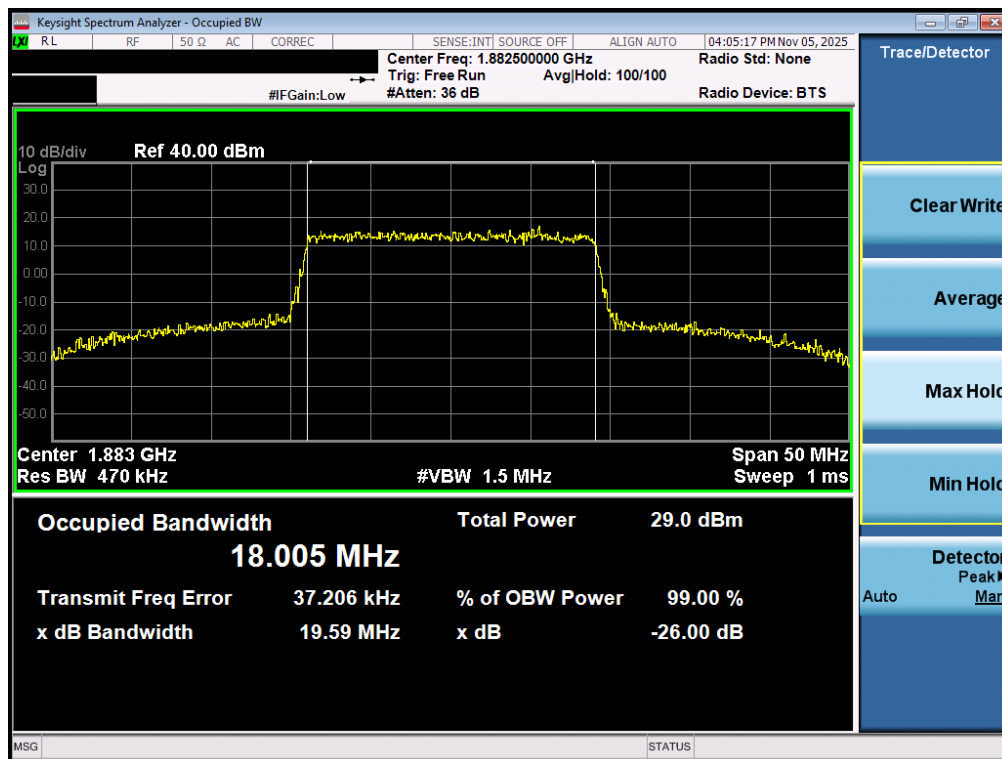

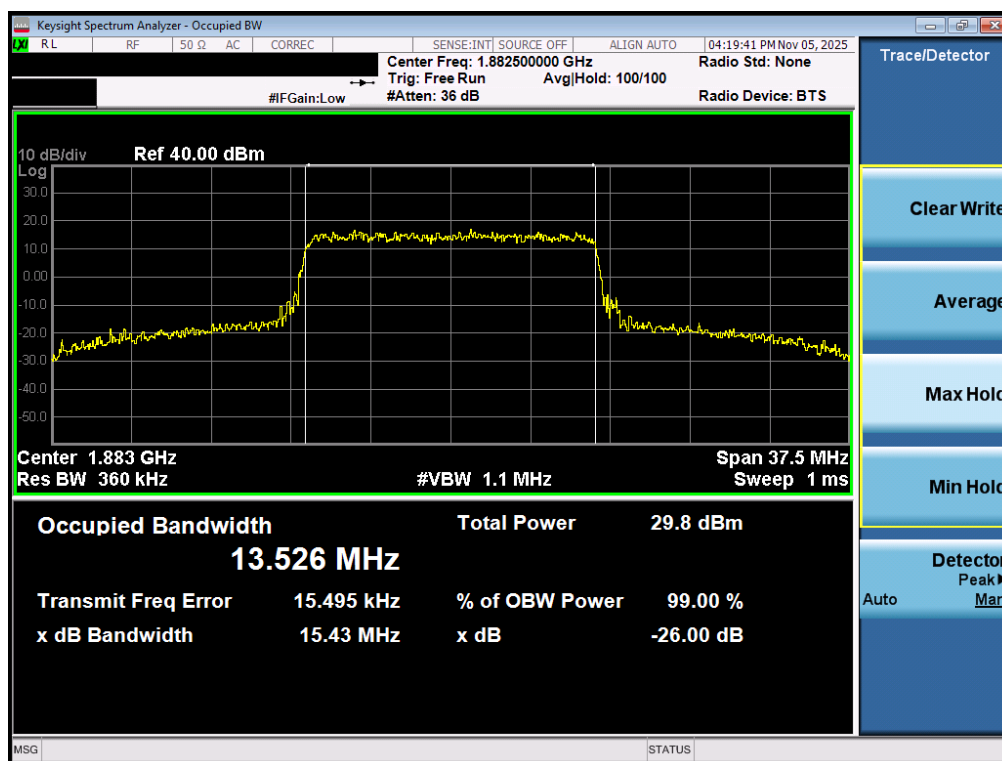


Plot 7-37. Occupied Bandwidth Plot (LTE Band 25/2 - 20MHz QPSK - Full RB - Ant2)

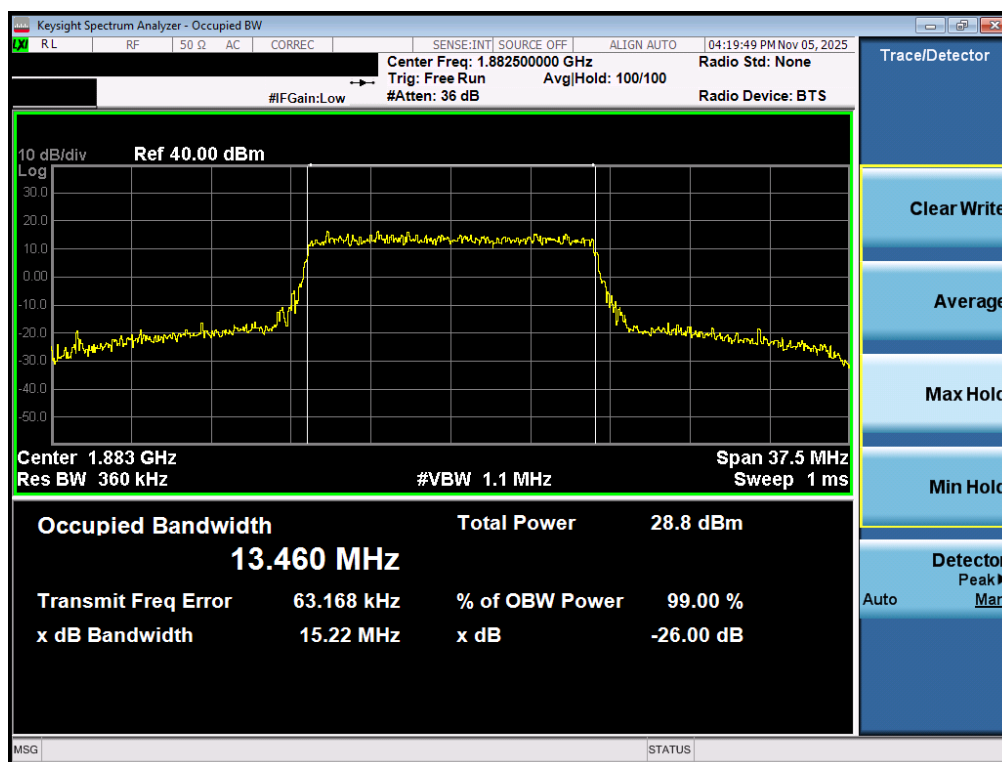


Plot 7-38. Occupied Bandwidth Plot (LTE Band 25/2 - 20MHz 16-QAM - Full RB - Ant2)

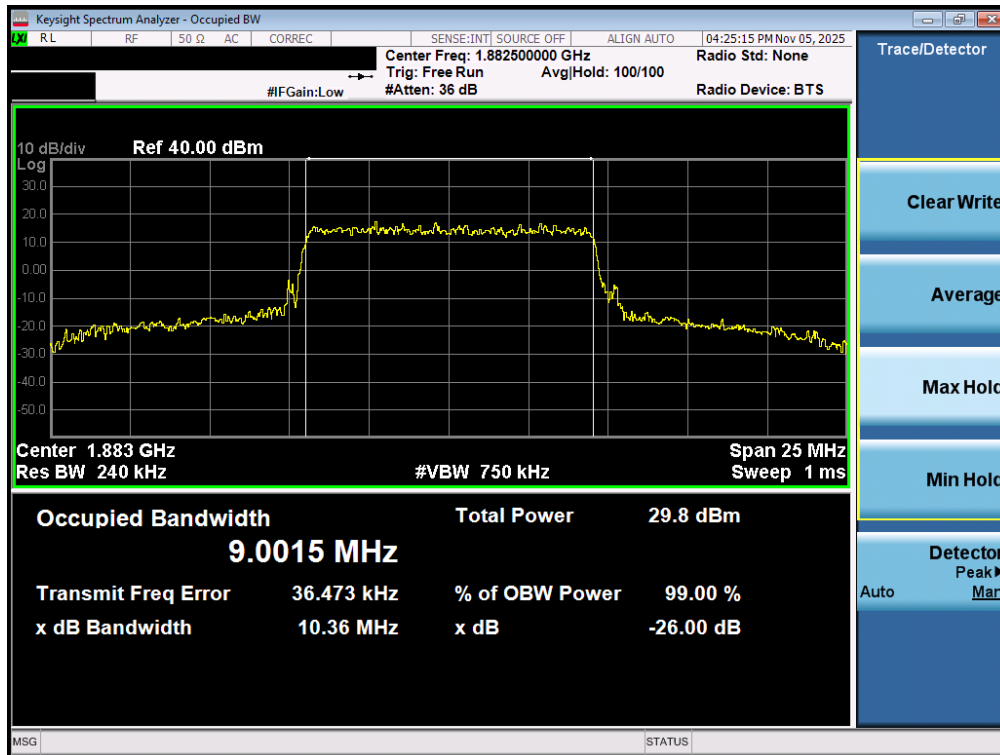


Plot 7-39. Occupied Bandwidth Plot (LTE Band 25/2 - 15MHz QPSK - Full RB - Ant2)

Plot 7-41. Occupied Bandwidth Plot (LTE Band 25/2 - 10MHz QPSK - Full RB - Ant2)

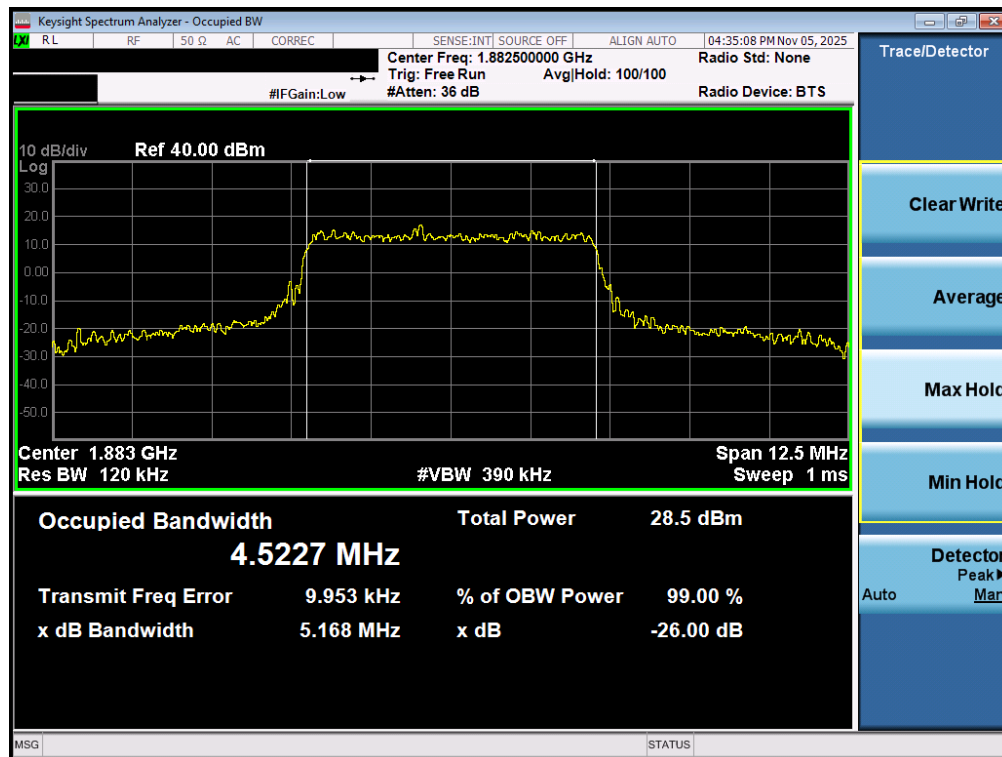


Plot 7-42. Occupied Bandwidth Plot (LTE Band 25/2 - 10MHz 16-QAM - Full RB - Ant2)

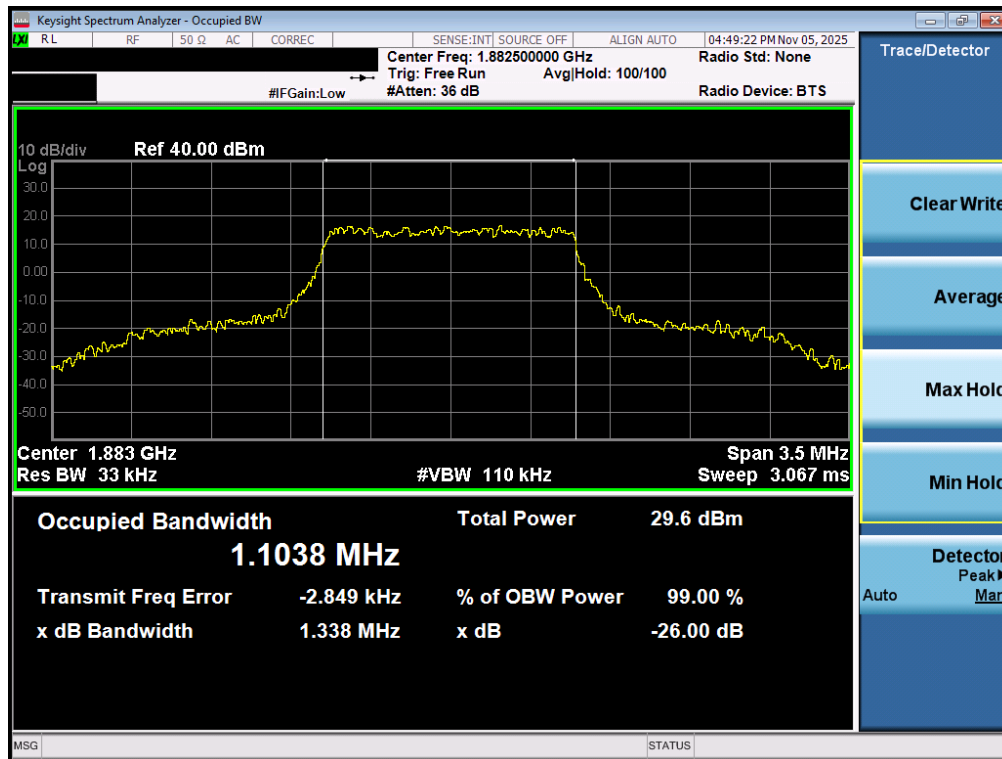


Plot 7-45. Occupied Bandwidth Plot (LTE Band 25/2 - 3MHz QPSK - Full RB - Ant2)

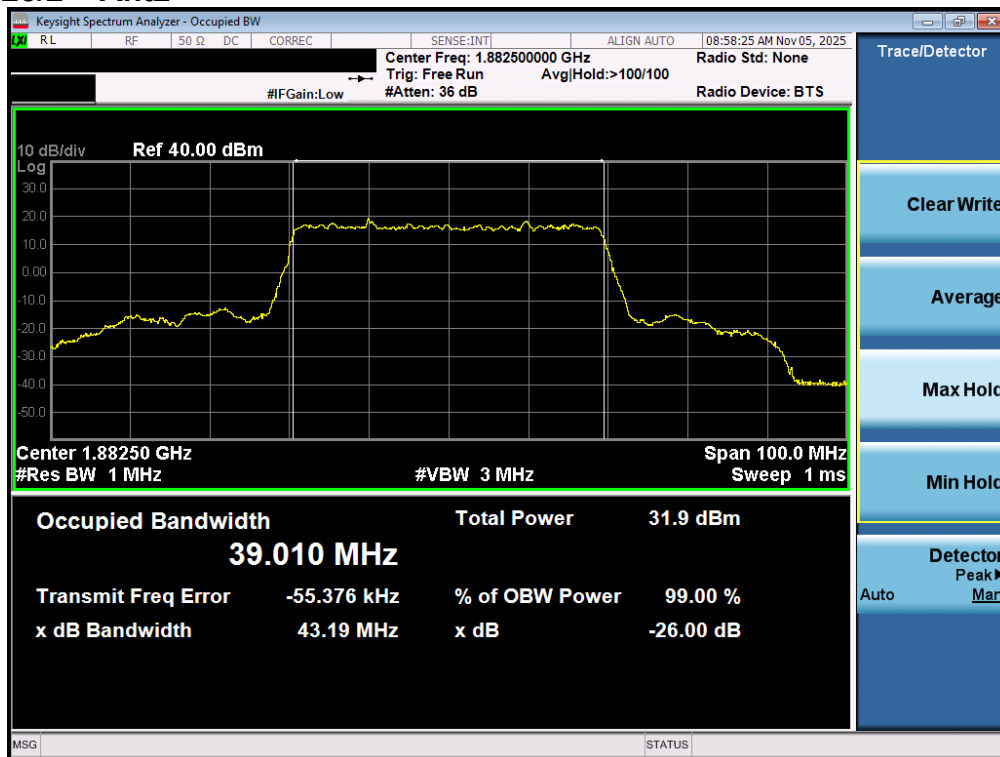
Plot 7-47. Occupied Bandwidth Plot (LTE Band 25/2 - 1.4MHz QPSK - Full RB - Ant2)

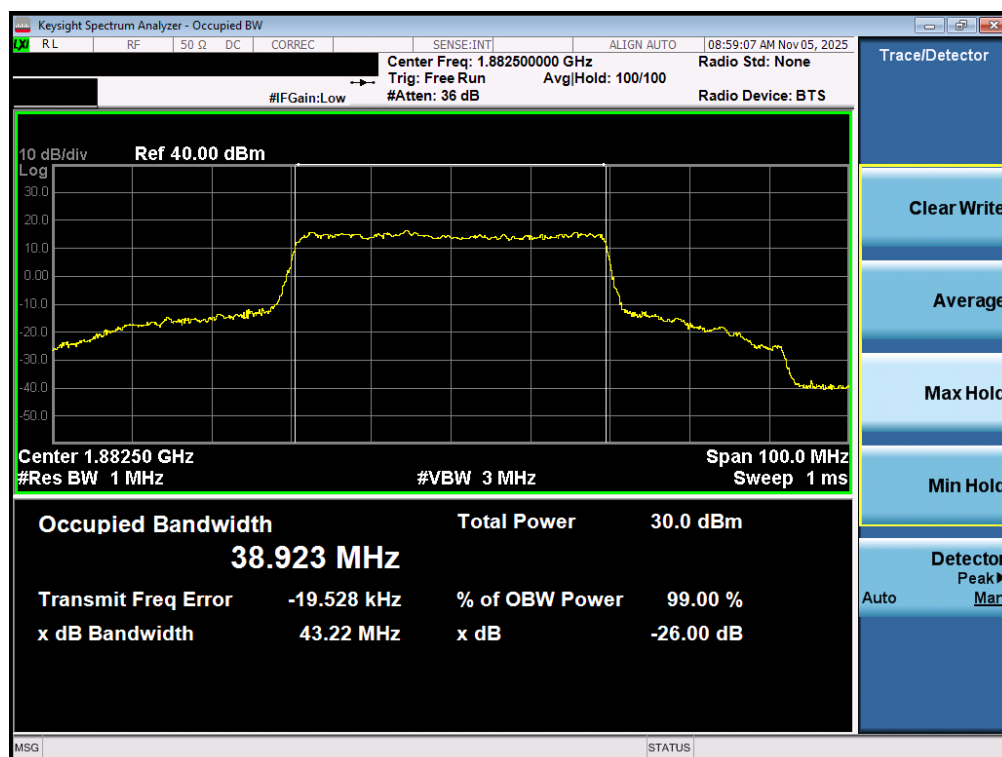

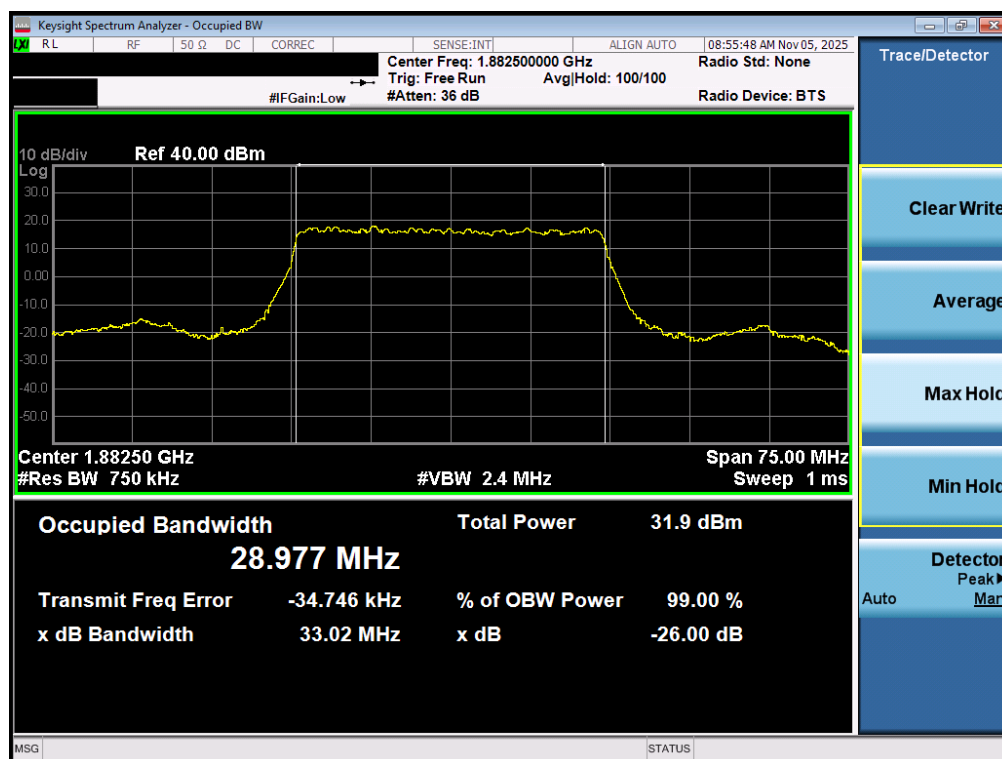

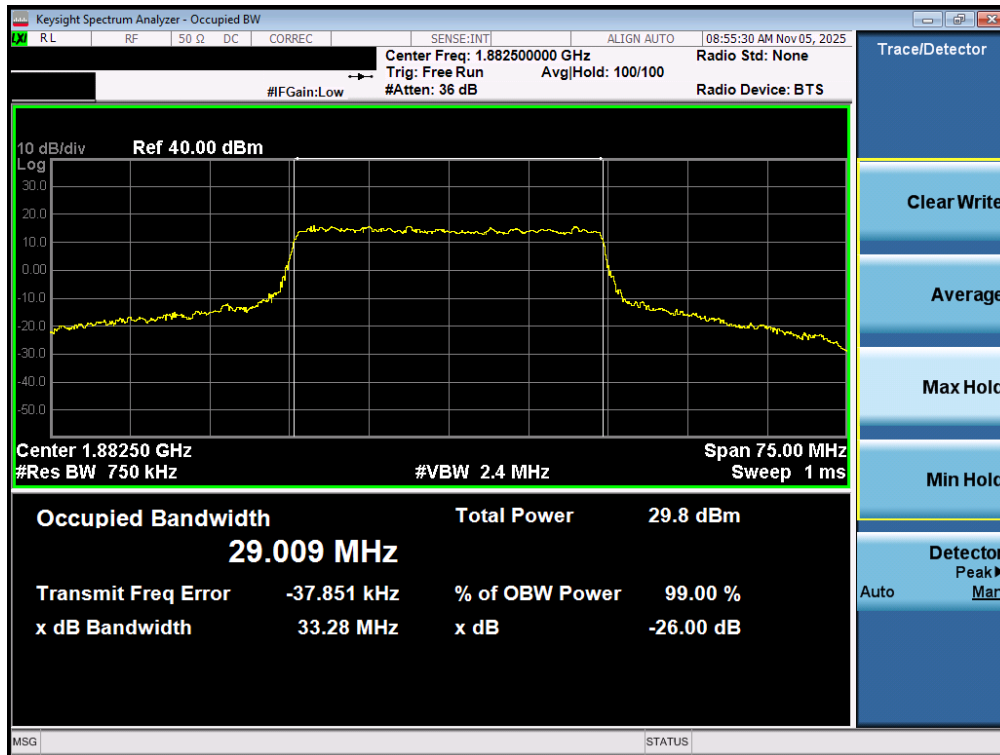

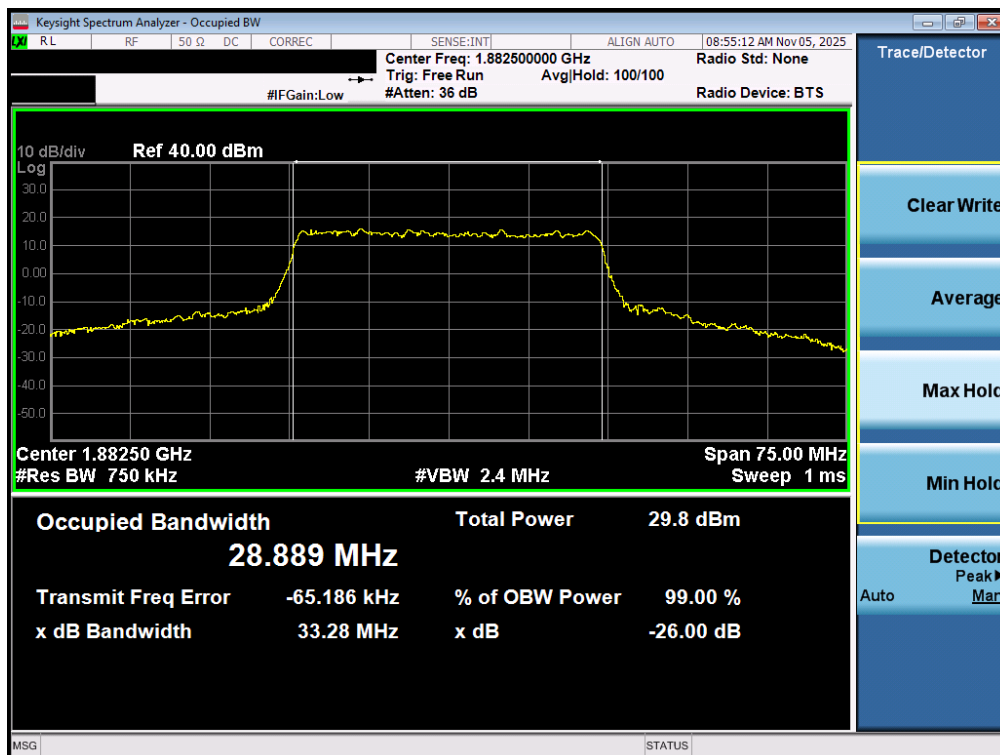

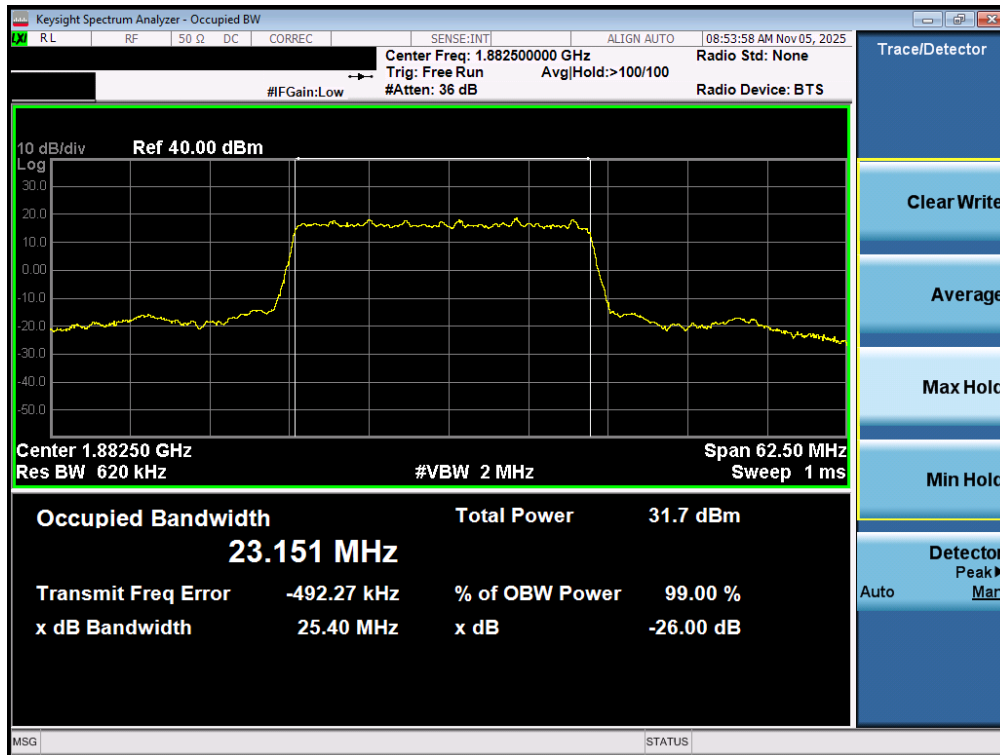

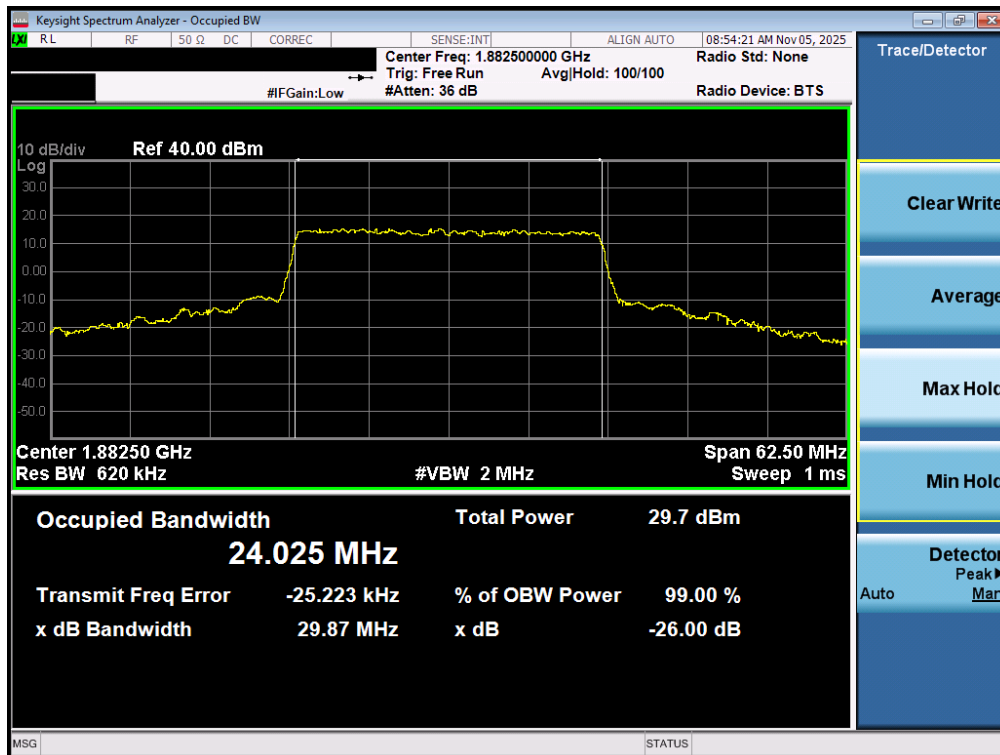

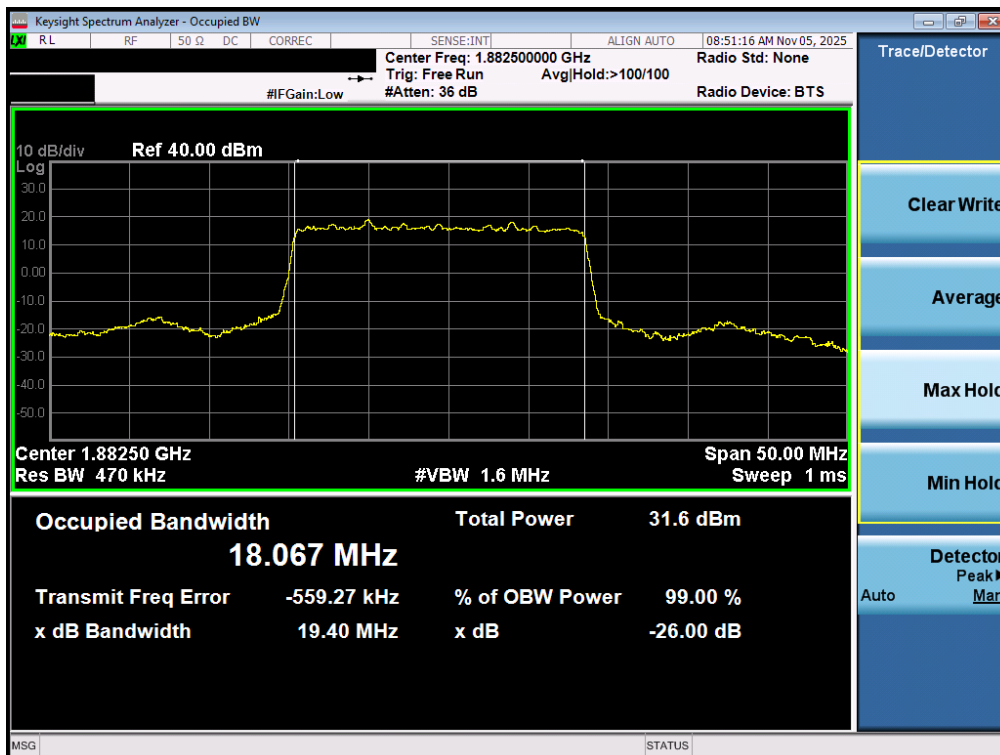

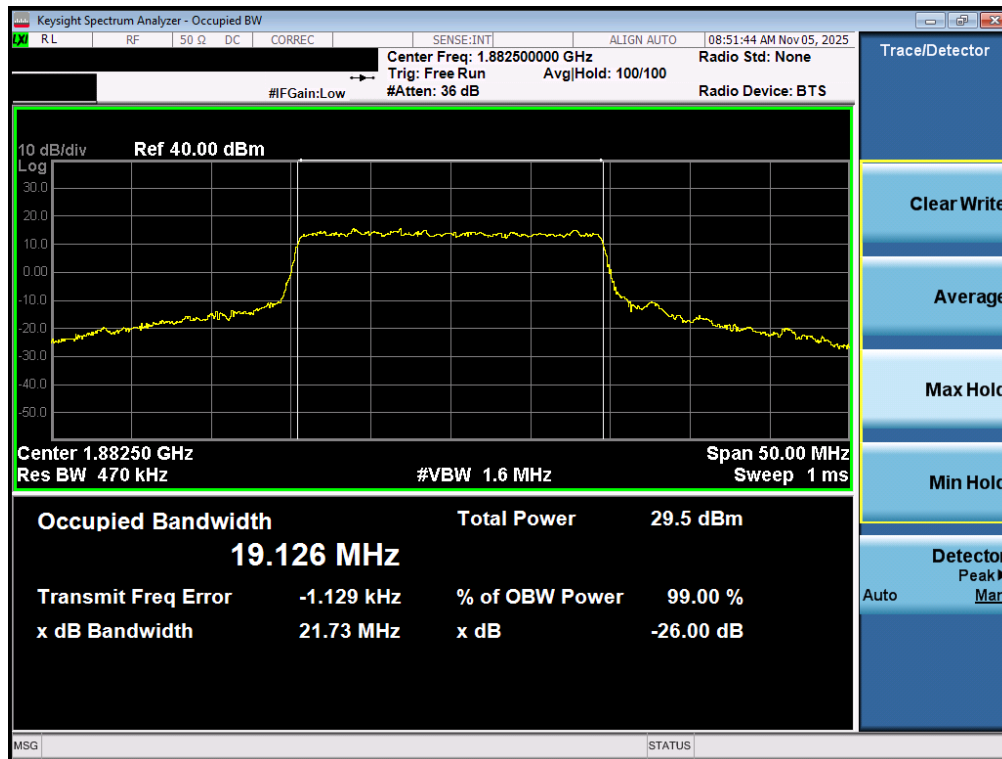

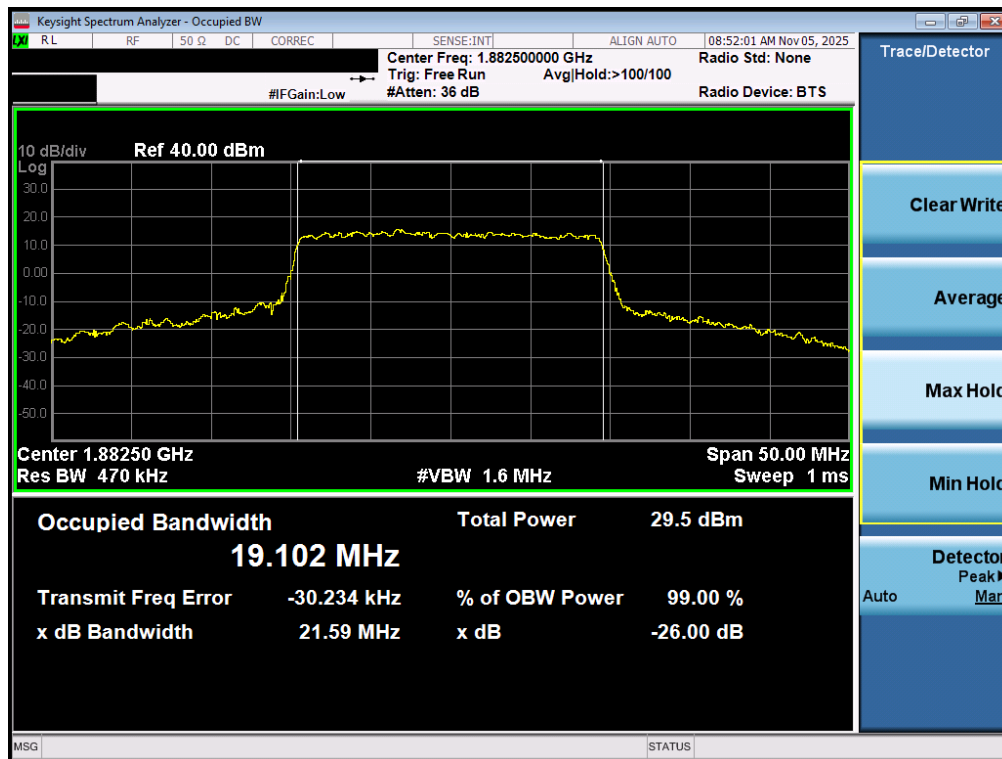

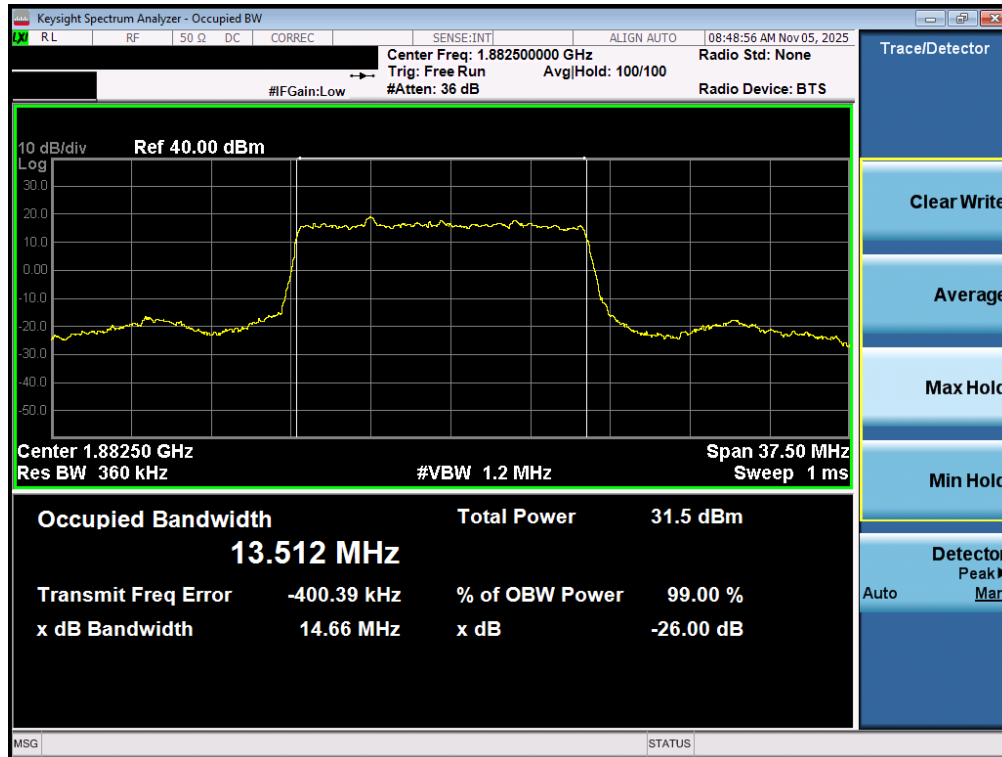

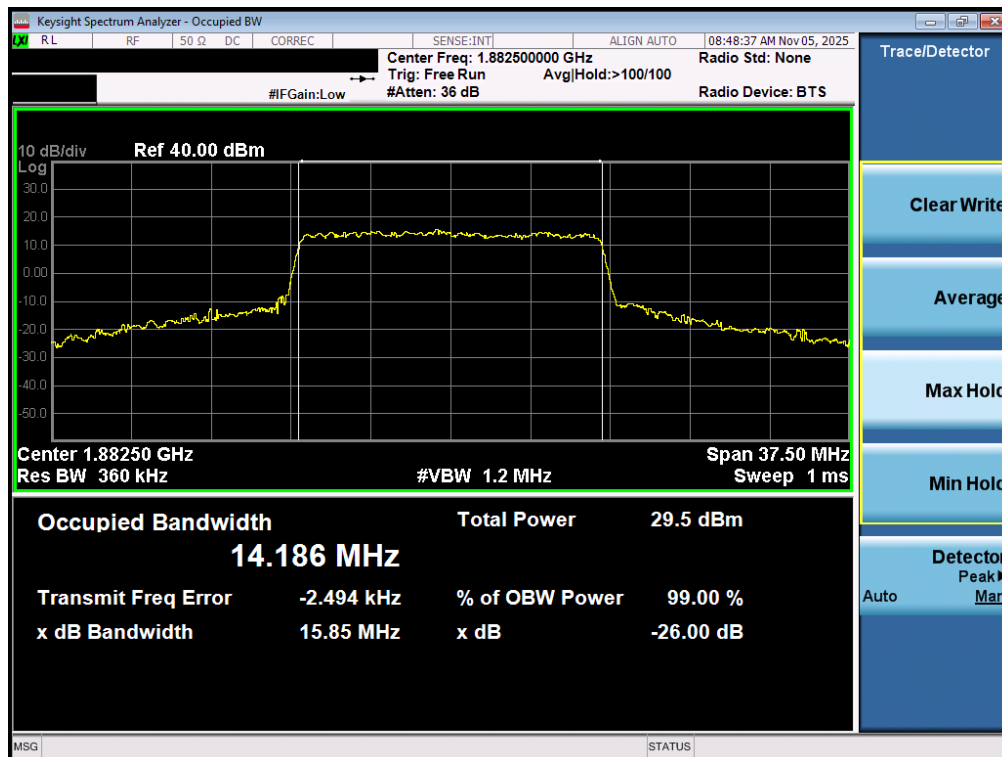

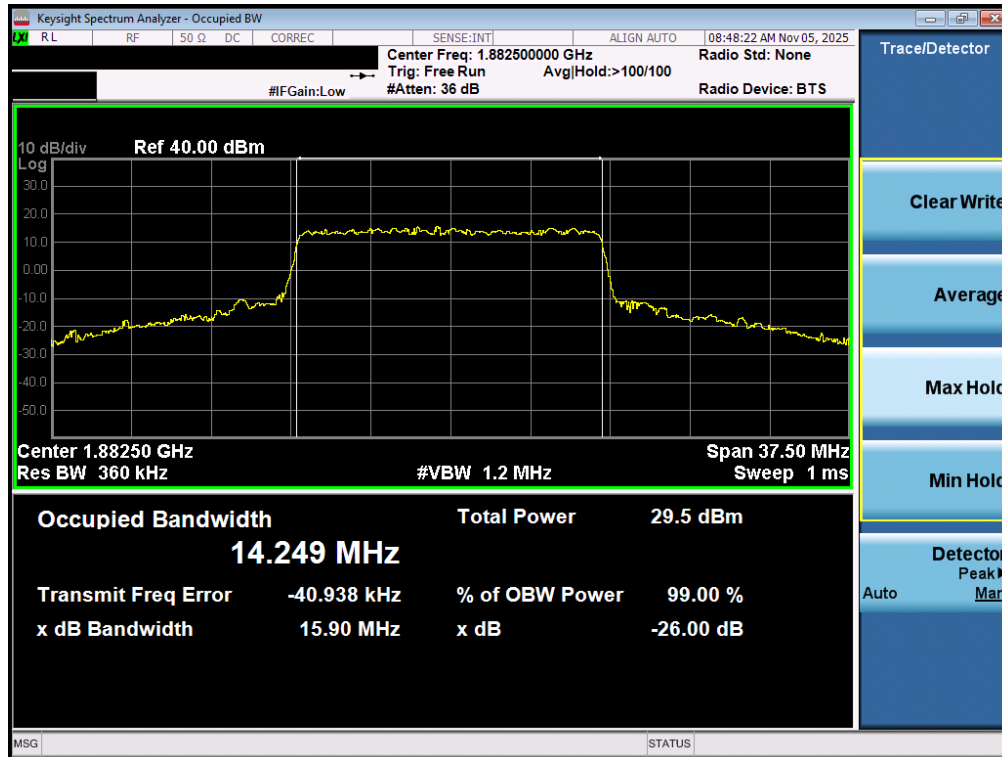

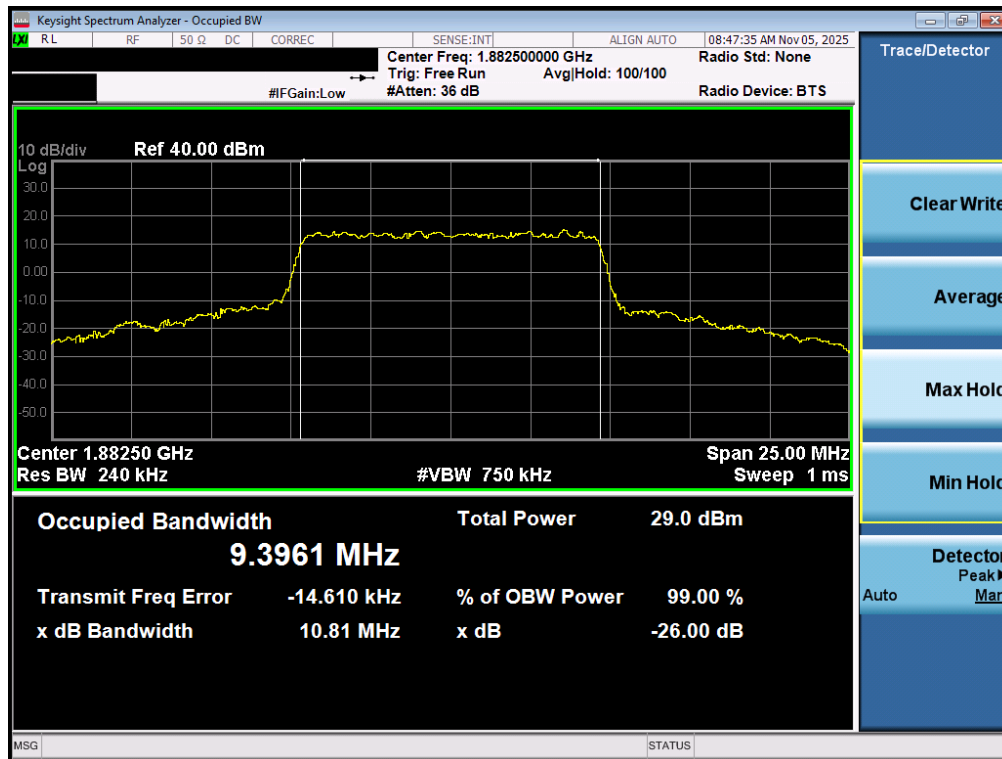

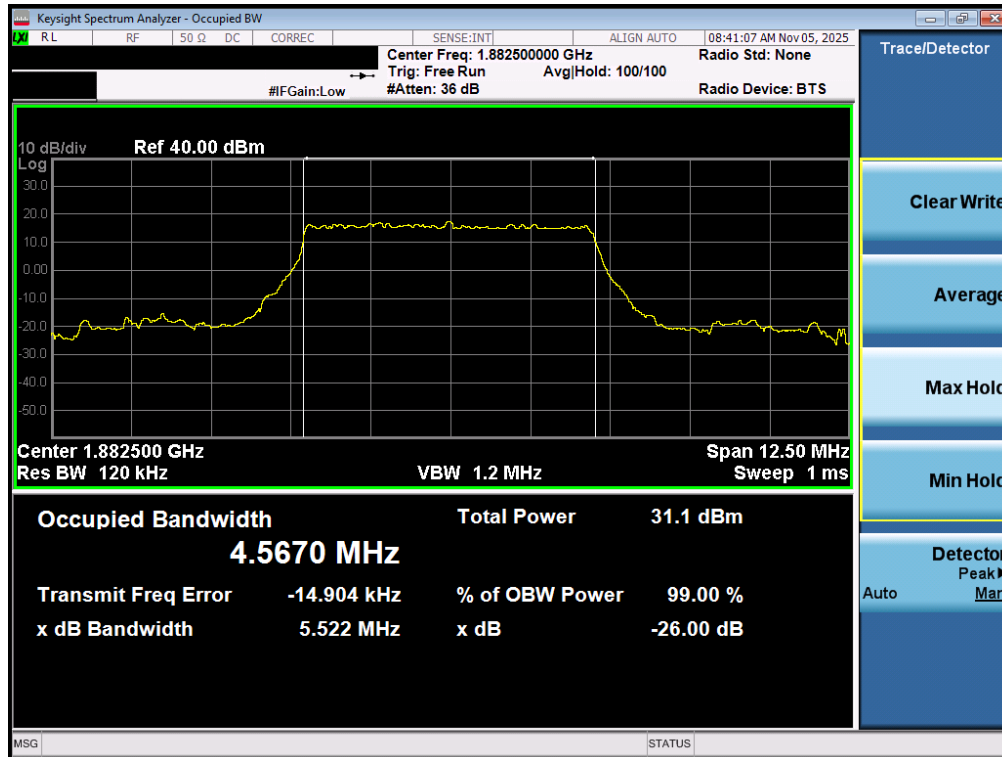

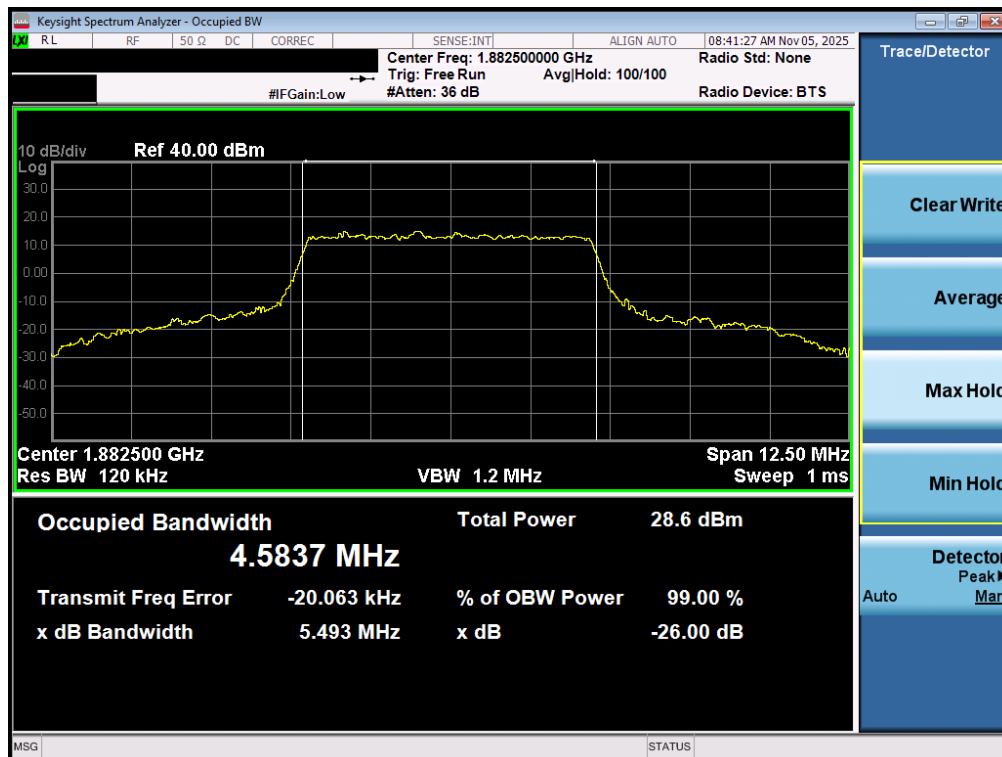

7.4 Spurious and Harmonic Emissions at Antenna Terminal

Test Overview

The level of the carrier and the various conducted spurious and harmonic frequencies is measured by means of a calibrated spectrum analyzer. The spectrum is scanned from the lowest frequency generated in the equipment up to a frequency including its 10th harmonic. All out of band emissions are measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at maximum power, and at the appropriate frequencies. All data rates were investigated to determine the worst-case configuration. All modes of operation were investigated and the worst-case configuration results are reported in this section.

The minimum permissible attenuation level of any spurious emission is $43 + 10 \log_{10}(P_{\text{Watts}})$, where P is the transmitter power in Watts.

Test Procedure Used

ANSI C63.26:2015 – Section 5.7.4

Test Settings

1. Start frequency was set to 30MHz and stop frequency was set to 20GHz (separated into at least two plots per channel)
2. Detector = RMS
3. Trace mode = trace average for continuous emissions, max hold for pulse emissions
4. Sweep time = auto couple
5. The trace was allowed to stabilize
6. Please see test notes below for RBW and VBW settings

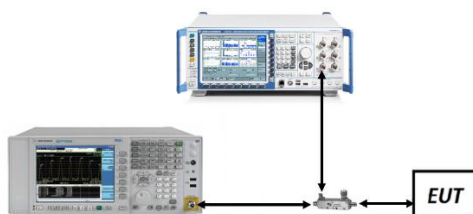


Figure 7-3. Test Instrument & Measurement Setup

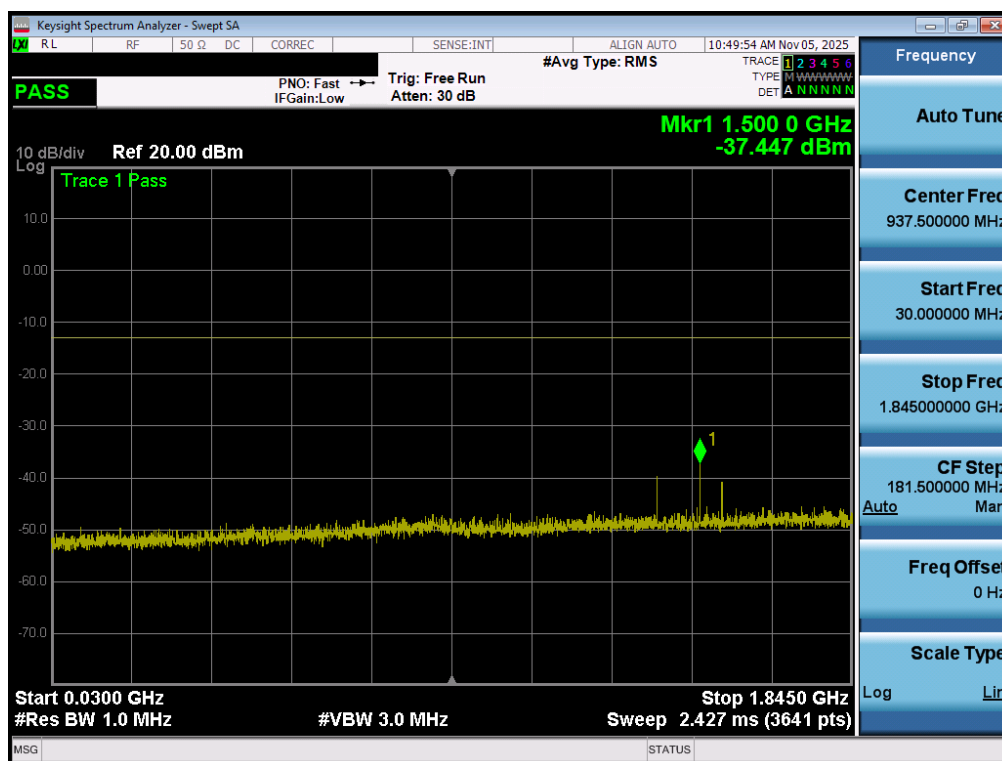

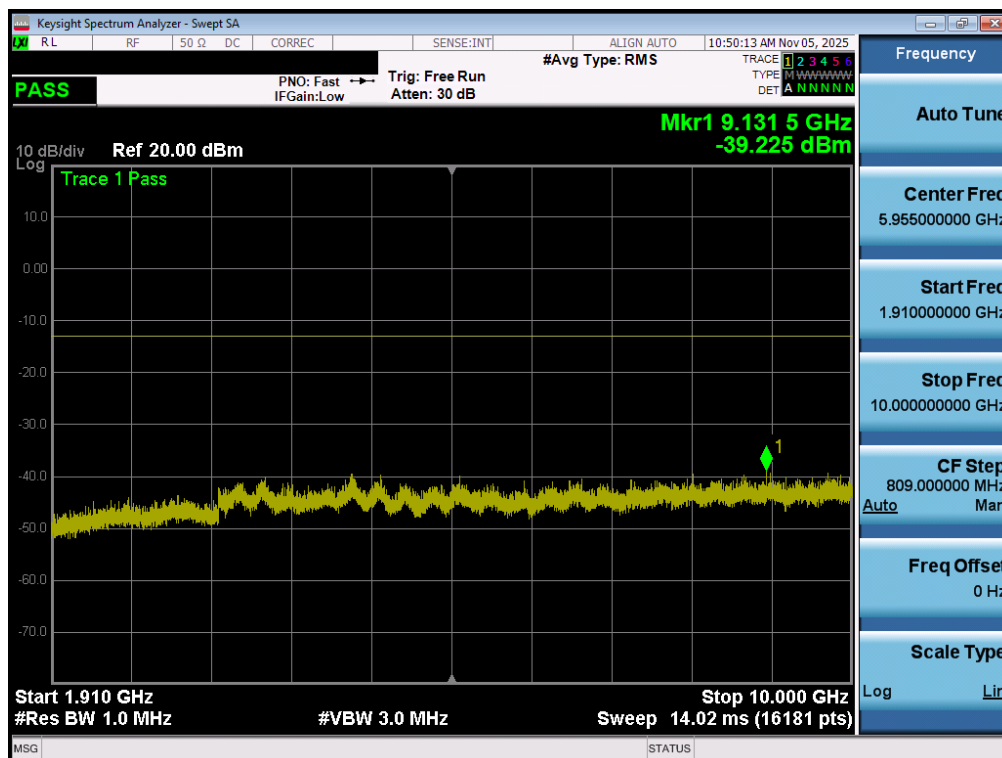

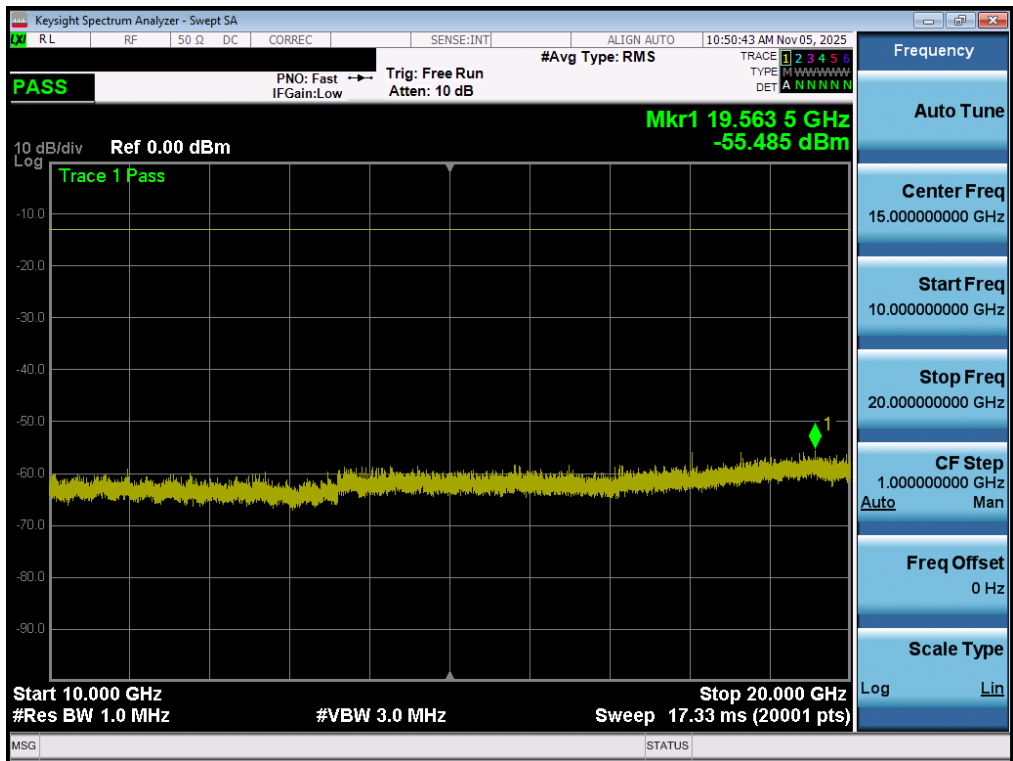


Plot 7-70. Conducted Spurious Plot (GPRS Ch. 512 - Ant1)

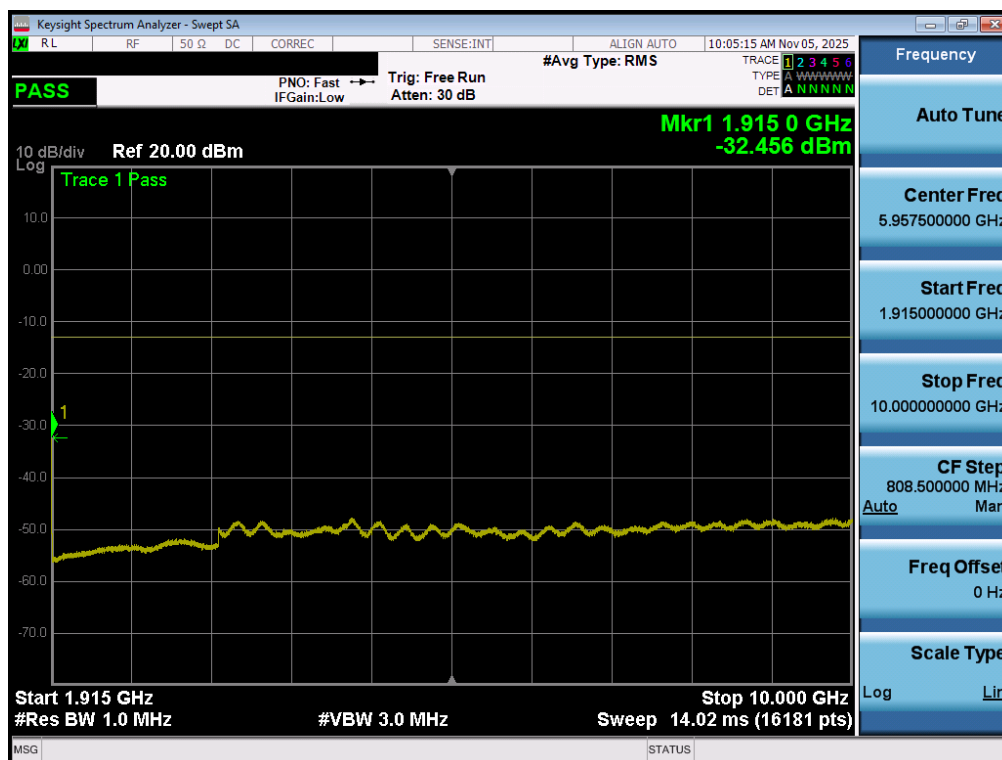
Plot 7-72. Conducted Spurious Plot (GPRS Ch. 512 - Ant1)

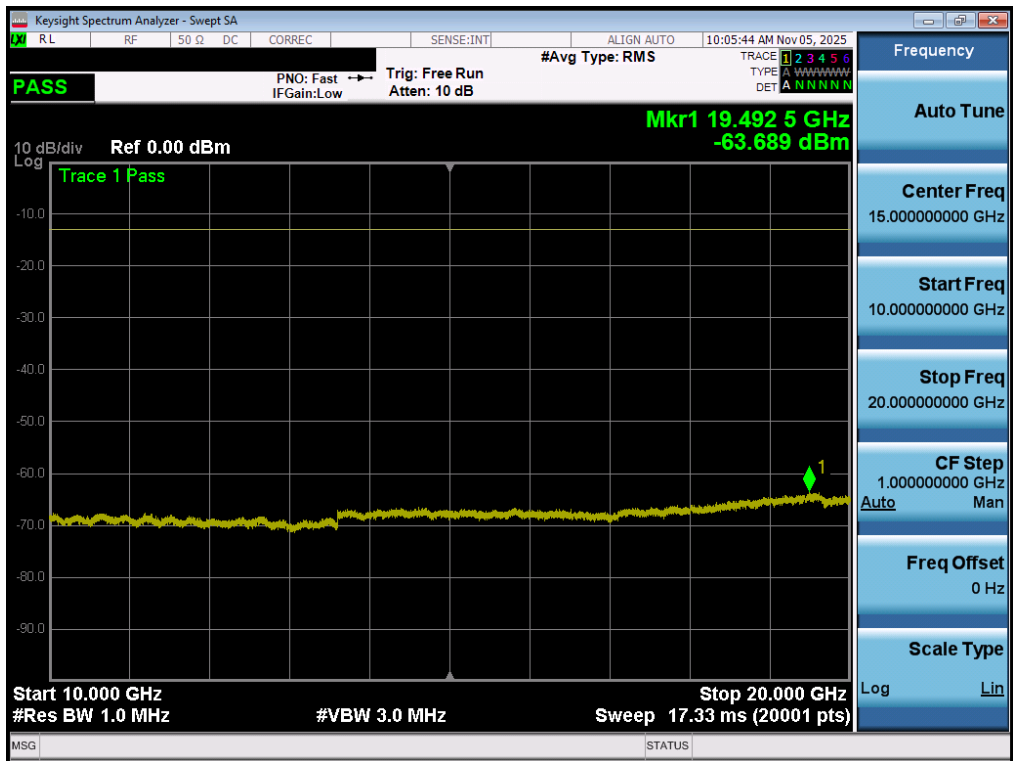


Plot 7-73. Conducted Spurious Plot (WCDMA Ch. 9538 - Ant1)

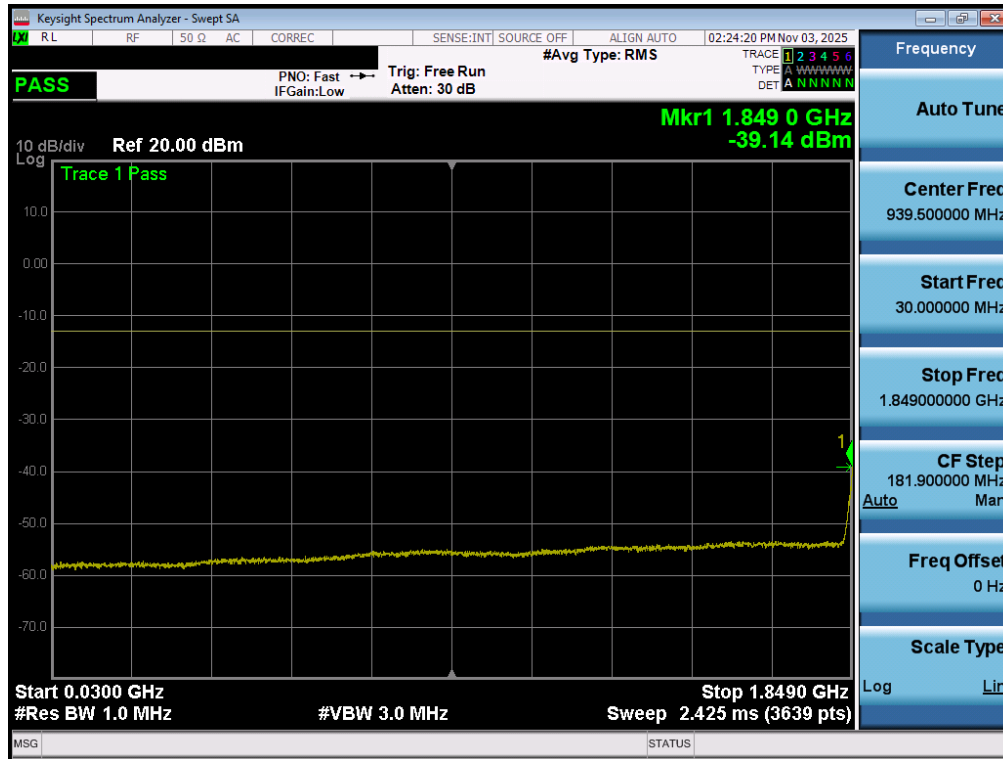

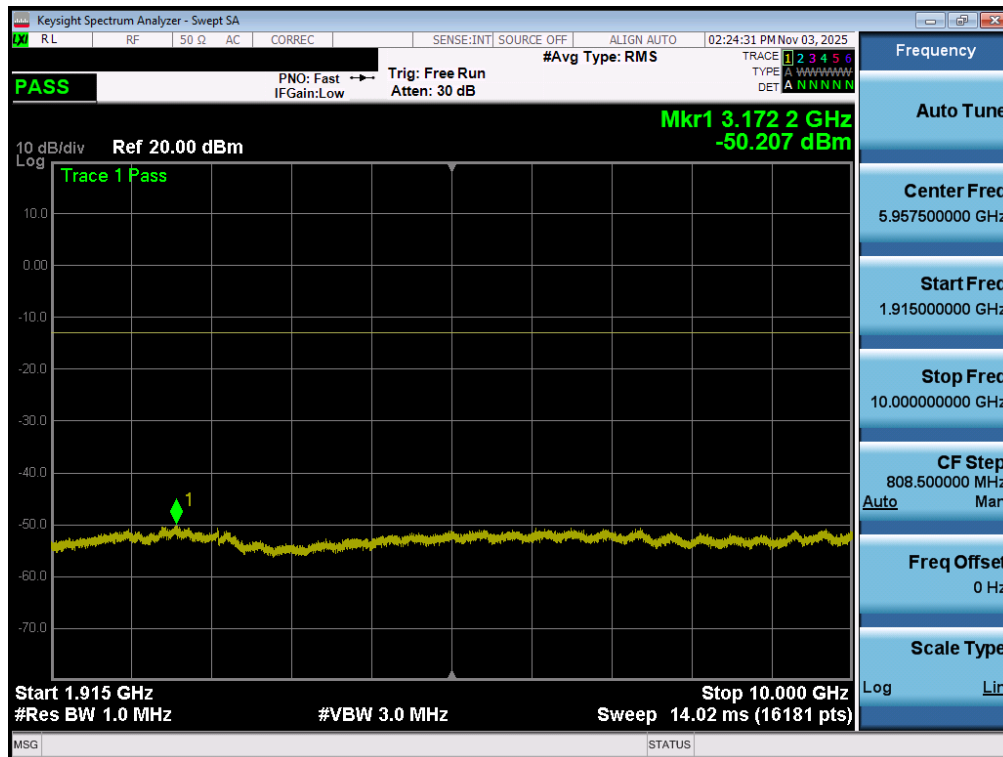
Plot 7-75. Conducted Spurious Plot (WCDMA Ch. 9538 - Ant1)

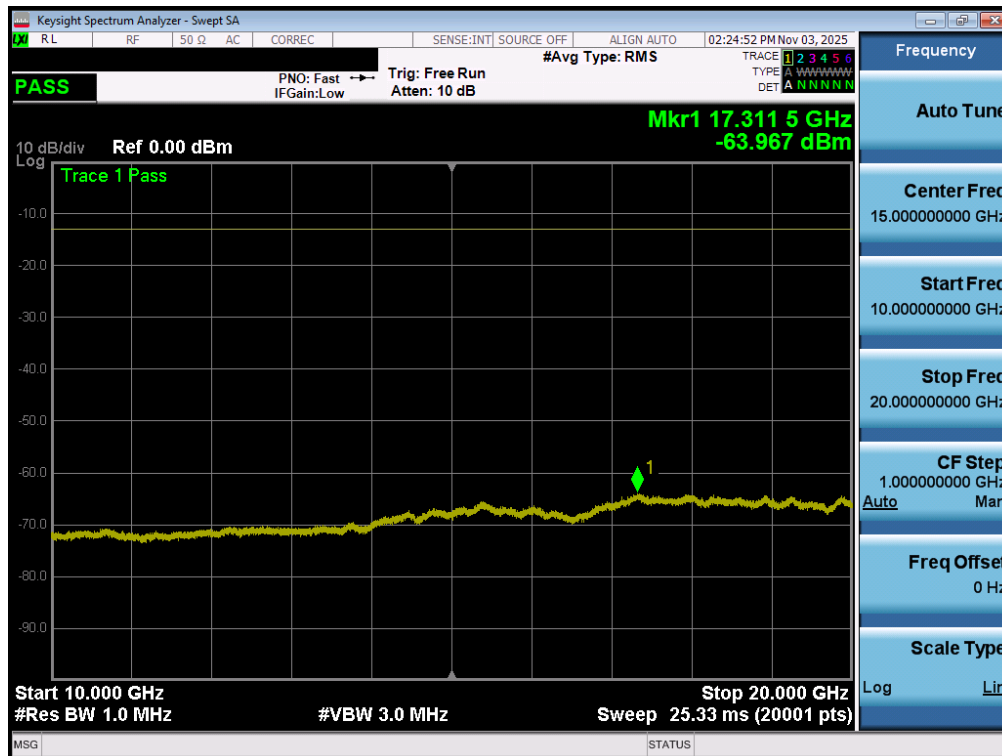


Plot 7-76. Conducted Spurious Plot (LTE Band 25/2 - 20MHz QPSK - 1RB - Low Channel - Ant1)

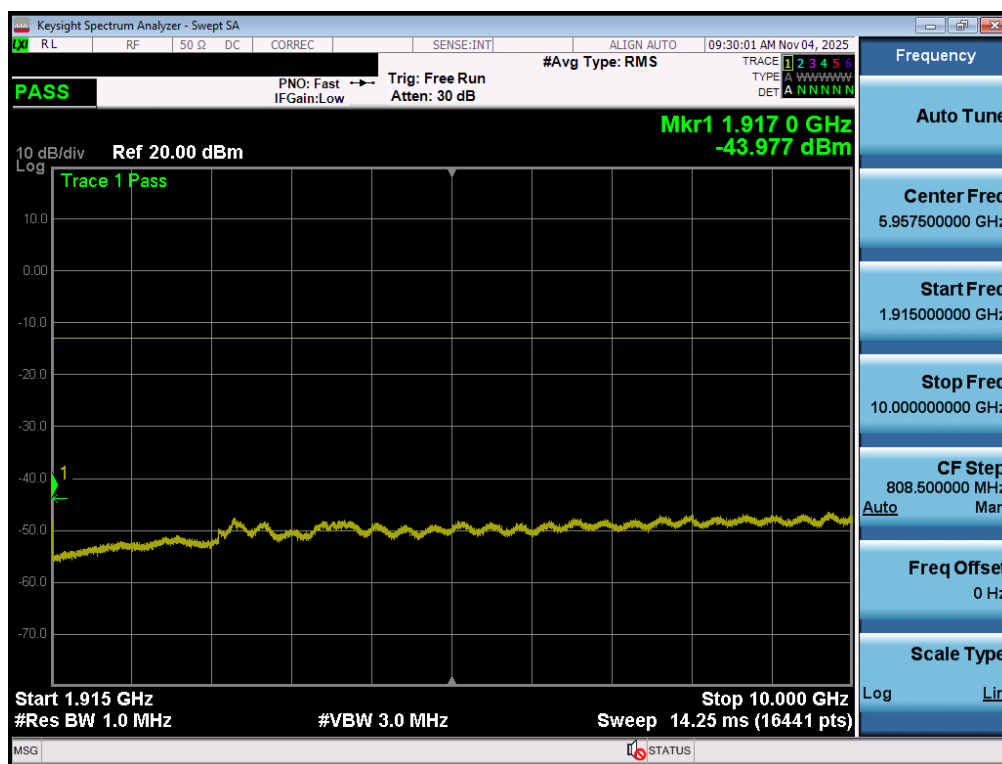
Plot 7-78. Conducted Spurious Plot (LTE Band 25/2 - 20MHz QPSK - 1RB - Low Channel - Ant1)

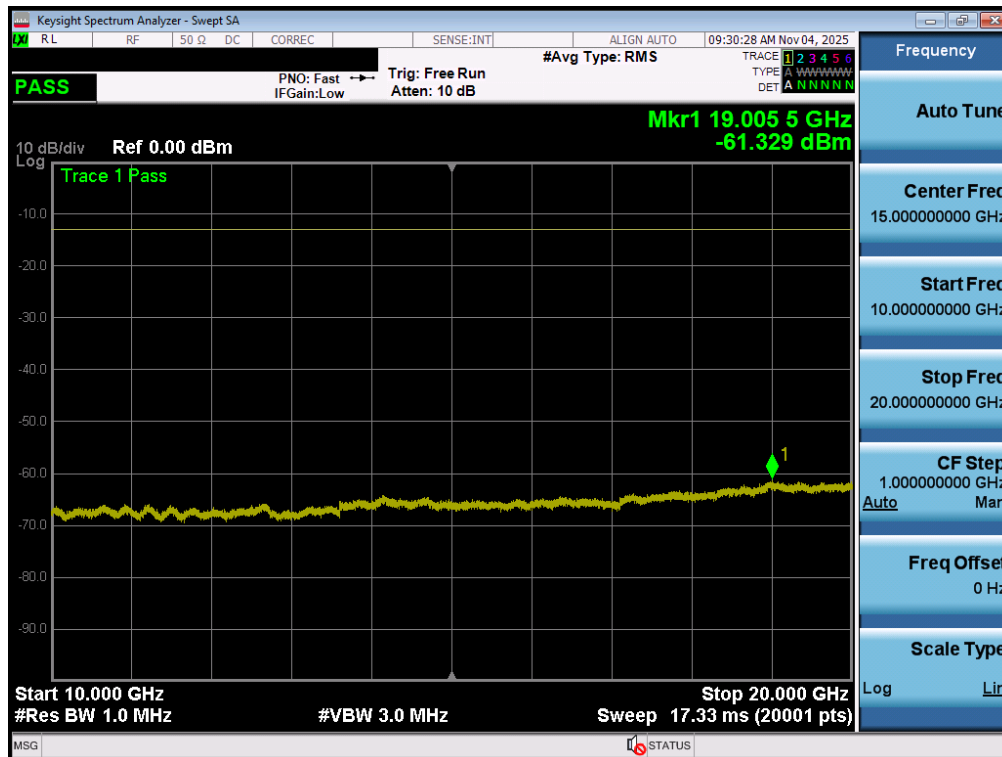


Plot 7-79. Conducted Spurious Plot (NR Band n25/2 -40.0MHz - 1RB - Low Channel - Ant1)

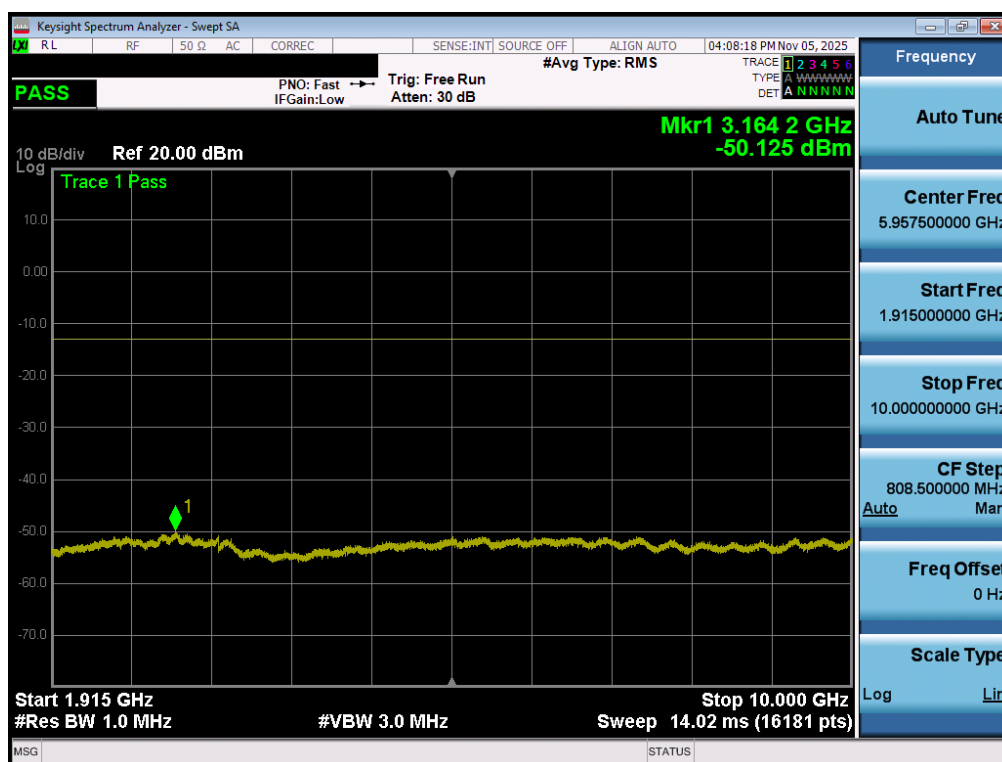

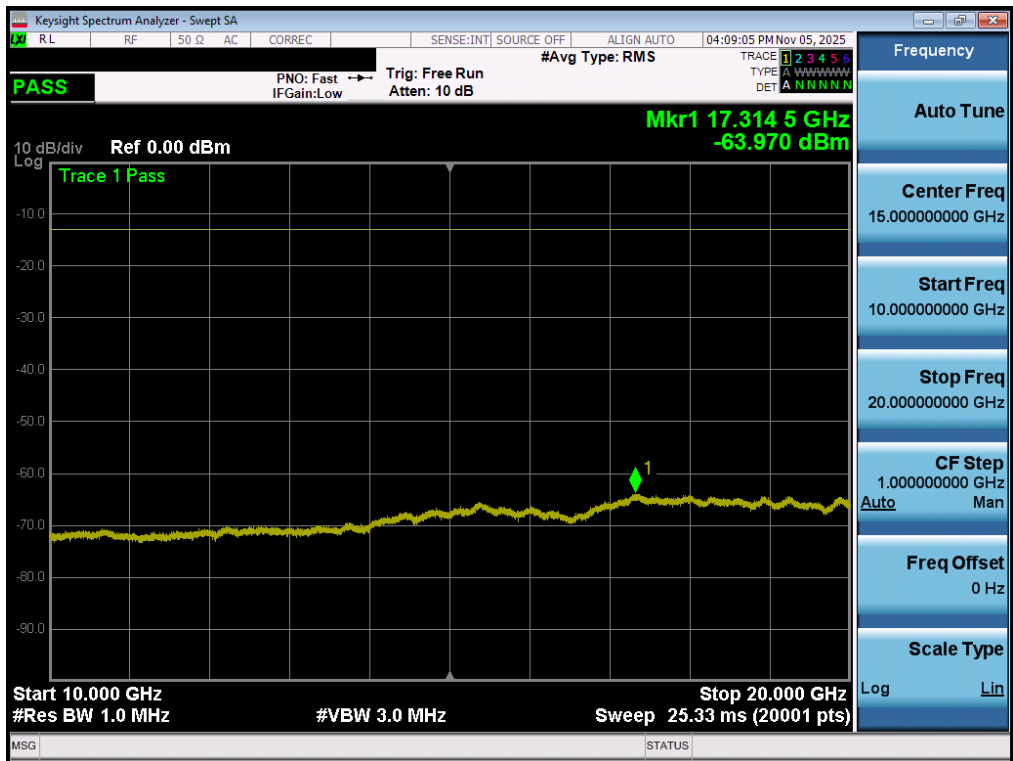


Plot 7-82. Conducted Spurious Plot (LTE Band 25/2 - 20MHz QPSK - 1RB - Low Channel - Ant2)

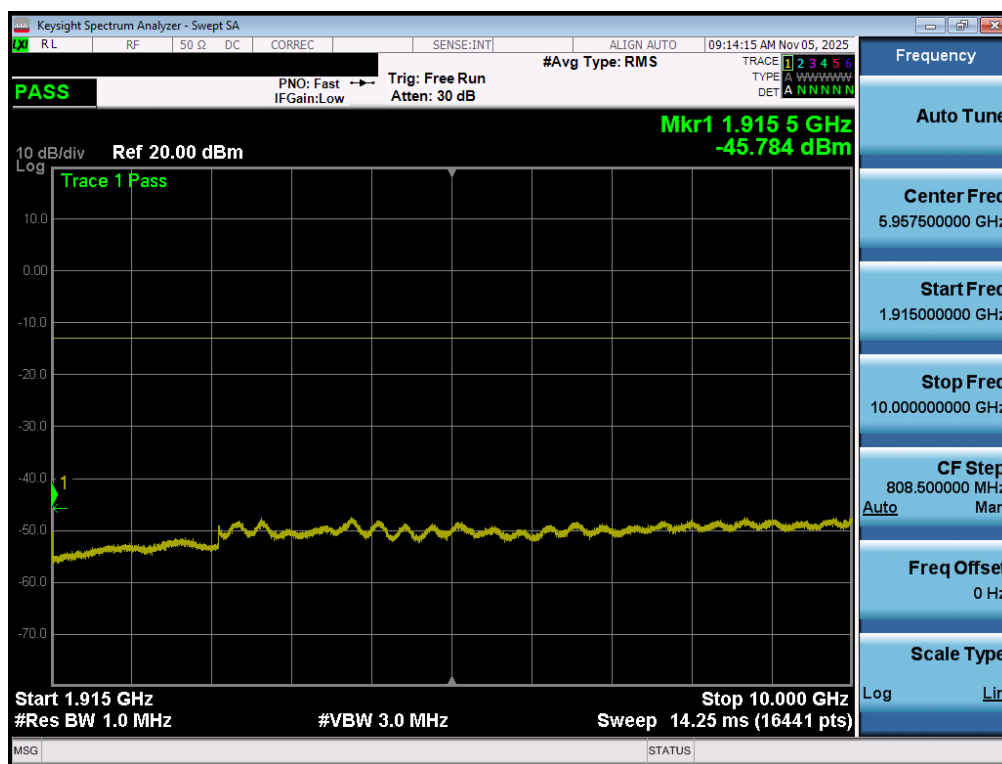
Plot 7-84. Conducted Spurious Plot (LTE Band 25/2 - 20MHz QPSK - 1RB - Low Channel - Ant2)

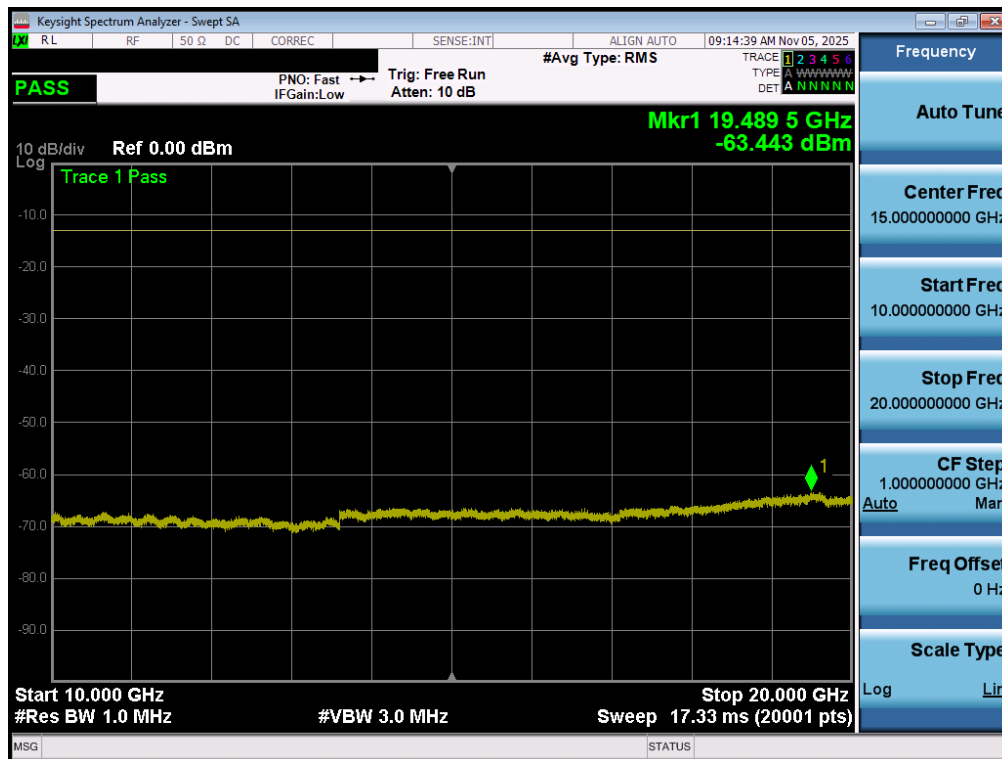


Plot 7-85. Conducted Spurious Plot (NR Band n25/2 -40.0MHz - 1RB - Low Channel - Ant2)

7.5 Band Edge Emissions at Antenna Terminal

Test Overview

All out of band emissions are measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at maximum power, and at the appropriate frequencies. All data rates were investigated to determine the worst-case configuration. All modes of operation were investigated and the worst-case configuration results are reported in this section.

The minimum permissible attenuation level of any spurious emission is $43 + 10 \log_{10}(P_{\text{Watts}})$, where P is the transmitter power in Watts.

Test Procedure Used

ANSI C63.26:2015 – Section 5.7.3

Test Settings

1. Start and stop frequency were set such that the band edge would be placed in the center of the plot
2. Span was set large enough so as to capture all out of band emissions near the band edge
3. RBW $\geq 1\%$ of the emission bandwidth
4. VBW $\geq 3 \times$ RBW
5. Detector = RMS
6. Number of sweep points $\geq 2 \times$ Span/RBW
7. Trace mode = trace average for continuous emissions, max hold for pulse emissions
8. Sweep time = auto couple
9. The trace was allowed to stabilize

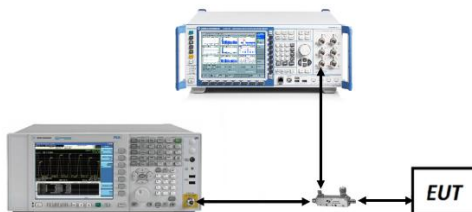


Figure 7-4. Test Instrument & Measurement Setup

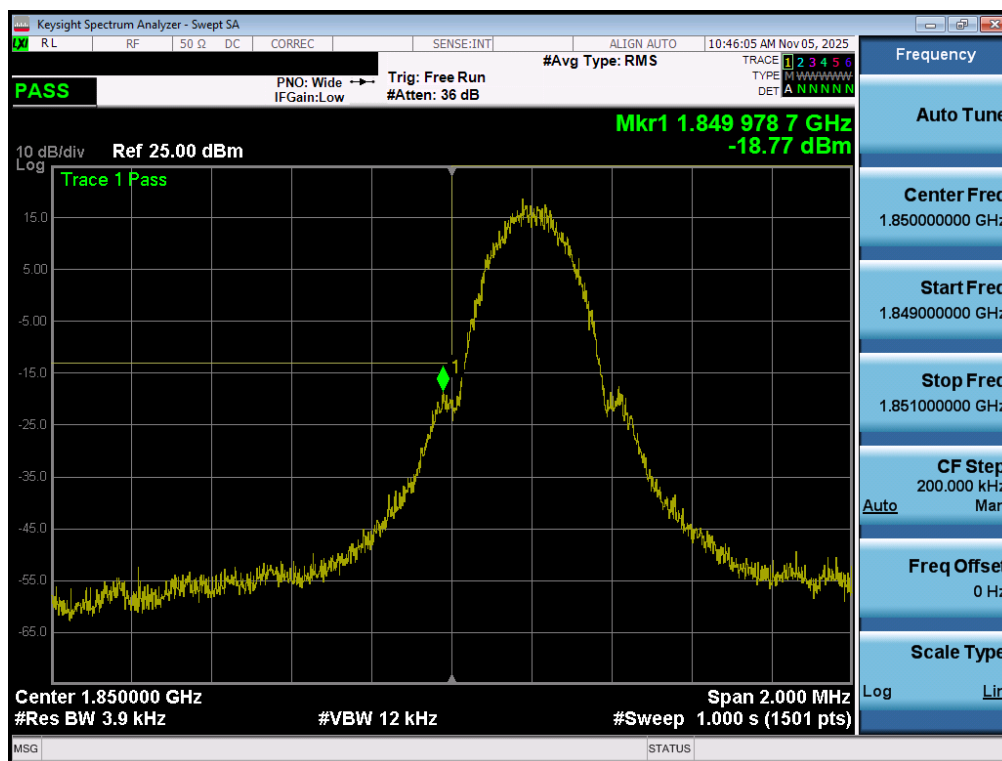

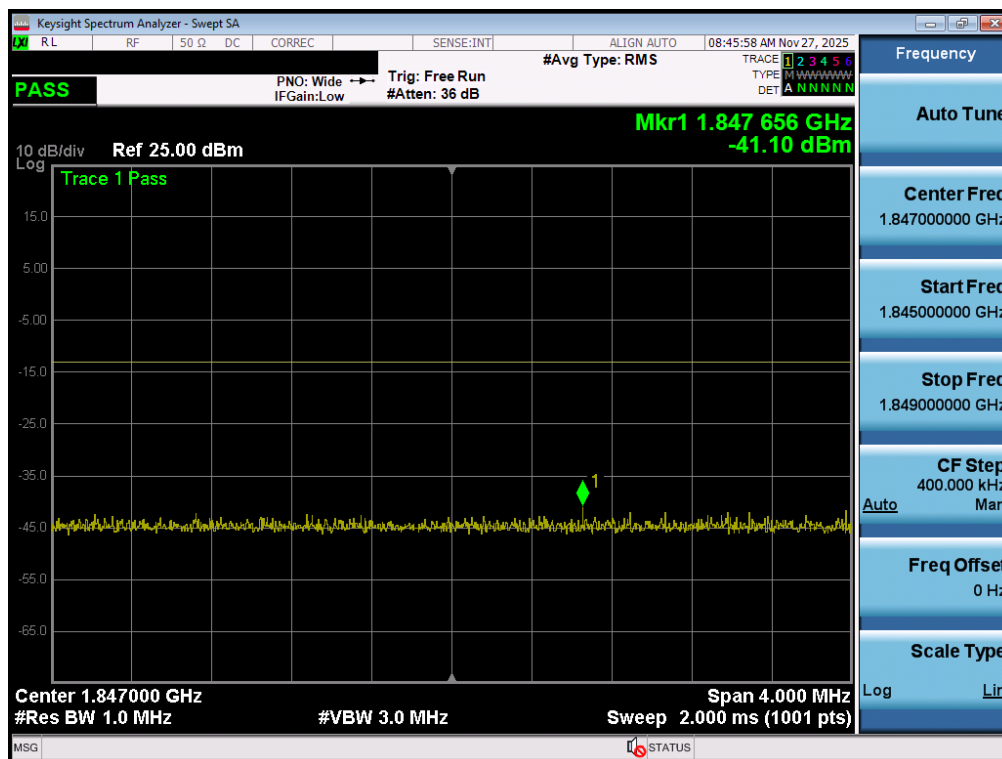

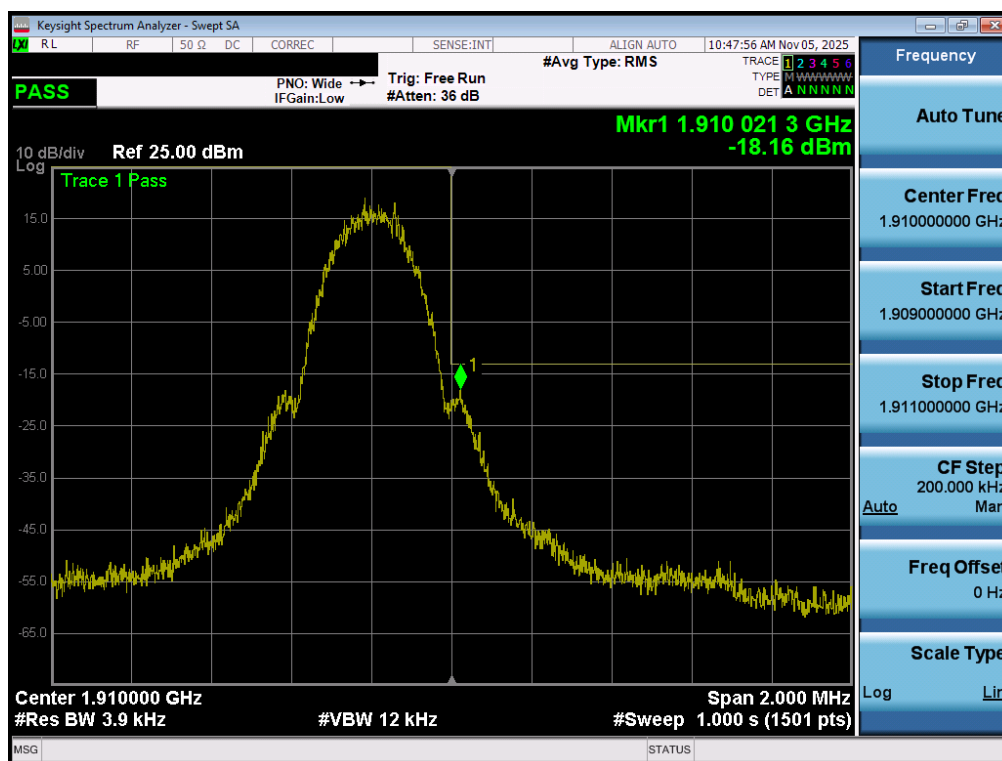


Plot 7-88. Lower Band Edge Plot (GPRS PCS – Ch. 810 - Ant1)

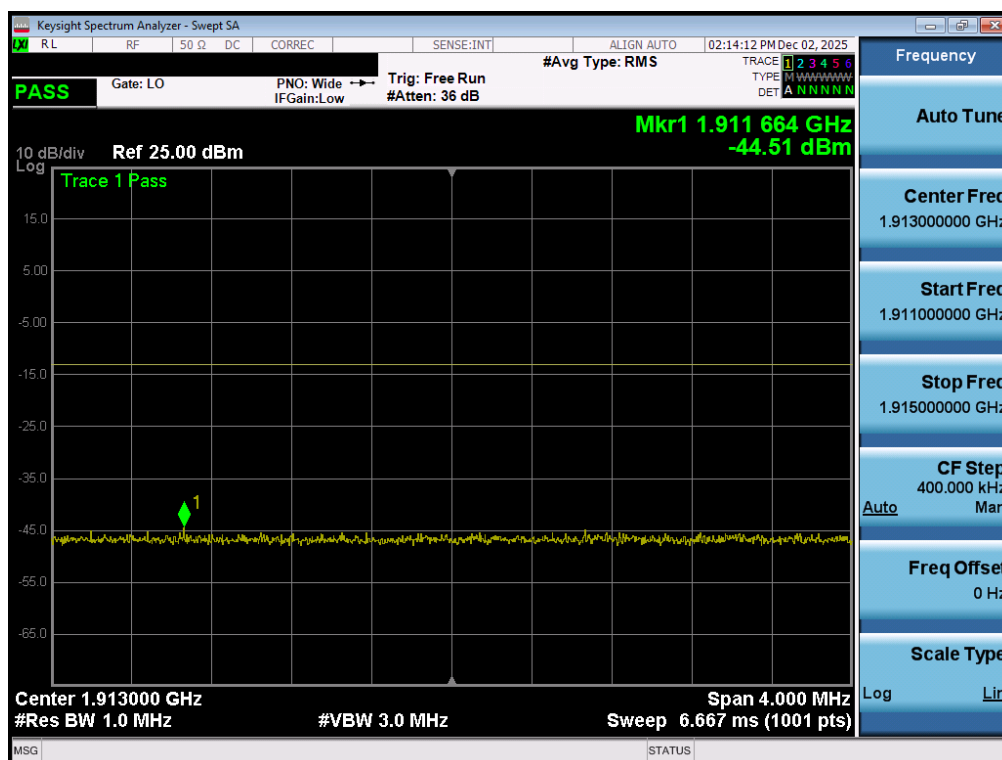


Plot 7-89. Extended Lower Band Edge Plot (GPRS PCS – Ch. 512 - Ant1)

Plot 7-90. Upper Band Edge Plot (GPRS PCS – Ch. 810 - Ant1)



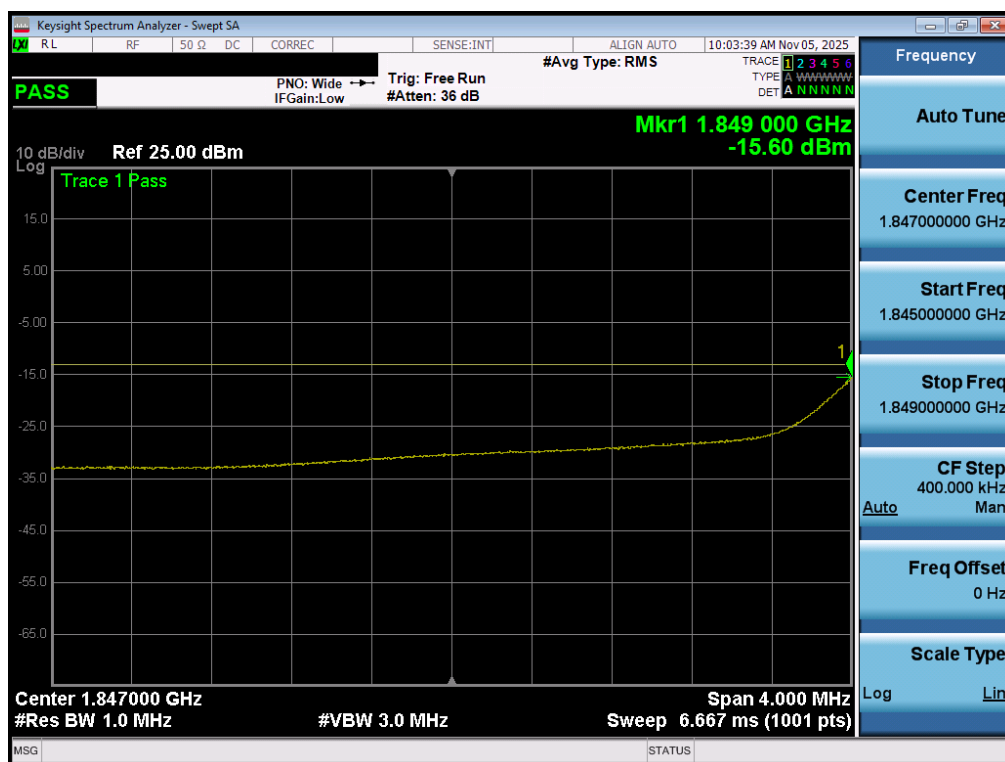
Plot 7-91. Extended Upper Band Edge Plot (GPRS PCS – Ch. 512 - Ant1)

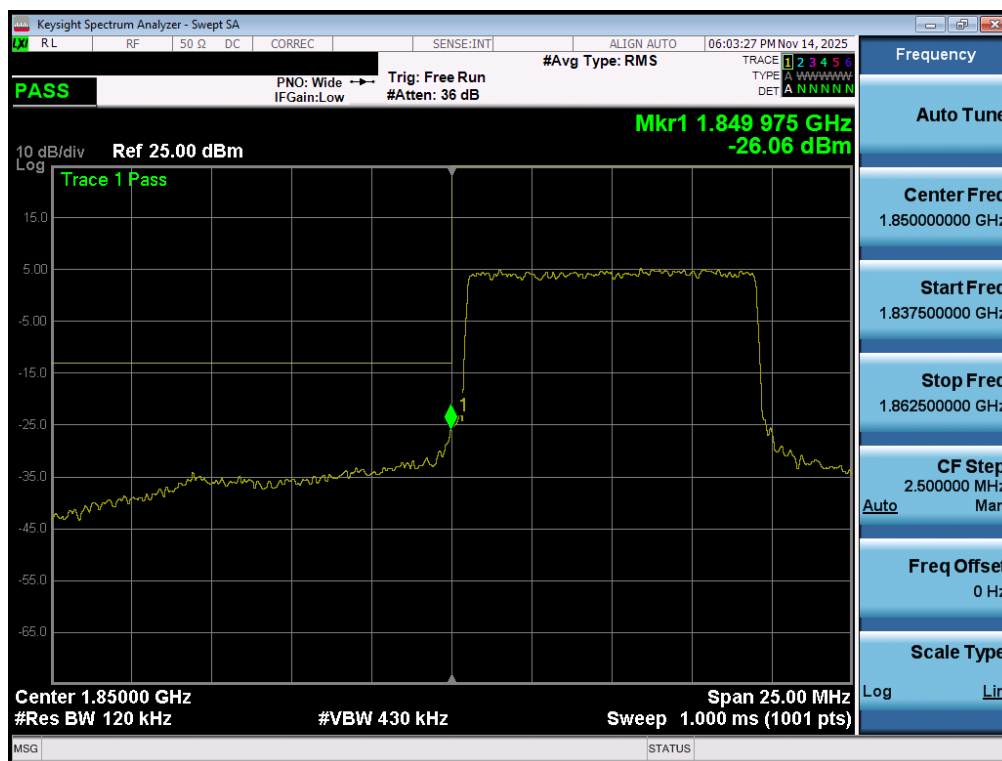
Plot 7-94. Upper Band Edge Plot (WCDMA PCS – Ch. 9538 - Ant1)



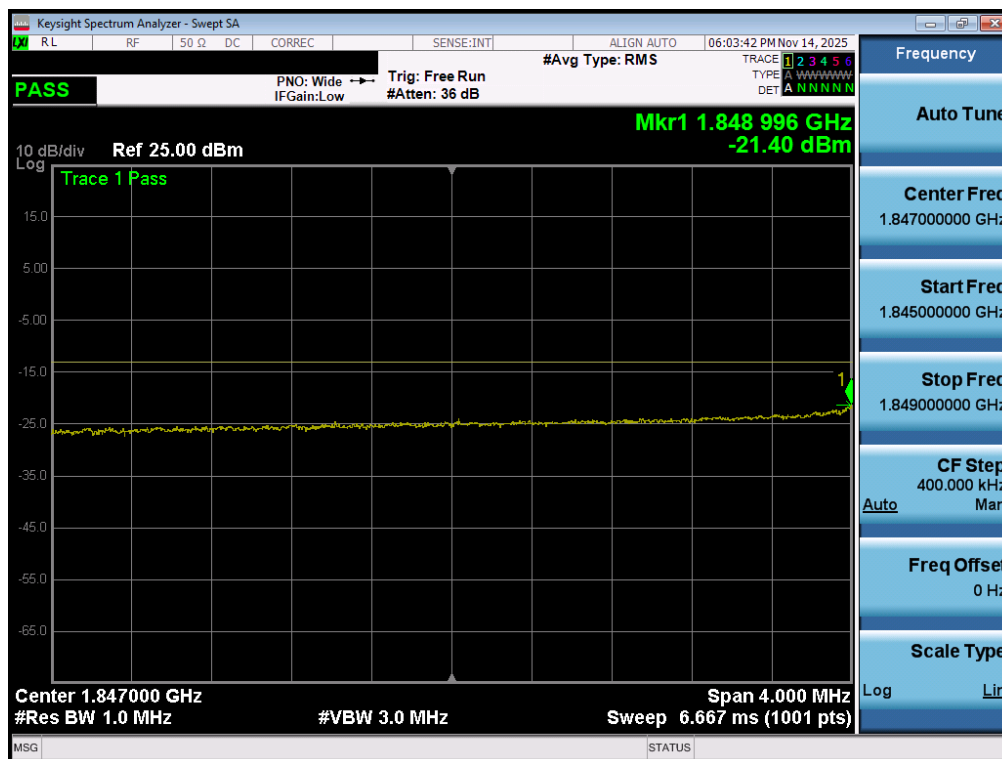
Plot 7-95. Extended Upper Band Edge Plot (WCDMA PCS – Ch. 9538 - Ant1)

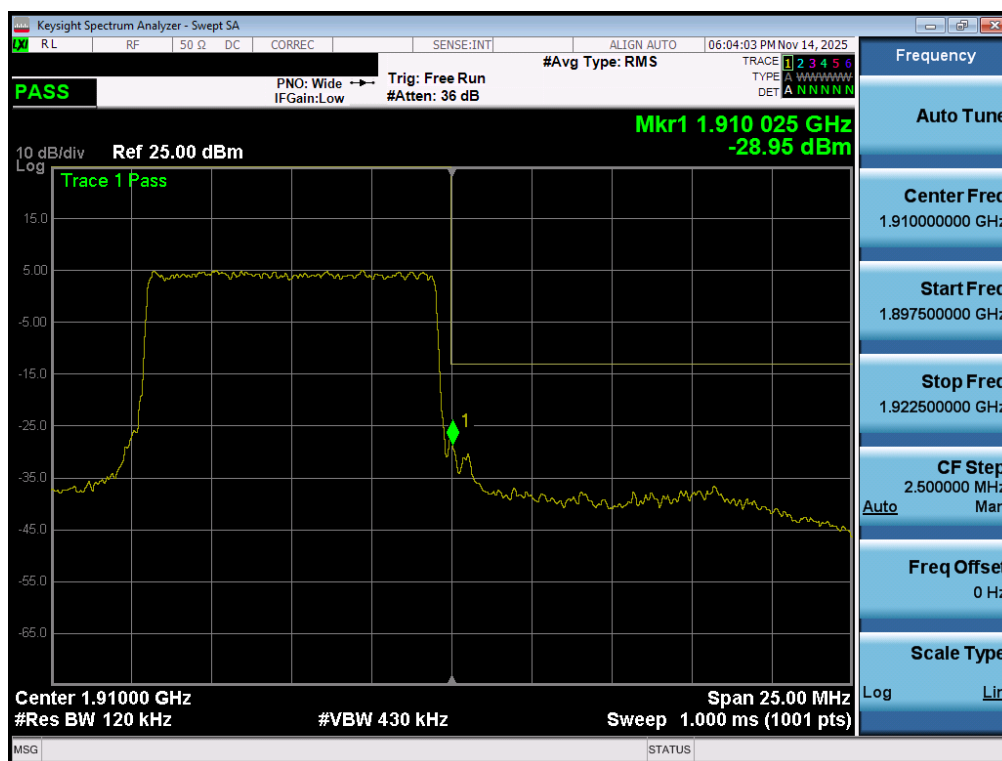


Plot 7-96. Lower Band Edge Plot (LTE Band 25/2 - 10MHz QPSK – Full RB - Ant1)

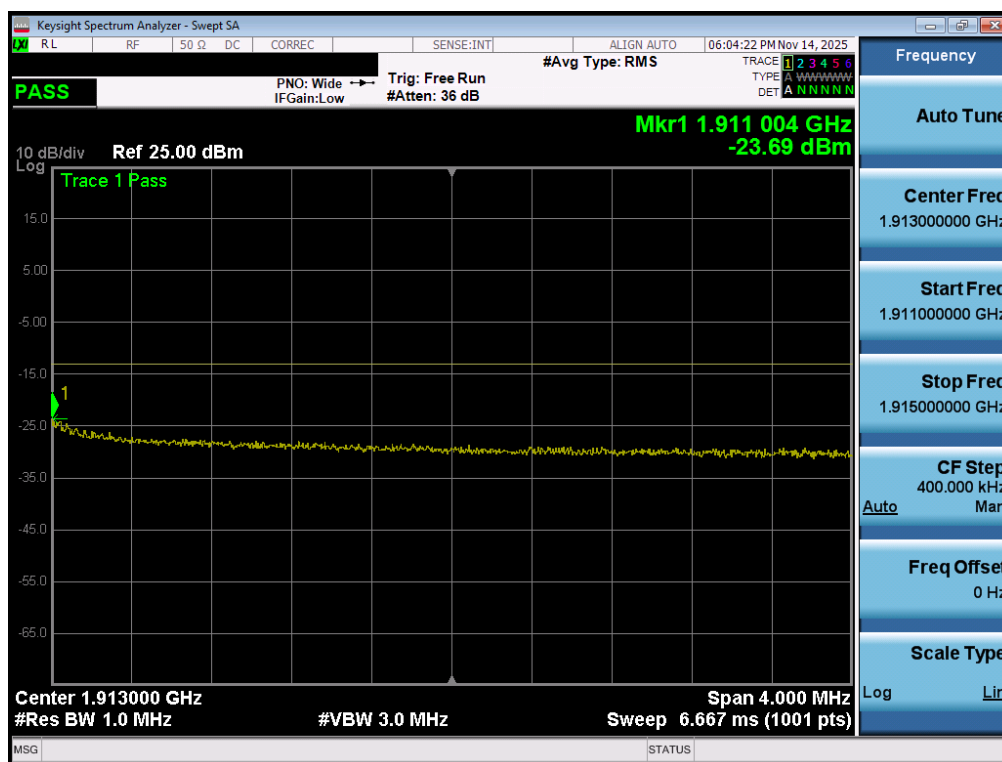


Plot 7-97. Extended Lower Band Edge Plot (LTE Band 25/2 - 10MHz QPSK – Full RB - Ant1)

Plot 7-98. Upper Band Edge Plot (LTE Band 2 - 10MHz QPSK – Full RB - Ant1)

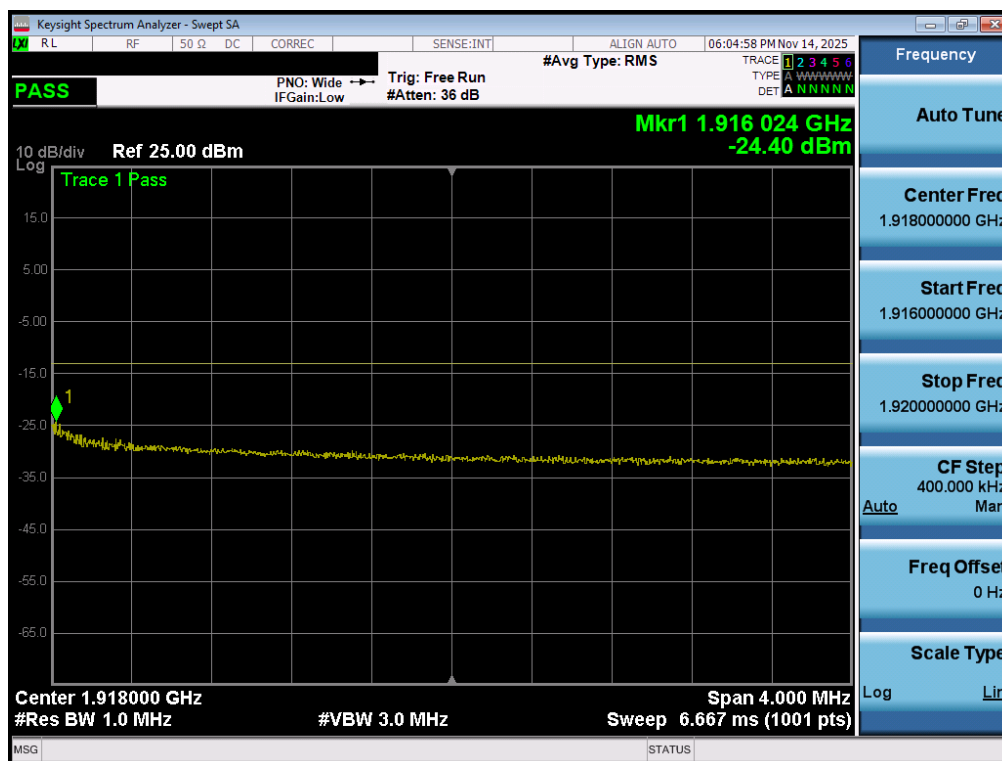


Plot 7-99. Extended Upper Band Edge Plot (LTE Band 2 - 10MHz QPSK – Full RB - Ant1)

Plot 7-100. Upper Band Edge Plot (LTE Band 25 - 10MHz QPSK – Full RB - Ant1)



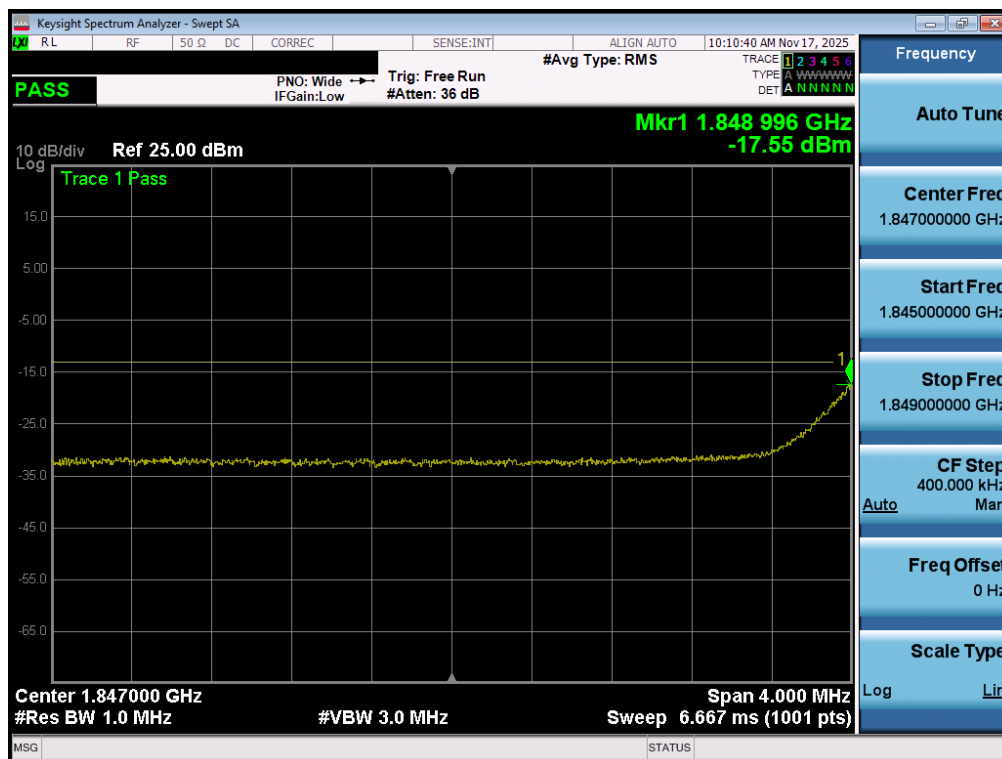
