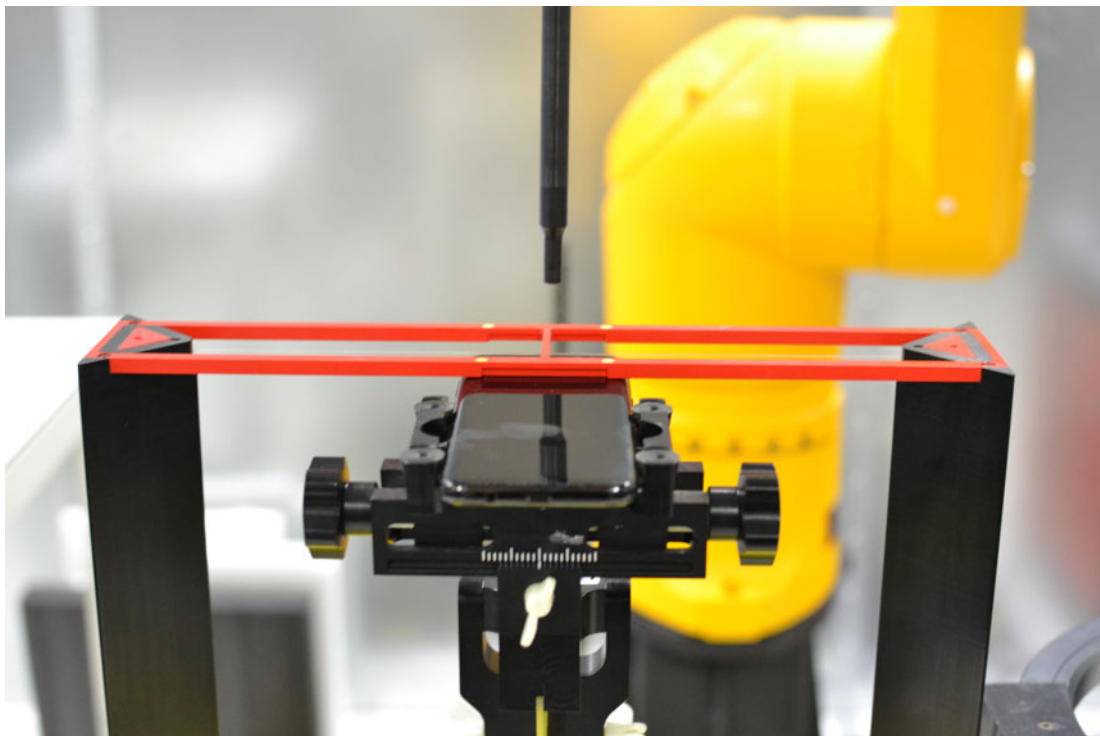

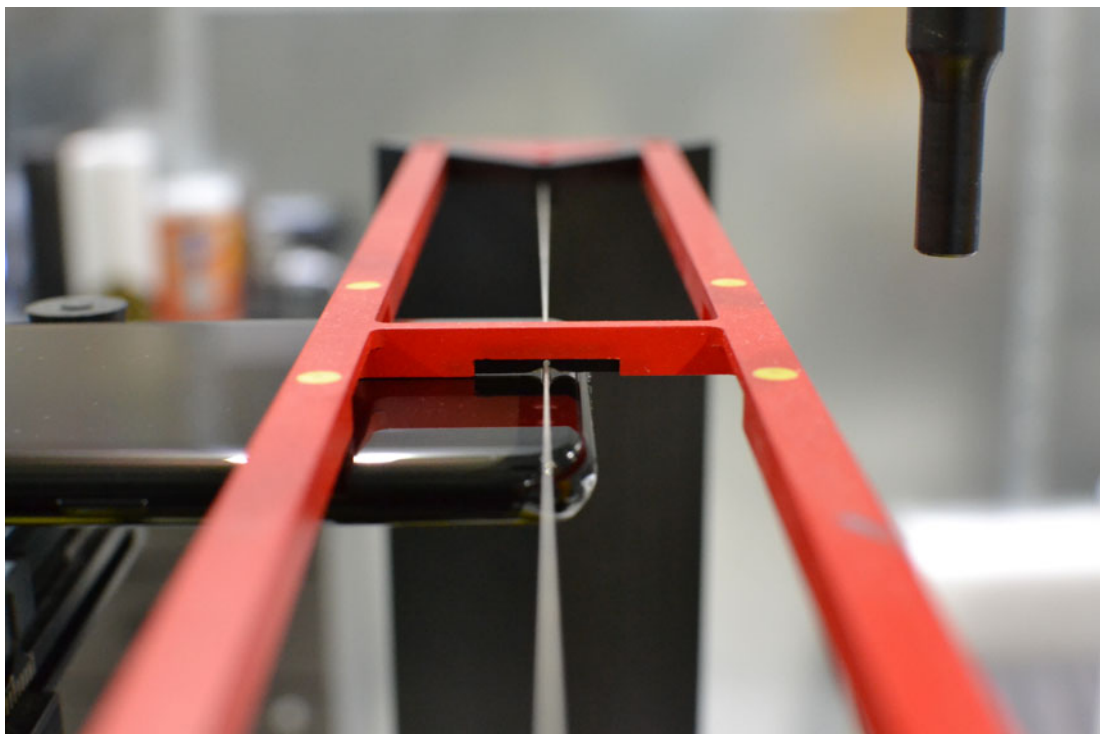

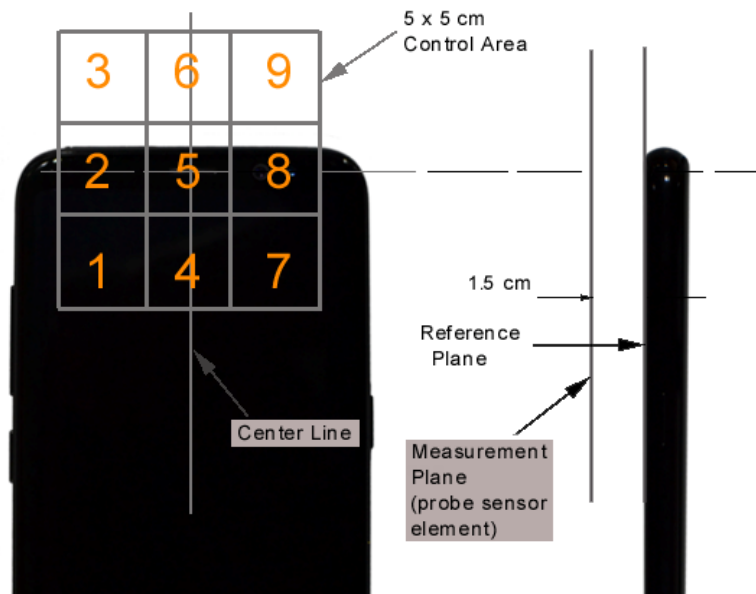


Figure 18-3 5x5 Scan grid above WD
