1.0 INTRODUCTION

1.1 Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Innovation, Science and Economic Development Canada.

1.2 Element Test Location

Measurements were conducted at the Element laboratory(ies) indicated in Section 1.3 below. All measurement facilities are compliant with the test site requirements specified in ANSI C63.4:2014 and KDB 414788 D01 v01r01.

1.3 Test Facility / Accreditations

Measurements were performed at Element lab located in Columbia, MD 21046, U.S.A. ("MD")

2.0 PRODUCT INFORMATION

2.1 Equipment Description

The Equipment Under Test (EUT) is the **Samsung Portable Handset FCC ID: A3LSMS942B**. The test data contained in this report pertains only to the emissions due to the EUT's licensed transmitters that operate under the provisions of Part 22.

Test Device Serial No.: 0110M, 0262M, 3006M, 0099M, 0257M

2.2 Device Capabilities

This device contains the following capabilities:

850/1900 GSM/GPRS/EDGE, 850/1700/1900 WCDMA/HSPA, Multi-band LTE, Multi-band 5G NR (FR1), 802.11b/g/n/ac/ax/be WLAN, 802.11a/n/ac/ax/be UNII (5GHz and 6GHz), Bluetooth (1x, EDR, LE), NFC, Wireless Power Transfer

2.3 Test Configuration

The EUT was tested per the guidance of ANSI C63.26:2015. See Section 7.0 of this test report for a description of the radiated and antenna port conducted emissions tests.

This device supports wireless charging capability and, thus, is subject to the test requirements of KDB 648474 D03 v01r04. Additional radiated spurious emission measurements were performed with the EUT lying flat on an authorized wireless charging pad (WCP) Model: EP-2400 while operating under normal conditions in a simulated call or data transmission configuration. The worst case radiated emissions data is shown in this report.

2.4 Duty Cycle Information

For all 5G NR and LTE operations in FDD mode, the EUT duty cycle was set to 100%.

For LTE TDD operation, a call box was used to force maximum transmission for each band. For LTE TDD bands, the maximum duty cycle is 63.3% for PC3 and 43.3% for PC2.

2.5 Software and Firmware

Testing was performed on device(s) using software/firmware version S942BXXU0AYI8 installed on the EUT.

2.6 EMI Suppression Device(s)/Modifications

No EMI suppression device(s) were added and no modifications were made during testing.

3.0 DESCRIPTION OF TESTS

3.1 Evaluation Procedure

The measurement procedures described in the “American National Standard for Compliance Testing of Transmitters Used in Licensed Radio Services” (ANSI C63.26:2015) were used in the measurement of the EUT.

Deviation from Measurement Procedure.....None

3.2 Radiated Power and Radiated Spurious Emissions

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. The test site inside the chamber is a 6m x 5.2m elliptical, obstruction-free area in accordance with Figure 5.7 of Clause 5 in ANSI C63.4:2014. Absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections for measurements above 1GHz. For measurements below 1GHz, the absorbers are removed. A raised turntable is used for radiated measurement. The turn table is a continuously rotatable, remote-controlled, metallic turntable and 2 meters (6.56 ft.) in diameter. The turn table is flush with the raised floor of the chamber in order to maintain its function as a ground plane. An 80cm tall test table made of Styrodur is placed on top of the turn table. A Styrodur pedestal is placed on top of the test table to bring the total table height to 1.5m.

The equipment under test was transmitting while connected to its integral antenna and is placed on a turntable 3 meters from the receive antenna. The receive antenna height is adjusted between 1 and 4 meter height, the turntable is rotated through 360 degrees, and the EUT is manipulated through all orthogonal planes representative of its typical use to achieve the highest reading on the receive spectrum analyzer.

For radiated power measurements, substitution method is used per the guidance of ANSI C63.26:2015. For emissions below 1GHz, a half-wave dipole is substituted in place of the EUT. For emissions above 1GHz, a horn antenna is substituted in place of the EUT. The substitute antenna is driven by a signal generator with the level of the signal generator being adjusted to obtain the same receive spectrum analyzer level previously recorded from the spurious emission from the EUT. The power of the emission is calculated using the following formula:

$$P_d \text{ [dBm]} = P_g \text{ [dBm]} - \text{cable loss [dB]} + \text{antenna gain [dBd/dBi]};$$

where P_d is the dipole equivalent power, P_g is the generator output into the substitution antenna, and the antenna gain is the gain of the substitute antenna used relative to either a half-wave dipole (dBd) or an isotropic source (dBi). The substitute level is equal to $P_g \text{ [dBm]} - \text{cable loss [dB]}$.

For radiated spurious emissions measurements, the field strength conversion method is used per the formulas in Section 5.2.7 of ANSI C63.26:2015. Field Strength (EIRP) is calculated using the following formulas:

$$E_{\text{[dB}\mu\text{V/m]}} = \text{Measured amplitude level [dBm]} + 107 + \text{Cable Loss [dB]} + \text{Antenna Factor [dB/m]}$$

And

$$\text{EIRP}_{\text{[dBm]}} = E_{\text{[dB}\mu\text{V/m]}} + 20\log D - 104.8; \text{ where } D \text{ is the measurement distance in meters.}$$

All radiated measurements are performed in a chamber that meets the site requirements per ANSI C63.4:2014. Additionally, radiated emissions below 30MHz are also validated on an Open Area Test Site to assert correlation with the chamber measurements per the requirements of KDB 414788 D01 v01r01.

Radiated power and radiated spurious emission levels are investigated with the receive antenna horizontally and vertically polarized per ANSI C63.26:2015.

4.0 MEASUREMENT UNCERTAINTY

The measurement uncertainties shown below were calculated in accordance with the requirements of ANSI C63.4:2014. All measurement uncertainty values are shown with a coverage factor of $k = 2$ to indicate a 95% level of confidence. The measurement uncertainty shown below meets or exceeds the U_{CISPR} measurement uncertainty values specified in CISPR 16-4-2 and, thus, can be compared directly to specified limits to determine compliance.

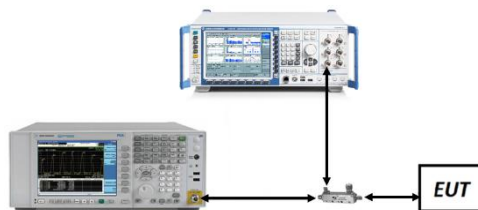


Figure 7-1. Test Instrument & Measurement Setup

7.3 Occupied Bandwidth

The occupied bandwidth, that is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers radiated are each equal to 0.5 percent of the total mean power radiated by a given emission shall be measured. 7. The trace was allowed to stabilize
8. If necessary, steps 2 – 7 were repeated after changing the RBW such that it would be within 1 – 5% of the 99% occupied bandwidth observed in Step 7

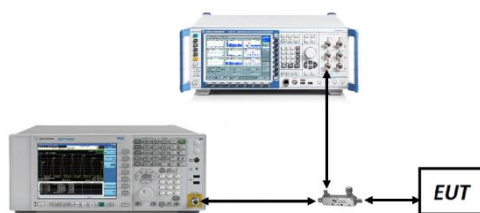


Figure 7-2. Test Instrument & Measurement Setup

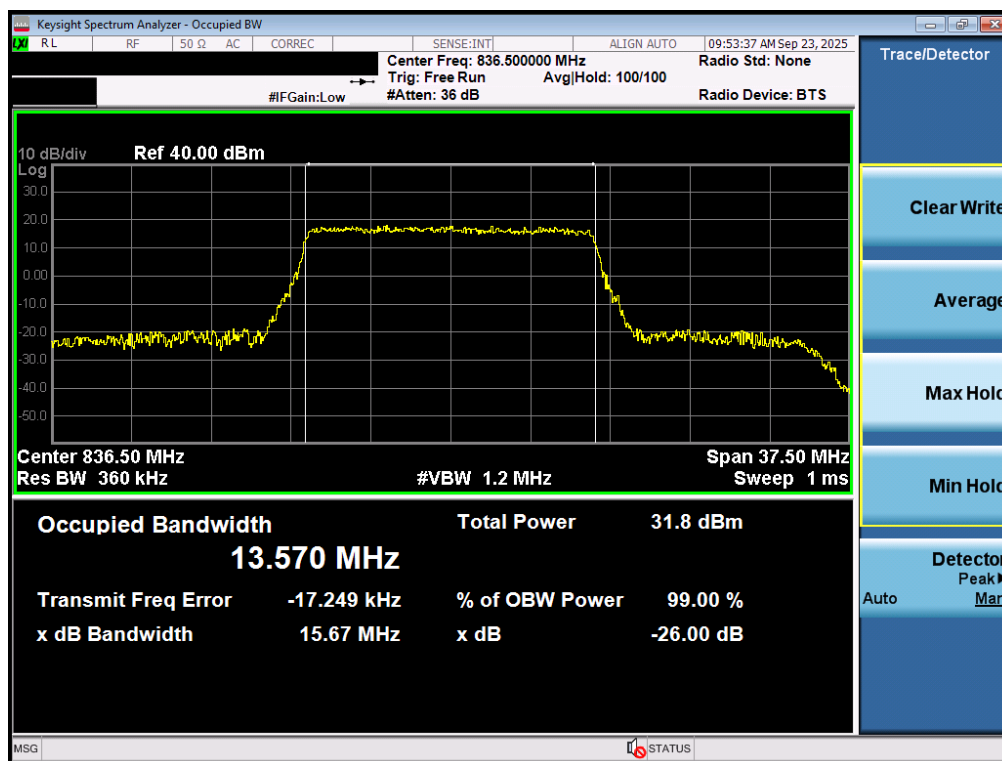

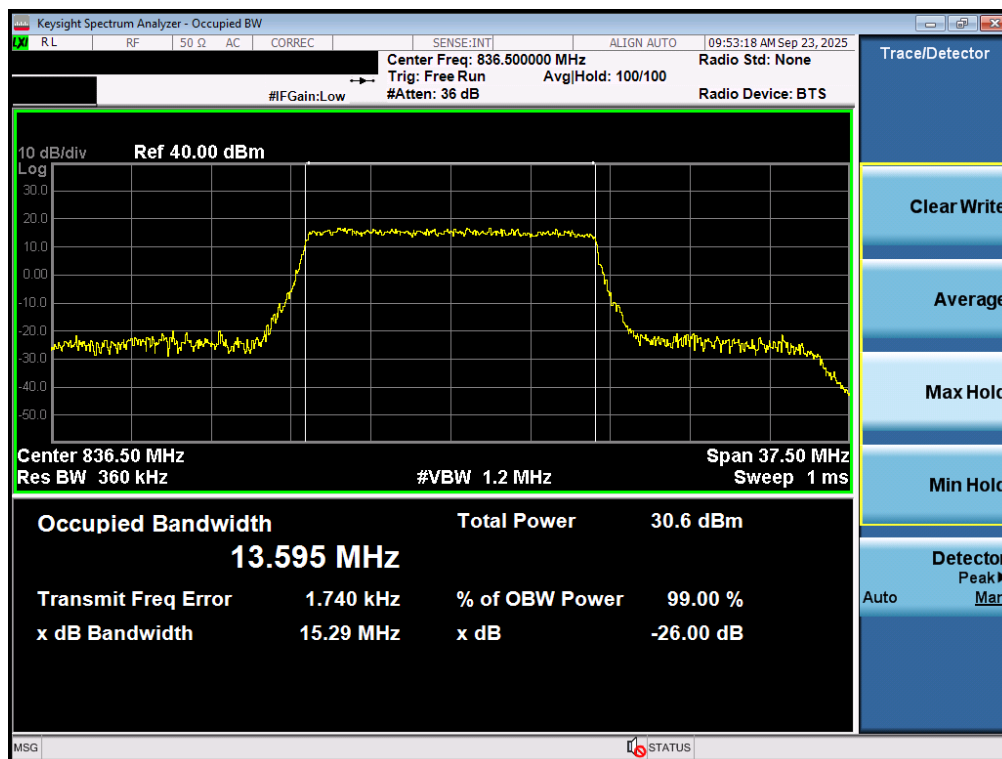

LTE Band 26/5 – Ant1

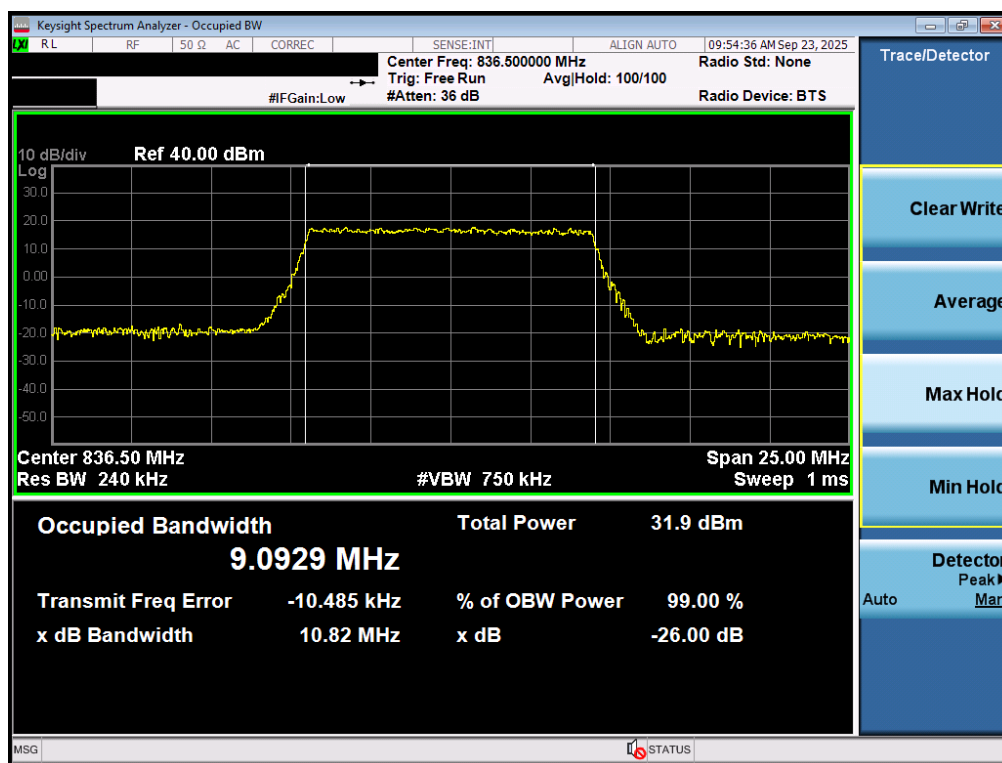


Plot 7-1. Occupied Bandwidth Plot (LTE Band 26 - 15MHz QPSK - Full RB - Ant1)

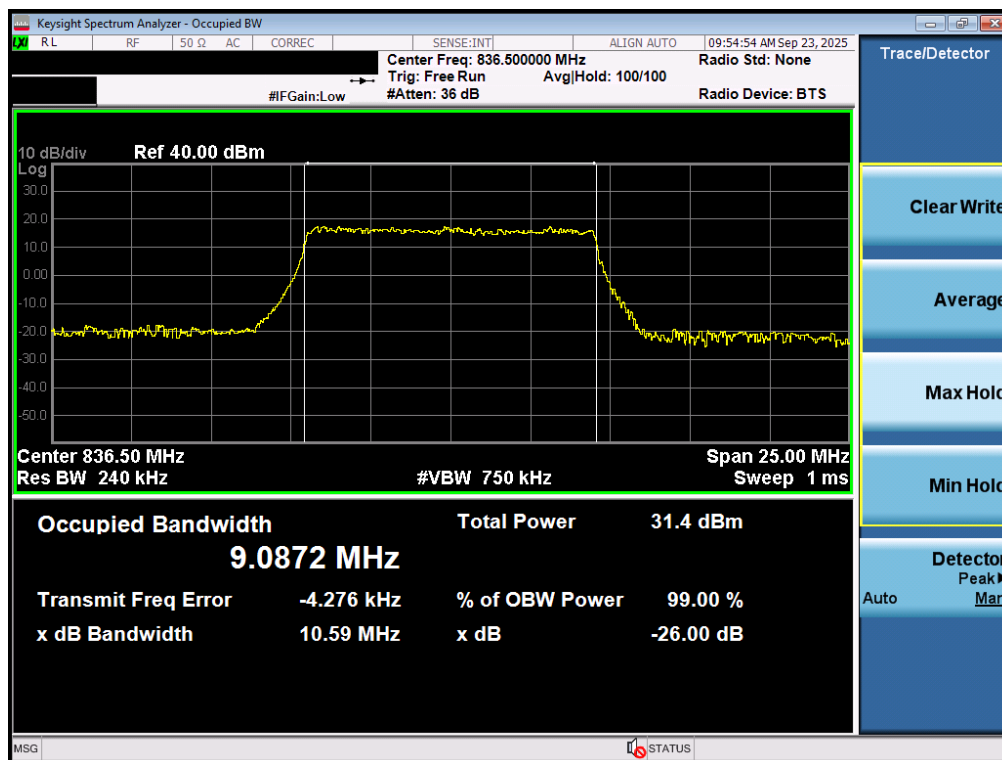


Plot 7-2. Occupied Bandwidth Plot (LTE Band 26 - 15MHz 16-QAM - Full RB - Ant1)

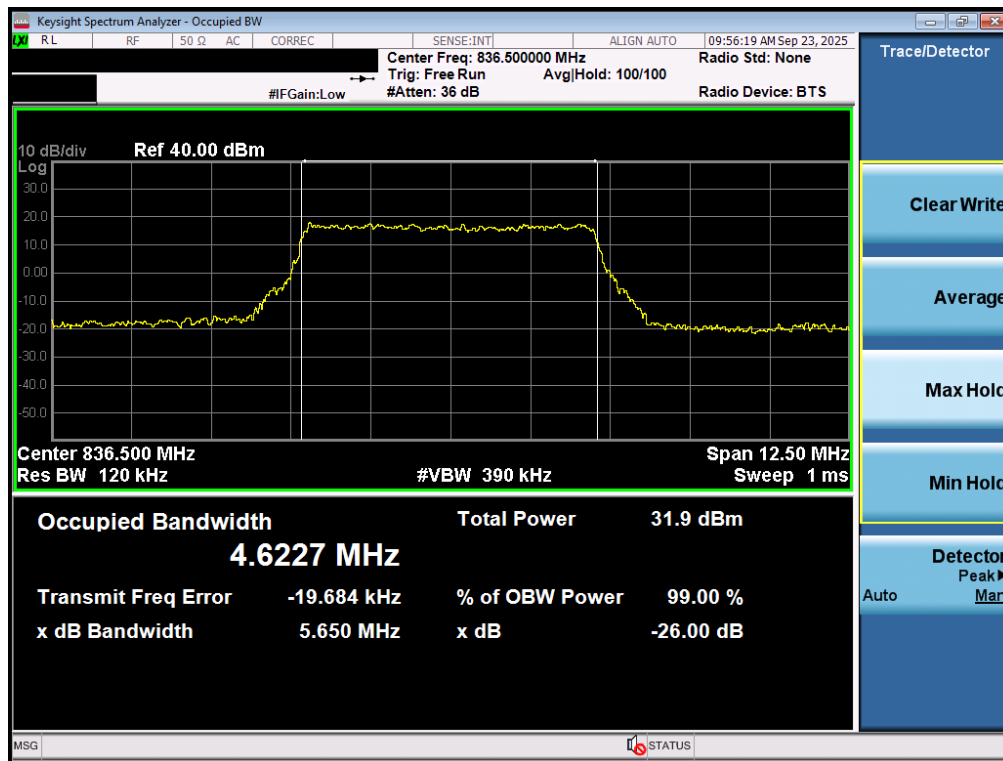


Plot 7-3. Occupied Bandwidth Plot (LTE Band 26/5 - 10MHz QPSK - Full RB - Ant1)

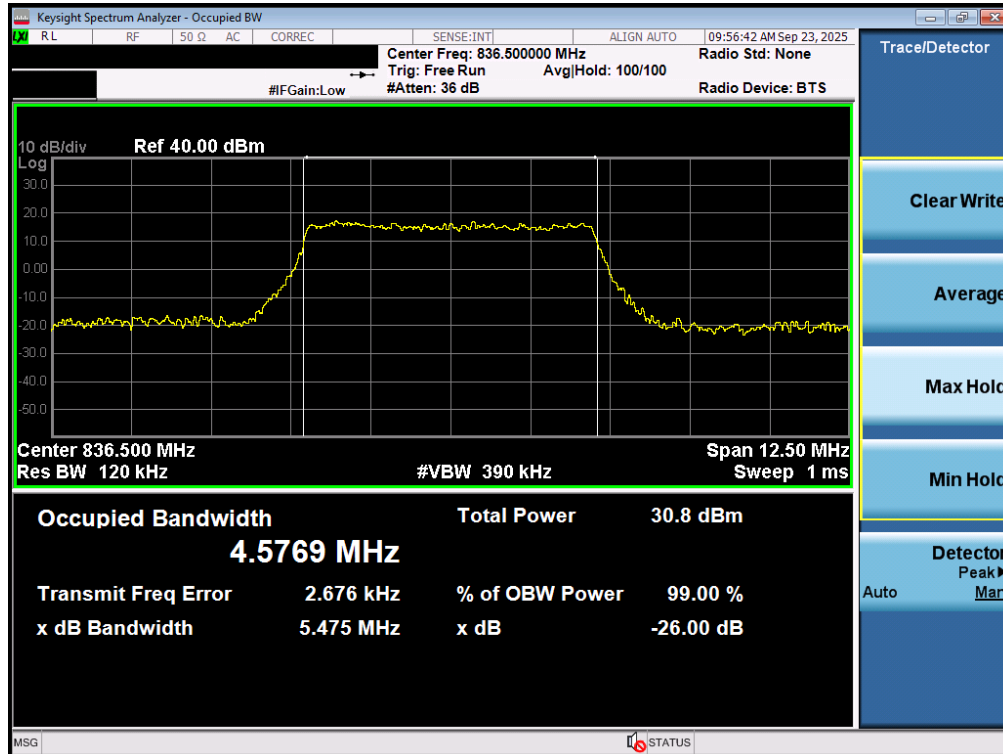


Plot 7-4. Occupied Bandwidth Plot (LTE Band 26/5 - 10MHz 16-QAM - Full RB - Ant1)

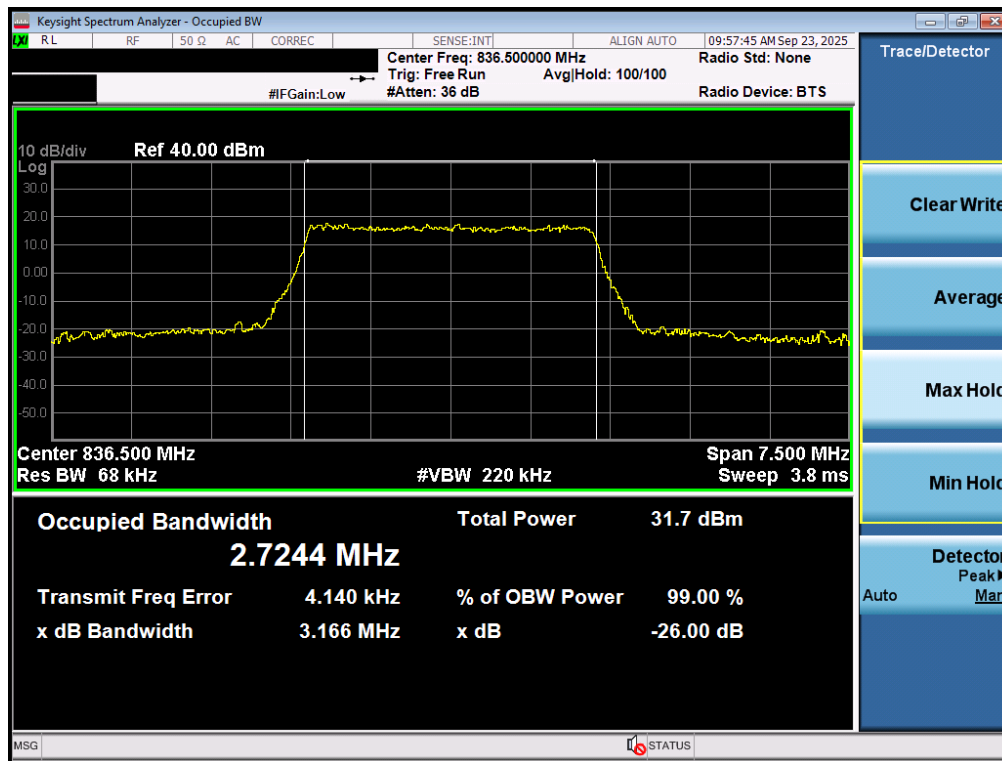


Plot 7-5. Occupied Bandwidth Plot (LTE Band 26/5 - 5MHz QPSK - Full RB - Ant1)

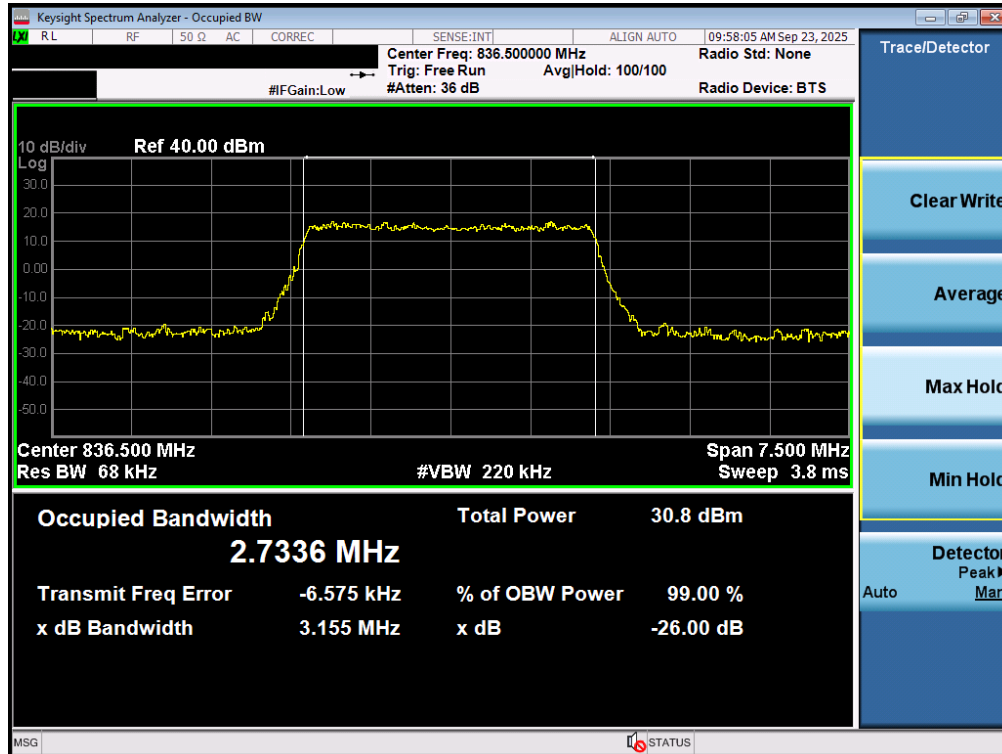


Plot 7-6. Occupied Bandwidth Plot (LTE Band 26/5 - 5MHz 16-QAM - Full RB - Ant1)

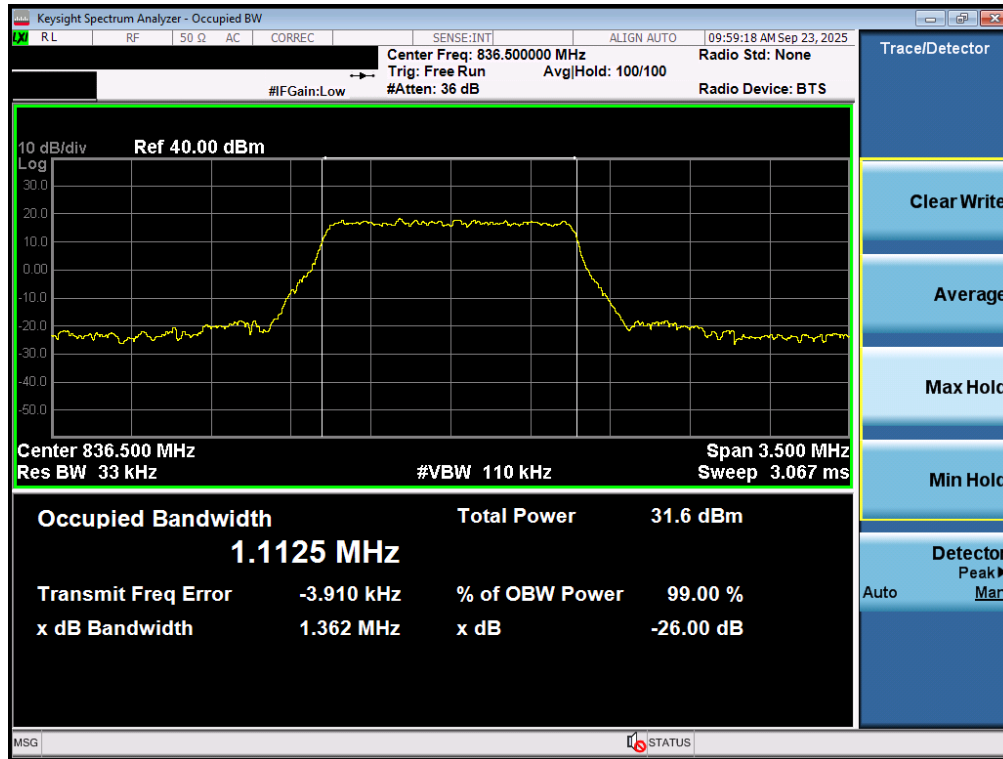


Plot 7-7. Occupied Bandwidth Plot (LTE Band 26/5 - 3MHz QPSK - Full RB - Ant1)

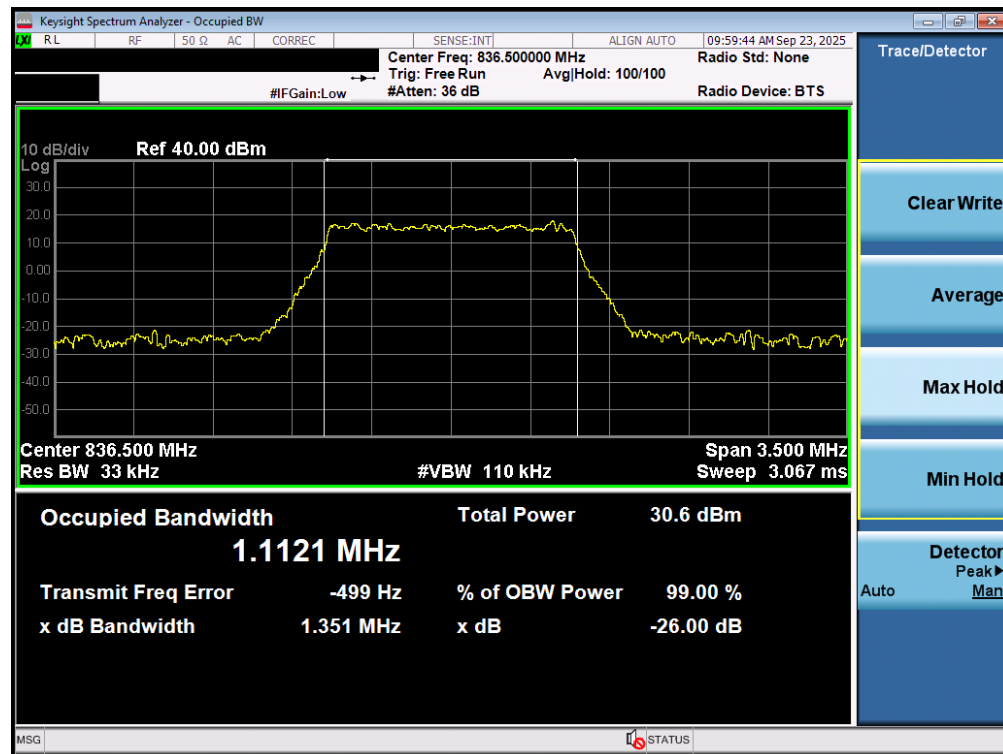


Plot 7-8. Occupied Bandwidth Plot (LTE Band 26/5 - 3MHz 16-QAM - Full RB - Ant1)

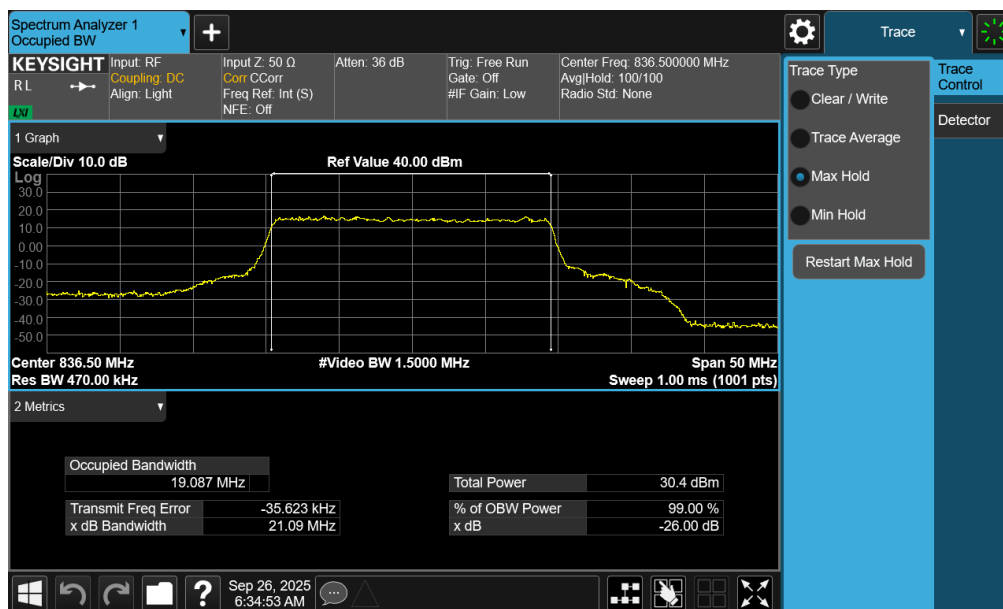
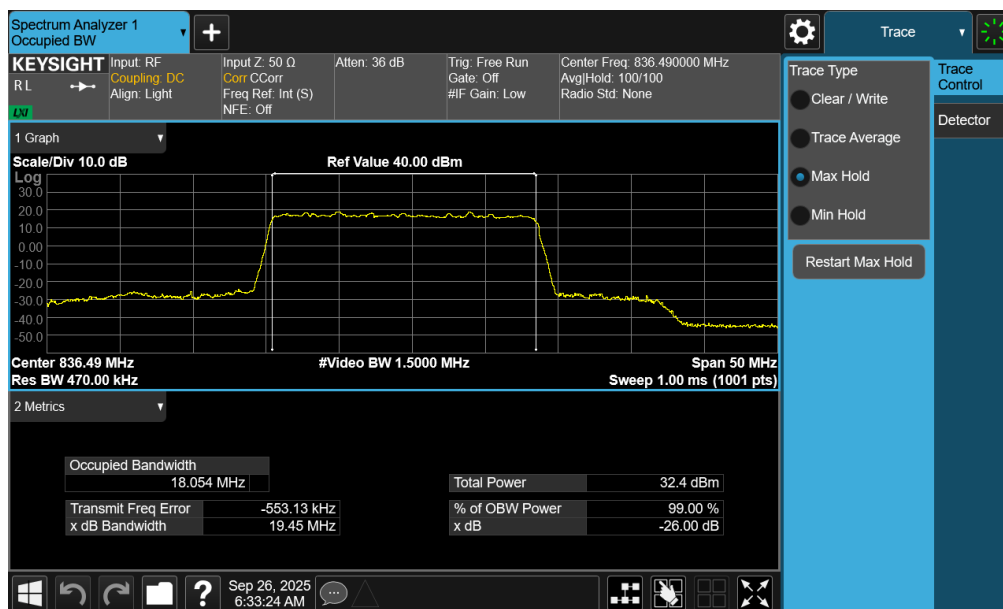
Plot 7-9. Occupied Bandwidth Plot (LTE Band 26/5 - 1.4MHz QPSK - Full RB - Ant1)



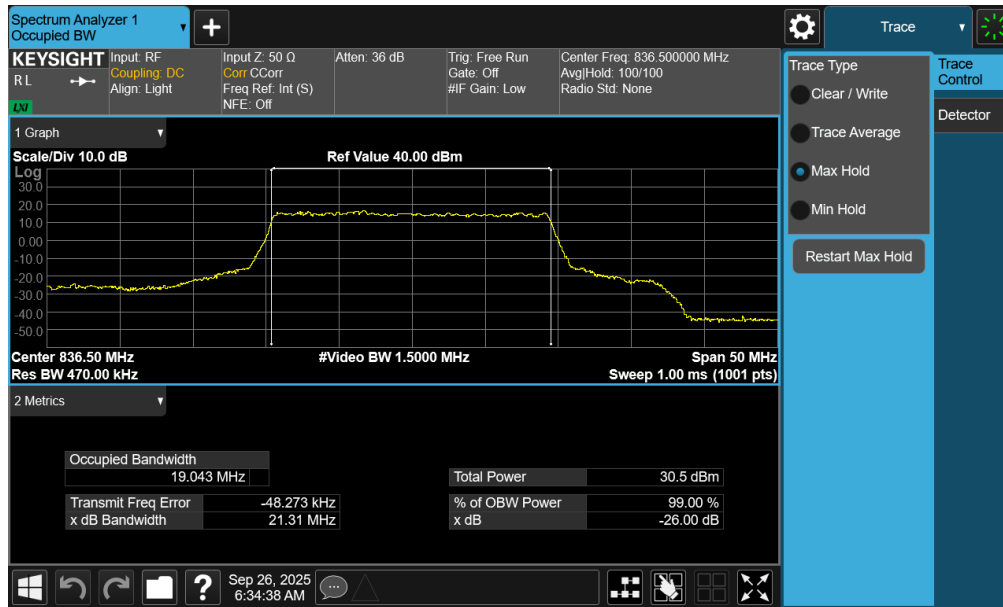
Plot 7-10. Occupied Bandwidth Plot (LTE Band 26/5 - 1.4MHz 16-QAM - Full RB - Ant1)

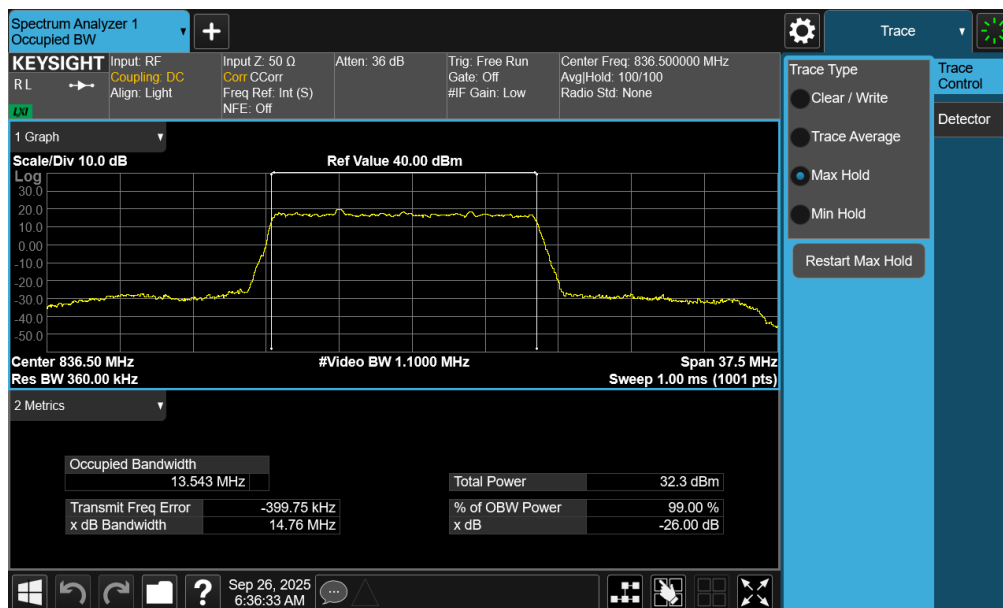

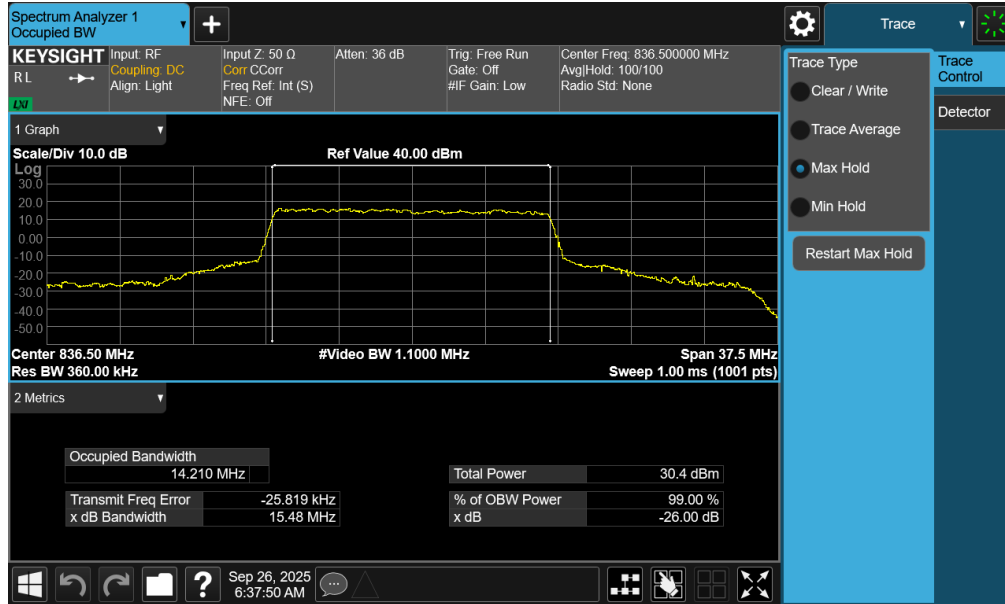


Plot 7-13. Occupied Bandwidth Plot (NR Band n26/5 - 20MHz 16-QAM - Full RB - Ant1)

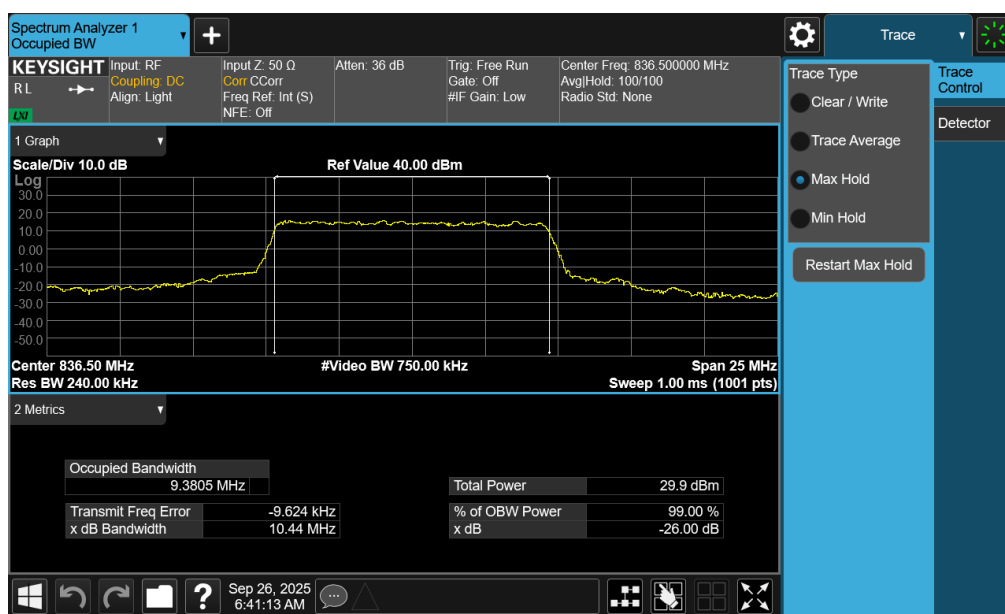
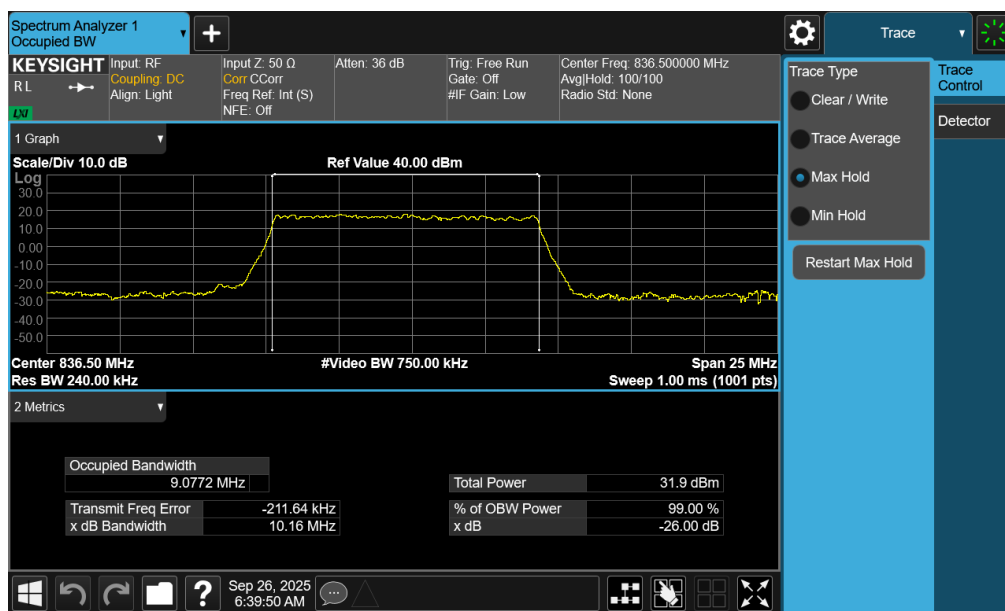


Plot 7-15. Occupied Bandwidth Plot (NR Band n26/5 - 15MHz QPSK - Full RB - Ant1)

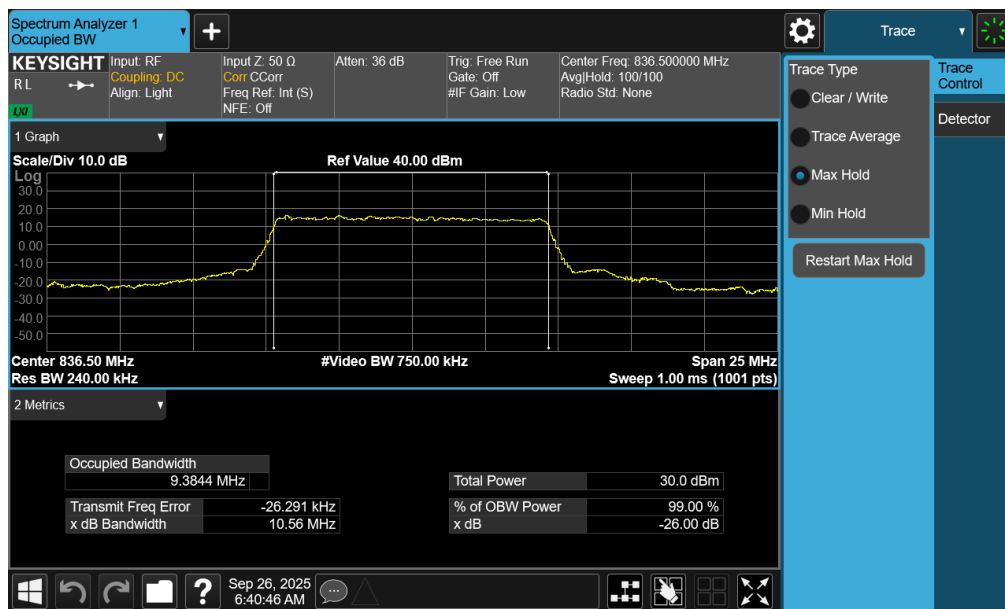


Plot 7-16. Occupied Bandwidth Plot (NR Band n26/5 - 15MHz 16-QAM - Full RB - Ant1)

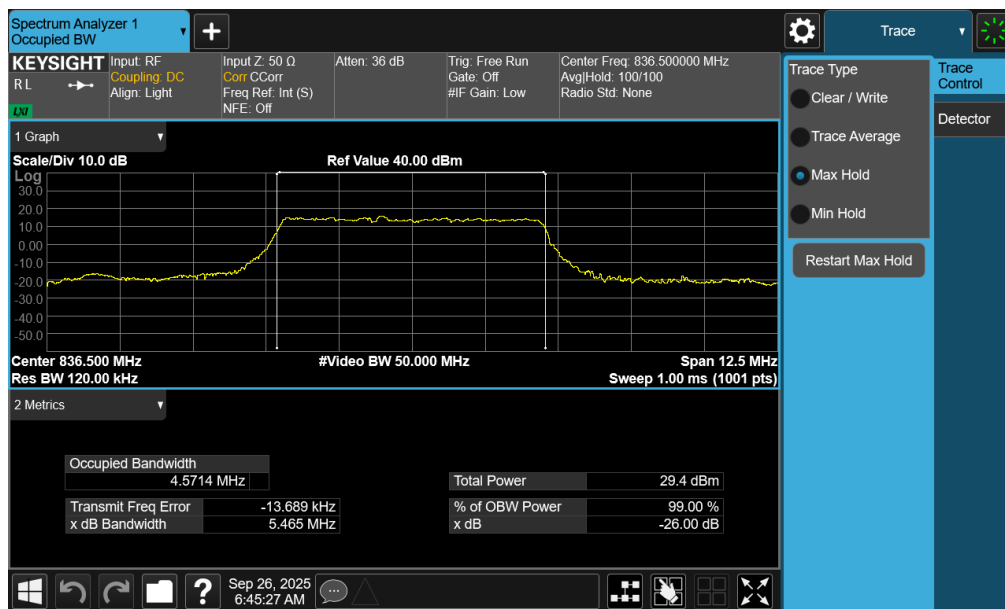

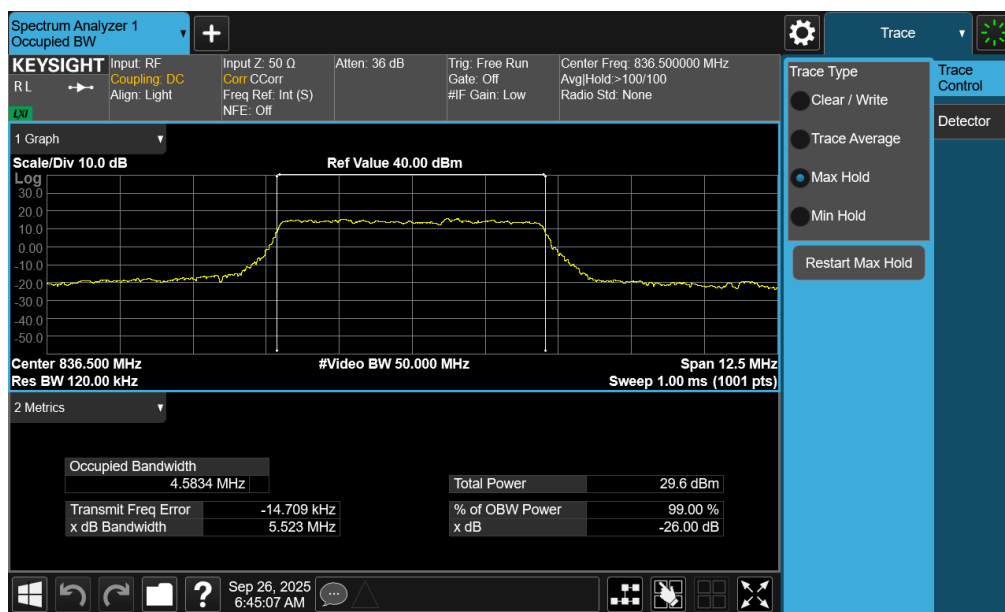

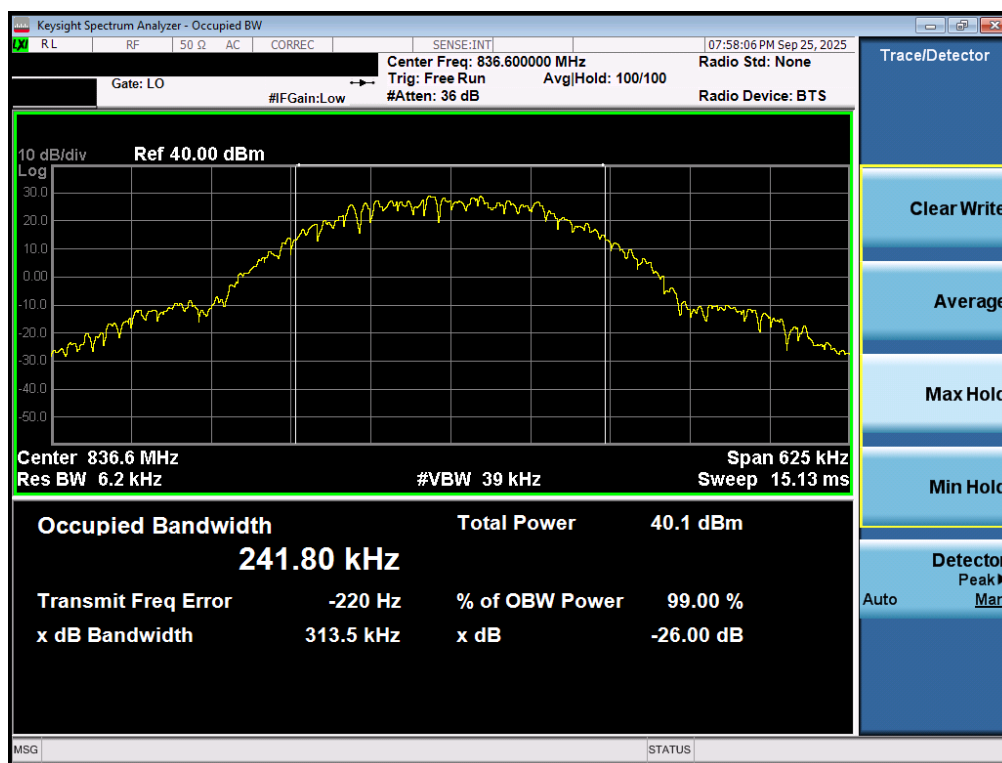
Plot 7-21. Occupied Bandwidth Plot (NR Band n26/5 - 5MHz QPSK - Full RB - Ant1)

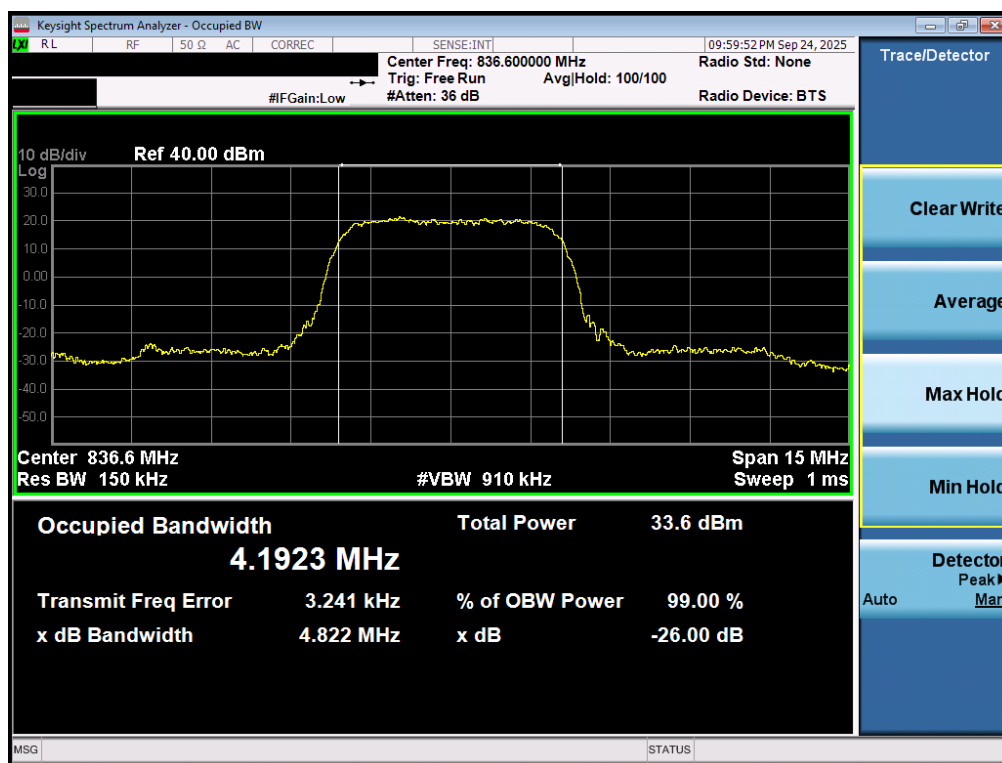
Plot 7-23. Occupied Bandwidth Plot (GPRS, Ch. 190 – Ant1)

Plot 7-25. Occupied Bandwidth Plot (WCDMA, Ch. 4183 – Ant1)

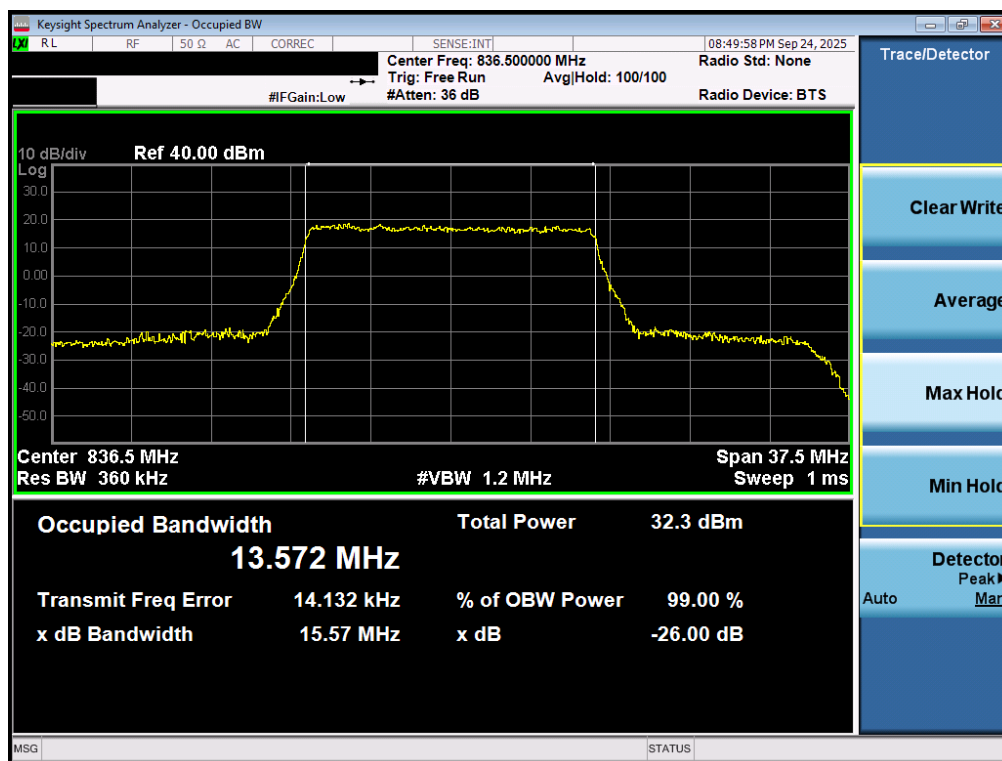

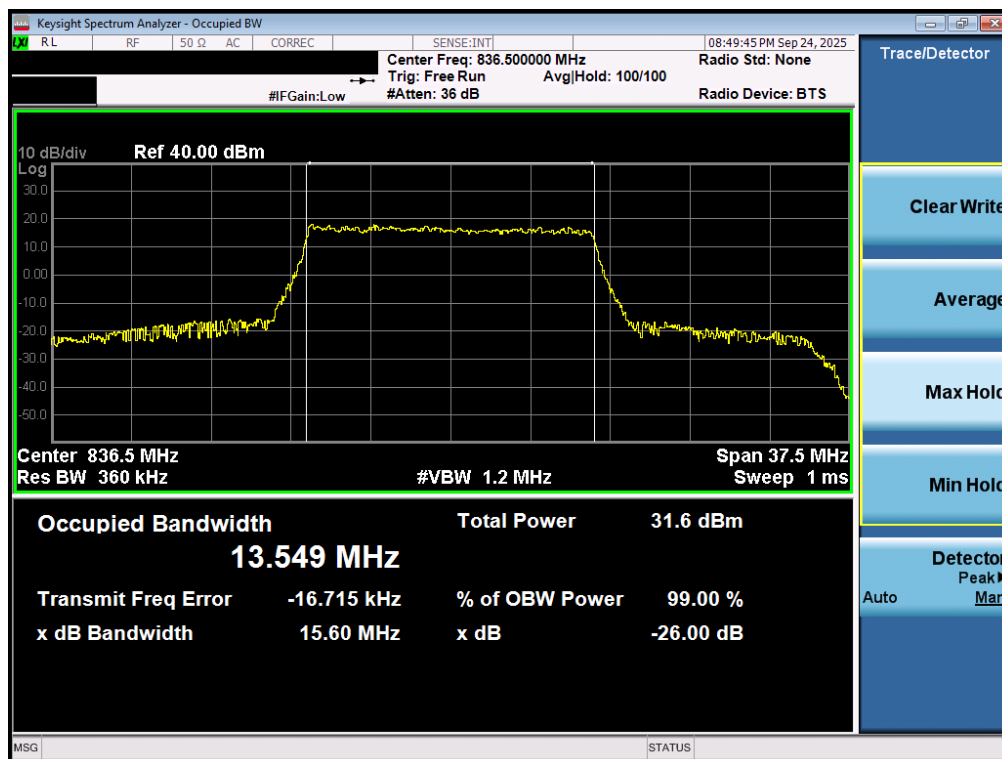

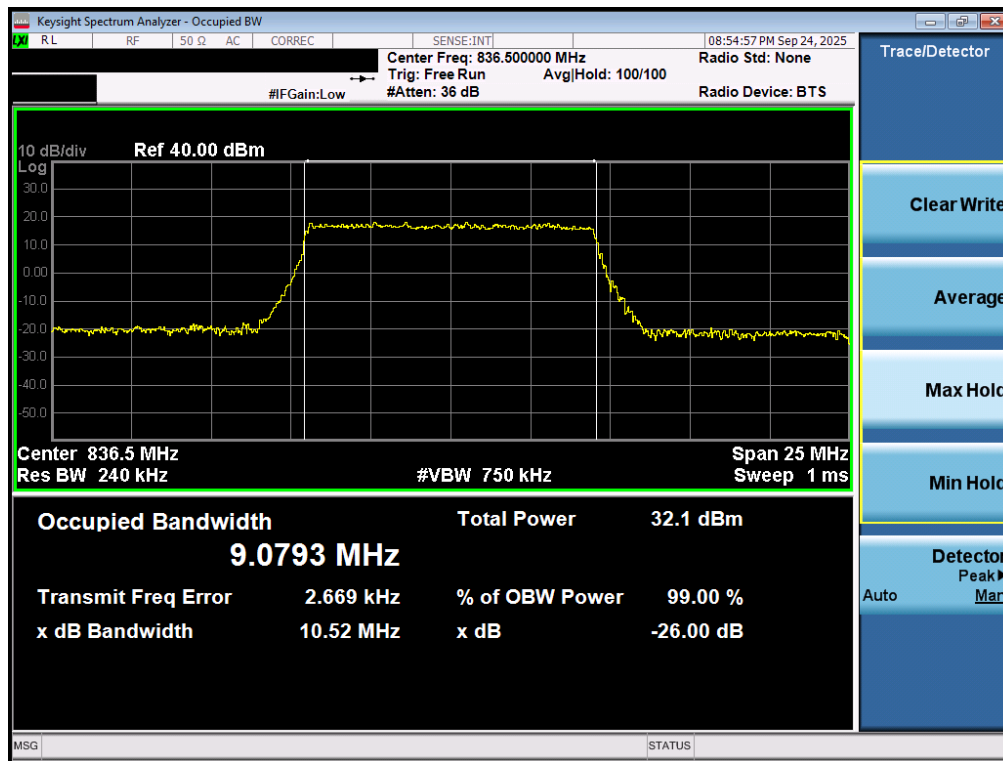


Plot 7-26. Occupied Bandwidth Plot (LTE Band 26 - 15MHz QPSK - Full RB - Ant2)

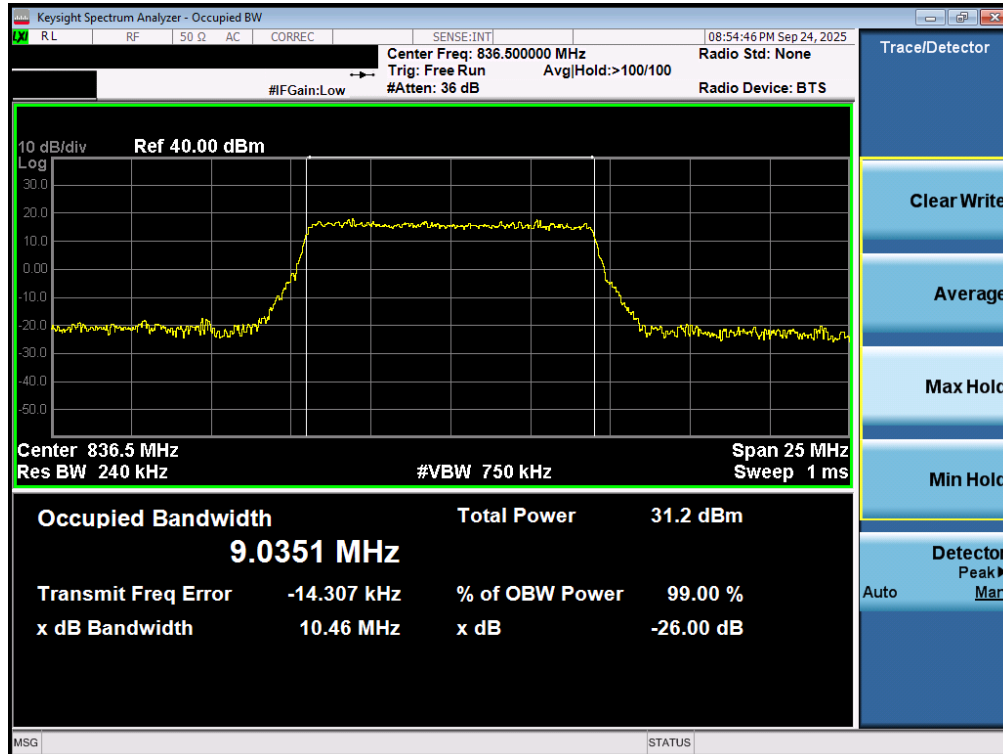


Plot 7-27. Occupied Bandwidth Plot (LTE Band 26 - 15MHz 16-QAM - Full RB - Ant2)

Plot 7-28. Occupied Bandwidth Plot (LTE Band 26/5 - 10MHz QPSK - Full RB - Ant2)

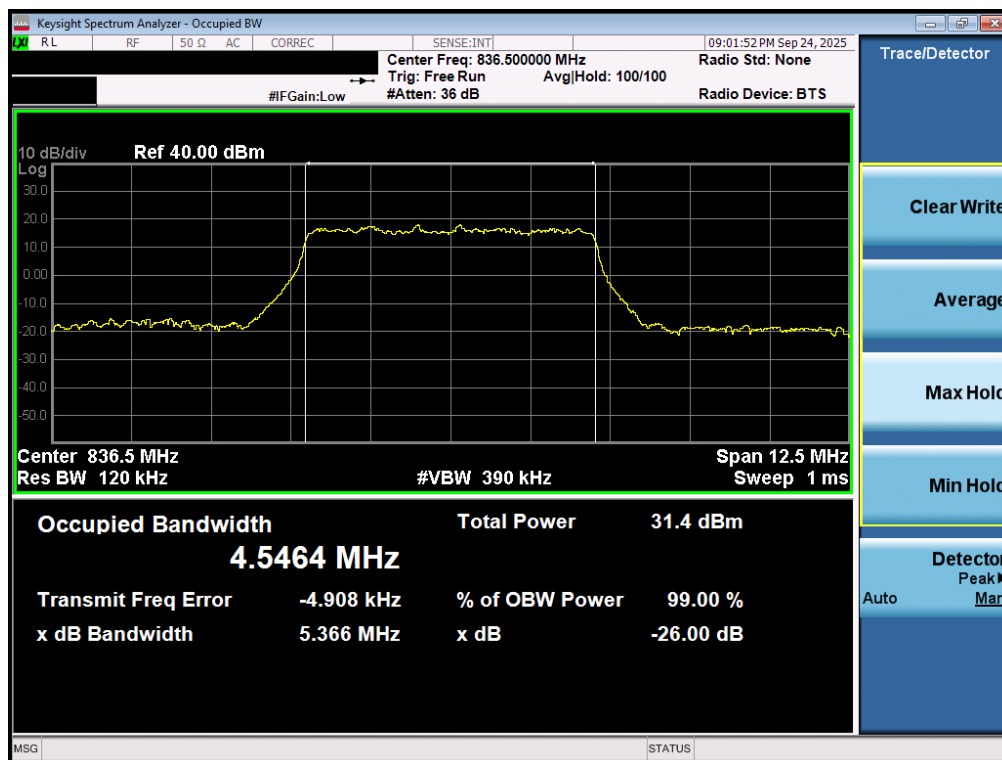


Plot 7-29. Occupied Bandwidth Plot (LTE Band 26/5 - 10MHz 16-QAM - Full RB - Ant2)

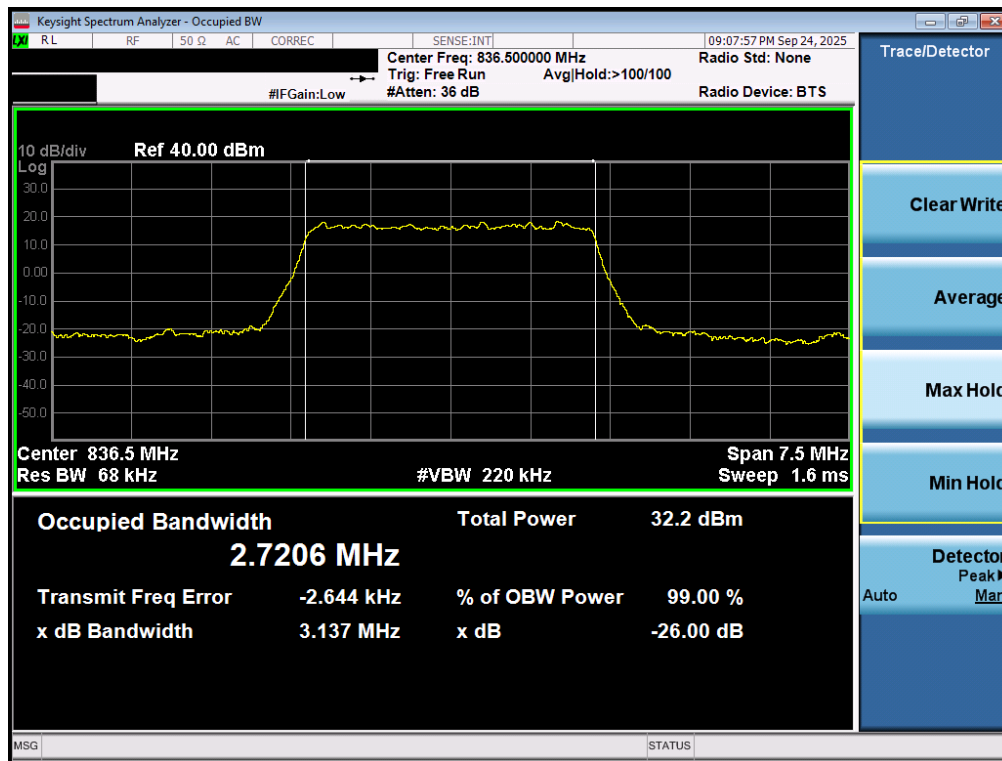


Plot 7-30. Occupied Bandwidth Plot (LTE Band 26/5 - 5MHz QPSK - Full RB - Ant2)

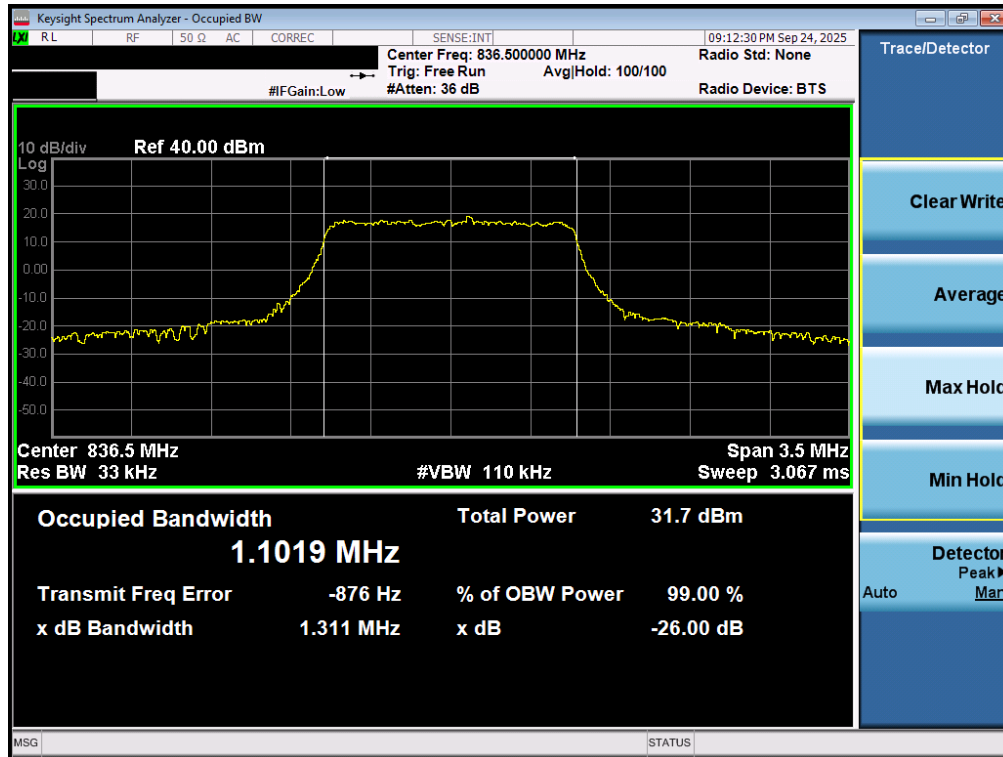


Plot 7-32. Occupied Bandwidth Plot (LTE Band 26/5 - 3MHz QPSK - Full RB - Ant2)

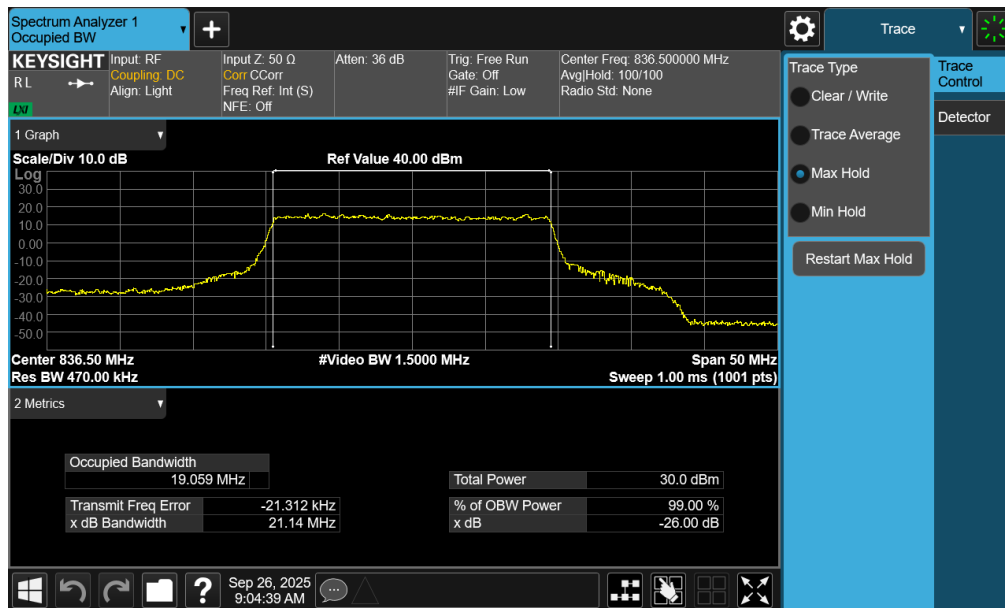
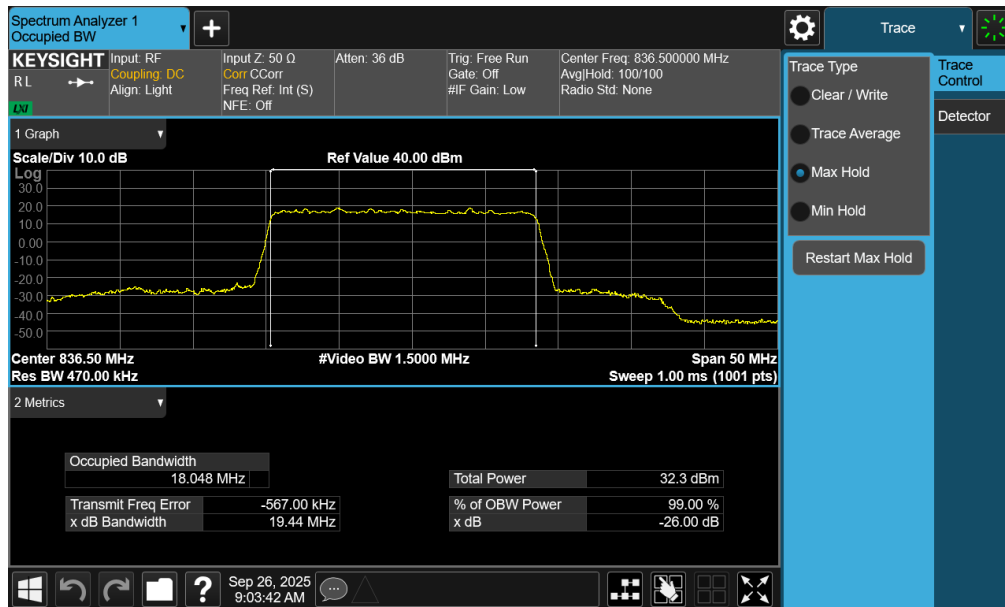
Plot 7-34. Occupied Bandwidth Plot (LTE Band 26/5 - 1.4MHz QPSK - Full RB - Ant2)



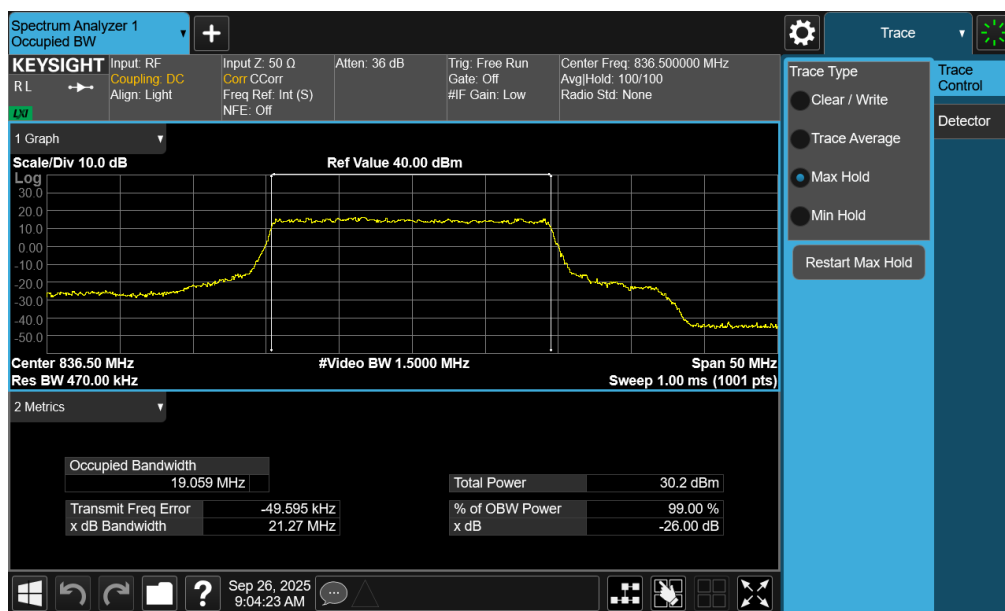
Plot 7-35. Occupied Bandwidth Plot (LTE Band 26/5 - 1.4MHz 16-QAM - Full RB - Ant2)

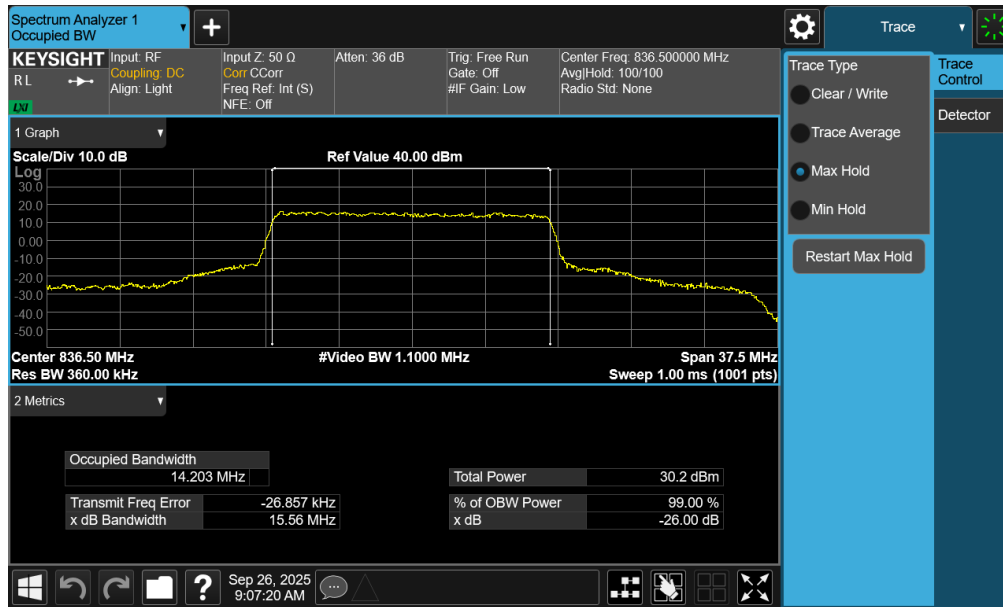


Plot 7-38. Occupied Bandwidth Plot (NR Band n26/5 - 20MHz 16-QAM - Full RB - Ant2)

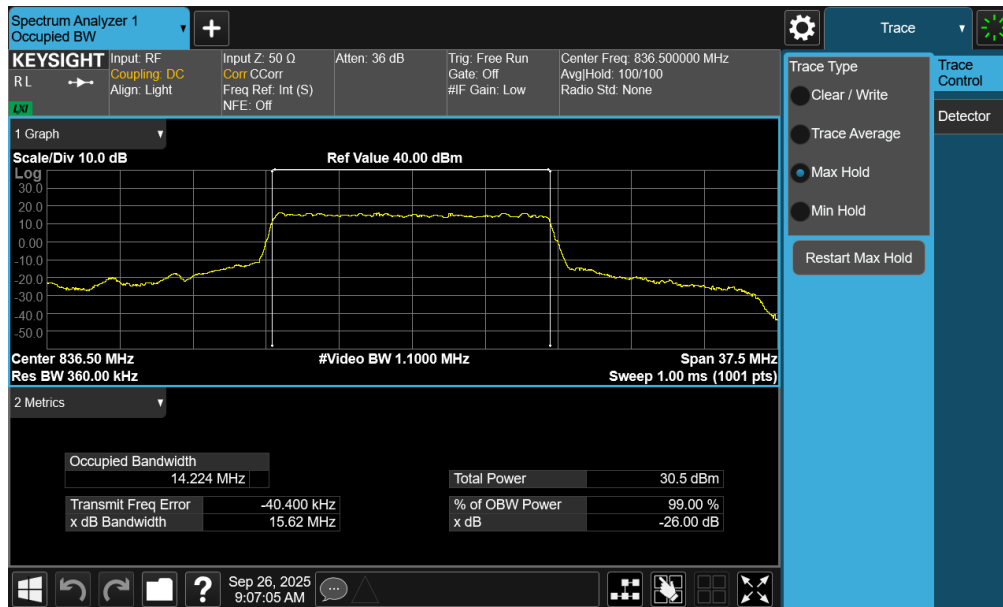

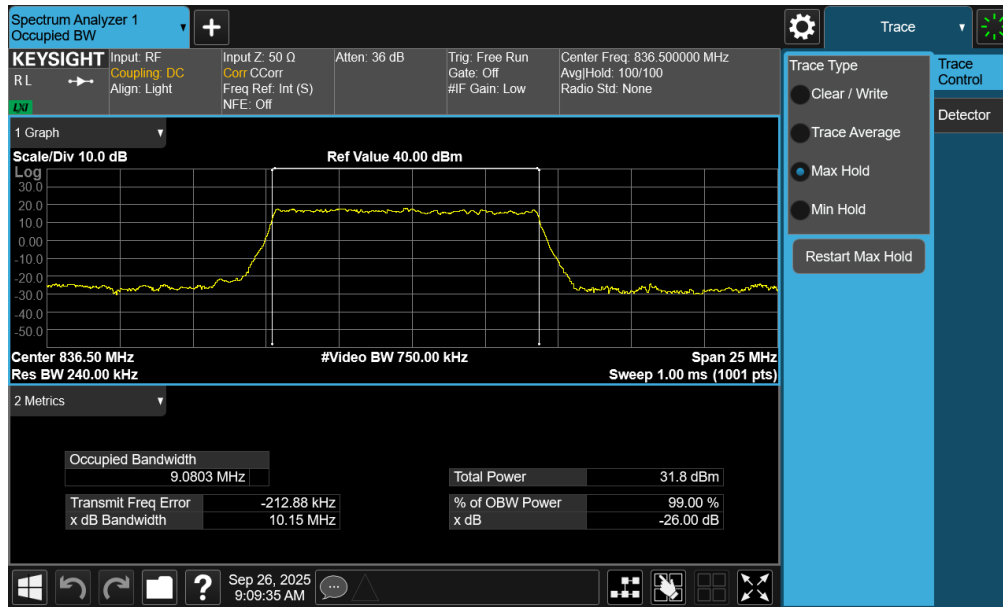


Plot 7-40. Occupied Bandwidth Plot (NR Band n26/5 - 15MHz QPSK - Full RB - Ant2)

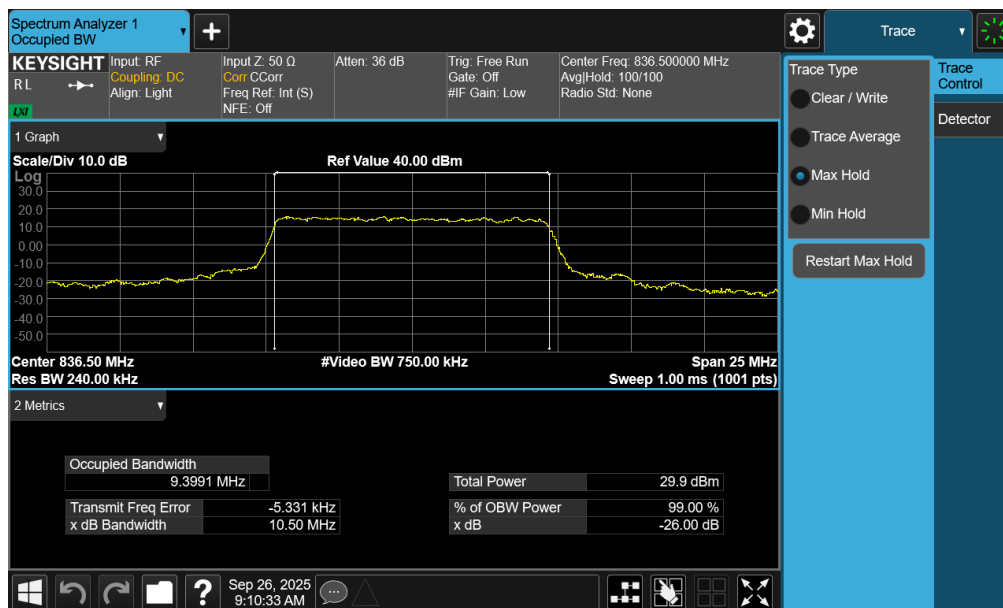


Plot 7-41. Occupied Bandwidth Plot (NR Band n26/5 - 15MHz 16-QAM - Full RB - Ant2)

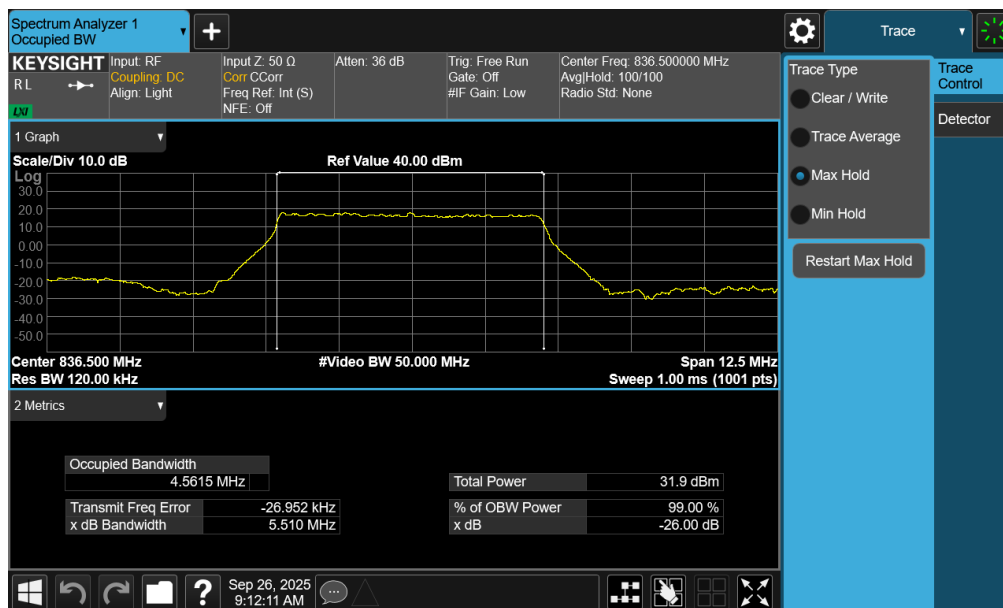
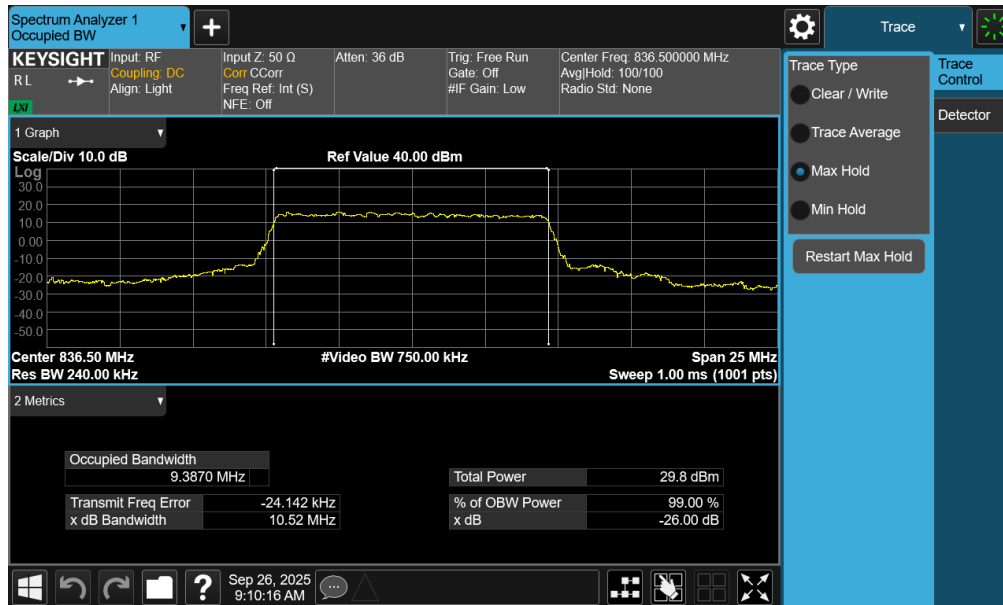

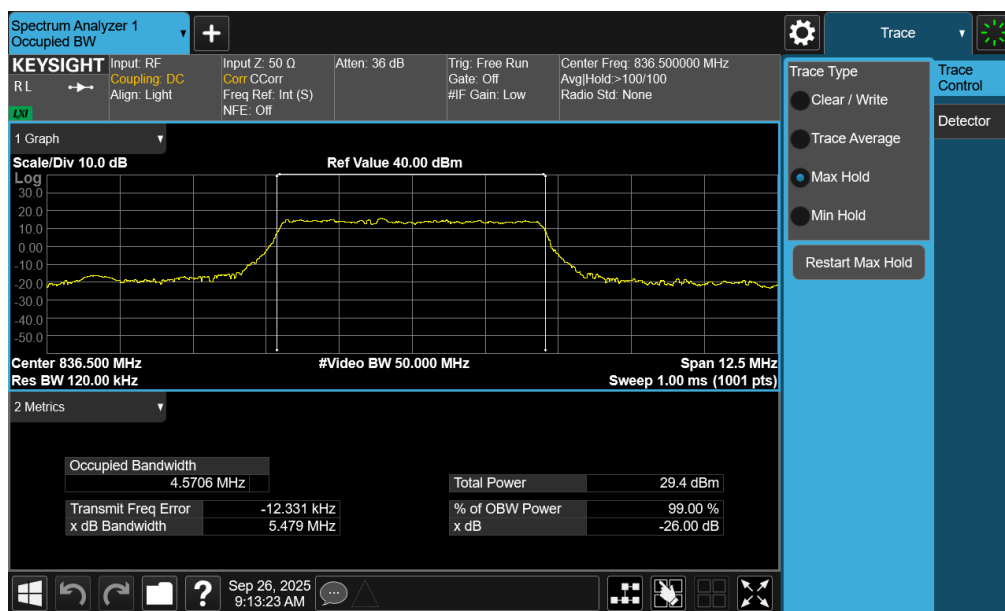


Plot 7-43. Occupied Bandwidth Plot (NR Band n26/5 - 10MHz QPSK - Full RB - Ant2)

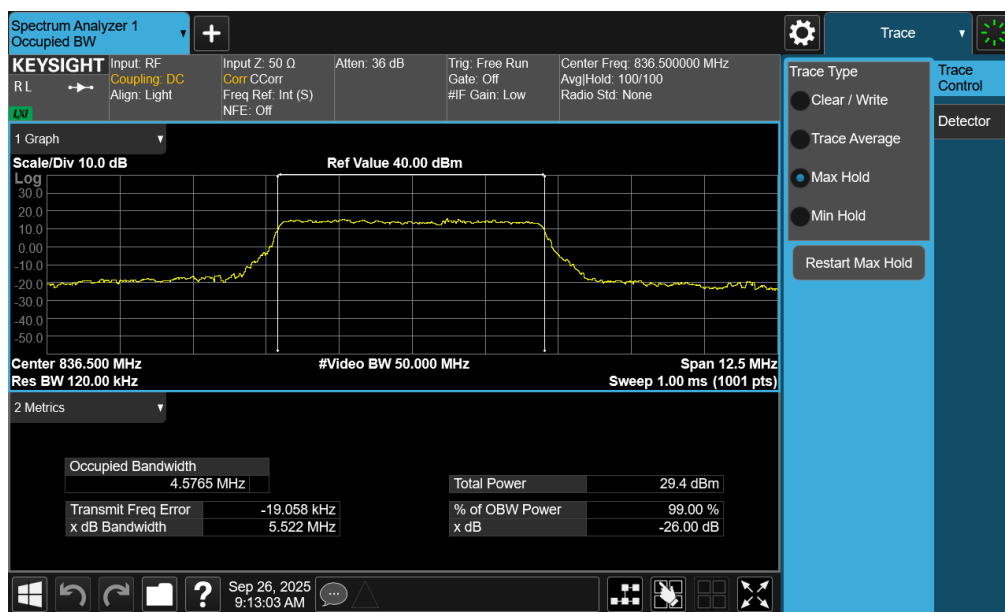

Plot 7-46. Occupied Bandwidth Plot (NR Band n26/5 - 5MHz QPSK - Full RB - Ant2)



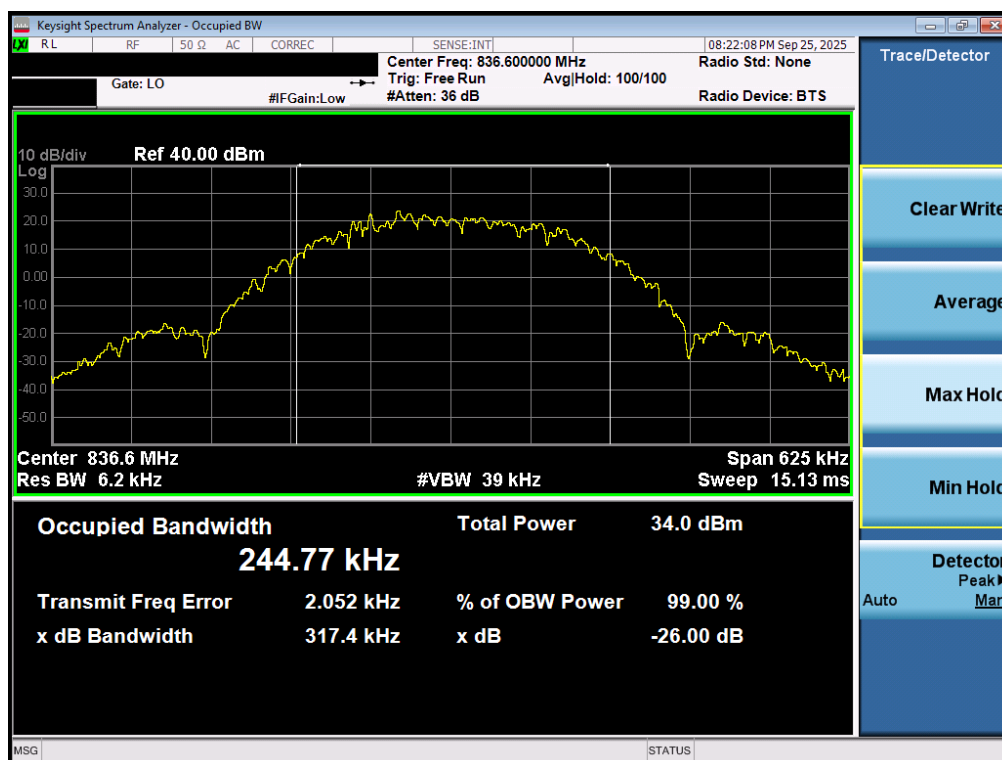

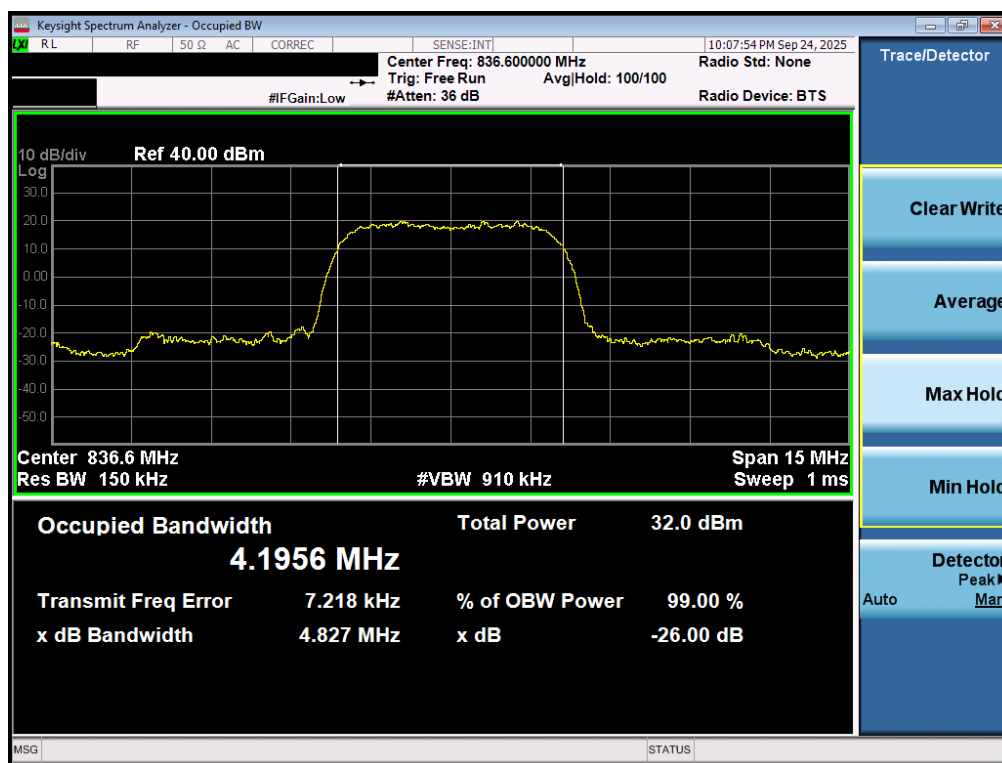
Plot 7-48. Occupied Bandwidth Plot (GPRS, Ch. 190 – Ant2)

7.4 Spurious and Harmonic Emissions at Antenna Terminal

Test Overview

The level of the carrier and the various conducted spurious and harmonic frequencies is measured by means of a calibrated spectrum analyzer. The spectrum is scanned from the lowest frequency generated in the equipment up to a frequency including its 10th harmonic. All out of band emissions are measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at maximum power, and at the appropriate frequencies. All data rates were investigated to determine the worst case configuration. All modes of operation were investigated and the worst case configuration results are reported in this section.

The minimum permissible attenuation level of any spurious emission is $43 + 10 \log_{10}(P_{\text{Watts}})$, where P is the transmitter power in Watts.

Test Procedure Used

ANSI C63.26:2015 – Section 5.7.4

Test Settings

1. Start frequency was set to 30MHz and stop frequency was set to 10GHz (separated into at least two plots per channel)
2. Detector = RMS
3. Trace mode = trace average for continuous emissions, max hold for pulse emissions
4. Sweep time = auto couple
5. The trace was allowed to stabilize
6. Please see test notes below for RBW and VBW settings

Test Setup

The EUT and measurement equipment were set up as shown in the diagram below.

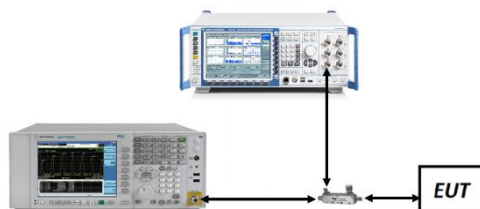


Figure 7-3. Test Instrument & Measurement Setup

Test Notes

1. Per Part 22, compliance with the applicable limits is based on the use of measurement instrumentation employing a resolution bandwidth 100 kHz or greater for measurements below 1GHz. However, in the 1 MHz bands immediately outside and adjacent to the frequency block a resolution bandwidth of at least one percent of the emission bandwidth of the fundamental emission of the transmitter may be employed. The emission bandwidth is defined as the width of the signal between two points, one below the carrier center frequency and one above the carrier center frequency, outside of which all emission are attenuated at least 26 dB below the transmitter power.
2. For NR operation, all subcarrier spacings (SCS) and transmission schemes (e.g. CP-OFDM and DFT-s-OFDM) were investigated to determine the worst case configuration. All modes of operation were investigated and the worst case configuration results are reported in this section.

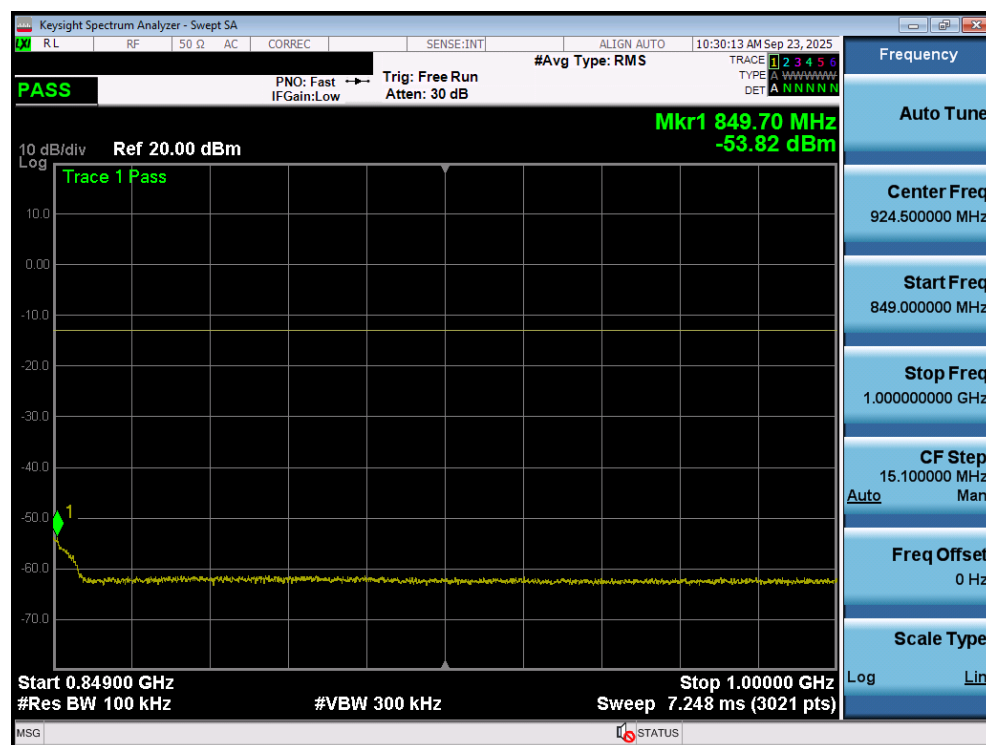

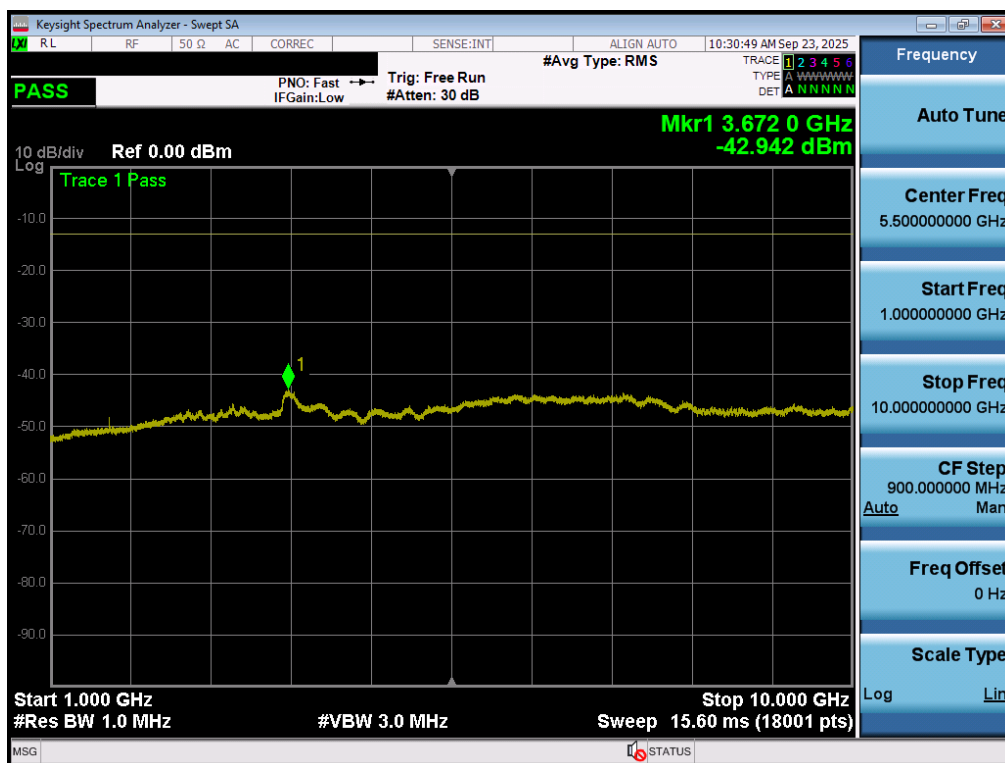


Plot 7-51. Conducted Spurious Plot (LTE Band 26/5 - 15MHz QPSK – 1 RB - Low Channel – Ant1)

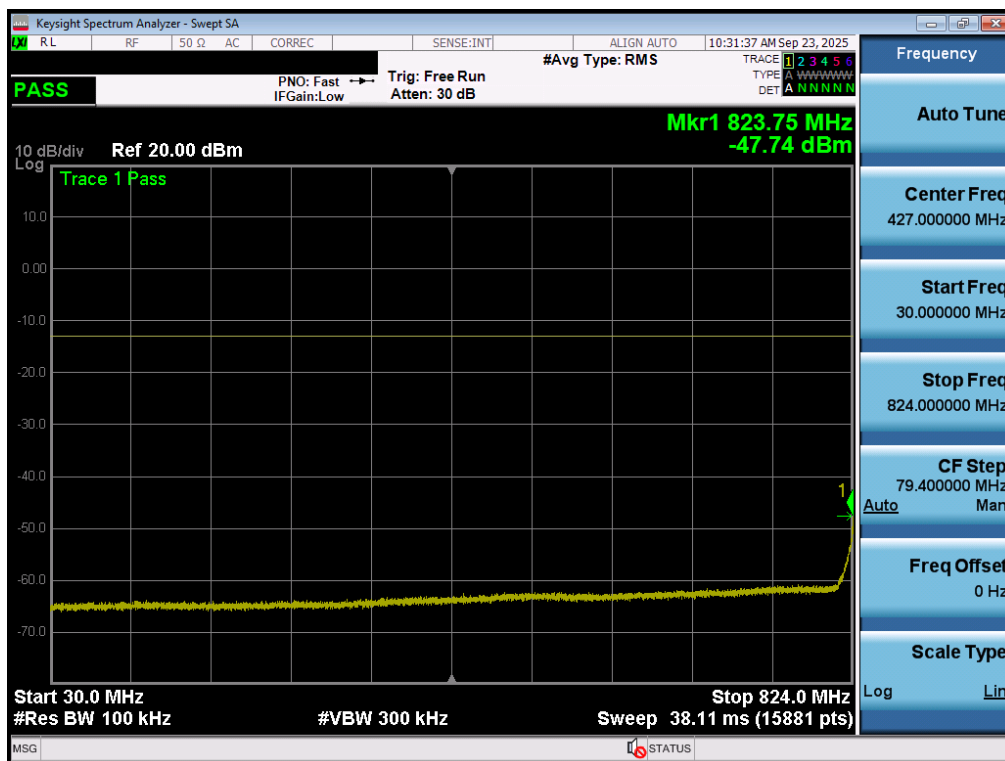


Plot 7-52. Conducted Spurious Plot (LTE Band 26/5 - 15MHz QPSK - 1 RB - Low Channel – Ant1)

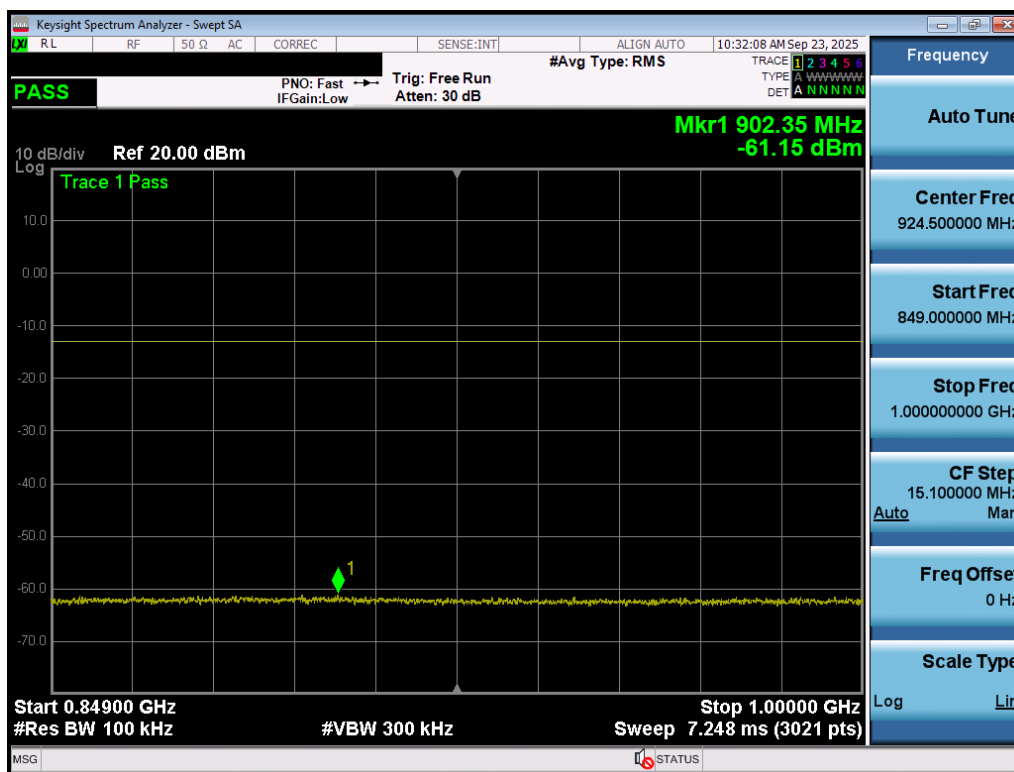


Plot 7-53. Conducted Spurious Plot (LTE Band 26/5 - 15MHz QPSK - 1 RB - Low Channel – Ant1)

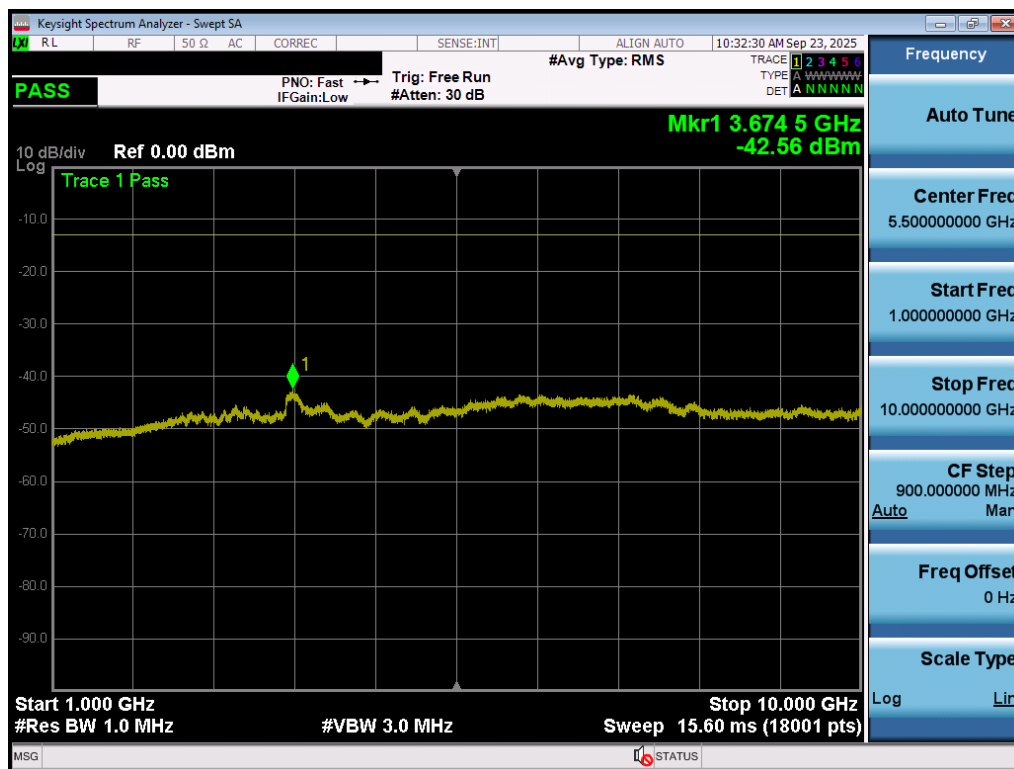


Plot 7-54. Conducted Spurious Plot (LTE Band 26/5 - 15MHz QPSK - 1 RB - Mid Channel – Ant1)

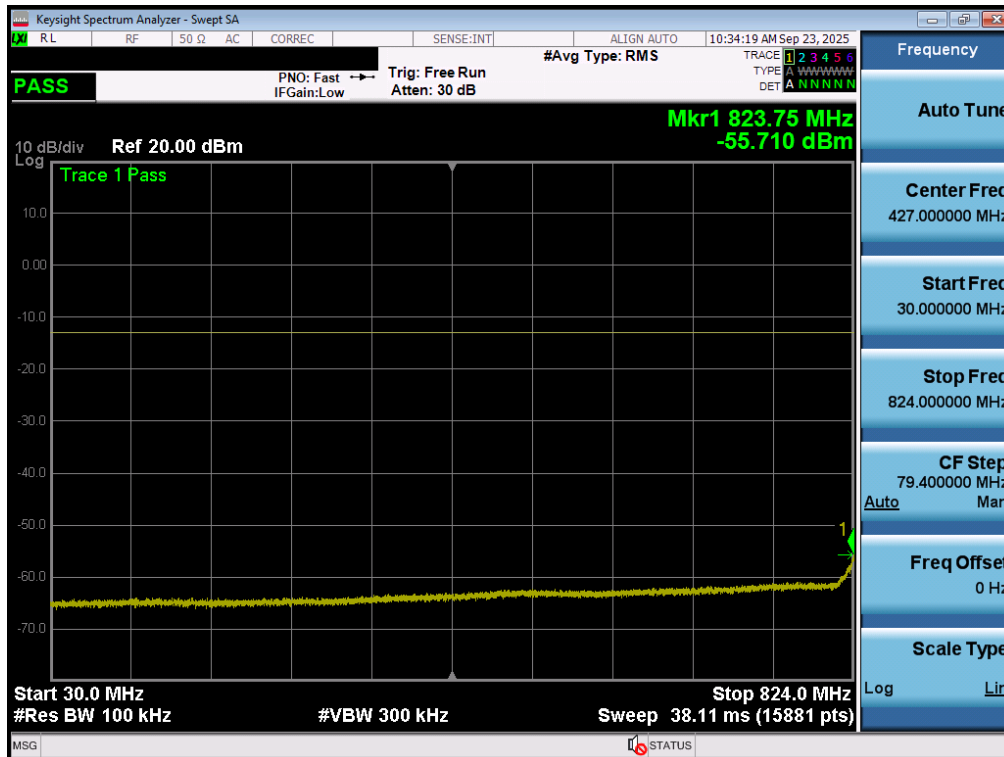


Plot 7-55. Conducted Spurious Plot (LTE Band 26/5 - 15MHz QPSK - 1 RB - Mid Channel – Ant1)

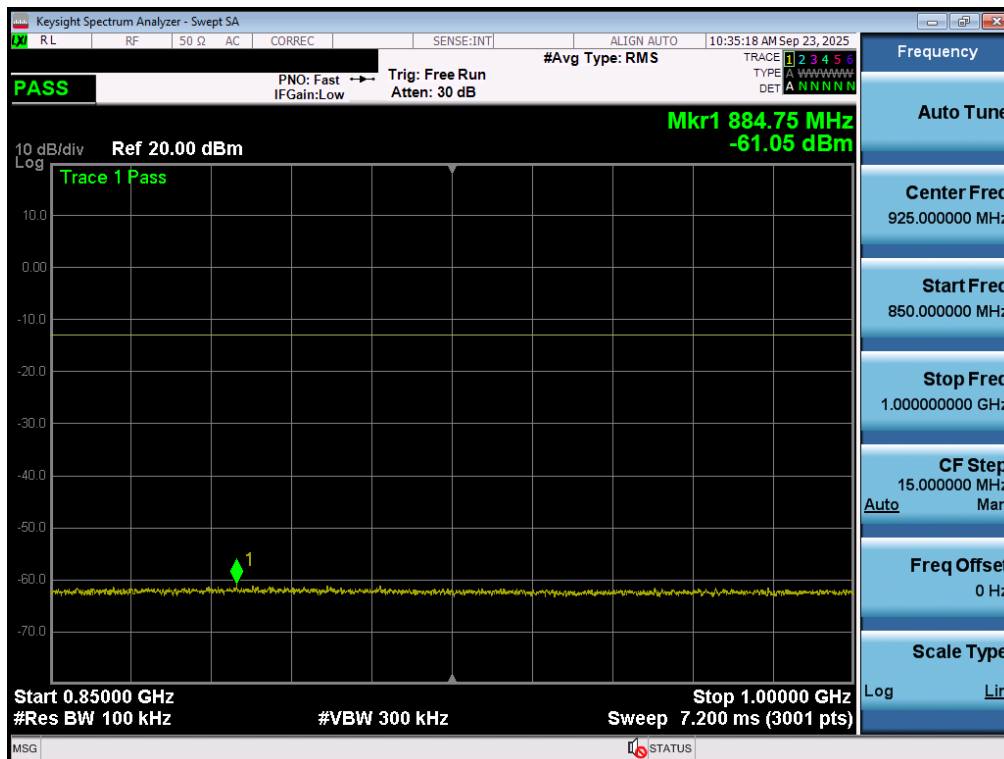


Plot 7-56. Conducted Spurious Plot (LTE Band 26/5 - 15MHz QPSK - 1 RB - Mid Channel – Ant1)

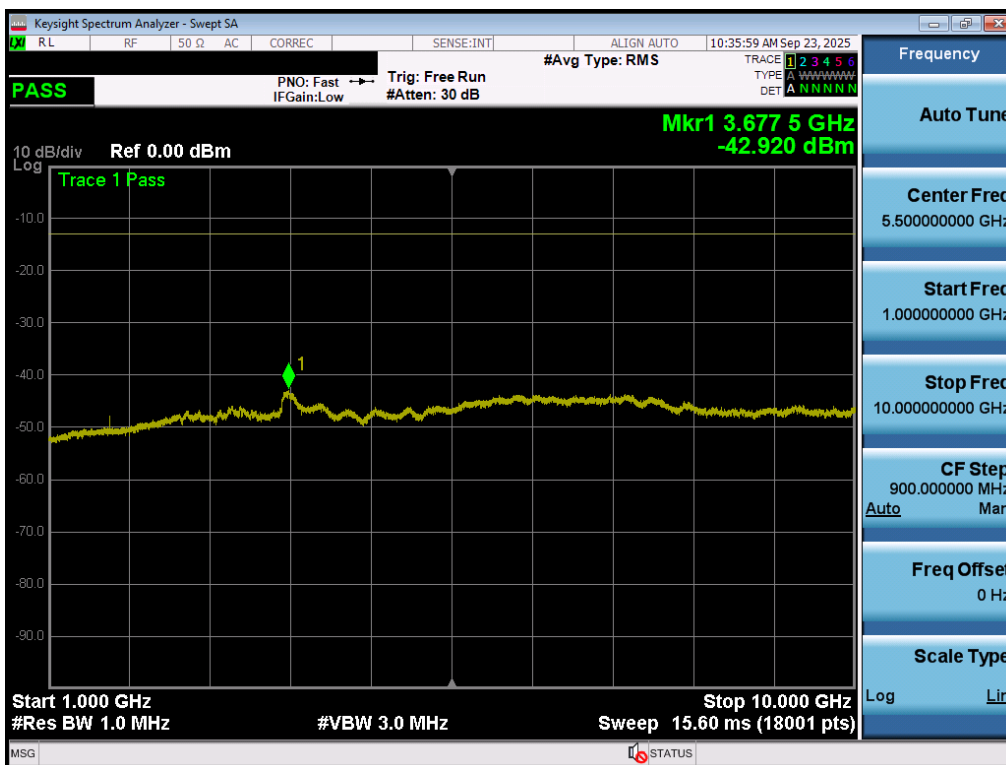


Plot 7-57. Conducted Spurious Plot (LTE Band 26/5 - 15MHz QPSK - 1 RB - High Channel – Ant1)

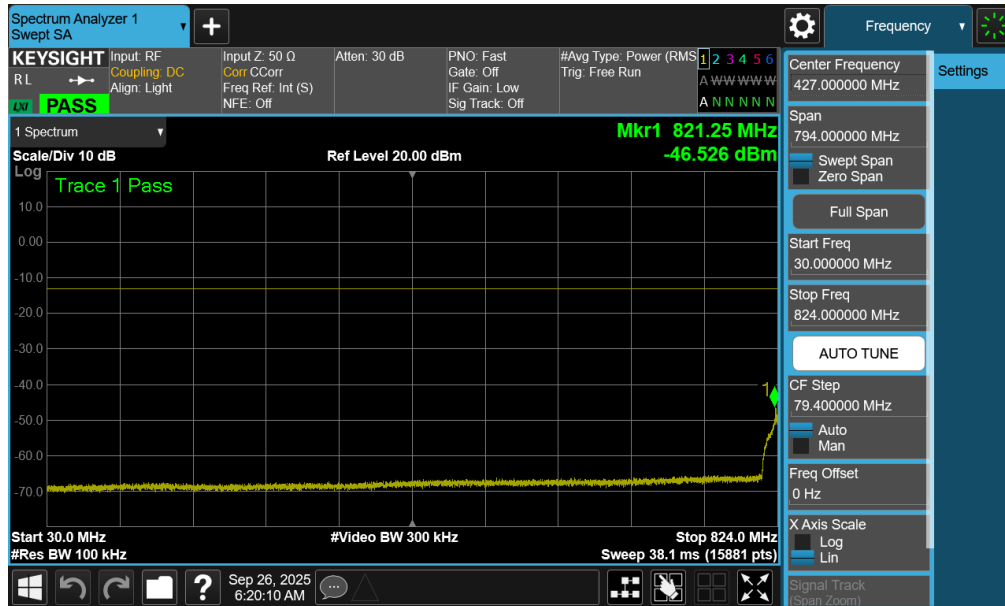

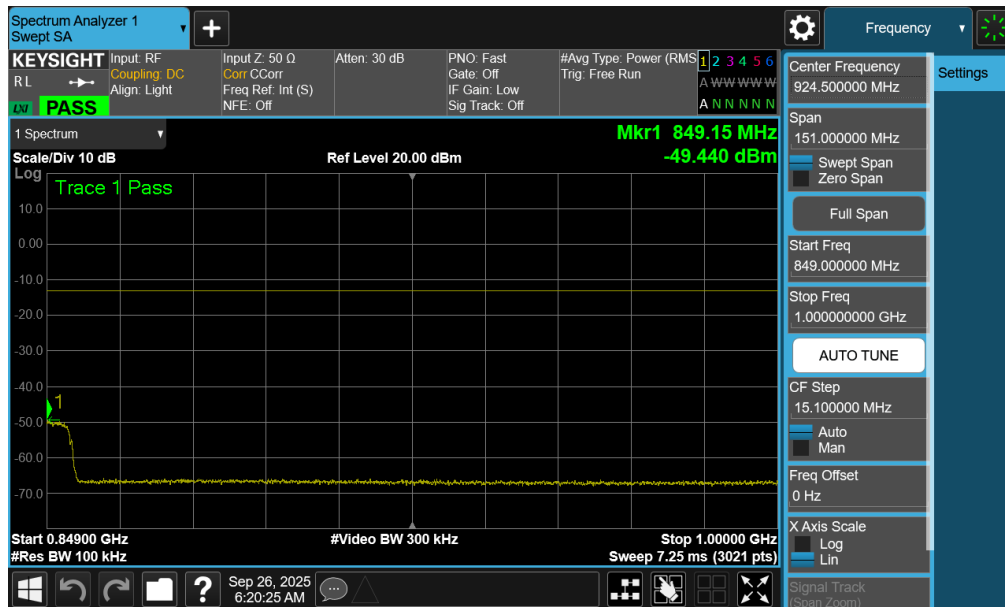
Plot 7-59. Conducted Spurious Plot (LTE Band 26/5 - 15MHz QPSK - 1 RB - High Channel – Ant1)

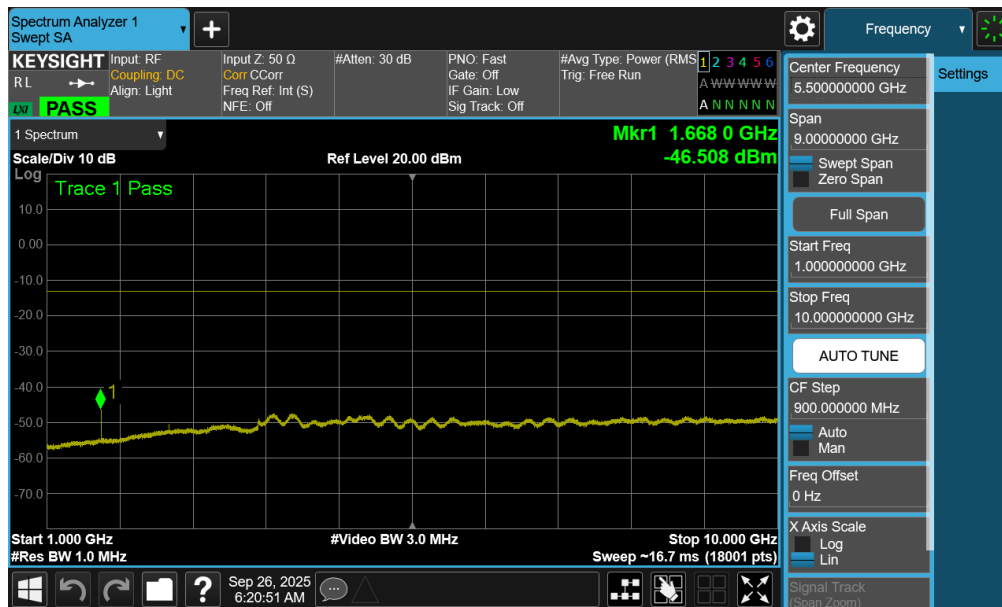


Plot 7-60. Conducted Spurious Plot (NR Band n26/5 - 20.0MHz - 1 RB - Low Channel - Ant1)

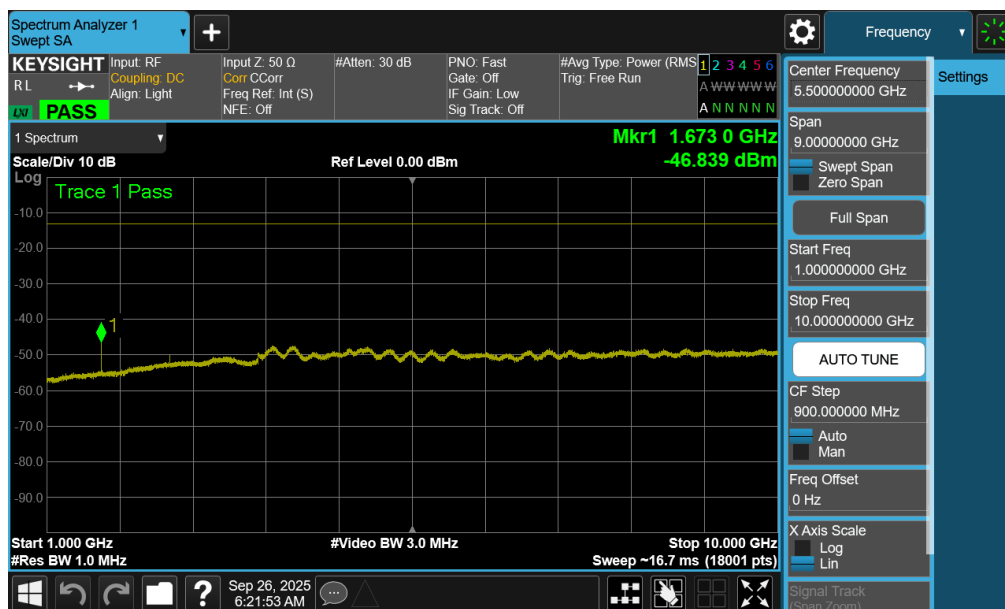
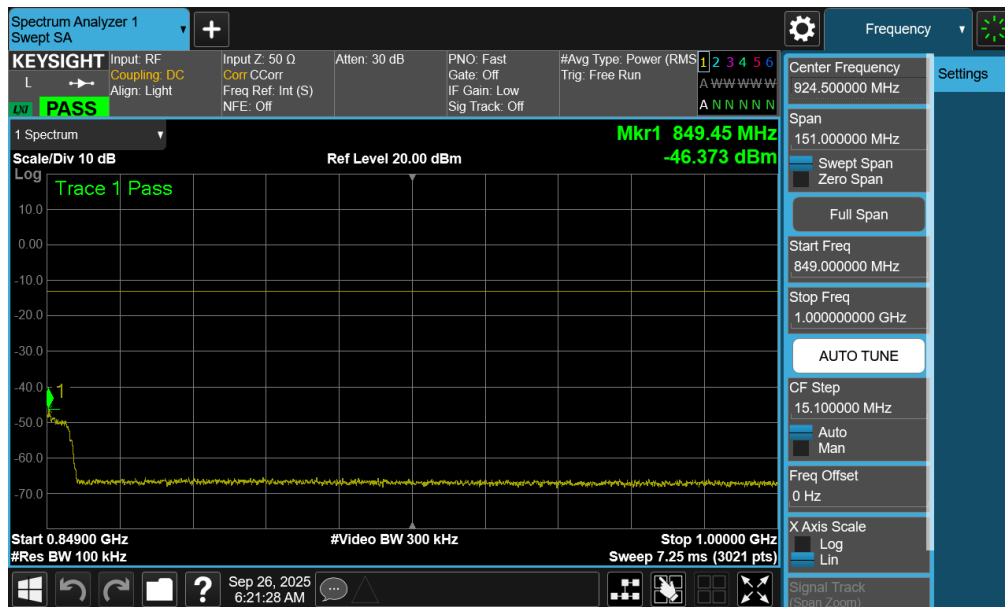


Plot 7-62. Conducted Spurious Plot (NR Band n26/5 - 20.0MHz - 1 RB - Low Channel - Ant1)

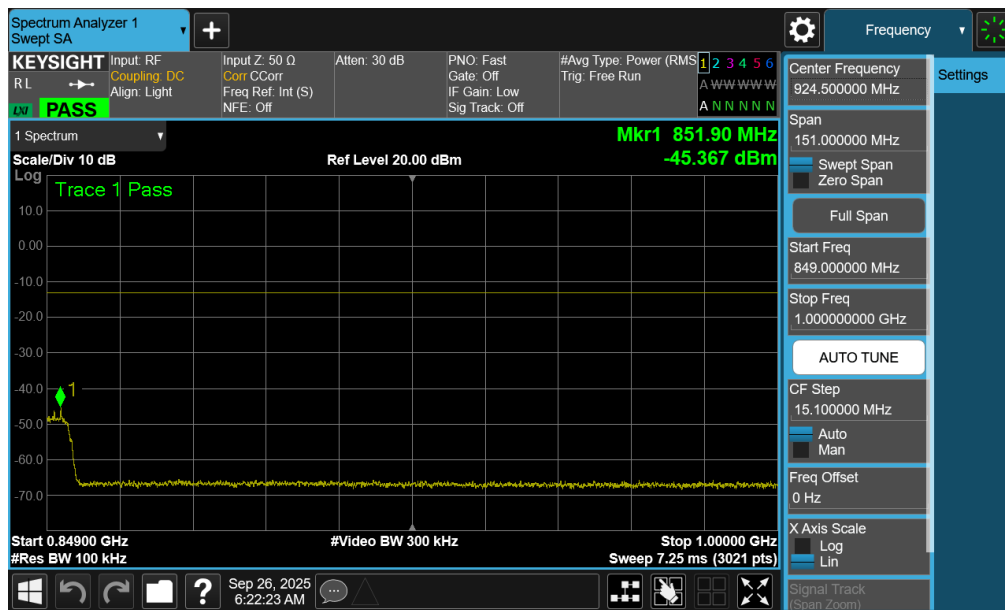


Plot 7-63. Conducted Spurious Plot (NR Band n26/5 - 20.0MHz - 1 RB - Mid Channel - Ant1)

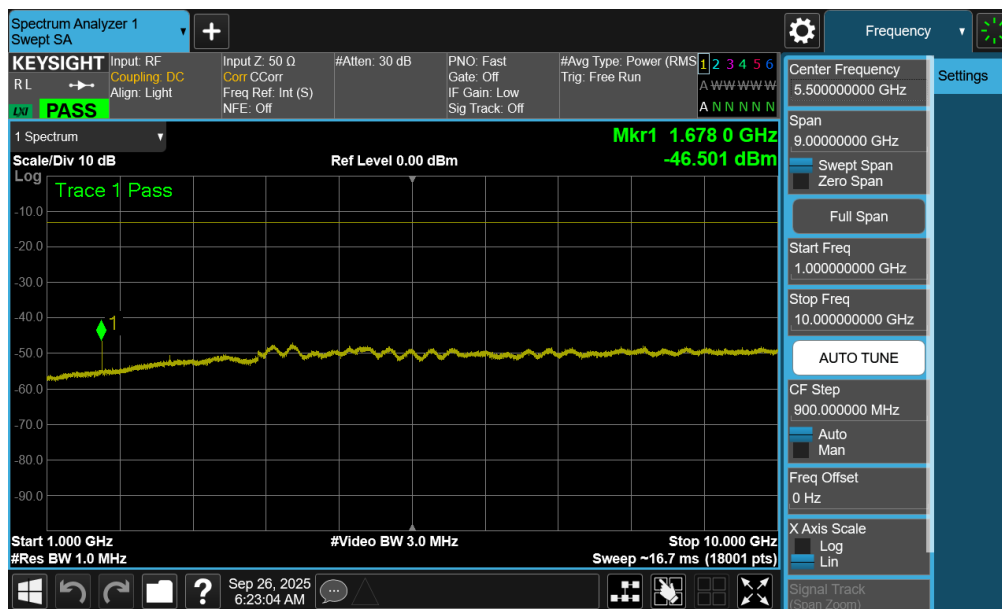

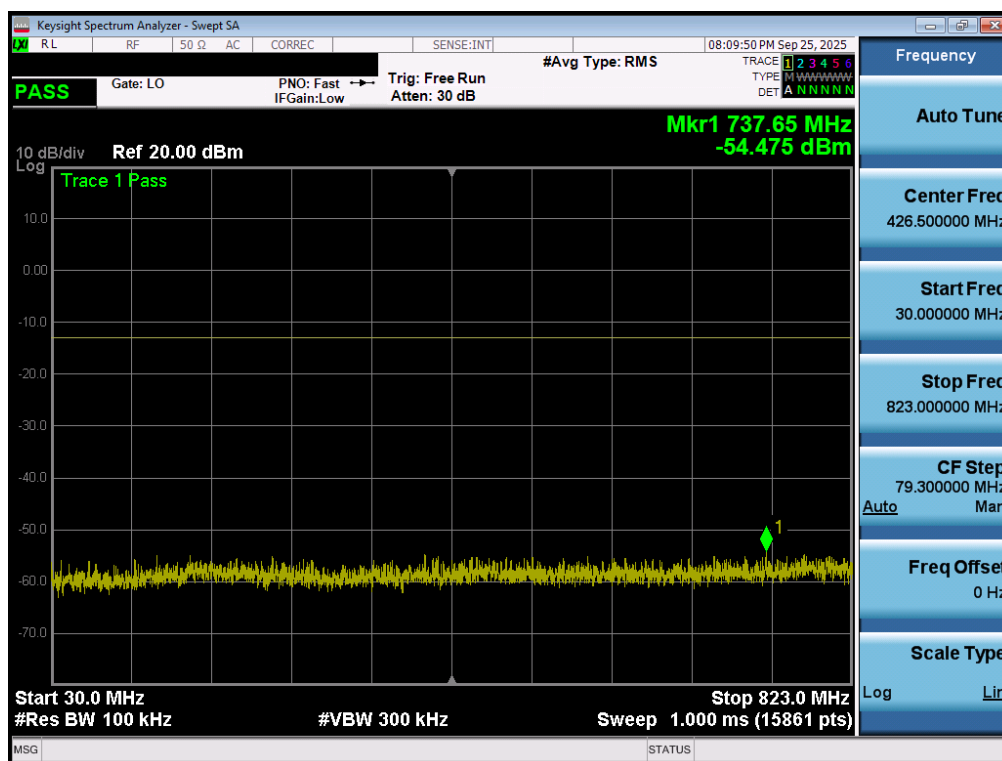

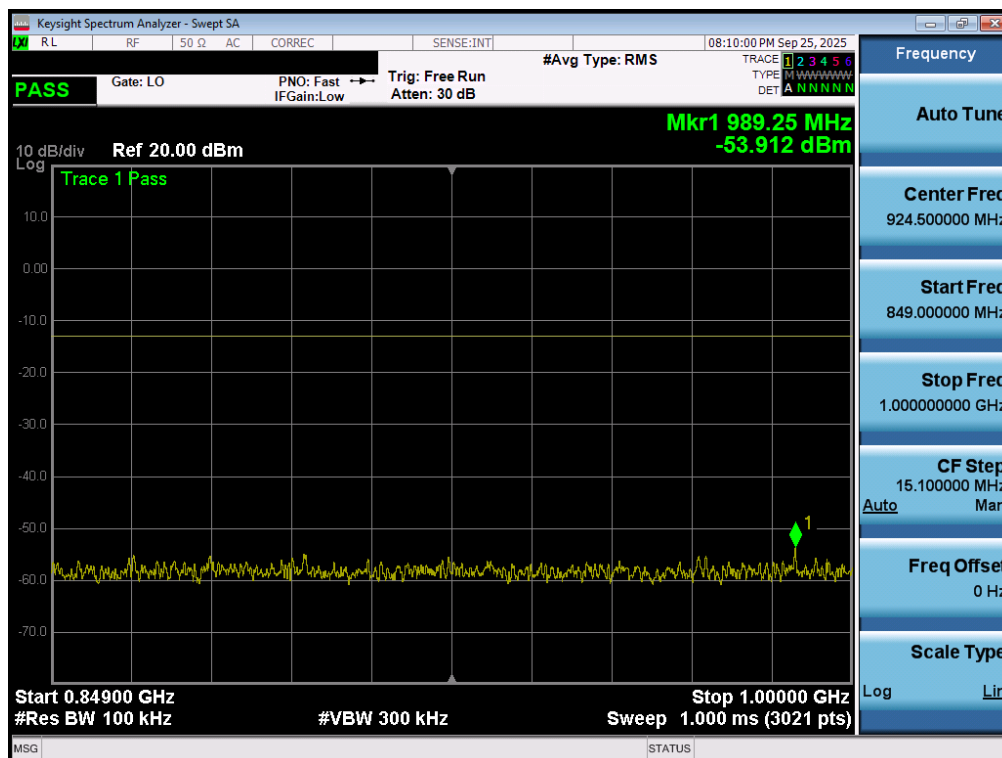
Plot 7-68. Conducted Spurious Plot (NR Band n26/5 - 20.0MHz - 1 RB - High Channel - Ant1)

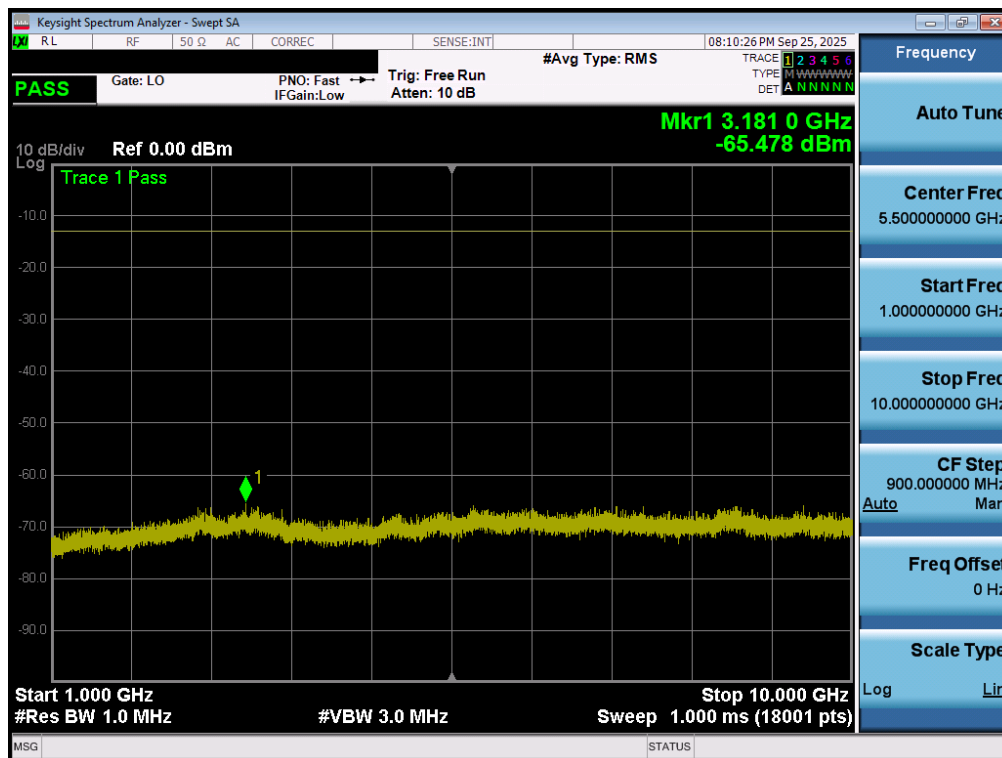


Plot 7-69. Conducted Spurious Plot (GPRS Ch. 128 – Ant1)

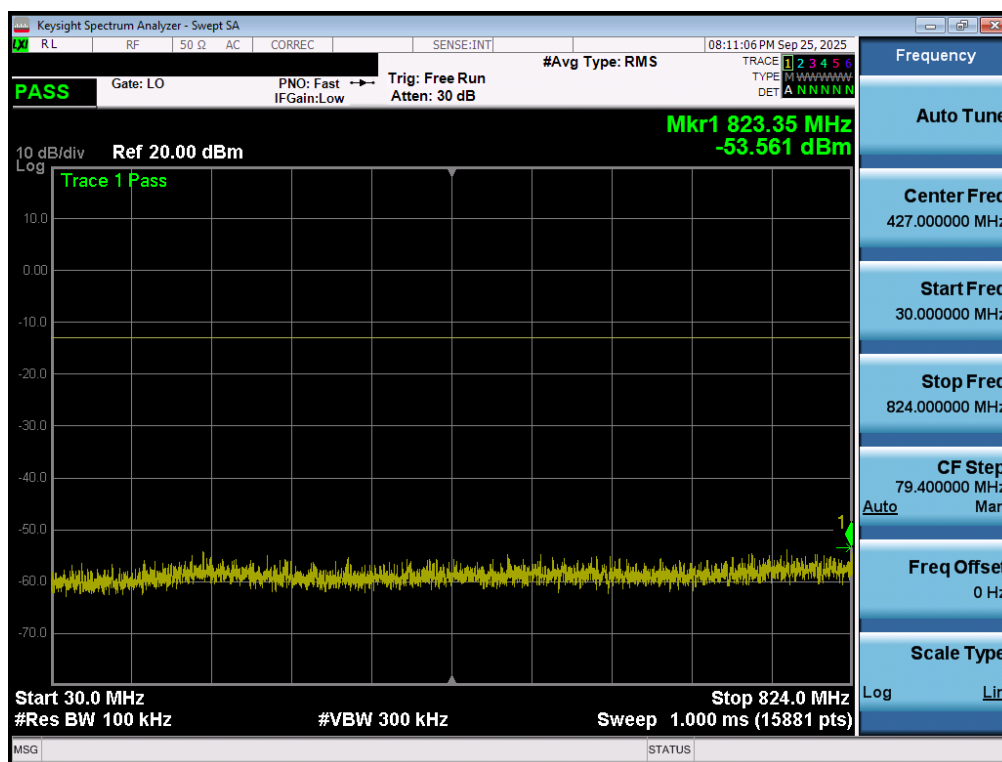


Plot 7-70. Conducted Spurious Plot (GPRS Ch. 128 – Ant1)

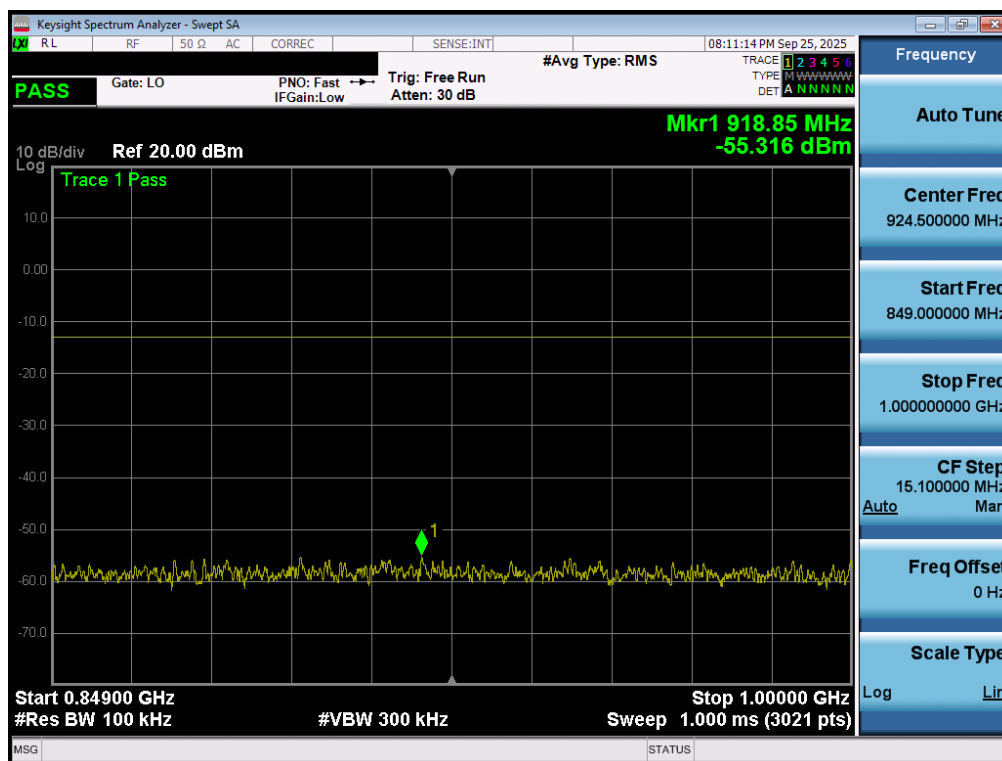


Plot 7-71. Conducted Spurious Plot (GPRS Ch. 128 – Ant1)

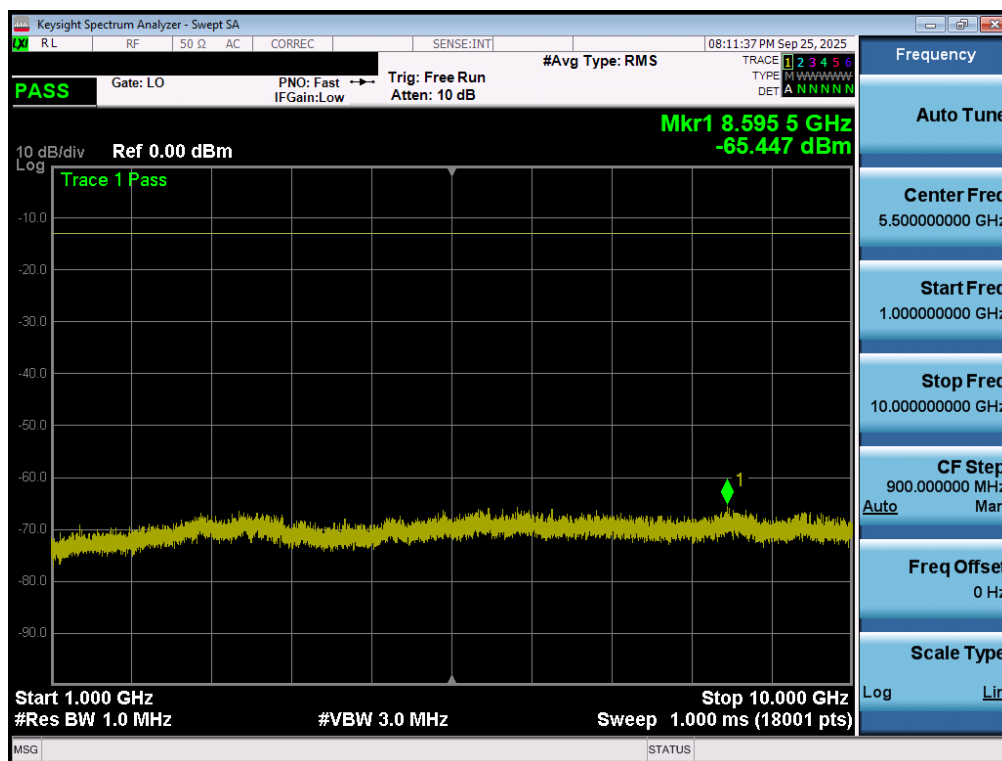


Plot 7-72. Conducted Spurious Plot (GPRS Ch. 190 – Ant1)

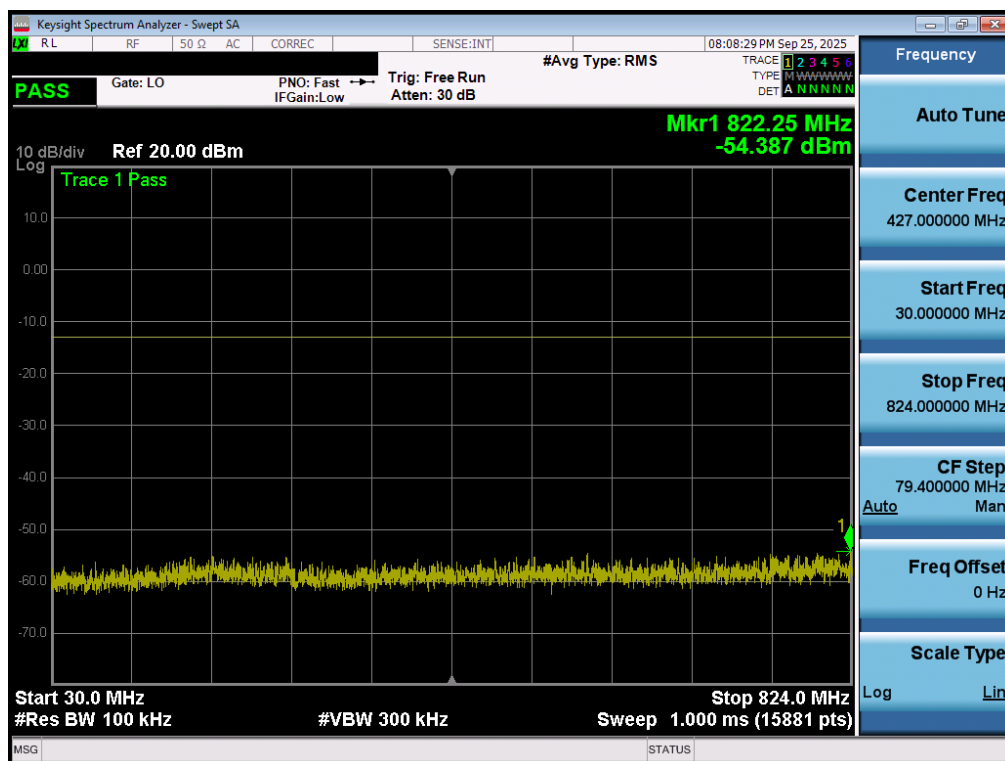


Plot 7-73. Conducted Spurious Plot (GPRS Ch. 190 – Ant1)

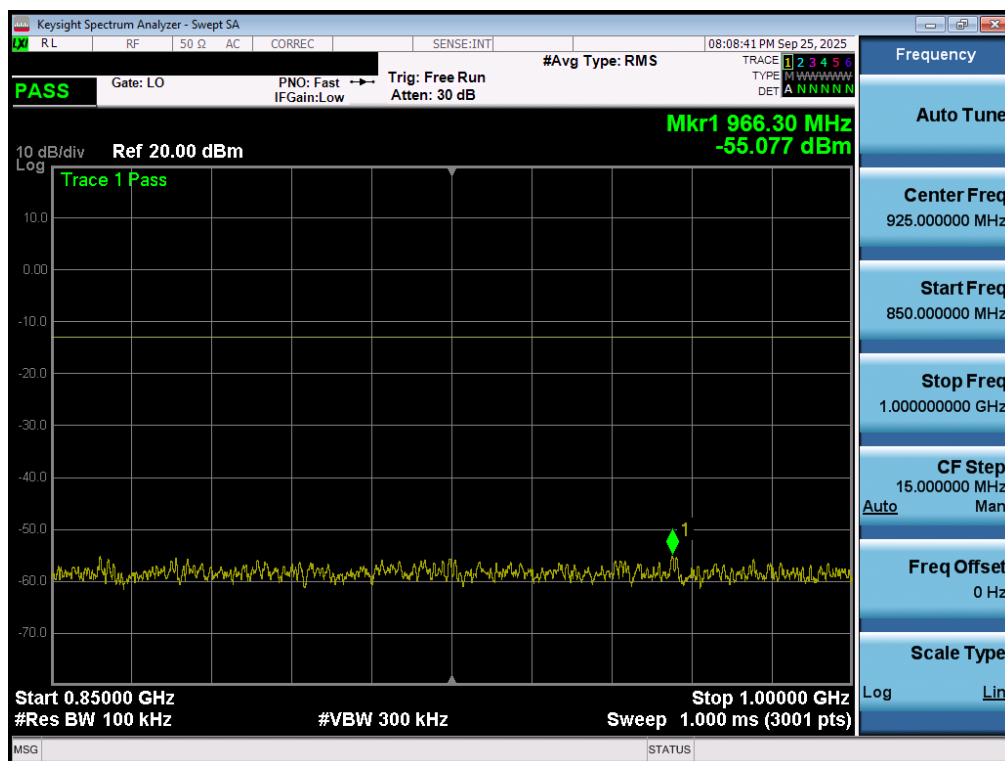


Plot 7-74. Conducted Spurious Plot (GPRS Ch. 190 – Ant1)

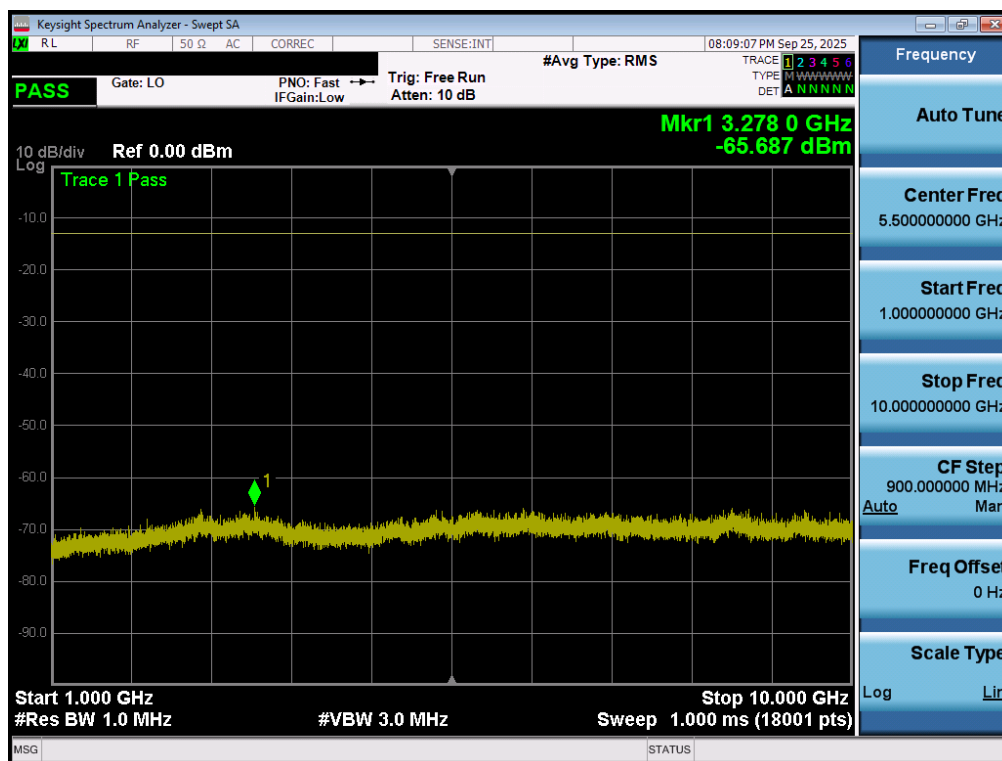


Plot 7-75. Conducted Spurious Plot (GPRS Ch. 251 – Ant1)

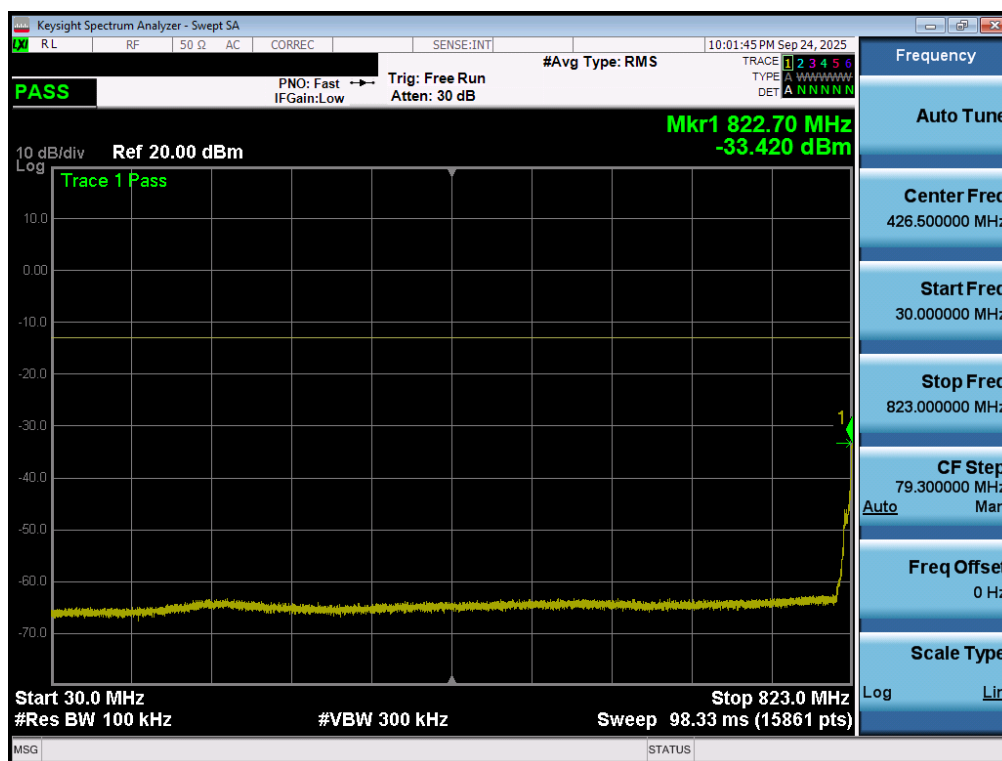

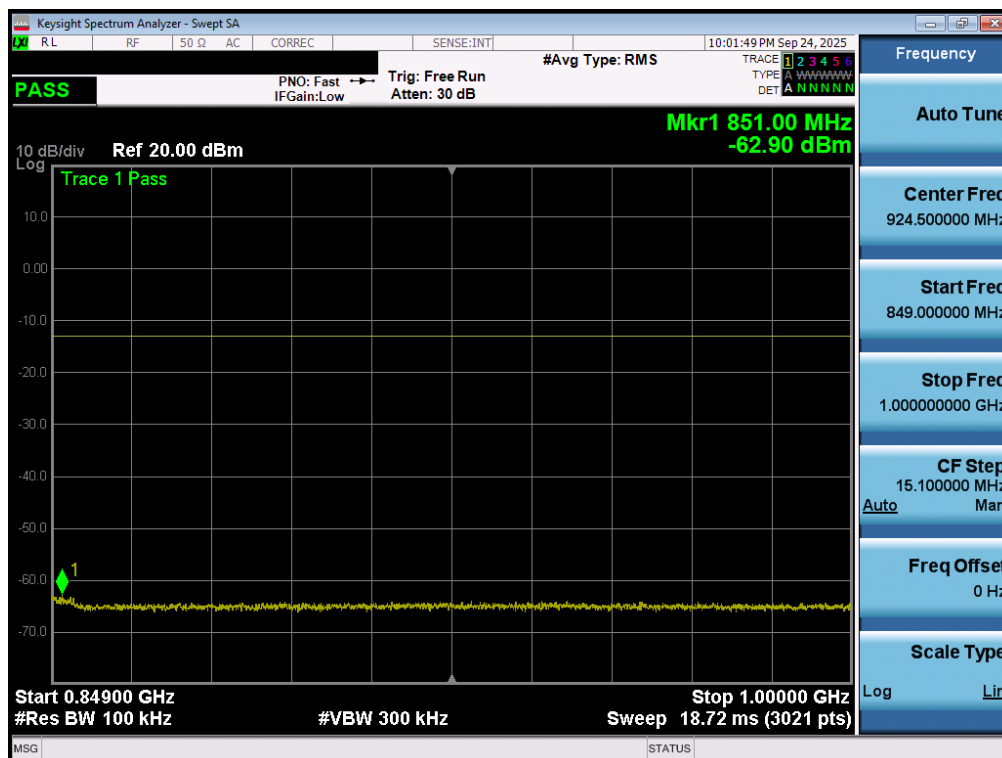
Plot 7-77. Conducted Spurious Plot (GPRS Ch. 251 – Ant1)

Plot 7-78. Conducted Spurious Plot (WCDMA Ch. 4132 – Ant1)

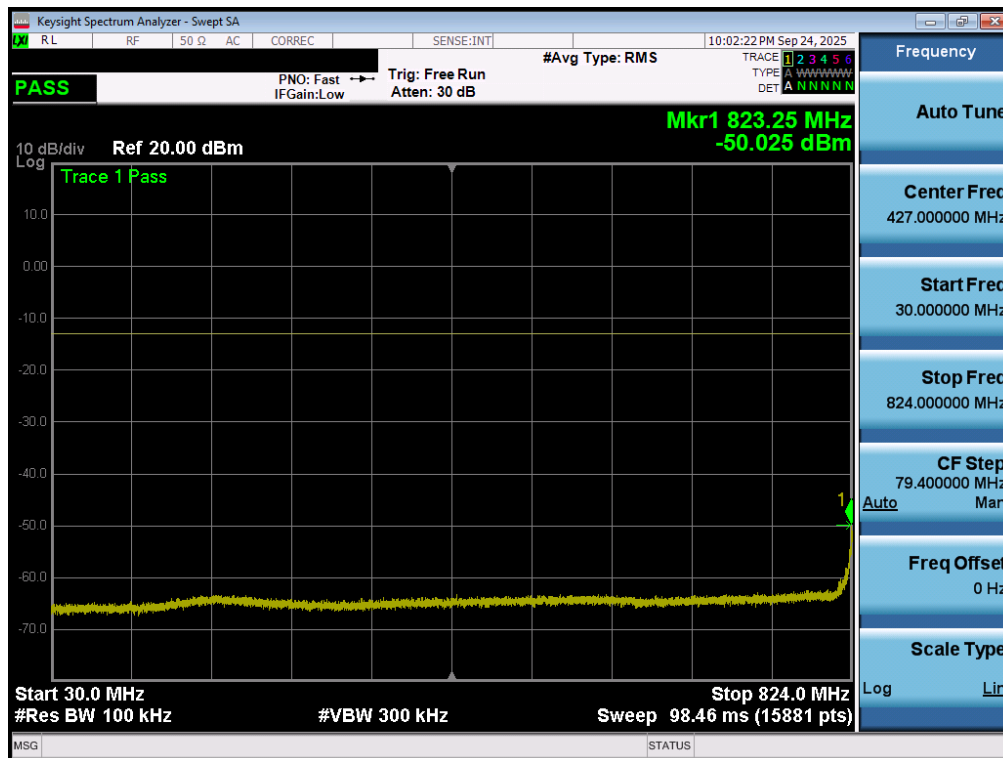
