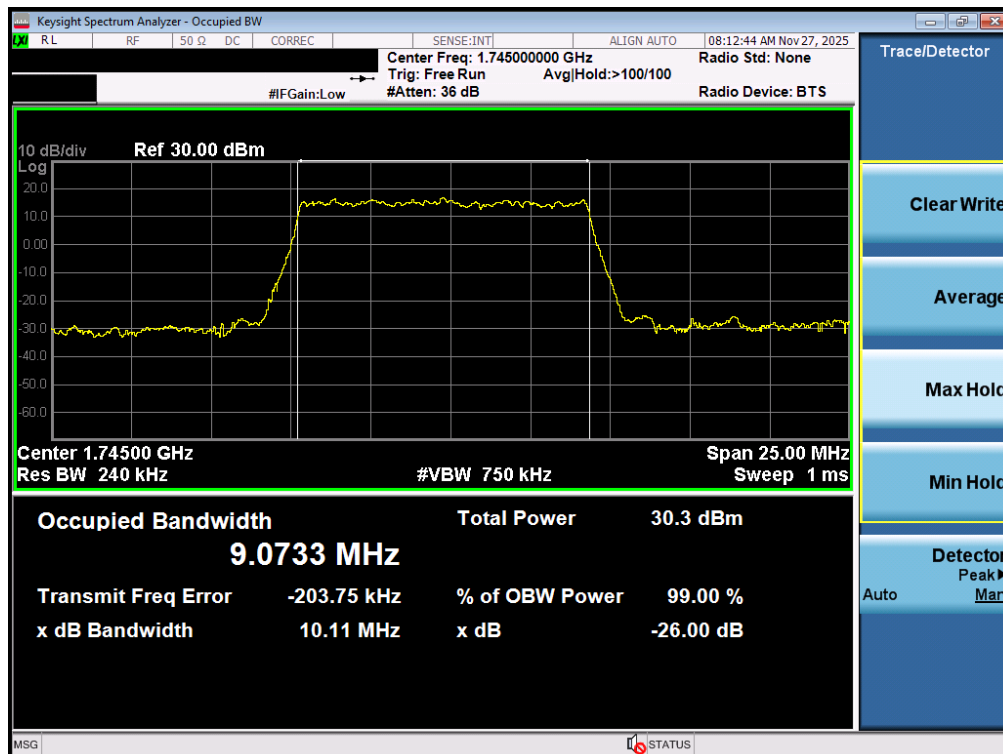


Plot 7-103. Occupied Bandwidth Plot (NR Band n66 - 15.0MHz CP-OFDM QPSK - Full RB – ANT2)

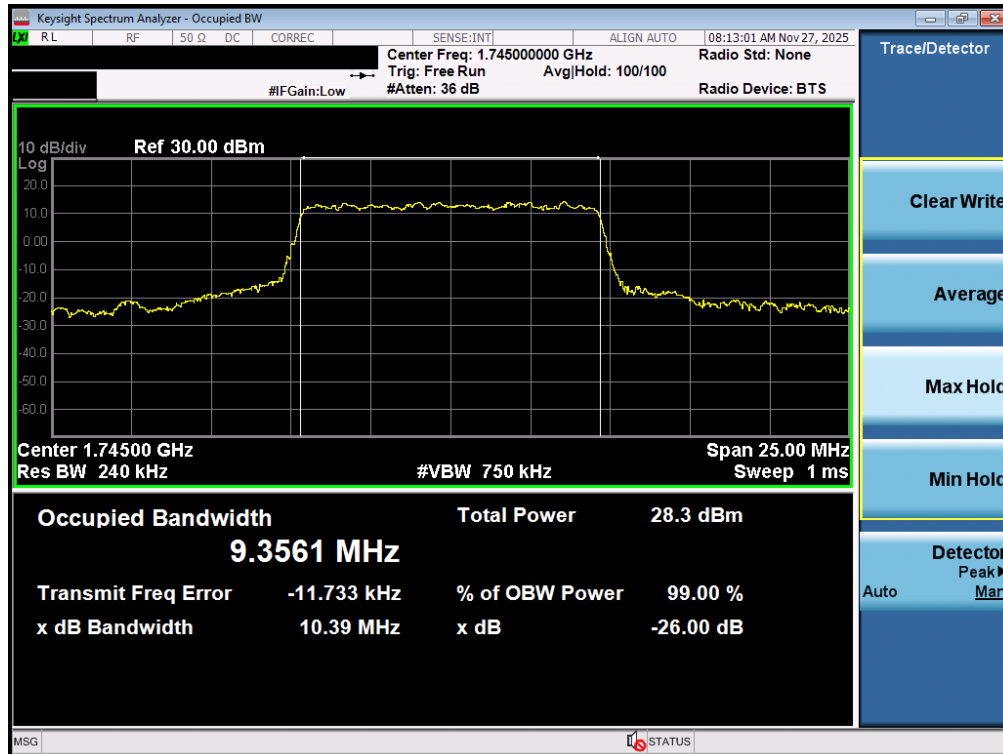

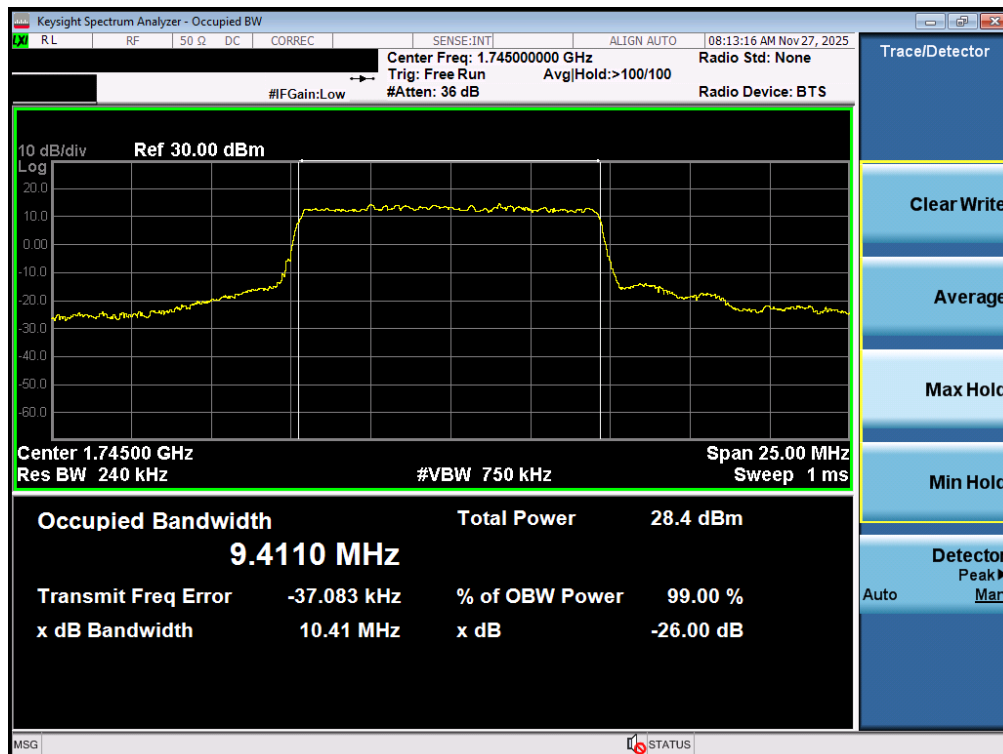

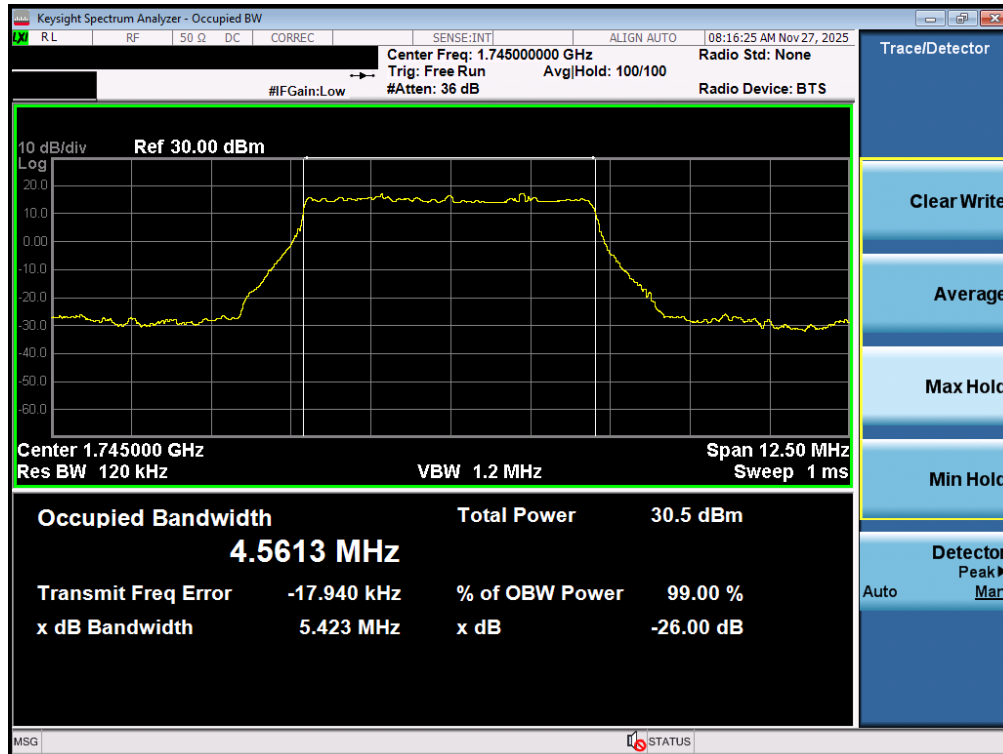


Plot 7-106. Occupied Bandwidth Plot (NR Band n66 - 10.0MHz CP-OFDM QPSK - Full RB – ANT2)

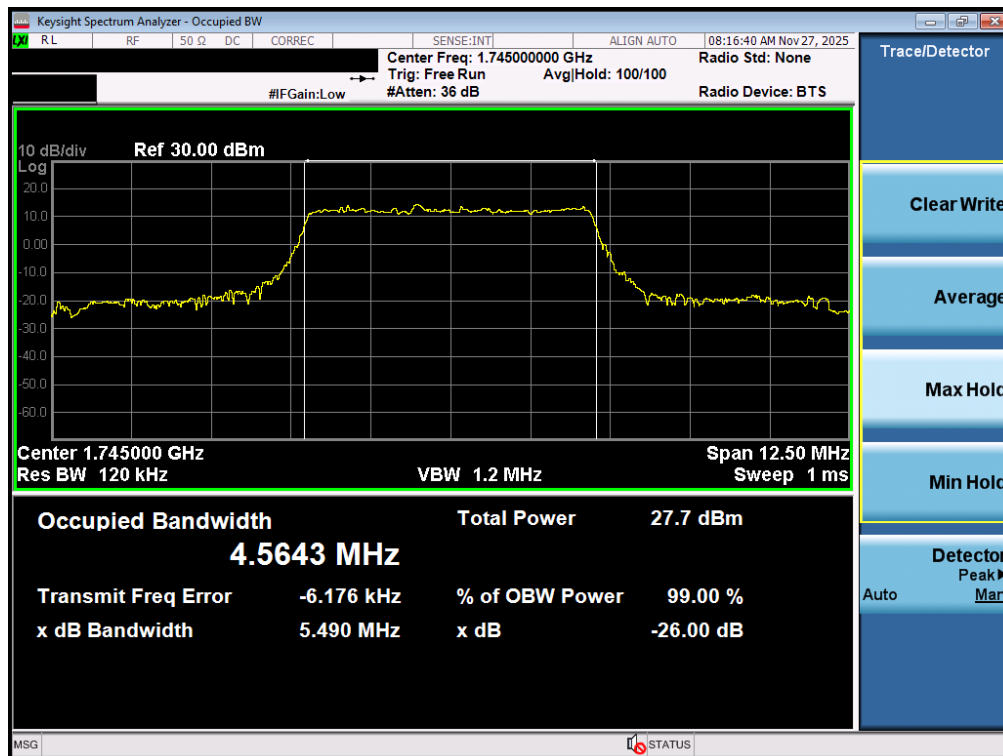

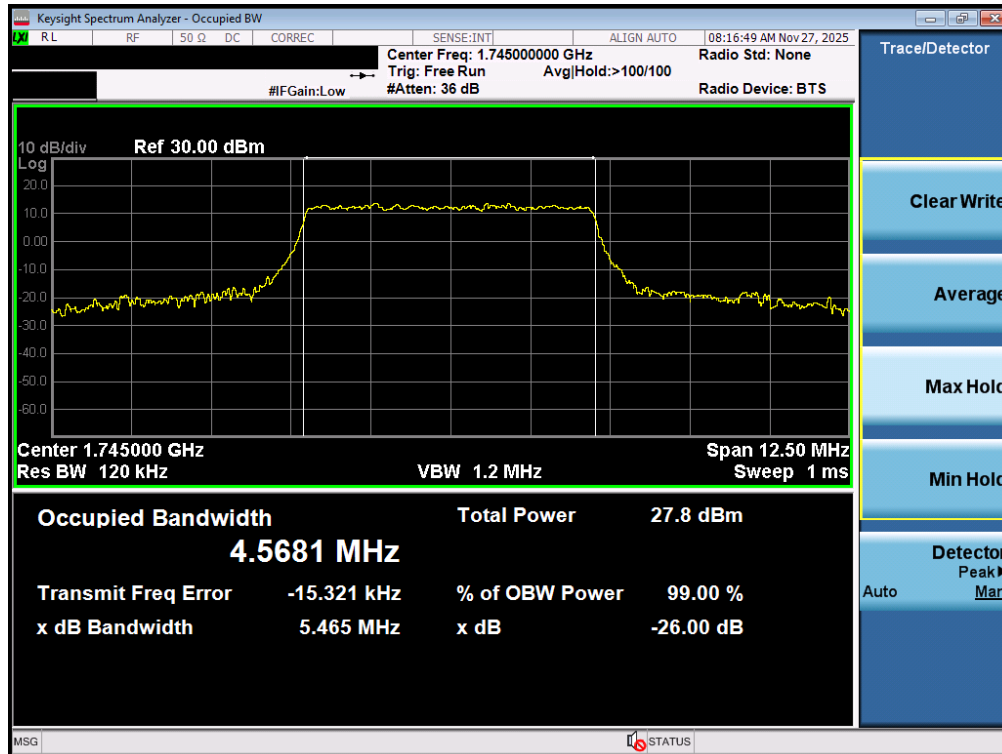

7.4 Spurious and Harmonic Emissions at Antenna Terminal

Test Overview

The level of the carrier and the various conducted spurious and harmonic frequencies is measured by means of a calibrated spectrum analyzer. The spectrum is scanned from the lowest frequency generated in the equipment up to a frequency including its 10th harmonic. All out of band emissions are measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at maximum power, and at the appropriate frequencies. All data rates were investigated to determine the worst case configuration. All modes of operation were investigated and the worst case configuration results are reported in this section.

The minimum permissible attenuation level of any spurious emission is $43 + 10 \log_{10}(P_{[Watts]})$, where P is the transmitter power in Watts.

Test Procedure Used

ANSI C63.26-2015 – Section 5.7.4

Test Settings

1. Start frequency was set to 30MHz and stop frequency was set to 18GHz (separated into at least two plots per channel)
2. RBW $\geq$ 100kHz
3. VBW $\geq$ 3 x RBW
4. Detector = RMS
5. Trace mode = max hold
6. Sweep time = auto couple
7. The trace was allowed to stabilize

Test Setup

The EUT and measurement equipment were set up as shown in the diagram below.

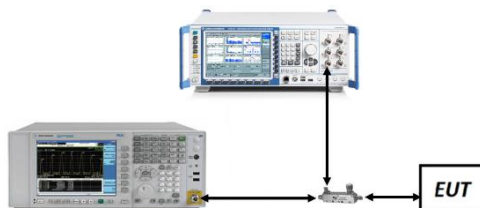


Figure 7-3. Test Instrument & Measurement Setup

Test Notes

1. Per Part 27 and RSS-139, compliance with the applicable limits is based on the use of measurement instrumentation employing a resolution bandwidth 100 kHz or greater for measurements below 1GHz.
2. For NR operation, all subcarrier spacings (SCS) and transmission schemes (e.g. CP-OFDM and DFT-s-OFDM) were investigated to determine the worst case configuration. All modes of operation were investigated and the worst case configuration results are reported in this section.

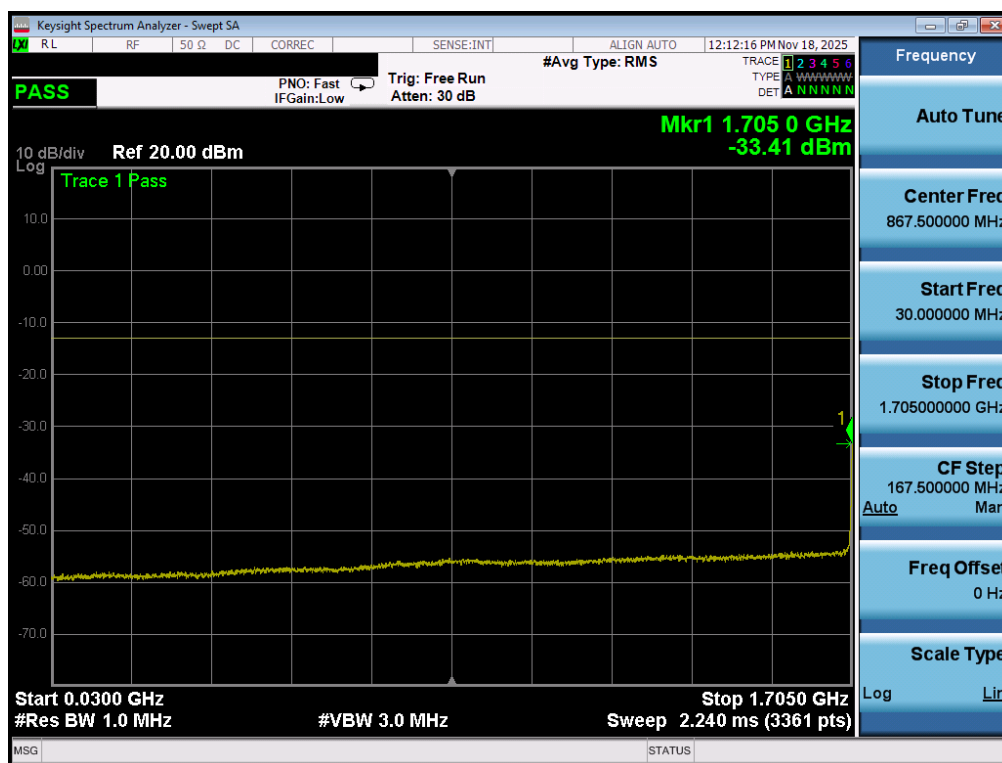

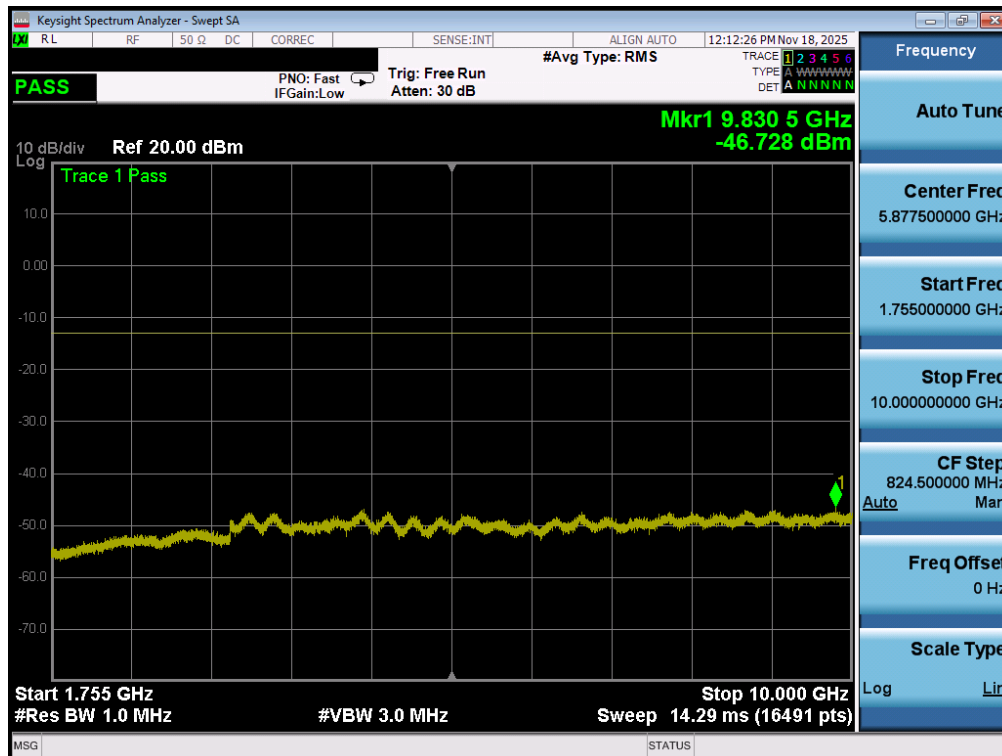

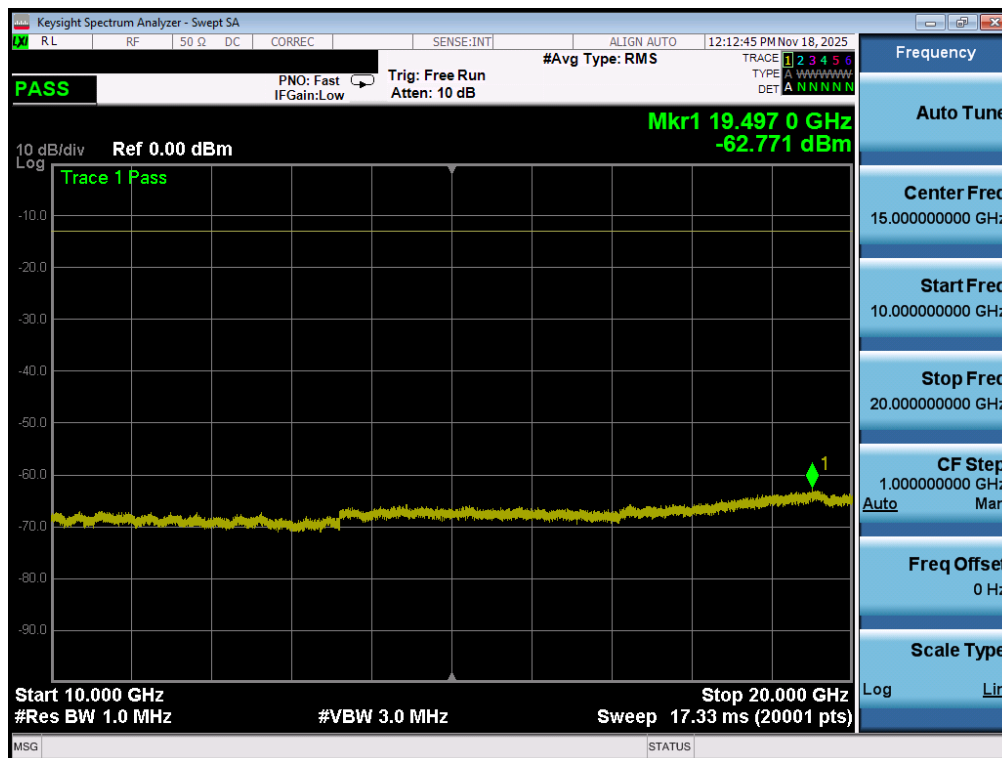


Plot 7-111. Conducted Spurious Plot (WCDMA-AWS - 5MHz QPSK - 1 RB – Low Channel)

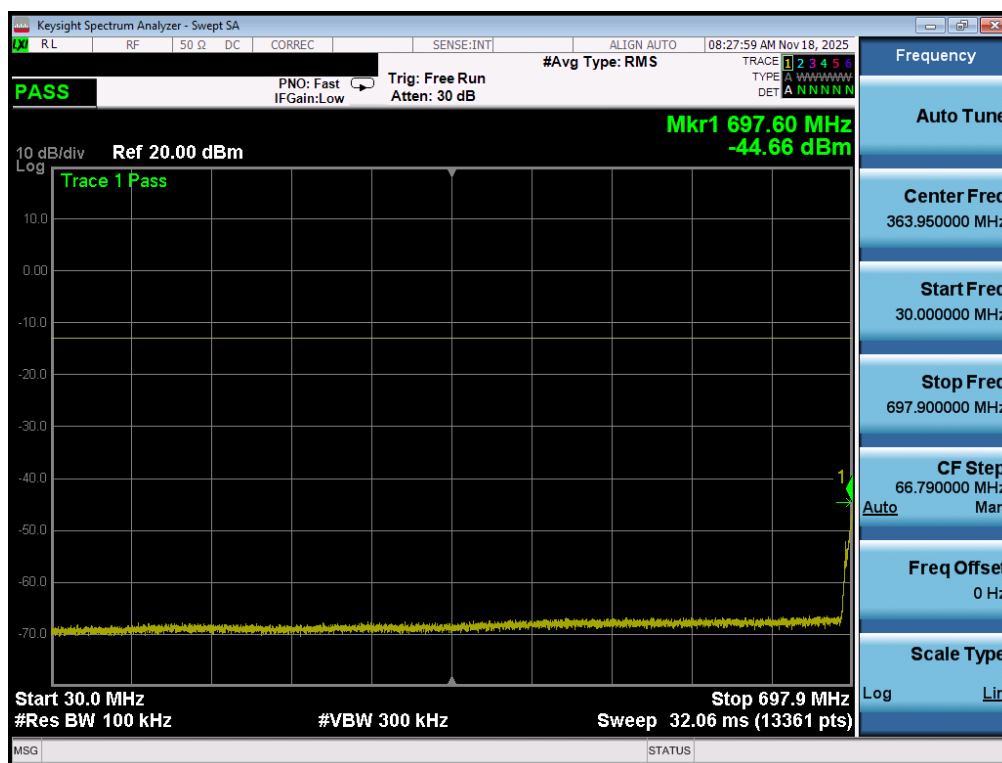

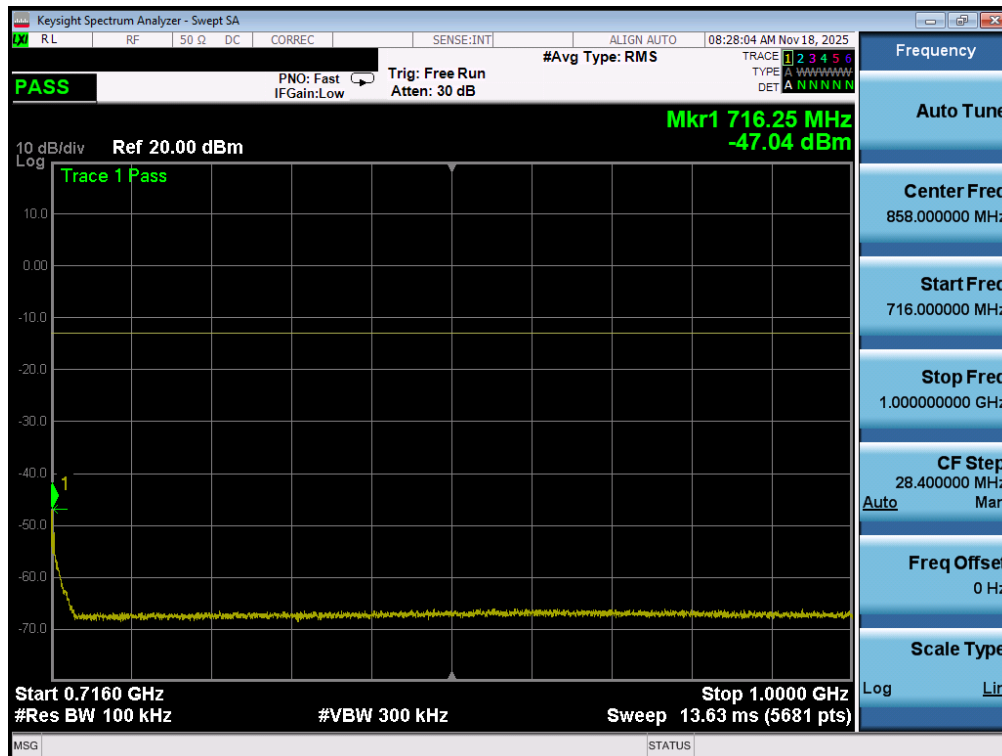
Plot 7-113. Conducted Spurious Plot (WCDMA-AWS - 5MHz QPSK - 1 RB – Low Channel)

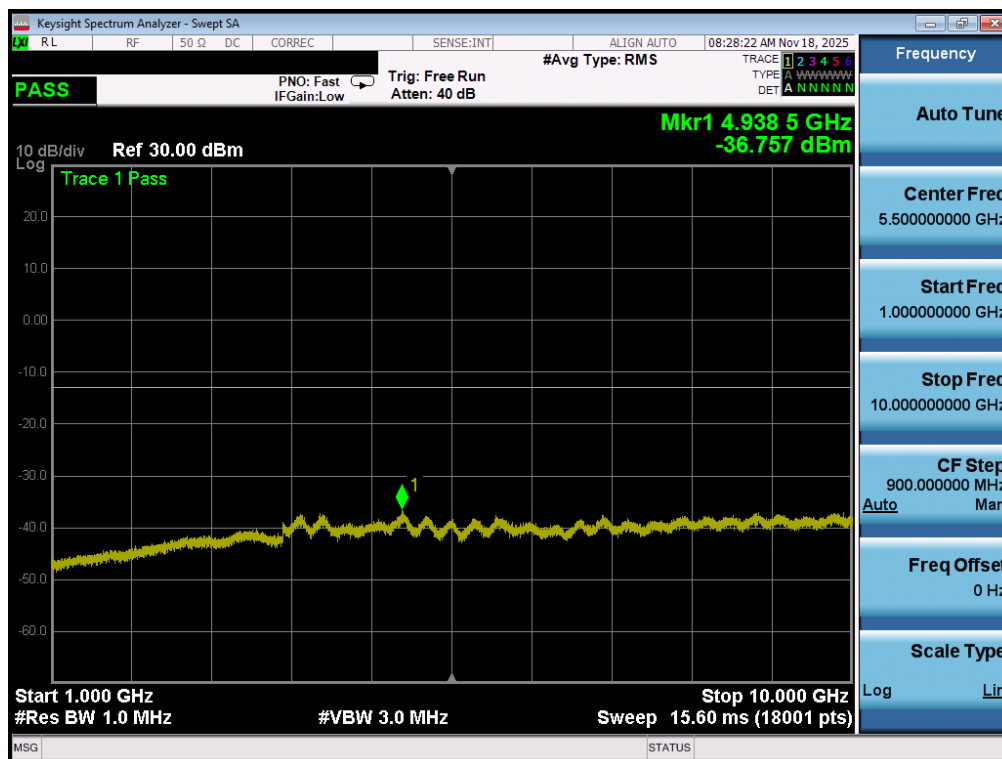


Plot 7-114. Conducted Spurious Plot (LTE Band 12/17 - 10MHz QPSK - 1 RB - Low Channel - ANT1)



Plot 7-115. Conducted Spurious Plot (LTE Band 12/17 - 10MHz QPSK - 1 RB - Low Channel - ANT1)

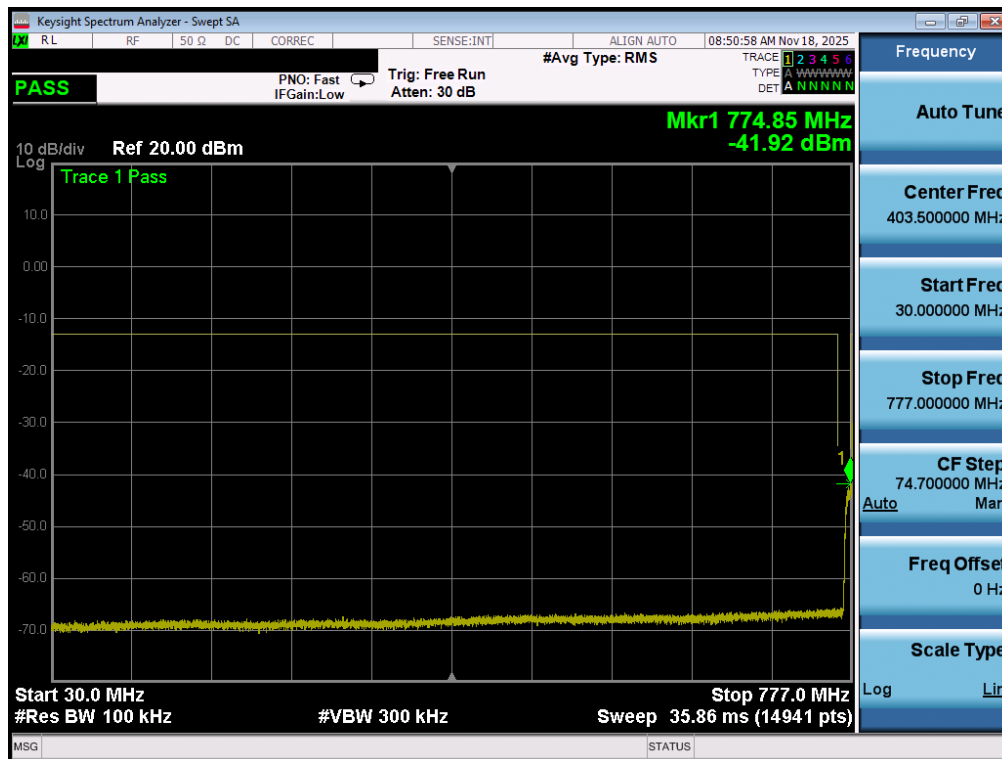

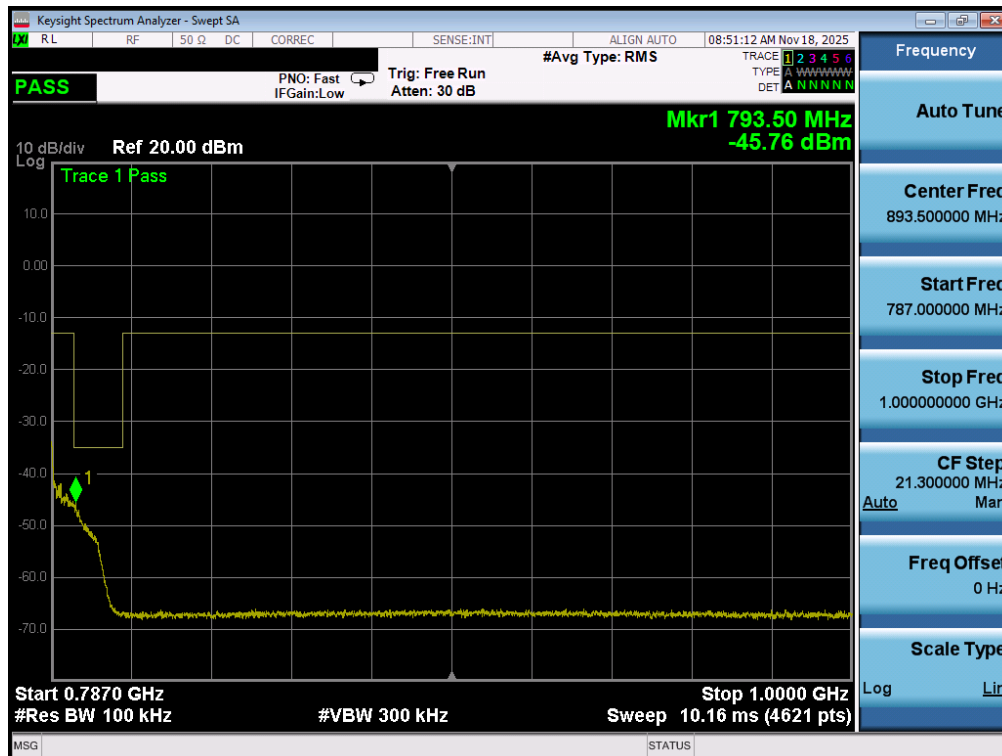
Plot 7-116. Conducted Spurious Plot (LTE Band 12/17 - 10MHz QPSK - 1 RB - Low Channel - ANT1)

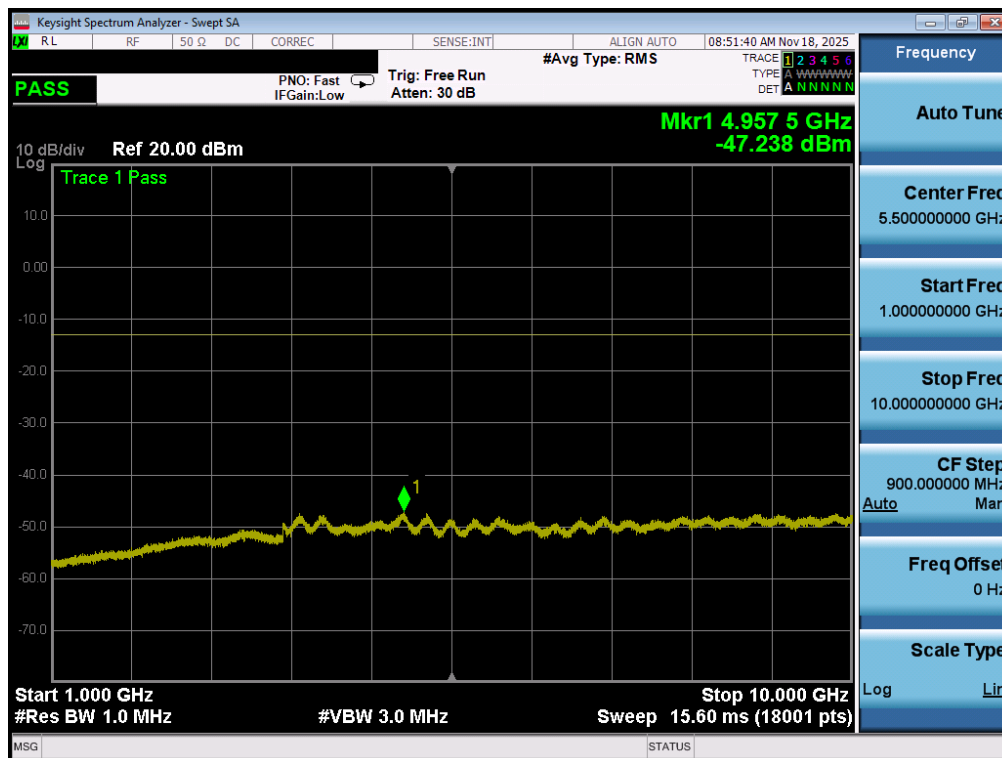


Plot 7-117. Conducted Spurious Plot (LTE Band 13 - 10MHz QPSK - 1 RB)

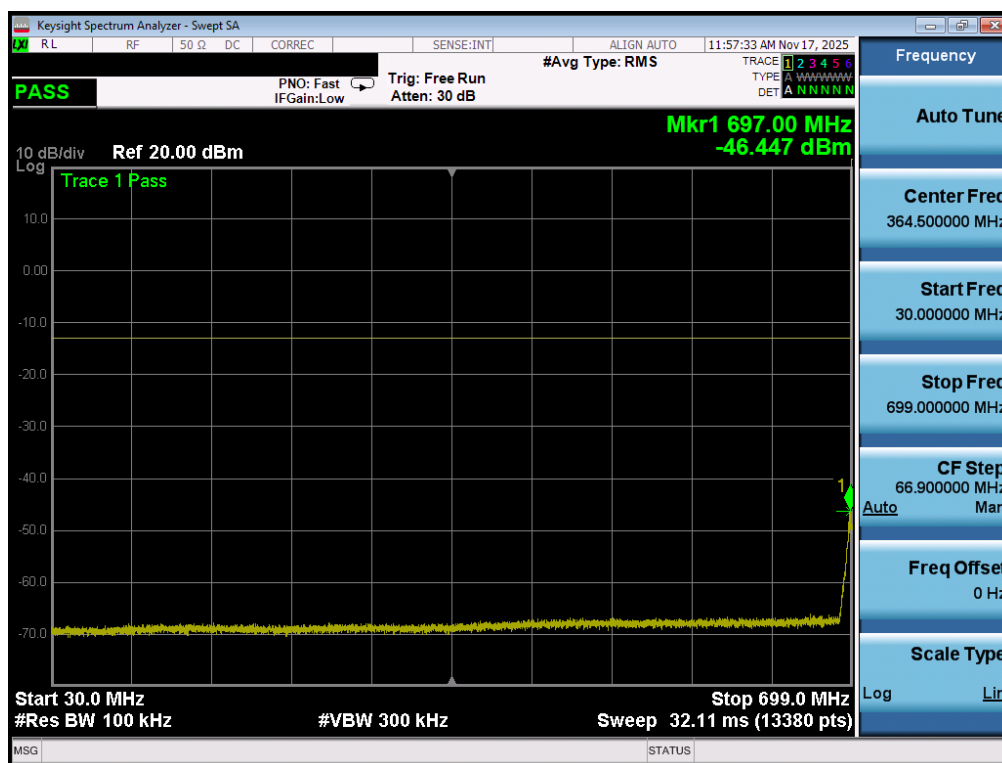

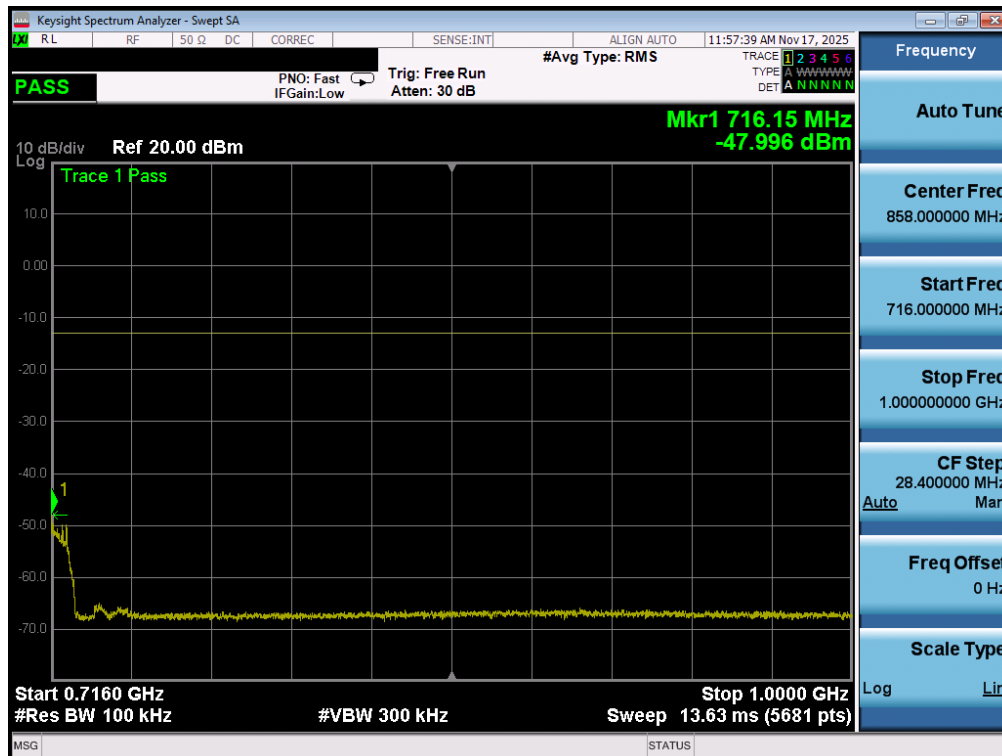
Plot 7-119. Conducted Spurious Plot (LTE Band 13 - 10MHz QPSK - 1 RB)

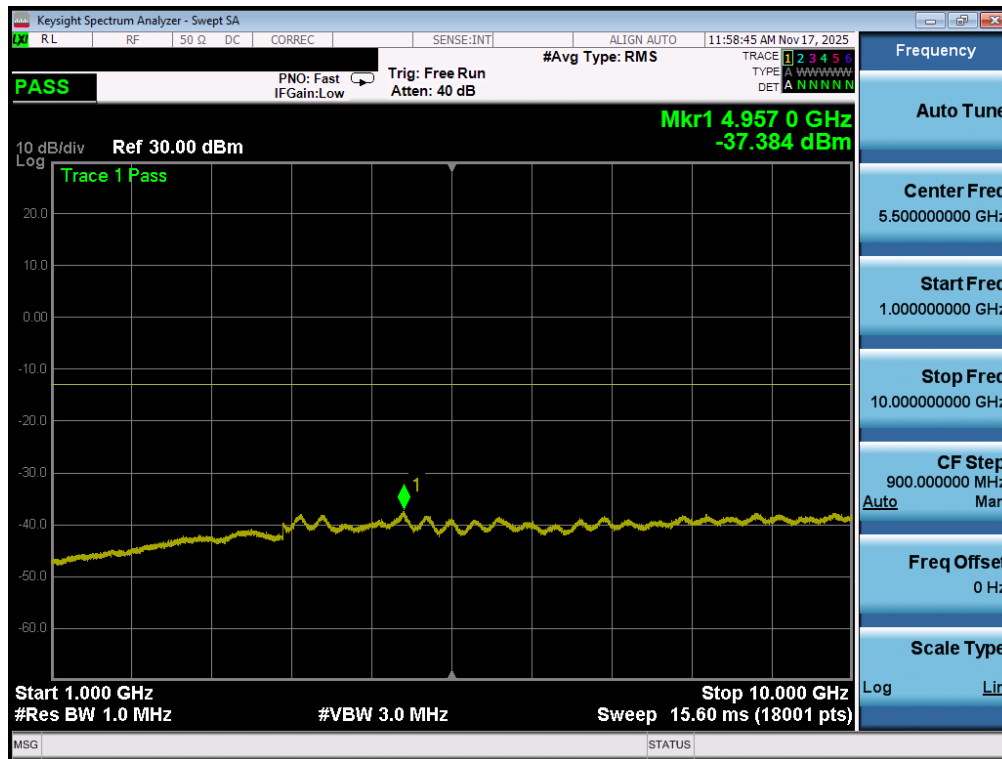


Plot 7-120. Conducted Spurious Plot (NR Band n12 - 15.0MHz - 1 RB - High Channel - ANT1)

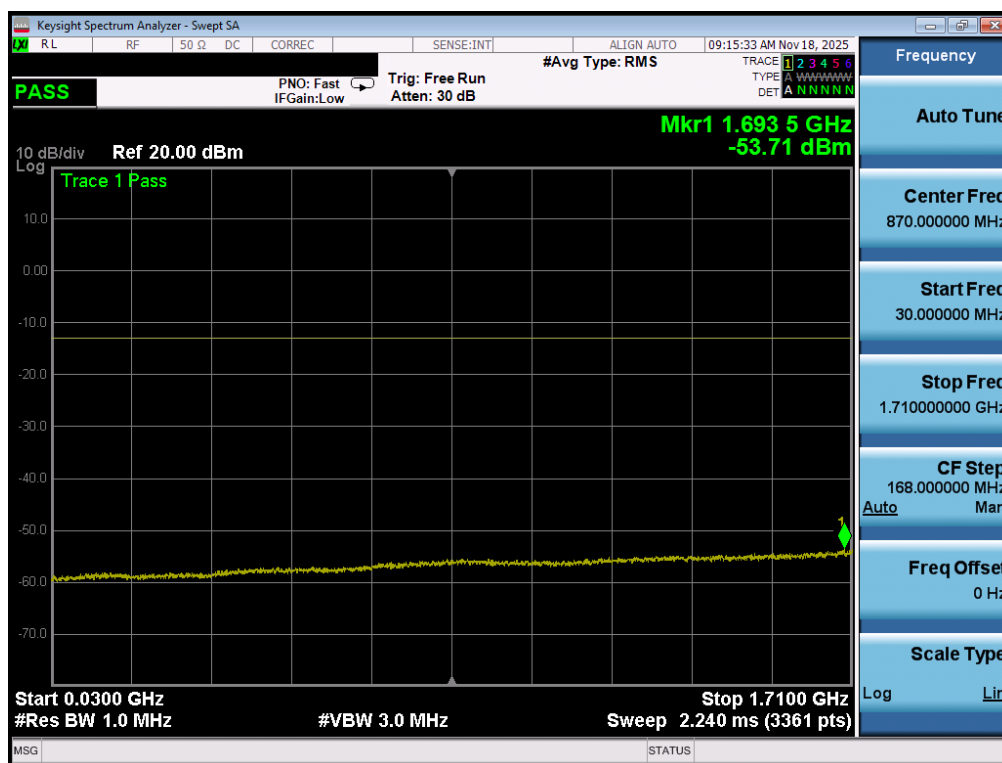

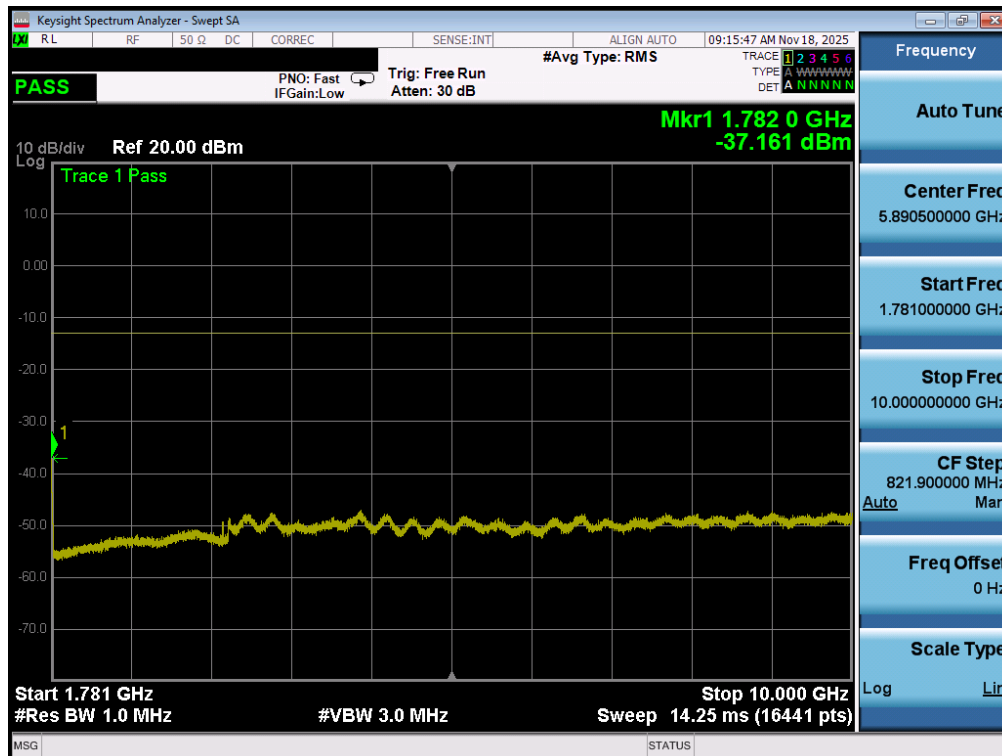
Plot 7-122. Conducted Spurious Plot (NR Band n12 - 15.0MHz - 1 RB - High Channel - ANT1)

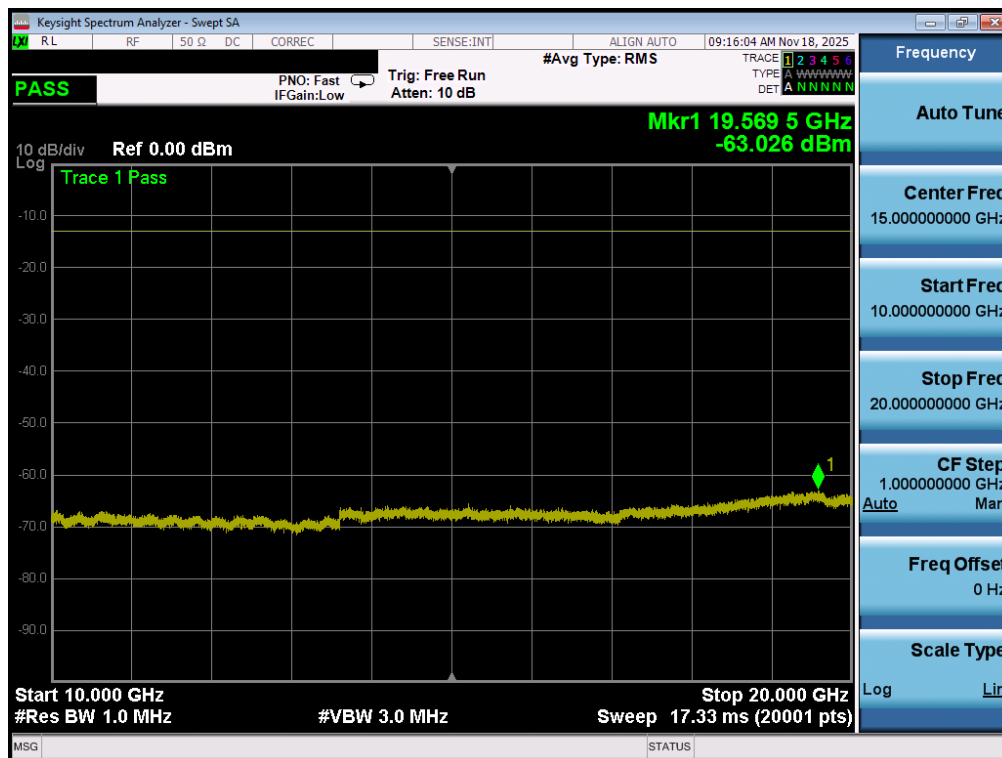


Plot 7-123. Conducted Spurious Plot (LTE Band 66/4 - 20MHz QPSK - 1 RB – High Channel)

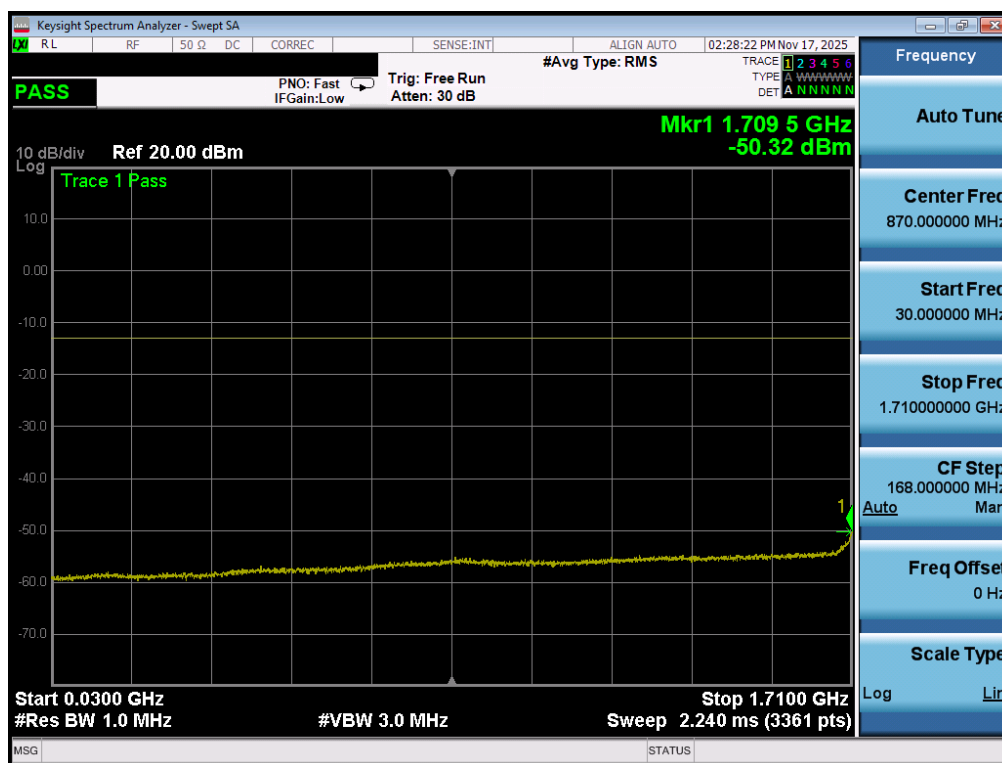

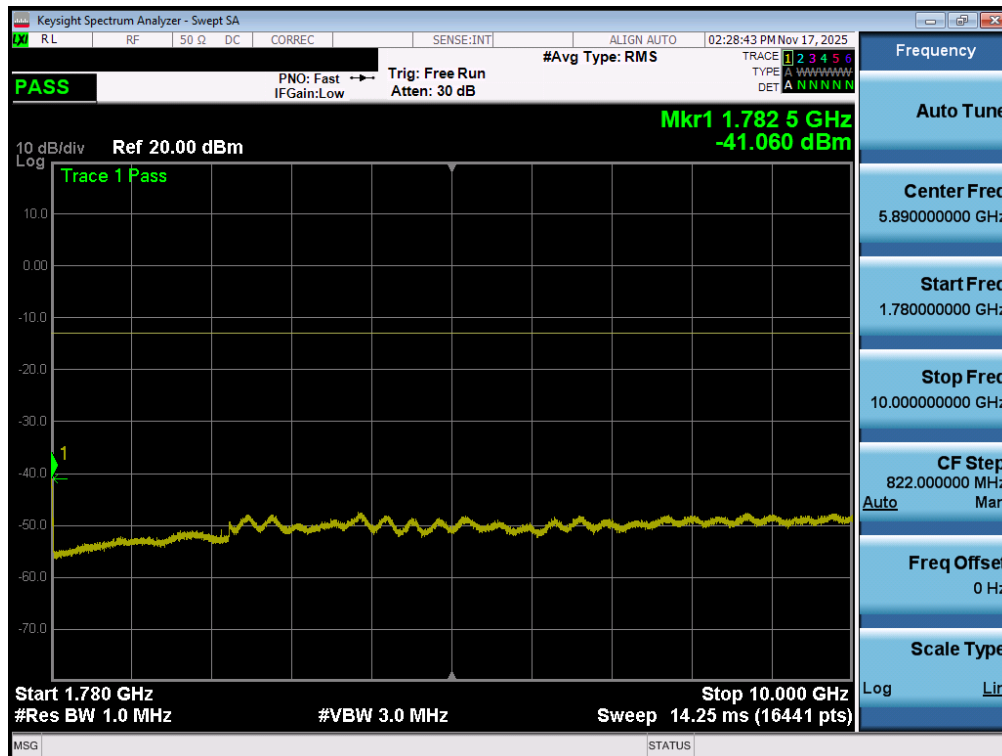
Plot 7-125. Conducted Spurious Plot (LTE Band 66/4 - 20MHz QPSK - 1 RB – High Channel)

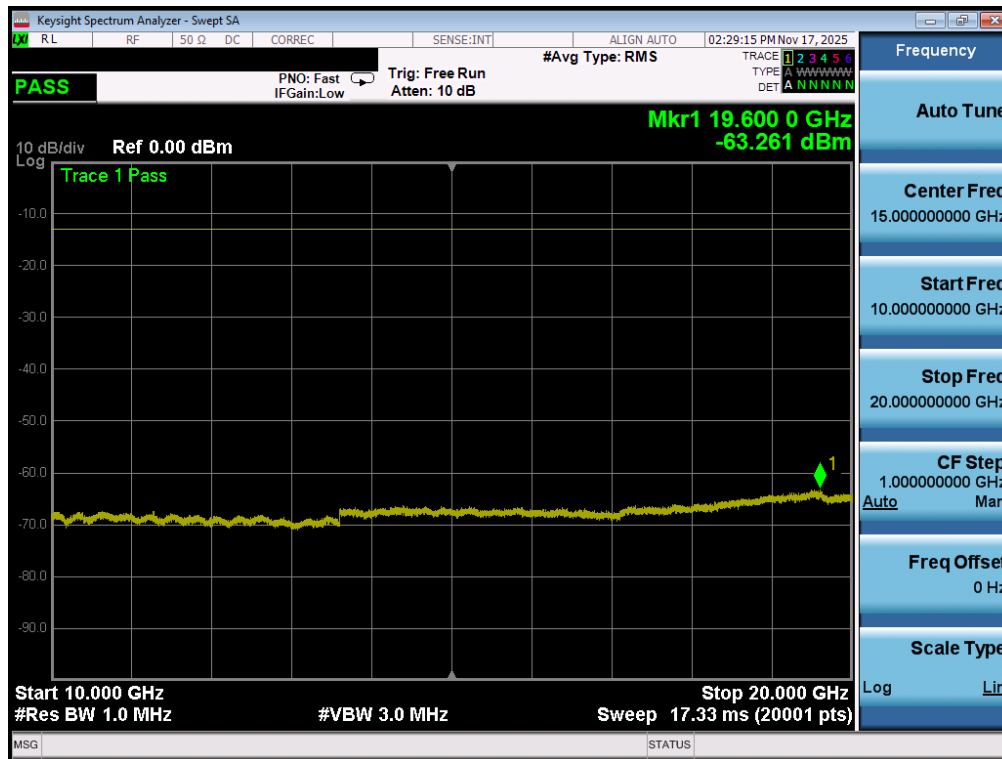


Plot 7-126. Conducted Spurious Plot (NR Band n66 - 40.0MHz - 1 RB - High Channel - ANT1)

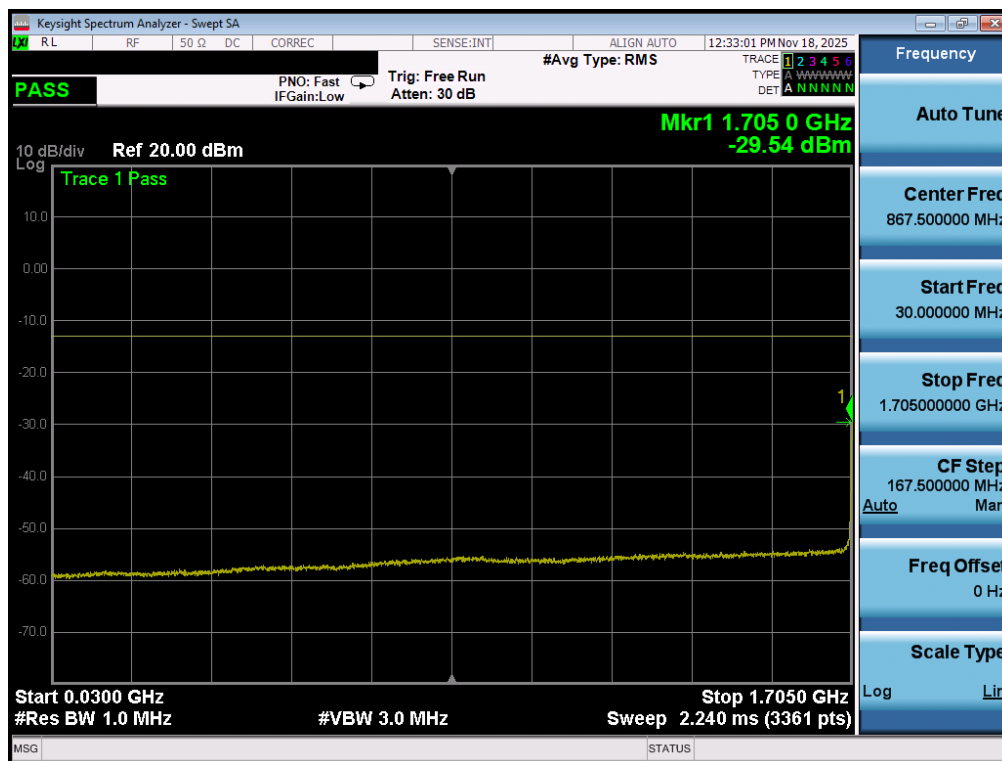

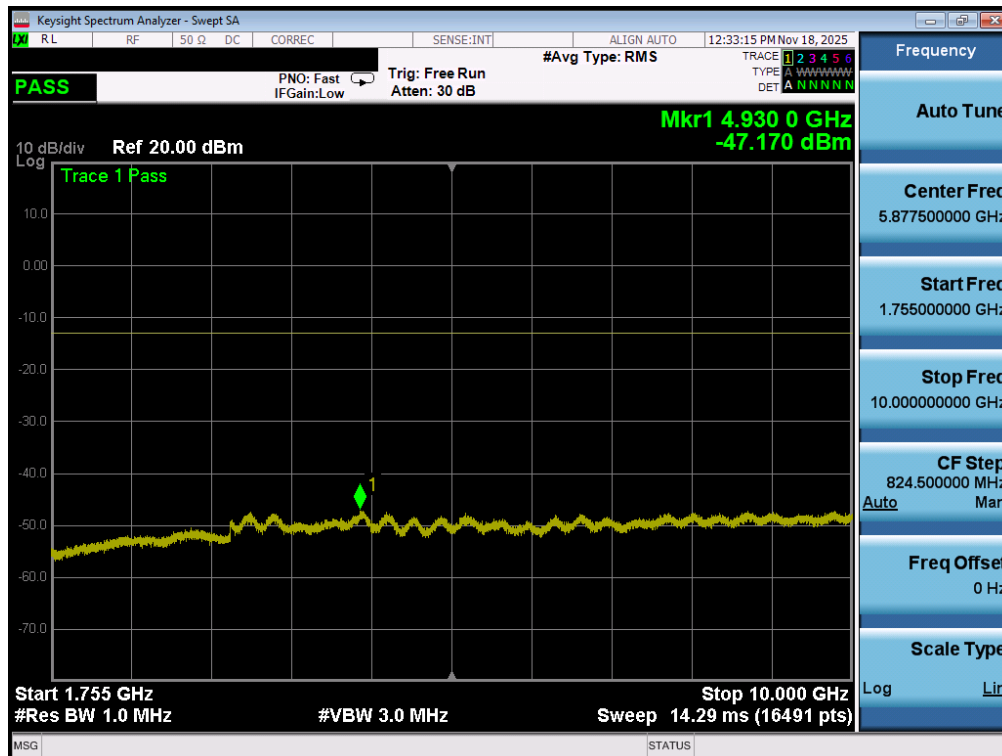

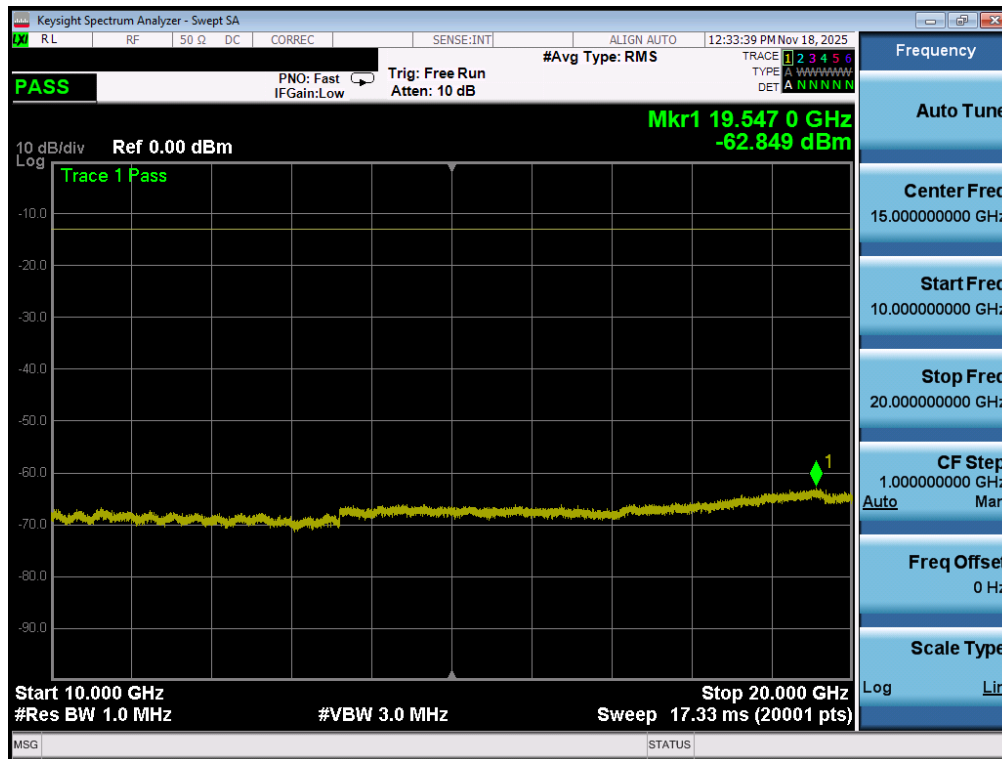


Plot 7-129. Conducted Spurious Plot (WCDMA-AWS - 5MHz QPSK - 1 RB – Low Channel - ANT2)



Plot 7-130. Conducted Spurious Plot (WCDMA-AWS - 5MHz QPSK - 1 RB - Low Channel - ANT2)

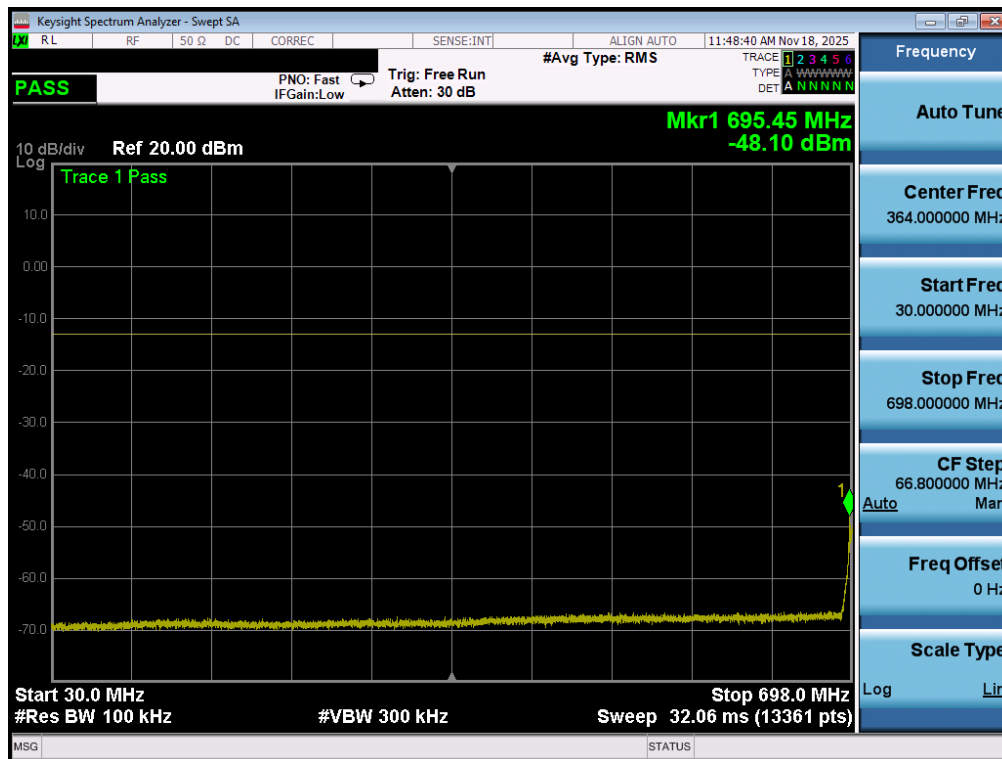

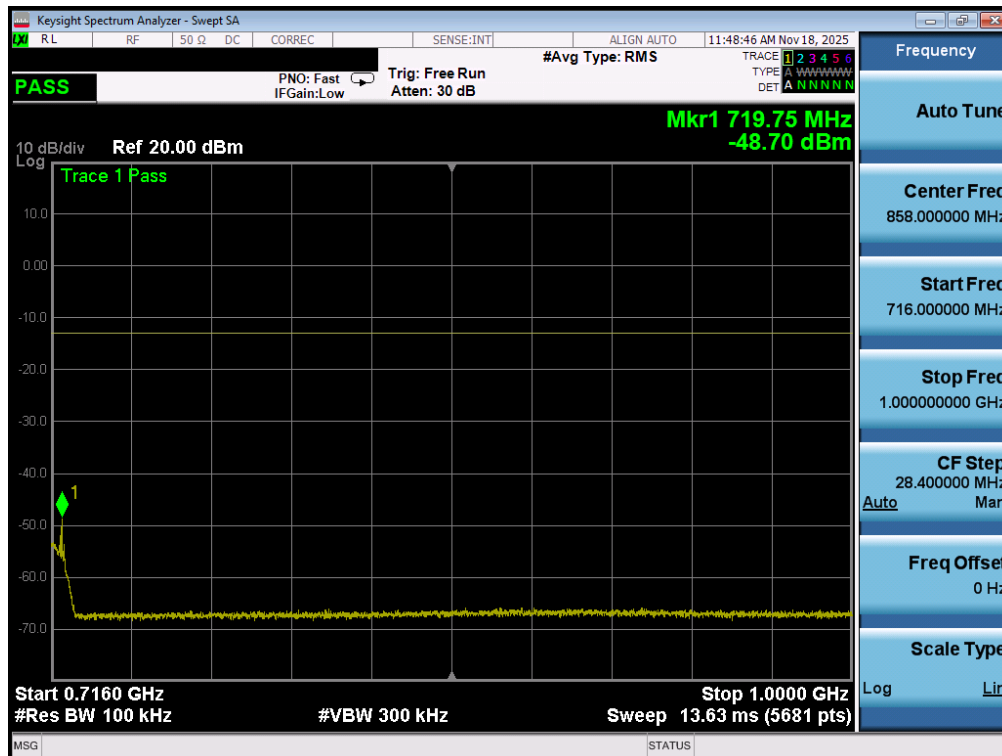
Plot 7-131. Conducted Spurious Plot (WCDMA-AWS - 5MHz QPSK - 1 RB - Low Channel - ANT2)

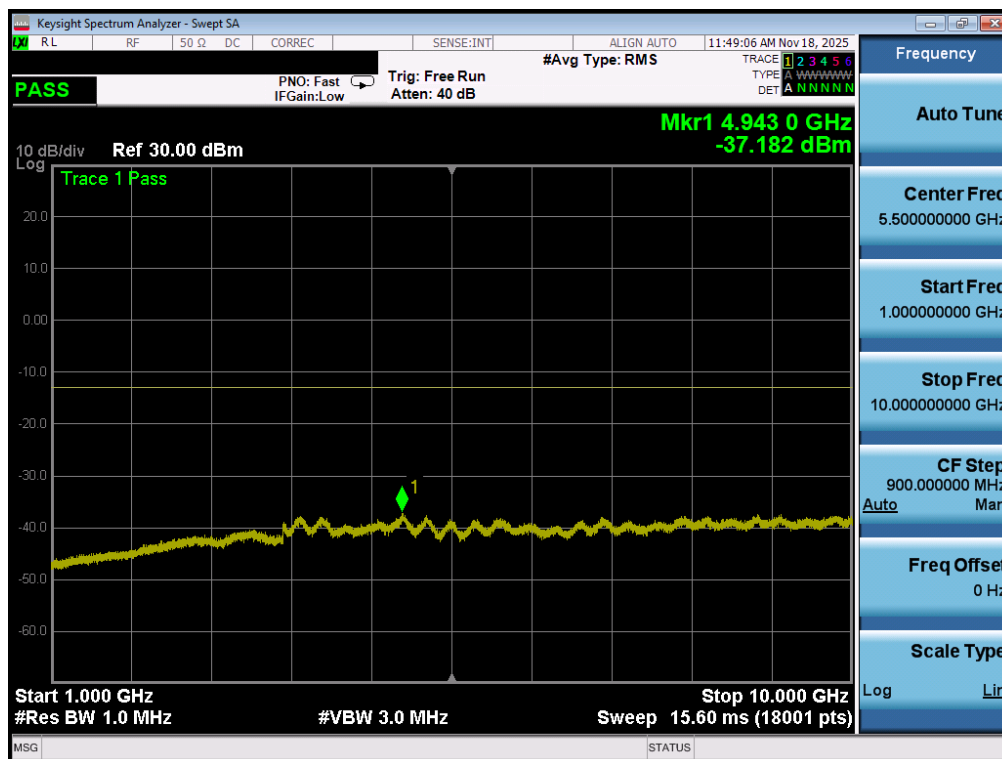


Plot 7-132. Conducted Spurious Plot (LTE Band 12/17 - 10MHz QPSK - 1 RB - Mid Channel - ANT2)

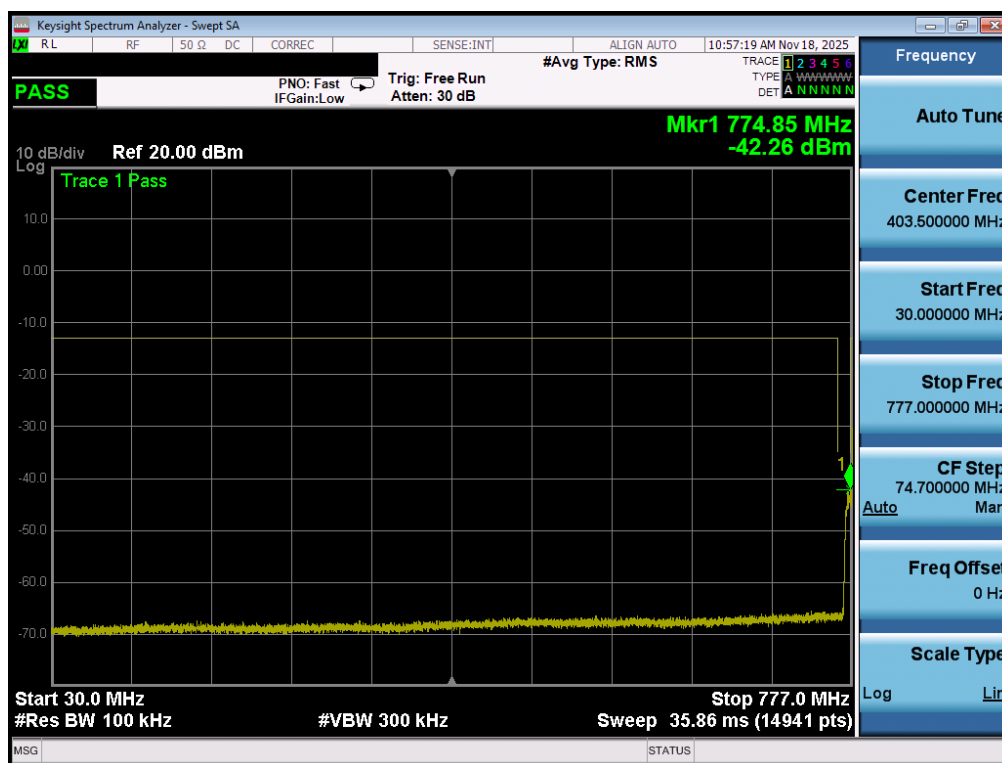

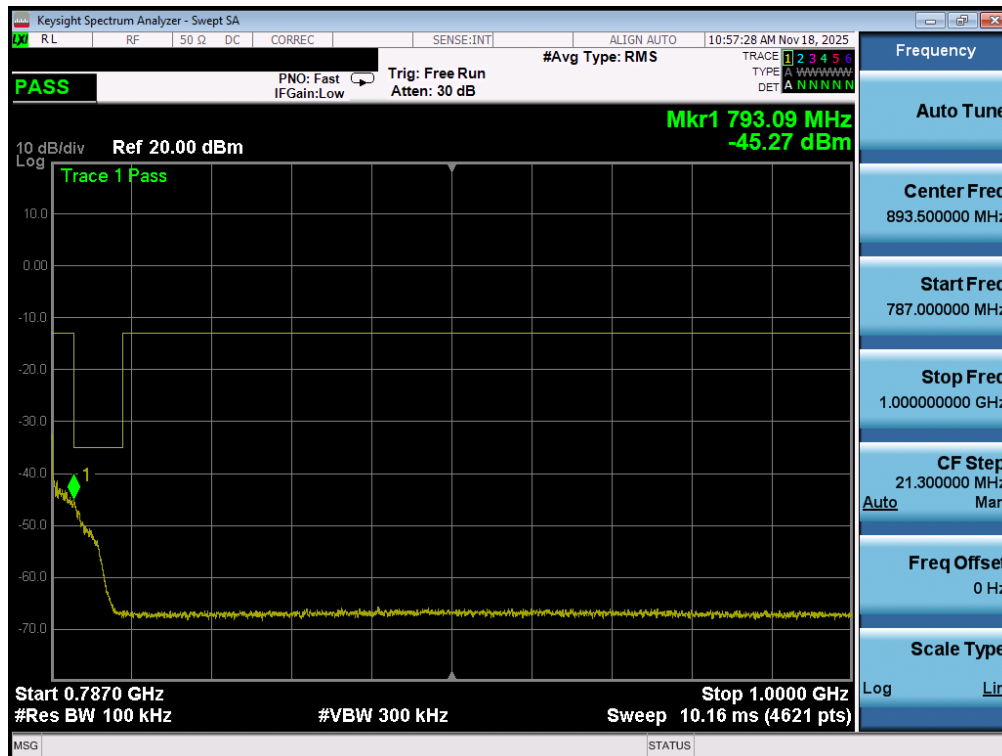
Plot 7-134. Conducted Spurious Plot (LTE Band 12/17 - 10MHz QPSK - 1 RB - Mid Channel - ANT2)

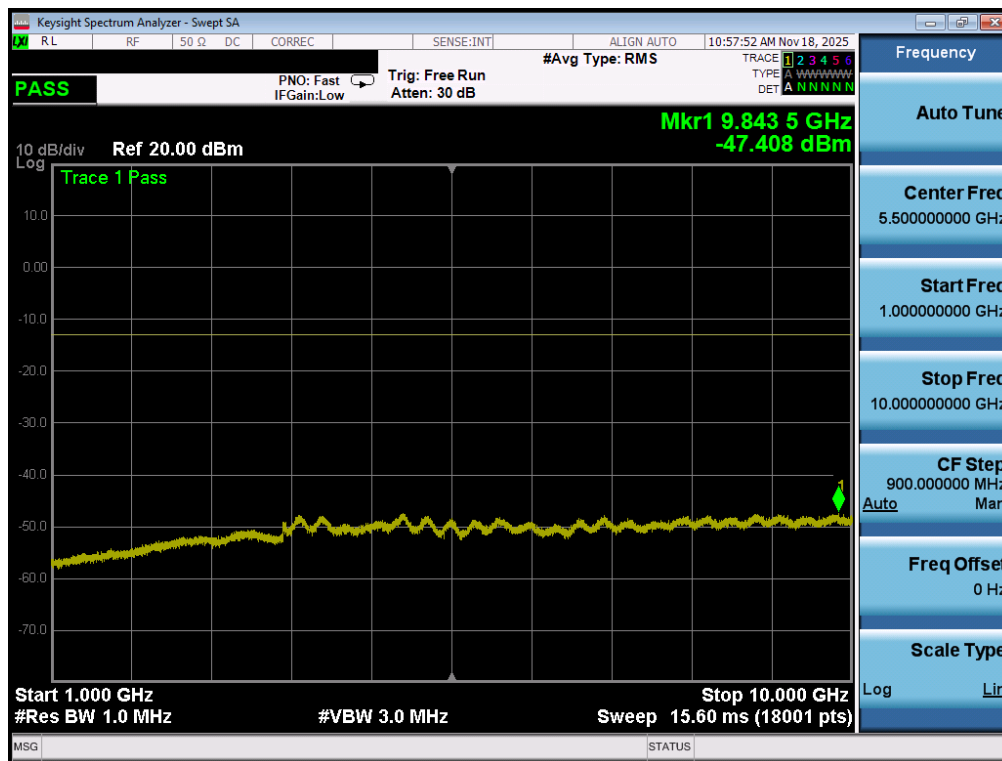


Plot 7-135. Conducted Spurious Plot (LTE Band 13 - 10MHz QPSK - 1 RB)

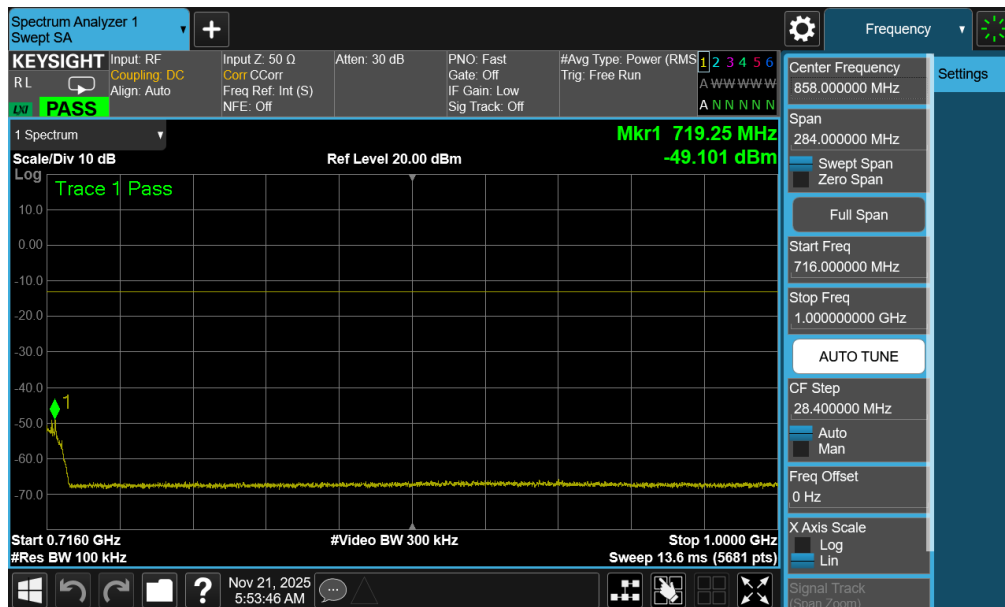
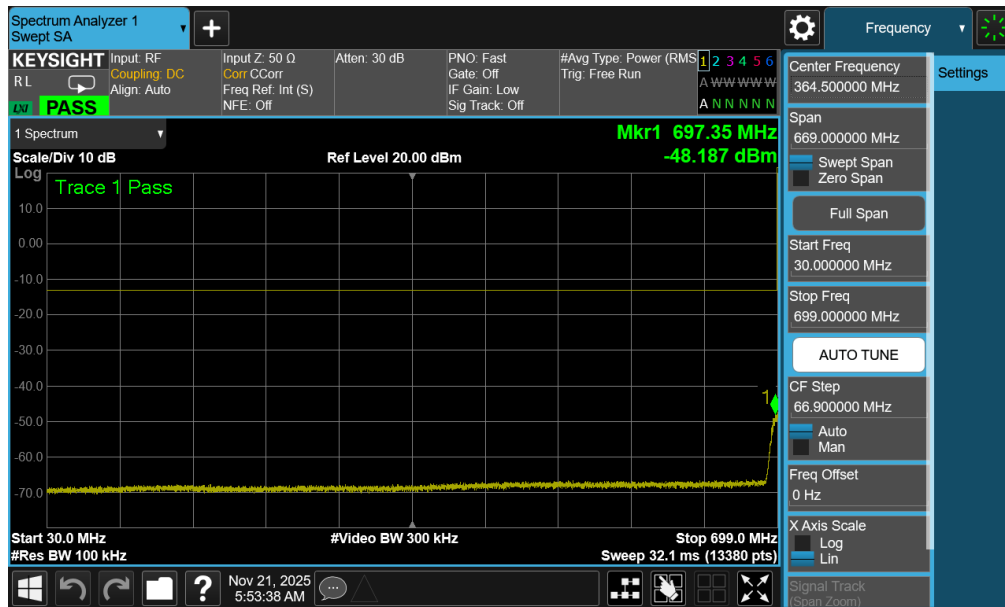

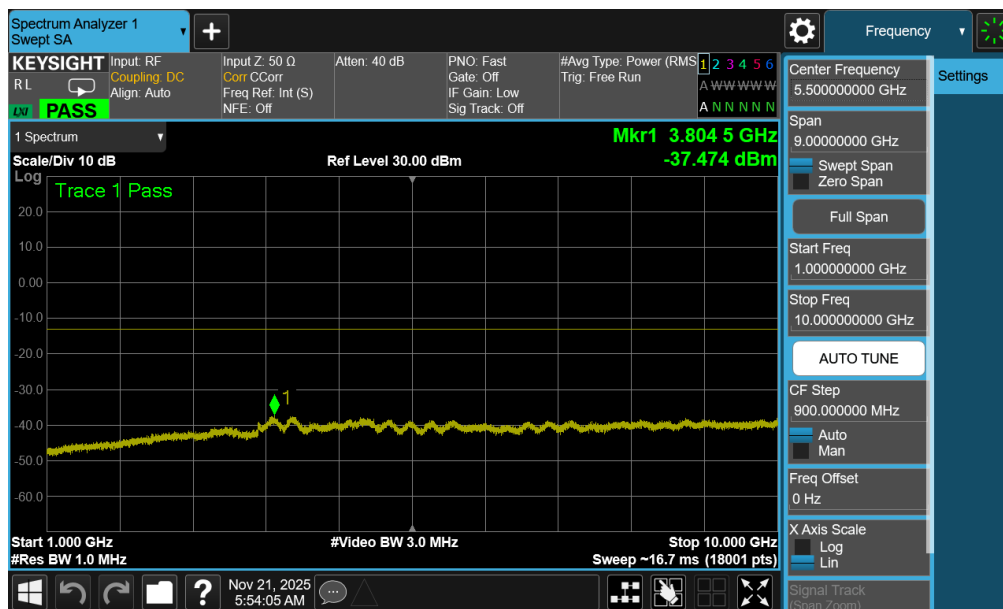
Plot 7-137. Conducted Spurious Plot (LTE Band 13 - 10MHz QPSK - 1 RB)

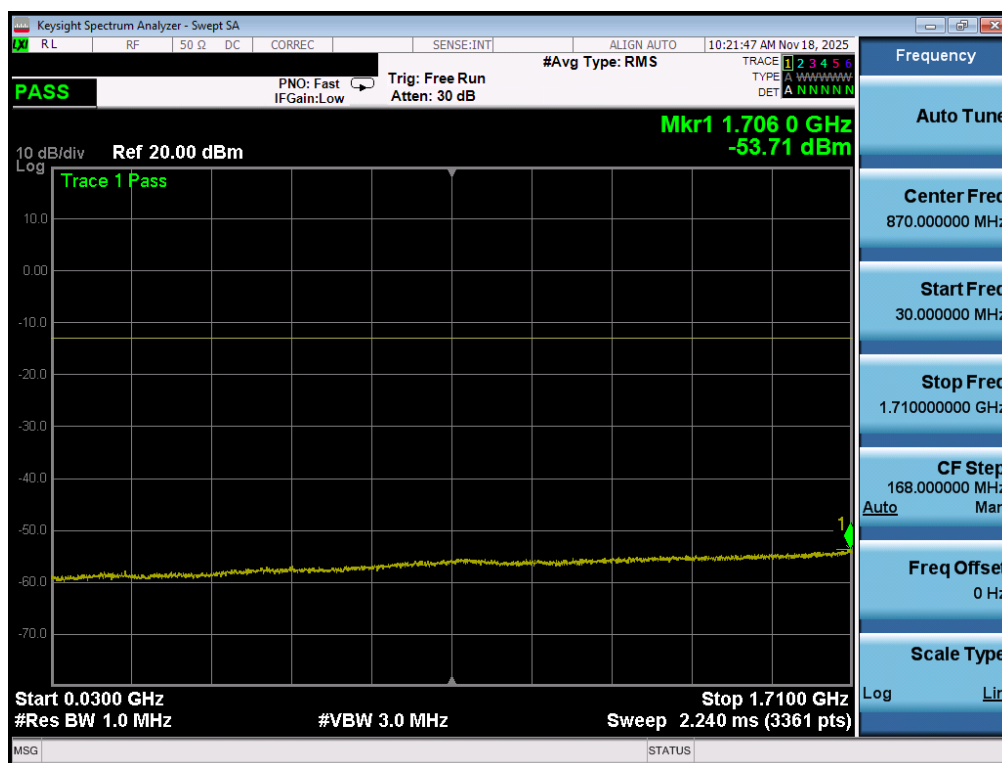

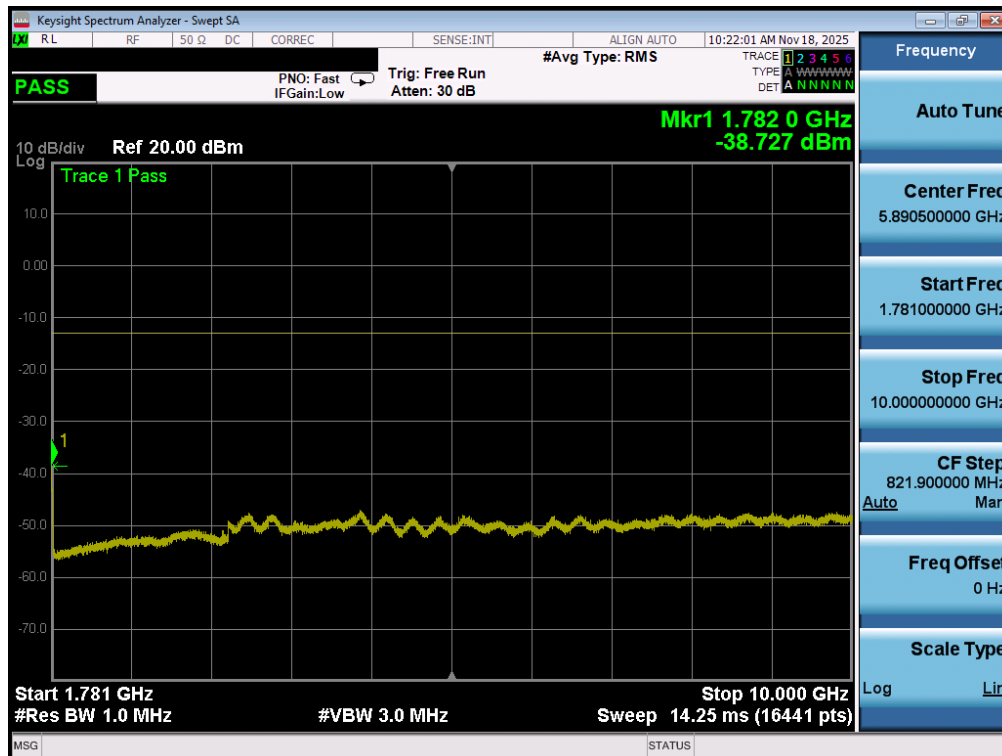
Plot 7-140. Conducted Spurious Plot (NR Band n12 - 15.0MHz - 1 RB – Low Channel - ANT2)

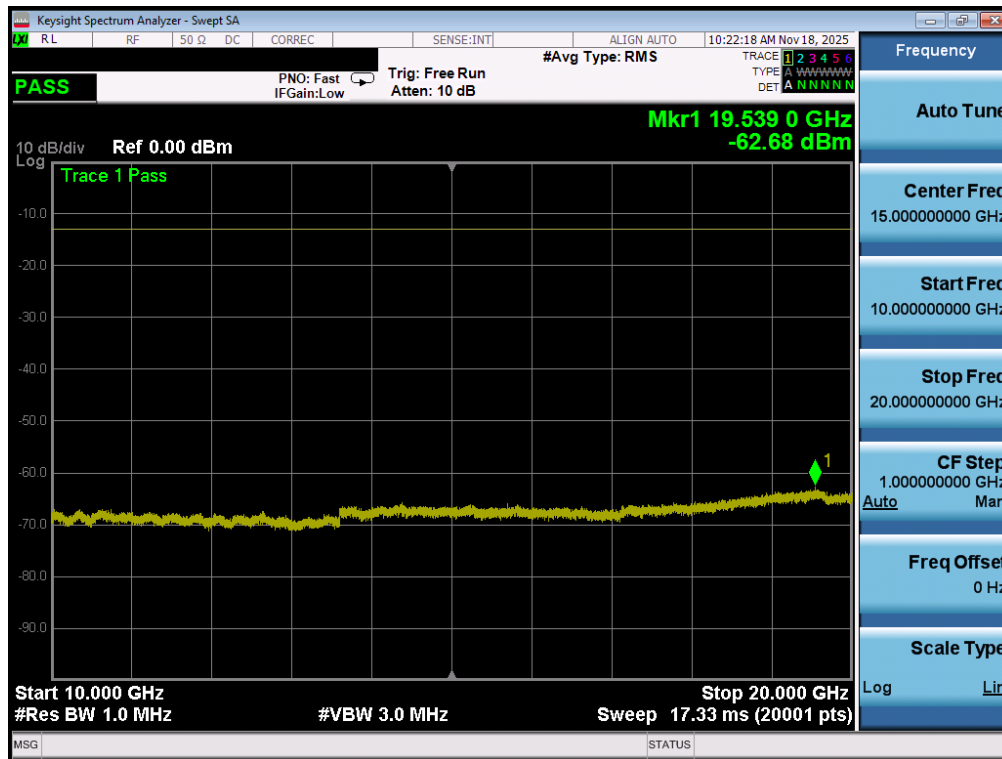


Plot 7-141. Conducted Spurious Plot (LTE Band 66/4 - 20MHz QPSK - 1 RB – High Channel)

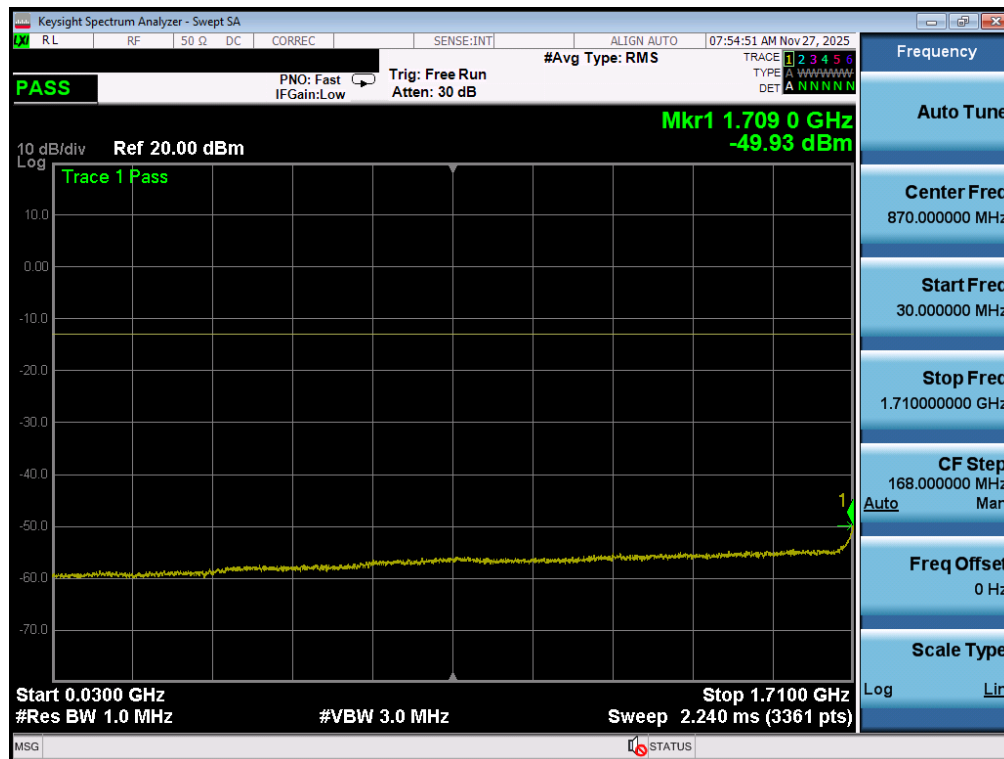

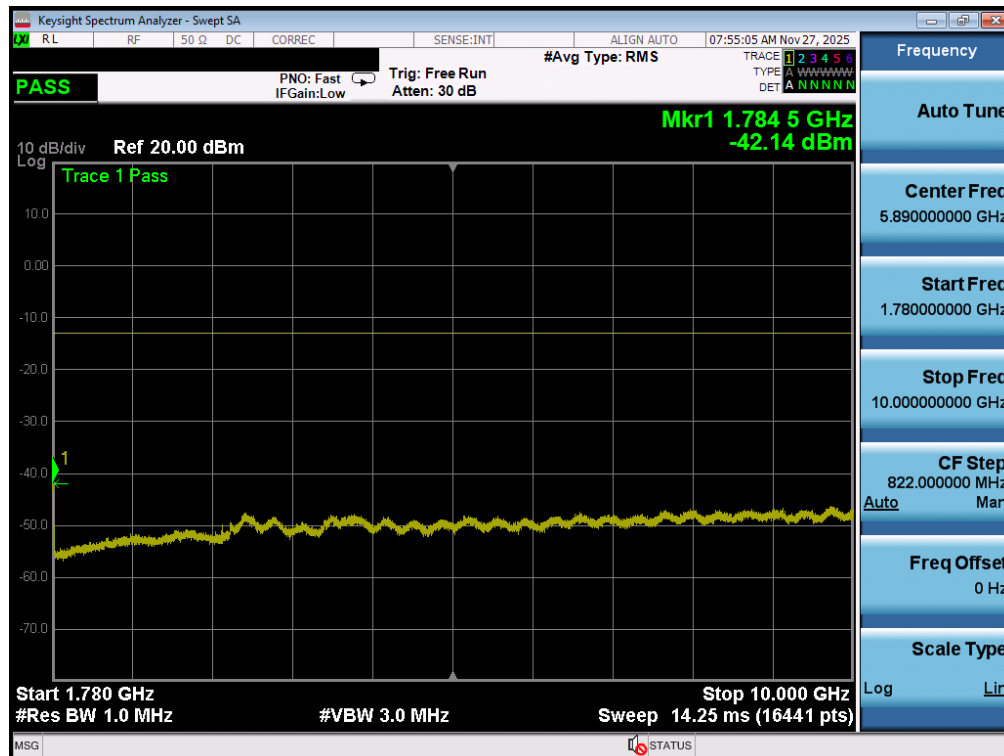
Plot 7-143. Conducted Spurious Plot (LTE Band 66/4 - 20MHz QPSK - 1 RB – High Channel)

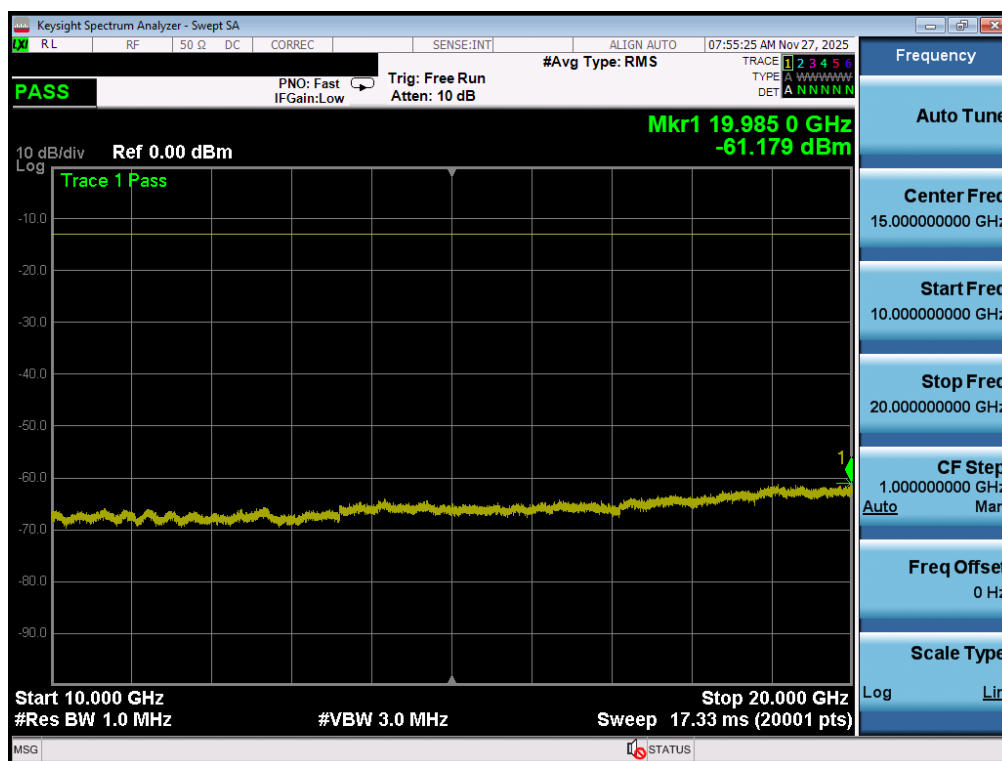


Plot 7-144. Conducted Spurious Plot (NR Band n66 - 40.0MHz - 1 RB - High Channel - ANT2)

7.5 Band Edge Emissions at Antenna Terminal

Test Overview

All out of band emissions are measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies. All data rates were investigated to determine the worst-case configuration. All modes of operation were investigated and the worst-case configuration results are reported in this section.

The minimum permissible attenuation level of any spurious emission is $43 + 10 \log_{10}(P_{\text{Watts}})$, where P is the transmitter power in Watts.

Test Procedure Used

ANSI C63.26-2015 – Section 5.7.3

Test Settings

1. Start and stop frequency were set such that the band edge would be placed in the center of the plot
2. Span was set large enough so as to capture all out of band emissions near the band edge
3. RBW $\geq 1\%$ of the emission bandwidth
4. VBW $\geq 3 \times$ RBW
5. Detector = RMS
6. Number of sweep points $\geq 2 \times$ Span/RBW
7. Trace mode = trace average for continuous emissions, max hold for pulse emissions
8. Sweep time = auto couple
9. The trace was allowed to stabilize

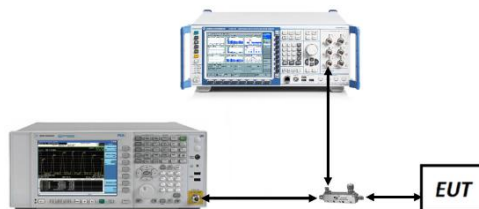


Figure 7-4. Test Instrument & Measurement Setup

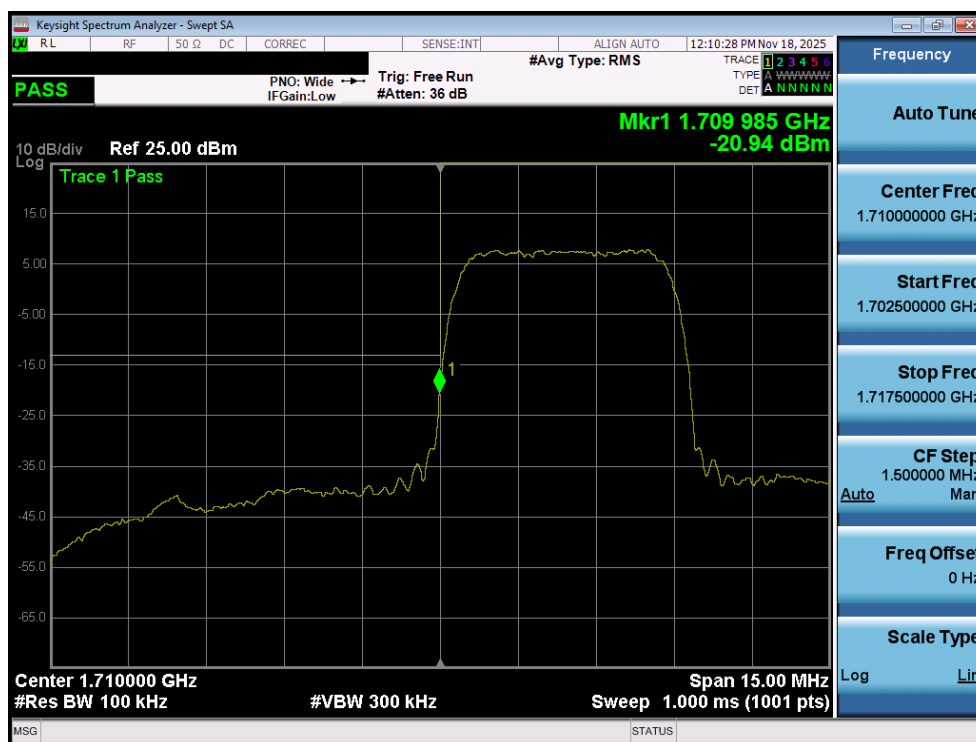

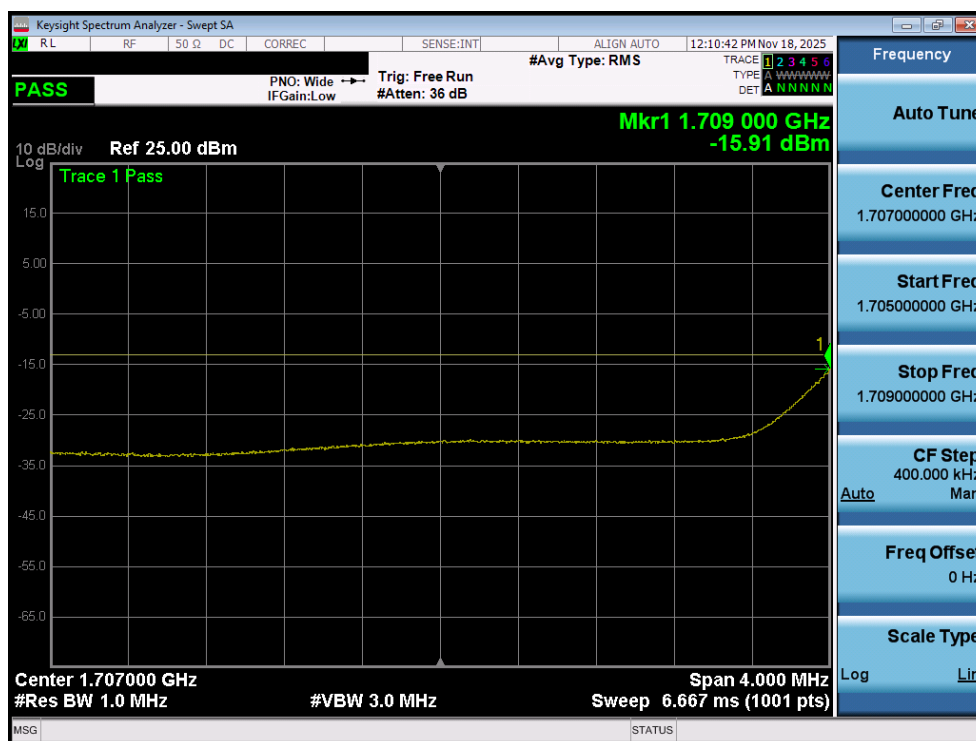

Plot 7-147. Lower Band Edge Plot (WCDMA AWS – Ch. 1312 – ANT1)

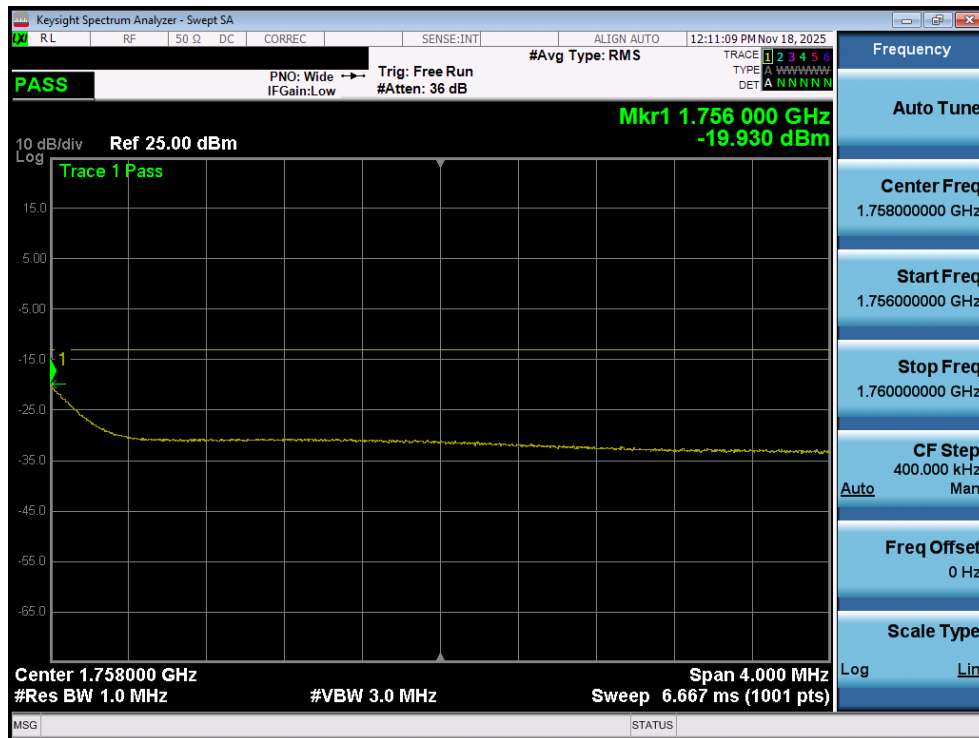


Plot 7-148. Lower Extended Band Edge Plot (WCDMA AWS – Ch. 1312 – ANT1)

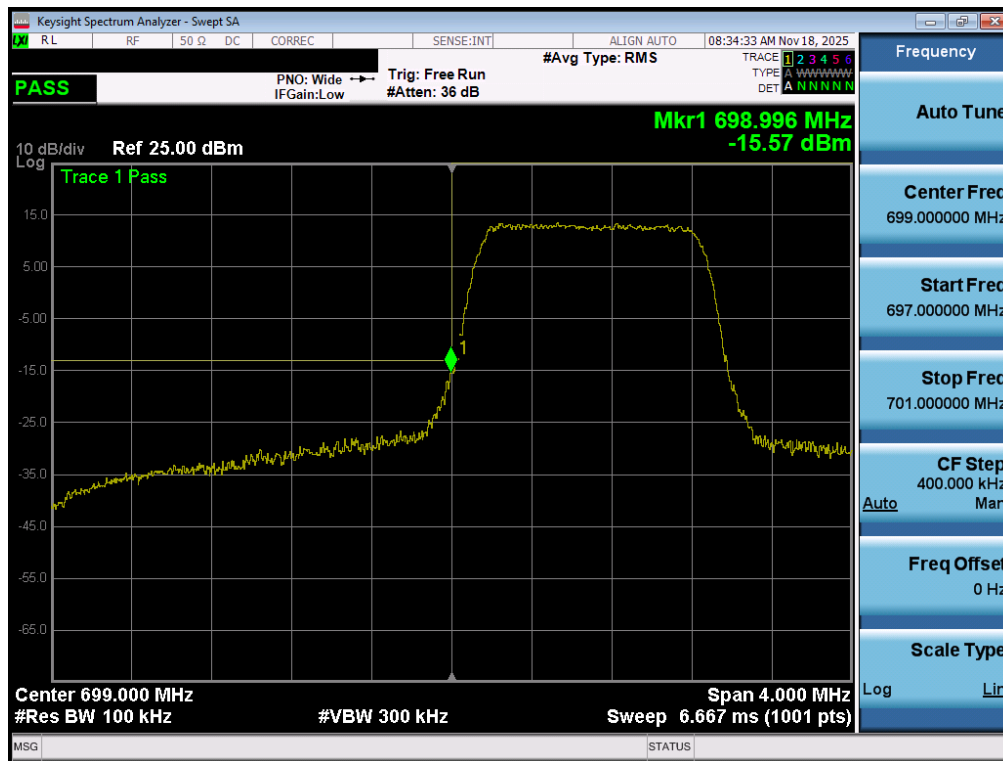
Plot 7-149. Upper Band Edge Plot (WCDMA AWS – Ch. 1513 – ANT1)



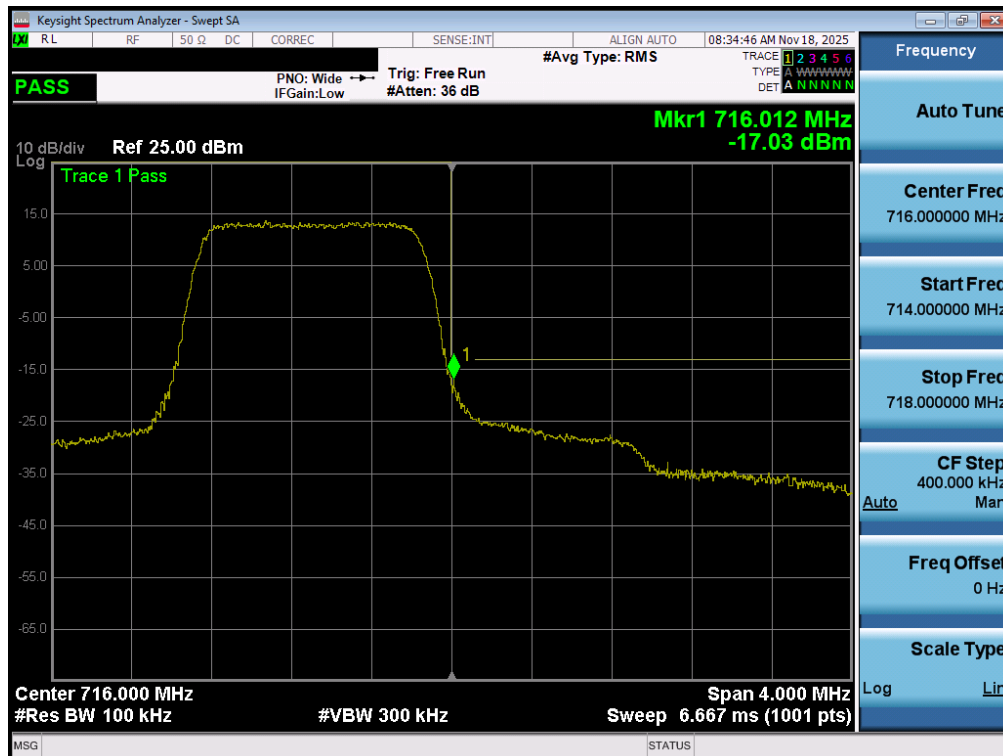
Plot 7-150. Upper Extended Band Edge Plot (WCDMA AWS – Ch. 1513– ANT1)

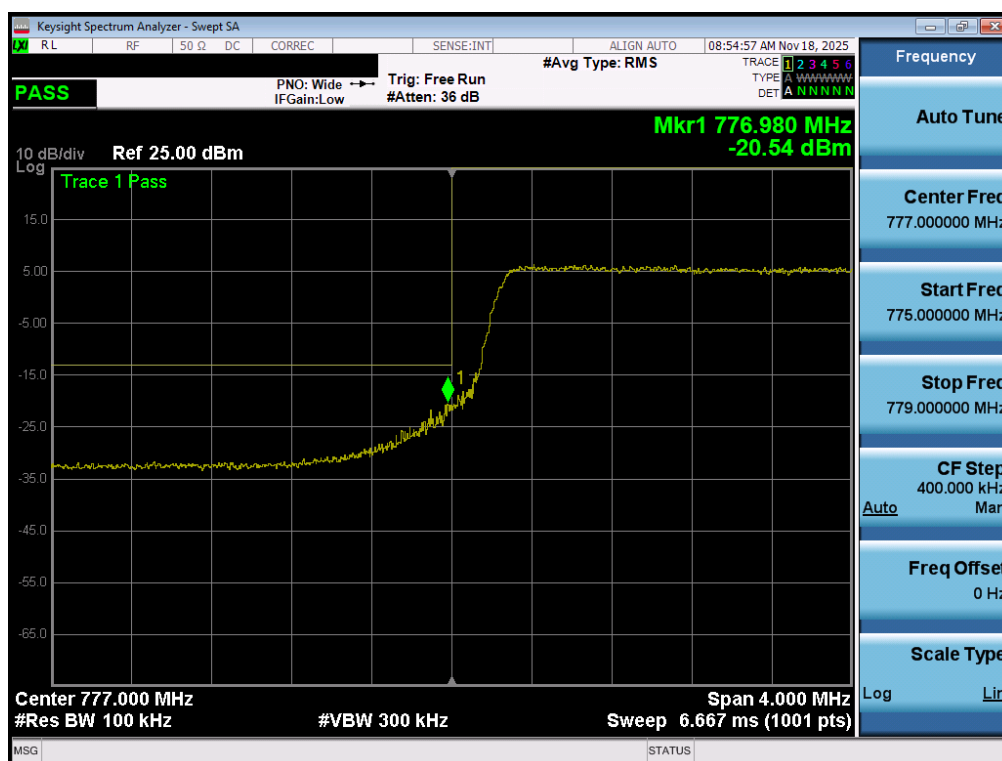
Plot 7-151. Lower Band Edge Plot (LTE Band 12 – 1.4MHz QPSK – Full RB - ANT1)



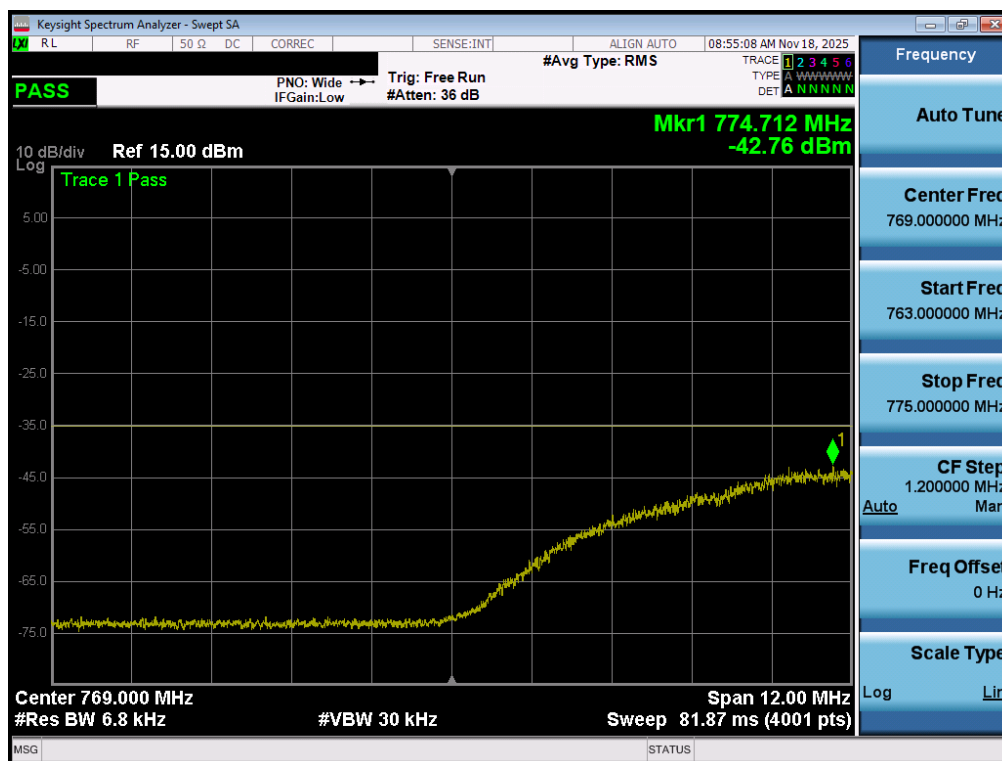
Plot 7-152. Upper Band Edge Plot (LTE Band 12 – 1.4MHz QPSK – Full RB - ANT1)

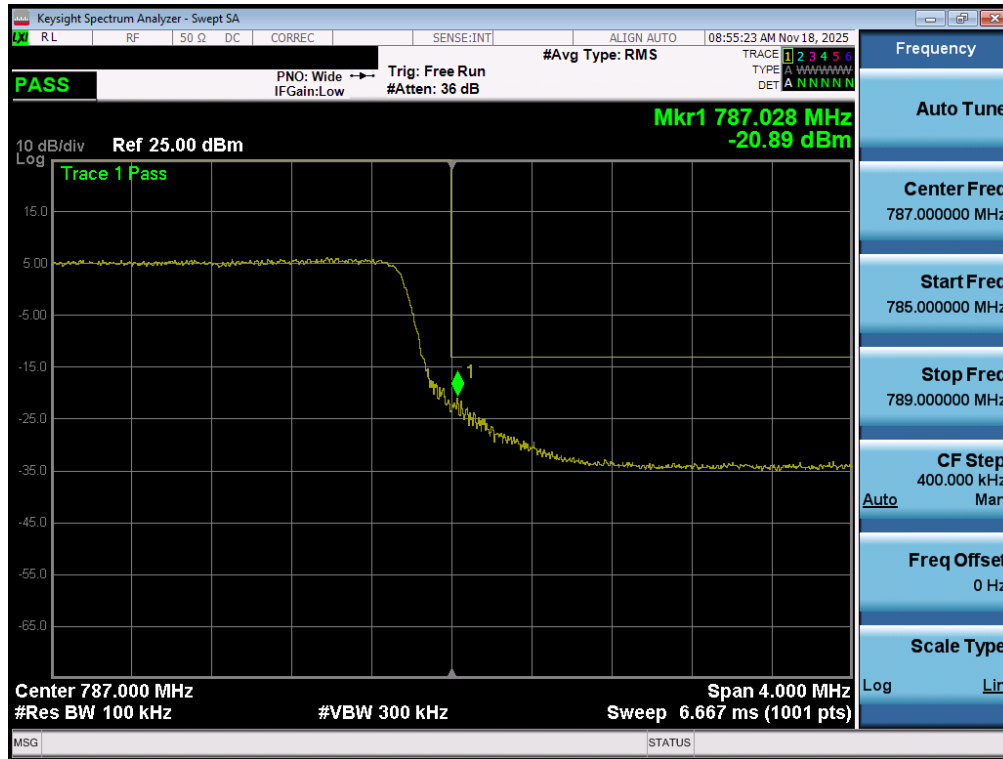


Plot 7-153. Lower Band Edge Plot (LTE Band 13 - 5MHz QPSK – Full RB - ANT1)

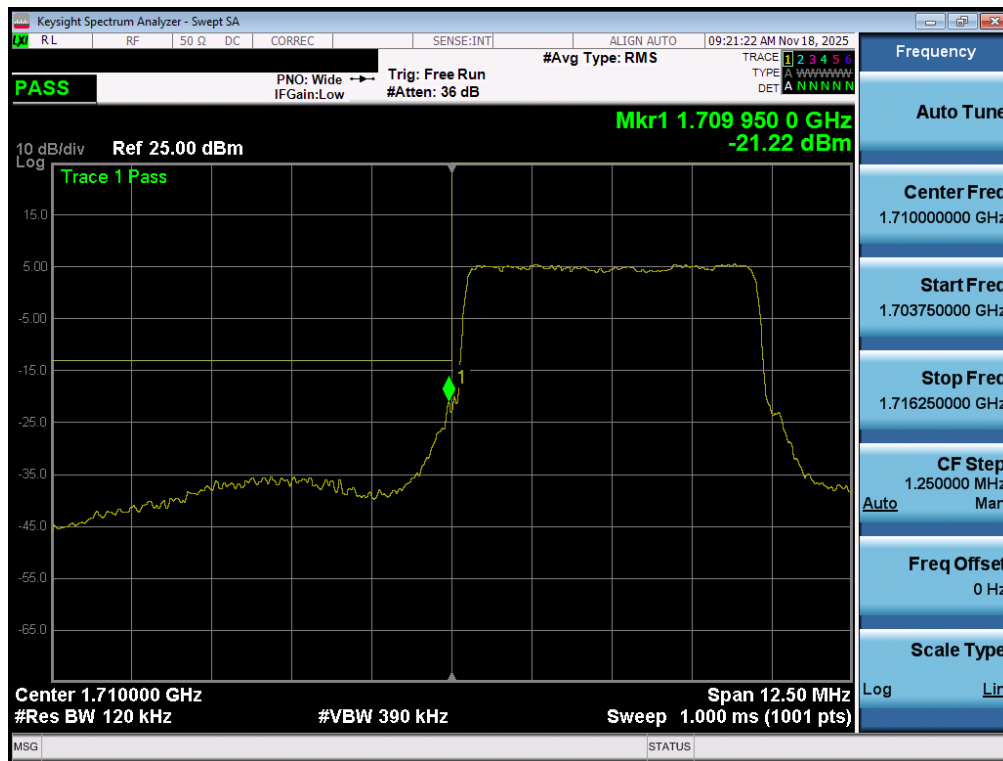
Plot 7-155. Upper Band Edge Plot (LTE Band 13 - 5MHz QPSK - Full RB - ANT1)



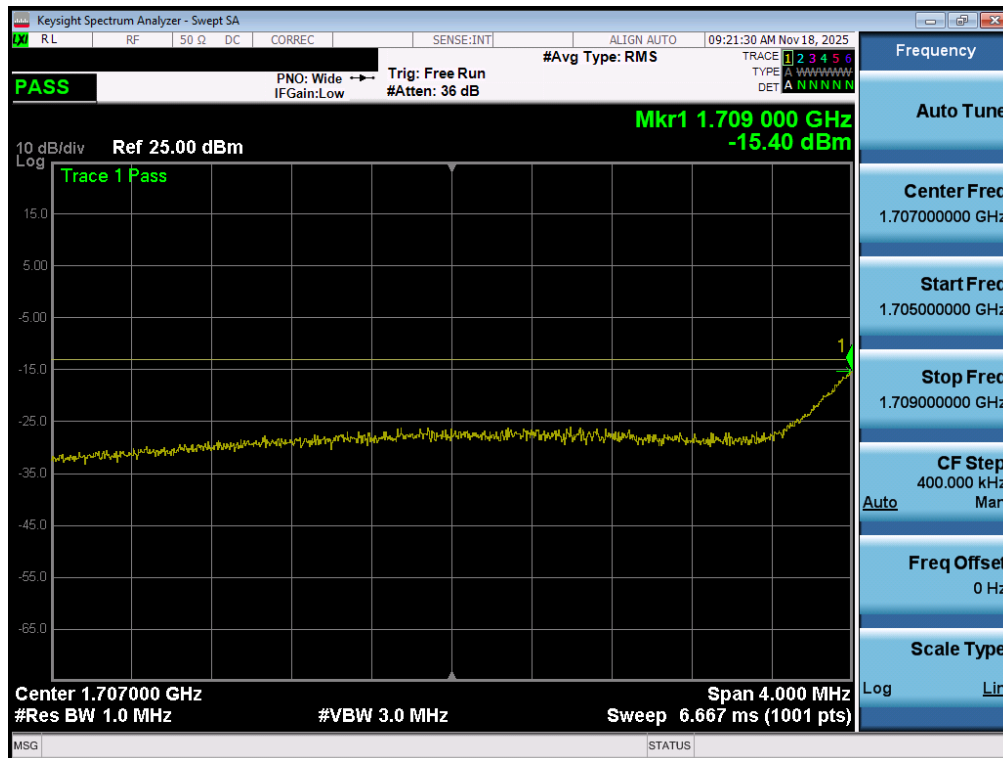
Plot 7-156. Upper Emission Mask Plot (LTE Band 13 - 5MHz QPSK - Full RB - ANT1)

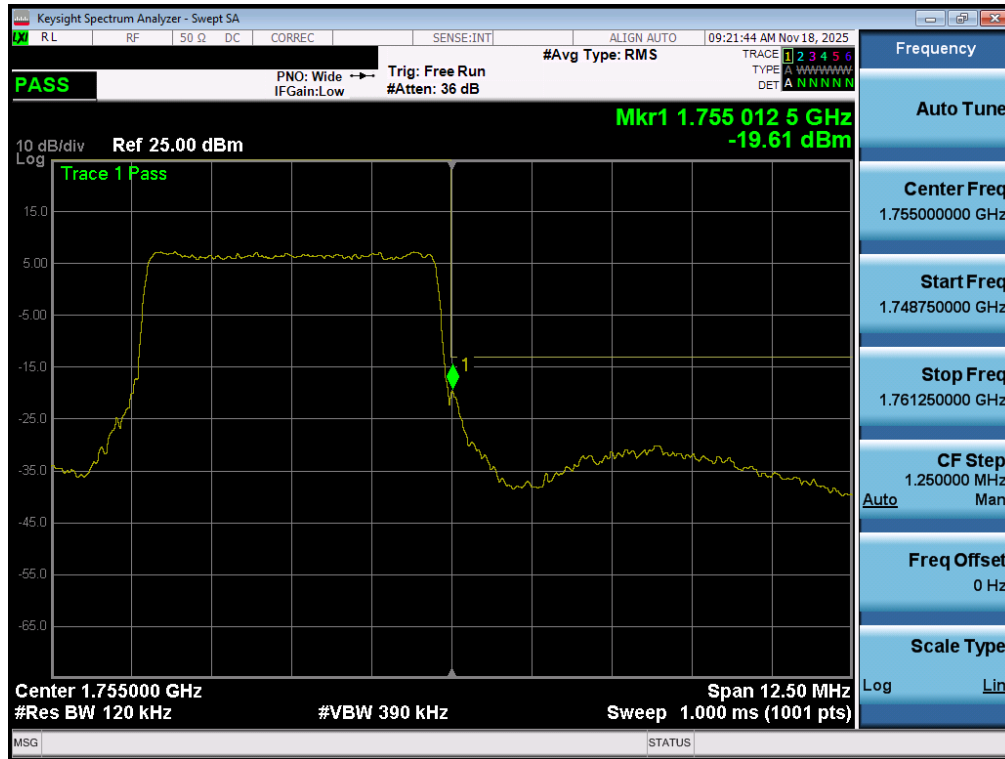


Plot 7-157. Lower Band Edge Plot (LTE Band 66/4 – 5MHz QPSK – Full RB - ANT1)

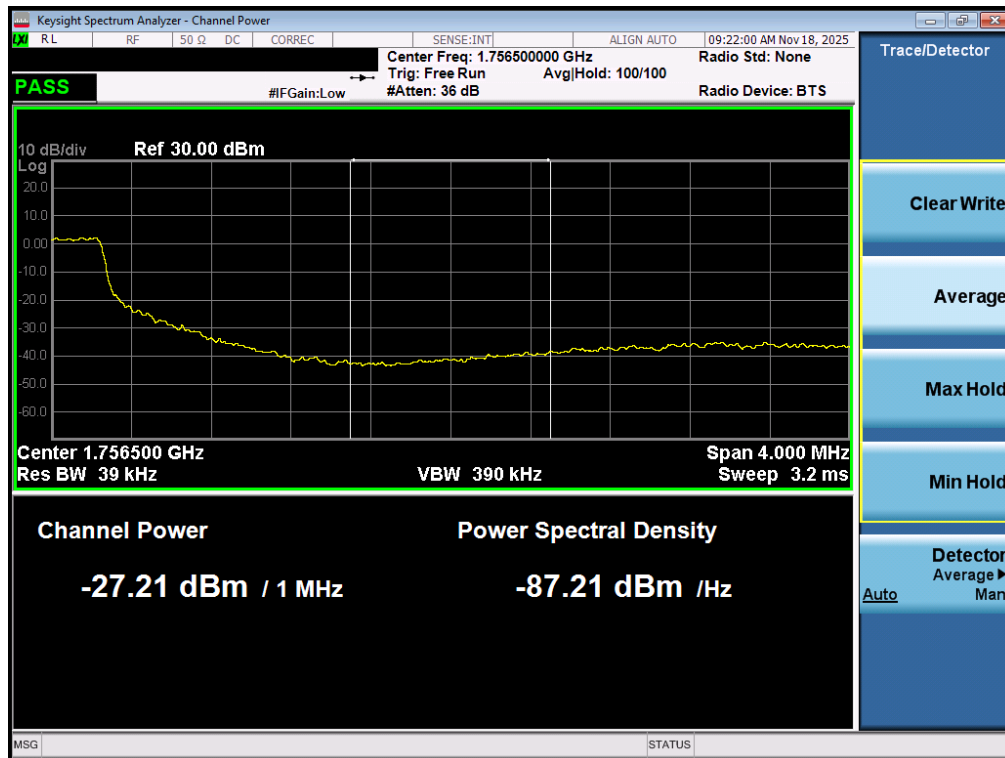


Plot 7-158. Lower Extended Band Edge Plot (LTE Band 66/4 – 5MHz QPSK – Full RB - ANT1)

Plot 7-159. Upper Band Edge Plot (LTE Band 4 – 5MHz QPSK – Full RB - ANT1)

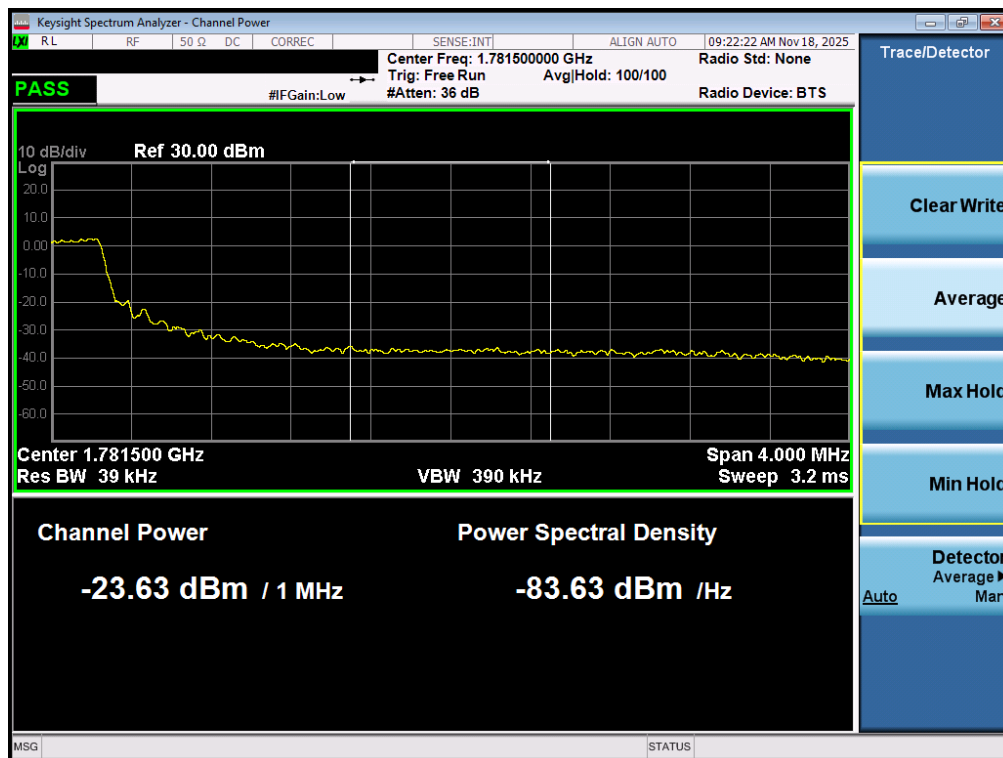


Plot 7-160. Upper Extended Band Edge Plot (LTE Band 4 – 5MHz QPSK – Full RB - ANT1)

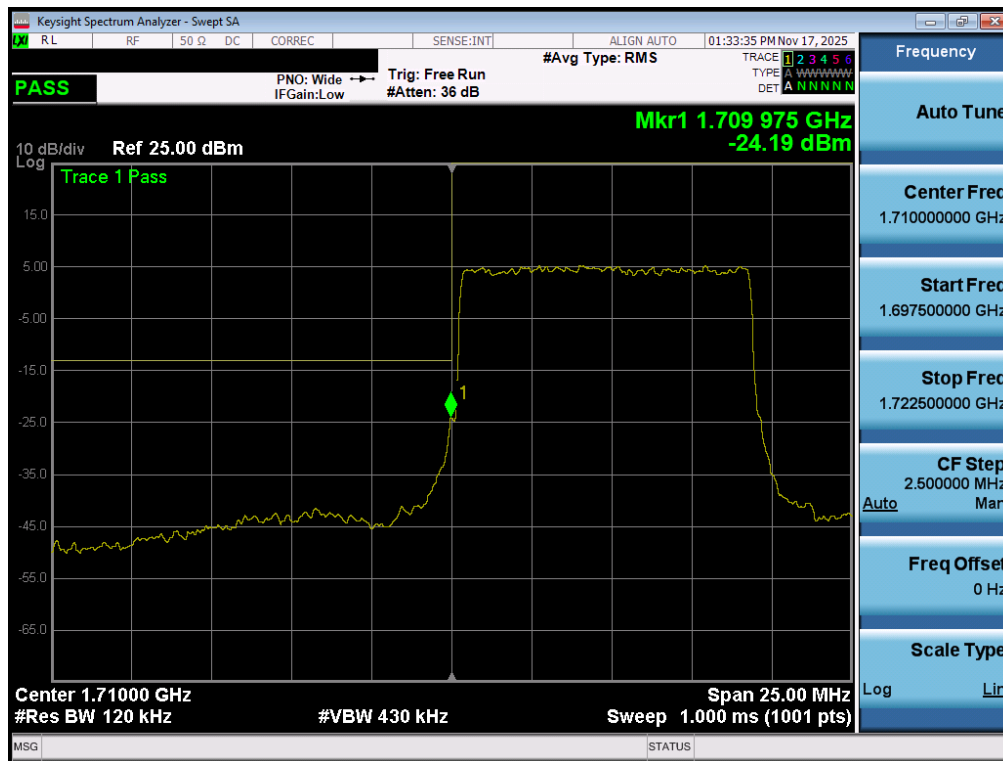
Plot 7-163. Lower Band Edge Plot (NR Band n12 – 5.0MHz - Full RB - ANT1)



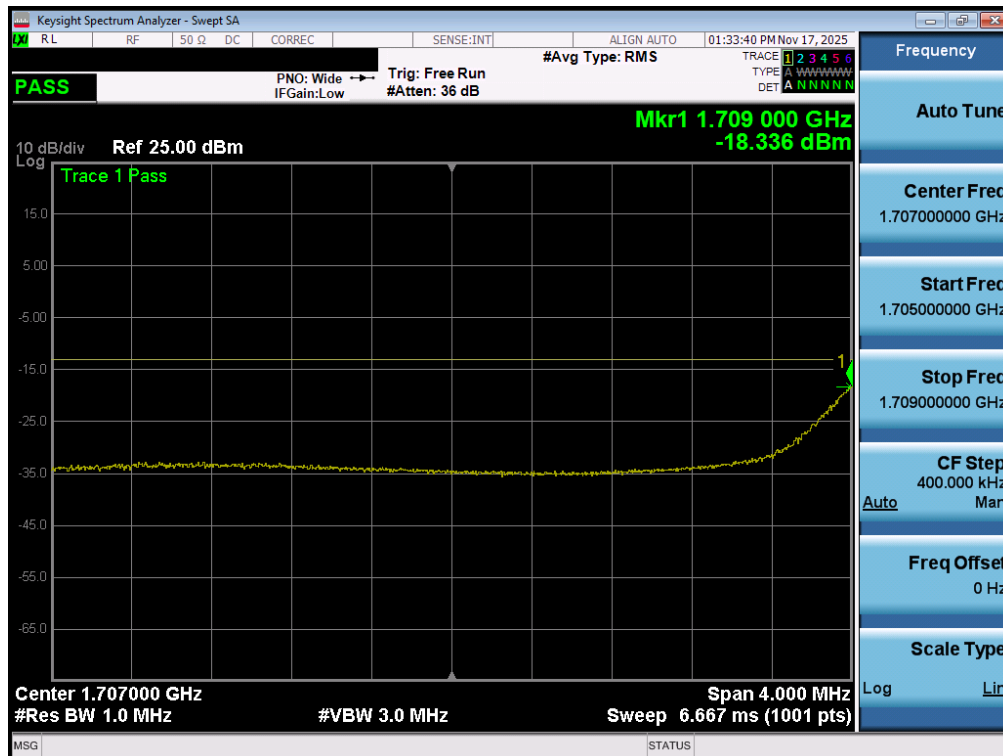
Plot 7-164. Upper Band Edge Plot (NR Band n12 – 5.0MHz - Full RB - ANT1)

Plot 7-165. Lower Band Edge Plot (NR Band n66 – 10.0MHz - Full RB - ANT1)

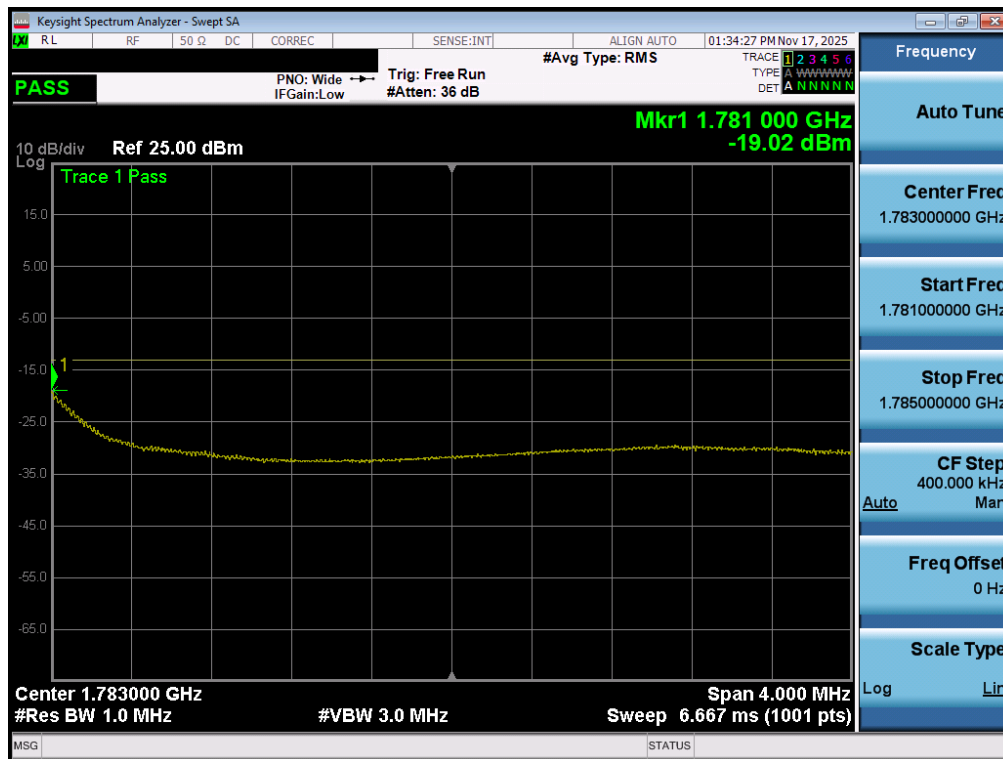


Plot 7-166. Lower Extended Band Edge Plot (NR Band n66 – 10.0MHz - Full RB - ANT1)

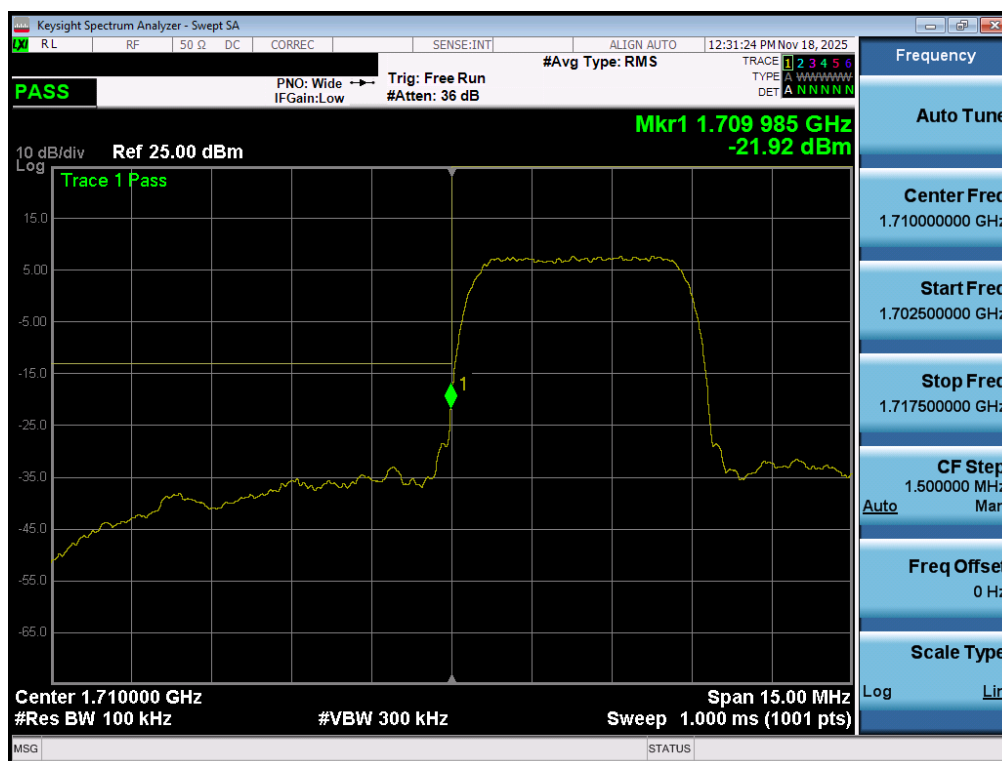

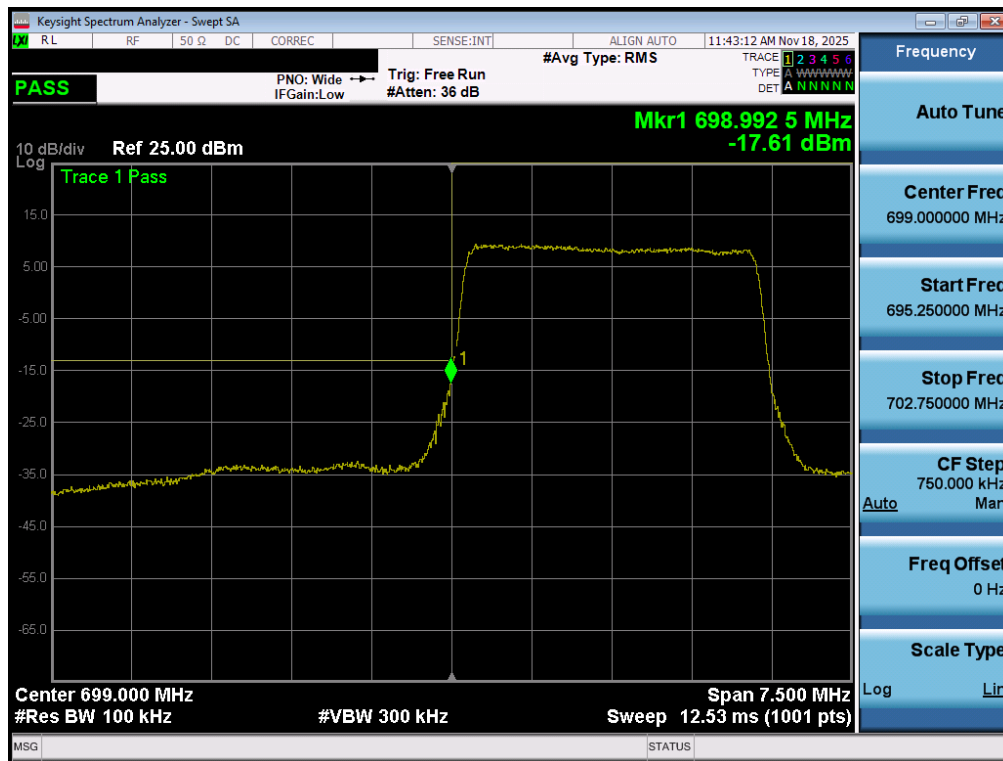
Plot 7-171. Upper Band Edge Plot (WCDMA AWS – Ch. 1513 – ANT2)



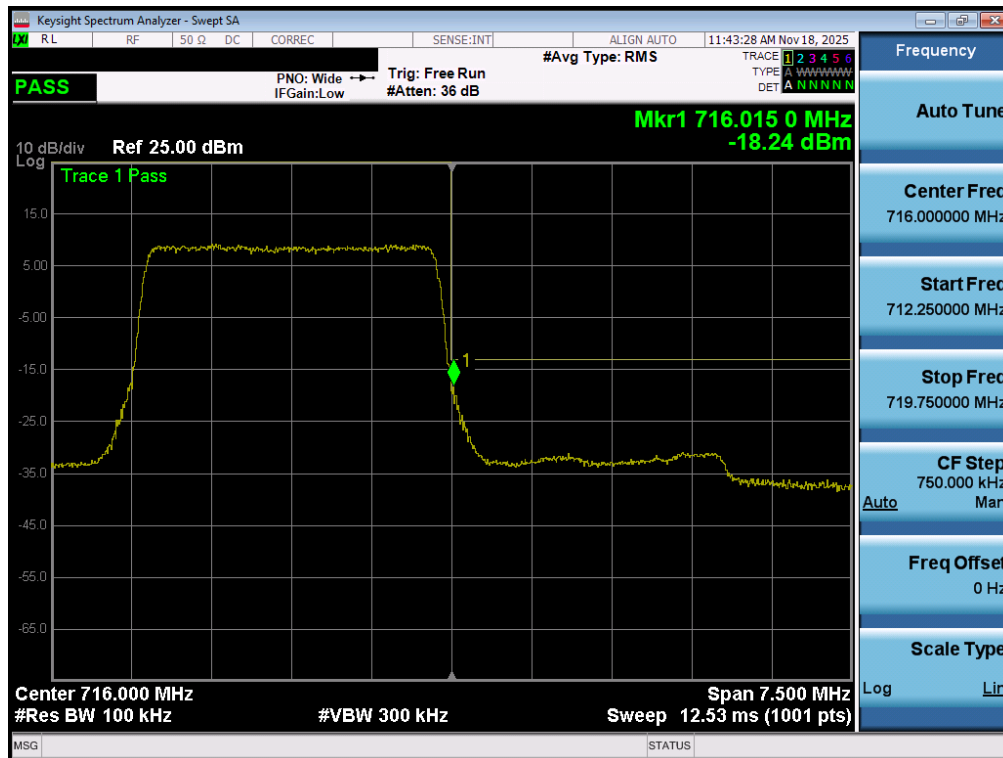
Plot 7-172. Upper Extended Band Edge Plot (WCDMA AWS – Ch. 1513– ANT2)

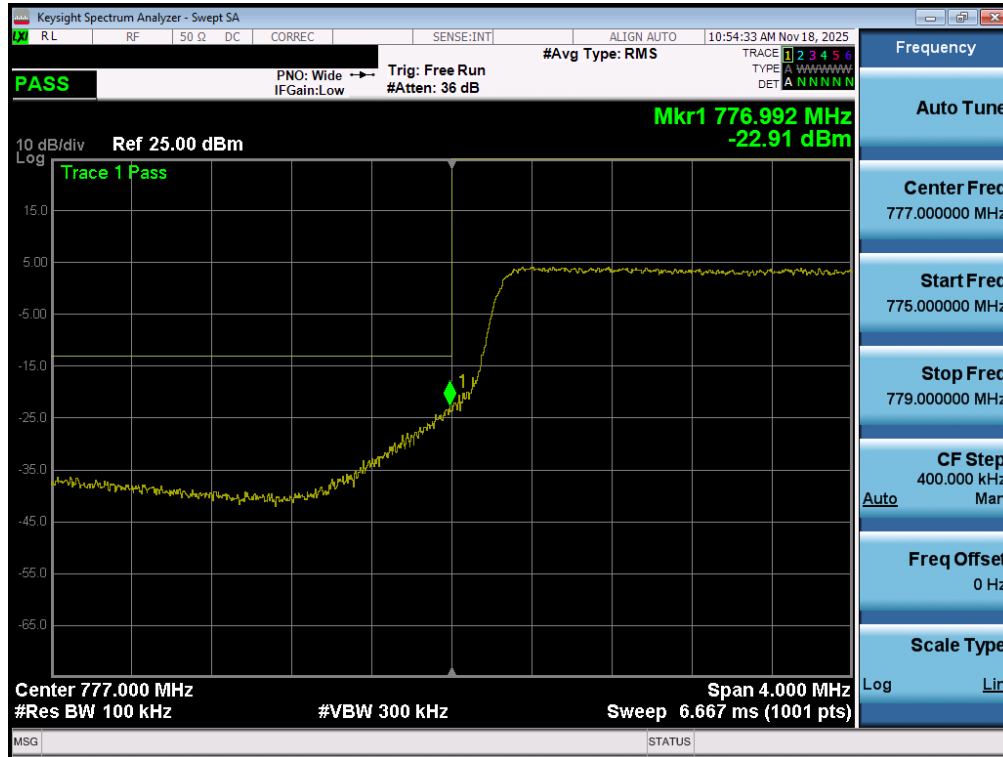
Plot 7-173. Lower Band Edge Plot (LTE Band 12 – 3MHz QPSK – Full RB - ANT2)



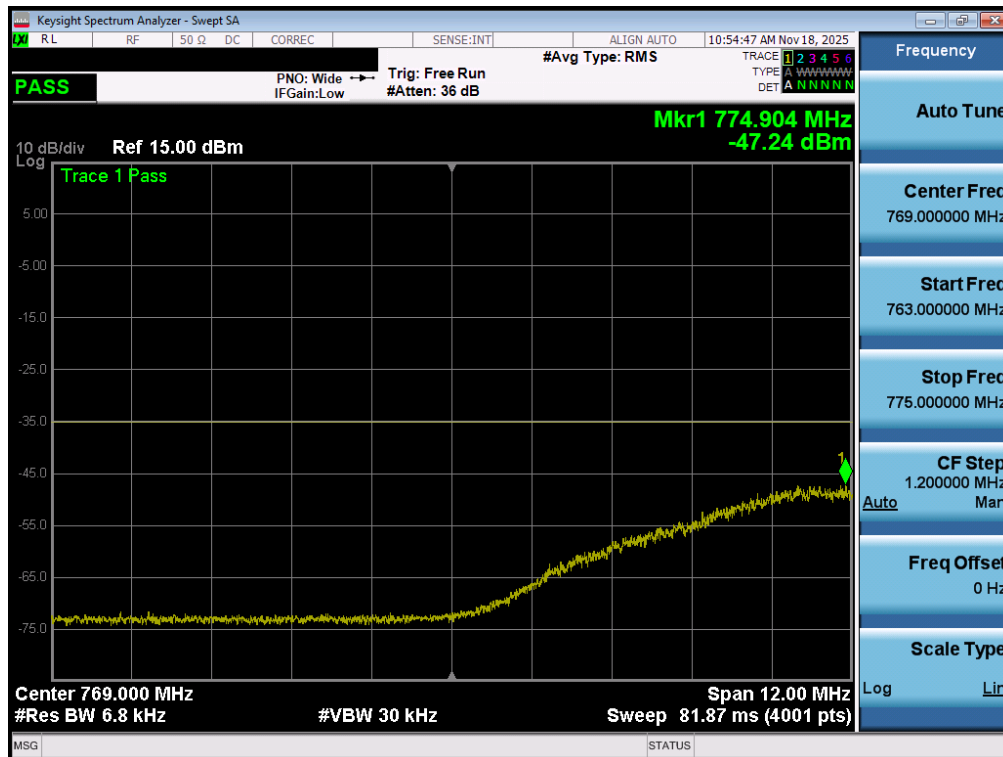
Plot 7-174. Upper Band Edge Plot (LTE Band 12 – 3MHz QPSK – Full RB - ANT2)

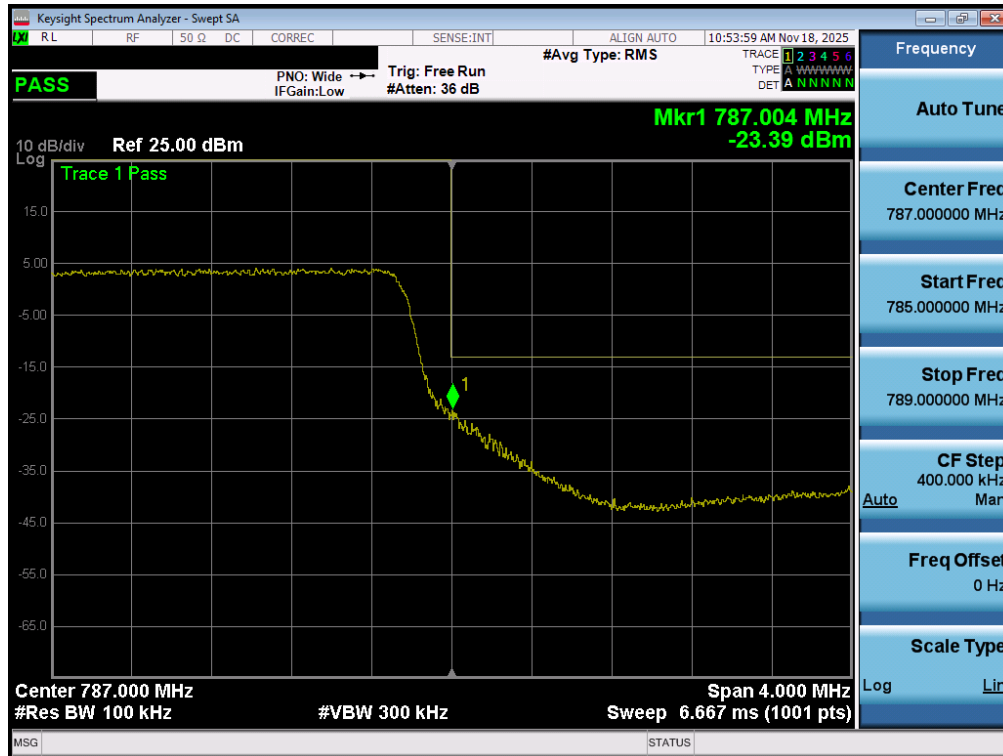


Plot 7-175. Lower Band Edge Plot (LTE Band 13 - 5MHz QPSK – Full RB - ANT2)

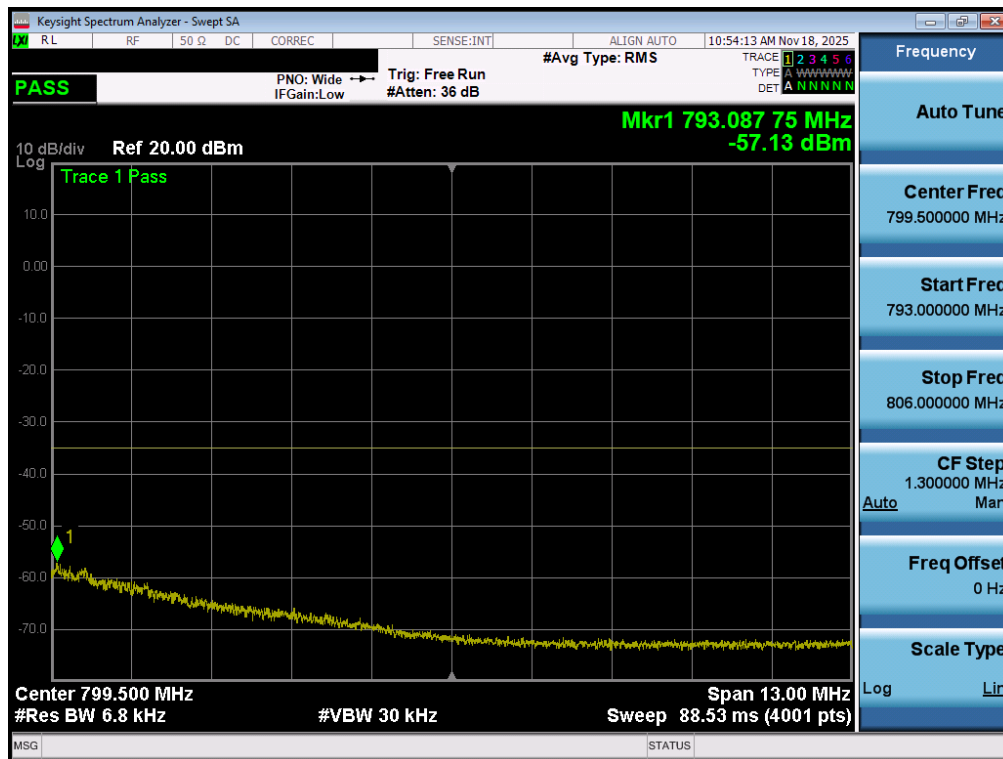


Plot 7-176. Lower Emission Mask Plot (LTE Band 13 - 5MHz QPSK – Full RB - ANT2)

Plot 7-177. Upper Band Edge Plot (LTE Band 13 - 5MHz QPSK – Full RB - ANT2)



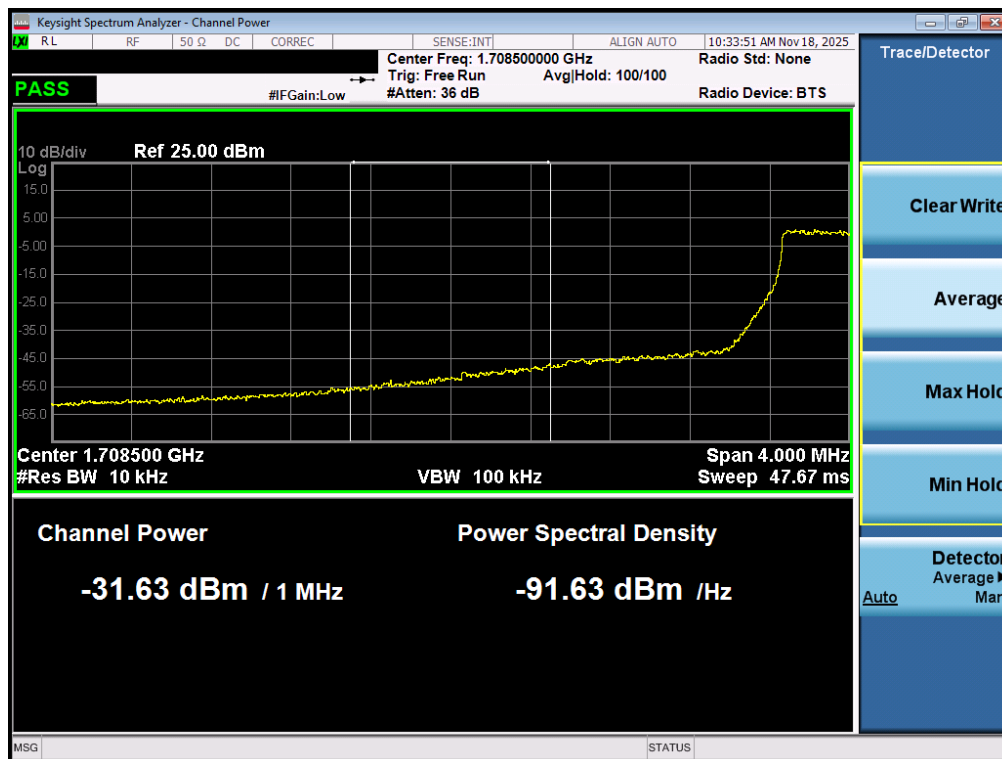
Plot 7-178. Upper Emission Mask Plot (LTE Band 13 - 5MHz QPSK – Full RB - ANT2)

Plot 7-179. Lower Band Edge Plot (LTE Band 66/4 – 1.4MHz QPSK – Full RB - ANT2)

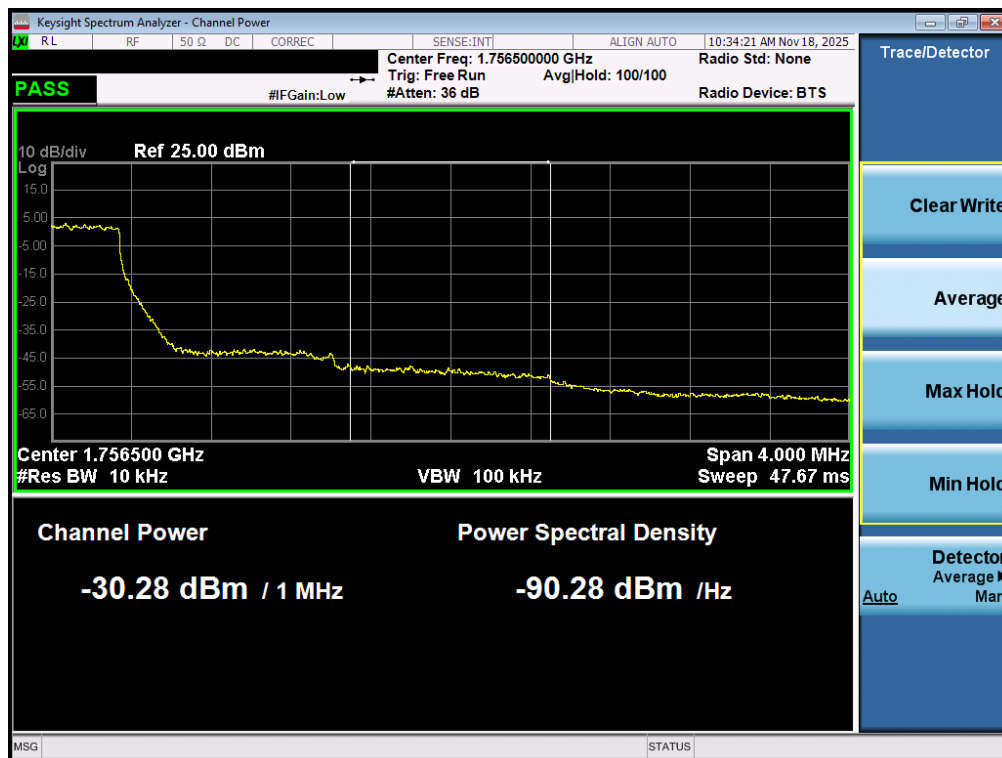


Plot 7-180. Lower Extended Band Edge Plot (LTE Band 66/4 – 1.4MHz QPSK – Full RB - ANT2)

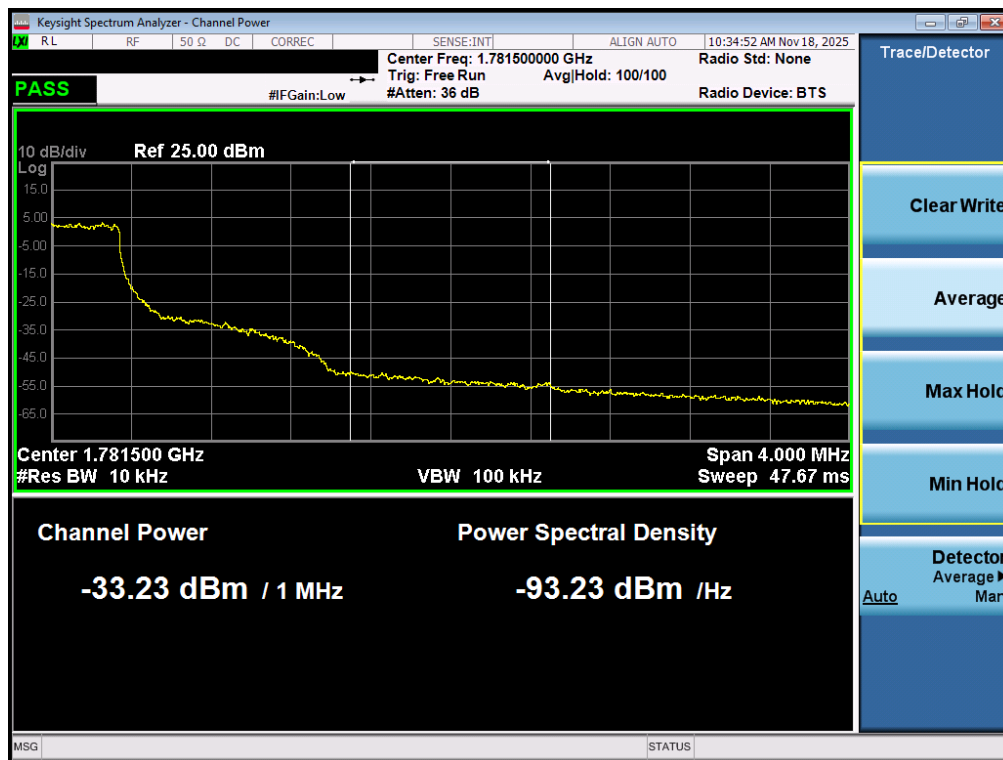


Plot 7-181. Upper Band Edge Plot (LTE Band 4 – 1.4MHz QPSK – Full RB - ANT2)

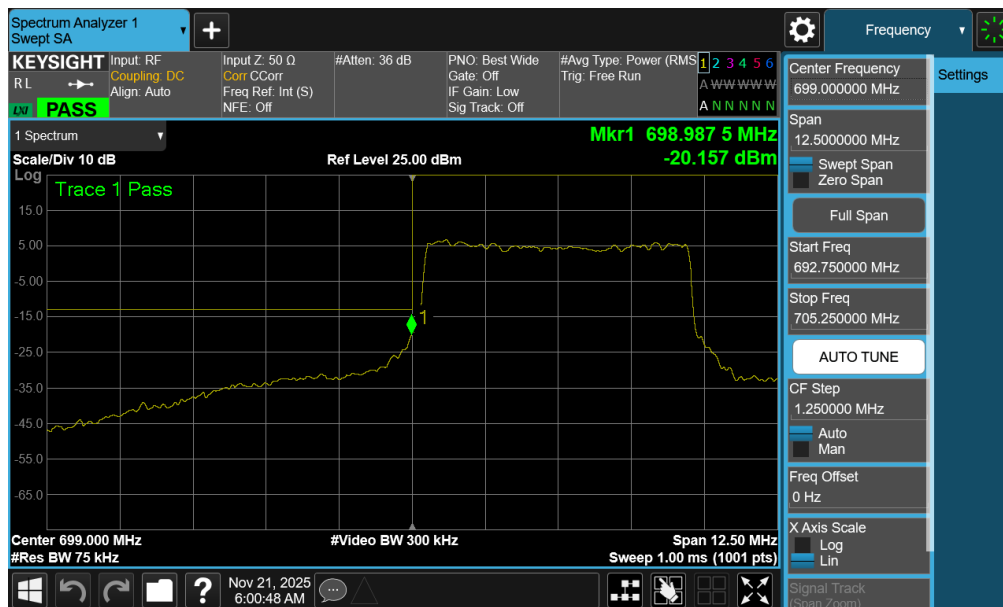

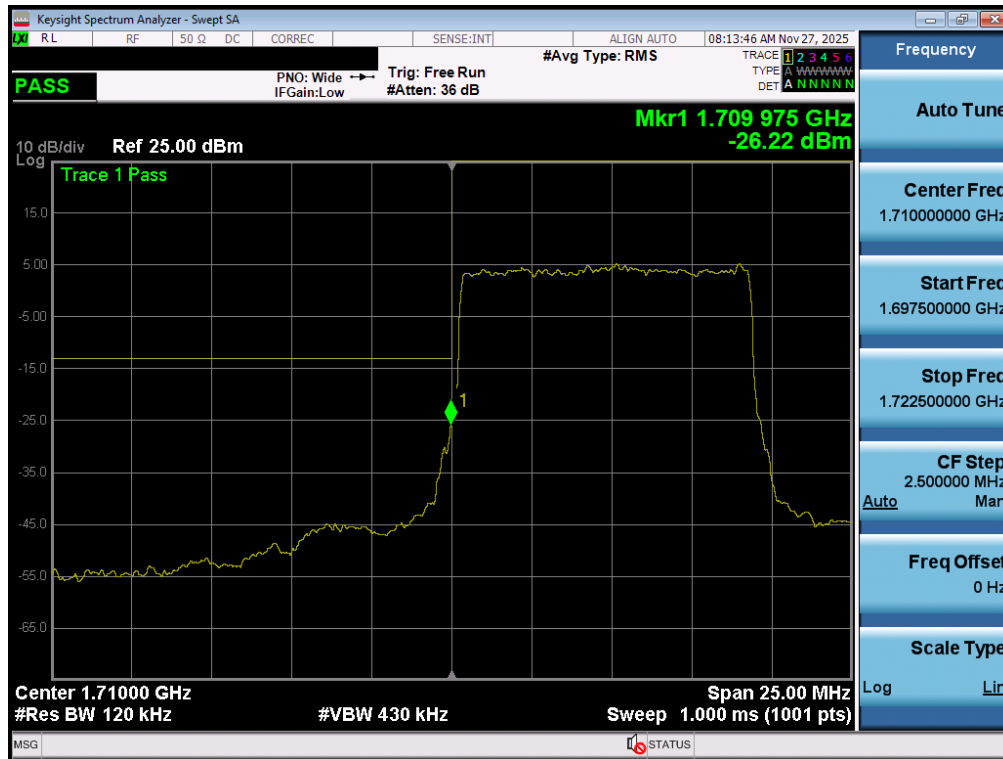

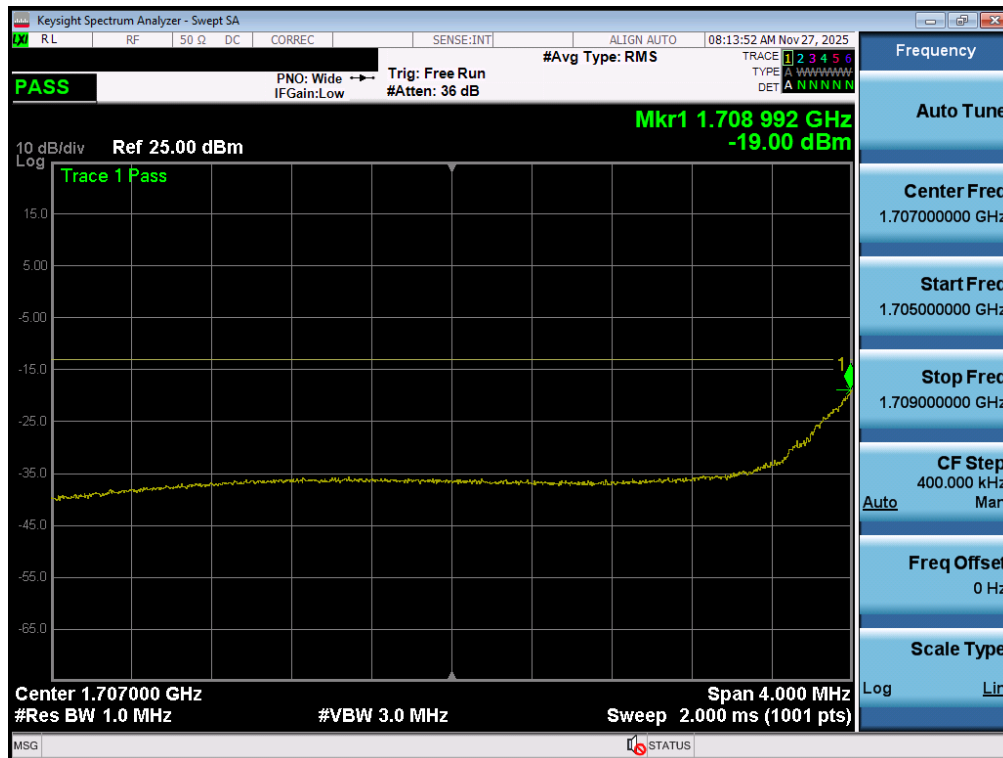

Plot 7-187. Lower Band Edge Plot (NR Band n66 – 10.0MHz - Full RB - ANT2)

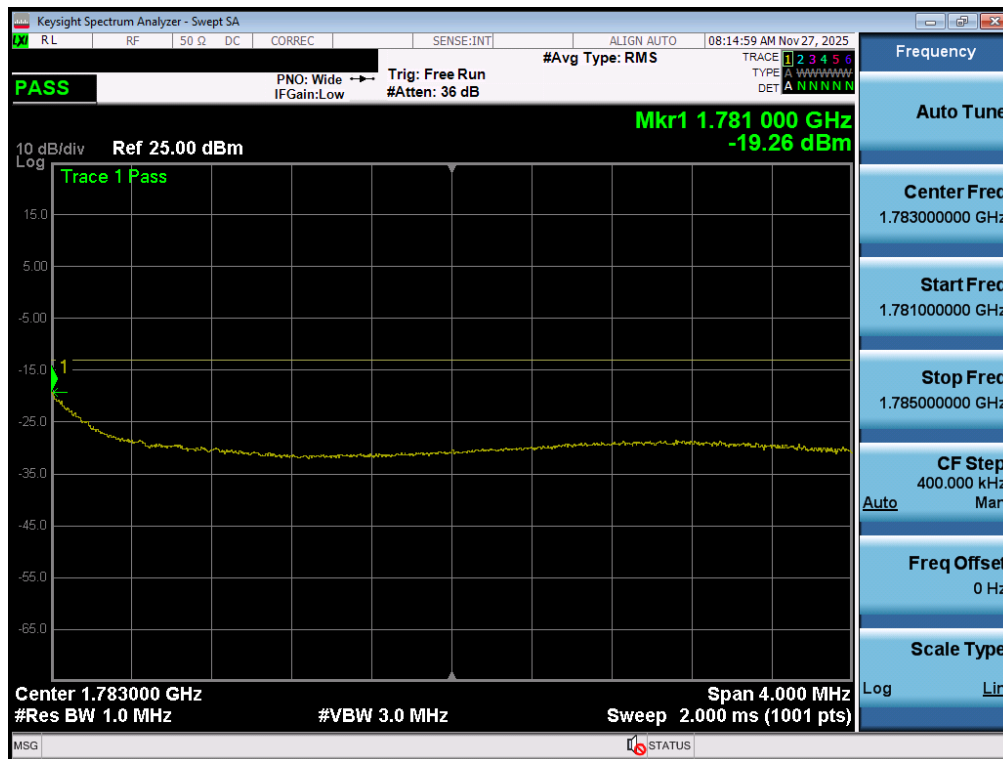


Plot 7-188. Lower Extended Band Edge Plot (NR Band n66 – 10.0MHz - Full RB - ANT2)

7.6 Peak-Average Ratio

Test Overview

A peak to average ratio measurement is performed at the conducted port of the EUT. The spectrum analyzers Complementary Cumulative Distribution Function (CCDF) measurement profile is used to determine the largest deviation between the average and the peak power of the EUT in a given bandwidth. The CCDF curve shows how much time the peak waveform spends at or above a given average power level. The percent of time the signal spends at or above the level defines the probability for that particular power level.

Test Procedure Used

ANSI C63.26-2015 – Section 5.2.3.4

Test Settings

1. The signal analyzer's CCDF measurement profile is enabled
2. Frequency = carrier center frequency
3. Measurement BW $\geq$ OBW or specified reference bandwidth
4. The signal analyzer was set to collect one million samples to generate the CCDF curve
5. The measurement interval was set depending on the type of signal analyzed. For continuous signals (>98% duty cycle), the measurement interval was set to 1ms. For burst transmissions, the spectrum analyzer is set to use an internal "RF Burst" trigger that is synced with an incoming pulse and the measurement interval is set to less than the duration of the "on time" of one burst to ensure that energy is only captured during a time in which the transmitter is operating at maximum power

Test Setup

The EUT and measurement equipment were set up as shown in the diagram below.

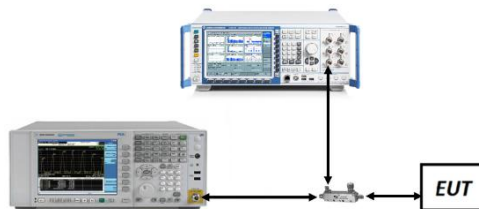


Figure 7-5. Test Instrument & Measurement Setup

For the QAM modulations, 256QAM was found to have the worst-case peak-to-average ratio so it is the only QAM measurement included in this section.

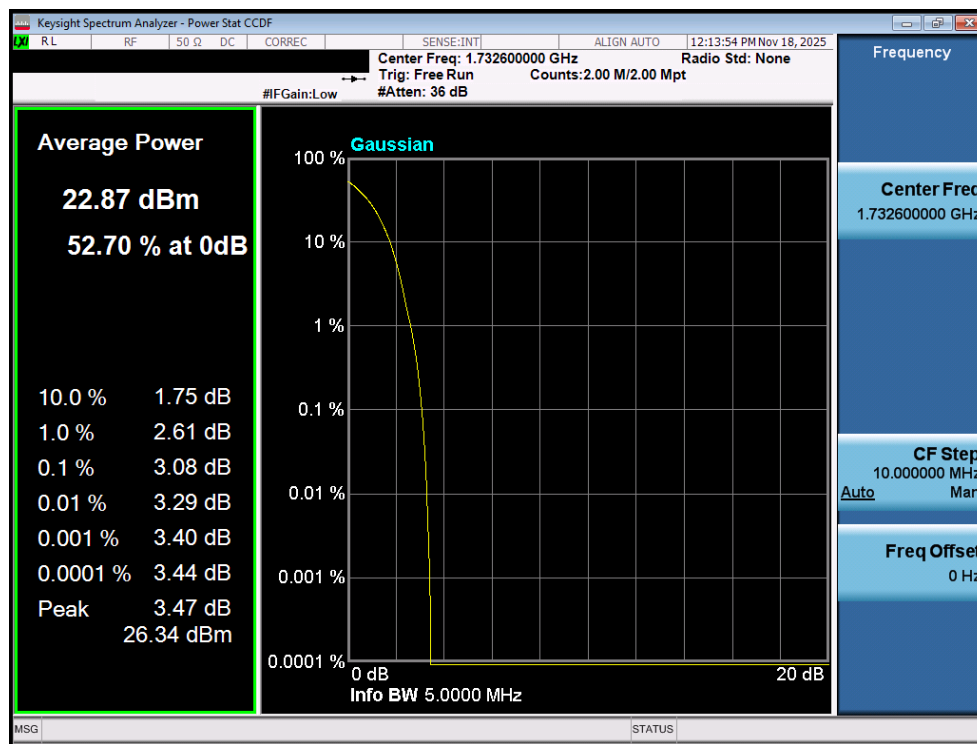

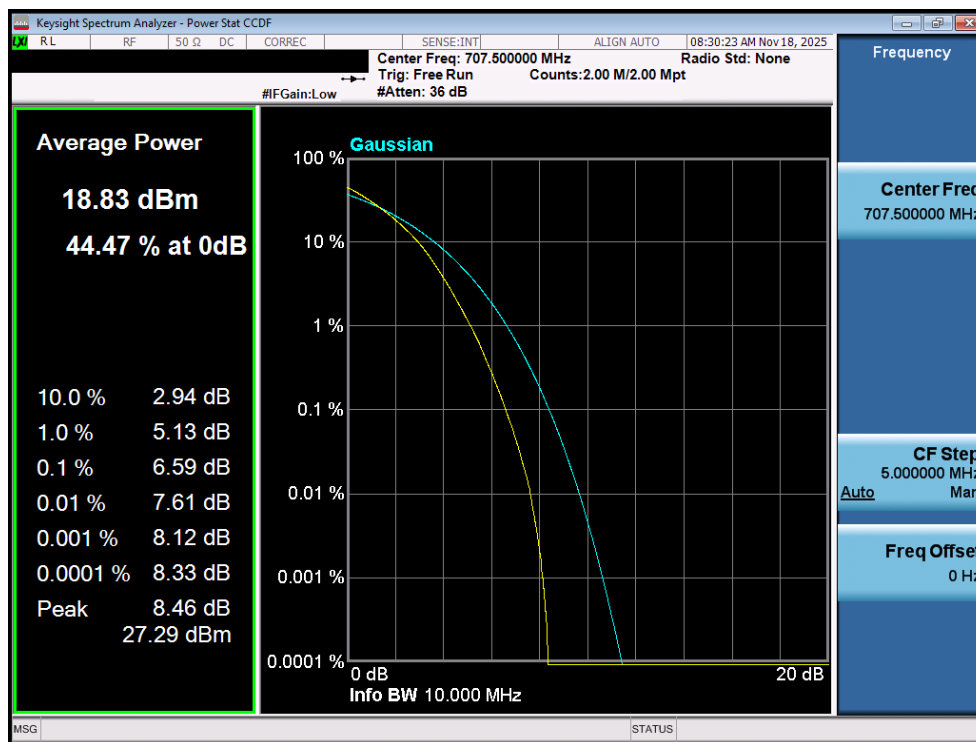

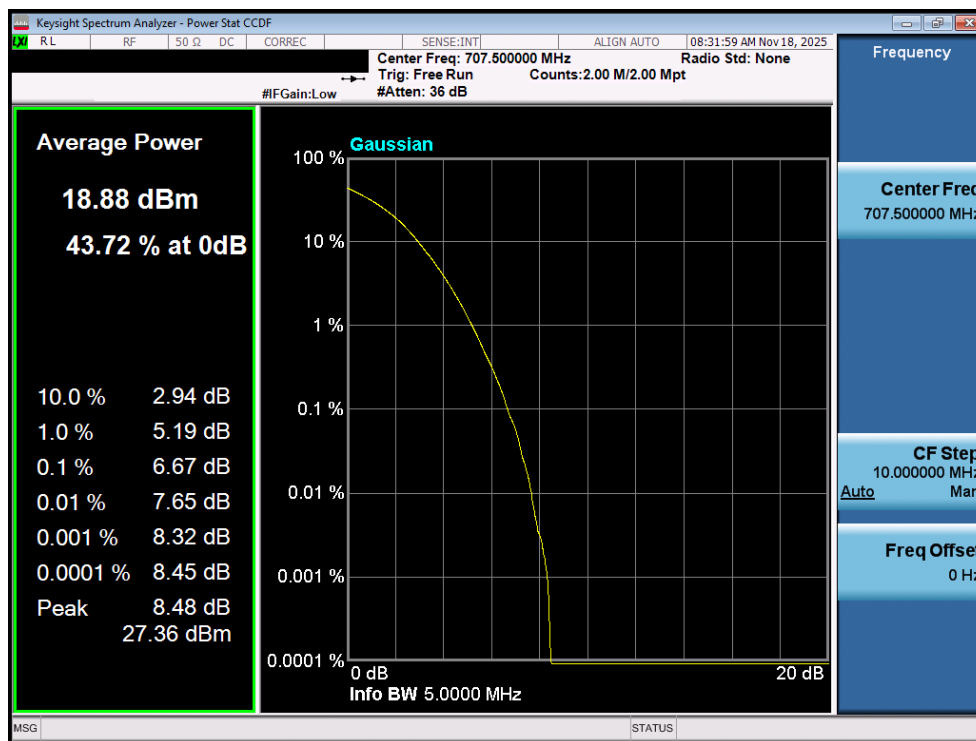
Plot 7-191. PAR Plot (WCDMA, Ch. 1413 – ANT1)

LTE Band 12/17 – ANT1

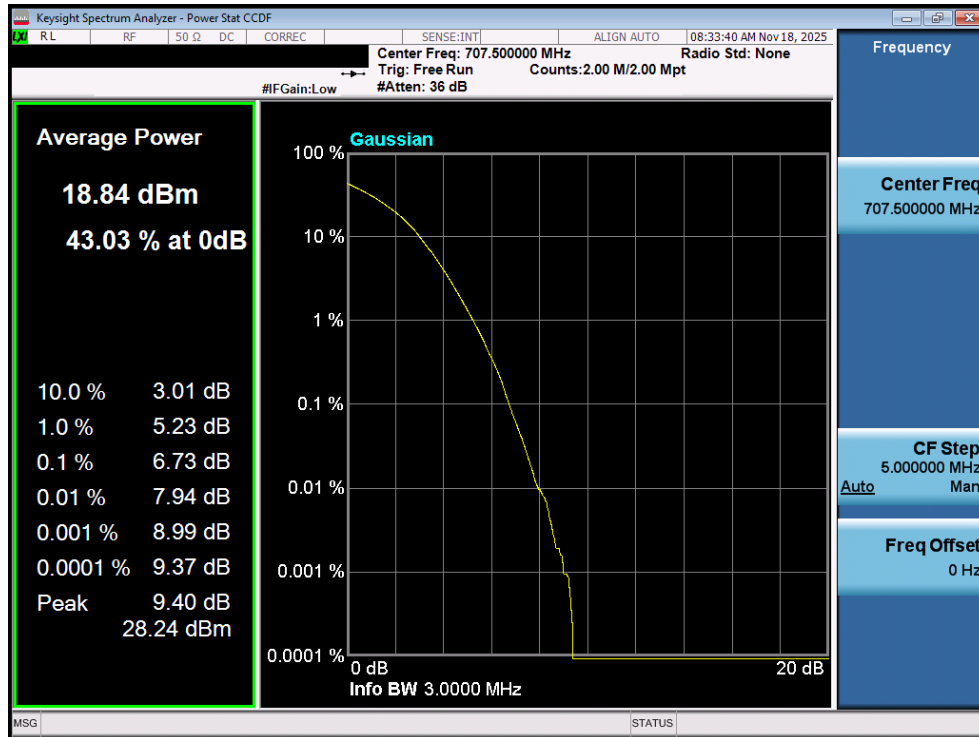


Plot 7-192. PAR Plot (LTE Band 12/17 - 10MHz 256-QAM - Full RB - ANT1)

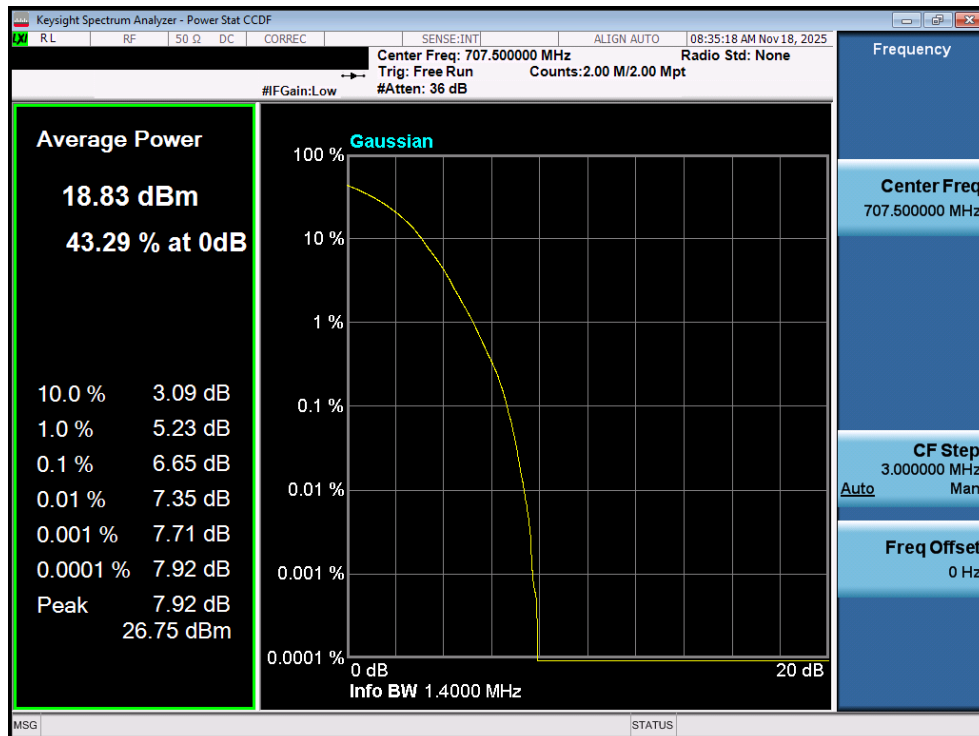


Plot 7-193. PAR Plot (LTE Band 12/17 - 5MHz 256-QAM - Full RB - ANT1)

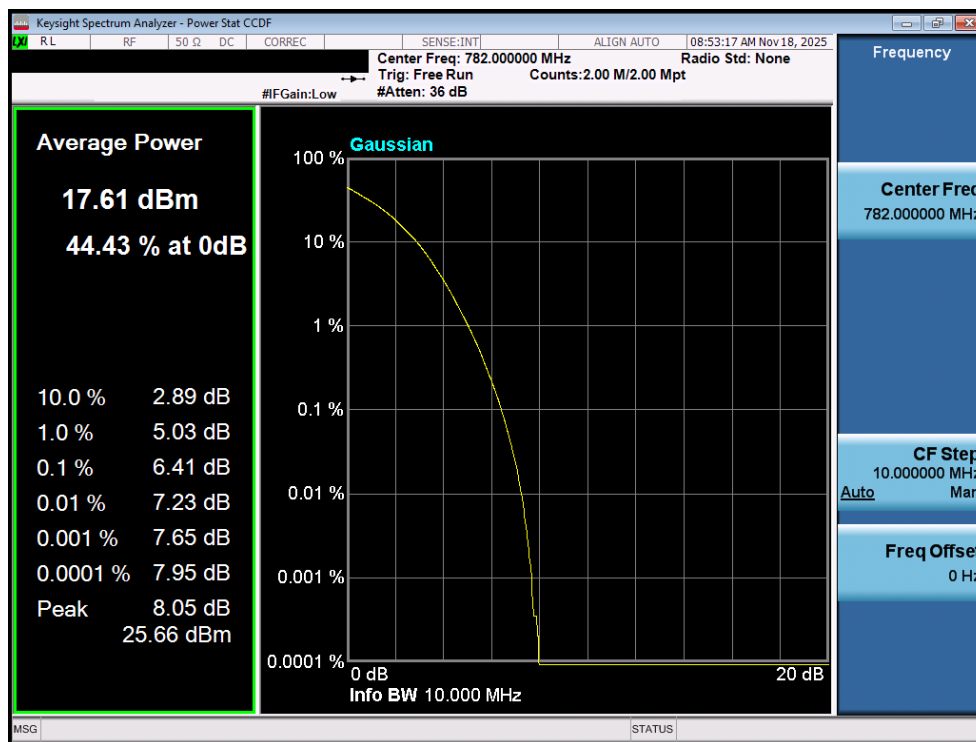
Plot 7-194. PAR Plot (LTE Band 12 - 3MHz 256-QAM - Full RB - ANT1)



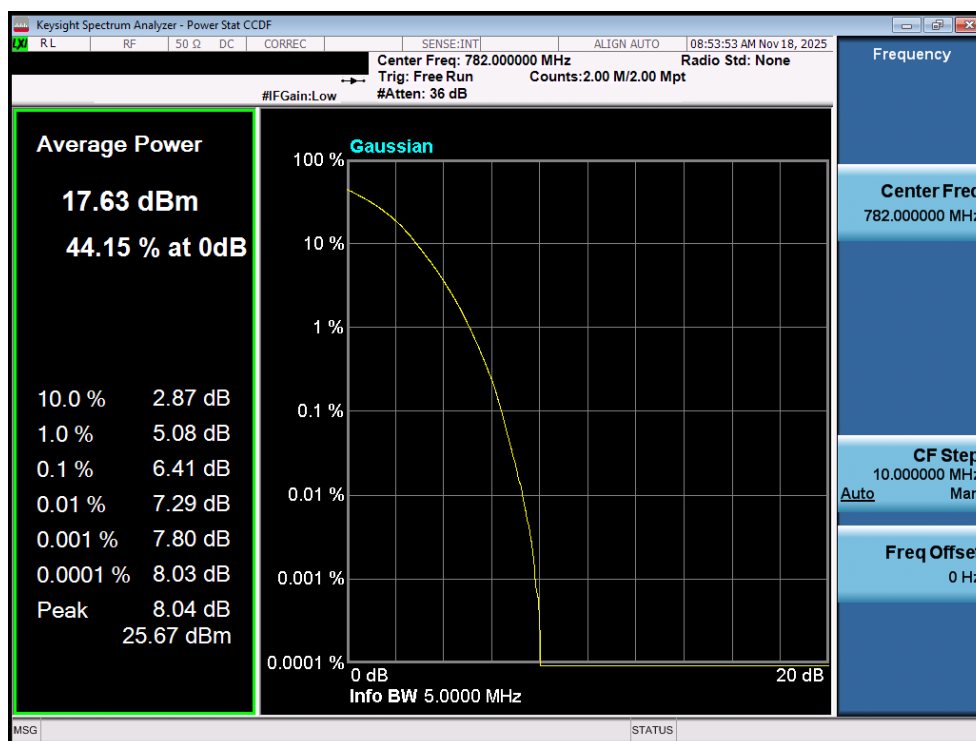
Plot 7-195. PAR Plot (LTE Band 12 - 1.4MHz 256-QAM - Full RB - ANT1)

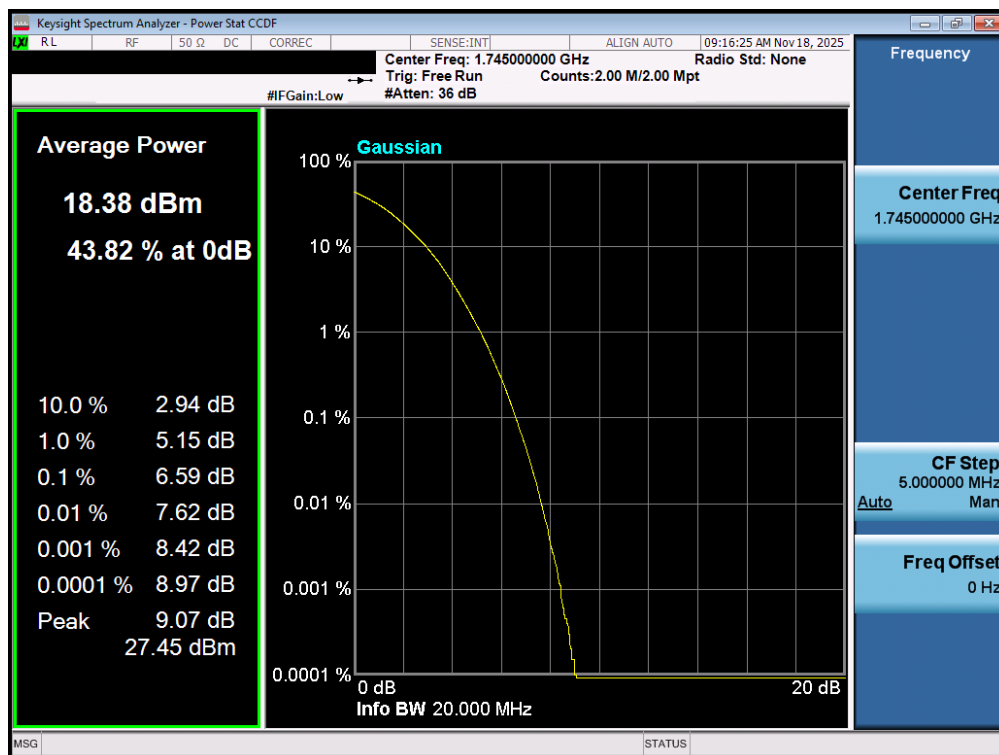
Plot 7-196. PAR Plot (LTE Band 13 - 10MHz 256-QAM - Full RB - ANT1)



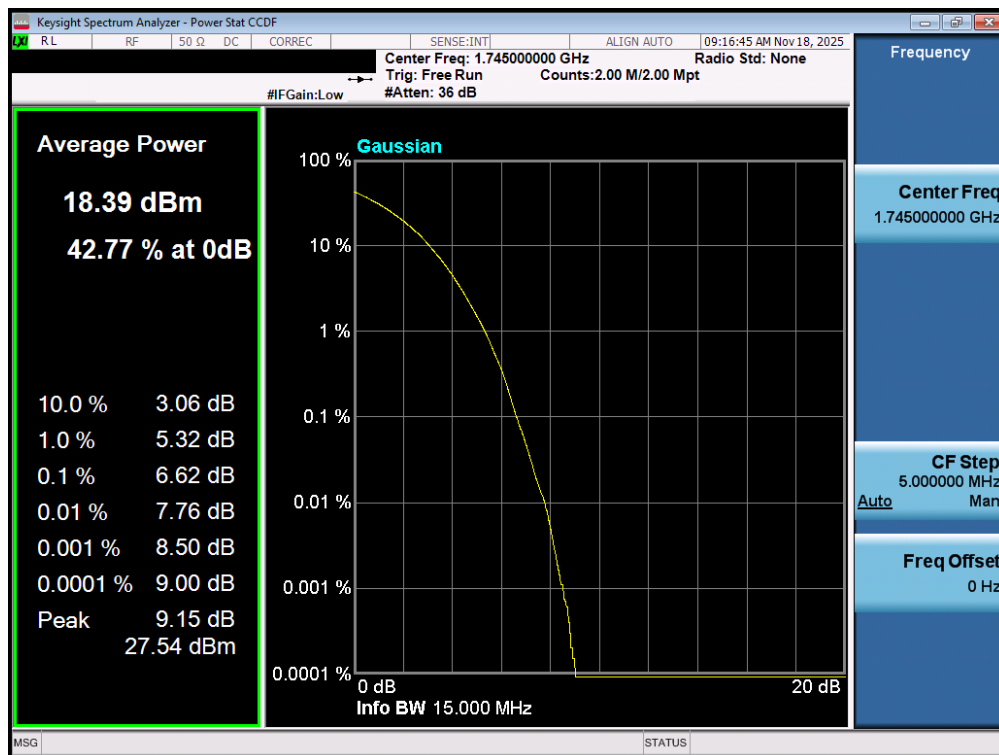
Plot 7-197. PAR Plot (LTE Band 13 - 5MHz 256-QAM - Full RB - ANT1)

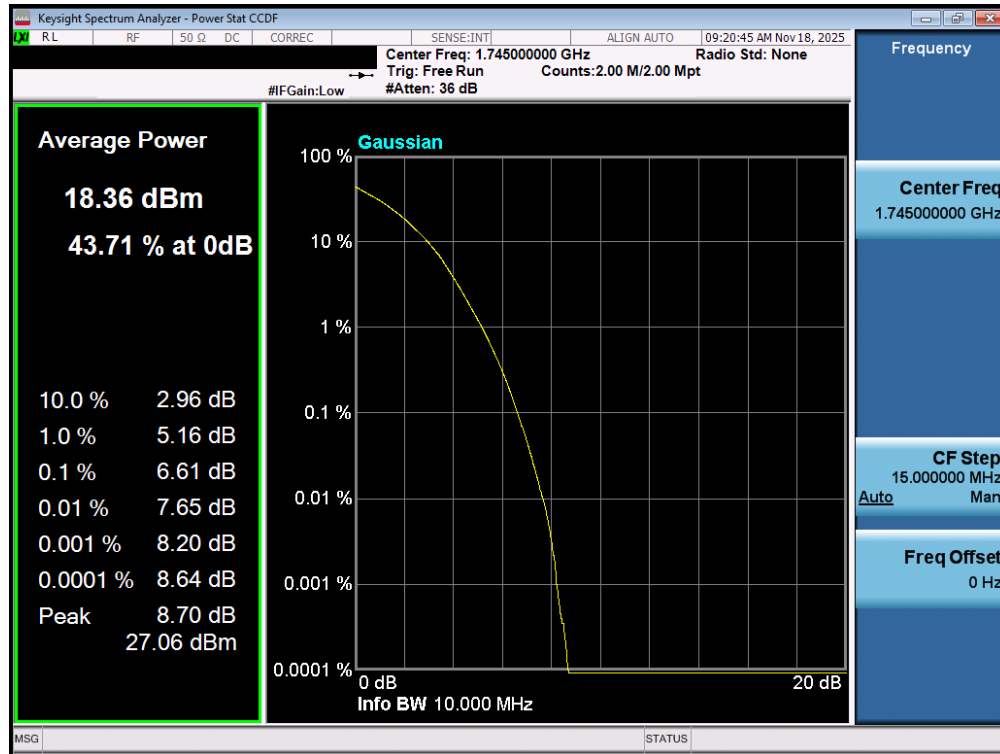


Plot 7-198. PAR Plot (LTE Band 66/4 - 20MHz 256-QAM - Full RB - ANT1)

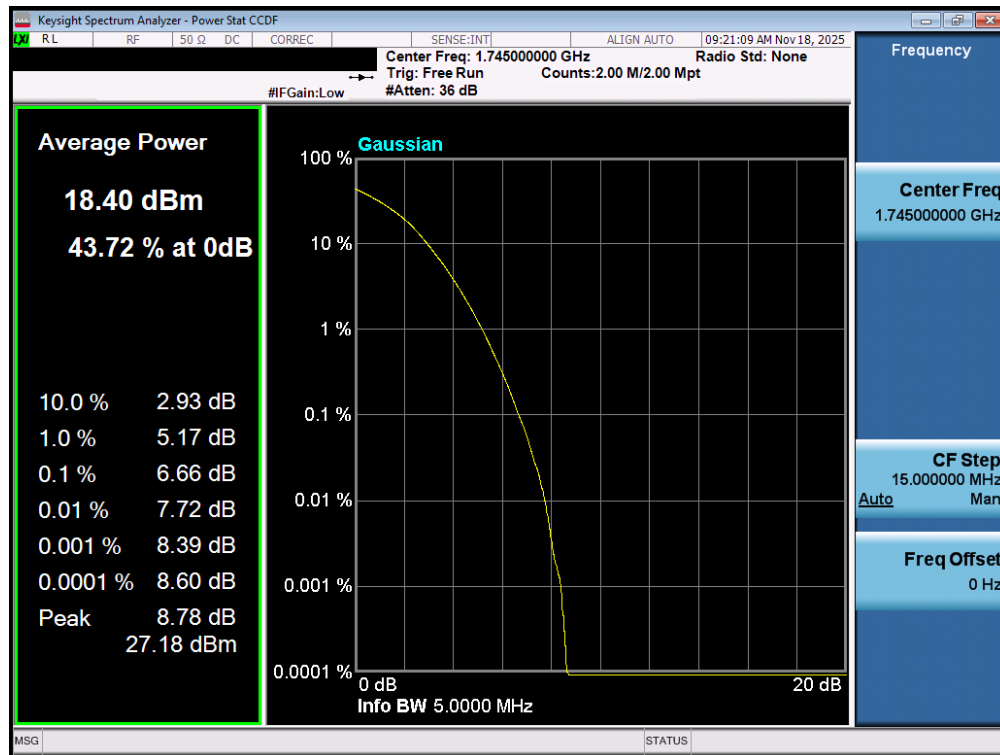


Plot 7-199. PAR Plot (LTE Band 66/4 - 15MHz 256-QAM - Full RB - ANT1)

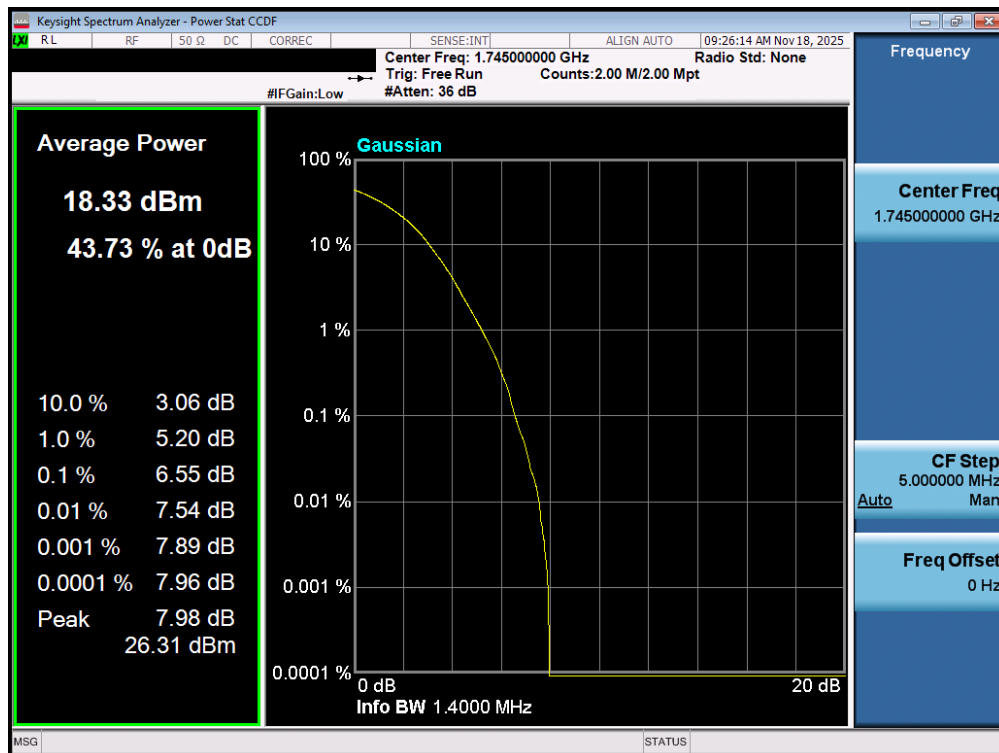
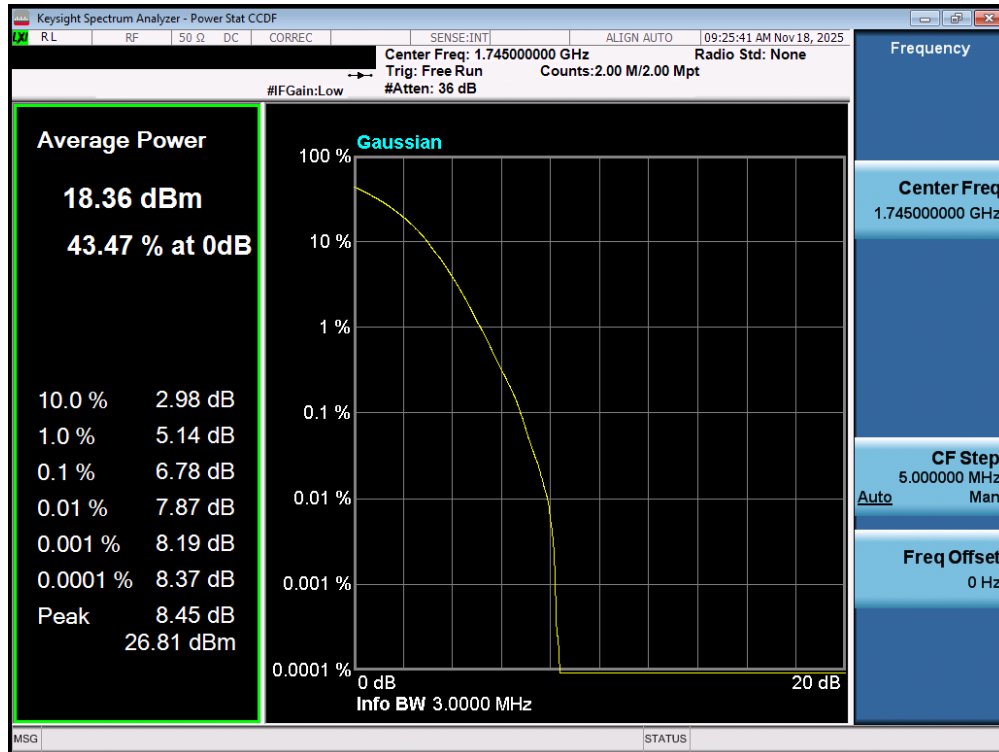


Plot 7-200. PAR Plot (LTE Band 66/4 - 10MHz 256-QAM - Full RB - ANT1)
